

Rains bring relief for Odisha from sizzling temperatures



BHUBANESWAR(KCN): After some days of sizzling temperatures and sultry conditions, people in the twin cities and most of northern, southern, interior and coastal pockets of Odisha have got a relief for them as rains lashed

most parts on Sunday. As per reports, gruelling temperatures have come down in most parts. Twin cities and many parts of the state experienced rains accompanied with lightning this evening. The India Meteorological Department,

Bhubaneswar Centre, had earlier predicted rains after April 6. The IMD also forecast that some locations in the state may experience light to moderate rains in the next two days. A resident of Mohana in

Ganjam said, "People could not venture out due to piping heat. The mercury was around 40 degrees Celsius in the town. After showers, people are relieved a little now."

Regional Director of the IMD, Bhubaneswar, Manorama Mohanty said, "Rains accompanied with lightning and gusty wind will occur at different places of the state in the next two days. Hailstorms are likely." As per reports, as many as 15 goats were killed in the lightning strike in Bhanjanagar area of Ganjam while three tourists were seriously injured due to the lightning strike on Udaypur beach under Bhograi block in Balasore.

Amid Heatwave Warning, Weather Office's Advice On 'One Nation, One Poll'

New Delhi(KCN): With the government contemplating the idea of simultaneous Lok Sabha and state elections, India Meteorological Department (IMD) Chief Mrutyunjay Mohapatra said the authorities should certainly take weather conditions and the climate into consideration when planning for such a massive exercise. Mr Mohapatra told PTI in an interview that India will experience intense heat during the general election period, and the IMD is providing specialised forecasts to help authorities prepare better, but it has not proposed a change in the timings of public rallies



and voting. Asked about the ideal time to hold elections, given the central government's contemplation of the 'one nation, one poll' concept, the IMD director general stressed that the authorities must consider weather conditions and the climate while planning. 'One nation, one poll'

refers to the idea of holding simultaneous polls in the country to elect Lok Sabha and state assembly representatives. This year, around a billion people are expected to exercise their franchise during the seven-phase general elections between April 9 and June 1, heightening concerns about vulnerability to heat waves.

Gujarat, Madhya Pradesh, Maharashtra, Bihar, Jharkhand, Odisha, and Andhra Pradesh are likely to record a significantly higher number of heatwave days, according to the national weather body. There's an elevated risk of heatwave-related health issues among the electorate and staff, Mr Mohapatra said.

PM Modi Launches BJP's Poll Campaign In Madhya Pradesh With Roadshow In Jabalpur



Jabalpur(KCN): Prime Minister Narendra Modi on Sunday kickstarted the BJP's Lok Sabha poll campaign in Madhya Pradesh with a roadshow in Jabalpur. He was accompanied by Madhya Pradesh Chief Minister Mohan Yadav, state PWD minister Rakesh Singh and the party's Jabalpur Lok Sabha candidate Ashish Dubey. The roadshow started around 6:30 pm from Shaheed Bhagat Singh crossing and culminated at Adi Shankaracharya crossing in Gorakhpur locality here at 7:15 pm.

PM Modi, who is on his first visit to the state after Lok Sabha polls were announced, Mr Yadav

and others held the BJP's poll symbol 'lotus' as their saffron coloured vehicle moved during the well-attended roadshow. A large number of people had lined up on either side of the route and were seen clicking photographs and shooting videos using

mobile phones. Several of them held 'Mera Ghar Modi Ka Ghar' and 'Mera Pariwar Modi Ka Pariwar' placards. The BJP had started a campaign to highlight that the people of the country comprised PM

Modi's family, the move coming after Rashtriya Janata Dal supremo Lalu Yadav had said the PM spoke about dynastic politics but had no family of his own. Tribals groups performed several dances enroute, including 'Badhai Nritya', a dance

form of the state's Bundelkhand region that is on display to mark marriages, childbirth and other happy occasions. A BJP leader said special arrangements were in place to shower PM Modi with flowers when the roadshow passes through Gorakhpur market. Jabalpur is part of the state's Mahakoshal region, which also comprises Chhindwara, the only Lok Sabha seat the BJP had failed to win in the 2019 polls. The ruling party had swept the remaining 28 seats in MP. Jabalpur and Chhindwara will go to polls in the first phase on April 19 along with Sidhi, Shahdol (ST), Mandla (ST) and Balaghat. It is suspected that both UTPs escaped from the



BHAWANIPATNA(KCN): In yet another instance of serious lapses in security measures, two under-trial prisoners (UTPs) in Odisha have escaped from prison. This time, the incident has been reported from Bhawanipatna jail in Kalahandi district. Sources said that both the UTPs escaped from the jail last night. The matter came to light in the early hours of Sunday. The UTPs have been identified as Sikandar Jal and Nilamani Majhi. Both of them were arrested in connection with POCSO case and were lodged in Bhawanipatna jail. It is suspected that both UTPs escaped from the

Titilagarh sub-jail. The jail warden was subsequently suspended on the charges of dereliction of duty in connection with the incident.

Later, one of the UTP

was arrested by police after a massive search operation.

NIA says no mala fide intent in action in Bhupatinagar blast case, attack on its team 'unprovoked'

New Delhi(KCN): The National Investigation Agency (NIA) Sunday strongly refuted the allegation of mala fide intention while carrying out raids and arrests in a two-year-old blast case during which its team was attacked by an unruly crowd in West Bengal's Purba Medinipur district.

One NIA officer was injured and a vehicle was damaged Saturday when the NIA team was going to arrest two persons in the Bhupatinagar blast case, in which three persons were killed in December 2022.

"The NIA categorically refuted allegations of mala fide in its Bhupatinagar blast case," an agency spokesperson said.

The NIA spokesperson termed the entire controversy "unfortunate" and made it clear that the attack on its team was "completely

unprovoked". The NIA statement came hours after Trinamool Congress national general secretary Abhishek Banerjee alleged an "unholy alliance" between the NIA and the BJP and said the Election Commission remains "conspicuously silent" on the issue.

"Experience the unfolding alliance between the @NIA_India and @BJP4Bengal, orchestrating conspiracies against Trinamool leaders and the Model Code of Conduct.

"While this collusion persists, the ECI stands by, conspicuously silent, neglecting its duty to ensure fair play," Banerjee posted on X.

On Saturday, after the NIA team was attacked, West Bengal Chief Minister and Trinamool Congress supremo Mamata Banerjee, while addressing an election rally in Dakshin Dinajpur

district, had accused the NIA team of attacking villagers. "The attack was not perpetrated by the women of Bhupatinagar, but rather by the NIA team," she alleged.

On Sunday, the NIA made it clear that its actions were bona fide, lawful and legally mandated, as part of its ongoing investigation into the heinous crime related to fabrication of crude bombs, leading to an explosion that killed three persons.

The NIA reiterated that its team had come under violent attack by an unruly mob when they had gone to conduct searches in Naruabila village Saturday in connection with its probe into the case.

"The attack was completely unprovoked and uncalled for and an attempt to obstruct the NIA from carrying out its lawful duties," the agency said. It pointed out that the searches were conducted at five locations in the presence of independent witnesses and under the security cover provided by the CRPF, which included women constables.

The arrests were made after following all lawful procedures, the NIA spokesperson said. "The NIA has re-stated that an aggressive crowd had assaulted the NIA personnel who were

taking arrested accused Manobrata Jana to the local police station for completing legal formalities. "One NIA official sustained injuries and an official vehicle of the NIA was also damaged in the attack," the spokesperson said.

The NIA has already filed a complaint at the area police station seeking legal action against the assailants. The NIA had Saturday arrested Manobrata Jana and Bailicharan Maity for their involvement in the case.

Lekhasree, Behera Join BJD

Bhubaneswar(KCN): Governing Biju Janata Dal (BJD), the largest political force in Odisha, today again welcomed two other party leaders just a few days ahead of elections for Lok Sabha and State Assembly.

Former Minister and senior Congress leader Ganeswar Behera and BJP State Vice-President Lekhasree Samantsinghar joined the BJD, after resigning from their respective parties. Lekhasree joined the BJD just a few hours after resigning from the BJP while Behera had resigned from Congress on April 2.

Shri Behera, a tall leader from Kendrapara district,

along with hundreds of his supporters formally inducted in the BJD in presence of BJD's Rajya Sabha MPs Manas Mangaraj and Sasmit Patra and former minister Pratap Jena here at party office Sankha Bhawan.

"Inspired by the developmental works and welfare measures taken by Chief Minister Naveen Patnaik, I have joined the BJD," he said. Shri Behera said he joined the ruling party to participate in the developmental process and expedite the developmental works in Kendrapara district. On April 2, he resigned from the primary membership



of the party. Following his joining, the BJD is likely to field Behera from the Kendrapara assembly segment which is reserved for the scheduled caste candidates.

In the 2019 polls, Shashi Bhusan Behera of BJD had won the seat by defeating Ganeswar Behera by a margin of 6,320 votes.

Similarly, Lekhasree is the second BJP Odisha vice-president after Bhrugu Baxipatra to resign from the BJP weeks before the polls and join the BJD. In her resignation letter to Odisha BJP President Manmohan Samal,

Lekhasree said that she decided to quit the saffron party having "failed" to earn the trust of the leadership. "I have given my sweat and blood to the Bharatiya Janata Party for the last ten years. However, despite all the sincerity and hard work, I could not earn the trust of the leadership. Hence, I feel there is nothing left for me to do here and my desire to serve the people of Odisha is being hampered," Lekhasree said in the letter. "It is difficult to change after sweating for a party that did not recognise my hard work. I thank BJD for accepting me. I am inspired by the developmental activities of chief minister Naveen Patnaik. I will do my best for the BJD," she told reporters after joining the regional party at 'Sankha Bhavan', the BJD state headquarters. Since BJD has yet to announce the name of its candidate from the Balasore Lok Sabha seat, she may try for a ticket to the Balasore Lok Sabha seat. The BJD in 2019 had fielded seven women candidates for the 21 Lok Sabha seats in the state. However, this time, the party has nominated only six women candidates so far.

9. Where assessee is unable to file e-appeal as system was not accepting e verification of legal heir: Petitioner contended that he was not able to file e-appeal as system was not accepting appeal in absence of legal heir certificate. Petitioner claimed that he was not legal heir of late assessee and thus, could not obtain heir-ship certificate. Considering facts, liberty was granted to petitioner to file appeal in hard copy to Commissioner (Appeals), who in turn was directed to decide the same on merits - Jagdish Madhavdas Ahuja v. UOI [2020] 114 taxmann.com 722 (Bom).

10. Whether payment of admitted tax before filing of appeal is mandatory or directory: It has been held that requirement of payment of admitted tax before filing of appeal is directory and not mandatory and in case assessee pays the taxes even after filing the

appeal, the appeal will be valid

Annapoorneshwari Investment v. DCIT (2019) 107 taxmann.com 417 (Bang ITAT), Smt. Sushila Devi Malu v. ITO [2019] 101 taxmann.com 62 (Ahmedabad - Trib.) (SB). However, it is not mandatory to pay interest - CIT v. Manoj Kumar Beriwal [2009] 316 ITR 218 (Bom.). 11. CIT(A) can reject an appeal on the ground that the assessee had not paid the taxes due on the basis of revised return which was filed beyond the time permitted: Revised return filed not in compliance with requirements of section 139(5) was non-existent and the same could not constitute a return contemplated in section 249(4)(a) as such appeal cannot be rejected for non-payment of demand based on such revised

return - Mohammed Farooq Sarang v. DCIT [2017] 81 taxmann.com 374 (Mum Trib).

Maharaja Krishnachandra Gajapati Narayan Dev and Odisha



Maharaja Krishnachandra Gajapati Narayan Dev was born in Parlakhemundi in Gajapati district from King Gaurachandra Dev and Queen Bishnupriya Devi. He was a good administrator and one of the leaders in the formation of a separate Odisha state. Under the direct supervision of his father and stepfather Padmanav Dev, he completed his childhood education under the supervision of Mr. Shamsundar Rajguru and M. Edmond Candler's home tutor and went to the then Mandraj for higher education. While studying in Mandraj, his father Gaurachandra Narayan Dev passed away. After graduating from Newington Prince's College, Krishnachandra returned to his homeland in 1913, married Nalini Devi, Rajjema of Kharuan State, and took charge of the government. He was the first graduate of South Odisha. He despised royal luxury and engaged himself in public service.

Especially since his student life, he was always thinking about Parlakhemundi and the improvement of the Oriya community. Even then, on the instigation of the Court of Birds, he objected to

plan to raise the college established by Padmanav Gajapati at Parlakhemundi to cut costs. As a result, the college did not open. On the occasion of his marriage, Utkalmani donated five hundred rupees for the construction of the dormitory of Satyavast Forest School established by Gopbandhu Das. In 1917, the Montagu-Chambers Committee expressed its opinion in favor of the formation of linguistic provinces. In this regard, Krishnachandra met Montagu in Delhi as a member of Uttar Pradesh. In 1922, the Bihar-Odisha Constituent Assembly passed a special proposal for the merger of the Orissa-speaking regions. Philip Duff Committee met with Gajapati during their visit to Visakhapatnam and Ganjam. In 1927, the British government appointed the Simon Commission for governance reforms in India. The whole country was in awe of the Simon Commission at that time. But for the sake of Odisha, Gajapati Antavdy went ahead to talk to the Simon Commission. As a result, a sub-committee was formed under the chairmanship of Atli to consider the issue of Odisha and that committee gave a favorable opinion for Odisha. At that time the first round table meeting (1930-31) was held in London. Therefore, Krishnachandra Gajapati got the opportunity to participate in the round table meeting as a selected member on behalf of Bihar and Odisha government. Krishnachandra Gajapati strongly proposed and said, "It is quite reasonable to demand the formation of a separate Odisha province by uniting the entire separated Odisha region, not only to make the Odisha-speaking people independent." Krishnachandra's AI-like strong and irrefutable arguments shocked the leaders of the conference and even the veteran leader Madhubabu. With the

attention of the British government. His initial main demand was "We want provinces on the basis of language and caste. You cannot reform India without allowing a separate province for a crore of Odians." The representatives of the British government present at the round table meeting were stunned and impressed after hearing the logical speech of this man.

As a result, the Bilat government set up the O'Donnell Committee in 1931 and this committee mainly focused on three issues. One of them was the demarcation of boundaries to form a separate Odisha province. In 1932, the O'Donnell Committee Report was published. The matter was published in the White Paper in 1933 with the approval of the Philip Duff Committee. That white paper was disappointing. Because Parlakhemundi and Jaipur landlords were excluded from it. On Madhubabu's plea, Krishnachandra went to Bilat to present the matter before the Giant Select Committee and in 1934 applied to the Giant Parliamentary Committee for the merger of Parlakhemundi with Odisha. The chairman of this committee was able to influence Lord Linlithgow. Therefore, Krishnachandra Gajapati got the opportunity to participate in the round table meeting as a selected member on behalf of Bihar and Odisha government. Krishnachandra Gajapati attended the Gajapati meeting and was the first to raise the claim of Odisha. He gave a historic speech and drew the

Bhashakasam 5th volume" and publication of many poems. He introduced himself as a literary man by providing full financial support. He even established a model agricultural farm at Parlakhemundi and a central grain research center at Cuttack for the betterment of farmers in Odisha. The initial work of establishing Odisha High Court also started during his time. He established a small steel plant in Parlakhemundi and contracted it with the Tata Company. Abhishek Banerjee Alleges "BJP-NIA Alliance" After Arrests In Blast Case



Kolkata(KCN): The arrest of two Trinamool Congress leaders by the National Investigation Agency (NIA) in a 2022 blast case has sparked a heated exchange between the Mamata Banerjee-led party and the BJP. While the Trinamool has alleged an "alliance" between the BJP and the NIA, the main opposition in Bengal has dared the ruling party to prove its

secretary Abhishek Banerjee took to X today to hit out at the BJP over the arrests. "Experience the unfolding alliance between the @NIA_India and @BJP4Bengal, orchestrating conspiracies against Trinamool leaders and the Model Code of Conduct. While this collusion persists, the ECI stands by, conspicuously silent, added.

Trinamool has demanded an FIR against NIA officer Dhanram Singh and his removal from Bengal. Mr Tiwari, a former Mayor of Ansals, has Trinamool is "spreading lies" as it finds the "ground slipping under its feet" due to allegations of corruption and atrocities against villagers.

"If TMC leader Kunal Ghosh fails to come up with evidence that me or any of our leaders had been involved in influencing NIA probe or meeting any of their officials, I will file a defamation case against him," he added.

BJP spokesperson Samik Bhattacharya has said Trinamool's allegations point to its "desperation". "TMC is trying to divert attention from the total breakdown of constitutional principles in its rule," he said.

Earlier, Chief Minister Banerjee accused the NIA team of assaulting villagers. On the injuries suffered by an NIA team member, she said it was "self-defence" by villagers. The central agency team, she said, barged into several homes over an incident of "bursting crackers".

Bengal police have, meanwhile, filed a molestation case against the NIA team on the basis of a complaint by the family members of those arrested.

Court On "Disturbing" Victim Impact Report In Case Linked To 2020 Delhi Riots



New Delhi(KCN): During proceedings related to the victim impact report (VIR) being prepared by the Delhi Legal Services Authority in connection to a case linked to the 2020 northeast Delhi riots, a court observed that it received a letter with "very disturbing" facts from the authority's secretary.

The judge forwarded a copy of the letter to the deputy commissioner of police (DCP) to take "immediate necessary action" on it.

The court in a previous hearing on the matter had termed the delay in preparation of the VIR as "unfortunate".

When the matter came for hearing around 10.30 am on Saturday, the court said there was no response from the DCP and the DLSA.

Issuing a reminder letter to both the DCP and the DLSA to ensure that a VIR was filed in the case, the court posted

the matter for further proceedings on April 20. At 11 am, the court said it received a sealed envelope containing a letter by the DLSA secretary. "I have gone through the letter of the secretary. The facts mentioned therein are very disturbing and hence a copy of this letter is

being forwarded to the DCP to take immediate necessary action, in view of facts mentioned therein under intimation to this court," Additional Sessions Judge Pulastya Pramachala said. The Delhi High Court has laid down the procedures for preparing VIRs after conviction. On Saturday, Additional Sessions Judge

Pramachala was hearing arguments against one Jony Kumar, who was sentenced for rioting and arson, when he directed the DCP to take action based on the DLSA's letter. Earlier on April 1, the court had noted that the secretary of the Delhi Legal Services Authority (DLSA) had requested the court to submit the VIR on a future date as the investigating officer (IO) did not bring one of the victims before it for interaction.

The judge said it was "unfortunate" that there was a delay in the preparation of VIR related to the case. "The Deputy Commissioner of Police (northeast) district is requested to sensitise all the station house officers (SHOs) and IOs to ensure the presentation of victims before DLSA at the earliest point of time so that VIR is prepared by DLSA at the earliest possible time," the court had said.

Raghu Mohanty Left BJP

"I do hereby inform you that I and my family members tendered resignation from the primary membership of Bharatiya Janata Party (BJP) with immediate effect," he said in his resignation letter sent to Odisha BJP President Manmohan Samal. The former Minister told reporters that he decided to quit BJP as its leaders in Balasore have weakened to such an extent that it is impossible to work with them.

"There is a vast difference of ideologies between BJP and me. So, it became impossible for me to remain in the party anymore," he said. Following his resignation, speculations are high that Shri Mohanty and his family members would return to BJD and his daughter-in-law Barshoni Choudhury is likely to be named as BJD nominee for Balasore Lok Sabha seat. While BJP has re-nominated former Union Minister Pratap Sarangi

from the seat, speculations are rife that Congress heavyweight, former Union Minister Srikant Jena, who was elected from Balasore Lok Sabha constituency in 2009, would be the Congress nominee from the seat. A five-time MLA from Basta in Balasore district, Shri Mohanty had contested the 2019 elections from Basta Assembly constituency as a BJP candidate but lost to BJD's Nityananda Sahoo. Shri Mohanty was first elected to the State Assembly from Basta under Balasore Lok Sabha Constituency in the 1990 Elections.. He retained the seat in 1995, 2000, 2004 and 2009 elections.

He was expelled from the ruling party following his arrest in a dowry torture case slapped by his daughter-in-law Barsa Sony Choudhury. Later, he was taken back into the party in 2017. However he left the party to join BJP.

Sunflower farming finds few takers in Kendrapara



Kendrapara(KCN): Sunflower cultivation has failed to find many takers in Kendrapara district due to lack of training and sponsorship by the state government.

The highly profitable sunflower farming is being ignored in Kendrapara district despite the district's immense potential for cultivation of the crop and heavy market demand for its oil.

The members of Maa Mangala Women Self-Help Group (SHG) at Koilipur's Charipokharia village under Rajkanika block have cultivated sunflowers on seven acres of land for the second year in a row. The experience which they gained in the first year of cultivation has matured them and prepared them better to take up the farming in a more organised manner. The sunflower oil produced by them has received wide acceptance from customers in the local market. The women have become an example for others to emulate. However, their success has failed to stir up any interest among other farmers towards the cash crop due to lack of training and sponsorship by the

state government. Local intelligentsia claimed that the cultivation done during the Rabi season can lead to establishment of small-scale industries and contribute to the economy of the district if it is encouraged. Local intelligentsia Ashis Kumar Senapati said that the price of edible oil is witnessing a constant increase in the country. The price rise of edible oil along with petrol, diesel and LPG cylinders has become a cause of concern for the common man. India is laying stress on import of palm oil from Malaysia and Indonesia after a stoppage in import of sunflower oil from Russia and Ukraine. Indonesia has imposed restrictions on export of palm oil while Malaysian

cultivation was first done on an experimental basis over 30 hectares of land in four panchayats of Garadpur block under Rashtriya Krishi Vikash Yojana. However, the absence of proper marketing facilities or mandis is weaning the farmers from sunflower cultivation, he added.

A farmer leader Rashmiranjan Choudhury said that agricultural investment makes up the lion's share of the district's annual plan. However, this is not done in reality. The district can be an example in sunflower farming if water management is strengthened in the district.

Farming can be taken up on over 40,000 hectares of land in the district. Around 55 per cent of oil can be collected from sunflower seeds which will lead to establishment of small and minor industries.

The Agriculture and Horticulture departments, Krishi Vigyan Kendra (KVK), local political representatives, administrators, voluntary outfits, pani panchayat and farmers club should join hands to take up sunflower farming to a greater height.

Flower wants RCB's 'level of aggression above a certain threshold'

New Delhi: After yet another underwhelming batting performance that saw Royal Challengers Bengaluru crash to their fourth defeat in five games, head coach Andy Flower admitted that his side were short of runs on a Jaipur surface that got better to bat with dew. On a night when Virat Kohli registered yet another IPL ton, none of the other RCB batters came to the party, leaving their former captain to do the bulk of the scoring. Having posted 183 on the board, RCB then saw RR chase it down with effortless ease, led by a century from Jos Buttler and a fifty from skipper Sanju Samson.

Dwelling on the lack of intent in the batting department, Flower was brutally honest in his assessment of the issue. "We do discuss strike rates and aggression, it's part of the understanding of the T20 game," said

Flower at the post-match press conference.

"The level of aggression has to be above a certain threshold and you have to always be putting the opposition under pressure. Certainly taking the aggressive option, especially on pitches like today. It's just a fact that at the moment that our top five aren't in sparkling form except Virat. It's a tough place to be. It's not from lack of effort, they're working hard, they're giving everything they've got. Just not firing at the moment. If we've got to turn this around, we need them firing."

Kohli's hundred, also the



joint-slowest IPL century of all time, was the lone ranger act although skipper Faf du Plessis did chip in with a decent knock of his own. The century opening stand had put RCB on track for a 190-plus score and perhaps the 200-run

mark as well. However, once the partnership was broken, RR put the squeeze through their spin duo of Ravichandran Ashwin and Yuzvendra Chahal, alongside the left-arm pace of Nandre Burger. The surface did have something in it for the slower bowlers in the first half and RR's attack made full use of it. The dew that came later on made RR's chase

considerably easier but RCB had begun the second half on a positive note with Yashasvi Jaiswal perishing to Reece Topley in the first over of the chase. The two-paced nature of the track that was evident at times in the first innings, did hang around at the start of the chase, but RR negotiated that phase well. With dew always a factor in Indian

conditions, RCB probably needed a cushion of 15-20 extra runs to stay in the hunt. Flower lamented the poor finish to the innings after the base set by the opening stand.

"We were a bit light (on runs) I thought, given the base we had, we were about 107/0 in the 12th over, so we should have got upwards of 200 being in that position on a good

pitch. But we started well with the ball, Topley and Yash, then Siraj were brilliant upfront but the last over of the powerplay cost us some serious momentum."

With just two points from five games, RCB's road ahead to the playoffs looks murky at the moment. Given the high tempo at which batters of other teams are operating, it's imminent for Bangalore also to join in the mix. The impact player rule has furthered the adventurous levels of batters, enabling them to play fearless cricket from the get-go. A big example of this is the fact that the highest-ever IPL total set by RCB in 2013, was breached twice in the space of a week, first by Sunrisers Hyderabad and then by Kolkata Knight Riders.

Flower knows that his

team needs to pull up their socks at the earliest to get out of the muddle. "We're one from five and that's not a position any side wants to be. Yes, we do have some issues with our batting. We got Virat in superb form but other guys are struggling for form and confidence. We're trying everything we can to make them feel strong and confident. As you've seen in this competition, scores and aggression of teams are only going one way. So the guys need all the form and confidence to put the opposition under pressure. We haven't found that form yet."

Skipper Faf du Plessis

echoed similar sentiments at the presentation ceremony when asked to evaluate the defeat. The South African registered a 33-ball 44 but wasn't at his fluent best in the innings. Once he perished, the other batters weren't able to sync up to the nature of the surface,

leaving Kohli to do it all. The RCB captain also felt that there was a stark contrast in the batting conditions across two innings.

"Batting out there with Virat tonight, we found the wicket was tricky and low in the first innings. In our heads, when we were batting, we felt 190 would be a good score. I did feel that maybe the last over or two, maybe there were 10-15 runs more that we could have maximized towards the end," Faf said.

"But if you look at how their spinners bowled through the middle, it was tough to hit; the ball was staying quite low. And a good decision by them to chase, you could see in the evening, with the dew, it played much nicer. But yeah, you feel in hindsight that you could have pushed a little bit harder and get through that 190-195 mark."

Wouldn't point fingers at Kohli: Clarke shields star after joint-slowest IPL hundred

New Delhi: Michael Clarke said that Virat Kohli should not be blamed for Bengaluru's defeat to Rajasthan in the Indian Premier League (IPL) 2024. On Saturday, April 6, RCB lost to RR by 6 wickets at the Sawai Mansingh Stadium in Jaipur after they slumped to their fourth defeat in 5 matches this season. Kohli hit the joint-slowest IPL hundred off 67 balls and went on to rack up 113 runs off 72 balls with the help of 12 fours and 4 sixes.

Apart from his decent knock, Kohli also laid the platform for RCB after stitching together a partnership of 125 runs off 14 overs along with captain Faf du Plessis. Clarke said that the 35-year-old Kohli played according to the situation, holding the innings together when



the other RCB batters were struggling to show any kind of consistency. "I wouldn't point my fingers at Virat Kohli. He was brilliant and I think he played the exact role he needed to play because the batters around him are not scoring enough runs, not playing with enough

confidence or enough freedom," Clarke told Star Sports. After being asked to bat first, RCB scored 183 for the loss of 3 wickets. However, the RR team chased down the target with 5 balls to spare on the back of Jos Buttler's unbeaten 58-ball knock of 100. Du

Plessis admitted that the visitors were short of where they would have liked to finish. Clarke also echoed the same, also expressing surprise at Cameron Green's promotion over Dinesh Karthik, who is known for finishing games off for RCB. "I think RCB left 15 runs on the ground. A few of their decisions were hard to understand. You have got Karthik as a finisher; I don't know why he did not come in probably after Maxwell. He certainly should have come in before Green. That was an interesting decision," Clarke added.

With the loss, RCB are

languishing at 8th in the table with 2 points and a net run rate of -0.843 thanks to wins in only 1 out of 5 matches. Sunrisers Hyderabad (SRH) captain Pat Cummins won the toss and opted to bowl against Chennai Super Kings (CSK) in their Indian Premier League (IPL) 2024 match at the Rajiv Gandhi International Stadium on Friday.

SRH will be looking to

make the most of home comfort in their second game while Chennai Super Kings will be keen to sharpen their all-round game. Chennai will miss out on their pivotal pacers - Mustafizur Rahman and Matheesha Pathirana, who will be replaced by Moeen Ali and Maheesh Theekshana. On the SRH side, Mayank Agarwal will miss the game due to illness and will be replaced by Nitish Reddy. Speaking at toss, Pat Cummins said, "We'll bowl first. Looks like a good wicket and should stay the same for the whole match. We've got a great squad. Mayank Agarwal is unwell, he's replaced by Nitish Reddy. Last time, there were 500 runs scored, this looks like a good wicket as well."

CSK captain Ruturaj Gaikwad said, "It's going pretty well, the group is responding well. Nothing much changed for me, obviously, this is a new challenge, but I'm feeling good. Pathirana is slightly ill - three changes for us, Moeen Ali, Theekshana and Mukesh Chowdhary come in. The bowlers are ready to go and so are the youngsters.

Buttler's sixth ton trumps Kohli's eighth as Royals go four-from-four

New Delhi: Virat Kohli's eighth IPL century went in vain as Rajasthan Royals secured a comfortable six-wicket win to go four-from-four at the start of IPL 2024. It was the third time that Kohli's IPL century came in a losing cause as Jos Buttler's unbeaten sixth IPL ton - achieved off the last ball of the chase - and Sanju Samson breezy half-century helped Royals over the line with five balls to spare at the Sawai Mansingh Stadium in Jaipur on Saturday.

There have been better and more fluent centuries Kohli has scored in the IPL. His innings was littered with shots that he couldn't time as well as he would've liked partly down to the slightly tacky

nature of the pitch in the first half of the match. There was ample intent to attack, but not every shot proved as effective as he would've liked. It took him 67 balls to reach the three-figure mark, the joint-slowest by anyone in IPL history.

He got going smoothly early on though, dictating terms in the powerplay. The acceleration began in the second over when he hit Nandre Burger over the mid on region for a boundary and then flicked another four through square leg. The region between deep square leg and deep mid wicket proved to be his most productive area from where he picked up nearly three-fourth of his runs. He even pulled Burger for a six in the

pacer's next over and provided RCB a strong start. However, while he got off to a strong start and maintained their scoring rate, Kohli mentioned after his innings that it was decided that the pitch wasn't as flat as it seemed from the outside and that they were forced to recalibrate the attempted total from 190 to 180 with one of the set openers batting till the end. Royals were also clever with their tactics. The pacers took the pace off consistently and bowled the short of good length, while the spinners also varied their pace and forced the batters to hit towards the longer boundary.

Every now and then, Kohli did manage to hit a

few boundaries. He was particularly good against Avesh Khan in the death overs, slicing his yorker square of the wicket, flicking him through mid wicket, hitting straight down the ground and even through the cover region - all for boundaries. However, he didn't get similar success against Burger in the end overs and the refusal to

pick the extra runs while nearing his century ensured that RCB were restricted to 183 for 3 even though Kohli registered his joint-highest T20 score. Faf du Plessis had got the innings going with a thumping drive over covers for four in the first over, and powered RCB to a fruitful opening partnership. Not only was it the first time this season that RCB had played out the powerplay without losing a wicket but they also blunted Royals' attack, which had picked nine scalps in this period in their first three games.

In the company of Kohli, du Plessis added 125 runs for the opening wicket - the 47th century stand for the franchise and the second highest against Royals. While the RCB skipper was largely away from strike for most parts of the innings, he ensured the duo added more runs on the day and continued to score at a rate of almost nine per over to set up a strong base for the rest of the batters to go on the offensive at the latter stage of the innings. Interestingly, several of Royals' better fielders made some mistakes. While Dhruv Jurel and Riyan Parag misfielded balls at the boundary, Trent Boult put down a sitter. However, the dropped catch didn't prove too costly as du Plessis fell off the next ball, hitting flat to Jos Buttler at long on, despite it being a more than 70-meter shot. They even

missed a few run out chances. However, following the dismissal of du Plessis after scoring a 33-ball 44, Royals were quick to pounce on that opening, and ensured that the new batters didn't have it any easier. After serving a couple of slower balls to Glenn Maxwell, Burger cleaned him up with a faster one. Saurav Chauhan's debut wasn't too noteworthy either as he was dismissed for a six-ball nine, offering a catch to Yashasvi Jaiswal at mid wicket, where he took it off a second attempt. Cameron Green's attempt to muscle some big shots didn't yield the desired result, as he could add only five runs in six deliveries.
