Bhubaneswar Pradhan chosen to portray Kansa in Bargarh Dhandu Yatra

Bhubaneswar, December 1 (KCN): Bhubaneswar Pradhan has been selected to play the role of Kansa in the 77th edition of the world-famous open-air theater, the Dhandu Yatra.

His selection was made following an audition held at the Bargarh Biju Patnaik Town Hall on Sunday.

Four actors – Bhubaneswar Pradhan, Jagdanand Mishra, Artatran Sunani, and Sushil Meher – participated in the audition. These actors had previously secured the second to fifth positions in the 2022 audition, in which Hrishikesh Bhoi was ultimately chosen to portray Kansa.

The 77th Bargarh Dhandu Yatra will kick off on January 3, and the executive committee



has unanimously decided to cast a new actor in the role of Kansa this year. This decision follows the controversy surrounding Hrishikesh Bhoi, who has been implicated in a bribery case and has not yet been acquitted. In response, the Bargarh Dhanu Yatra Artist Coordination Committee recommended that a different artist take on the role of Kansa for this year's performance.

Bhubaneswar, Dec 1 (KCN): Prime Minister Narendra Modi attended the 59th All India Conference of Director Generals/ Inspector Generals of Police at Bhubaneswar on November 30 and December 1, 2024.

In the valedictory session, PM distributed President's Police Medals for Distinguished Service to officers of the Intelligence Bureau. In his concluding address, PM noted that wide ranging discussions had been held during the conference, on national and international dimensions of security challenges and expressed satisfaction on the counter strategies which had emerged from the discussions. During his address, PM expressed concern on the potential threats

generated on account of digital frauds, cyber-crimes and AI technology, particularly the potential of deep fake to disrupt social and familial relations. As a counter measure, he called upon the police leadership to convert the challenge into an opportunity by harnessing India's double AI power of Artificial Intelligence and 'Aspirational India'.

He expanded the mantra of SMART policing and called upon the police to become strategic, meticulous, adaptable, reliable and transparent. Appreciating the initiatives taken in urban policing, he suggested that each of the initiatives be collated and implemented entirely in 100 cities of the country. He called for the use of technology to reduce the workload of the constabulary and suggested that the Police

Station be made the focal point for resource allocation. Discussing the success of hackathons in solving some key problems, Prime Minister suggested deliberating on holding a National Police Hackathon as well. Prime Minister also highlighted the need for expanding the focus on port security and preparing a future plan of action for it.

Recalling the unparalleled contribution of Sardar Vallabhbhai Patel to Ministry of Home Affairs, PM exhorted the entire security establishment from MHA to the Police

Station level, to pay homage on his 150th birth anniversary next year, by resolving to set and achieve a goal on any aspect which would improve Police image, professionalism and capabilities. He urged the Police to modernize and realign itself with the vision of 'Viksit Bharat'. During the conference, in depth discussions were held on existing and emerging challenges to national security, including counter terrorism, left wing extremism, cyber-crime, economic security, immigration, coastal security and narco-trafficking. Deliberations were also held on emerging security concerns along the border with Bangladesh and Myanmar, trends in urban policing and strategies for countering malicious narratives. Further, a review was undertaken of implementation of newly enacted major criminal laws, initiatives and best practices in policing as also the security situation in the neighborhood. PM offered valuable insights during the proceedings and laid a roadmap for the future. The Conference was also attended by Union Home Minister, Principal Secretary to PM, National Security Advisor, Ministers of State for Home and Union Home Secretary.



Kishan Kumar's wife reveals daughter Tishaa Singh didn't die of cancer



Producer Krishan Kumar's wife Tanya Singh has claimed that their 20-year-old daughter Tishaa didn't die of cancer. She

claimed on social media that her family were "sucked into the medical trap".

Tishaa passed away aged 20 in July 2024. At

that time, reports claimed that she succumbed to cancer.

On Thursday night, Tanya posted a lengthy note on Instagram about her daughter's death. She also shared a video of some old pictures and videos of Tishaa from her childhood to the final months.

Talking about her death, she wrote in the caption: "A lot of people have been writing and asking me to tell what happened. Truth is subjective and relative to how one perceives it. When a pure, innocent soul goes through injustice due to someone

/ some other bad doings, things get complicated and confusing & suddenly it's too late!"

She talked about medical malpractice and misdiagnosis in her post and said that 'no one can escape the wrath of their Karmic deeds'.

"Having said that, my daughter TISHAA, no matter what went down, she never, not once gave in to fear or depression. She has been the bravest version of brave, the most fearless and cool 20-year-old ever, and that's what TISHAA wanted to spread to kids her age/younger/older... how to 'not' let medical

diagnosis etc scare you, coz she knew that the body is a biological being for whom immunity is key and she wanted to help spread the word through her experience of overcoming a misdiagnosis, & dealing with 'chemo SIDE EFFECTS' with BIOMEDICINE."

She said: 'truth' is that my daughter did not have 'cancer' to begin with. she had a vaccine at age 15 & 1/2 which possibly triggered an autoimmune situation, which was wrongly diagnosed (we did not know this at the time)".

Tanya added that parents

show get a second opinion for their children if they have 'lymph node swellings'.

"PLEASE make sure to get a second & third opinion before going in for a 'bone-marrow' test or a biopsy. Lymph nodes are the body's defence guards & they can also swell due to emotional trauma, etc, or due to a previous infection not treated fully. Doing Bongs wrong: Bollywood's portrayal problem



even Bengali actors portraying Bengali characters would mispronounce deliberately (case in point, Mouni Roy's character in Reema Kagti's Gold).

On today's Cinematic Saturday, we try and understand how there has been a systematic stereotyping of Bengalis in Hindi cinema that is continuing in recent times as well. Celebrated director Srijit Mukherji also shares his input and how this can be avoided and Bengalis can be portrayed with authenticity.

Bengali is the second most-spoken language of India after Hindi, with 8.3 percent of the population speaking it across the nation (according to the 2011 Census). And yet, there are so many films that come out each year with Bengalis being misrepresented, or worse,

stereotyped. There have been two recent releases that have a Bengali connection. While on one hand, there is Anees Bazmee's Bhool Bhulaiyaa 3 and on the other, there is Shoojit Sircar's I Want To Talk.

Both are starkly different in the portrayal of Bengali characters - one falling victim to stereotyping and the other getting it perfectly right.

The former features several characters who are Bengalis. And one of the most the jarring things that any Bengali would probably catch first is Vijay Raaz's introductory dialogue where he says that he is the king and the one on the wheelchair (played by Bengali actor Kanchan Mullick) is his 'angrakshak'.

Now, one may argue that it was done to make the non-Bengalis understand

what was being said on screen. But, with a rising population of Indians consuming regional films, as well as TV shows in a completely different language like Korean, would subtitles not have sufficed?

In fact, this is also a problem that noted director Srijit Mukherji, known for Bengali films like Baishe Shrabe and, more recently, Tekka and Hindi films like Sherdil: The Pilbit Saga and Shabaash Mithu, finds while watching some Hindi films.

"I feel pretty offended when I see stereotyping, especially the diction. The diction is horrible in many big-budget films and series. And, I refuse to believe that, despite spending so much, a language coach or diction coach can't be employed by big production houses. It's really very sad," he

lamented while speaking exclusively with India Today Digital.

It is also true for films like Rocky Aur Rani Kii Prem Kahaani. One doesn't need to put a picture of Rabindranath Thakur to show a Bengali family, do they? As one might argue that the film shows several stereotypes, only to debunk them later and that it also employed actual Bengali actors as Rani's parents, the problem with diction can't be overlooked. In fact, Rani says 'khela hobe' in the film, a phrase that became Bengal's slogan during elections. It's just two words, and yet the pronunciation is starkly off.

That's not all the problem - the attempted change of every 'A' to 'O' and saying the same things in Hindi to make it so-called Bengali - is way too common in Bollywood. There are also cases, like in Reema Kagti's Gold, where a Bengali character, Monobina, played by an actual Bengali - Mouni Roy, mispronounces Hindi because Bengalis can't speak Hindi after all. In fact, she further stereotypes by saying, "Kaisa Bengali hai tum. Fish khata hai fir bhi akol nahi hai (What kind of Bengali are you? You eat fish and still aren't intelligent)?", not just in the funniest of accents but also insinuating that all Bengalis eat fish. When this woman beckons her husband, he comes by saying 'Dugga Dugga', something Bengalis say to wish people a safe journey. We are sure that a Bengali diction coach would have come in handy, and our leading lady could have done better.

Vivad Se Vishwas Scheme, 2024: Some FAQs Part 1

The Direct Tax Vivad Se Vishwas Scheme, 2024 was announced on 23rd July 2024 in the Union Budget 2024 and has come into force from 1st October 2024 vide Notification No. 103/2024 dated 19th September 2024 for settling appeals. The salient features of the scheme are discussed in this Article.

1. What disputes can be settled under the scheme?

As per Section 89 of the Direct Tax Vivad Se Vishwas Scheme, 2024 (VSVS) ITAT, High Court and Supreme Court or writ petition or SLP pending before High Court or Supreme Court as on 22.07.2024.

(b) Where an objection before DRP is filed and DRP has not issued any direction on or before 22.07.2024

(c) Where a direction is issued by DRP u/s 144C(5) but the A.O has not completed the assessment U/s 144C(13) on or before 22.07.2024

(d) Revision petition pending before CIT u/s 264 on 22.07.2024.

2. Which disputes have been specifically excluded from the scheme?

As per Section 96 of VSVS, 2024 following disputes have been specifically excluded from the scheme:

a) Assessment Year for which assessment is made pursuant to search u/s 143(3), 144, 147, 153A or 153C on the basis of search initiated u/s 132 or 132A

b) Assessment year in respect of which prosecution has been instituted on or before date of

filings declaration

c) Tax arrears relating to undisclosed income from a source located outside India or undisclosed asset located outside India

d) Tax arrears relating to assessment or reassessment made on the basis of information received under agreement referred to in section 90 or section 90A

e) Assessee in respect of whom there is any detention order under Conservation of Foreign Exchange and Prevention of Smuggling Activities Act, 1974 (COFEPOSA)

f) Assessee notified u/s 3 of Special Court (Trial of Offences relating to Transactions in Securities) Act, 1992.

g) Any person in respect of whom prosecution for any offence punishable under the provisions of the Unlawful Activities (Prevention) Act, 1967, the Narcotic Drugs and Psychotropic Substances Act, 1985, the Prohibition of Benami Property Transactions Act, 1988, the Prevention of Corruption Act, 1988, the Prevention of Money Laundering Act, 2002 has been instituted on or before the filing of the declaration or such person has been convicted of any such offence punishable under any of these Acts.

h) Any person in respect of whom prosecution has been initiated by an Income-tax authority for any offence punishable under the provisions of the Bharatiya Nyaya Sanhita, 2023 or for the purpose of enforcement of any civil liability under any law for the time being in force, on or before the filing of the declaration or such person has been convicted of any such offence consequent to the prosecution initiated by an Income-tax authority.

3. How much amount is payable by the declarant?

As per Section 90 of the VSVS, 2024, amount payable by the declarant is as under:

i) Where assessee is an appellant after 31.01.2020 but on or before 22.07.2024 and desires to settle tax arrears i.e. disputed tax and interest and penalty on such disputed tax, he will be required to pay entire disputed tax (including surcharge and cess). On payment of such tax, the interest and penalty will be waived provided the payment is made on or before 31.12.2024.

In case the payment is made on or after 01.01.2025 the assessee shall be required to make an additional payment of 10% of the disputed tax.

However, if the appeal is filed by Department or the Department has lost an issue, assessee is required to pay 50% of disputed tax (including surcharge and cess). If payment is made on or before 31.12.2024 and if payment is made on or after 01.01.2025, 55% of the disputed tax is to be paid. On payment of the disputed tax, interest and penalty would be waived.

ii) Where assessee is an appellant before 01.02.2020 at the same appellate forum and desires to settle tax arrears i.e. disputed tax and interest and penalty on such disputed tax, he will be required to pay 110% of the disputed tax (including surcharge and cess). On payment of such disputed tax, interest and penalty will be waived provided the payment is made on or before 31.12.2024. In case the payment is made on or after 01.01.2025 the assessee shall be required to pay 125% of the disputed tax.

However, if the appeal is filed by Department or in case the Department has lost an issue, assessee is required to pay 55% of disputed tax if payment is made on or before 31.12.2024 and if payment is made on or after 01.01.2025, 62.5% of the disputed tax is to be paid. On payment of the disputed tax, interest and penalty would be waived.

iii) Where the assessee is an appellant after 31.01.2020 but on or before 22.07.2024 and desires to settle appeals relating to interest, fees or penalty he will be required to pay 25% of interest, fees or penalty as the case may be provided the payment is made on or before 31.12.2024.

In case the payment is made on or after 01.01.2025 the assessee shall be required to pay 30% of the interest, fees or penalty as the case may be, in place of 25%. On payment of interest, fees or penalty, the balance fees, interest or penalty as the case may be, shall be waived.

iv) Where assessee is an appellant before 01.02.2020 at the same appellate forum and desires to settle appeals relating to interest, fees or penalty he will be required to pay 30% of interest, fees or penalty as the case may be provided the payment is made on or before 31.12.2024.

In case the payment is made on or after 01.01.2025 the assessee shall be required to pay 35% of the interest, fees or penalty as the case may be, in place of 30%. On payment of interest, fees or penalty, the balance fees, interest or penalty as the case may be, shall be waived.

Where the subject matter of appeal of the assessee is covered in favour of assessee by the order of a higher appellate authority in assessee's own case for any year, the assessee is required to pay only 50%

Also refer FAQ 32 of Circular No. 12 of 2024 dated 15.10.2024.

CBTD vide circular no. 12 of 2024 dated 15.10.2024 in FAQ No. 3 has clarified as under: Where an appeal/ writ petitions/ SLP is filed by the income tax authority on any disputed issue, the amount payable shall be 50% of the amount payable specified in the Table above. Where an appellant before Commissioner (Appeals)/ Jt CIT (Appeals) or objections are filed before the Dispute Resolution Panel on any issue on which he has already got a decision in his favour from ITAT (where decision on such issue is not reversed by High Court or Supreme Court) or the High Court (where the decision on such is not reversed by the Supreme Court), the amount payable shall be 50% of the amount payable as specified in the Table above.

Banda o sahib o mohtaj o ghani ek hue,

Teri sarkar mein pohanche to sabhi ek hue."

(Sultan Mahmood and his servant Ayaz stood together in the same row.

No servant remained,

nor did any master.

The servant, the king,

the needy, and the wealthy became one.

When they came into Your presence, all became equal.)

This imagery underscores Islam's emphasis on equality, where the only distinction in Allah's sight is righteousness, as stated in the Quran: "Indeed, the most noble of you in the sight of Allah is the most righteous of you." (Surah Al-Hujurat: 13).

The Rights of the Mosque

Yet, an important question arises: Are we, as believers, fulfilling the rights of our mosques and valuing their sacred role?

While the mosque provides us with tranquility and ease—clean water for ablution, lights for clarity, and carpets for comfort and during winters hot water while masjid hamaam provides comfort, warmth (A Hamam in Kashmiri refers to a heated room with limestone slabs over a hollowed floor, warmed by a fire beneath, traditionally used in mosques and shrines for warmth and ablution in

winters.)

These blessings come with the obligation to ensure their sustenance.

—how often do we consider our responsibilities toward it?

A mosque is not anyone's personal property; it is our collective heritage. Its protection, maintenance, and cleanliness are responsibilities that rest upon all of us. Here are key areas where believers can contribute:

Financial Support: Every worshiper should contribute a fixed monthly amount to the mosque, no matter how small.

Consistent donations collectively ensure the mosque's upkeep.

Maintenance and Cleanliness:

Participating in cleaning and maintaining the mosque is as important as monetary contributions.

Those who dedicate their time to administrative and

fundraising efforts deserve the community's wholehearted support.

Just as we budget for household expenses like electricity, internet, and school fees, the mosque should be part of our financial priorities.

The services we enjoy—water, electricity, and cleanliness—require resources. It is our shared duty to provide them.

A Call to Action

A mosque is not merely a place of worship but the cornerstone of faith, establishing a direct and unbroken connection between a believer and Allah. It is described as the spiritual haven, a center of learning, and a hub for unity and support. However, its upkeep often goes unnoticed, depending entirely on the contributions of the faithful.

Supporting the mosque is not limited to financial contributions.

Volunteering time and skills, organizing community events, and teaching younger generations the value

of the mosque are equally important. Together, these efforts ensure that the mosque continues to enrich the lives of future generations.

The mosque's True Beauty

Despite all these efforts, the true adornment of a mosque lies in the establishment of prayer, as emphasized by our beloved Prophet (PBUH) in the hadith: 'The beauty of a mosque is through prayer, not its structure.'

Salah is undeniably the cornerstone of faith, establishing a direct and unbroken connection between a believer and Allah. It is described as the defining characteristic of a believer, where

neglecting it equates to an act of disbelief (kufr). The importance of Salah is profoundly emphasized in the Hadith:

Sunan al-Tirmidhi (Hadith 2620):

"The covenant that distinguishes between us and them (disbelievers) is prayer; whoever neglects it has

committed disbelief."

Sunan Ibn Majah (Hadith 1079):

"Between a person and disbelief is abandoning the prayer."

The detachment of Muslims from their mosques signifies a distance from Allah's mercy. This estrangement is one of the reasons why oppressor nations have gained dominance over us. Reflecting on the condition of Muslims and their relationship with mosques, Allama Iqbal poignantly remarked:

'Masjid to bana di shab bhar mein imaan ki hararat walon ne,

Mann apna purana papi hai, barson mein namazi ban na saka.'

"Though the mosque was built overnight by the passionate believers,

Their hearts, tainted by old sins, could not become devout even after years."

This verse captures the irony of building magnificent mosques while neglecting the spiritual transformation that true devotion and prayer bring."

May Allah Almighty grant us the understanding that the mosque is not just a building but an integral part of our spiritual and communal life. May He guide us to fulfill this sacred responsibility with sincerity, enabling us to prioritize Salah, revive the essence of mosques in our daily lives, and strive for spiritual and moral transformation. Only through such efforts can we hope to regain the honor and dignity that Allah has promised to those who adhere steadfastly to His commandments. May He guide us to take this responsibility seriously and enable us to serve the mosque in every possible way.

Punjab CM Meets World Bank Team, Solicits Support to Combat Problems Faced By The State

Chandigarh (JAG MOHAN THAKEN), During a meeting with the World Bank team on Friday, Punjab Chief Minister Bhagwant Singh Mann solicited fulsome support and cooperation from the World Bank to further combat the major problems being faced by the state.

An official statement divulges that During the meeting with World Bank Country Director for India Auguste Tano Kouamé, the Chief Minister presented a strong case for financial assistance to the state.

Mann highlighted the state government's commitment to fiscal and institutional resilience besides emphasising the need for financial support to drive growth, improve public services and enhance the overall quality of life for its

citizens.

He showcased the state's strong reform agenda, focusing on fiscal prudence, improved governance and enhanced service delivery as a key factor in its quest for financial assistance.

The Chief Minister said that proposed financial assistance is expected to support Punjab's development priorities, including infrastructure development, human resource development and social welfare initiatives.

He said that with this significant development, Punjab is poised to take a major leap forward in its journey towards prosperity and growth. C M Mann said that environment is the major thrust area of the state government and it is giving top priority to conservation of Ground



water.

The Chief Minister said that the state government is reviving old water resources and trying to provide canal water to maximum part of the irrigation land thereby reducing the consumption of electricity on one hand and checking the depletion of ground water on the other hand.

He said that lining of canals, reviving of old Water courses (Khals) and other initiatives are

being taken so that farmers are able to use maximum surface water. Mann said that due to strenuous efforts of the state government in the last two years ground water level has increased by around one metre.

The Chief Minister further said that the state government has designed a program for solarisation of Agricultural pump sets adding that it will increase the income of

the farmer's manifold. He said that in five years the state government can rapidly solarize the major part of the Agricultural pump sets. Dwelling on another issue Mann said that the state government is mulling to incentivise the farmers to switch out the paddy.

The Chief Minister said that Rice is not the staple diet of Punjab but the farmers of the state are cultivating paddy to meet the needs of the entire nation. He said that there

are alternative crops such as pulses, Maize and others but need of the hour for value addition of these crops to encourage the farmers. Mann said that the state government is already mulling in various projects to save the environment.

The Chief Minister said that the state government is committed to developing Punjab as an export hub for fruits and vegetables. He said that due to hard working

and resilient farmers of the state and the fertile soil, Punjab's agricultural productivity is higher in the World and the state government is looking for crop diversification.

Auguste Tano Kouamé also acknowledged the state's potential for growth and development and expressed their willingness to support Punjab's endeavours, recognizing the importance of a strong and resilient public financial management framework.

He said that the Bank is looking for cooperation areas and Fiscal prudence, Data Sharing, Services in large cities. Auguste Tano Kouamé also admired various projects initiated by the Punjab Government and said that the Bank is willing to replicate in other parts.

Jujumura open-air jail shall be opened after the High Court's order!

Sambalpur (KCN): There will be an open-air jail in every district. The Hon'ble High Court has given important advice to the state government on the issue of prison reform. The Hon'ble High Court headed by Hon'ble Chief Justice Chakradhari Saran Singh and Justice Sabitri Rathna has also given advice to the DG of Jails on how to implement it in Odisha by studying the open-air jails in other states. Due to this, the long-proposed issue of construction of Jujumura open-air jail has come up for discussion again. Odisha's first open-air jail was proposed to be built in Jujumura block of Sambalpur district. For this, one Location in between the Sambalpur-Cuttack National Highway No. 56, from Gargadabhal to Kansar Hills, was selected. For this, preparations were made at the government level, funds were allocated and the work

process started. But why did Odisha's first proposed Jujumura open-air jail fail? At that time, many prominent people and social workers raised their voices and put pressure on the government to implement this important scheme. Even during the general elections, one or two leaders raised their voices and demanded for the construction of this open-air jail. Now, the advice of the Honorable High Court has become a challenge for the state government, and in honor of the proposal of the first open-air jail in Odisha, social worker Dr. Rajaram Sarangi reminded the government and Union Minister Dharmendra Pradhan to build it on an experimental basis at Jujumura. He also demanded that Redakhol MLA Prasanna Acharya to submit a proposal in the assembly to implement the long-standing proposed

scheme of Redakhol constituency, which does not have a district or state level institution. He further said, it is worth mentioning here that during the hearing on

Thursday, the Hon'ble Court advised the State Government to construct open-air jails in every district. The High Court also advised to create an AI-connected web-based database of all the prisoners in the State and directed to submit the details within the next week. A plan has been prepared between the Prisons Department and NIC for this. The State Government has informed the Court that it has spent Rs 2 crore in the first phase for this. After the Hon'ble High Court advised the State Government to construct open-air jails, the public is optimistic that, construction of Jujumura open-air jail, to be constructed in Odisha, will be a great success.

Kolkata, (KCN): In keeping with its proven commitment towards customers and the capability to handle multiple projects of various classes concurrently, Garden Reach Shipbuilders and Engineers (GRSE) Ltd commenced steel-cutting of an Ocean Research Vessel (ORV) that the shipyard is building for the National Centre for Polar & Ocean Research (NCPOR) today.

This important event marks the beginning of any shipbuilding process after the signing of the contract between GRSE and NCPOR, an organization under the Ministry of Earth Sciences, Government of India, on July 16, 2024.

While Dr M Ravichandran, Secretary, Ministry of Earth Sciences, graced the occasion as Chief Guest, among the others present were Cmde P R Hari, IN (Retd), Chairman and Managing Director, GRSE, Shri R K Dash, Director (Finance), GRSE, Cdr Shantanu Bose, IN (Retd.), Director (Shipbuilding), GRSE, DIG Subrato Ghosh, ICG (Retd.), Director (Personnel), GRSE, Dr. Thamban Meloth, Director,

NCPOR, Dr. M. V. Ramana Murthy, Scientist G, Mission Director, MoES, and other senior officers from NCPOR & GRSE.

The contract for the ORV is worth nearly Rs 840 crore. The ship will be 89.50-metres long and 18.80-metres wide, with a depth of 12.50-metres. It will have a gross tonnage of 5,900 Tons with a speed of 14 knots at 90% maximum continuous rating (MCR). The research vessel will be able to operate at a maximum depth of 6,000-metres.

The ORV, once delivered, will be capable of Underway Swath Multibeam as well as Geophysical Seismic surveys in coastal seas and deep waters. She will also be able to carry out Conductivity, Temperature and Depth (CTD) profiling and water sampling operations such as

biological sampling using vertical and horizontal methods through various nets.

It will also effectively carry out surface and deep-sea mooring and data buoy operations, seabed sampling using corers and grabs as well as rock dredging with chain bag dredges. She will also undertake underway atmospheric observations, surface meteorological and current measurements and collect upper air data. She will also be able to deploy and retrieve heavy test/ protocol-type equipment and submersibles such as AUVs and ROVs. Scientists will be able to carry out analytical work and data processing on board. The ship will also provide training and education to scientists and technicians.

Dr. M. Ravichandran, Secretary, Ministry of Earth Sciences (MoES), is confident that this

project of the ORV shall be a stepping stone towards the execution of more such research vessels for the Ministry of Earth Sciences.

GRSE has the necessary expertise in the field of survey vessels and has been building them for the Indian Navy for nearly four decades now. Over the last 12 months, GRSE delivered the INS Sandhayak and INS Nirdeshak, the first two Survey Vessels (Large) in a series of four such ships being built by it for the Indian Navy. These are the largest vessels of their class to be built in India. The two remaining of this class are at various stages of completion at the shipyard at the moment. GRSE is fast turning into a destination for those in search of specialized vessels. Recently, it signed a contract worth Rs 490.98 crore with DRDO's Naval Physical and Oceanographic Laboratory (NPOL) for an Acoustic Research Ship. At the moment, GRSE is working on 43 platforms, including 17 warships of four classes. These include several export orders as well as 13 hybrid ferries for the Government of West Bengal.

Political tension escalates in Odisha as Cong, BJD, BJP trade barbs over Modi's remarks

Bhubaneswar (KCN): A day after Prime Minister Narendra Modi accused opposition parties of conspiring against the country, the Congress, BJD and BJP Saturday engaged in a war of words in Odisha, each blaming the other.

Senior BJD leader and party's deputy leader in the Assembly, Prasanna Acharya, alleged that the BJP government in the state had done nothing in the last five months, except for changing the colour of buildings.

"In the last five months, the BJP government changed the names of 22 schemes that were earlier launched by the BJD government," Acharya said.

He also pointed out contradictions in the PM's stand, noting that Modi had once praised BJD and its leader Naveen Patnaik for adhering to the federal system.

"The PM himself praised Naveen Patnaik in Parliament and said the BJD government follows the federal system the most. Now, he is claiming

that the previous government had changed central schemes. Modi is changing his stand," Acharya remarked.

Referring to Modi's claim that the Centre was giving priority to Odisha, Acharya said, "He made the same claim when he visited Telangana and Maharashtra. If Odisha is a priority, then why is the coal royalty not being revised?"

He emphasised that the central assistance Odisha received over the years was its rightful due, not the PM's mercy, adding, "It is given according to the federal system."

In response, BJP leader and Revenue and Disaster Management Minister Suresh Pujari rejected Acharya's allegations.

He pointed out that Odisha had financially benefitted after Modi's amendment of the MMDR Act in 2014 and the revision of rules under the Company Act.

"The state received huge revenue from mining, and companies were forced to spend on corporate social



responsibility," Pujari said.

He also highlighted that the Modi government had allocated significantly more for the railway sector in Odisha compared to the UPA government.

"While the previous UPA government sanctioned a maximum of Rs 1,000 crore annually for the railway sector, the NDA government led by Modi has allocated around Rs 10,000 crore annually for railways in Odisha," Pujari added.

Meanwhile, Congress leader and former OPCC president Jaydev Jena accused the Prime Minister of attempting to

mislead the people of Odisha with claims of development, while the new BJP government had done little in the past five months.

He cited the deaths of three tribal women from hunger, stating, "The BJP has put Odisha on the world map for the deaths of three tribal women due to hunger in 2024."

Congress Legislature Party leader Rama Chandra Kadam demanded a special package for Odisha, similar to the ones given to Bihar and Andhra Pradesh by the NDA government.

"We will admit that Modi gives priority to Odisha if

he announces a special package for the state," Kadam said.

State Law Minister Prithiviraj Harichandan lashed out at Congress, accusing the party of becoming "anti-India."

Harichandan further claimed that Congress was "paralyzed" across the country and had lost its ability to function. "Now, Congress is trying to walk by holding the stick of small regional parties, but its nature does not change," he added.

In response to BJP's attacks, Congress' student and youth wing staged a protest on Saturday against Modi and Home Minister Amit Shah's visit to Odisha. Marching

toward the Lok Seva Bhawan, where the All India DGP/IGP Conference was taking place, the protesters raised slogans against the declining law and order situation in the state will be under control."

In response, Harichandan called the Congress protest "unfortunate," adding,

"This shows that Congress is going against the country, against development, and against the people. While Odisha is drawing attention from the entire country, they are staging demonstrations and making hateful statements against the Prime Minister and Home Minister."

Rayagada Railway Div a non-starter



that the delay was least anticipated given the fact that Union Railway Minister Ashwini Vaishnaw represents Odisha. Moreover, questions are now being raised over the continued neglect of Rayagada at a time when the saffron party is at the helm both at the Centre and the state. Nevertheless, the contentious issue has sparked widespread concern and discontent among the public. For reference, a tender for the Rayagada Railway Division was floated in August 2024, with a submission deadline of one month, with the initial phase of the project estimated at Rs 108 crore. Thirteen consulting agencies were deemed technically eligible for the tender. However, delays in the

financial bidding process had been reported, triggering public speculations over the likelihood of intentional postponement of the project. In political circles the delay fuelled allegations that the Union government is repeatedly yielding to pressures from the Andhra Pradesh government. There are also talks that work on the Rayagada Railway Division ahead of the formation of the SCoR Zone in Visakhapatnam, could diminish the prominence of the latter. Currently, the Visakhapatnam Division oversees 255 km of Odisha's railway network. Upon establishment, the Rayagada Division would take over jurisdiction of railway tracks and stations in districts such

as Rayagada, Gajapati, Koraput, Nabarangpur, Malkangiri, and Nuapada. Nevertheless, the BJP state leadership has allegedly gone silent over the establishment of a railway division at Rayagada. Observers pointed out that the dominance of Congress in Koraput district—the MP and MLAs from the six Assembly segments are from the party—might be the reason behind the alleged neglect towards the project. Meanwhile, various organisations have demanded immediate action over the Union government's announcement of setting up the railway division in Rayagada, a region classified as underdeveloped. When contacted, Rayagada MLA Appalaswami Kadraka said, "The government's announcement was merely symbolic, aimed at gaining electoral advantage. Despite being in power both in the state and at the Centre, no tangible progress has been made."

Kolkata (PARTHA ROY): Addressing the 16th Mutual Fund Summit, focusing on Vikshit Bharat 2047 - Transitioning from Financial Inclusion to Financial Wellbeing organised Indian Chamber of Commerce (ICC) in Kolkata on 30th November 2024,

Shri Ananth Narayan Gopalakrishnan, Whole Time Member, Securities and Exchange Board of India, said "The mutual fund ecosystem has made extraordinary progress over the years, marked by a surge in unique investors from 2 crores in 2019 to over 5.1 crores today and Assets Under Management (AUM) skyrocketing from 23 lakh crores to 267 lakh crores. This incredible

growth brings with it a responsibility to preserve the ecosystem. Nonetheless, Mutual funds are inherently tied to market risks. Financial inclusion in capital markets differs from banking. Investors must approach with eyes wide open, understanding there are no guarantees, only opportunities coupled with risks. This is the unique nature of mutual funds: they promise returns but demand a commitment to understanding volatility. Despite recent market volatility, mutual funds continue to deliver robust returns—close to 15% CAGR over five years, with indices providing 10-12% in FY24 despite fluctuations. The findings—such as 93% of F&O traders losing money—underscore the importance of informed



participation. As an ecosystem, we must address inefficiencies like redemption delays. With technology enabling near-instantaneous transfers, the shift to T+0 settlement must be prioritised. Faster processes will instil confidence among investors and enhance the overall experience. The mutual fund ecosystem's growth is undeniable, but this progress demands caution. Bad actors or oversight lapses could harm the very tree yielding golden fruits. As custodians of this ecosystem, we must embrace analytics, transparency and collaboration to protect its integrity."

Speaking on advancing financial inclusion and financial literacy in India, Venkat Nageswar Chalasani, Chief Executive, Association of Mutual Funds in India, said, "Despite fluctuations in global markets, the Indian economy has demonstrated stability and promise. All indicators, including reports from global rating agencies and institutions like the World Bank,

project India as a leading driver of growth. However, achieving the vision of becoming a developed nation by 2047 is not just the dream of our Prime Minister but a shared responsibility for all of us. To truly realise this vision, financial prosperity must reach every corner of the country. This brings us to the importance of financial literacy. While India boasts an overall literacy rate of 75%, financial literacy lags significantly at just 27%, as per NCFB surveys. Bridging this gap is crucial to ensuring that all citizens can benefit from the opportunities our economy offers. Pakistan ready to accept hybrid Champions Trophy, seeks uniform ICC policy: Sources

New Delhi, (KCN): The Pakistan Cricket Board (PCB) is reportedly ready to accept the hybrid model for the Champions Trophy if the ICC implements the same model across all ICC events until 2031. With around three months left for the tournament, the schedule is yet to be announced.

The Pakistan Cricket Board (PCB) is willing to accept a hybrid model for next year's Champions Trophy if the International Cricket Council (ICC) implements the same policy for all ICC events going till 2031. The schedule for the

upcoming 50-over tournament is yet to be announced with less than three months left amidst PCB and its chairman Mohsin Naqvi's stance that Pakistan would not accept the Hybrid model.

After India refused to go to Pakistan for the Champions Trophy due to security concerns, PCB was adamant not to move any of the matches out of the country. Thereafter, the ICC proposed the idea of a hybrid model, to which Pakistan responded that it was off the

table. The PCB chief had also said that India not playing cricket in Pakistan is unacceptable.

The ICC board meeting, attended by representatives from all 12 full members, three associate members, and the ICC chair, concluded without reaching a consensus. However, the anticipated agreement from the PCB signalled a potential resolution. During this while, the PCB chairman also met Mubashir Usmani, the Emirates Cricket Board head, in Dubai. Usmani serves as the chairman



of the ICC's Associate Members Committee. Sources reported that Naqvi assured the situation in Pakistan remains stable, and all



teams participating in the mega-event will receive state-level security. As reported earlier, the PCB had set certain

team, including group stage games, semi-finals, and the final (if qualified), will be held in Dubai. This decision follows the Indian government's stance against sending its team to Pakistan.

Backup Hosting in Lahore

If India doesn't advance beyond the group stages, Pakistan will host the semi-finals and the final in Lahore.

Neutral Venues for ICC Tournaments

The Pakistan Cricket Board (PCB) has proposed that if India hosts any future ICC

events, Pakistan's matches should be held at neutral venues instead of in India. This suggestion stems from the ongoing political tensions between the two nations, which have impacted their bilateral cricketing ties and led to similar arrangements in the past for other tournaments.

The Champions Trophy is scheduled to take place from February 19 to March 9, 2025. Karachi, Lahore and Rawalpindi are the hosts, with the grounds in Pakistan being renovated.

Pakistan are the defending champions after they won the title back in 2017.

After Perth debacle, Australia suffer another major blow to WTC final hopes



New Delhi: Australia have suffered a major blow to their World Test Championship (WTC) final hopes as they dropped one more spot in the WTC standings after South Africa's win over Sri Lanka.

Australia have dropped further down in the World Test Championship (WTC) standings ahead of their second Test against India at the Adelaide Test. Notably, after being hammered by 295 runs in

the series opener in Perth, the Kangaroos lost their top spot in the standings. The Pat Cummins-led side has further dropped to the third spot in the standings after South Africa's victory over Sri Lanka in first Test. The Proteas emerged victorious by 233 runs at Kingsmead, Durban as Marco Jansen registered his career-best match figures of 12/86. Following their win, South Africa have

climbed up three spots to be at the second spot in the WTC standings. The Temba Bavuma-led side is having a points percentage of 59.26% with five wins from nine matches. Australia has dropped down to the third spot with eight wins from 13 matches having points percentage of 57.69%. Sri Lanka have also dropped two spots below having five wins from ten matches with a 50% points percentage. India remain on top having

points percentage of 61.11% with nine wins and a draw from 15 games. New Zealand continue to occupy the fourth spot with six wins from 11 matches with a points percentage of 54.55.

The WTC table is likely to experience several shifts in the next few months with all teams playing Test cricket. India will take on Australia in the second Test from December 6 while South Africa and Sri Lanka will lock horns in the second game from December 5. Meanwhile, England, who're currently at the sixth spot with nine wins from 19 matches, could rise higher if they manage to beat New Zealand in the ongoing first Test between the two countries. On the other hand, Pakistan (7th), West Indies (8th) and Bangladesh (9th) continue to occupy the last three spots in the table.

Harbhajan Singh highlights R Ashwin's age factor after Sundar's selection in Perth



New Delhi: Former India cricketer Harbhajan Singh has shared his thoughts on India selecting Washington Sundar over Ravichandran Ashwin in ongoing Border Gavaskar Trophy.

Former India cricketer Harbhajan Singh feels India are planning for the future with their selection of Washington Sundar over premier spinner Ravichandran Ashwin. Notably, India rested their senior spinners Ashwin and Ravindra Jadeja and picked Sundar over him in the first Test of the ongoing series against Australia.

Sundar scored 33 runs across two innings and picked two wickets in 17 overs. He recently made his comeback to Test cricket after over three years and picked an 11-wicket haul against New Zealand on his comeback albeit in a losing cause. With

Sundar outperforming both Jadeja and Ashwin with the ball, he was preferred over the senior duo in Perth.

"I think that's what their (team management and selectors') long term plan is. Ravichandran Ashwin has done a phenomenal job playing for India in taking all those wickets in his career," Harbhajan told PTI in an exclusive interview.

He further said that Ashwin is aging and hence the team

management is preparing him for the future once Ashwin hangs up his boots.


"But now that he is at that stage, at the age of 38, so that's why they have kept Washington Sundar with them (for) whenever R Ashwin will retire. The team thinks that they have to prepare Washington, so I think they are working on the same path," he added.

The second Test of the series will be played in Adelaide where Ashwin

bowed phenomenally well on the last tour. The off spinner was India's best bowler at the venue during the 2020-21 series as he scalped five wickets across two innings including a 4/55 in the first innings. He managed to get big scalps of Steve Smith and Travis Head helping India take a 53-run lead.

Hence, the team management will face a huge conundrum in the second Test whether to tinker with the winning combination or giving Ashwin a chance at the venue where he loves to bowl. The 38-year-old averages 30.43 at Adelaide with 16 wickets from three matches. Hence, it remains to be seen whether Ashwin will get a chance on the basis of his past laurels or will Sundar continue to be ahead of him in the pecking order.

When conditions are tough, we need to be better - Shukri Conrad



New Delhi: Maybe South Africa had too many runs to play with, and thus struggled to keep their bowling radar as sharp as it might have been. Maybe the Sri Lankans remembered how to play in these conditions. Maybe the wind swinging from southerly to northerly for the first time in the match, flattening the pitch, was the thing. Whatever else it was, the completion of South Africa's win in the first men's Test at Kingsmead on Saturday - by 233 runs with more than four sessions to spare - was hard work. In a match in which four wickets fell inside the first 20 overs, and 19 went down on the second day, to wait 17 minutes short of two hours for the first of the last five to tumble, and another two hours for the next to go, was like waiting for Godot. Happily for the South Africans and their supporters, and unlike

Godot, the other three did come. And quickly. They fell in the space of 34 deliveries after lunch. Marco Jansen nailed Asitha Fernando's middle and leg stumps to seal victory, which earned him match figures of 11/86 - the second-best at this ground after Clarrie Grimmett's 13/173 for Australia in February and March 1936. That makes them the best by a fast bowler here.

And good enough for Jansen to crack the nod for player-of-the-match. Fair enough: we don't see 11/86 every day. But the key performance was delivered by Temba Bavuma. Not his 113 in the second innings, by which time the result was almost assured. Rather, Bavuma's 70 in the first innings, which started when South Africa were 14/2 on their way to 80/4 and helped nurse them to a total of 191, turned the

match around. At a press conference on Saturday, Shukri Conrad concurred: "Temba is at his best when backs are against the wall and he needs to stand up. He was exceptional in this match. That 70 went a long way to giving us something respectable to bowl at."

This was the first time in Bavuma's 60 Tests, encompassing 103 innings, that he has passed 50 in both of his trips to the crease. That wasn't lost on Conrad: "I quietly whispered to him yesterday evening that I thought this was his best hundred. I thought this was his best Test he's played, given what's gone before. He's come off a long layoff [to recover from an elbow injury sustained on October 4]. And the way he's battled through stuff epitomises Temba. That is what we want to see in the side." Conrad saw more of the same quality in Wiaan Mulder, who volunteered

to bat at No. 3 in the second innings - he normally bats at No. 7 - despite having broken a finger in the first innings. Mulder's logic was that while his injury precluded him from playing the cross-bat strokes expected of the middle order, it didn't stop him from keeping his bat straight - the top order mantra. "Wiaan suggesting that he walk in early because he still wanted to

contribute, that is what I want to build this team around; that mental and sometimes physical toughness we need to go through. Tristan Stubbs' contribution [of 122 in the second innings] as well. Marco was brilliant, but Temba was super special."

Stubbs' and Bavuma's centuries brought to eight the number of hundreds South Africa's players have scored in the team's eight Tests this year. That's the same number of tons as they made in the 21 Tests they played in the previous three years.

Bowling, particularly fast bowling, is often held up as South Africa's key strength. Were the batters catching up?

"There's a lot to be said for confidence and feeding of each other," Conrad said. "The group gains confidence from that, and there's a lot of talk among them around the know-how and how to go about the processes. There's a lot of sharing of knowledge, not from us as coaches necessarily but among the players' peers. There's also a lot to be said for knowing that when conditions are good, we have the ability to get hundreds. It's really satisfying to know that."

As much as you tell the guys, 'Listen, we've got to do the business, and this and that, and stay disciplined, et cetera, it creeps in. That's why I enjoyed the toil of today. It will be a good lesson for us to learn when we go to Gqeberha, for the rest of the summer, and for the growth of this team. We often talk of references, and I think today will be a great reference in that regard."

That was central to Conrad's overall message to his team: "When the conditions are tough, we need to be better. We can't just roll over and fold like a pack of cards, like we've had the habit of doing."
