Compensation will be paid to insured farmers for the entire sum insured based on the loss.

# International Research Initiated for the Conservation of Horseshoe Crabs by Global Scientists

•Dr. Siddhartha Pati from India joins 18 scientists from different countries.

•Survey conducted at 52 sites across 11 countries, including Odisha.

**Balasore, 22/12 (Krushna Kumar Mahanty):** A new international research initiative has been launched to provide the first genetic baseline data to evaluate the conservation status of the Asian Horseshoe Crab (*Limulus*). This significant study aims to assess the genetic diversity and population structure of the species and guide conservation efforts.

The findings of this research will be published in the journal Conservation Letters, making the study's insights publicly available. This collaborative research involves scientists from India, Japan, Singapore, Indonesia, Malaysia, China, Thailand, and Australia, among others. Representing India, Dr. Siddhartha Pati from Balasore, Odisha, played a vital role in the study.

As part of the research, surveys were conducted in Odisha, along with regions in Indonesia, Malaysia, China, Thailand, Japan, Vietnam, Bangladesh, and Singapore. Across these 11 countries, data were collected from 52 different sites. The genetic study was conducted at the National University of Singapore. The scientists extensively sampled natural habitats of three Asian Horseshoe



Crab species to understand their

vulnerabilities caused by climate change. The goal was to provide baseline information for future conservation initiatives, as this species has remained almost unchanged since before the age of dinosaurs. The study also highlights how they have survived global changes while showing their critical dependence on conservation efforts. Horseshoe crabs are considered "living fossils" that have persisted for over 400 million years, surviving despite drastic global transformations. However, they are now facing rapid decline worldwide due to anthropogenic pressures. Four species of horseshoe crabs exist

globally, with three of them found in Asia. Two of these species are observed along the coasts of India, including Odisha. This research examined the DNA and genomes of the three species—*Carcinoscorpius rotundicauda*, *Tachypleus gigas*, and *Tachypleus tridentatus*. By combining extensive geographical and genomic sampling with environmental and climatic datasets, the study successfully assessed the genetic structure and population history of these species. Dr. Siddhartha Pati, a key member of the research team, emphasized that the

study provides critical baseline data for habitat conservation efforts. He noted that the findings serve as a significant step toward ensuring the future survival of horseshoe crabs, offering guidance for preserving their natural habitats. Recognition for Contributions to Marine Life Research Dr. Siddhartha Pati has been honored with the prestigious "Biju Patnaik Wildlife Conservation Award 2024" by the State Forest, Environment, and Climate Change Department for his pioneering research on horseshoe crabs and marine biodiversity.

# Parab: Promoting spirit of brotherhood

Parab signifies festival or celebration, but more than that, it's a part of culture and heritage in Odisha, the southern part of the state in particular, where this tribal festival is organised as a gala event to showcase the splendour of local traditions.

So, when a movie is made with this title that too by the makers of Daman, a 2022 blockbuster, expectations skyrocket. An ensemble cast comprising Sidhant Mohapatra, Anu Choudhury, Chaudhury Jayprakash Das, Dipanwit Das Mohapatra, and Suryamayee Mohapatra should do the rest to get the crowd to the theatres even as the euphoria surrounding Pushpa 2 is yet to subside. The movie has somehow managed to achieve that to a certain extent.

Talking about positives, the movie, most importantly, is not a remake of films in other languages and is made in the backdrop of the ongoing border dispute



between Odisha and Andhra Pradesh. However, there is more to this fictional take by director Chinmaya Das than the warring administrations of the two states. Parab sheds light on the dispute between the Odia and Telugu communities, residing in a village bordering Odisha's Gajapati with AP's Srikakulam districts. With chest-thumping

pride of the local communities showing no signs of diminishing anytime soon, thus begins a never-ending saga of conflict between them. Sidhant and Anu, one of the most popular onscreen romantic couples a few years ago, are tasked with something different to do this time. Though playing husband and wife, their encounters as District Collectors of Gajapati

and Srikakulam add momentum to the growing tension in the plot. Choudhury Jayprakash, the accomplished actor he is, has justified his character, wearing Odia pride on his sleeve. For instance, the sequence between Jayprakash and Anu over animosity between Odia and Telugu communities will surely be etched on viewers' memory for a long time. These days, he

is synonymous with all content-driven movies made in Odisha. Dipanwit, paired opposite Suryamayee, daughter of Jayprakash's character, played his part effortlessly, especially the way he mouthed thick-Telugu-accented Odia. Distortion of Odia has been a concern in most of the mainstream movies in recent times. The makers of such movies have a lot to learn

on this count from Parab. Anyone who truly aches to see the picturesque beauty of Odisha's bordering district must watch Parab for Kartik Paramar's cinematography. The splendid wide-angle shots, captured in particular in the valleys, must be commended for their breathtaking visual appeal, offering a rare sense of scale that enhances the film's gripping narrative. Though the movie had a slow start at the box office till the filing of this report, positive word-of-mouth may bring a drastic turnaround.

On rooms for improvement, in the post-interval part, the plot fails to rescue itself from the trap of banality, as the actors, too, could not rise above the linear dialogues offered to them. However, this would register as a minor complaint, since Biswajit Paital's splendid editing makes up for the flaws. Overall, a 'thumbs up' as the team has done a decent job at the end of the day.

All the rumours I've encountered have been good and positive, which makes me hope that they are indeed true."

## Aditi Rao Hydari: 'Been told I'm fragile like glass'

Actor Aditi Rao Hydari is one of the few actors in Indian film industry who has worked with numerous maestros. She has been a Mani Ratnam heroine as well as a Sanjay Leela Bhansali heroine, both depicting a side to her that had never been explored. In SLB's 'Heeramandi', she plays Bibbo Jaan, a sweet woman whose purpose in life is beyond the walls of Heeramandi. In an exclusive chat with IndiaToday.in, Aditi spoke about being perceived as a 'delicate darling' and her looks being used as an excuse to perhaps not cast her sometimes. Speaking about how she felt almost liberated playing Bibbo Jaan, Aditi said, "I am perceived in a particular way because

of the way I look or the way I am or the parts I have played, usually the fragile, feminine, petite girl. Often people say, 'oh, she will just blow away.' Or 'oh she is like glass, if you touch, she will break.' Today, I own it and I am what I am. It is not a burden for me, but if it is for you, then you need to figure it out. Secondly, my vulnerability is my strength." Aditi then elaborated on why she feels Bhansali manages to show women with their flaws, strength and vulnerabilities alike: "I also feel it is also about directors who bring that out in an actor. To have a vision and say that there are different kinds of strengths. I'm so happy that I lived this life of Bibbo Jaan because it was literally like 'here is a girl who



is so kind, so feminine, and artistic.' She sings and dances. She is celebrated for her beauty, but beneath that, she has this simmering purpose, courage and fearlessness. I feel that fearless belief is so inspiring, and they are not mutually exclusive. You can be both. I relate to it." Aditi also spoke about

'silly' things actresses hear for any project they are offered, like 'you are too beautiful'. Responding to it, she shared, "That's so silly. It is somebody's insecurity that is speaking because it is such a silly thing to say about somebody. A person is how they look, but there is more to the person. There

are directors who create very beautiful female characters, and in this case, like Sanjay Bhansali, he doesn't look at a woman as a one-tone character. Bibbo could have been a sweet and obedient girl, but the fact that she has this arc, shows how he looks at women as complete beings." The actor also

questioned why many in the industry fail to look at an artist as an artist: "I have 100 per cent been told that you are too beautiful for this role. But I am a person. I am a sum total of many things." Aditi quipped, "Also, why is this a problem? You don't tell somebody that 'you act too well'. It doesn't make sense. But that is also being heard now, oh 'that girl is too good an actor, she will outshine the others.' It has not been told to me, but I have heard this as well. It just doesn't make sense. It means your intentions aren't pure." 'Heeramandi' is currently streaming on Netflix. It also features Manisha Koirala, Sonakshi Sinha, Sanjeeda Shaikh, Richa Chadha and Sharmin Segal in pivotal roles.



# Vivad Se Vishwas Scheme, 2024: Some FAQs Part 4

18. I f J C I T ( A p p e a l s ) / C I T ( A p p e a l s ) has given an enhancement notice, can the appellant avail the DT V S V Scheme, 2024 after including proposed enhanced incoming the total assessed income:

C B D T v i d e Circular No. 12 of 2024 dated 15.10.2024 in FAQ No. 16 has clarified as under-

Yes. Where an appeal is pending before the J C I T ( A ) / C I T ( A ) , the disputed tax is the amount that is payable by appellant if such appeal was to be decided against the appellant. This is as per the definition of 'disputed tax' in u/s 89(1)(j) of the DT V S V Scheme, 2024, Hence, where J C I T ( A ) / C I T ( A ) has given enhancement notice, the taxpayer can avail the Scheme after including proposed enhanced income in the total assessed income. Appropriate calculation of disputed tax is accordingly provided in

the relevant Schedules of Form-1.

19. W h e t h e r taxpayers can settle appeals under DT V S V Scheme, 2024 using the refunds which they are expecting from the department:

C B D T v i d e Circular No. 12 of 2024 dated 15.10.2024 in FAQ No. 17 has clarified as under-

As per section 92(2) of the Scheme, the declarant shall pay the amount determined under section 92(1) of the Scheme within a period of fifteen days of the date of receipt of the certificate and intimate the details of such payment to the Designated Authority in the prescribed form and thereupon the Designated Authority shall pass an order stating that the declarant has paid the amount. There is no provision in the Scheme allowing payment of the amount determined u/s 92(1) of the Scheme through adjustment of any refund expected

from the Department. 20. I f t a x e s a r e paid after availing the benefits of the DT V S V Scheme, 2024 and later the taxpayer decides to take refund of these taxes paid, would it be possible:

C B D T v i d e Circular no. 12 of 2024 dated 15.10.2024 in FAQ No. 18 has clarified as under-

No. Any amount paid in pursuance of a declaration made under the Scheme shall not be refundable under any circumstances as per provisions of section 94(1) of the Scheme.

21. W i l l d e l a y i n deposit of TDS/TCS be also covered under the Scheme:

C B D T v i d e Circular no. 12 of 2024 dated 15.10.2024 in FAQ No. 19 has clarified as under-

The disputed tax includes tax related to tax deducted at source (TDS) and tax collection at source (TCS) which are disputed and pending in appeal. However, if there is no dispute related to TDS or TCS and there is delay in depositing such TDS/ TCS, then the dispute pending in appeal related to interest levied due to such delay will be covered under the Scheme.

22. W h e r e assessee settles TDS appeal (against order u/s 201 of the Act) as

deductor of TDS, will credit of such tax be allowed to deductee:

C B D T v i d e Circular no. 12 of 2024 dated 15.10.2024 in FAQ No. 20 has clarified as under-

Yes. However, the credit will be allowed as on the date of settlement of dispute by the deductor and hence the interest as applicable to deductee shall apply.

23. W h e n a s s e e s e e settles his own appeal under DT V S V Scheme, 2024, will consequential relief be available to the deductor in default from liability determined under TDS order u/s 201 of the Act:

C B D T v i d e Circular no. 12 of 2024 dated 15.10.2024 in FAQ No. 21 has clarified as under-

Yes. In such a case, the deductor in default would not be required to pay the corresponding TDS amount. However, he would be required to pay the interest under sub-section (1A) of section 201 of the Act. If such levy of interest under sub-section (1A) of section 201 of the Act qualifies for DT V S V Scheme, 2024, the deductor in default can settle this disputed interest by filing up the relevant schedule of disputed interest.

24. W h e r e assessee settles TDS liability as deductor of under DT V S V Scheme,

2024(i.e. against order u/s 201), when will he get consequential relief of expenditure allowance under proviso to section 40(a)(i)/(ia) of the Act:

C B D T v i d e Circular no. 12 of 2024 dated 15.10.2024 in FAQ No. 22 has clarified as under-

In such cases, the deductor shall be entitled to get consequential relief of allowable expenditure under proviso to section 40(a)(i)/(ia) of the Act in the year in which the tax was required to be deducted, if the disallowance under section 40(a)(i)/(ia) of the Act is with respect to same issue on which order under section 201 has been issued.

However, if the assessee has already claimed deduction of the same amount under section 40(a)(i)/(ia) of the Act in subsequent year on account of recovery of TDS in such subsequent year, he shall not be entitled to consequential relief under section 40(a)(i)/(ia) of the Act on the basis of the settlement under DT V S V Scheme, 2024.

In case, in the order under section 143(3) there are other issues as well, and the appellant wants to settle the dispute with respect to order under section 143(3) of the Act as well, then the disallowance under section 40(a)(i)/(ia) of

the Act relating to the issue on which he has already settled liability under section 201 of the Act would be ignored for calculating disputed tax.

25. A trust has been denied registration u/s 12AA of the Act. Whether appeal against such order is eligible for DT V S V Scheme, 2024:

C B D T v i d e Circular no. 12 of 2024 dated 15.10.2024 in FAQ No. 23 has clarified that appeal against order of denial of registration u/s 12AA order is not eligible for DT V S V Scheme, 2024.

26. A n o r d e r has been set aside, fully or partially, to the AO. Can the taxpayer avail the DT V S V Scheme, 2024 if the set-aside matter is pending as on 22.7.2024:

C B D T v i d e Circular no. 12 of 2024 dated 15.10.2024 in FAQ No. 24 has clarified as under-

According to the Scheme, an appeal which is pending as on 22.7.2024 shall be eligible for settlement. A set-aside matter to the AO is not an appeal pending as such. Therefore, set-aside matters to the AO, whether fully set-aside or partially set-aside are not covered under the Scheme.

27. W h e r e t h e r e are two appeals filed for an assessment year in respect of the same order – one by the appellant and one by the tax department, whether the appellant can opt for

only one appeal: How would the disputed tax be computed in such a cases: C B D T v i d e Circular no. 12 of 2024 dated 15.10.2024 in FAQ No. 25 has clarified as under-

Yes. The appellant has an option to opt for settling appeal filed by him or appeal filed by the department or both. This has to be specified in the declaration to be made in Form-1. Also refer to the proviso to Rule 4 of the Direct Tax Vivad se Vishwas Rules, 2024 which is reproduced as under:- "where the appellant and the income-tax authority have both filed an appeal or writ petition or special leave petition in respect of the same order, single Form-1 shall be filed by the appellant."

Accordingly, relevant Schedules in Form-1 have to be filled out by the appellant and the disputed tax would be worked out.

28. I f a w r i t has been filed against a notice issued under section 148/ 148A of the Act and no assessment order has been passed consequent to that notice, whether such cases are eligible under the Scheme: C B D T v i d e Circular no. 12 of 2024 dated 15.10.2024 in FAQ No. 26 has clarified as under-

The income in such cases is yet to be determined. Therefore, the disputed tax is not ascertainable. Thus, the taxpayer would not be

eligible for the Scheme in such cases.

# Education of refugee children on the margins

*More than half of the world's refugee children are under the age of 18 and are living in very difficult conditions. Most of them have little hope of returning home. The world is grappling with various kinds of crises. Here the issue of education of refugee children cannot be ignored.*

A recent report released by the International Rescue Committee says that about two-thirds of Ukrainian children have been forced to leave their homes since the war began in Ukraine and Russia in February 2022. According to an estimate, four million children in Ukraine require humanitarian aid and more than 1,300 schools have been destroyed. Similar conditions are also seen in some regions of Russia, confirming that childhood is in crisis in both countries after the war. According to an estimate, about 224 million children in the world affected by crises need educational support, including more than 72 million children who cannot go to school. Those who can continue learning face many obstacles in getting quality education.

Similarly, a global study released in the year 2023 has found that the number of children in crisis requiring quality education is increasing. The study also shows that the problem is not only of

access, but also of quality. More than half of the children in crisis are not able to achieve even minimum proficiency in education. This study talks about inclusive, quality education for all. The study highlights that quality education is important to ensure better learning outcomes in crises. At the same time, there is a need to fill data gaps on children in crisis who urgently need quality education as a global good for collective action. However, efforts in this direction are not being made as much as they should be.

A report released by the United Nations Refugee Agency (UNHCR) says that of the 7.1 million school-age refugee children, 3.7 million (more than half) do not attend school. The report, titled Stepping Up: Refugee Education in Crisis, shows that as refugee children grow older, it becomes harder to overcome the barriers preventing them from accessing education. Only 63 percent of refugee children attend primary school, compared

to 91 percent globally. 84 percent of adolescents worldwide receive secondary education, while only 24 percent of refugees have this opportunity. UNHCR says school is where refugees get a second chance. Refugees are being failed by not being given the opportunity to develop the skills and knowledge necessary to invest in their future, which should not be the case. The report says that refugees should be integrated into the national education system rather than being allowed to attend informal parallel schools and be allowed to follow a formal, recognised curriculum through pre-primary, primary and secondary school. This would lead to recognised qualifications that could be a springboard for them to university or higher vocational training.

Even if refugee adolescents overcome obstacles and reach secondary school, only 3 percent are lucky enough to receive some form of higher education. This is

much lower than the global figure of 37 percent. The issue of education for refugee children around the world is very urgent. By the end of 2018, there were more than 25.9 million refugees worldwide, of which 20.4 million were under the care of UNHCR. Nearly half of them were under the age of 18 and millions had been living in difficult conditions for a long time with little hope of returning home. At the same time, a new report by the United Nations shows startling figures that the number of crisis-affected school-age children who need educational support is increasing.

According to this report, the number of needy children has increased from 75 million in 2016 to 222 million now. The report says that out of these more than 220 million boys and girls, 78.2 million children are out of school for education in emergency and long-standing crisis-affected areas. About 120 million children are

not able to acquire minimum skills in mathematics or reading despite attending school. Only one out of every 10 children suffering from the effects of crises is able to meet the reality proficiency standards at the primary or secondary level. Violent conflicts, displacement and climate disruptions in crisis-affected areas are snatching away their dreams for the future.

As per the analysis of the report, 84 percent of children deprived of school are living in areas affected by long-standing crises. These include Afghanistan, Democratic Republic of Congo, Ethiopia, Mali, Nigeria, Pakistan, Somalia, South Sudan, Sudan and Yemen, among others. The UN says that the needs have never been so huge and so immediate. Due to COVID, the loss of education has been more in the poorest families. Also, those communities have also been affected, which were already lagging behind in education. Both these categories generally

include children living in crisis-affected areas. The UN says that the basic rights of crisis-affected children must be protected at all costs. These include the right to equitable, inclusive and quality education. All have to make efforts to keep education within the reach of every child everywhere.

The Education Can Not Wait (ECW) report says that only 25 million children in crisis-affected countries are in school and achieving minimum proficiency levels. The rate of out-of-school children among the forcibly displaced populations in these countries remains worryingly high, rising to around 58 percent for school-aged children. Around 14.5 million children have functional difficulties and are not attending school. About 11 million of these are concentrated in high-intensity crises. Access to secondary education is inadequate in these areas, with around a third of lower secondary school-aged children out of school. Almost half of the upper secondary school-

aged children are unable to access education.

It is estimated that at least 25 million crisis children are left out of inter-agency schemes and appeals by the end of the expected period from three years of age to the completion of upper secondary education, representing around 9.4 percent of the global total. Comparative analysis of crisis-hit countries in sub-Saharan Africa suggests that learning for children aged 7 to 14 years may be about six times slower on average in countries affected by frequent natural disasters than in countries without them. At the same time, there is a relationship between the risk posed by climate change and the severity of the crisis. Globally, about 83 percent of children who do not go to school in emergencies and about 75 percent of children who go to school but are deprived of education live in countries whose climate change risk index is higher than the global average value of 6.4.

In fact, children's education is most affected during times of crisis. Education is suspended first during a crisis and restored last. Some things have to be kept in mind to make children better during times of crisis. Among these, it is important to maintain the education and

welfare of children. Children affected by the crisis will have to be given education assistance. Education systems need more resources, but they receive less than three percent of humanitarian aid. This has to be increased. The lack of teaching and staff in education systems has to be met. Data gaps cause difficulty in decision making and coordination challenges. These have to be overcome. Children get protection from school during times of crisis. Along with this, they also get life-saving food, water, health care and sanitation facilities. During this time, children will also have to be given psychological help. But that is not sufficient. During this time, psychological help will also have to be provided to the children. Serious action will have to be taken to solve their problems. Those whose childhood is in trouble will definitely have to be brought out.

“We strongly demand you to direct the Union Government to save the life of farmer leader Jagjit Singh Dallewal, stop repression and tear gas shelling on farmers marching to Delhi, release all the farmers put in Luxer Jail of Gatam

Buddha Nagar, withdraw the falsely implicated charges including attempt to murder on them and take stringent action against the Police Commissioner Laxmi Singh and others responsible for the conspiracy, withdraw the National Agriculture Market Policy, Digital Agriculture Mission and the National Cooperation Policy and immediately hold discussions with all the farmer organisations on struggle and accept the genuine long pending demands of farmers on MSP, loan waiver, privatization of electricity, and implementation of LARR Act 2013.” SKM memorandum states that they strongly protest against the NDA 3 led Union Government for not adhering to democratic principles of governance and hold discussions with all the farmers' organisations and platforms who are struggling for the genuine demands. The farmers’



union has reminded that even the Supreme Court had asked for holding consultations with the farmers. SKM has given a call to the farmers to organize protest on 23rd December 2024 in all districts across the country and stated that the NDA2 Government had shamelessly violated the agreement signed with

Parliament on 16, 17, 18 July 2024 just after the NDA3 Government took office after the 18th Lok Sabha election. Farmers organized a protest against the corporate control on agriculture across the country on 9th August 2024. SKM along with Platforms of Central Trade Unions and Agricultural Workers Unions conducted massive worker-farmer protest demonstrations in more than 500 districts participated by nearly ten lakh people and submitted a memorandum to you through the district collectors on 26th November 2024. The Farmers’ Union, showing its resentment, stated that it is highly unfortunate that the Prime Minister, Shri. Narndra Modi is not ready to hold discussions with farmer organisations on struggles. Instead, consistent efforts are there to brutally suppress the struggles of farmers at Shambu and Khanuri borders of Punjab and

Noida- Greater Noida in Uttar Pradesh by using tear gas shelling, rubber bullets, water cannons and putting hundreds of farmers in jail for holding peaceful demonstrations and Dharna. SKM divulged that in the Gautam Buddha Nagar, the FIR No.0538 dated 4th December 2024 reveals that the Police Commissionerate has implicated 112 farmers on false charges of section 109 of Baratiya Nagraik Nyay Samhita for attempt to murder of a Police Sub Inspector one Rajiv Kumar and stop the Metro Train which are baseless. The farmers are in jail for the last 21 days. Showing concern over the ‘New National Agriculture Market Policy’(NNAMP), SKM stated that the new policy is a part of the strategy of the corporate agenda to permit backdoor resurrection of the three farm laws. The conscious efforts in the last two years to thwart procurement in APMC

markets in Punjab and Haryana, dismantle FCI by promoting cash transfer on food subsidy, reduction of food subsidy by Rs. 60,470 Cr. and fertiliser subsidy by Rs. 62,445 Cr. in the last three consecutive years are corporate attacks on the existing system of limited MSP and Food security of the country. The Farmers’ Union alleged that the corporate forces are challenging the working people of India and the Union Government led by Prime Minister Narendra Modi is serving the corporate interests only. Requesting to intervene, the SKM urged the President, “We hope, as the head of the Government of India, you will take serious note of the genuine demands raised in this representation by the farmers of this country and will ensure adequate, immediate action on them.” Commenting over the farmers’ issues, the SKM

leader and National Vice-President of All India Kisan Sabha, Dr. Indrajeet Singh told the Ground Post that the 23rd December call for protest is against the backdoor entry of regressive policy as well as extremely serious health condition of Dallewal ji causing concern of the people in Punjab, Haryana and elsewhere. He added that a new situation has arisen with the release of draft of National Policy Framework of Agriculture Marketing which is looked upon as a revival of the three farm laws since repealed as a result of prolonged historical struggle of farmers and this is absolutely unacceptable and it will have to be explained to the farmers and other stakeholders in terms of exclusion an overwhelming majority of the small and marginal farmers will have to face rendered pauperisation.

Adv. Narayan Jain, National President of AIFTP pointed out that Delhi High Court in the case of Naveen Kumar Agarwal vs CBDT TS /913/HC 2024 has asked the CBDT to consider the matter to allow VSV benefit to taxpayers in cases where assessment was completed before 23rd July, 2024 and the time for filing appeal is not expired on 23rd July 2024. S.M. Surana Chairman of Direct Tax Representation Committee said that there are many cases where orders have been passed by different authorities before 23rd July 2023 and normal time for filing of the appeal did not expire. The assessee's were contemplating to file the appeal. Hower after announcement of the scheme they did not prefer appeal since in the earlier scheme there was provision that if the time for filing of appeal has not expired the assessee can avail the scheme. However, on announcement of the scheme the said provisions as existed earlier was missing. Now the CBDT should urgently allow the same.

## No action yet on illegal radio towers



**Mahakalapara (KCN):** Illegal radio towers in villages under this block in Kendrapara district are being used to alert fishermen catching fish in prohibited zone of Gahirmatha Marine Sanctuary about any impending raids, thereby threatening the survival of Olive Ridley turtles. Illegal fishing in the restricted zone of Gahirmatha leads the rare sea turtles to get caught in trawler and gill nets and lose their lives prematurely. The fishermen, on receiving the message, give slip to the Forest personnel during raids and escape. The Forest officials have registered cases after reports appeared in media but the towers remain untouched and have not yet been dismantled. The Gahirmatha Marine

Sanctuary under this block has been declared a restricted zone for the protection of rare sea turtles. Fishing activities using trawlers, boats, and other equipment have been banned from November 1, 2024, to May 2025. However, several trawler operators and fishermen in villages such as Tantiapal, Ratapanka, Sasanpeta, Narsinghpur, and Suniti have installed more than 20 Very High Frequency (VHF) radio towers fitted to bamboo poles on the rooftops of houses of fishermen and trawler drivers. These towers allow them to secretly communicate with their kin and close friends while fishing in the sea. A report highlighting the dangers these illegal towers pose to Olive Ridley turtles was

recently published in a premier vernacular daily, sparking action by the Forest Department. This has raised concerns on internal coastal security. Operators reportedly use the devices to inform the fishermen and trawler drivers of patrol teams' movements, allowing them to flee the restricted zones before the enforcement teams arrive. As a result, Forest Department patrol teams often return empty-handed from Gahirmatha. Sashanka Kumar Mandal, a traditional fisherman from Tantiapal, expressing frustration said, "While we depend on small dinghies for fishing to sustain our livelihood, the Forest department harasses us. Meanwhile, trawler owners employ illegal tactics to fish in restricted

areas with impunity." He alleged that trawler owners have installed VHF towers, which help the fishermen and trawler drivers to escape after getting alerted about impending raids and despite their illegal operation running for years, authorities like the forest range office, Tantiapal marine police, district police, and intelligence agencies have failed to take any significant action. This negligence and lack of action have emboldened hundreds of trawlers from places like Balasore, Balamangadi, Bhadrak, Dhamra, Kasafal, Digba, and even West Bengal to dominate the sanctuary areas. They are accused of exploiting marine resources, catching high-value fish, and becoming rich overnight leaving conservation efforts in jeopardy.


## SPCB holds public hearing on environment clearance

**Jajpur (KCN):** The Odisha State Pollution Control Board (SPCB) held a public hearing for environmental clearance on the proposed expansion project of Nilachal Ispat Nigam Limited (NINL) in Jajpur district. The proposed expansion will increase NINL's production capacity from 0.981 million tonne per annum (MTPA) to 9.5 MTPA without additional land requirements. Over 225 people, including some opposing NINL's proposed expansion project, gave

their opinion at the public hearing for the environmental clearance held by SPCB Friday. "Around 225 people have given their opinion on the NINL's expansion project. We will send the people's views to the Ministry of Forest, Environment and Climate Change," said the Regional Officer, SPCB, Kalinga Nagar, Madan Mohan Sahu. Asked about the disturbance during the public hearing, Additional District Magistrate (ADM), Kalinga Nagar, Sapan Kumar Nanda, who

presided over the public hearing, said, "The people have given their opinion in the public hearing." The public hearing was also attended by NINL Executive Sanjeev Kumar Ghosh, who gave a detailed presentation on the plant's proposed expansion plan, while MD and CEO, Sudhir Kumar Mehta, addressed public concerns. Tata Steel Long Products Limited acquired NINL in July 2022 and achieved operational milestones swiftly. Within 100 days, the plant

resumed operations, and its rated capacity was achieved within nine months. NINL officials informed the participants that comprehensive upgrades included advanced pollution control systems such as Electrostatic Precipitators (ESPs), cyclone separators, dry fog systems, bag filters, and water sprinkling mechanisms. To further minimise environmental impact, a scrubber-based gas cleaning plant was introduced to treat BOF (basic oxygen furnace) gas.

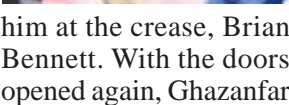

"If any player does not retire then he is definitely available for selection (for the Champions Trophy)," Faruque told reporters following board meeting at the Sher-e-Bangla National Stadium on Friday. "Shakib issue is a totally different issue and there

**New Delhi:** Hardik Pandya is not part of the Baroda team for the Vijay Hazare Trophy (VHT), which began on Saturday (December 21) across various venues. The Baroda Cricket Association (BCA) said the all-rounder will join the squad from the knockout stages of the 50-over tournament. "He will play from the knockouts; he has informed us," said Kiran More, a member of the Cricket Improvement Committee (CIC) of the BCA. The Board of Control for Cricket in India (BCCI) and the national selection committee, led by Ajit Agarkar, have made it clear that every cricketer must participate in domestic competitions unless otherwise advised or exempted. Pandya recently featured in the Syed Mushtaq Ali Trophy (SMAT), where Baroda reached the semifinals. In seven matches, he scored 246 runs and claimed six wickets. Pandya (31) has not played



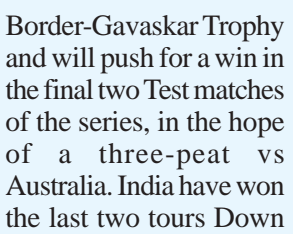
a non-T20 official match in nearly 14 months. His last appearance in a non-T20 match was in the ODI World Cup on October 19, 2023, against Bangladesh in Pune, where he suffered an ankle injury and remained sidelined from competitive cricket for an extended period. He has ceased playing red-ball cricket altogether. Pandya's participation in the one-day domestic championship could play a seminal role in his selection

for next year's Champions Trophy, especially with the Indian team unearthing a potential like-for-like pace-bowling option in Nitish Reddy. The Andhra allrounder has excelled with his skills and temperament with an impressive all-around performance in the ongoing Border-Gavaskar Trophy (BGT) series in Australia. Since his injury last year, Pandya has played 38 T20 matches, including internationals, IPL, and

domestic games, but none in other formats. This has fueled the perception that he has been focusing exclusively on T20 competitions. Moreover, his participation in the VHT will depend on Baroda qualifying for the knockouts. More sought to dispel such assumptions. "He participated in all the SMAT matches, and he will play in the 50-over games too. Baroda performed well in the SMAT, reaching the semifinals, which they lost due to wet conditions in Bengaluru. Hopefully, the team will make it to the knockouts of the VHT as well," said the former India chief selector. Coincidentally, Baroda will host the VHT knockout rounds from January 9, with the final scheduled for January 18. Baroda, led by Krunal Pandya, Hardik's brother, are competing in Hyderabad currently. **New Delhi:** India captain Rohit Sharma and batter KL Rahul copped injury blows ahead of the Boxing Day Test match in Melbourne. While Rohit was hit on his knee, KL Rahul was spotted getting attended by the physio after an injury to his right hand. Ahead of the Boxing Day Test match, India captain Rohit Sharma copped a big blow on his left knee during practice on Sunday, December 22. Rohit was injured during a session with the throwdown specialist when the ball sneaked through his pads and hit him on the knee. The injury comes just four days ahead of the Boxing Day Test match in Melbourne. India are level 1-1 with Australia in the



Under, first under the leadership of Virat Kohli and then under Ajinkya Rahane. The hope for the threepeat might be under threat if the India captain gets

injured for the last two Tests of the series. On Sunday, Sharma was spotted applying an ice pack on his knee after his injury and had hobbled out of the nets in Melbourne.

Earlier on Saturday, India opener KL Rahul got hit on his hand while batting at the nets and was promptly attended to by the team's physio ahead of the fourth Test against

Australia. Rahul was hit on his right hand and was seen in some discomfort at the Melbourne Cricket Ground. The BCCI did not provide clarity on either of the injuries.

India have played 14 Tests at the iconic MCG. The team has won only 4 of the 14 Tests and has lost in 8 occasions. Only 2 Test matches have ended in a draw. India first played at the MCG in January 1948 against a Donald Bradman-led Australian side. Under the leadership of Lala Amarnath, India lost the match by 233 runs.

India's recent record at the MCG is however quite good. India have not lost at the 'G' since 2014. They have won 2 and drawn 1 out of their three games.
