

Centuries-old desire of Ram temple now a reality: President Murmu

New Delhi(KCN): President Droupadi Murmu Wednesday said the centuries-old desire to build a Ram temple in Ayodhya has now become reality as she listed the achievements of the Modi government over the past 10 years. In her 75-minute address to the members of both Houses of Parliament assembled in the Lok Sabha chamber of the new Parliament building, Murmu also hailed the armed forces for giving a befitting reply to terrorism and expansionism, an apparent reference to Pakistan and China. In her maiden address in the new Parliament building, the President listed out the economic reforms undertaken by

the government that has transformed India from the group of "fragile five" to the "top five" economies in the world. Murmu said the government's successful hosting of the G-20 summit had strengthened India's global standing and noted that Jammu and Kashmir, and the northeastern states hosted some international meetings of the grouping for the first time.

"This is the time for India to script the future for the coming centuries. Our ancestors have bequeathed us a legacy spanning thousands of years. Even today, we remember with pride the exceptions of our ancestors. Today's

generation should also build a lasting legacy that will be remembered for centuries," she said. The Lok Sabha chamber reverberated with applause and thumping of desks when the President spoke about the building of Ram temple in Ayodhya, which is witnessing pilgrims in large numbers.

"Over the past 10 years, India has witnessed several such tasks being accomplished in the national interest, for which the people of the country were waiting for decades. For centuries, there was an aspiration to construct the Ram Mandir. Today it is a reality," Murmu said. The President said within five days of the



opening of the temple, 13 lakh devotees had visited Ayodhya Dham. She termed the consecration ceremony at the Ram temple on January 22 as an "epochal moment". "There were doubts regarding the removal of Article 370 from Jammu and Kashmir. Those are now history. This Parliament also enacted a strict law against

and expansionism and India has emerged as a prominent voice against terrorism in the world. "Today my government is building modern infrastructure along the entire border. This work should have been done long ago on a priority basis. Be it terrorism or expansionism, our forces today are giving a befitting response," Murmu said. The President said the tangible results of the government's efforts to strengthen internal security were visible.

"There is a sense of security in Jammu and Kashmir today. The earlier deserted look of marketplaces due to strike has been replaced by the hustle and bustle of crowded markets," Murmu said.

The President said there has been significant reduction in the incidents of separatism in the northeast and many organisations have taken steps towards permanent peace. "Naxal affected areas have shrunk and there has been a steep decline in Naxal violence," Murmu said. The government, she said, believed the grand edifice of a developed India will stand on the four strong pillars of youth power, women power, farmers and the poor. After Murmu's speech, Prime Minister Narendra Modi in a post on X said, "The Budget Session began with Rashtrapati Ji's extensive and insightful address highlighting the collective strength of 140

crore Indians, seen in a series of feats our nation has achieved. The Address also highlighted the vision of further developing India in the coming years."

In her address, the President highlighted the government's achievements over the last five years, including India's moon landing and the country's performance in the Asian Games.

"We all have heard the slogan 'Garibi Hatao' since our childhood. Today, for the first time in our lives, we see poverty being alleviated on a large scale. According to the NITI Aayog, in the 10-year rule of my government, nearly 25 crore people have come out of poverty," she said.

Bill on tackling exam malpractices likely in Parliament Monday

New Delhi(KCN): The government is likely to introduce a new bill in Parliament next week to deal sternly with malpractices and irregularities in competitive examinations, with sources saying it may propose a maximum jail term of 10 years and a fine up to Rs 1 crore. The sources said the Public Examination (Prevention of Unfair

Means) Bill, 2024 may be introduced Monday but a final call is yet to be taken. The bill was cleared by the Union cabinet recently. The sources said students will not be a target of the proposed law. It will essentially act against organised crime, mafia elements, and those found in collusion, including government officials, with them. The bill also proposes a

high-level technical committee that will offer recommendations to make the computerised examination process more secure. It is a central law and will also oversee competitive exams including Joint Entrance Exams and exams for admission in central universities. Earlier in the day, addressing a joint sitting of Parliament at the beginning of the Budget

session, President Droupadi Murmu said the government is aware of the concerns of the youth regarding irregularities in examinations. "Therefore, it has been decided to enact a new law to deal sternly with such malpractices." The sources said exam paper leak has become a nationwide problem, therefore, the need for a first-of-its-kind central

law was felt. Some states like Gujarat have brought their own laws to deal with the menace.

The teacher recruitment exam in Rajasthan, Common Eligibility Test (CET) for Group-D posts in Haryana, recruitment exam for junior clerks in Gujarat, and constable recruitment examination in Bihar were among others cancelled last year following question paper leaks.

Naga Log Drums and The Stories They Tell

Music is an inherent part of a tribal community and constitutes the essence of their society. The role of didactic performances and folk music are not limited to producing melodious sounds, but are also a way to communicate with their ancestors, and surroundings, and to transmit knowledge to future generations. It is not just the musical instruments themselves, but everything they incorporate that makes it an indispensable part of our tangible and intangible cultural heritage. One such instrument is the Naga log drum.

A Naga log drum can be categorised as an idiophone, an instrument that creates sound primarily by vibrations. It is called by different names depending on the tribe and region it belongs to. Though its primary function is that of a drum, it is also venerated like an idol. This tradition of making a log drum is practised in Naga tribes like the Konyak, Ao, Yimchunger, Sangtam, Phom, Khamtiung and Chang of Nagaland and Wancho of Arunachal Pradesh. Traditionally, a log drum may be installed in the Morung (youth dormitory) or at a vantage point. Villages of these tribes could have one or two log drums, with the size of the village reflected in the size of the drums. The larger the village, the larger the drums.

Myths and beliefs associated

Each tribe has certain beliefs and myths associated with the making and beating of the log drum. The log drum of the Konyaks, Kham, is associated with the tribe's origin myth. Konyaks of Nagaland regard it a chief duty to serve their elders and to keep the memory of their ancestors alive. They believe that their ancestors used canoes carved out of single tree trunks to cross a mystical river and reach their present settlement. Hence, in memory of this

journey they carve the log drum to be of similar shape to the fateful canoe used by their ancestors. In a Konyak village, a new log drum may be carved every few decades depending on the village's needs. A log drum cannot be made for individual purposes and must be for and by the community. This custom of carving log drums also created an environment that birthed Naga wood craftsmen and blacksmiths, further aiding in the preservation and development of their heritage.

A log drum is considered to be a female entity and given a name by the village elder, believed to have been revealed to him in a dream. The whole process of making and installing a log drum could take three weeks or a month, and is all the while accompanied by rituals, prayers and feasts. This community feast is primarily prepared by the women folk and is an important part of the process. It is considered to be a bad omen if any community member were to miss out on this feast, as it is believed that they would have missed out on blessings.

Preparation and carving of the log drum

An extraordinary skill is required to make a log drum. A typical log drum consists of the head, chest, wing, neck, body, tail and drum sticks or beaters. Some may also have steps carved on the sides, which help in climbing the drum. Before the process of making a log drum starts, all disputes within the community members are settled. Compromises and negotiations are made, and debts and interests paid to ensure that a strong spirit of harmony and community prevails.

The dense rainforests of Nagaland and Arunachal Pradesh make it ideal for sourcing the raw materials required in making a log drum. Once the tree is selected, it is struck with precision keeping in mind the

direction the trunk would land. It is felled amidst loud cries and prayers are offered. The log drum is ceremonial and must be protected at all costs. Tribesmen cover it with twigs, branches and leaves so that no wild animal vandalises it or worse, defecates on it. If any such unfortunate events were to occur then

easier. This task is usually assigned to the junior males who also gather the wood for the baton-shaped beaters, or Laphu and Lamphu as it is called in Konyak. Shaping of the log drum usually starts on the 8th-10th day. A long slit runs across the length of the drum and through this the drum is made hollow.

the while accompanied by loud cries. To be the first man to climb the felled tree was an honour given to an experienced warrior, who was usually the one with the highest headcount. An honest man, he was also one of the few chosen men allowed to ride the drum into the village. This man

contribution is noted in the preparation of feasts, and singing of songs to the spirits and their ancestors. One such Konyak song goes, "Oh, mighty tree do not be upset

Oh, mighty tree do not be upset

Protect all men and women from any harm

Oh, come mighty tree

Oh, come mighty tree".

This song is sung to venerate the tree from which the log drum is carved. It shows respect and gratitude for the tree's role in bringing blessings to the village. Such practices are common in tribal settlements as the forest and all that it encompasses are considered sacred and ceremonial.

Finally, on an auspicious day pre-decided by the female entity, the log drum arrives in the village. A sumptuous feast is organised on her behalf, with contributions made by the whole village. Each family's contribution is decided based on their

then formally installed in the Morung, where men grab the beaters and beat the drum in rhythmic successions. In olden days, sacrifices were also made in honour of the log drum. The arrival of the log drum would be accompanied by hoisting of the heads of enemies up on a flag post. Blood of the enemies would also be smeared on it, and in Ao villages the log drum was not beaten until it was coloured with the blood of the enemy. A log drum serves numerous purposes. It was used to announce the return of the warriors after a successful raid, to call for a public meeting, to mourn the death of a community member, to sound an alarm on being attacked or when there was a fire, when a wild animal was killed, and was also beaten post harvest in praise of a good crop. Sounding of the log drum could bring a multitude of blessings or signify a bad omen. Each occasion has a unique beating pattern known to members of the



pathway, and any person who owns property in the line of the pathway is duly compensated with cooked rice, meat, and blessings. Using the ropes, rollers and dowels, it is then pulled by employing the combined force and strength of the community members, all

must not have any in-laws residing in the village as it was considered to be a bad omen. Today, with the onset of Christianity the role of this chosen man is replaced by a pastor or church elder.







"Will Conduct Countrywide Caste Census After Coming To Power": Rahul Gandhi

While addressing a rally as part of 'Bharat Jodo Nyay Yatra' in West Bengal's Malda district, Rahul Gandhi accused the RSS and the BJP of propagating hatred and violence.

"We want social justice and the biggest aspect of delivering it will be a countrywide caste census. After we come to power at the Centre, we will conduct a caste census across the nation to find out the number of Dalits, tribals and people from other backward communities," he said. Rahul Gandhi had in neighbouring Bihar on



Tuesday alleged that Chief Minister Nitish Kumar was "feeling trapped" after getting a caste survey conducted in the state under pressure from the Mahagathbandhan partners and the BJP "provided him a way out". His remark berating the JD(U) president came just two days after Kumar returned to the BJP-led NDA, dealing a severe blow to the opposition bloc INDIA of which Kumar was regarded as one of the architects. Accusing the BJP and RSS of propagating hatred and violence, Rahul Gandhi underscored the essence of the yatra, stating, "The word 'nyay' (justice) has been attached to the yatra because injustice prevails across the country." "The BJP government has been meting out injustice to people across the country, be it youth, women or the working class," he said.

Amid differences with

TMC over seat-sharing in West Bengal for the upcoming Lok Sabha elections, Rahul Gandhi had on Sunday in northern West Bengal called on the people of the state to spearhead an "ideological battle" against prevailing injustices in the nation. Expressing gratitude to the people of West Bengal, Rahul Gandhi said, "The people of West Bengal are known for being ideologically oriented. It is your responsibility to stand against the ideology of hate. Personalities such as Rabindranath Tagore, Subhas Chandra Bose and Amartya Sen have Bengal origins." Rahul Gandhi's statement closely followed Chief Minister Mamata Banerjee's announcement that her party would contest the Lok Sabha polls alone in the state.

"No Abnormalities": Supreme Court Rejects Termination Of 32-Week Pregnancy

New Delhi(KCN): The Supreme Court on Wednesday refused to allow a 26-year-old woman, who had lost her husband in October last year, to terminate her over 32-week pregnancy, saying the medical board has held that there were no abnormalities in the foetus.

A bench of Justices Bela M Trivedi and Prasanna Bhalachandra Varale refused to interfere with the January 23 order of the Delhi High Court recalling its earlier verdict of January 4, allowing the woman to terminate her then 29-week-old foetus.

"It's a 32-week-foetus. How can it be terminated? Medical board has also said that it cannot be terminated. It is a matter of two weeks, then you can give it for adoption, if you want," the bench said.

Advocate Amit Mishra, appearing for the woman, said if she is to give birth then it will be against her wish and



and that she will have to bear the trauma throughout her life. The bench added that each and every point has been considered by the high court, including the opinion of the medical board. "We cannot go beyond the opinion of the medical board. The medical board has opined there is no abnormality and it is a normal foetus," Justice Trivedi said, adding it has also been opined that there is no risk to even the petitioner, if she carries on with the pregnancy. Mr Mishra argued that the woman is a widow and she will have to bear a life-long trauma and the court should consider her interest. Justice Trivedi asked him, "Why should we consider only her interest?" The bench then refused to interfere with the high court order and dismissed the plea.

On January 4, the court had allowed the widow, suffering from depression, to terminate her then 29-week-old

foetus as continuation of pregnancy could affect her mental health and observed that the right to reproductive choice also includes the right not to procreate.

The high court's January 24 order had come after the Centre filed a plea seeking recall of its January 4 order allowing medical termination of the pregnancy on the grounds that the child has a fair chance of survival and the court should consider protecting the right to life of the unborn child. The All India Institute of Medical Sciences (AIIMS), where the woman was medically examined, also claimed that it was advisable

that the pregnancy be continued for another two-three weeks for the betterment of the health of the mother and the child.

In its order, the high court had taken note of the opinion of AIIMS medical board which stated that the woman was suffering from depression associated with stress due to life events and not any psychotic features, and that there was no suggestion that the ongoing pregnancy or delivery would cause such a grave injury to her mental health that would necessitate termination of pregnancy.

The medical board, the high court added, had also opined that since the foetus did not show any abnormality, foeticide was neither justified nor ethical and a preterm induction of labour has a high chance of failure, leading to serious implications on her future pregnancies as well as physical and mental deficiencies in the newborn.

COAST GUARD DAY TO CELEBRATE 48th RAISING DAY TODAY

Kolkata(KCN): The Indian Coast Guard (ICG) is celebrating its 48th Raising Day tomorrow (February 1, 2024). From a modest beginning with just seven surface platforms in 1978, ICG has grown into a formidable force with 152 ships and 78 aircrafts in its inventory and is likely to achieve targeted force levels of 200 surface platforms and 100 aircrafts by 2030. ICG is now considered to be one of renowned Coast Guards in the world due to its achievements and for the efficiency with which it operates its assets in a challenging environment, thereby ensuring round the clock safety and security. True to its motto "Vayam Rakshamah" meaning "We Protect", the service has to its credit, saving over 11,554 lives since its inception in 1977 and 200 lives in the year 2023, which translates into saving one precious life every second day.

To ensure security in the Maritime Zones of India, the Indian Coast Guard has maintained 24 x 7 vigil by deploying about 50 to 60 ships and 10 to 12 aircrafts daily. This is to fulfill the nation's expectation to keep our seas free and secure in order to facilitate sustainable progress on blue economy efforts by various stakeholders, besides ensuring a safe environment for maritime transportation through our sea lanes. It is envisioned that the future ICG shall be omnipresent by showing strong presence in

Normal To Above-Normal Rainfall Likely In North India In February: Weather Office



"Monthly rainfall over the country as a whole during February is most likely to be above normal (more than 119 per cent of the long period average)," Mohapatra said.

Based on data from 1971-2020, the long-period average (LPA) of rainfall over north India and the country as a whole in February is 65 mm and 22.7 mm, respectively.

North India, consisting of seven meteorological subdivisions, is most likely to receive above-normal rainfall (more than 122 per cent of the long-period average) in February.

Most parts of the country are likely to witness above-normal minimum temperatures in February while

northwest, west-central, northeast and parts of east-central India are likely to see above-normal maximum temperatures, according to the IMD. Normal to below-normal maximum temperatures are likely in most parts of peninsular India and parts of east-central India during February," it said.

The strong El Nino conditions -- abnormal warming of surface waters in the central Pacific Ocean -- are likely to weaken steadily and turn to ENSO-neutral conditions by the end of the spring season.

Most models indicate a transition to La Niña conditions, considered favourable for the Indian southwest monsoon, around July-September, Mohapatra said.

Fact Check: Viral Claim On Proposed Changes In Work Week Debunked

New Delhi(KCN): The Fact Check Unit (FCU) of the Press Information Bureau has alerted people about a "fake" news claiming that Finance Minister Nirmala Sitharaman will introduce a policy mandating three-day week-offs in all companies. In a post on X (formerly Twitter), the PIB's fact-checking unit said that no such proposal has been put forth by the Finance Ministry.

"An image circulating on social media claims that the Union Finance Minister Nirmala Sitharaman will announce a 3-day week off policy in the next #Budget. This claim is #fake...No such proposal has been floated by the Ministry of Finance," it said.

The misleading post had also asserted that employees will be required to work extended hours, ranging from 10 to 12 hours per day, for four days a week, starting July 1,



With the formation of the new government expected around June, all eyes are on the subsequent unveiling of the final budget for the fiscal year 2024-25, projected to take place in July. The live broadcast of Ms Sitharaman's speech will be available on DD News. Additionally, the PIB is set to amplify accessibility by broadcasting the Budget online through its official YouTube channel and website.

Mission Shakti Cafe, Mission Shakti Bhawan plaques vandalised before inauguration in Odisha

PURI,(KCN):The information plaques for Mission Shakti Cafe and Mission Shakti Bhawan were vandalised on the premises of the Kakatpur block in Puri on Tuesday before its inauguration.

As per reports, the inauguration of the Mission Shakti Cafe and Mission Shakti Bhawan on the block premises is scheduled to be done by the Minister of State for Home, Tusharkanti Behera.

According to sources, the names of Sarpanch and some others were not mentioned in the plaques. It is alleged that the supporters of the sarpanch and the block chairperson deliberately damaged



the plaques. Following the incident, a complaint was lodged at the police station. The sarpanch concerned admitted that his supporters have broken the plaques because his name was not there on the plaques. Some supporters of the

Minister lodged a complaint against the block chairperson and the sarpanch. On the other hand, a counter-complaint was filed at the police station, alleging that the supporters of the Minister misbehaved with the sarpanch. Block chairperson

Sridhar Nayak said, "The Mission Shakti Cafe and Mission Shakti Bhawan were approved on my instruction on the block premises. The work is in progress and is not yet complete. Last night, the work was done in a hurry. My wife Rina Nayak,

who is the sarpanch of Kantapada panchayat came to know about the work being done in a hurry for inauguration."

He added that the sarpanch rushed to the spot and asked the people working there why the names of the sarpanch, the block chairperson, the vice chairperson, the BDO, and the samiti members were not mentioned on the plaques.

"The supporters of the Minister who were present at the site misbehaved with the sarpanch and pushed her aside. We have filed a complaint," Nayak said. No reactions from the minister and police were received.

CRPF jawan from Rajasthan found hanging in hotel room in Bhubaneswar

Bhubaneswar(KCN):The body of a Central Reserve Police Force (CRPF) jawan was found hanging in a hotel room here, police said Tuesday.

Police have identified the deceased as Mir Singh, 44, a resident of Rajasthan and of a CRPF battalion deployed in Jharkhand. He had checked into the hotel Ashok Nagar under Capital police limits here January 26 evening, police added.

Police sources said that the hotel staff found him hanging from the ceiling fan Monday evening and informed police.

A police team immediately reached the spot and brought the body down. The hotel staff had also reportedly heard Singh



speaking angrily and loudly with an unknown person over the phone in his hotel room before death, the source added. "We are trying to find out the reason behind his visit to Odisha. We have informed the family members who are on the way and will reach Bhubaneswar soon. The actual reason behind the death can only be ascertained after the interrogation of family members," a police official said.

Naveen urges farmers to conserve water

All Eyes Western Odisha

Bhubaneswar(KCN):Much ahead of the Election Commission of India announcing the dates for the upcoming General Elections for Lok Sabha and Odisha Assembly, the state's three major parties have already started electioneering, making strategies to win the confidence of the people of western region. This is because everybody here knows that the first phase of elections will be held in the western Odisha earlier and the poll for the coastal belt will come later.

The major parties like ruling BJD and opposition BJP and Congress have already started work in western region. Everybody in Odisha politics knows that the saffron BJP is comparatively in a better position in western region for which party candidates won in five Lok Sabha seats like Sundergarh, Sambalpur,

Bargarh, Bolangir and Kalahandi in 2019 elections. The party, however, won three more LS seats in Bhubaneswar, Balasore and Mayurbhanj. But the party's main stake lies in the western region. Though the BJD leadership is aware that the party has better possibility in Lok Sabha polls in western region, it has to further its assembly election prospects. As per simple mathematics, the saffron party should have won at least 35 assembly seats from the five LS constituencies. If that is not enough, the party should get at least 30 MLAs from the western region. However, nothing of that kind happened in the 2019 elections. The party in total, including the western region, could win only in 23 assembly segments. Therefore, the BJD leadership has to work very hard and also win Assembly seats from western region if it wants

to form the Government in Bhubaneswar. Therefore, western region is very important for the BJD. Similarly, the case for the Naveen Patnaik headed BJD in the western region. Though the voters of western region voted en-mass for the conch symbol, they preferred to cast their votes for Lotus in the LS elections. Therefore, the western region is equally important for the BJD. As the regional party has been targeting to win 20 of the 21 LS seats in Odisha, it must get the support and cooperation of the voters in western districts of Sambalpur, Bargarh, Jharsuguda, Sundergarh, Kalahandi, Bolangir, Nuapada, Boudh, Deogarh and Subarnapur.

For Congress, which has only nine MLAs in the House of 147 members in Odisha Assembly, four members come from western region (Rajgangpur, Kantabanji, Bolangir and Khariar), three from southern region (Jeypore, Mohana and Sanakhemundi) and two from coastal region (Barabati-Cuttack and Jatni). Therefore, the highest number of MLAs come from western side of the state. Therefore, the oldest party also considers that it has to raise its stake in the western region if it wants to become the principal opposition party in the state. The BJP had replaced the Congress as the main opposition party in the 2019 elections. Keeping in view the importance of the western region in the state politics, BJP's Prime Trump Card and Prime Minister Narendra Modi is scheduled to address a public meeting in Sambalpur though he is undertaking an official visit to inaugurate the permanent campus of Indian Institute of Management (IIM) Sambalpur.

Elgar and Kohli washed away 2015 spitting spat with drinks

New Delhi: Dean Elgar alleges Virat Kohli spat at him during South Africa's Test series in India in November 2015. Elgar says the two made up over a drink in India's series in South Africa in January 2018. That wasn't the only striking claim made as the cameras rolled.

Elgar, who played the last of his 86 Tests against India at Newlands earlier this month, made the incendiary allegation during a panel discussion led by Nick Rabinowitz, a comedian. Chris Morris and Jean de Villiers, a former captain of South Africa's men's rugby team, were the other participants.

"I came in to bat, and I was holding my own against Ashwin and Jadeja," Elgar said. "Kohli spat at me, and I said to him, 'If you do that again I'll f*****g p***s [a South African profanity meaning hit] you with this bat. I will absolutely knock you out on this field."

Elgar said AB de Villiers, Kohli's RCB teammate, confronted India's then captain: "AB went up to

him and said, 'Bud, why are you spitting at my teammate? That's not on.' Two or three years later we're playing in South Africa, and [Kohli] calls me aside and says, 'Can we have a drink together at the end of the series? I just want to apologise for my actions.' The punchline is we drank until three in the morning."

The discussion, billed as "Banter, [sic] with The Boys", is "presented by" the SA20's title sponsor and available online. In it, Australia's explosive Test series in South Africa in March 2018 is revisited, and Elgar says off-field issues played a role in his decision to retire from the international game.

In 2018, Steve Smith - then Australia's captain - David Warner and Cameron Bancroft were fined and banned, and publicly shamed at home after they were caught, during the third Test at Newlands, using sandpaper to roughen the ball. During the first Test at Kingsmead, Quinton de Kock retaliated to hours of on-field verbal abuse by Warner by

insulting Warner's wife in a stairwell altercation with her husband. That prompted Warner to threaten to assault De Kock. Spectators and CSA staff at the second Test at St George's Park wore face masks to taunt Warner.

Morris, who was in the squad for the last two of the four matches, said tensions had been heightened by events in Durban: "That switched the South African team on properly. I remember AB saying, 'Ons gaan hulle nou seermaak.' [Now we're going to hurt them.] AB is usually placid and relaxed when he's batting; he does his thing. But in that [Newlands] Test he was in such a zone.

"When it [the exposure of ball-tampering] happened, AB was batting with Aiden Markram. AB blocked the ball and the big screen showed what had gone on with the sandpaper, and that's when the crowd got involved. AB didn't hear a thing. He was so focused on f*****g the Australians up, because they were abusing him.



"Aiden walked down the wicket and said, 'Abbas, something's gone on here.' AB said, 'What do you mean?' As he said that, it played on the big screen, showing Bancroft with the ball and putting it [the sandpaper] away. AB blocked the next ball. Bancroft came to pick it up. AB looked at him saying, 'Hey! Cameron! Hey!' Bancroft sheepishly looked up and made eye contact. AB went, 'You're f*****d now, mate.' Elgar said he had sympathy for the Sandpapergate three: 'I felt sorry for the players, especially because of what happened afterwards. Watching Steve Smith be escorted out of the airport with 30 cops around him. He didn't kill someone.' According to Elgar, he was assaulted by Andrew Symonds after the St George's park Test in that series: "We went to the casino. It was two o'clock in the morning. The late Andrew Symonds was there. He was upside down [drunk]. He saw a great opportunity to give me a peek. For nothing. He smacked me. I looked at him, and I looked at AB. And AB said, 'Oh no - don't do this.' I went forward [to punch Symonds] and AB pulled me back."

Of his retirement, Elgar said: "I should have done it ages ago, really. I'm not totally retired - just from international b*****t. I've still got a lot of good years left in me. Unfortunately it's not going to be on our shores. It's going to be God Save the King [in a three-year contract to play for Essex]."

Elgar led South Africa in 18 Tests and was replaced by Temba Bavuma in February last year. But he ended his career back in charge because Bavuma was ruled out at Newlands

forward [to punch Symonds] and AB pulled me back."

Asked by Morris whether "at any stage did it become a las [drag] to play for the

country", Elgar said: "There were times when it became a lot of hard work and you lose your enjoyment. Playing for your country is the greatest honour, but I had to deal with a lot of stuff off the field - especially with the captaincy role. "We had a new board and a coach [Mark Boucher, who was cleared on racism charges] who was going through a lot of scrutiny in South Africa, if not the world. You take all of that on board and you lose your focus. Your focus is actually to go out and play and score runs and win games. My focus shifted a lot. You wipe the s***t out of your eyes and two years have gone by. And you're like, 'I've wasted two years of energy.' I've got about a hundred thousand more grey hairs. Why put yourself through that?"

Elgar answered that question when he walked away at Newlands. As he did so, having been caught at first slip off Mukesh Kumar in his last Test innings, a familiar figure embraced him warmly. Maybe Kohli was keen on another drink.

Frontman Rohit's big test as great team heads towards the third age

New Delhi: Soon after the last rites of the Hyderabad Test were read and the formalities of the post-game handshakes were done with, Rohit Sharma was pictured standing by the boundary line, waiting to share with the rest of the world, via the broadcasters, his views on the remarkable turn of events that characterised his 12th game as India Test captain. Despite the disappointment of the result, a cluster of Indian fans continued to cheer and yell his name, which Rohit acknowledged with a half hand-raise and a smile in acknowledgement.

The Indian captain is



among a few with an ability to strip any cricketing situation of its gravitas and see it for what it is. That air of nonchalant lightness is his personality trait. He rightly acknowledged that his team was undone by an exceptional knock in the third innings and batting

apprehension in the fourth. One was an outlier while the other, quite par for the course in these conditions. But together those two events ensured that Rohit took a fourth 'L' to his captaincy report card, which amounted to losses in a third of the Tests he has skippered in. Two of them

have come at home, inside 12 months. And while India have lost home Tests before, including opening Tests of marquee series, in Pune in 2017 and in Chennai in 2021, this one from a position of total dominance hit differently and even seemed to cover their aura of home invincibility in a sudden, strange mist.

The last time India went

through a similar run of three consecutive home Tests without a win (two defeats and a draw) was nearly 12 years ago and it remains to date the last series they've dropped on home soil. While England have some way to go towards reprising their

great feat of 2012, they may have just caught Rohit's team in a very similar state of inevitable transition.

It's an uncomfortable and a different prospect confronting Rohit, whose takeover of the white-ball teams was more seamless and resulted in immediate success, that is if you are okay with quantifying success based on win percentages and not limiting it to just ICC silverware. Between him and coach Rahul Dravid, India vow to be more tactically on-point and have identified and implemented playing styles in keeping with the times.

Mayank Agarwal hospitalized in Agartala after falling sick on flight

New Delhi: Mayank Agarwal, the Karnataka captain, has been admitted to a hospital in Agartala after falling sick on a flight. Agarwal, who was leaving for Delhi from the capital city of Tripura along with the Karnataka team on Tuesday (January 30), consumed a beverage onboard the flight following which he complained of uneasiness and a burning sensation in his throat, and started vomiting. He was deboarded and rushed to the hospital immediately. KSCA president, told Cricbuzz that Mayank is out of danger and will ideally be discharged from the hospital tomorrow. He's expected to fly back to Bengaluru and consult the local doctors before deciding on his further course of action. KSCA is confident that he will be back on the field soon.

Karnataka completed their Group C Ranji assignment against Tripura in Agartala and will next face Railways starting February 2 in Surat. Nikil Jose, the vice-captain of the team, is likely to take over the leadership in Agarwal's absence.

In-form Musheer Khan paves another India win

New Delhi: Musheer Khan's second hundred in the U-19 World Cup was followed by a clinical bowling performance led by Saumy Pandey's four-wicket haul as India mauled New Zealand by 214 runs to get their Super 6 campaign off to a rousing start at Mangaung Oval in Bloemfontein.

Musheer's 126-ball 131 included 13 fours and 3 sixes as he powered India to 295/8. Asked to bat, India lost Arshin Kulkarni early but Adarsh Singh came up with a well-compiled half-century and added 77 in partnership with Musheer to provide a good platform. Musheer then had the company of skipper Uday Saharan as they put on 87 for the third wicket. New

Zealand hit back with regular wickets in the last

15 overs, with Mason Clarke picking up four, but Musheer ensured a sizeable total for his side. New Zealand were rattled early in the chase as Pandey and Raj Limbani shared the first four wickets between them with only 22 runs on the board. There was no way back after that as India continued their wicket-taking spree, with Musheer also picking up a couple, as New Zealand were bundled out for 81 in 28.1 overs.

West Indies, however, ran through the middle order to leave Sri Lanka reeling at 134/6 at one stage. But Malsha Tharupathi's 42 helped the team over the 200



mark, giving their bowlers a fighting total. West Indies started well with Stephan Pascal scoring 33 off the 48 added in the opening stand. They lost a couple of wickets but were back on track thanks to Steve

Pakistan vs Ireland

Ireland ran Pakistan close in their defence of 181 but the Saad Baig-led team got over the line in the 44th over with three wickets in hand at Senwes Park in Potchefstroom. Ahmad Hassan came up with an all-round performance, picking up 2-37 before scoring an unbeaten 57 to help his team over the line.

Asked to bat, Ireland lost wickets in a heap and were struggling at 63/6 before the 24th over was completed. But they managed to pick themselves up thanks to John McNaughton's 53, with support from Harry Dyer

(31) in a 65-run partnership. They were 158/9 at one stage but Oliver Riley's 18 helped them finish with 180-plus.

Pakistan lost their openers early but they got back on track in the chase with Azan Awais and Baig putting on a 40-plus stand. But from 73/2, they slipped to 96/5 as Dyer gave Ireland hope with quick wickets. But Hassan's measured 57 not out off 72 and Haroon Arshad's 25 provided assurance in the Pakistan camp as they eventually sealed the deal.
