Health Survey Begins

Berhampur(KCN): An integrated survey campaign has been launched in the state. Health Minister Mukesh Mahaling inaugurated the programme from Maharaja Krishna Chandra Gajapati Medical College in Ganjam. The event was held at diamond jubilee town hall premises in Berhampur.

Speaking as the chief guest at the event, Minister Shri Mahaling said that health is wealth. Everyone should be careful about it. The Integrated Survey Campaign programme is being conducted under the convenorship of the Prime Minister, Narendra Modi. It will make people aware of deadly diseases like diarrhoea, dengue, TB, leprosy, tuberculosis.



Pregnant women who have not been tested for hepatitis B this year have also been included in the campaign. Minister Shri Mahaling said that the campaign will start from today and will continue till August 31.

During this campaign, asha workers will visit all the households in both rural and urban areas and make them aware about the use of ORS, zinc, use of toilets and washing hands thoroughly with soap. Integrated wire corners

will be set up for stocking items such as zinc, ORS, RDT and displayed along with control stock.

The campaign has been going on since 2014 and around 8,38,000 families and around 5,086 children under the age of five have joined the campaign and reaped the benefits. The identified with diarrhea were treated with ORS and zinc.

Similarly, around 25,640 fever tests have

been conducted for the detection of malaria and dengue patients, 2,591 for TB and 1,994 leprosy patients have been identified and steps have been taken accordingly. It is a massive and integrated campaign, through which awareness is being spread from time to time through TV, newspapers, radio and media.

A reference booklet has been provided to all the aspirants. Speaking on the occasion, Gokulanand Mallik, Minister of Fisheries & ARD said, "We hope that this year also this campaign will be successfully implemented and together everyone will achieve its goal.

Heavy Rains To Hit Odisha In Next Two Days, IMD Predicts Gusty Winds, Thunderstorms



Bhubaneswar(KCN): The India Meteorological Department issued a yellow alert for several districts in Odisha, forecasting extremely heavy rainfall over the next two days.

After 16 years, Odisha CM at people's durbar: 'Barrier between people and govt has been destroyed'

Bhubaneswar(KCN): According to the government, the CM will attend the meeting for two hours every Monday.

With a photograph of her missing son and a copy of an FIR lodged last year based on her complaint, Sanjukta Bharati from the Bari area of Odisha's Jajpur district was among the hundreds of people who gathered outside the Chief Minister's grievance cell as new Odisha CM Mohan Charan Majhi held his first grievance redress meeting in Bhubaneswar, remaining there for the entire first half of the workday.

This was the first time in 16 years that a Chief Minister was present at the grievance redress cell meeting. Though the mechanism was in place during the previous Biju Janata Dal (BJD) government too, Majhi's predecessor Naveen Patnaik last attended a meeting of the CM's grievance cell on August 16, 2008. Instead, he used to depute junior officers in the Chief Minister's Office (CMO) to hear out people.

"My son was working as a plumber in Himachal Pradesh. On May 28 last year, he called us to inform us that he was travelling to Delhi from where he would board a train for home (Odisha) on May 30. Since then, he has been missing. I have lodged an FIR with Ramchandrapur police station but they said they can't help since my son



went missing in Delhi," said Bharati, 58.

Bharati said she earlier tried to meet district police officials but failed. "I decided to come here after I came to know that the CM himself would attend the grievance redressal meeting," she said.

According to the government, the CM will attend the meeting for two hours every Monday. District Collectors, Superintendents of Police (SPs), and various state government departments have also been directed to resume their grievance redress meetings every Monday at their respective offices.

The administration along with the public grievance department has developed a mechanism for the smooth conduct of the CM's grievance meeting, according to officials.

Another complainant who met Majhi on Monday was Kastahari Jena, a person with a disability from Kathpal village in Keonjhar district. His demand: a house under the government's rural housing scheme and a wheelchair.

"I have informed the CM about my concerns. He assured me that he would resolve it as soon as possible and directed officers to take note of my concerns," Jena told reporters. "The state government's priority is to listen to people's grievances and resolve them. Our government has revived the grievance hearing meetings from the grassroots to the state level. Under the previous government, there was a barrier between the administration and people due to which people faced problems in getting their problems resolved. That barrier has been destroyed today to ensure direct interaction between the government and its

people," Majhi told the media.

Deputy CM K V Singh Deo who joined the CM at the meeting said around 2,000 people registered to raise their grievances. "After hearing the grievances, we directed concerned departments to look into the matters. Had this exercise been carried out regularly, we would not have witnessed a turnout of such a large number of people to lodge their grievances. The CM will receive all grievances and we'll try to resolve as many of them as possible," said Singh Deo.

Last year, Naveen Patnaik's close aide V K Pandian, who was then serving as his private secretary, toured across the state to receive grievances from people. The CMO under the BJD government claimed at the time that Pandian, during his visits, collected around 60,000 grievances, out of which nearly 45,000 were resolved during a special drive.

Before his tenure as Odisha's CEO, Dhal was the Additional Chief Secretary of the Energy Department and served as the Odisha Special Relief Commissioner (SRC) in 2023.

New Delhi (KCN): The newly-laid Broad Gauge Rail Line of 40.934 kms in Dhenkanal - Hindol Road Railway Section of Salegaon-Budhapank 3rd & 4th Line Railway project and 12.353 Kms newly laid rail line in Dantewara-Kamlur Railway Section of Kottavalasa-Kirandul Rail Line project has been completed and commissioned.

The Model Anganwadi Centres also prioritize the health and nutrition of young children, as well as pregnant and lactating mothers. Each centre includes a dedicated 'Mamata Gruha,' where regular

health check-ups, counselling and immunizations are conducted by ANMs.

Additionally, the centres monitor children's weight, haemoglobin levels, and other health indicators.

Anganwadi Centres in Mayurbhanj district are being modernized. These new centres are more appealing to children and significantly contribute to their physical and intellectual development through various creative activities," says District Social Welfare Officer, Annapurna Sanku.

Genesis of paper leak; steps to prevent future leak

G.K. Chesterton, a prolific writer of the 20th century, once remarked, "Education is simply the soul of a society as it passes from one generation to another." Regrettably, the esteemed position held by individuals within the education establishment has not only failed the system but also betrayed the ideals of this renowned author and his philosophy of education. The unethical practice of exam paper leaks has severely tarnished the integrity of the entire education system and compromised the future of countless students. It is imperative to investigate the sources of these leaks and identify those responsible for these reprehensible actions.

Frequent reports of exam paper leaks in India highlight a significant and recurring problem. Due to these breaches, numerous examinations have been canceled. Media reports indicate that, over the past seven years, more than 70 examination papers have been leaked in various states, affecting the careers of over 15 million youths. It is not possible to establish a system that ensures the integrity of these examinations and

prevents leaks?
An exam paper leak refers to the unauthorized release of examination papers prior to the scheduled test date, thereby granting unfair advantages to certain individuals. These leaks typically affect high-stakes examinations, including school board exams, college entrance tests, and competitive recruitment assessments. There are two prevalent methods by which exam paper leaks occur. Firstly, leaks occur when question papers are accessed and disseminated by individuals or groups external to the educational institution responsible for conducting the examination. These leaks are often the result of well-organized syndicates that exploit vulnerabilities within the examination system to obtain confidential papers. These syndicates operate across multiple regions and employ sophisticated techniques to infiltrate examination systems and access sensitive materials, which are then distributed to interested parties for financial gain.

Internal leaks involve individuals within the educational institution responsible for conducting the examination, such as teachers, administrative staff, or even students. These individuals may compromise the sanctity, secrecy, and confidentiality of the

examination by leaking the papers. In some instances, education administrators, who have privileged access to examination papers, are primarily involved in these leaks, making them potential culprits. Exam paper leaks have emerged as a critical challenge within the education system, undermining the fairness and credibility of assessments. The responsibility for these leaks falls on organized syndicates, education administrators, teachers and staff, and occasionally students. To address this issue effectively, it is indispensable to implement stronger security measures, adopt technological safeguards, provide ethical training, protect whistle-blowers, impose strict punitive measures, and increase public awareness. By enforcing these measures, we can safeguard the integrity of examinations, uphold the value of education, and ensure a fair and equitable system for all students. Unemployment and Poverty: A Double Burden on India's Economy



Unemployment and poverty are significant challenges impacting the Indian economy. As of 2024, India's unemployment rate stands at approximately 7.5%, with youth unemployment rates exceeding 20% in urban areas. This high unemployment rate contributes to poverty, with over 22% of the population living below the poverty line as of 2024. Despite economic growth, approximately 276 million people need more access to necessities such as food, healthcare, and education. Rural areas are particularly affected, with higher poverty rates than urban regions. The multidimensional poverty index (MPI) indicates that nearly 25% of the population experiences deprivation across various aspects of life, including health, education, and living standards. Resolving this issue requires comprehensive policy interventions to uplift the

impoverished and ensure equitable economic development. The economic impact of poverty on the Indian economy is profound: reduced consumer spending weakens domestic markets, and a large portion of the workforce remains unproductive, stifling economic growth. Furthermore, poverty exacerbates social issues, such as inadequate healthcare and education, which perpetuate the cycle of unemployment. Addressing these issues through targeted skill development, robust social security programs and economic reforms is crucial for fostering sustainable economic growth and improving living standards across India.

In today's fast-paced and ever-evolving job market, employers are no longer solely interested in hiring candidates with degrees from prestigious institutions like the Indian Institutes of Technology (IIT) or the Indian Institutes of Management (IIM). They now prioritize candidates with specific skill sets. Despite the widespread recognition of IITs for academic excellence and coveted

placement opportunities, recent reports have revealed that they need to deliver based on their ranking and perception. This shift in hiring priorities underscores the growing importance of practical skills over formal education, a trend reshaping the job market and contributing to the unemployment problem.

Thousands of students aspire to gain admission to IITs yearly, yet only 20-25 per cent of them clear the Joint Entrance Exam (JEE) Advanced process. Once admitted, these students look forward to the placement season, hoping for lucrative job offers. However, the 2024 placement season has been described as "lacklustre" by IIT students. This is particularly concerning at IIT-Bombay, ranked third among engineering institutes in India according to the National Institutional Ranking Framework (NIRF). According to the Global IIT Alumni Support Group, nearly 36% of students needed help to secure jobs during the 2024 placements. Although IIT-Bombay contested this report, stating that only 6.1% of students

remained unplaced, the situation remains worrisome. Further data from the Global IIT Alumni Support Group shows that nearly 30-40% of students at the top ranked older IITs, such as Bombay, Delhi, and Kanpur, still need to be found. This figure rises to around 50-60% in the 15 newer IITs, including BHU (Varanasi) and Ropar. This discrepancy highlights a critical issue: many well-educated individuals are entering the workforce but still need to be found. One key reason for this mismatch is that higher education degrees do not necessarily equip graduates with the practical skills employers require. While a degree may provide a broad understanding of a subject, the specific, applicable skills determine success in a job. A candidate with the correct set of skills, even without a higher degree, can perform exceptionally well and meet job demands effectively. The rise of the gig economy offers a promising solution to this problem. The gig economy in India is

vibrant, skill-driven, and provides significant opportunities to unemployed youth. According to Taskmo, a gig work platform with over 750,000 registered gig workers, youth participation in the gig economy increased eightfold between 2019 and 2022, primarily from Tier-I and Tier-II cities. A 2022 projection report by Niti Aayog predicted a growing demand for skilled gig workers in digital marketing, social media management, logistics, healthcare, and beauty wellness. The gig workforce is expected to expand to 23.5 million by 2029-30, up from 7.7 million in 2021-22. Professionally trained gig workers can earn competitive incomes, often surpassing traditional degree holders. For instance, a hairdresser with professional training can earn more than an MBA graduate or an IITian. Jawed Habib, a renowned hairstylist and entrepreneur, exemplifies this trend, inspiring young people to consider beauty and wellness as viable and lucrative career paths. Given these insights, here are several suggestions to resolve

the unemployment problem by focusing on skill development and embracing the gig economy: Educational institutions should integrate vocational training programs that equip students with practical skills relevant to the job market. Courses in digital marketing, data analysis, coding, healthcare, and other high-demand areas should be prioritized. Strengthening partnerships between educational institutions and industries can ensure curricula align with current market needs. Internships, apprenticeships, and on-the-job training programs can provide students' real-world experience. Government and private sector initiatives should focus on making skill development programs accessible to all, particularly in rural and underserved areas. Subsidized training programs and scholarships can help bridge the gap. Platforms facilitating gig work should be promoted and regulated to ensure fair wages and working conditions. Training programs designed for

gig work can prepare the youth for this growing sector. Success stories like that of Jawed Habib should be highlighted to change perceptions about non-traditional career paths. Campaigns and career counselling sessions can inform students about the diverse opportunities beyond conventional degrees. Continuous learning and skill upgrading are crucial in today's dynamic job market. Employers, educational institutions, and governments should encourage lifelong learning through workshops, online courses, and certification programs. In addition to technical skills, soft skills such as communication, teamwork, and problem-solving are essential for employability. These skills should be incorporated into educational programs and professional training. Encouraging entrepreneurship can create new job opportunities and drive economic growth. Initiatives like startup incubators, funding programs, and mentorship networks can support aspiring entrepreneurs. As technology evolves, so do job requirements. Educational institutions and training programs should stay updated with the latest technological trends and incorporate relevant skills into their offerings. Government policies should support skill development initiatives, incentivize private sector participation in training programs, and ensure that labour laws protect gig workers and provide them with social security benefits. Resolving the unemployment problem requires a multidimensional approach that prioritizes skill development, embraces the gig economy, and adapts to the evolving job market. Focusing on these areas, we can create a workforce that is not only well-educated but also well-equipped to meet the demands of today's employers, thereby reducing unemployment and fostering economic growth.

Pending court cases- When AIR news reader get fair justice

Around eight years ago on March 12, 2016, Prime Minister Narendra Modi expressed concern over the large number of cases pending in courts for years, saying there is a need to tackle them with speed when she used to read the bulletins in her baritone voice with clear pronunciation. She was a celebrity in her own right when Radio news was still regarded as sacrosanct. Since, post retirement around one decade ago, her life revolves around visiting the

PM Modi said during his address at a function held here at the end of the year-long Patna High Court centenary celebrations. The Prime Minister also suggested that the courts should come out with an annual bulletin, mentioning the number of pending cases in them and since when. Sadly, nothing has improved on this front and millions of people are suffering due to the snail pace of the delivery system in our courts. Along with legends like Devki Nandan Pande and Vinod

acquired their land in 1975. During those days GDA was known as Awaas Vikas. On the acquired land, GDA later developed Pratap Vihar, but it failed to pay even a single penny to all those poor people whose land was acquired by the GDA. Rather than cursing their luck, R.K. Mehra and many, many others are fighting to get their just and fair compensation from the GDA for their acquired land. He filed a case in the Ghaziabad court on February 2, 1978 so that he gets compensation. Since then, R.K. Mehra and

Sheela Mehra have been visiting the office of GDA. Except for the assurances from the top officials of GDA, nothing is happening. They are paying fees to their advocate even though their resources are very few. As they say, all the concerned officials on GDA even know their case file number- 21/1979, yet nothing is happening. Now, they are planning to meet the Uttar Pradesh Chief Minister, Yogi Adityanath to look into the cases of all of them on humanitarian

grounds as all those who are begging for the compensation are in twilight years of their lives. Can those seeking compensation from GDA get a fair deal sooner rather than later? Those who know the working of departments like GDA say that with just one order from the UP Chief Minister of the state, hundreds of helpless people can get their due. Though nothing is moving due to bureaucratic hassles and other reasons. Sheela Mehra says, " We had filed a case in the lower court of Ghaziabad with a hope

to get justice. But, we get dates from the court on a regular basis. On the day of the court, five people have to present there. They are the Judge, we as complainant of the case, our lawyer, GDA lawyer and GDA official. While both we and our advocate reach the GDA office in time, the same is not true for the other three persons. One of them remains absent for one reason or the other.”

It is a matter of grave concern that cases pending in various courts in the country have crossed the five-crore mark, Rajya Sabha was informed on July 20,2023. In a written reply, Law Minister Arjun Ram Meghwal said over 5.02 crore cases were pending in various courts -- the Supreme Court, the 25 high courts and subordinate courts. Pendency of cases in courts can be attributed to several factors, including non-availability of adequate number of judges and judicial

officers, supporting court staff and physical infrastructure, complexity of facts involved, nature of evidence, cooperation of stakeholders such as the Bar, investigation agencies, witnesses and litigants. Other factors that lead to delay in the disposal of cases include lack of prescribed time frame by respective courts for disposal of various kinds of cases, frequent Chief Minister, Yogi Adityanath directs the GDA to address the issues of compensation seekers, thousands of cases can be cleared within no time. That can bring smiles to the faces of people like Sheela Mehra and her husband. On February 17, Chief Justice of India D Y Chandrachud stressed the importance of focusing on trial courts to alleviate the increasing burden of cases in higher courts. He said, “Trial

cases, frequent adjournments and lack of adequate arrangement to monitor, track and bunch cases for hearing.

There is one view that the disposal of pending cases in courts is within the domain of the judiciary. The government has no direct role in the disposal of cases in courts. But, experts say that state or centre governments can also play an important role in disposing of the cases. For instance, if either top officials of UP government or the active and agile

He remarked, "Trial courts are where the solution to problems begins, there is a need to pay attention. "Justice delayed is justice denied" is a legal maxim. It means that if legal redress or equitable relief to an injured party is available, but is not forthcoming in a timely fashion, it is effectively the same as having no remedy at all. It is high time that India wakes up and provides cheap and quick justice to millions of people like Mehras.

He said that as a part of these changes, forensic team visits have now been made mandatory for offences carrying a sentence of 7 years or more. This will increase the demand for forensic experts across the country, which the NFSU will cater to. Mr. Shah said that human resources have to be created to implement these new criminal laws.

The union home minister said that having a laboratory, university and training institute in same campus itself will greatly simplify both the instructor and the trainee. He said that if a training institute is planned to be opened here, then the

campuses of this university have been opened in 9 states and work will be done to take this university to about 16 states of the country. This, he said, would create trained manpower and help in speeding up the pace of solving crimes and improving the conviction rate. also helps in strengthening the forensic infrastructure. Mr. Shah said this will help Police Sub Inspectors (PSIs), Deputy Superintendent of Police (DSPs) and Superintendent of Police (SPs) level officers and judges of Delhi, Punjab, Haryana, Himachal Pradesh, Jammu and Kashmir. He expressed confidence that this initiative taken today will bring changes in the criminal justice system of Haryana in the coming days.

Union Home Minister proposed the establishment of a

training institute at the Center of Excellence for training and laboratory testing facilities in forensic science, which will be set up on approximately 50 acres in Haryana. He said that the central government will make all arrangements for its establishment.

Speaking on this occasion, Union Minister of Power, Housing and Urban Affairs, Manohar Lal Khattar said that the conception of this center was envisioned in Surajkund in 2022, and today, through this MoU, this vision is being realized. He said that previously, there was only one forensic science lab in the state, but now four more are operational. With the establishment of the

National Forensic Science University campus here, victims will be able to get justice swiftly, said Khattar.

The Haryana Chief Minister, Nayab Singh said that the establishment of this center will greatly benefit the criminal justice system. Often, due to the lack of resources, justice is delayed, but with the new technology, we will be able to provide swift justice to the victims. During the Chintan Shivir in Surajkund, the union home minister envisioned the establishment of this campus, which is now becoming a reality. With the establishment of the National Forensic Science University, Haryana is taking the lead, and it will benefit the state, said Nayab Singh.

Tuberose farmers lament lack of marketing facilities

Berhampur (KCN): Cultivation of tuberose (Rajanigandha) flowers is a lucrative business. If marketed properly, it is a source of substantial earnings for farmers. However, lack of marketing facilities is hurting tuberose farmers in Ganjam district, locals informed Wednesday. The effort and energy spent in producing tuberose flowers pales in comparison to the meagre amounts earned, they added. Rajanigandha flowers are mainly cultivated in Digapahandi and Hinjilicut blocks of Ganjam district. More than 100 acres of land are used for the production of Rajanigandha flowers,

officials of the district Horticulture department informed. Farmers, however, alleged that as the state government has not put up a proper marketing system in place, they have to incur heavy losses. Ralabha village under Hinjilicut block is famous for its Rajanigandha cultivation. In fact, the place has been nicknamed 'Rajanigandha village'. Rajanigandha cultivation in the village started after the 1999 Super Cyclone. A resident of the village Jhumar Dalai, along with some young farmers started tuberose cultivation. Now more than 107 families of the village are engaged in the cultivation of Rajanigandha. Each of the

families cultivates tuberose on lands measuring 0.4 acre to one acre.

'Subhadra Yojana' to be launched on PM Modi's birthday, says Odisha CM

Bhubaneswar (KCN): Odisha Chief Minister Mohan Charan Majhi Sunday said that the 'Subhadra Yojana', a financial assistance scheme promised by the BJP in its election manifesto, will roll out September 17, the birthday of Prime Minister Narendra Modi. He also said that the Ratna Bhandar (treasury) of Lord Jagannath temple in Puri will be opened soon and an inventory of the valuables stored inside it will be made.

Majhi was addressing a felicitation programme organised by Odisha BJP here to felicitate the party's newly elected MPs and MLAs in the state.

"Subhadra Yojana will be launched on Prime Minister Narendra Modi's birthday on September 17," the chief minister said. Under the scheme named after Lord Jagannath's sister, cash vouchers of Rs 50,000 will be provided to women of the state.

"The Ratna Bhandar will be opened soon and an inventory of the valuables of Lords will be made. If any irregularities are found,



stern action will be taken against the guilty," Majhi said.

The reopening of the Ratna Bhandar, located in the basement of the 12th-century shrine in Puri, was a major political issue in the state during the assembly and Lok Sabha elections. The previous BJD government had promised that the treasury would be reopened for inventory and repair work during this year's Rath Jatra next month.

An inventory of the treasury was last made in 1978. In August last year, the Congress the then opposition BJO alleged that there is a "glaring mismatch" between the figures of the quantity of gold and silver ornaments

stored in the Ratna Bhandar mentioned by the BJD government in the state assembly and by the Shree Jagannath Temple Administration in an affidavit in the Orissa High Court.

Auditing of Ratna Bhandar's inventory was also in the manifesto of the BJP. The chief minister said that for proper management of the Puri Jagannath temple, his government has decided to create a Rs 500 corpus fund.

He said all promises made by the BJP in its manifesto will be covered in the 100-day action plan of the BJP government. Majhi said his government has also announced to procure paddy from Odisha farmers at an

MSP of Rs 3,100 per quintal from this Kharif season. Odisha BJP president Manmohan Samal indicated that more welfare would be announced by the state's saffron party government when it would complete 100 days.

Four major decisions on the Jagannath temple and farmers' issues were taken by the BJP government in its first cabinet are "just trailers", Samal said.

"Wait for the 100th day to see the picture," he said thanking the people of Odisha for bringing the BJP to power.

"We will have to work hard in the next five years," Samal said.

flowers grown in Ralabha are in great demand in various parts of the state. The total income for all the families can be well over rupees one crore annually if the product is marketed properly," Kalu Charan Dalai, a young farmer informed. The 'Krishi Vigyan Kendra' here is encouraging farmers of Ralabha village to take up cultivation of the 'Prajwal' variety of tuberose. It is a better product, officials said. "The new variety has two petals and hence weighs more. It is a better product for making garlands," opined chief and senior scientist of 'Krishi Vigyan Kendra', Dr Sujit Kumar Nath.

Scientists are also training the Rajanigandha farmers of Ralabha village by regularly organising discussion sessions. Farmers are attending workshops on soil testing, use of organic manures, benefits of using bio-fertilisers and phospho bacteria on their farmlands for better yields. Farmers have also welcomed this move, officials informed. Rajanigandha farmers meanwhile informed that they get an annual financial assistance of Rs 6,000 for cultivation of tuberose on 1.5 acres of land. They use the money to buy shoots and fertilisers, farmers said.

However, they reiterated that the absence of a proper marketing system is hurting them badly. They also lamented the lack of storage facilities. Farmers added that the government should address these issues. When contacted, assistant director Subhash Chandra Panda of the district Horticulture department informed that recently the state government has fixed the selling price at Rs 50 per kilogram for Rajanigandha farmers. He said that the collector of Ganjam has welcomed the move and will soon implement the rate in the district.

New Delhi: You couldn't help but agree with Hardik. It did feel like destiny. Like it was destined to end this way. With Rohit Sharma and Hardik Pandya, after everything they've been through in the two months leading into this June 29 clash at the Kensington Oval, left to write the final chapter of this remarkable saga for Indian cricket. The fact that Suryakumar Yadav would be the one pulling off a freakish catch to more or less seal the game. The fact that Virat Kohli would win his first T20 World Cup on his last day as a T20I cricketer. The fact that Rahul

Dravid would get to lift a World Cup trophy on his final day as head coach after having failed to do so as a cricketer. And of course, the fact that Hardik, after being booed and jeered in cricket stadiums all around India for nearly two months, would be the one delivering the finishing touch to one of Indian cricket's greatest days. Minutes after he'd bowled the final delivery to seal India's second T20 World Cup trophy win, Hardik was in tears. Not too far from him, Rohit was on the ground punching the ground with the bottom of his fist repeatedly before being swarmed by his teammates, while he remained face-down on the ground.

Virat Kohli had broken down the earliest, the moment the fifth delivery of the last over from Hardik didn't concede a boundary. Down on the long-off boundary, he threw his fist up in the air before immediately covering his eyes with his right hand. There were tears there, tears of joy, as he then took a deep breath put his hands to his knees and took a few more deep breaths while being bent and staring at the ground. He knew his team was

single ball left in his T20I career for India. Kohli wasn't the only one who couldn't wait for



Hardik to make sure his front foot was within the popping crease as he delivered the last ball before letting himself get sucked into the wave of ecstasy and jubilation as reserve players and

support staff stormed the field with Indian flags. While Rohit was on the ground, and Hardik stood motionless by the pitch just pointing at the sky, the others hugged and jumped and slid and threw themselves on each other. It was unbridled. Nobody bothered about staying in character. It was a moment to break free. It was then that it hit home that this World Cup win for India wasn't a feeling; it was an emotion. A collective emotion that was experienced by not just the players in the middle or the coaching staff led by Dravid or their families who joined

them in the middle of the Kensington Oval. But for millions of Indian cricket fans all around the world who'd held their collective breath when David Miller's skied shot was caught, then tossed up, and then caught again by Suryakumar Yadav only a few minutes earlier.

It was the kind of emotion that cannot easily be explained. There was pure joy for sure. But there was also relief, and that bit of unexplained mania. It wasn't an emotion you could feel. It had to be experienced.

Euro 2024: Late Bellingham, Harry Kane goals help England survive Slovakia scare in R16



New Delhi: England survived a massive scare from Slovakia in the Round of 16 clash in Euro 2024 on Sunday, 30 June. Playing at the Veltins-Arena, England managed to sneak in a come-from-behind 2-1 victory against 45th ranked Slovakia with goals from Jude Bellingham and Harry Kane. It was a heartbreak for Slovakia who were ahead even till the 90+5'th minute of the game when Bellingham stunned the crowd with the sensational bicycle kick to forced the game into extra time. Harry Kane added to Bellingham's goal in the first half of extra time to see England through to the quarter-final of the tournament.

England came back from the brink of elimination on Sunday. England played poorly in both halves of the match. Much of the issues came from Gareth Southgate playing Kieran Trippier and Phil Foden on the left side of the pitch, which they do not do with their clubs in LaLiga and Premier League respectively. After not showing enough desire in front of the goal for the majority of the game, England found their hero in Jude Bellingham, whose last-gasp bicycle kick took the match to extra time, with Harry Kane heading the winner. England were unable to get a foothold against a Slovakia team who were aggressive from the start and pressed their opponents relentlessly, taking the lead with an Ivan Schranz strike from a counter attack in the 25th minute. Declan Rice hit the post from long range as England desperately sought an equaliser, but it wasn't until five minutes into added time that Bellingham found the net, with his side's first shot on target in the game, before Kane headed home in the first minute of extra time. England will face Switzerland in the quarter-finals after they knocked-out defending champions Italy with a 2-0 win on Saturday.

New Delhi: Germany marched forward to the quarter-finals with a 2-0 win against Denmark. The match saw delays due to a thunderstorm, with goals by Kai Havertz and Jamal Musiala securing the victory. Kai Havertz and Jamal Musiala's second-half goals sent Germany into the Euro 2024 quarter-finals with a 2-0 win over Denmark on Saturday after their last-16 clash was delayed by a thunderstorm. The game was suspended for 20 minutes in the first half due to the weather before Danish defender Joachim Andersen went from hero to zero soon after the

break when his close-range finish was disallowed for offside and he conceded a penalty converted by Havertz in the 53rd minute.

Nico Schlotterbeck earlier had a goal ruled out for a foul in the build-up as Germany started strongly in front of an expectant crowd, but Denmark grew into the

game and went close either side of halftime. The hosts established an unassailable lead in the 68th minute, however, when Musiala ran on to a ball over the top and

curled home his third goal of the tournament to put Germany into the last eight, where they will face Spain or Georgia.

Germany started the game in command and goalkeeper Kasper Schmeichel was forced to make several saves as Denmark struggled to create any type of combinations, barely crossing the halfway line in the first 15 minutes. Buried deep with a back five that was just trying to survive Germany's onslaught, Denmark were lucky to avoid conceding in the opening half an hour.

New Delhi: Legendary fast bowler Wasim Akram hailed Virat Kohli after the latter's retirement from T20I cricket. Kohli won the player of the match award for his 76 off 59 balls. Legendary fast bowler Wasim Akram hailed Virat Kohli as one of the greatest of all time after the batter called time on his T20I career on Saturday, June 29. Virat Kohli won the player of the match award in the final T20I of his career, guiding India to their second T20 World Cup title. Wasim spoke about Kohli via a Twitter video and said that it was unfortunate that the current generation will not be able to watch Kohli play. Akram, who was in the Caribbean islands for his commentary engagements, hailed the Indian team for



showing incredible grit in the final of the tournament. Wasim felt that India was going to lose the final of the tournament when South Africa needed 30 runs in as many balls. Hurricane disrupts India's return after World Cup triumph in Barbados

New Delhi: After their World Cup win in Barbados, India are facing some obstacles in returning home. The Barbados government has issued a warning about a hurricane of 'very dangerous' category, throwing the return itinerary into a state of uncertainty and prompting the BCCI to make immediate arrangements. The Indian team will remain here in Bridgetown for one more day. As per the World Cup schedule, Sunday was designated as the reserve day for the final and the team was to fly out only on Monday. According to the initial itinerary, the team was supposed to fly to New York and then take Emirates flights to Mumbai but the BCCI managers are now forced to make alternative plans, with BCCI secretary Jay Shah himself overseeing the arrangements. The BCCI is first trying to determine whether the Barbados airport will remain open and it is learnt that it may be closed from 8 pm on Sunday night. So the board is now considering hiring a charter from the US to fly directly to India. "Beryl, the first hurricane of the 2024 Atlantic



season, intensified into a 'very dangerous' Category 3 storm on Sunday morning as it churned toward Barbados and the Windward Islands, promising destructive hurricane-force winds and life-threatening storm surge, according to the National Hurricane Center," CNN reported. With the unexpected development of the hurricane in the way, the itinerary is being tweaked. The entire entourage, including support staff, families, and officials, consists of about 70 members, requiring an aircraft large enough to accommodate

everyone. Such aircrafts are apparently not available in the Caribbean, so efforts are

underway to secure one from the United States. As of Sunday, the plan is to fly all the team

members and their families to New Delhi, where a meeting with Prime Minister Narendra Modi is being considered. The Prime Minister personally called several team members, including captain Rohit Sharma, coach Rahul Dravid, and star batsman Virat Kohli, to congratulate them after Saturday's victory. On his part, Shah said, "This team truly embodies a rising, vibrant, and resilient India, asserting its rightful place in the world of cricket. I am delighted that, as the governing body of the sport in India, the BCCI has played a part in this team's success through our relentless focus on identifying, grooming, and nurturing the right talent. Under the exceptional leadership of Rohit Sharma, this team has shown

remarkable resolve and resilience, becoming the first team in the history of the ICCT20 World Cup to win the tournament unbeaten. "They have faced and silenced their critics with stellar performances time and again. Their journey has been nothing short of inspirational. Led by Rohit Sharma, and ably assisted by Virat Kohli, Jasprit Bumrah and others they have fulfilled the dreams and aspirations of 1.4 billion Indians." Earlier in the evening, Shah on behalf of BCCI announced a whopping prize money of INR 125 crore to the Indian team as an incentive for winning the World Cup.
