Odisha Deputy CM Evaluates Gop CHC, Commits to Enhancements



Bhubaneswar, (KCN Bureau): In a significant move to assess and enhance healthcare facilities in Puri district, the Deputy Chief Minister of Odisha, Pravita Parida visited the Gop Community Health Centre (CHC) on Wednesday. During her visit, she engaged in a comprehensive discussion with the medical superintendent of the CHC, Dr. Jasmine Afroz, regarding the current health system and treatment protocols. The Deputy Chief

Minister emphasized the importance of maintaining vigilance in delivering health services to the local population. She conducted an extensive tour of the facility, visiting each patient ward to personally assess the conditions and care. She interacted with the patients, doctors, nursing staff and office bearers to discuss the conducive atmosphere of the CHC. Superintendent Dr. Afroz brought to the Deputy Chief Minister's attention the requirement for a

new ambulance. In response, Deputy CM Parida assured that an ambulance vehicle would be made available to the medical center soon. After her visit, the Deputy Chief Minister expressed her satisfaction with the overall health services at Gop CHC. She lauded the efforts of the medical staff and encouraged them to continue their dedicated service to the community. Her visit underscores the government's commitment to enhancing healthcare facilities and ensuring that quality medical services are accessible to all citizens in the region.

Champai Soren resigns as Jharkhand CM, Hemant stakes claim to form govt



Ranchi (KCN): Jharkhand Chief Minister Champai Soren Wednesday resigned from his post, following which JMM leader Hemant Soren called on Governor CP Radhakrishnan and staked claim to form the government. Earlier in the day, leaders and MLAs of the ruling coalition at a meeting at Champai Soren's residence here unanimously decided to elect Hemant Soren as the

JMM legislature party leader. "I have resigned as per the decision of the JMM-led alliance. Our alliance is strong," Champai Soren said after coming out of Raj Bhavan. "All know what had happened with

Hemant Soren Ji... I was given the responsibility by the coalition partners. Now, the alliance has decided in favour of Hemant Soren Ji," he said. Hemant Soren was released from jail on June 28 after nearly five months, after the high court granted him bail in a money laundering case linked to an alleged land scam. He had resigned as the CM shortly before his arrest on January 31.

Harsimrat K Badal raised farmers' and other Punjab related issues in Lok Sabha

Chandigarh (JAG MOHAN THAKEN), July 3: Raising farmers' and other Punjab related issues in Lok Sabha, Shiromani Akali Dal leader and Bathinda MP Harsimrat Kaur Badal on Tuesday appealed to the union government to resolve all grievances of farmers through mutual discussion and by giving them representation in the MSP Committee as promised besides calling for opening of the Wagah and Hussainiwal borders for trade with Pakistan and Central Asia and institution of an industrial package for Punjab, especially its border areas.

The Bathinda MP, while speaking on the President's Address in parliament, also made a fervent appeal for the immediate transfer of Chandigarh to Punjab, saying the latter was the only State which did not have control over its capital city. She also castigated the attempts being made to dilute Punjab's right over Chandigarh by disregarding the 60:40 ratio in posting of officers of Punjab and Haryana in the union territory, implementing central rules in the UT and discriminating against Punjabi in official functioning.

Mrs Harsimrat Badal in her awe-inspiring speech also asserted that the Shiromani Akali Dal (SAD) had fought to ensure Punjab was not robbed of its river waters and asserted that injustice should not be done to the State on this account. She also reminded the union government of its commitment during the 550th birth anniversary celebrations of Sri Guru Nanak Dev Ji in 2019 to release all Bandi Singhs. She said it was unfortunate that the government had taken an about turn on this issue by first stating in court that the Sikh

detainees were a threat to society and later demanding the detainees apologize for their acts. She also flagged the manner in which Sikh women were being discriminated against in their own country by being forced to remove their articles of faith (Kakaar) as had happened at an

examination centre in Rajasthan recently.

Speaking about the need to address the grievances of farmers, Mrs Harsimrat Badal said farmers had been given a guarantee when they had lifted the Kisan Andolan on the borders of Delhi that all their demands would be considered sympathetically and that a committee would be formed to make MSP a legal entity. "This is yet to be done and instead farmers were tear-gassed by the Haryana Police and one of them was even martyred when they tried to proceed to Delhi to

remind the centre about the promises made to them some months back".

Mrs Badal also called for giving a special industrial package to Punjab stating "Punjab lost out immensely when the neighbouring hill States were given tax concessions to give a fillip to industrial development. While resulting in shifting of a section of Punjab industry to the hill States it has also resulted in unemployment. An industrial package is the need of the hour, especially in the border belt". She also called for opening of the Wagah

and asked all concerned servitors to execute their duties on time.

This will be the first such occasion when the President will participate in the Rath Yatra, the Gajapati said.

He also informed that the Justice Arijit Pasayat committee is expected to have its meeting July 5 and stated that the initiative to open the Bhitar Ratna Bhandar (inner treasury compartment) of the temple may be taken. Lord Jagannath, His siblings recover from sickness, ready for Puri Rath Yatra

Puri(KCN): A team of senior Daitapatis and Pati Mahapatra servitors of the Sri Jagannath temple Wednesday apprised the Gajapati King about the recovery of Lord Jagannath, His elder brother Lord Balabhadra, and their sister Devi Subhadra from sickness. The servitors, in a Ghanta, Chhata, and Kahali procession, went to Sri Nahar (the royal palace) located alongside the Badadanda near the Srimandir in a ceremony called "Rajprasad Bije." They informed the Gajapati King that the deities would be ready to ride their respective chariots to the Gundicha temple on a nine-day sojourn starting July 7. The deities had been in the sick house, supposedly suffering from fever after the

recovery of the deities from fever in the Anasargha (sick room) of the temple. They said that after the administration of Phuluri oil and Dasmula Oushadhi, the deities are recovering. The deities have changed their sick clothes from white to coloured ones and have been made to sit on platforms called "Chaka Bije." Orissa High Court order limiting period of bail to two months 'incorrect', says Supreme Court



New Delhi(KCN): The Supreme Court has termed as 'incorrect' an order of the Orissa High Court which limited the period of bail granted to an accused in a case lodged under the Narcotic Drugs and Psychotropic Substances (NDPS) Act to two months.

The bench, while referring to a verdict

settled that the right to speedy trial is recognised as a fundamental right guaranteed by the Constitution and is closely tied to the right to life and personal

liberty. A vacation bench of Justices JB Pardiwala and Ujjal Bhuyan noted that the petitioner had filed a bail application in the high court which had taken notice of the fact that the petitioner was in custody since May 11, 2022, and only one witness was examined so far.

"In such circumstances,

the high court thought it fit to order the release of the petitioner on bail pending final disposal of the trial itself," the apex court said in its July 1 order. It

Later, the National School of Drama in New Delhi expanded Theater in Education. Abdul Latif Khatana and Swarn Rawat of NSD were in charge. NSD first show of Theater in Education in the basement of the Kala Mandir in Kolkata, which became a new pattern in acting. Using his experience in theater in education, Samir Mitra admitted him to an English medium school in Asansol. At the same time, he found Rabindra Bharti University drama examiner Moinul Haque. Samir Mitra created an example of the children and their mothers of the notorious red light area of Asansol with this theater in education. The emerging energy crisis, dwindling fossil fuel resources and climate change concerns along with high oil prices have drawn global attention towards the development of renewable, alternative, eco-friendly and carbon neutral fuels to meet the growing energy demands.

Recently, in the G-7 summit held in Apulia, Italy, once again the energy sector was discussed in detail. This shows the increasing importance of the energy sector in the world. It has been said in the conference that the G-7, a group of the seven most prosperous countries in the world, will reduce dependence on fossil fuels and will move rapidly towards adopting changing sources of energy. This was said in the draft statement issued by the group at the end of the conference. The draft states that they will gradually reduce dependence on fossil fuels in a systematic manner. They will make serious efforts together in this decade to achieve the target of zero carbon emissions by 2050. It has been said in this document that by 2035, the process of reducing coal-based power generation will begin and concrete steps will be taken in this direction.

It is worth noting that

in the month of April, the finance ministers of the G-7 countries agreed on this proposal. Prime Minister Narendra Modi, who was invited as a special guest in the conference, said that India's approach in the field of energy is based on four principles - availability, access, affordability and acceptability. We are making every effort to fulfil our commitment to achieve the goal of net zero by 2070. Addressing the global leaders, Modi said that we should together try to make the coming time a green era. He said that India is the first country to fulfil all the commitments taken under COP before time. Underlining the importance of the energy sector, he also said that we should together make every effort to make the coming time a green era.

Why is the energy sector being discussed so seriously again and again? Why is this issue being raised every time on global forums? Actually, the world is facing crises in the energy sector. Everyone has understood that the coming time will be very challenging if this sector

is not given serious attention now. The emerging energy crisis, dwindling fossil fuel resources and climate change concerns along with high oil prices have drawn global attention towards the development of renewable, alternative, eco-friendly and carbon neutral fuels to meet the growing energy demands. Most energy crises have been caused by local shortages, wars and market manipulation. Some have argued that government actions such as tax hikes, nationalisation of energy companies and regulation of the sector have exacerbated the crisis.

As for India, there are several challenges in tackling its energy crisis. Firstly, everyone has limited energy resources. India has limited energy resources such as coal, oil and gas and is dependent on imports to meet its growing energy demands. The estimated value of petroleum imports for FY23 is estimated at around US\$210 billion. This includes import value of US\$163 billion for crude oil and US\$17.6 billion and US\$14 billion for LNG and LPG respectively. Crude oil

imports have increased by 53 per cent compared to the previous financial year. At the same time, coal reserves are weak and there are significant environmental concerns associated with their extraction and use. As a result, India is looking for alternative sources of energy, such as solar, wind and hydropower.

There is currently inadequate investment in the country's energy sector. The country's energy sector needs massive investment to improve its infrastructure and expand its energy capacity, but the government and the private sector are not able to invest enough in the energy sector. The country's low per capita income and high poverty rate also make it difficult for people to afford clean energy sources. According to a report, the industry sector in the country consumes the most electricity, about 42 percent. The domestic sector is second, consuming 24 percent

electricity. Commercial buildings consume eight percent of electricity. The building sector accounts for 32 per cent of total consumption, but the implementation of energy efficiency standards in buildings has been the lowest.

Actually, the country needs rapid reforms in the energy sector. First of all, to reduce dependence on imports, attention will have to be paid to improving the quality of domestic coal. This can be achieved by investing in technology to increase the calorific value of coal and reduce the amount of ash. At the same time, renewable energy will have to be encouraged. The country has immense potential for renewable energy sources such as solar, wind and hydropower. The government should encourage the development of renewable energy projects through incentives and subsidies. Carbon pricing can help encourage the use of renewable energy. At the same time, investment will have to be made in the development of energy infrastructure to ensure efficient transmission and distribution of energy.

This can be achieved through upgrading existing infrastructure and building new power plants, pipelines and transmission lines.

Many potential solutions to the global energy crisis already exist, but they are not being widely used. The best solution is to

purchased, this will save electricity. The list of electrical appliances used in homes; buildings include more than a hundred appliances. It has to be ensured that all energy appliances used in buildings are within the ambit of efficiency standards and they should be implemented compulsorily and not voluntarily. At the same time, there should be a ban on the sale of appliances without ratings. Experts say that in the last few years people have become more aware about energy efficiency, but there is still a need to be more aware. We have to take care of small things. In this way, we can save electricity with small efforts and all of us have to adopt such efforts.

The Punjab Pradesh Mahila Congress President Gursharan Kaur Randhawa also urged the residents of Jalandhar West to vote for Congress in the upcoming by-elections on the 10th of July to ensure such issues do not persist and to facilitate real progress and betterment in the area. The Punjab Pradesh Mahila Congress, led by President Gursharan Kaur Randhawa and Dr. Jasleen Kaur Sethi, National Coordinator of the All-India Mahila Congress, organized a massive protest against the administration of Jalandhar and the state government. The protest was in response to the severe contamination of drinking water in the Jalandhar West region, resulting from the mixing of sewage water with drinking water following the first monsoon showers over the past few days.

The protesting leaders alleged, "The region has also experienced severe water logging after the initial rains of the season, with major areas of Jalandhar West submerged under knee-deep water due to improper drainage systems. This situation is of significant concern as it leads to the breeding of mosquitoes and other health issues such as typhoid, which are prevalent during the monsoon season."

Odisha: Joda flyover cracks spark concern

Joda(KCN): The appearance of cracks on the newly-built flyover passing through this town in Keonjhar district has sparked concern among the residents. Regular commuters are now questioning the quality of its construction. The flyover was opened for public use March 11, 2024. Hence the appearance of cracks in less than four months of its inauguration has created serious apprehensions in the minds of the commuters. It's not just the cracks that are bothering the users. At various places concrete slabs have

become loose and at other places iron rods are protruding out putting the lives of the commuters at risk. Someone can seriously get injured due to the rods, they opined.

After initial reports of the damages surfaced, Odisha Bridge Construction Corporation Ltd (OBCCL), the main agency entrusted with the responsibility of building the flyover acknowledged the issues and stopped movement of heavy vehicles and started repairing the bridge. Residents are now worried as to whether they should use

the flyover or not. They have blamed the shoddy work of the agency for the present state of affairs. Locals said the Joda flyover is deemed as the longest in Odisha. The state government had sanctioned ₹250 crore for construction of the flyover which is 2.9km in length.

Narasingh Mohanta, general manager of OBBCL had claimed after the flyover's inauguration that it can endure the movements of heavy to very heavy vehicles. However, now it seems those claims were false. Mohanta had also asserted that



with proper maintenance, the flyover will last more than 100 years. He had also claimed that using of rubber bearings in place of iron ones will increase the durability of the bridge. Now it

seems that the tall claims have fallen flat. Such is the condition of the flyover that it shakes violently when a couple of heavy vehicles pass over it at the same time. Pictures of the shaking bridge have gone viral on several social media platforms. However, more importantly, residents of this town remain panic-stricken when they use the bridge.

Residents alleged that the previous state government inaugurated the flyover hastily without conducting proper examination as both the Lok Sabha and the Assembly elections were on the anvil. They wanted to take credit for construction of the bridge. Now however, safety concerns have cropped up in a major way due to the wear and tear of the bridge.

When contacted, Bhagirathi Panda, a human resources official of 'Chevrox Constructions Private Ltd' which had received the contract from OBCCL for construction said the flyover has a capacity to take a maximum load of 200 tonne at any particular time. However, the movements of heavy vehicles have not been streamlined. Hence there are many occasions when the bridge has to bear weight exceeding its capacity. Panda said that this is the main reason why the 'wearing coat' (upper layer) is peeling off. Unless the weight is streamlined, the flyover will suffer excessive wear and tear, he added. Panda informed that the flyover has been closed for commuters as a fresh layer of 'wearing coat' is being laid. He also added that the service roads leading to the flyover will be concretised.

Blood bank-ruptcy

Bhubaneswar(KCN): The state is presently facing an acute shortage of blood, with blood banks at 10 hospitals, including the SCB Medical College and Hospital in Cuttack, running completely dry, Tuesday.

As per information accessed by Orissa POST, apart from SCB, the SDH Baliguda in Kandhamal; NALCO Hospital, Damanjodi; DHH, Nuapada; SDH, Athamallik; Apollo Hospitals, Bhubaneswar; DHH Baripada; SDH, Dharmagarh; AMRI Hospitals, Bhubaneswar and NALCO Hospital, Angul had exhausted stock of the life-saving fluid by Tuesday morning. Also, baring a few, many of the remaining 50 blood banks were having single digit stock that may prove insufficient in case of exigencies.

For example, DHH Khurda has just one unit of blood, while SDH Rairakhol (4), CHC Jajpur Road (3), DHH Paralakhemundi (3), SDH Gunupur (6), SDH

Rairangpur (3), SDH Kantabanji (2), SDH, Champua (2), DHH Boudh (8), DHH, Puri (8), DHH Sonepur (3), DHH Keonjhar (6), CRCBC Cuttack (8), SDH Titilagarh (3), DHH, Jajpur (4) and DHH, Kendrapara (6) as stock. Sources said with a total of 2,326 units, the 60 blood banks in the state are having just 10 per cent of their regular storage at present.

Top sources in the Health department said the situation looks precarious in the backdrop of the fact that the state requires at least 40,000 units of blood for various healthcare facilities every month (4-5 lakh units per year) for regular and scheduled transfusions. Hospitals in Cuttack city alone need around 4,000 units of blood every month, they said. "Due to the present shortfall, we are also facing difficulties in administering blood to thalassemia (state has 17,000 thalassemia cases) and sickle cell patients who are solely dependent on blood banks for their regular requirements," sources added.

While authorities attributed the long election season and grueling summer months for the present scarcity, organizations engaged in collection of blood alleged that the problem has been persisting since long in the absence of any policy framework. Swaroop Das, Assistant Director, State Blood Transfusion Council (SBTC), the apex body for operation of blood banks in Odisha, told Orissa POST that the present 'deficit' was on account of the 'lean' collection months. "Blood collection took a beating during the three-four election months as donation camps were few. Moreover, during summer season people are often averse to donate due to heat conditions. Also, most of the schools and colleges (students constitute a majority of blood donors) were closed due to summer vacation," he said.

Spokesperson of a

voluntary outfit, which organises blood donation camps across the state, claimed that successive governments' failure in streamlining the 'voluntary act' of blood donation through a defined policy and lack of incentives to donors were playing the dampener in the process.

He said situation has come to such a passé that patients at several hospitals are being fleeced by middlemen while arranging donors in exchange of getting transfusions. It is worth mentioning here that while organisations like Rotary Club, Lion's Club and other voluntary/social groups are contributors to blood banks, the majority regular stock used to be supplied by volunteers of Odisha Mo Parivar.

Meanwhile, despite several attempts, Health and Family Welfare Minister Mukesh Mahaling could not be contacted for his

response over phone.

Doctors at HCG Panda Cancer Hospital successfully treated 33-year-old suffering from a rare case of Salivary Gland Cancer

Bhubaneswar / Cuttack : Doctors at HCG Panda Cancer Hospital, Cuttack, treated 33-year-old Reema (name changed), hailing from Western Odisha, from Parotid Gland Carcinoma, a rare form of cancer that occurs in the salivary glands situated right below the ear lobes. The cancerous gland was resected by conducting an advanced form of Total Parotidectomy Surgery on the patient while preserving her facial nerves, which are responsible for facial expressions. This incredible feat was achieved by Dr Manjunath NML, Senior consultant Surgical Oncologist and his team at HCG Panda Cancer Hospital Cuttack.

Reema suffered from unexplained excruciating pain continuously on the face and earlobes for a period of 8 months. In order to get relief from the pain, she visited neurological specialists and physicians from multiple hospital where she was misdiagnosed for other neurological diseases and was treated with analgesics, as they failed to diagnose her actual condition. She consulted the doctors at HCG Panda Cancer Hospital, who discovered a vague swelling near the earlobes and with suspicion of a tumour. Imaging of the parotid gland was conducted to check for any malignancy and it was discovered that she had a parotid lobe tumour in the

Shakib undecided on India tour participation

Dhaka: Bangladesh all-rounder Shakib Al Hasan is unsure if he'll be part of the upcoming tour of India. Bangladesh are scheduled to play two Tests and three T20Is against India from September 19 to October 12 following their tour of Pakistan in August, where they are slated to play a two-match Test series.

The 37-year-old Shakib, who left Dhaka for USA on Monday (July 1) to play for the Los Angeles Knight Riders in the upcoming Major League Cricket, said that he was not thinking too far ahead and until now has planned only up to the tour of Pakistan.

"I don't have many plans. There are two T20 tournaments in front of me one is MLC and the other one is the Global T20 League in Canada and let me see where I stand after playing these two tournaments because I need to understand

[how I feel]," Shakib told reporters at the Airport on Tuesday before departing for the USA.

"There is international cricket and there is a series against Pakistan and I am planning till that point of time and not planning beyond that. Now I don't have time to plan for three four years and so planning for three to six months is better and later will think about my next plan and so till now I am planning till the Pakistan series," he added.

Shakib also revealed that pace bowler Taskin Ahmed had apologised to his teammates for missing the game against India. Cricbuzz reported that Taskin had missed the team bus and reached late at the Sir Vivian Richards Stadium in Antigua for the teams' Super-8 clash of the just-concluded T20 World Cup.

"The team bus starts at a certain point and

there is a rule for cricketers that team bus does not stop for anyone and if anyone misses it in that case he comes in the next car. The manager's car or a taxi is there and the support of transport was difficult in the West Indies. When Taskin arrived it was five to 10 minutes before the toss and certainly it was difficult to pick him at that point in the team and it was difficult for him as well," Shakib said.

Taskin apologized to the team for that afterwards and everyone in the team took it normally because a man can make a mistake and anyone can commit unintentional mistake and he accepted it and the thing ended at that point of time," he said.

Nazmul not happy with Bangladesh approach against Afghanistan

Meanwhile, Bangladesh Cricket Board president Nazmul Hasan was critical of the



team's approach in the Super 8 game against Afghanistan for their failure to try and force qualification to the semifinals.

Bangladesh were required to score 115 in 12.1 over to advance to the last-four on better Net Run-Rate but the opportunity went in vain as well as they pulled the plug on chasing qualification and

eventually lost the game to Afghanistan to help them secure their spot in a World Cup semi-final for the first time in their cricketing history.

"We are happy that we have reached the Super-8, but it is not acceptable that they did not try after losing three wickets [against Afghanistan].

"I think we should have tried till the 12 over but what I have seen is that we defended when we were expected to hit while we hit when we were expected to defend and so what can I say," Nazmul told reporters

Euro 2024: Demiral brace powers Turkey into quarters with 2-1 win over Austria



New Delhi: Turkey's Merih Demiral shone with a goal in each half and goalkeeper Mert Gunok made a crucial stoppage-time save, securing a thrilling 2-1 victory over Austria on Tuesday to advance to the Euro 2024 quarter-finals. The man-of-the-match, Demiral, scored just 57 seconds in and added a powerful header just before the hour mark.

This set up a quarter-final clash on Saturday in Berlin against the Netherlands, who

defeated Romania 3-0 earlier the same day. Austria's Michael Gregoritsch reduced the deficit midway through the second half, but their hopes of equalizing were dashed in the final seconds when Christoph Baumgartner's header was brilliantly saved by Gunok. Celebrations erupted across several German cities as Turkish fans took to the streets, honking car horns, waving flags, and chanting in anticipation of a potential repeat of their Euro 2008 semi-final run.

For Austria, considered dark horses of the tournament, it was a bitter exit, as they are still waiting for their first knockout match win in a major tournament since 1954. Turkey grabbed the lead in a frenetic start when Demiral capitalised on a goalmouth scramble following a corner, scoring the fastest goal in Euros knockout stage history. Despite ceding possession to Austria, who had defeated them 6-1 in a friendly in March, Turkey pressed high and

aimed to catch their opponents on the break, disrupting Austria's typical playing style. Even without their suspended captain Hakan Calhanoglu, Turkey managed to keep Austria at bay in the first half, with Ralf Rangnick's team failing to register a shot on target. Austria intensified their efforts after the break, and captain Marko Arnautovic should have equalized six minutes into the second half, but Gunok blocked his one-on-one attempt.

Instead, Turkey extended their lead with Demiral's second goal, a powerful header from another corner delivered by the impressive teenager Arda Guler in the 59th minute. In pouring rain, Austria pulled one back through substitute Gregoritsch in the 66th minute and amassed 20 attempts on goal as they sought an equaliser.

South Africa's David Miller rubishes rumours of T20I retirement: 'The best is yet to come'

New Delhi: South Africa's veteran batter David Miller rubished rumours that he had retired from T20 Internationals after the World Cup final heartbreak against India in Barbados. Miller took to social media on Tuesday, July 2 to confirm he would be available to play for the Proteas in the shortest format of the game.

David Miller acknowledged that several news reports claimed that the 35-year-old announced his retirement from T20Is after the T20 World Cup final on Saturday. Miller, 35, was heartbroken and gutted after the big final as he was not able to finish the game in South Africa's chase of 177. "Contrary to reports, I have not retired from T20 international cricket. I will continue to be available for the Proteas. The best is yet to come," Miller wrote in his Instagram story.

Indian team set to return home from Barbados following hurricane-induced delay

New Delhi: The Indian team, stranded in Bridgetown, Barbados since the World Cup triumph on June 29, is set to depart the Caribbean island on Tuesday night. As previously reported by Cricbuzz, they will fly directly to New Delhi, where they are expected to meet with the Prime Minister.

Members of the squad, support staff, and their families have been stranded on the island for the past two days due to flight cancellations caused by Hurricane Beryl, which hit this part of the world on Monday with high intensity. As a precautionary measure, the entire island was shut

down for two days, forcing the players to remain confined to their hotel. The BCCI managers have been attempting to arrange a private jet/charter flight to transport the players home, but they have faced obstacles due to the closure of the airport. As of the time of filing this report (Tuesday morning local time), Grantley Adams International Airport (GAIA) remains closed. However, it is anticipated to reopen later today, with air traffic expected to resume.

Local media reported that the airport has remained unaffected



'during the passage of Hurricane Beryl.' While teams at the Grantley Adams International Airport were assessing damages to the facility in the wake of Hurricane Beryl immediately following the all-clear given by Minister of Home Affairs Wilfred Abrahams on Monday afternoon, the initial report is that damages were at a minimum. "We just need to make sure that when we do our assessment, everything is clean and safe so that we can welcome our passengers because, as you can appreciate, after the all-clear is given by the officials, which it has, then our team needs to come in and do their

assessment so that everyone else can have their operations run as smoothly as possible," an airport official told Cricbuzz.

Balaji yet to accept TN role

The Tamil Nadu Cricket Association (TNCA) has confirmed to Cricbuzz that Lakshmi Balaji has been appointed as the coach of the state side for the upcoming domestic season. However, there remains uncertainty regarding whether he will

take over from the Sri Lanka series scheduled later in this month. India's tour of Zimbabwe is being overseen by the NCA staff headed by VVS Laxman.

SA players leave Barbados

The members of the South Africa side, who lost to India in the final, managed to leave the shores of Barbados before Hurricane Beryl hit the island. In fact only three players - Keshav Maharaj, Ottneil Baartman and Lungi Ngidi - were to return home after the final and the rest have left Barbados to take part in the Major League Cricket (MLC) or Lanka Premier League (LPL).
