To browbeat and bully others is vintage Congress culture', says PM Modi on lawyers' letter to CJI



NEW DELHI, (KCN):

Reading to an open letter to the Chief Justice of India, D.Y. Chandrachud, which was signed by over 600 advocates on Thursday, Prime Minister Narendra Modi said that to "browbeat and bully others is the vintage culture of the Congress".

The country's top advocates, including Harish Salve, Pinky Anand, Manan Kumar Mishra, Chetan Mittal, Hitesh Jain, and many others, sent an open letter to the CJI on Thursday morning, expressing their concern over the attempts made

they shamelessly want commitment from others for their selfish interests but desist from any commitment towards the nation."

"No wonder 140 crore Indians are rejecting them," PM Modi added, in a veiled dig at the grand old party's flagging fortunes as the latter gets overpowered by its allies in the seat-sharing talks for the ensuing Lok Sabha elections.

The open letter, dated March 26, said, "Their pressure tactics are most obvious in the political cases, particularly those involving political figures accused of corruption." Though the identities of the vested interest groups remain unclear, the lawyers claimed, "A false narrative of supposed 'better past' and 'golden period' of the courts, contrasting it with the happenings in the present, was being presented.

NEW DELHI, (KCN): The Centre has notified a 3-10 per cent increase in the wage rates for workers under the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGA) for the financial year 2024-25. The new wage rates will come into effect from April 1.

The average MGNREGA wage nationwide for

2024-25 will be Rs 289

up from Rs 261 for 2023-24 which is an increase of Rs 28 per day.

The increase in wage

rate varies from 3 per

cent for Uttar Pradesh and Uttarakhand to 10.56 per cent for Goa and 10.4 per cent for Karnataka. In the case of Andhra

Pradesh, the increase is 10.29 per cent, Telangana (10.29 per cent) and Chattisgarh (9.95 per cent).

Currently, MGNREGA wages are linked to changes in the rural inflation rate as measured by Consumer Price Index- Agriculture Labour.

The Rural Development Ministry had recently obtained the Election Commission's permission

to notify the revised wage rates as the model code of conduct has come into force for the Lok Sabha elections.

Workers in Haryana will get the highest wage of Rs 374 per day. The lowest has been fixed for Arunachal Pradesh and Nagaland at Rs 234 per day.

The Centre has allocated Rs 86,000 crore for MGNREGA in the Union budget for 2024-25.

Only 4 per cent of Indian firms are 'mature' to tackle modern cyber attacks: Report

NEW DELHI, (KCN): Only 4 per cent of organisations in India have the "mature" level of readiness needed to be resilient against modern cybersecurity risks, a new report showed on Thursday.

Readiness is critical as 82 per cent of respondents said a cybersecurity incident is likely to disrupt

their business in the next 12 to 24 months, according to Cisco's '2024 Cybersecurity Readiness Index.'

However, 88 per cent of companies still feel "moderately to very confident" in their ability to defend against a cyberattack with their current infrastructure.

"We cannot underestimate

the threat posed by our own overconfidence," said Jeetu Patel, EVP and General Manager of Security and Collaboration at Cisco.

"Today's organisations need to prioritise investments in integrated platforms and lean into AI in order to operate at machine scale and finally tip the scales in the favour

of defenders," Patel added. Almost all (99 per cent) companies globally expect to increase their cybersecurity budgets in the next 12 months.

About 71 per cent of companies plan to significantly upgrade their IT infrastructure in the next 12 to 24 months.

"They must also ensure that AI is integrated into

frontline defenses as part of their overall cybersecurity strategy to fortify their defenses against evolving threats, futureproof their operations, and strengthen security resilience in a digital-first world," said Samir Kumar Mishra, Director, Security Business, Cisco India & SAARC.

The Chief Electoral Officer said that after the implementation of the Model Code of Conduct, any candidate or political party giving advertisements for printing or broadcasting in print or electronic media will be required to verify whether the advertisement has been certified by the Media Certification

and Monitoring Committee (MCMC). He said that the MCMC committee has been formed at the central, state, and district levels, and candidates or political parties don't need to obtain certification

only from Haryana's MCMC committee. Candidates or political parties can also obtain certification from the MCMC committee located in Delhi, which will also be valid in Haryana. He advised the media

to refrain from broadcasting communal, illegal, casteist, and anti-national news.

CEO Agarwal, providing information about the rules and guidelines set by the Press Council of India

and the News Broadcasting Standards Authority, said that during the Model Code of Conduct, the media should refrain from broadcasting communal, illegal, casteist, and anti-national news.

He said that various types of advertising material are printed by candidates and political parties for election campaigning, so it is necessary to send the printed material by the publisher and printer to the office of the concerned District Magistrate or Chief Electoral Officer.

He said that if any individual prints or broadcasts advertising material on behalf of a candidate or political party, then the media organization will have to check whether the individual has obtained consent from the candidate or political party. If advertising material is being printed or broadcasted with the consent of the candidate or political party, then the expenditure of the advertisement will be added to the election expenses of that candidate or political party. If any advertising is being done without the consent of the

candidate or political party, a case will be filed against that individual. The Chief Electoral Officer said that the media should ensure balanced and unbiased reporting so that citizens receive accurate and truthful news, avoiding any kind of misinformation. He said that to increase voters' trust, the Voter Verified Paper Audit Trail (VVPAT) will be used again this time. When the voter casts his vote, the VVPAT screen will display the voter's vote for 7 seconds. This gives the voter the confidence that the vote he has cast has gone to the intended candidate.

Six-time BJD MP Bhartruhari Mahtab joins BJP

BHUBANESWAR, (KCN): Six-time MP Bhartruhari Mahtab, who recently resigned from the primary membership of Biju Janata Dal (BJD), joined Bharatiya Janata Party (BJP) on Thursday. Besides, former BJD MP Siddhant Mohapatra and noted litterateur Damayanti Besra also joined the BJP at party headquarters in Delhi.

Bhartruhari joined the saffron party formally at the party headquarters in New Delhi today. He had quit the ruling party in Odisha on March 22. At that time, speculation was rife that Mahatab would join the BJP.

The son of Odisha's former Chief Minister Harekrushna Mahtab,

Bhartruhari has been representing the prestigious Cuttack Parliamentary seat since 1998. He had also been BJD's floor leader in Lok Sabha from 2014 to 2019. He emerged victorious as a Parliamentarian for successive six times in 1998, 1999, 2004, 2009, 2014 and 2019.

Bhartruhari bagged the prestigious Outstanding Parliamentarian Award in 2017. He was also conferred with Sansad Ratna awards in 2017, 2018, 2019 and 2020.

Bhartruhari is currently the chairperson of the Parliament Standing Committee on Labour,



Textiles and Skill Development. He is also the deputy chairperson of the Committee of Parliament on Official Language, and a member of the Public Accounts Committee.

“My decision to snap my umbilical cord with BJD

may be harsh but it has given me immense relief. This is because I had been living with a kind of pain. When it became unbearable, I took the decision,” Bhartruhari had earlier said.

Bhartruhari has been critical of the functioning

of the BJD and the Odisha government in multiple editorials of his newspaper. Notably, Bhartruhari's resignation from BJD came a day after the Special Court for MP/MLAs framed charges against him in connection with the alleged assault on a police officer.

After joining the BJP, Mahtab said, “Sometimes, taking a decision in life becomes inevitable. As per my experience of 28 years, three things such as nationalism, ekatmata

and purvodaya can only be achieved through the BJP. Going by the last 10 years of experience, I thought it wise to join the BJP. I am thankful to the BJP's top leadership. The enthusiasm of Prime Minister Narendra Modi, the confidence of Home Minister Amit Shah and the inspiration of the party's national president will help me to move ahead. I am going to start a new innings along with a new team and I hope I will get the support of all.”

Thanking the BJP's top leadership, Damayanti Besra said, “I was with the people earlier. Inspired by ‘sab ka saath, sab ka vikash,’ I will work for the welfare of all. The BJP has given me a chance to fulfil this

purpose.” She also added that a change is going to take place in Odisha and in fact, the winds of change are blowing in Odisha. “I will reach out to women who have been deprived of development,” she added. 

V.K. Cherian has done a yeoman service in documenting perhaps the first comprehensive account of the seven-decade-long journey of the Film Society Movement in India and how it helped Indian cinema come into its own as a global entity now. Till the 1950s, 80% of the films screened in India were from abroad and the country was not on the map of the global film world. Today, the country is dominated by Indian films and has a place in all International film festivals, competing against Hollywood with its Bollywood films. The massive transformation is credited to Indian film policies, new film institutions and the Film Society movement. Honestly, not many books have been written on this subject.

V.K. Cherian writes the first official film society in India, the Bombay Film Society was started in 1940, to expose budding Indian documentary film makers to the best of world documentary especially the works of Grierson, Wright, Jennings and others so



questions in great detail.

The world of cinema and theatre is very close to the heart of V.K. Cherian even though he is a career journalist who had worked with many important publications in the past. He had a tryst with theatre when he was in his college in Kerala. Of course, that has helped him in bringing out such a fabulous book on our film society movement. The movement received a huge boost after the unprecedented national and International recognition which "Pather Panchali" directed by the film society pioneer Ray bagged.

If Satyajit Ray was the pioneer of Film society movement in India, Mrinal Sen and Ritwik Ghatak have also played key role in giving impetus to the



movement. The hub of the movement Kolkata produced film makers like Buddhadev Das Gupta, Goutam Ghose, Sandip Ray, Aparna Sen and Dibyendu Chakraborty etc. KA Abbas was also a film society veteran and his Film Forum in Bombay saw the emergence of Shyam Benegal, Govind Nihalani, AK Kaul, Basu Bhattacharya, Basu Chatterjee and Khalid Mohammed and even Shoojit Sircar. In Bangalore the lineup is impressive with Pattabhirama Reddy, Girish Karnad, BV Karantha, Prema Karanth, Kavitha Lankesh and Girish Kasaravalli. In Maharashtra, Jabbar Patel and Vijaya Mehta and even Vijay Tendulkar stand out from the movement. In Kerala,

the movement was led by Adoor Gopalakrishnan. G Aravindan, TV Chandran, PA Becker, KG George, John Abraham were also inspired by the FSM. V.K. Cherian writes, "Prime Minister Jawaharlal Nehru spotted the potential of the Film Society Movement as early as in 1950s, by organizing the first international film festival of Asia in India in 1952."

Till the 1970s, film societies were the only window to world cinema for thousands across India. But with modern technology — VHS tapes, CDs, Blue Rays and now the ubiquitous pendrives and internet — many classics are now available to the public for free. As Adoor Gopalakrishnan writes in the book's foreword,

"Film society lost the unique position of being the one and only window to world cinema."

Film Societies has focused its activities on the promotion of good cinema, worked to acquire feature and short films to feed its member units for screenings, and associate it with both national and international organisations undertaking similar work.

However, as the world has changed with the passage of time, Film Societies are no longer the exclusive window on best of films, but they are still the connoisseurs and professionals place, especially for the budding ones.

V.K. Cherian also writes about the Delhi Film Society (DFS). "DFS was the most privileged of the film societies across India. The membership and the leadership were the who's who of the nation's capital in the 1960s and 1970s. Diplomatic missions vied with each other to patronise the DFS by offering their films and bringing in film makers from their respective countries to meet Delhi's film buffs." It may be recall that the Film Club of India International Centre is one of the oldest

functioning film societies in Delhi. Open to all members of the IIC, the focus of the Film Club is to screen films of merit and excellence that are not normally available in the commercial circuit, experimental works and arthouse cinema. Four to six films are screened every month and festivals and retrospectives organised focusing on the work of well-known directors, actors, genre

or country. Retrospectives organised have included the works of directors such as Ingmar Bergman (Sweden), Akira Kurosawa, Yasujiro Ozu, and Takeshi Kitano (Japan), Fritz Lang, Rainer Werner Fassbinder, Werner Herzog and Wim Wenders (Germany), Jean Renoir, Francois Truffaut and Jean Luc Godard (France), Vittorio de Sica, Pier Paolo Pasolini (Italy). In this highly readable book, V.K. Cherian deals with series of pertinent questions like : Do film societies have a future in the Digital Era? The debate on Box Office Versus Meaningful Films? If you love cinema from your heart, this book published by ATLANTIC publishers is for you and your ilk.

Once upon a time I was a school headmaster at Umerkote, then in Koraput district of Odisha. I also taught in various centres of higher learning throughout the country as a visiting faculty in the last four decades. I feel nostalgic every year when Teachers' Day comes on 5 September.

Many of my friends may have forgotten that once upon a time I was a visiting faculty in the Delhi University's College of Vocational Studies in their PG Course in Book Publishing for about 5 years. I used to teach Editing. My friends Dr G S Jolly was also teaching Editing and Kalyan Banerjee and Sumit Bhattacharjee on Book Production.

My assignment as a faculty came as a surprise. Sumit and I were good friends and were commuting to office together. His

He used to send me Teachers' Day gift for many years even after the college stopped the course. Now he is a Professor.

Besides Sakul I fondly remember two girls. One was working with Sage Publications and the other with Macmillan. If I correctly recollect, Swati was with Sage. She used to come everyday at 7.30 pm and was with at least two questions which was to be instantly replied by me. And, the other girl working with Macmillan wanted notes from me for her preparation for the examination. 'But I have never prepared notes in my entire career.' I told the girl. She was upbeat. She thought that I am probably hiding. One day she reached my office with her parents with a packet of sweet. 'If you have come on a courtesy call, I accept this sweet packet and will gladly share with Sumit and other colleagues here as it is from my student. And if you want any favour, I am afraid, I may have to regret accepting your gift. Please don't misunderstand me.. I said. Then he divulged his intention. His doubt

was, since I have two post graduate degrees with two decades of experience in the field, I must have prepared notes and may not be willing to share. 'Believe me, my daughter will use it only for her examination..', he assured

'I am a teacher, I never disbelieve my students', I said. Then I asked, 'You want your daughter to be an editor or a clerk. If you want her to be an editor, I will do that labour. And, if you want her to be a clerk, I can recommend her some help series books for preparation.'

"he stuck his head in the doorway" synonyms: door, room access, threshold. He stood in the doorway, wondering if he should go in. Homeless people sleep in the doorways of the shops.

The Doorway

Effect occurs because we change both the physical and mental environments, moving to a different room and thinking about different things. That hastily thought up goal, which was probably only one plate among the many we're trying to spin, gets forgotten when the context changes. Corridors and doorways are places of transit. The likelihood of meeting someone in one of these locations is higher than in other places because there's a concentration of interactions. People aren't normally scheduling a meeting in a corridor it's just the place where they met someone.

Psychologists believe that walking through a door and entering another

room creates a "mental blockage" in the brain, meaning that walking through open doors resets memory to make room for a new episode to emerge. This is generally referred to as the doorway effect.

New research from University of Notre Dame Psychology Professor Gabriel Radvansky suggests that passing through doorways is the cause of these memory lapses. "Entering or exiting through a doorway serves as an 'event boundary' in the mind, which separates episodes of activity and files them away," Radvansky explains.

The doorway effect is a known psychological event where a person's short-term memory declines when passing through a doorway moving

ICAR-CIFRI ventures Gandak for Sustainability

KOLKATA (KCN): One of Nepal's most important rivers, the Gandak (or Narayani or Gandaki) flows into the Indian subcontinent from the left bank of the Ganges. To evaluate the ecological management of this river and the effects of human activities on it, the NMCG team from ICAR-Central Inland Fisheries Research Institute (ICAR-CIFRI), Barrackpore, performed a comprehensive survey in March 2024. The survey covered a wide range of topics, including fish distribution patterns, ecological traits, community structure changes, and diversity. A total of five sampling sites in Bihar were selected for the analysis: Anandpur Ghat in Patna District, Mahadev Ghat in Saran District, Rewa Ghat in Muzaffarpur



District, Dak Bangla Ghat and Dumaria Ghat in Gopalganj District along the Gandak River. The investigation revealed that the water of the Gandak River had a slightly alkaline nature, with a pH range of 6.94 to 7.9. Additionally, the Dissolved Oxygen (DO) level was found to be within the optimal range of 3.7 to 5.2 ppm. Consequently, the river environment was

determined to be a favorable habitat for the survival of fish. A total of 54 fish species were recorded in the Gandak River during the sampling. Fishes like Eutropiichthys vacha, Mystus tengara, Cabdio morar, Notopterus notopterus were found as major dominant species in the Gandak. The whole length of the river was traversed by sightings of the Gangetic

River Chirag Paswan Confident That NDA Will Win All 40 Lok Sabha Seats In Bihar

Patna (KCN): Chirag Paswan, who is part of the NDA alliance in Bihar, is confident of his party's showing in the 5 seats that they are contesting. Pawan today accompanied his brother-in-law Arun Bharti as he filed his nomination from Jamui. The LJP (Ramvilas) is contesting on Vaishali, Hajipur, Samastipur, Khagaria and Jamui seats. Chirag Paswan, who is a sitting MP from the Jamui Lok Sabha constituency, has allotted the seat to Arun Bharti this time. Chirag himself is contesting the Hajipur seat against his uncle Pashupati Paras. During a brief interaction with media Chirag said, "There is no doubt that NDA alliance will win all 40 seats (in Bihar). Our alliance candidates are filing their nomination in Gaya, Jamui and Nawada today."

BJP's Bihar chief and deputy chief minister Samrat Choudhary also exuded confidence on the Alliance victory. "NDA candidates will file their nominations today. Our aim is to win all 40 seats (in Bihar)," Samrat Choudhary said. Meanwhile, leader of Hindustani Awam Morcha (HAM) and National Democratic Alliance (NDA) candidate, Jitan Ram Manjhi, filed his nomination from Gaya on Thursday. While BJP's Rajya Sabha MP Vivek Thakur, son of former Union Minister C P Thakur, will be filing his nomination from Nawada, the seat was represented by LJP (Paras) Chandan Kumar who was elected in 2019.

On March 18, the ruling National Democratic Alliance (NDA) announced seat-sharing

in Bihar for the Lok Sabha polls with the BJP set to contest 17 seats and JD(U) 16. Jitan Ram Manjhi-led Hindustani Awam Morcha (HAM) and Rashtriya Lok Samta Party (RLSP) will contest one seat each. Lok Janshakti Party (Ram Vilas) will contest five seats.

In the 2019 Lok Sabha elections, the NDA, comprising the BJP, JD (U), and LJP, dominated the 2019 elections by winning 39 out of 40 seats.

In contrast, the Mahagathbandhan, led by RJD, INC, and RLSP, managed to secure only one seat. The BJP won 17 seats with a vote share of 24.1%, JD(U) won 16 seats with a vote share of 22.3%, and LJP won 6 seats with a vote share of 8%. The INC could only secure one seat with a vote share of 7.9%.

1st Flight Of Light Combat Aircraft Tejas Mk1A Conducted Successfully



Bengaluru (KCN): The first aircraft LA5033 of the Tejas Mk1A series successfully soared in the sky after taking off from the Hindustan Aeronautics Limited (HAL) facility in Bengaluru today, the public sector aerospace and defence company said.

According to HAL, the Tejas Mk1A aircraft did a successful sortie with a flying time of 18 minutes. The plane was piloted by Chief Test Pilot Group Captain K K Venugopal (Retired).

"HAL achieved this significant production milestone with concurrent design and

development amid major supply chain challenges in the global geopolitical environment, subsequent to the contract signature in February 2021," HAL Chief Managing Director CB Ananthakrishnan said.

Extending its gratitude to the Ministry of Defence, Indian Air Force, Defence Research and Development Organisation (DRDO) and associated private firms for contributing to the success of this programme, HAL said the country can look forward to early induction of the Tejas Mk1A by the IAF, and more numbers through

the three lines of production established at HAL.

"The Tejas Mk1A will have an advanced electronic RADAR, warfare and communication systems, additional combat capability and improved maintenance features," HAL said. The agreement was aimed at manufacturing BMI Engine Bay Door for the series production of Light Combat Aircraft (LCA) - Tejas Mk1A - an indigenous 4.5 generation, all-weather and multi-role fighter aircraft for the Indian Air Force.

Axis Bank Credit Card Users Impacted By Fraudulent Transactions: Report



Mumbai (KCN): Several customers having Axis Bank credit cards have been impacted by fraudulent overseas transactions, a senior official from the third largest private sector lender said today. Sanjeev Moghe, head of cards and payments at the city-based lender, said starting Tuesday evening, customers witnessed unauthorised transactions where they received transaction alerts on certain low-value purchases being carried out at some e-commerce sites.

There has been "no data breach" at the bank's end, Mr Moghe said, asserting that the scale of such transactions is very limited and customers' data is safe and secure. Amid growing social media chatter about such unauthorized transactions going through, Mr Moghe said the bank's internal mechanisms stopped some transactions but added that many

customers have been impacted.

The bank witnessed spends of about ₹ 500 crore per day by its credit card customers, Mr Moghe said, adding that when compared with it, the extent of such transactions has been "very small".

Asked for more details, he said it is a small fraction of the overall

spends and added that "we are speaking about thousands and lakhs".

He also hinted that such incidents happened for a day, and have stopped. Fraudsters gained access to a few card numbers and matched it with the expiry dates to carry out the unauthorized transactions, he said, explaining that as these

are international transactions, they can go through without any second factor authentication like a one-time password over SMS or even the CVV number.

To a query on how the data can be sourced by the fraudsters, he said the first six digits in a 16-digit number are bank-specific, and added that

the card numbers can be picked up when the card is given for payments at petrol pumps or restaurants.

Asked if other banks have also experienced similar instances as their customers' credit card numbers can also get picked up in a similar way, Mr Moghe said he is not immediately aware about the same.

Axis Bank is replacing the credit cards for the impacted customers, and charging back the debited amount, Mr Moghe said, adding that this is not a hit for the lender.

The Reserve Bank has been informed about the incidents and the bank will have to look at strategies like audits to avoid such incidents in the future, he said.

The Axis Bank scrip closed 0.50 per cent down at ₹ 1,048.30 a piece on the BSE on Thursday as against gains of 0.90 per cent on the benchmark.

Adani Ports to acquire 95% stake in Odisha's Gopalpur Port for Rs1,349 crore

Berhampur(KCN): Adani Ports and Special Economic Zone Ltd (APSEZ) Tuesday announced the acquisition of a 95 per cent stake in Gopalpur Ports in Odisha from Shapoorji Pallonji Group and Orissa Stevedores Ltd at an equity value of Rs 1,349 crore.

In Gopalpur Ports, Shapoorji Pallonji Group (SP Group) firm SP Port Maintenance Pvt Ltd has a 56 per cent stake and Orissa Stevedores Ltd (OSL) has a 44 per cent stake. Gopalpur Port is an all-weather deep-water berthing port with a capacity of 20 million tonnes per annum (MTPA) situated in Ganjam district of Odisha.

In a regulatory filing, APSEZ said that it has entered into definitive agreements to acquire the entire 56 per cent shareholding of SP Group and a 39 per cent stake of OSL in Gopalpur Port Ltd (GPL). OSL will continue as a JV partner with a 5 per cent stake, the filing added.

APSEZ said the equity consideration for a 95 per cent stake is Rs 1,349 crore, with an enterprise value of Rs 3,080 crore, subject to closing adjustments.

In addition to the

enterprise value stated above there is a contingent consideration of Rs 270 crores estimated to be payable after 5.5 years, subject to fulfilment of certain conditions as agreed with the sellers, it added. Along with deferred payments, total enterprise value is Rs 3,350 crore.

In a separate filing, SP Group informed that it has agreed to sell its stake in Gopalpur Port to APSEZ at an enterprise value of Rs 3,350 crore, as part of its deleveraging strategy with planned asset monetisation.

"Acquisition of Gopalpur Ports Limited (GPL) will drive synergy with our existing ports and strengthen APSEZ's presence on the East Coast," APSEZ said.

"The acquisition of Gopalpur Port will allow us to deliver more integrated and enhanced solutions to our customers," APSEZ managing director Karan Adani said.

Adani added that its location will allow APSEZ unprecedented access to the mining hubs of Odisha and neighbouring states and allow us to expand our hinterland logistics footprint.

The port had recently signed up with Petronet LNG to set up a greenfield LNG regasification terminal. In FY24, GPL is estimated to handle about 11.3 MMT cargo (up 52 per cent Yo-Yo) and earn a revenue of Rs 520 crore (up 39 per cent Yo-Yo). The estimated EBITDA will be Rs 232 crore (YoY growth of 65 per cent).

"In our view, the Gopalpur Port is all set for strong growth and margin expansion in FY'25 with opportunities already identified for achieving higher operational efficiencies and infra debottlenecking, implying further value accretion for APSEZ shareholders," APSEZ said.

According to the APSEZ statement, the Odisha government had awarded a 30-year concession to GPL in 2006, with the provision of two extensions of 10 years each.

The SP Group said that the port is capable of handling 20 MTPA of cargo volume.

The sale of the Gopalpur Port is the second port divestment in the last few months from the SP Group, a diversified construction and infrastructure, real estate and energy conglomerate. It had earlier divested its Dharamtar Port in Maharashtra to JSW Infrastructure Ltd at an enterprise value of Rs 710 crore.

The group acquired the Dharamtar Port in 2015 and successfully turned around port operations, increasing capacity from less than 1 MTPA, when it took over to an expected capacity to handle 5 MTPA in FY24. "The planned divestments of Gopalpur

relatively short period of time, capitalising our core strengths in project development and construction," a Shapoorji Pallonji Group spokesperson said.

The spokesperson further said, "These divestments are key milestones in our roadmap to reduce group debt and set the stage for growth, taking advantage of the macro trends for demand in our core businesses, both in India and overseas.

The SP Group has been looking at several ways to reduce its debt, which has

been reported to be around Rs 20,000 crore. As a deep draft, multi-cargo port, Gopalpur handles a diverse mix of dry bulk cargo, including iron ore, coal, limestone, ilmenite, and alumina. The port plays an important role in supporting the growth of mineral-based industries in its hinterland, like iron & steel, alumina and others.

APSEZ is a part of the globally diversified Adani Group. It is the largest port developer and operator in India with

seven strategically located ports and terminals on the west coast (Mundra, Tuna, Dahej, and Hazira in Gujarat, Mormugao in Goa, Dighi in Maharashtra and Vizhinjam in Kerala). It has seven ports and terminals on the East coast of India — Haldia in West Bengal, Dhamra in Odisha, Gangavaram and Krishnapatnam in Andhra Pradesh, Kattupalli and Ennore in Tamil Nadu and Karaikal in Puducherry, representing 27 per cent of the country's total port volumes.



874 year-old inscription found near Vizianagaram

Bhubaneswar(KCN): Kalinga Epigraphical Research Group (KERG) rediscovered an inscribed stone panel belonging to the ruling period of Anantavarman Chodaganga Deva near Champabati River, Vizianagaram district, Andhra Pradesh.

"This particular inscription mentions about the gifting of land and a perceptual lamp to the temple of Chodagangeshwara at Dharmapura. During our survey, we found a village named 'Dharmapuri' still exists near Vizianagaram and remnants of an old Shiva Temple were found scattered which indicates presence of Shiva Temple at Dharmapuri



which was probably built by Chodaganga Deva and was addressed as Chodagangeshwara Temple," Deepak Nayak said. Deepak Kumar Nayak and Bikram Kumar Nayak from KERG were assisted by local heritage enthusiasts D Santosh and Bijaya Kumar in the exploration. Deepak Kumar Nayak, a heritage researcher is currently listing and documenting the Kalingan

known that Kalinga's southern region was spanned up to Godavari River. We are currently listing and documenting the archaeological and cultural sites having connection with Kalinga." The sheer negligence of these archeological sites makes it an important task to list and document before they are completely lost. Decades ago, Late Padmashari Satyanarayana Rajaguru had shared details about these inscriptions in his book 'Inscriptions of Orissa, Volume 3'. The inscription inscribed in Telugu script and Language was assigned to a date Shaka year 1072 which equals year 1150 CE.

Mining firm razes forest to make way for minerals

Joda(KCN): A mining firm has allegedly denuded a forest land of its green cover to facilitate transportation of minerals from Inganijharan BC Dev mines under Joda mining division in Keonjhar district.

On being informed, the Forest Department conducted a probe and stopped the transportation of minerals on the patch of land under Baitarani reserve forest at Gurubeda. The construction of the road assumes significance as Baitarani reserve forest is home to a large number of elephants.

Regular plying of heavy vehicles is likely to endanger the pachyderms and disturb their peaceful existence in the forest.

Meanwhile, the Forest Department has launched a high-level probe to ascertain the irregularities and the persons involved in the fraud. Sources said the state government has imposed a penalty of Rs 116 crore on Inganijharan BC Dev mines on charge of illegal mining. The Orissa High Court has directed the Inganijharan BC Dev mines to sell off the mineral and deposit the penalty amount by April

2024. As per the direction, the Inganijharan BC Dev mines received the mineral transportation order from the Mining department to sell off the mineral deposits in its mines. Later, it chopped off trees on the forest land March 14, Thursday and constructed a road to transport the minerals. The mining firm was noticed transporting minerals on the newly constructed road following which complaints were lodged before the divisional forest officer (DFO) of Keonjhar.

On receipt of the

complaints, Keonjhar DFO HD Dhanraj directed Joda forester Trinath Jena to conduct a probe and initiate action in this regard. Jena raided the spot March 15, Friday and found the mining firm transporting minerals on the newly constructed road on the forest land. He directed the Forest officials to dig up a trench and stopped mineral transportation by the mining firm on the newly constructed road on the forest land. Jena said that acting on a tipoff, Forest officials raided the place and found the charges to be true.

Maphaka's first day at school

New Delhi: Joe Root and Jemimah Rodrigues know a challenge Kwena Maphaka never will. It's captured in a question: have you done your homework?

It would have been asked of Root until he sprouted stubble on the chin that, despite him being in his 34th year, he doesn't quite have. It will be asked of Rodrigues, who is 10 years Root's junior, for a long time.

Looking younger than you are has few drawbacks. One is that you need to prove you're old enough to be served in a pub. Another is that, whenever you step onto a cricket ground, some wise guy or girl in the opposition will ask whether you've done your homework. The inference is that you're a kid who should be busy

with your schoolbooks and not playing with adults.

Maphaka, who has made a fairytale entry to the IPL as a hastily arranged replacement for the hamstrung Dilshan Madushanka in Mumbai Indians' squad, doesn't have that problem. For one thing, he is blessed with a face that makes his age, in the eyes of his beholders, a slippery perception. He could be 12, 22 or 32. For another thing, yes, he will have done his homework. Maphaka is 17 and in his senior year of high school. A 10-week interruption, far from home, won't help his efforts to try and graduate with good grades. So his school books have followed him to Mumbai. How might that work?

"It's not unusual for us to have students competing in different spaces and needing to go overseas," Eugene Stolk, the deputy headmaster and academic head at St Stithians College in Johannesburg, Maphaka's school, told Cricbuzz. "We manage our students online with some of our old Covid protocols, which we've done really well. The boys have access to all their teachers in the digital classroom space." In March last year, for instance, another St Stithians boy, Ben Wallis - then South Africa's under-17 football captain - kept up with his schoolwork in this fashion during a trial with English Premier League club Fulham in London. "Kwena's got four hours of maths lined up in the

next week or so with his maths teacher here," Stolk said. "We will manage some of his commitments with the IEB [Independent Examinations Board] to make sure he does the tests that he can do remotely, and he can submit those digitally.

When he gets back, we'll have second tests of equivalent status and stature set up so he can achieve what he would have done if he hadn't gone away."

Stolk was confident Maphaka would cope, not least because he has done so before. The men's under-19 World Cup was played in South Africa from January 19 to February 11, or on 24 of the 64 days - more than a third - that comprised the year's first term. Maphaka, who was named player of the tournament for taking 21 wickets at

9.71, was back at school the day after the final.

"He knew what he had missed and he made plans to talk to people to catch up," Stolk said. "He's such a keen student, so it wasn't onerous on the people he was keen to work with. Kwena just gets on with things. I think that kind of mentality is why he's such a good sportsman, because he's always thinking about what's coming next. He's got a lot of natural ability, obviously, but I think he's a smart lad who thinks hard about how he can get the best bang for his buck. Academically, he does the same thing."

It helps that Maphaka's school will be closed for holidays for 37 of the 66 days that will make up the IPL, and that the seniors will only write

tests on nine other days. For more than half the tournament Maphaka wouldn't have been in the classroom anyway.

Stolk also had an eye on the bigger picture: "This [the IPL] is going to open so many doors for him. We're just managing expectations on our side. So while he may have been aiming for a distinction in a specific subject, now we're asking what's a fair level of achievement for him."

Maphaka had to manage his expectations himself on Wednesday. He took the field in Hyderabad as Mumbai's youngest foreign debutant and the third-youngest in the IPL overall at 17 years and 354 days, and left with the most expensive figures in the franchise's history.

CA contracts 2024-25: Four new additions but Stoinis left out



New Delhi: Cricket Australia have handed out central contracts to four new players for the 2024-25 season but have left out veteran allrounder Marcus Stoinis from their 23-man list. Xavier Bartlett, who has played just three games for Australia (all in 2024), is joined by Nathan Ellis, Matt Short and Aaron Hardie.

While Bartlett makes the cut for the first time, the other three players have effectively retained their spots. Even though they were not handed a contract at the start, they earned upgrades

throughout the season having played games for Australia in ODIs and T20Is. Considering the fact that the contract is effective post the T20 World Cup this year, David Warner doesn't make the cut as he intends to bring the curtains down on his international career after the showpiece event. Stoinis, who had lost his spot in the ODI side during the World Cup last year, is in frame to play the T20 World Cup this year but has still not been handed a contract. The biggest thing we've seen in Riyan is maturity: Sangakkara

New Delhi: It's the sixth successive season of the Indian Premier League where Rajasthan Royals have put their faith in Riyan Parag, an investment they made when he was merely a 17-year-old. For five years after becoming the youngest half-centurion in the tournament, they threw him in the deep end hoping to reap rewards but struggled to get the desired result. Despite that, in the 2022 IPL mega auction, they tussled it out till Rs 4.6 Crore to bag his services again. In the 54 games of his first five seasons, Parag was mostly thrust into the role of a finisher, and averaged merely 16.22 at a strike rate of 123.97. Only Washington Sundar boasted of a worse strike rate in positions 6, 7 and 8 (among batters who have played at least 20 innings since Parag's debut).

"He's seen the huge jumps that Jaiswal and Jurel have made, and he's got a hunger there now and an example to follow into the international side," Sangakkara said on Wednesday, a day ahead of Royals' game against Delhi Capitals in Jaipur. "We have players who have a variety of ambitions, IPL being one of them. I think he has understood that how he



performs here, leads up to it. Maturing, understanding his game more, taking on more responsibility is non-negotiable for him." It's not without reason that Royals have backed the young Assam all-rounder. In the last couple of seasons, he has enjoyed a terrific run in domestic cricket, which includes top-scoring in the recently concluded Syed Mushtaq Ali Trophy - all

should look like in terms of on-field, off-field, focus on performance - all of that has changed in Riyan."

But before passing a judgement on Parag's underwhelming performances in IPL, Sangakkara adds a word of caution. "He's still a very, very young cricketer. We shouldn't forget that, he's also been hugely in the focus over the years as one of the faces of the franchise of the younger brigade." Parag has ticked off the 2024 season with an impactful innings against Lucknow Super Giants in Royals' opening encounter of the season, in Jaipur. He did enjoy his share of luck with Mohsin Khan dropping a sitter at short fine when he was batting on 29, but he cashed in on it well, scoring 13 runs off the next six deliveries.

SRH, MI put on a show to lay down early marker

New Delhi: Some of the blockbuster Indian films in recent years have shared a common element: the prominent presence of large machine guns. Protagonists armed with ammunition belt-supported firearms have imposed themselves on movie screens with their firepower. However, such action sequences are typically centred around a single major star doing all the damage. In the IPL a similar spectacle unfolded in 2013 when Chris Gayle unleashed a ballistic performance, pulverising the Pune Warriors bowlers across every corner of the Chinnaswamy stadium. Gayle's remarkable 175 not out off 66 deliveries propelled RCB to a formidable total of 263/5. That remained the highest total in the IPL for close to 11 years before SRH scaled the peak. This

time, however, it wasn't a one-man show, or even a one-team show for that matter. The distinction between the powerplay and the death overs became hazy amidst the batting onslaught. It seemed as though the powerplay never truly concluded, or that the death overs commenced right from the start of the match.

It was built up as a contest between pace supremo Jasprit Bumrah and the world's best T20 batter Heinrich Klaasen. But what the game produced was beyond that. After relentless attacking from both teams the climax of this onslaught was an astounding 523 runs scored in the match, the highest ever in men's T20 cricket and the first instance of a 500-plus aggregate in IPL history. Bumrah bowled ten deliveries to Klaasen and

Until Wednesday (March 27), Warner had notched seven out of the ten fastest fifties for SRH. However, even before the halfway mark of the first innings in Match 8 of IPL 2024, two batters had already overtaken the former SRH opener. Travis Head kick-started the innings with a blazing fifty off only 18 balls, and this was just the opening act. SRH raced past the 100-run mark in seven overs as Head relentlessly attacked the MI bowlers. The onslaught continued with Abhishek Sharma, the 23-year-old left-hander, who was matching Head shot for shot. Despite Head's dismissal, MI's hopes of tightening the game faded as Abhishek swiftly surpassed him to claim the title of the fastest half-centurion for SRH, achieving the feat in a mere 16 deliveries. A staggering 148 runs were amassed in the first 10 overs, setting yet another IPL record. Abhishek eventually fell for 63, his runs coming at a massive strike rate of 273.91, marginally quicker than Head's 258.33 for his 62.



Injured Rajitha ruled out of second Test against Bangladesh

New Delhi: Sri Lanka received a blow ahead of the second Test against Bangladesh as pace bowler Kasun Rajitha is ruled out of the series concluding match, scheduled at the Zahur Ahmed Chowdhury Stadium from March 30. Asitha Fernando joined the squad as a replacement for Rajitha while the latter returned home to start rehabilitation work.

"Kasun Rajitha will not be available for the second Test match as the player has suffered an injury to his left upper back area," SLC said in a statement on Wednesday. Rajitha, who grabbed eight wickets in the opening Test against Bangladesh at Sylhet, played a key role behind their win by picking a five-

fer in the second innings to help them earn a massive 328-run win. The right-arm medium fast bowler sustained the injury while playing the first Test and played the game by managing his injury. Both the teams reached Chattogram ahead of the second game and will start their preparation from Thursday for the second Test which is part of the ICC Test Championship. Shakib Al Hasan, who made himself available for this contest, will be joining the team as well before they begin their preparation. The ace all-rounder featured for Sheikh Jamal Dhanmondi Club against Gazi Group Cricketers in the ongoing Dhaka Premier League, the country's traditional list A tournament, at BKSP on Wednesday (March 27). Shakib scored a 65-ball 53 and later picked two for 14 run to help his side win the game by 39 runs and in the process prepare for the important encounter against the islanders.
