

Congress, allies only focused on filling their coffers before 2014: PM Modi



Jajpur(KCN): Prime Minister Narendra Modi Tuesday attacked the Congress, alleging that the party and its allies only focused on filling their coffers before 2014, when they were in power at the Centre. Modi also charged the opposition leaders with making personal attacks on him as he worked for the 140 crore people of the country whom he considered his family. Addressing a rally at Benapur in Jajpur

district which is considered a stronghold of the ruling BJD, the prime minister said the central government wants Odisha to become the gateway for 'Viksit Bharat' (Developed India). "The massive development work taking place today could have been undertaken earlier also... But in the years before 2014, the entire focus of the Congress and its allies was only on filling their coffers," he said. "Over the past 10 years, the BJP-led central government has made huge investments in Odisha. We want Odisha to become the gateway for Viksit Bharat," the PM asserted.

He also said that a permanent house, tap water and gas connection at home, which were once a dream for the poor, "is now becoming a reality".

"My slogan 'Mera Bharat, Mera Parivar' troubles the INDI Alliance leaders. So, they are making personal attacks. But the people across the country including poor, youths, farmers and others have started staying they belong to Modi Ka Parivar," he said. Modi occasionally spoke in Odia, evoking applause from the audience.

Claiming that the

opposition parties have a single-point agenda to remove him from office, the prime minister said: "My agenda is to make India the third largest economy in the world." "For them, the family is first while it is nation which is first for Modi," he said adding that 25 crore people have come out of poverty since 2014 when he came to power.

On the other hand, Modi alleged, the aim of the opposition leaders is

to make their relatives rich. Targeting the previous Congress governments, the prime minister said that when the poor sought help from the administration, it asked for guarantees for various services. "They (Congress) demanded guarantees from everybody—for opening a bank account or taking a loan for business. By installing rooftop solar panels, consumers can get 300 units of free

electricity and sell the surplus, he said adding that the farmers can also now generate solar power in their open fields. Overwhelmed at the massive turnout at his public meeting which he described as the blessings of Lord Jagannath, Modi said it reflects the mood in the East and Odisha's resolve which is 'Ab Ki Baar, 400 Paar' (This time, NDA will get over 400 Lok Sabha seats).

Mayurbhanj: Retired Sub Inspector Gets 5-Yr RI In Graft Case

Mayurbhanj(KCN): A former Sub Inspector of police in Mayurbhanj district has been sentenced to 5 years of rigorous imprisonment in a graft case.

Sarat Chandra Ray, Ex-SI of Police (Retired) was charge-sheeted by Odisha Vigilance in a case vide Spl. Judge, Vigilance, Baripada TR No.17/2017 U/s 13(2) r/w 13(1)(d)/7 P.C. Act, 1988 for demanding and accepting a bribe of Rs.7,000 from a complainant.

The Special Judge, Vigilance, Baripada today convicted Ray for the offence and sentenced him to undergo rigorous imprisonment for 5 years and a fine of Rs.5,000 and in default of payment of the fine, to undergo further rigorous imprisonment for 5 months more for the offence U/s 13(2) r/w 13(1)(d) of P.C. Act, 1988.

Berhampur(KCN): Former Odisha Assembly Deputy Speaker Rama Chandra Panda Monday got back gold snatched from his wife in Maharashtra around two decades ago, officials said.

Two Government Railway Police (GRP) personnel from Kurduwadi railway station, where the 'mangalsutra' of Panda's wife was snatched in a moving train 19 years ago, visited the Berhampur residence of the BJD leader and handed him over the 1.6 grams of gold, albeit in a moulded form, worth Rs10,000. "I thanked the railway policemen from Maharashtra for recovering the snatched gold ornament and returning it to the rightful owner after about two decades. The value of the ornament might be small, but this gesture shows



their accountability. It will strengthen the common man's faith in the police," he said. The incident took place between Solapur and Pune December 20, 2005, when Panda and his wife Sushama were going to Pune aboard the Bhubaneswar-Mumbai Konark Express. He had lodged an FIR with the railway police in Maharashtra, alleging that his wife's 'mangalsutra' was snatched by some miscreants inside the train when it was moving slowly. Police had recorded his statement March 7, 2006 and started an investigation, the officials said.

During the probe, police had arrested a chain-snatcher from Solapur, who was allegedly involved in a series of snatching cases inside trains, March 20, 2006. The looted gold ornament in a moulded form was also recovered from a goldsmith, they said.

After completing all the legal procedures, the police had May 20, 2011 asked Panda to collect the snatched gold from Kurduwadi Railway Police Station. Panda, however, refused to cover such a long distance to get back the gold and requested the police to hand it over to the Maharashtra government. "We came here to hand over the recovered gold to Panda, as per the directions of our higher-ups, after consulting him about his availability at his house," Shinde Yashwant Dagadu, one of the policemen who visited his residence, said.

Malkangiri(KCN): As per the direction of Chief Minister Naveen Patnaik, Chairman 5T and Nabin Odisha Sh. Kartik Pandian visited Malkangiri district today. Congress asks if 'Modi Ka Parivar' includes Vijay Mallya, Brij Bhushan Sharan Singh

Bhubaneswar(KCN):

The Congress Tuesday sought clarification from the BJP whether fugitive businessmen Nirav Modi and Vijay Mallya were also in "Modi ka parivar". Congress spokesperson Pawan Khera raised the issue at a press conference in Bhubaneswar after BJP leaders suffixed "Modi ka Parivar" to their names on their social media profiles, a day after RJD chief Lalu Prasad Yadav took a jibe at him for having no family.

Khera asked, "Weren't Brij Bhushan Sharan Singh, Pawan Singh, Nirav Modi, and Vijay Mallya also Modi ka

parivar?" Brij Bhushan Sharan Singh is a BJP MP and former Wrestling Federation of India (WFI) chief, who is accused of sexually harassing women wrestlers.

Pawan Singh is a Bhojpuri singer-actor who withdrew his name as BJP Lok Sabha poll candidate from West Bengal's Asansol seat Sunday. West Bengal's ruling TMC alleged that many of his songs were crude and depicted women in a vulgar way. "(PM Narendra) Modi has completed 10 years in office and his associate Chief Minister Naveen Patnaik has

completed 24 years in Odisha. We want to ask the PM what action has been taken on the chit fund scam and mining scam in Odisha," Khera said ahead of the prime minister's visit to the state.

Claiming that lakhs of people in Odisha have been affected by the "multi-crore scams", the Congress leader alleged that none has got back their money.

Despite recommendations made by a commission, no CBI probe was conducted in the mining scam and no one was arrested, Khera claimed.

He said, "Whenever there is a corruption or

scam in the state, the BJP comes to BJD's rescue. Recently, the BJD has allotted one Rajya Sabha seat to the BJP."

Khera asked the Prime Minister to disclose the kind of relation the BJD has with the BJD.

"Earlier, there was an invisible relation between

the two parties, but now, it has become visible to all," he said.

Khera said that the Congress, after coming to power, will take strong action against persons involved in the chit fund and mining scams.

The Congress spokesperson alleged that tenders of big projects have been awarded to non-Odisha contractors.

"Valuable land and forests of Odisha are being sold to outsiders. The rights of the people of the state are being provided to outsiders. One non-Odia man became king of the state and has been roaming in choppers," he alleged without naming anyone.

Now Odisha is ready for change and the Congress will bring the change for them, he said.

He claimed that Congress' vote share in Odisha is going to increase by 30 to 35 per cent in upcoming Lok Sabha and Assembly polls and the party would win 10 to 12 Lok Sabha seats.

"Young boys and girls are committing suicide due to unemployment. Two farmers are committing suicide every hour. To whose family they belong?" the Congress leader asked.

The BJP and the BJD are yet to react to the accusations of the Congress spokesperson.

NTPC holds Media Interaction-2024 meet



Peddapalli, March 5

(KCN): "NTPC Ramagundam & Telangana Super Thermal Power Station has now become the second largest power generating station in NTPC with a combined capacity of 4200 MW," said Executive Director of NTPC of Ramagundam and Telangana Kedar Ranjan Pandu. Addressing the mediapersons at the EDU Millennium Hall of NTPC, Ramagundam in Media Interaction-2024 on Tuesday, Kedar Ranjan Pandu termed the year of 2023-24 as a momentous year for NTPC Ramagundam (2600 MW) as it had been celebrating the 40th year of continuous operation. "The past four decades, Ramagundam has been generating reliable, efficient and economic power and continuously supplying power to the state of Telangana and

others," he added. Stating that in addition to Ramagundam, NTPC has set up a new generating capacity of 1600 MW named as Telangana Super Thermal Power Station (2X800 MW) within the same premises, Executive Director Kedar Ranjan said that the 1st unit (800 MW) commenced commercial operation in Sep'23 and was dedicated to the nation by Prime Minister, Narendra Modi on 3rd October, 2023 while the second unit (800 MW) started commercial operation from 1st March, 2024 and dedicated to the nation by Prime Minister on the 4th March, 2024. "The Telangana STPP units (2X800 MW) are based on Ultra-Supercritical Technology with highest efficiency and will supply 85% of power generated to Telangana State. NTPC Ramagundam

also boasts of installing the country's largest floating solar of 100 MW capacity. Future plans of expanding solar generation by 176 MW is underway," he explained. Remarking that NTPC Ramagundam, in addition to its core mission of generating electricity, has been taking steps for environmental conservation and protection like development of green belt, Miyawaki afforestation, roof top and ground solar installations in township and plant, rain water harvesting works, Kedar Ranjan Pandu asserted that NTPC, Ramagundam had also been contributing to the upliftment of socio-economic status of the people through various CSR/CD activities in the surroundings. Sood wrote the story after one and a half years of research and interviews with victims, cybercrime police officers, and ethical hackers. He essays the role of a tech-savvy investigation agent who is on a mission to protect the country from cybercrime.

Grammys Reduce Nominees From 10 to 8 In Top 4 Award Categories

Grammys has announced to reduce the number of nominees in four of its award categories - Album, Song, Record of the Year, and Best New Artist - from 10 to 8, Variety reported on Friday. An announcement in this regard was made after the Recording Academy updated its rules and guidelines following its semiannual board of trustees meeting. The number of nominees for those categories was increased from eight to ten in November 2021, just before the nominees for 2022 were announced -- a surprising and perplexing turn of events, given that such changes usually occur after the annual board meetings, Variety reported. While three new award categories were announced earlier this week, the reduction in the number of nominees in four award categories was announced on Friday. An Artificial Intelligence (AI)-related rule was also introduced, effectively stating that only human creators are eligible for awards; however, as with all things AI, the vast possibilities that the technology makes possible in this still-developing area necessitate an extensive series of caveats, Variety further reported. While Recording Academy CEO Harvey Mason Jr. stated at the time that the change was "an incredible opportunity for us to honour more artists and shine a light on more great music, and potentially offer a greater chance for more genres of music to be honoured", some speculated that it was done to ensure Taylor Swift received a best new album nomination for her album 'Evermore' and thus increase the chance that she would appear on the show and boost its rating, as reported by Variety.

SLUMS Expanding instead of reducing

According to a study published in the International Journal of Environment and Pollution, weather patterns are changing in Asia due to pollution from slum settlements. On one hand the wind speed is increasing, on the other hand the rainfall is decreasing. Climate models have already indicated that local pollution can influence the formation and development of cyclonic storms.

These days slum settlements have become a problem for the world. According to estimates, about a quarter of the world's urban population lives in slums. This is a big problem in India also. In the coming 10 years, 50 percent of India's population will start living in cities. 28 percent of India's current population lives in cities. This huge increase in urban population will have a direct impact on their habitat. There will be a rapid increase in the population living in slums in the coming years. According to a report, there are slum areas in 2,613 cities of India. A large population lives in these settlements. Of these, 57 percent of the population lives in Tamil Nadu, Madhya Pradesh, Uttar Pradesh, Karnataka and Maharashtra.

Delhi is the sixth largest metropolis in the world. Despite this, one-third of the houses here are part of slum

areas. Even basic resources are not available in it. According to a recently released report, every sixth urban citizen in the country is forced to live in slums. These settlements are not fit for human habitation. The person living here is forced to live a low standard of living. Statistics show that every third urban family in Andhra Pradesh lives in these slums. 9 out of every 10 houses in Odisha have no drainage facility. Slum settlements can be seen in 65 percent of the cities of the country. Despite being a part of the dazzling world of cities, the people living in these settlements are still in darkness.

Statistics show that 6 out of every 10 people in the country live in slums. There are dirty drains in these settlements. 4 out of every 10 do not have access to basic facilities like clean water. The people living in these slums are the result of political games and administrative neglect. Actually, slum area means illegal urban settlements on public land. Usually, it develops continuously and irregularly over a period of time. Slum areas are considered an integral part of urbanization and are seen as an expression

of the overall socio-economic policies and plans in the urban area. In the slum areas most of the people are living in poverty. The literacy rate is low in these places. However, the literacy rate in Dharavi, the country's largest slum area, is 69 percent. In Andhra Pradesh, 36.1 percent of the urban population lives in slums. A large part of the urban population of Chhattisgarh, Madhya Pradesh, Maharashtra, Odisha, West Bengal, Sikkim, Jammu and Kashmir and Haryana live in the slums. According to a report, 64.1 percent of the houses living in slums of Odisha have not yet reached clean drinking water. On the other hand, 90.6 percent of the houses in these settlements do not have any arrangement for drainage. There remains a risk of spreading the disease here.

A total of 65.49 million people live in 13.7 million slum houses in the country. Slums and slum areas exist around 65 percent of Indian cities, where people live in dense clusters. According to the National Service Scheme Round survey, as of 2012, there were about 6,343 slums in Delhi, with more than one million houses. 52

percent of the total population of Delhi lived here. About 81 percent of the country's population works in the informal sector. The sudden imposition of the complete Covid lockdown had severely affected the livelihoods of slum dwellers. Delhi saw a large number of reverse migrations after the first lockdown. Thousands of migrant workers went back to their hometowns. During this period, about 70 percent of the slum population became unemployed, 10 percent had wage cuts and eight percent saw other effects.

According to a study published in the International Journal of Environment and Pollution, weather patterns are changing in Asia due to pollution from slum settlements. On one hand the wind speed is increasing, on the other hand the rainfall is decreasing. Climate models have already indicated that local pollution can influence the formation and development of cyclonic storms. It is noteworthy that many big cities are situated on the east coast of India, which are regularly affected by storms between

Letter to Chief Minister

Respected Shri Patnaik:

Subject: Request for setting up a semiconductor chip manufacturing

I am a Photolithography Scientist at IMEC (Belgium), with 10+ years of experience in chip manufacturing and nanotechnology research (at MIT, EPFL, and NUS). With great enthusiasm, I am writing to you regarding the recent interest of the Odisha government in semiconductor design and manufacturing.

At the outset, thank you for introducing chip design (fabless) companies in Odisha. I am also excited about the MoU signed with the SRAM & MRAM Group, planning to set up a chip manufacturing plant in Odisha. However, I want to echo an important point raised during the recent World Economic Forum debate, where our esteemed Minister Shri Vaishnav (of MEITY) presented his visionary and pragmatic thoughts. But a point raised by the US Science and Technology Policy Director Arati Prabhakar on R&D in chip manufacturing also struck a chord.

As you know, an important value-creating step in chip manufacturing is process development. It involves R&D to determine the optimal recipe to manufacture functional chips. Production-driven fabs – focusing on economies of scale – have minimal scope to undertake such R&D. Instead, they outsource the research to specialized R&D hubs (in the EU or the US) which are equipped with relevant equipment and expertise. So, while our "SemiconIndia Program" attracts production giants like Micron and others, I feel that incentivizing production plants alone might have limited value-addition to our semiconductor ecosystem.

Potentially, to bridge this gap, our government is investing in infrastructure development at IITs and other institutes. However, I feel that a dedicated research institute with production-level equipment (and automation capabilities) will be better poised to deliver customized process development services to incoming fabs and attract internal and overseas funding too. Secondly, as rightly acknowledged in the "Odisha Semiconductor Manufacturing and Fabless Policy 2023", there will be a critical shortage of skilled workforce for chip manufacturing. To that end, our government is ramping up existing universities to impart relevant skills to students. Collaborations are also being planned to make available virtual platforms such as SemiVerseTM for simulated training.

However, chip manufacturing is an interplay of optics, materials, and nanotechnology, requiring multidisciplinary knowledge and hands-on experience with the right equipment and tools. Creating infrastructure at all the IITs to address these needs for a rapidly growing workforce will be cost-intensive and might also strain the educational programs of these premier institutions.

On the other hand, a research institute will be more effective in preparing a competent workforce. For one, having an institute with an industry-centric R&D program will attract experienced researchers and experts who could offer more effective training. Secondly, involving students in R&D projects will equip them with industry-relevant skills, also contributing to R&D projects thereby reinforcing their learning. Since I am working on one of the most critical steps in chip manufacturing (photolithography) I understand that the exceedingly high cost of equipment and cleanroom setup is a roadblock. Fortunately, the recent MoU signed between India and the EU could enable the setting up of such a research institute through cooperation and guidance from existing R&D centers in the EU. If you kindly consider my request to set up a chip research institute in Odisha, I will be happy to share a detailed proposal for your reference. Thank you for your valuable time and kind consideration.

Vinayak Damodar Savarkar


How many of us known about Vinayak Damodar Savarkar. Here with iam disclosing some points about Savarkar. Vinayak Damodar 'Veer' Savarkar is back in the news, 38 years after he passed into the ages.

Savarkar (1883 to 1966) was a revolutionary who spent many years in prison in the Andamans. He propounded the philosophy of Hindutva. He was born on May 28, 1883, in Bhagpur village near Nashik. After his parents died young, his elder brother Ganesh looked after the family.

In 1898, the British hanged the Chapekar brothers in Pune for killing a British officer. This had a deep

impact on the teenaged Savarkar, who decided to take up armed struggle against the British. In 1901, he joined the Ferguson College in Pune and set up the Abhinav Bharat Society, which preached a revolutionary struggle against the British. He also won a scholarship that took him to Britain to study law in 1906.

In Britain, Savarkar organised students and advocated an armed struggle to throw the British out of India. He also wrote his book on the 1857 Sepoy Mutiny, which he called India's First War of Independence, a terminology the Indian government accepted after Independence. Since there was no question of printing the book in Britain, it was printed in Holland and copies of it were smuggled into India. The book was a huge success, giving Indians a strong sense of pride, providing a fresh perspective on a war that was till then merely seen as the outcome of disgruntled



Bhikaji Cama, to meet him at Marseilles, but they arrived late and the British recaptured him.

Since Savarkar did not speak French, he was unable to tell the local policeman that he was a refugee. Even though he could not escape, this story resonated across India. He was tried, and on December 24, 1910, sentenced to 50 years in prison. On July 4, 1911, he was sent to Port Blair's Cellular Jail. 50 years! That must have been very tough.

Savarkar's release, a demand also backed by Gandhi and Nehru. On May 2, 1921, Savarkar was shifted from the Cellular Jail, first to the Alipore Jail in Bengal and then to Ratnagiri Jail in western Maharashtra. He was released on January 6, 1924 on the condition that he would not leave Ratnagiri district, which is not very far from Mumbai (then Bombay), till 1937.

Up to this point, most historians regardless of ideology would agree that Savarkar was a committed revolutionary, even if one does not support the notion of an armed struggle. But from the point of his release from jail, Savarkar becomes a divided figure, either loved or loathed. Savarkar agreed he would abstain from political activities to facilitate his release. His supporters say he only made such promises to get out of prison and that he remained committed to throwing the British out of India.

He became active in the Hindu Mahasabha, founded in 1915, which sought to protect the

interests of Hindus. The Hindu Mahasabha, which differed radically from the Indian National Congress, did not support the Quit India movement launched in August 1942.

Savarkar also asked Hindus to help the British in their war effort against Germany and Japan. His supporters say this was a tactic to get more Hindus to pick up military training that could have been turned against the British later. He was not alone. The Communist Party of India and Muslim League also did not support the Quit India movement.

For his supporters, Savarkar believed in a strong Hindu society and in the Hindutva ideology of one nation, one culture, one people, which meant no special provisions for any minority. For his opponents, this ideology divides India today by trying to deny the minorities a rightful place in Indian society.

New Delhi (KCN): The Medical Superintendent of Safdarjung Hospital, Dr. Vandana Talwar, informed a 26 years old deceased donor Vijay and his family generously gave a new lease of life to four patients. The family hails from Ballabgarh district, Haryana. He was unwell for a week and was on private treatment for a while. He had acute febrile illness and was hospitalized in Safdarjung Hospital on 25th Feb 24 in critical condition. On the evening of 2nd March, 2024, after a series of tests, a panel of specialists certified him brain dead. The family was explained and counseled for donation of organs, to which they agreed in spite of tremendous grief after losing their son. The parents of the deceased donor Vijay agreed for this act.



generosity and decided to donate four vital organs to the hospital for waitlisted needy patients. The organ retrieval was successfully carried out in Safdarjung Hospital by the Organ Donation and Transplant Coordination Committee.

The retrieved organs were allotted across the city in coordination with NOTTO. The heart of the deceased donor was transplanted in a patient at AIIMS, New Delhi, and

the liver and one kidney were transplanted in R & R Army hospital and one kidney was transplanted in Safdarjung Hospital by the respective teams of Nephrology and Urology. The recipient of the kidney at Safdarjung Hospital is stable and recovering well. This selfless act on the part of the kin of the donor will go a long way to spread awareness in the masses regarding Organ Donation.

The current cadaveric organ donation and the previous cadaveric organ donation in Safdarjung Hospital in the month of Jan 2024 are a result of the revival of ongoing programme for increasing awareness in the faculty and residents towards Brain stem death declaration and Deceased Organ Donation. The Medical Superintendent also informed that in Safdarjung Hospital, the

Organ Donation and Transplant Coordination Committee, under the charge of Dr. Vandana Chakravarty, Additional MS and the officer in charge Dr. Binita Jaiswal has been actively holding sensitization and training sessions to increase awareness towards potential brain stem death declaration and organ donation.

The Organ donation involves healthy organs and tissues from one person to be transplanted into another. The organs can only be donated either after the natural death of a person or if the person is declared brain dead, which was legalised in India under the 'Transplantation of Human Organ (THO) Act' in 1994. Since then it has been made possible to undertake multi-organ transplant activity from brain dead donors.

Plastic Ban In National Parks, Sanctuaries

Bhubaneswar(KCN): With an aim to ensure a plastic-free environment for wildlife, the State Government has imposed a ban on use of plastics in the premises of national parks, tiger reserves and wildlife sanctuaries of the State from 1 April.

The Principal Chief Conservator of Forests (Wildlife) & Chief Wildlife Warden, Susanta Nanda has issued an order in this regard on Monday. PCCF Wildlife, Shri Nanda is known for nature care and a no-nonsense mandarin, so acting tough he has issued marching orders in this regard.

"In exercise of power conferred U/S 33(C) of the Wildlife (Protection) Act, 1972, it is hereby ordered that, entry of single-use plastic shall be prohibited inside Sanctuaries/ National Park/Tiger Reserves of the State with effect from 1st April, 2024," read the order issued by the PCCF Wildlife Shri Nanda.

A Nature Lover, Shri Nanda posted a video in his X in which it was seen a Royal Bengal Tiger was lifting a plastic bottle from the forest stream and threw it in front of a videographer, delivering the message "Loud & Clear", which was appreciated by all. As plastic water bottles

will also be banned, alternate drinking water facilities will be provided for the tourists at different places inside the protected areas and refundable plastic water bottles may be provided for them at the entry points if they so desire, he said.

Visitors carrying food items in plastic wraps will have to dispose of the wraps in designated places/garbage bins etc and not litter the protected areas. As per the order, all the plastic garbage generated from visitors sources/camps/nature camps and other places inside the protected areas will be disposed

of in accordance with existing guidelines and local Panchayats/Urban Bodies in this respect. Following the notification, PCCF Wildlife Shri Nanda has written a letter to all Regional Chief Conservator of Forests,

Divisional Forest Officers (T/WL) Deputy Director, STR, North, South & Nandankanan.

The PCCF said entry of single use plastics has been prohibited in all the protected areas in the State and at the same time use of single use plastics is banned at Eco Tour sites from April 1, 2024.

Wide publicity is to be given to facilitate tourists to the PAs and Eco Tour Camps that single use plastics are banned from 01.04.2024, he instructed.

For violation of the instructions issued vide order under Section 33(C) of the Wildlife (Protection) Act, 1972, all should be impressed upon that violating the same would invite arrest and jail term along with fines, he pointed out.

Sufficient alternatives will be provided at the entry gate with help of SHGs and EDCs to the tourist for purchase after depositing the single use plastics and Styrofoam.

The field level officer asked to sensitize villagers residing inside the sanctuary that this is in the interest of their habitat and they should come forward to assist the Department and stop using the banned items. Resorts and eateries, even in the eco-sensitive areas, would be informed not to use the banned items, which may enter into the habitat of the PAs. Help of the Odisha State Pollution Department and the District Administration are to be taken to enforce this ban from 1 April, 2024, PCCF Wildlife added.

The Mission Director, National Health Mission, (NHM) Odisha Brundha D, said that the new store has been constructed under NHM Bhubaneswar.

Research funds now at govt medical colleges

Bhubaneswar(KCN): To strengthen the quality of medical education and research in the state, the government decided Monday to create a research fund under the deans or principals of all government medical, dental colleges and hospitals and postgraduate institutes for meeting expenditure towards research activities undertaken by these institutions. In a notification, the Health and Family Welfare department said, "For imparting quality education to medical students, conducting research activities along with participation of faculties in seminars and conferences are essential. These help the faculties to remain updated in the field of advanced treatment and



teaching methodologies which in turn will help in providing better healthcare services to the people." A total annual provision of Rs 9 crore has been made by the government for this purpose. The notification informed that every year, a total research fund of '1 crore each will be provided to SCBMCH, Cuttack, MKCG MCH, Berhampur and VIMSAR, Burla. A

research fund of `50 lakh each per annum will be provided to the new government medical colleges and SCB Dental College, Cuttack. The PG institutes will be provided with a total research fund of Rs 25 lakh each per annum. "The provision of research fund will enhance the quality of medical education by facilitating research, publication, participation in seminars and conferences within the

We lost the Ranji semifinal at 9 am on day one: TN coach

New Delhi: Tamil Nadu head coach Sulakshana Kulkarni has cited a mistake at the toss for his team's innings-defeat to Mumbai in the Ranji Trophy semifinal. The former first class cricketer said that the side was mentally prepared to field first if they won the toss but captain R. Sai Kishore had 'some different instinct'.

Sai Kishore opted to bat first and saw his side quickly slip to 42 for 5 in the first session under helpful bowling conditions. Although the captain hit back with a five-fer of his own in the first innings, Mumbai's famed lower-order resistance came to the fore in easing conditions with Shardul Thakur's 109 and Tanush Kotian's 89 powering a huge lead for the hosts, something Tamil Nadu couldn't recover from.

Kulkarni minced no words in his assessment of the game. "I always speak straightforward -- we



lost the match at 9 o'clock on day one," he said after the team's defeat in their first Ranji Trophy semifinal in seven years. "The moment I saw the wicket I knew exactly what we were going to get. Everything was set, we won the toss, as a coach, as a Mumbai player, I know the conditions well. We should have bowled but the captain had some different instinct."

"When I saw that they had played on a

different pitch in the quarter-final and what wicket they gave, [that] moment I realised that this is a seaming-friendly wicket and it was going to be a very tough match, we would have to play really well to win this game," Kulkarni said. "Ultimately he [Sai Kishore] is the boss. I can give my feedback and inputs [on] the kind of wickets and Mumbai's mindset also."

According to Kulkarni,

once Tamil Nadu lost opener Sai Sudharsan to the fourth ball of the innings, there was no arresting the slide. "We were mentally prepared that whoever wins the toss would bowl first," he said. "We knew that we would bowl first. The moment the TV said we would bat first, whatever you say, it goes in the batsmen's minds. That first half an hour [before start of play] got in the batsmen's minds.

"When you get into the first over, fourth ball, your

international player gets out and you see the situation... In the first hour, we lost the game and the plot. It was very difficult to come back."

Kulkarni, who has won this competition with Mumbai both as player and coach, doffed his hat to his former team for having the best lower-order batting strength in the domestic circuit. "They are the best Nos. 9 and 10 in India. I told this in the dressing room that their batting starts after No. 6. I can take the horse to the water, [but] the horse has to drink."

Kulkarni's comments, publicly running down the team after a defeat, didn't go down too well. Veteran TN cricketer Dinesh Karthik termed them 'disappointing'. "This is so WRONG," Karthik wrote on X. "This is so disappointing. This is so WRONG" Karthik wrote on X. "This is so disappointing from the coach... instead of backing the captain who has brought the team to the semis after 7 yrs and thinking it's a start for good things to happen, the coach has absolutely thrown his captain and team under the bus."


Sam Kerr to stand trial over alleged racial harassment of police officer

New Delhi: Chelsea and Australia football star Sam Kerr is set to face trial in the UK over allegations of racially aggravated harassment towards a police officer. The incident, which has sent shockwaves through the sporting world, reportedly took place on January 30 in Twickenham.

According to reports, Kerr has been charged with using insulting, threatening, or abusive words that caused alarm or distress to a police officer, with the allegations specifically pointing towards racial harassment.

The Metropolitan Police confirmed the charges on the star striker, confirming they relate to an incident involving a police officer.

"Samantha Kerr, 30 (10.09.93) of Richmond was charged via postal charge requisition on 21 January with a racially aggravated offence under Section 4A Public Order Act 1986. The charge relates to an incident involving a police officer who was responding to a complaint involving a taxi fare on 30 January 2023 in Twickenham," the Metropolitan Police said in a statement.



The Chelsea striker has pleaded not guilty to the charges, thereby necessitating a criminal trial in the UK to ascertain the veracity of the allegations. "I understand that the defence is that she didn't intend to cause alarm, harassment or distress to the officer, [her behaviour] did not amount to it and it was not racially aggravated," Judge Judith Elaine Coello was reported to have said to Kerr's barrister in court. In a statement, Football Australia (FA) said they're focused on supporting Kerr and will continue to monitor the situation. "Football Australia is aware of the legal proceedings involving

Sam Kerr in the United Kingdom. As this is an ongoing legal matter, we are unable to provide further comment at this time. Our focus remains on supporting all our players, both on and off the field. We will continue to monitor the situation and provide support as appropriate," said FA in a statement. Kerr is the all-time leading goalscorer for Australia, netting 69 goals in 128 appearances. She has scored 58 goals for Chelsea in the WSL since joining the club in 2020 following prolific stints in the USA and Australia.

However, the star-striker has been sidelined since January after suffering an anterior cruciate ligament (ACL) injury during training with Chelsea.

Thierry Henry hails 'outstanding' Arsenal after Sheffield United hammering

New Delhi: Legendary Arsenal striker Thierry Henry has heaped praise on his former club, saying they were outstanding in their win over Sheffield United. The Gunners hammered Sheffield United 6-0 in the Premier League on Monday, March 4.

Martin Odegaard, Gabriel Martinelli, Kai Havertz, Declan Rice, Ben White scored, while Jayden Bogle netted an own goal as Arsenal routed Sheffield 6-0 at Bramall Lane.
