## Odisha Government Extends Free Rice Supply Till December 2028

**Bhubaneswar(KCN):** The Odisha government has announced the extension of its free rice distribution scheme until December 2028. This decision follows the Union Cabinet's approval to continue the supply of free fortified rice under the Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY) from July 2024 to December 2028. Food Suppliers Minister Krishna Chandra Patra thanked Prime Minister Narendra Modi over the development.



Odisha government will also extend the supply of free fortified rice under its own scheme. He further informed that E-KYC verification process of ration cards is currently going on in the State.

"Around 2.30 crore E-KYC verification has been completed so far. Around one crore E-KYC verification is still to be made and it will be completed within 15-20 days. After the completion of the process, new ration cards will be issued," said Minister Patra. Earlier, Patra had informed that E-KYC verification process will not be stopped until the last applicant is verified. "After the completion of the E-KYC process, the number of false cards will be known. Then we will omit them and provide ration cards to eligible beneficiaries," Patra had said.

## Miscreant Injured in Police Encounter in Sambalpur Days After Attacking Cop

**Sambalpur(KCN):** A miscreant, who had allegedly attacked and injured a police constable, sustained injuries in a police encounter in a forest near Burla in Odisha's Sambalpur district, today. Kamal Pradhan, the man who hacked the police constable's palm

six days ago, sustained bullet injuries to his right leg and was admitted to VIMSAR in Burla for treatment. The encounter occurred in the Katapali forest, where Pradhan had been hiding since the attack. Acting on a tip-off, police launched a raid to apprehend him. During

the operation, Pradhan attacked the police team with the same sharp weapon he had used to injure the constable. "After receiving information about his location in Katapali forest, a team led by Burla IIC raided the area. When they attempted to capture

him, he assaulted the team, injuring Sub-Inspector Debasish Khilar. In response, IIC Anil Pradhan fired in self-defence, injuring the accused in his right leg," said Harishchandra Pandey, Additional SP. He had on October 4 injured police constable

Saroj Bhoi during a clash in Jharapali village. Bhoi underwent major surgery at the SCB Medical College and Hospital in Cuttack following the attack. A driver by profession, Pradhan has a history of violent altercations in his village, police sources said.

# CUO Celebrates Utkalmani Gopabandhu Das' Birth Anniversary



## Similipal Tiger Reserve Reopens for Tourists After Four-Month Hiatus



**Mayurbhanj (KCN):** The Similipal Tiger Reserve in the Mayurbhanj district of Odisha welcomed visitors again on Thursday after a four-month closure. Similipal offers a rare chance to discover one of India's most biodiverse national parks, housing Bengal tigers, elephants, leopards, and a plethora of over 200 bird species. It stands as an ideal spot

for wildlife aficionados and nature admirers. According to reports, Similipal Tiger Reserve authorities greeted tourists at the Pithabata gate in Baripada and at Kuliani in Jashipur. From 6 am to 9 am, 35 four-wheelers are permitted to enter the forest via the Kuliani gate in Jashipur, and 25 vehicles through the Pithabata Gate in Baripada. Visitors can obtain entry permits at the booking counters located at both gates. The entry fee has been set at Rs 100 per visitor. To maintain the cleanliness of the sanctuary, bans have been placed on plastic items, drugs, non-vegetarian food, and combustible materials. Tourists are encouraged to book in advance on the website ([www.ecotourism.com](http://www.ecotourism.com))

for overnight accommodations in Similipal's guest houses. Typically, tourist entry to the reserve forest is barred from mid-June each year due to the monsoon season disrupting road access within the sanctuary. The national park, a prominent Odisha tourist attraction, generally reopens in the first week of November. This reopening schedule coincides with the Durga Puja holiday, allowing visitors to revel in the natural splendour of Similipal, especially when the waterfalls and streams are brimming. Sources indicate that the sanctuary saw a decline in visitor numbers in the 2023-24 fiscal year. The national park hosted 41,346 tourists in 2022-23, but this figure fell to 25,846 in 2023-24.

Religion is a unified festival! Simple minded Hindus do not understand the deep conspiracy behind this worship. Everyone follows everyone's religion properly. Only the Hindus have come out of the protection of their religious scriptures and made it a festival. Here is the difference, Durga Puja is completely Hindu. The almighty goddess of Hindu scriptures came to kill Mahishasura. Mahisura was attacked from 10 directions with ten weapons given by the gods in ten hands and was victorious. It is called Vijaya Dechami. Durga Pooja in complete worship mantra. So it is a completely Hindu festival. Durgotsava is not for those who do not follow Hindu tradition Sanatan Dharma. As we celebrate today! We do not believe in that. Rather think that I do not practice what I believe.

What strange thoughts of this man! We celebrate Durgotsavam in mahasamarah but we don't believe in it. In front of us foreigners call Mother Durga the worship of Bitpi where.

Hearing this, no one objected. If there is no soil in the prostitute, then

Durgotsavam does not take place. Unaware of its spiritual interpretation, many support Hindu worship of Durga Puja. When we become unbelievers in their hearts. It would be better to say that perhaps we do not think of our religion as a religion. So keep saying this brief discussion to bring harmony of all religions! It is as if we Hindus are sitting against all religions. In the Muslim religion, 'La Illaha Illaha' means there is no god but Allah. Screaming in front of the Almighty Mahamaya is futile.

Needless to say, Durga Puja has become a festival of atheists among the people of the world. Because the religious Durga Puja is now becoming an entertainment platform. When did Durga Puja, the big festival of Hindus, become a festival of Odia? The Hindu public did not understand when Mother's moderate calling turned into a ritual of drinking alcohol and eating meat. Today the Asuras are organizing the Pujarachna of Goddess Mahamaya Durga. Incidentally, since the Mahalaya period, various media have been announcing the story of ancestors - Matri festival. It is the story of Uma's arrival. There is no abnormality here. The arrival of a daughter brings great joy to the father. But when a girl leaves her father's house, it is normal to feel a lot of joy in her father's house, but now it has become too public.

Racist DJ, Madhyap 'will happen again next year' at Hindu festival of joy. When

the asuras become the worshippers, when the Durachamas become the attackers of Mahamaya Devi, then such a change takes place. So it is not a tearful farewell to the mother, but an asar of wine and meat. The procession shouts to the tune of bitter songs, 'It will happen again next year. That proper joy is kept for the next year. Four days wait for 361 days of happiness! Just fun, fun, fun all around. There is no sign of spirituality. As a result puja is performed day after day, but the mother does not give success or victory. There is no real worship of Mother Goddess, there is no sense of devotion to chanting.

On the other hand, businessmen strive to make a profit. How to make more money by turning religion into a business. Keeping Durga Puja classical and spiritual aims to increase business. Therefore, after Durga Puja, Kali Uma's body is adorned with a long head garland, holding a sceptre, and a mother's tongue, which creates a symbolic atmosphere of the Durga festival in people's minds. 'Ya Devi Sarva Bhuveshu' is a Sanskrit mantra. Actually happiness today means enjoyment of the soul, happiness means material gain for the happiness of the five senses. I want clothes, I want shoes, I want all happiness, I want ornaments, I want form, I want food. Pray to Mother to get these, 'Rupang dehi, yashan dehi, dehianand'. He urges the mother to find this success and victory. People are deluded by the karma of their previous births and think that they are consumers. Despite having ten weapons, the goddess killed Mahishasura with the trident weapon of Mahadev.

The prongs between the trident are symbols of satta, raja and tama. This means that the prongs in the middle are satta guna and the two prongs on either side are symbols of

Rajashik and Tama guna. By defeating this demon called Bhava-Jalar-Yankanana, Mother Kali can destroy the evils of life and get rid of them. Only Mahamaya's tongue forgets the reason for his attachment. He forgets to ask for his happiness. A symbol of mother's arrival, status and renunciation.

Hindus are spreading the auspicious arrival of Mahamaya through commercial advertisements without understanding the scriptures.

Without explaining the true meaning of classical Durga Puja, businessmen will create money making machines. This has been happening for ages. At this time Lord Sri Ramachandra worshiped at the invocation of Ma to gather strength for victory from the rabbi. That 'Aradhana' is today's Sharadiya Durgotsav. How happy Hindus know that story. This is the truth. We do not follow what we believe. Rather, our pride in imitating the latter, our respect for the latter, our politics in the eyes of the latter. Sad thoughts, observations. Some may have classical beliefs about Durgotsava, but few observe it. He prides himself on following. Therefore, in the name of Mother's Puja, a large 'Burj Khalifa' is built or a fake temple is made in the model of the White House, Buddhist buildings, any permanent and real temple. They are proud of these imitations. Fighting Mahamaya theme in Pandal.

Because the scriptures say, Kali's position is controversial. One has to be busy arguing about the classical Mahamaya. Durga Maa is decorated with silver, gold and silver ornaments. Colorful lights, huge attractive towers, drunkards are so used to doing it that initially the police have to take steps to stop them or the mischief. Closed circuit cameras are a must these days. Mahisus was afraid

of being in front of his mother. Then we could not free ourselves from evil. So either fearlessly or in fact, worshipping on classical basis or thinking of Durga Puja as Sharadiya Utkalya Durga Puja is joining idol worship of atheists. The Durga statue no longer evokes maternal energy in the mind. Today's Puja Mahol may be called the modern 'business conference' or 'Durga Festival'.

Sometimes it becomes a political tool in a thousand year old city like Cuttack. Put dust in the eyes of others, politics! It is necessary to consider religiously, Hindus-Buddhists-Muslims-Christians-Jains of all religions consider it as a puja festival. But according to some, it is only Hindu worship. Only the Hindu scriptures provide guidance on the existence and worship of Goddess Durga. Those who are used to reading scriptures will find clearly written 'Hindu Durga Puja'.

Therefore, there should not be any difference of opinion regarding Hindu Durga Puja. Durga Puja is being cleverly lost from Hindus for commercial interests. Durga Puja is the biggest gathering of Hindu people. It is said in Hindu scriptures that the principle of 'V a s u d h a i b a n g Kutumbakam'. Worldwide, more than 10 percent of pregnant women and women who have just given birth

suffer from stress. Every year, over 720,000 individuals lose their lives to suicide. Suicide ranks as the third most common cause of death for individuals aged 15 to 29. Although there are effective treatments for mental health, more than 75 percent of people in low- and middle-income countries do not receive adequate care.

# Relevance of Digital Evidence in Income Tax: Part 1

**1. Introduction:**

Income tax department has started Faceless assessments and Faceless appeals as announced by the Hon'ble Prime Minister. Already the taxpayers are required to furnish their Income Tax Return as well as Tax Audit Reports electronically. The appeal before the CIT (Appeals)/ JCIT (Appeals) is also required to be e-filed. The Notices are issued by Income Tax Department by email and such Notices are considered as valid service of Notice. In Income tax Search also gathering of Digital evidence is becoming powerful tool for the Department in its efforts against tax evasion.

Digital evidence helps to lay hands on past activity & transactions and also help in gathering evidence of illegal and unlawful activity. However, the steps should be taken to maintain integrity of the data so that digital evidence collected may be admissible in Courts. Digital evidence, which is ephemeral, also poses problems in course of

survey, search and seizure. Problems posed in recovery of deleted data are the challenges which law enforcement agencies tackle with help of experts. Digital evidence are credible evidences similar to paper documents/evidences. As these are of diverse and hi-tech nature and available in different form of software and programmed form, these are generally stored in various digital storage devices like Hard-disks, CD & DVD Media, USB Pen-drives, Flash drives, USB i-Pods, USB MP3 players, Floppy Media, Mobile SIM cards, Memory Card as well as internal memory of devices.

2. Definition of Books of account include books maintained/kept in electronic or digital form [Section 2(12A)]:

Section 2(12A) of Income-tax Act defines 'book or books of account'. It includes ledgers, day-books, cash books, account books and other books, whether kept in the written form or as print-outs of data stored in: a) Floppy, b) Disc, c) Tape; or d) In any other

form of electro-magnetic data storage device. The Finance Bill has amended this definition to include books of account kept in electronic form or in digital forms as well. This will now cover books of account maintained and stored in software installed on a computer or maintained and stored on a cloud or website. The amended definition is having larger scope now.

**3. What is Digital Evidence:**

Digital evidence or Electronic Evidence is any probative information stored or transmitted in digital form that may be used before the Income-tax authorities and Courts. Section 79A of the Information Technology (Amendment) Act 2008 defines electronic form of evidence as "any information of probative value that is either stored or transmitted in electronic form and includes computer evidence, digital audio, digital video, cell phones, digital fax machines". The main characteristics of the digital evidences are:

a) It is latent as fingerprints and DNA  
b) Can transcend national borders with ease and speed  
c) Highly fragile and can be easily altered, damaged or destroyed and also time sensitive. For these reasons, special precautions should be taken to collect, preserve and examine such evidence.

**4. Relevance of Digital Evidence for the purpose of Income Tax:**

As far as Income-tax Act, 1961 is concerned, it has been amended thrice by way of Finance Act, 2001, Finance Act, 2002 and Finance Act, 2009 respectively. By way of first amendment by the Finance Act, 2001, provisions of section 2(12A) was inserted to give legal recognition to the books of account maintained on computer and section 2(22A) was inserted to provide definition of 'document' which now includes electronic record as defined under Information Technology Act 2000.

**5. Digital Devices:**

Sources for Digital Evidences The use of digital devices in day to day life has increased tremendously. Accordingly, we may come across a wide range of the digital evidence which include E-mail word processing documents, data base tables, files saved from accounting programmes, digital photographs, ATM transaction logs, instant message histories, internet browser histories, the contents of computer memory, computer back-up, global positioning system tracks, digital video or sound files, data stored in mobile telephones and the data stored in all types memory storage devices. For easy understanding, a compilation of various devices and the potential evidences,

these devices may contain, is provided below:

- a) Desktop Computer: The device contains all the files and folders stored including deleted files and information which may not be seen normally. Analysis of key document files like word documents, excel files, email's, tally data may help in unearthing potential evidences. Retrieval of deleted files using Cyber Forensics can help get key evidences that have been destroyed.
- b) Pen Drives: The pen drive stores many files and may be hidden easily. In many cases the parallel books of accounts maintained as tally data or excel sheets are kept in Pen Drives that can be easily hidden.
- c) Hard Drives: The device stores many files and may be hidden easily. Backup of earlier years may be kept and may be easily hidden.
- d) Mobile Phones, Electronic Organizer, IPAD, Personal Digital Assistant and other Handheld Devices: Much information can be obtained from the devices like Address Book, Appointment calendars/information, documents, emails, phone book, messages (Text and Voice), video recording, email passwords etc. Many applications like CHAT, Whatsapp can store crucial conversations important for the investigations. Remittances and transactions are done by fund transfer through mobile phone service providers utilizing money deposited with the latter bypassing banking channels. A person may do all his business through a mobile phone without computer or laptop.
- e) Smart cards, Dongles and Biometric Scanners: The device itself enables to understand the user level access to various information and places.
- f) Display Monitor (CRT/LCD/TFT etc), Screens of Mobile Phones: All graphics and files that are open and visible on screen in switched on systems can be noted as electronic evidence.
- g) Answering Machines: The device can be captured only in video, photographs and through description to be noted in seizure memos.
- h) CD/DVDs: The device stores many files which may contain the evidence.
- i) Fax Machines: The device stores some documents, phone numbers, send/receive logs that can contain the evidence.
- j) Pagers: The device can be looked for address information, Text message and phone numbers.
- k) Global Positioning Systems (GPS): The device may provide travel logs, home location, previous destinations etc which may be crucial in finding places where evidences may be stored.
- l) Modems, Routers, Hubs and Switches: The device may contain details of IP addresses, where the actual data is stored.
- m) Servers: These contain crucial data on business related applications like SAP, ERP, CRM, Mail Servers. The device is a potential evidence for pulling out audit logs using forensic analysis. Analysis of emails of key persons from Mail Servers can help in finding crucial evidences required for the case.
- n) Local Area Networks (LAN) Card or Network Interface Cards: The device itself is a digital evidence and may contain crucial evidences.
- o) Fax Machines: The device stores some documents, phone numbers, send/receive logs that can contain the evidence.
- p) Pagers: The device can be looked for address information, Text message and phone numbers.
- q) Global Positioning Systems (GPS): The device may provide travel logs, home location, previous destinations etc which may be crucial in finding places where evidences may be stored.
- r) Cloud Data Servers: The device is available on all smart phones and tablets. The Cloud may be used to store hidden data where crucial evidences may be stored. Some enterprises offer service

for storage of commercial data in servers located in foreign countries and business data are stored there through internet – which can be accessed as per terms and conditions. From the digital devices, two types of evidences may be gathered, one is persistent evidence and other is volatile evidence:

- i) Persistent evidence is the data that is stored on a local hard drive and is preserved when the computer is turned off. For example, Documents (word, slide, sheet, pdf etc.), Images, Chat log, Browser history, Registry, Audio / Video, Application, Email, SMS / MMS, Phone book, Call log etc.
- ii) Volatile evidences: It include data stored in memory, or exists in transit, that will be lost when the computer loses power or is turned off. For example, Memory, Network status and connection, Process running, Time information. It is to be noted that in certain cases, where volatile evidence is crucial, switching off a switched on system may result in destruction of volatile evidence.

# Silicon Valley Exec Remembers Ratan Tata, Says He "Wouldn't Be Here Without Him"

NEWDELHI, (KCN): A Silicon Valley executive has paid a heartfelt tribute to business tycoon Ratan Tata, saying he "wouldn't be here" had it not been for the billionaire. Taking to X, Arnav Sahu, a Principal at Y Combinator, said that Ratan Tata's scholarship programme allowed him to study in the US and build a career in the land of opportunity. Notably, Mr Sahu is one of the students who benefited from Ratan Tata's scholarship scheme which helped him pursue higher education at Cornell University - an Ivy League college in New York. His post came after the 86-year-old industrialist died on Wednesday at Mumbai's Breach Candy Hospital.

"This is a really sad moment for me. Ratan

Tata's scholarship program allowed me to come to the US. He even paid for my flight ticket, laptop, books and rent. Many of us wouldn't be here without him. One of the most important philanthropists of all time. RIP," Ms Sahu wrote on X. Following Mr Tata's demise, several people whose lives he impacted in large and small ways paid tribute to the industrialist. Among them was Mr Sahu, a beneficiary of Ratan Tata's Tata Scholarship Fund which supports Indian students at his alma mater, Cornell University.

On Thursday, the Ivy League college also posted a message honouring the man who continues to inspire businessmen and entrepreneurs across



generations. Mr Tata attended Cornell University in 1962 for a degree in architecture and structural engineering.

In a post on X, the University wrote, "Ratan Tata '59, B.Arch. '62, the university's most generous international

donor and one of India's most respected business leaders and philanthropists, passed Oct. 9. We will remember his legacy

of transformative giving to Cornell." Notably, Mr Tata's association with Cornell University remained strong

throughout his life. The University hailed the industrialist as its largest international donor, recognising his significant

contributions to the institution's global impact.

"In 2008, a \$50 million gift from the Tata Trusts created the Tata-Cornell Institute for Agriculture and Nutrition, a long-term research initiative, and endowed the Tata Scholarship for Students from India. In 2017, a \$50 million investment from Tata Consultancy Services helped build the Tata Innovation Center on Cornell Tech's Roosevelt Island campus in New York City," read the tribute from the University.

The Tata-Cornell Institute for Agriculture and Nutrition opened doors for many Indian students to study at Cornell. As of this year, 305 scholarships have been awarded to 89 Indian students, many of whom came from "non-feeder" schools.

## Ahead Of Polls, Maharashtra Government's Big SC-OBC Outreach



Mumbai (KCN): Hoping to repeat the BJP's success in Haryana, the ruling BJP-Shiv Sena-NCP coalition in Maharashtra, which is seen as facing an uphill battle in the Assembly polls expected to be held later this year, has reached out to two key groups - the Scheduled Castes (SC) and Other Backward Classes (OBCs).

On Thursday, the Maharashtra cabinet took several key decisions, including approving an ordinance

giving constitutional status to the state Scheduled Caste Commission and giving its nod to a proposal urging the Centre to hike the income criterion for inclusion in the creamy layer among OBCs from ₹ 8 lakh a year to ₹ 15 lakh.

A statement from the office of Maharashtra Chief Minister Eknath Shinde said the cabinet approved a draft ordinance to accord constitutional status to the Maharashtra State Scheduled Caste

Commission. The ordinance, the statement said, would be tabled in the next session of the state legislature and added that 27 posts had been approved for the panel. A proposal to request the Union government to increase the income limit for inclusion in the 'creamy layer' category to ₹ 15 lakh per year from the current ₹ 8 lakh was also passed. A non-creamy layer certificate, stating that the family income of a person is below the prescribed limit, is

needed to get reservation benefits in the OBC category.

The opposition Maha Vikas Aghadi alliance in the state, which comprises the Congress, the Sharad Pawar faction of the NCP and the Uddhav Thackeray faction of the Shiv Sena, had stunned the ruling coalition, known as the Mahayuti, by winning 30 of Maharashtra's 48 Lok Sabha seats. The BJP, whose tally was 23 in the last general elections, was reduced to just nine while the Ajit Pawar-led

NCP managed to win only one seat. One of the reasons attributed to the Maha Vikas Aghadi's big victory was that it managed to get its caste combinations right and Thursday's cabinet decisions are seen as a way of making a dent in that. The decisions are also being read as a means of blunting the Congress and the INDIA alliance's attack on the NDA during the Lok Sabha elections that it wanted to end reservations and was seeking over 400 seats to do so. The BJP eventually managed to win 240 constituencies while the NDA was comfortably over the majority mark of 272 seats with a tally of 293. Ahead of the elections in Haryana, where the BJP was perceived to be on the back foot after ruling the state for two consecutive terms, the state government had hiked the creamy layer ceiling from ₹ 6 lakh to ₹ 8 lakh. The decision is seen as having contributed to the party managing to defy exit poll predictions and beat anti-incumbency to win 48 seats, two more than the majority mark in the 90-member Assembly.

. London: Prime Minister Narendra Modi has been urged by a London-based delegation to help negotiate peace among countries that are in conflict. The conference, which was held in London, appealed to Prime Minister Modi to "intensify his efforts" to help resolve conflicts in Europe and Asia. The two conflicts which have seen a worrying escalation in world are in West Asia and Europe. In West Asia, the Israel-Gaza war has spread to the north and now even involves Lebanon. To make matters worse, with Iran's ballistic missile attack on Israel, the Middle East crisis has taken a dangerous turn, with a possible all-out war between Israel and Iran.

The conflict in Europe is between Russia and a West-backed Ukraine. With the US and UK's move that may allow Kyiv to target areas deep inside Russia with cruise missiles supplied by Britain, Russia has amended its nuclear doctrine. Moscow has warned the NATO and the Western countries that any escalation by Ukraine to bomb territories inside Russia may lead to a nuclear response. India, which has friendly ties with both Russia and Ukraine, as well as Israel and Iran, has been urging all parties involved in the crises to desist from any further escalation and resolve issues through diplomacy and dialogue. To this outcome, Prime Minister Narendra Modi has met or spoken to the leaders of all four countries and has assured all possible help in order to bring peace to the regions.

Today, the International Conference of Jurists and Writers for World

Peace called upon all governments, international organisations and civil societies to work together to resolve conflicts through peaceful means, prioritising diplomacy, negotiation and mediation. The conference made a special appeal to PM Modi, who has close proximity and friendly relations with all the leaders involved in these conflicts.

A resolution adopted at the conference noted that if the escalation in these war zones are not stopped, "The world will be pushed into a third World War, which can possibly consume millions of lives across nations and cause irreversible damage to economies and the environment."

Dr Adish C Aggarwala, President of the International Council of Jurists, London, and International Commission of Writers, said, "There is volatility and strife in West Asia and other places (in Europe), hostile clashes are claiming hundreds of lives each day in different countries, and the international organisations are unable to bring about a ceasefire."

"Human lives have lost their value and the future is looking bleak and dark," he said, adding, "it is at such a time, the Jurists and Writers from across the globe came together to find ways to bring about peace in an increasingly complex world."

Reading out a message from Prime Minister Modi where he had stressed that "Global peace is necessary for a bright future for humanity," the chief of the international conference appealed to him to help achieve this outcome.

# Odisha girl's award-winning solution set to revolutionise diabetes care

**BHUBANESWAR (KCN):**

Komal Panda (22), a resident of Odisha's Rourkela and a fourth-year industrial and product design student at the National Institute of Design (NID) Haryana, has been named the national winner of the James Dyson Award 2024 for her innovative design project named 'Novocarry'.

Announced September 11, 2024, the award recognises her design of a portable cooling solution for medications like insulin, which require refrigeration during transport. The device addresses the need for discreet, convenient, and reliable storage for users.

From a young age, Panda has passionately pursued drawing and attended art classes. While she initially had no exposure to industrial design, her journey of exploration ultimately led her to discover the field and the National Institute of Design (NID). Notably, product and industrial design apply creativity to solve real-world problems by creating practical, appealing, and efficient products for everyday use.

The young designer notes that her father, a diabetic patient, was the first user and test subject for the project. She actively sought his feedback to refine and enhance her product design.

"My father, a diabetic

who works at Rourkela Steel Plant, faces a daily challenge during lunch breaks—he rushes home to take his insulin shot and eat because there's no refrigerator at his workplace to store insulin

at the required temperature," she said. Panda said that ice packs to store the insulin vial proved impractical, melting quickly and requiring constant replacement. She also

said that shared refrigerators often posed the risk of tampering or medications would spoil due to improper storage. She discovered that many people shared similar struggles,

especially those managing conditions like arthritis, diabetes, and growth hormone therapy. Motivated by these insights, Panda designed Novocarry. "My goal is to empower users to carry their medications confidently, knowing they'll stay effective regardless of their surroundings," she said. The device uses bullet-shaped heatsinks to cool two vials of medicine, such as insulin, maintaining a consistent temperature of around 5 degrees Celsius. It's designed to be compact and portable, about the size of a power bank, with space for diabetic supplies. The dual-battery system ensures

reliability, and the design eliminates the need for a fan to cool the vials, making it more efficient. Panda recalls that she came to know about the James Dyson Award — one of the most prestigious awards in industrial design — during her second year at NID. By the end of her third year, she decided to apply for the award and ultimately emerged as a winner.

Reflecting on her achievement, Panda expressed her joy, stating, "I was thrilled that my product caught the attention of my inspiration, James Dyson. This recognition has validated the viability and necessity of my design.



## Firecrackers worth Rs 18 lakh destroyed

## Black Tiger Safari To Start Soon



**Bhubaneswar (KCN):** Principal Chief Conservator of Forests (PCCF) Wildlife Susanta Nanda is an ace nature lover and wildlife conservator par excellence.

He was determined to set up black tiger safari near Simlipal Tiger Reserve and accordingly PCCF Wildlife left no stone unturned to see that unique initiative comes up in the State. Now the State Government is all set to start black tiger safari near Simlipal Tiger Reserve in Mayurbhanj district soon.

Establishment of a melanistic tiger safari in the State will be a groundbreaking initiative and first of its kind

globally. Four black tigers from Nandankanan zoo will be relocated to the dedicated tiger safari zone and the State has received the necessary approval from National Tiger Conservation Authority (NTCA) and Central Zoo Authority (CZA), informed PCCF Wildlife Shri Nanda. The State Forest Department is waiting for the approval of the Supreme Court, which is also necessary for the project, he said, adding, "We are continuing our preparedness for the tiger safari. Soon after getting approval from the SC, we will start it." Maximum of the visitors coming to Simlipal were not able to sight tigers as

the possibility was less than 1 percent. So, keeping it in view, the Black Tiger Safari will be started there, officials said. The visitors, who used to return without seeing melanistic tigers, can now enjoy the tiger safari. This move aims to provide tourists and visitors with a unique opportunity to witness the rare and majestic species found exclusively in Odisha.

Covering an expansive 100-hectare area adjacent to National Highway 18, the chosen site is approximately 10 km away from the Simlipal Tiger Reserve, featuring a similar landscape. The open enclosure will

cover about 100 hectares for display purposes, while the remaining area will be utilised for veterinary care facilities, a rescue center, staff infrastructure, and visitor amenities, according to Principal Chief Conservator of Forests.

Notably, Simlipal Tiger Reserve (STR) stands as the sole habitat for melanistic tigers worldwide. Out of 30 Royal Bengal Tigers found in Odisha, 27 were located in the Simlipal Tiger Reserve (STR). In Simlipal, 14 (equal number of male and female) are usual morph tigers and 13 (six male and seven females) are pseudo-melanistic tigers.

# Nitish Reddy, Rinku Singh muscle India to a convincing series win

New Delhi, (KCN): India outclassed Bangladesh at New Delhi to clinch the three-match T20I series 2-0 with a match to go. An all-round show from Nitish Reddy was the highlight of their thumping 86-run win - their biggest victory margin against Bangladesh.

Powered by a 108-run stand between Nitish and Rinku Singh for the fourth wicket, India muscled their way to 221 after being put in to bat. The pitch in Delhi played true to pre-match predictions, largely offering batters plenty of value for money for the shots they played. But briefly, during the PowerPlay, Bangladesh had their toss decision

vindicated with three quick wickets. Both Sanju Samson and Suryakumar Yadav chipped to mid off with the ball appearing to stop on them while Abhishek Sharma chopped on after getting to 15. India had started the innings on a quick note with Samson picking two boundaries off Mehidy Hasan's first over while Abhishek got one more in the same over. But the duo fell in successive overs of pace with Taskin Ahmed and Tanzim Hasan Sakib striking. Mustafizur Rahman joined the party when he got the better of skipper Suryakumar Yadav and India were put in a spot of bother inside the PowerPlay, despite getting a healthy 45. Rinku and Nitish took a short while before imposing themselves on the spinners. Rinku's slog-swept six off legspinner Rishad Hossain signalled their intentions while Nitish did an encore in the following over by Mahmudullah. The 10th over of the innings showcased the switch in gears as Rishad Hossain was tonked for three sixes and a four by the duo that amassed 24 runs in the process. Even as pace was brought on straight after, the onslaught continued with Nitish whipping a six over long on and Rinku cutting a four to put Mustafizur under pressure.



Nitish brought up his maiden international fifty, off just 27 balls, in the following over as the partnership gathered pace rapidly. The 100-partnership came up with Nitish hitting Mehidy for three sixes and a four before he was undone by a slower one from Mustafizur. His 74 off 34 had turned the tide by then, and the momentum gained was kept up by Hardik Pandya, who

kept the boundaries coming as India raced past 200 in the penultimate over. The relentless pursuit cost India in the back end where four wickets fell in the last seven balls robbing them of a higher total. However, 221 proved to be more than enough with Bangladesh barely mounting a challenge in the chase. Even though Parvez Hossain Meroz punched Arshdeep Singh for three boundaries in the opening over, the innings fell apart soon after. Arshdeep had his man in the following over chopping on while Washington Sundar struck in his first, getting Najmul Hossain Shanto miscuing to long on. The spinners continued to dent

Bangladesh with each of Varun Chakaravarthy and Abhishek Sharma hitting the stumps in their opening overs. Bangladesh lost 3 for 6 in a 14-ball period that sent them spiraling downwards. Mahmudullah and Mehidy arrested the slide briefly before the latter hit one straight to long off. Nitish capped off his exploits with the bat with two wickets in the latter stages of the innings to cap off a near-perfect day.

## Shakib apologises for silence during protest, seeks support during farewell Test



New Delhi: Bangladesh all-rounder Shakib Al Hasan on Wednesday (October 9) cleared his political stance, paving the path for the possibility of him getting a farewell Test against South Africa at home in Bangladesh as he had hoped.

Cricbuzz had earlier reported that Shakib's dream of playing his farewell Test at home could turn into reality and now with his public

apology, it would appear that things are going to plan. Earlier, Youth and Sports Advisor, Asif Mahmud Shojib Bhuyain insisted that Shakib would need to clarify his position before asking for security. Shakib, a former lawmaker under the Awami League regime, was also accused of being involved in a murder case last month. He finally

broke silence on his stance on the Students' movement, two months after the fall of Sheikh Hasina's regime. The former member of the parliament apologised for remaining silent during that time and sought people's support for his final Test match at home later this month. "At first, I respectfully remember all the students who sacrificed their lives or were injured

while leading the anti-discrimination student movement. I offer my deepest respect and condolences to them and their families. Although no sacrifice can ever fully compensate for the loss of loved ones, the pain of losing a child or a brother is irreplaceable," Shakib wrote in his official Facebook post on Wednesday.

"For those of you who felt hurt or disappointed by my silence during this critical time, I sincerely apologise acknowledging your feelings. If I were in your position, perhaps I would have felt the same way," he added. Shakib urged his fans to stand by him when he takes to the field for the final time in whites. "As you know, I will soon be playing my final match. In my final match, in the closing chapter of this story, I want you all by my side. I want to bid farewell with all of you standing with me," he said.

## ICC exploring option to move entire Champions Trophy out of Pakistan



New Delhi: The International Cricket Council (ICC) is considering shifting the 2025 Champions Trophy from Pakistan. Initially scheduled to be hosted by Pakistan, the tournament is facing uncertainties due to India's participation issues.

The International Cricket Council (ICC) is considering relocating the 2025 Champions Trophy, which was initially scheduled to be hosted by Pakistan. With the tournament set to take place early next year, discussions are underway to explore alternative hosting arrangements due to uncertainties surrounding India's participation in Pakistan.


As the situation evolves, the ICC is considering three potential models for the tournament. While Pakistan holds the official hosting rights, the governing body has

prepared budgets for the following scenarios: Full Tournament in Pakistan: This option would see the Champions Trophy take place entirely within Pakistan, maintaining the original plan. Hybrid Model: Pakistan and a Secondary Venue: In this scenario, India's matches, along with the semi-finals and finals, would be hosted at a secondary location, likely Dubai, to accommodate security concerns regarding the Indian team traveling to Pakistan. If the Champions

Trophy shifts to a neutral venue, South Africa, Sri Lanka, and Dubai are considered ideal locations. Importantly, the Pakistan Cricket Board (PCB) will retain the hosting rights, regardless of where the tournament is ultimately held.

The Pakistan Cricket Board (PCB) has already submitted a draft schedule for the upcoming ICC Champions Trophy, set to commence on February 19, with the final scheduled for March 9. Lahore, Karachi, and Rawalpindi have been designated as the host venues for the tournament. This situation mirrors the recent Asia Cup 2023, where the tournament was held in a hybrid model due to India's absence from Pakistan, with matches involving India taking place in Sri Lanka.

## Harmanpreet, Mandhana and Shafali set up India's NRR-boosting win



New Delhi: India flexed their batting muscles and avenged their Asia Cup loss against Sri Lanka to the tune of 82 runs at the Dubai International Stadium. The victory margin - India's highest (by runs) in Women's T20 World Cups - was large enough to take their Net Run Rate above that of New Zealand, against whom they could end up competing for a spot in the semifinals during the final round of the Group A fixtures. This also meant that Sri Lanka stood eliminated after their third straight loss. After a couple of indifferent batting performances to start the tournament, the cream de la creme of India's batting rose to the stakes. Captain Harmanpreet Kaur (52\* off 27) and her deputy Smriti Mandhana (50 off

38) scored impressive half-centuries while Shafali Verma set the tone for the innings, scoring 43 in an opening partnership of 98. The total of 172/3 - the highest in the tournament so far - proved to be too steep a mountain to climb for Sri Lanka, who had been grappling with batting insecurities even before this game. India took their time to get going after opting to take first strike. It was only midway through the third over that Verma chipped a Udesika Prabodhani delivery over extra cover. India managed 37 runs in the first four overs after the PowerPlay by when Mandhana had overtaken her fast-starting partner. The pair of Mandhana and Verma, who achieved a record-equalling feat of registering 20 stands of

50 or more runs in T20Is, was finally separated in the 13th over after a 98-run opening partnership when the former was run-out two balls after completing a 36-ball half-century. Verma was dismissed off the very next ball, attempting to flick a Chamari Athapaththu delivery

across the line, only to get a leading edge to point. However, India needed just an over of stabilisation before they began setting themselves up for another push. If Mandhana targeted the off-side, her captain Harmanpreet opted for the most old-fashioned slogs and swipes through cow corner. A six and a four off Sugandika got her going. Two more fours came off the Athapaththu over and another brace arrived in the 19th over bowled by Ama Kanchana. Harmanpreet began the final over of the innings on 41 but hit back-to-back fours to complete a 27-ball half-century - the fastest for her and by an Indian batter in Women's T20 World Cups. After managing only 12 fours over the first two games, India hit 18 fours and two sixes in a single innings to leave their opponents with a very tall order. It wasn't just the batting that found its mark on the day for India. Their fielding, so often their bugbear, came good off just the second ball when substitute fielder Radha Yadav completed a diving take running back from backward point under a Vishmi Gunaratne skier. Renuka Thakur, the wicket-taker, added another wicket in her second over when she had Harshitha Madavi nicking to the keeper. Between those two dismissals, Shreyanka Patil extracted over four degrees of turn to have Athapaththu

edging a defensive push to first slip. After losing three wickets in the first 14 balls of the chase, Sri Lanka were pretty much out of it. The challenge ahead of India was to see if they could restrict their opponents to under 127 - the score that would help them pip New Zealand on NRR. As it turned out, they could go even better and keep them 100. Asha Sobhana continued her fine bowling form to take 3 for 19 while Arundhati Reddy matched her with identical figures. India polished off the win with a ball to spare.
