# National Seminar and Workshop on Sustainable and Regenerative with Natural Farming Concludes at Central University of Odisha

**KORAPUT, (KCN):** The Central University of Odisha hosted a four-day National Seminar Cum Workshop on Sustainable and Regenerative Approaches with Desi Chasa (Natural Farming) from 27 August to 30 August 2024. Organized jointly by the School of Agriculture and the School of Animal Husbandry, the event focused on integrating Indian knowledge systems into modern agricultural practices. The seminar was inaugurated by Prof. Chakradhar Tripathi, Hon'ble Vice-Chancellor of the University, who presided over the inaugural session. In his presidential address, Prof. Tripathi underscored the critical role of natural farming in

preserving Indian knowledge, culture, and tradition. He highlighted the significant advantages of natural farming over conventional chemical methods, emphasizing its positive impacts on environmental sustainability, soil health, biodiversity, water conservation, and health benefits. He encouraged students to pursue careers as job creators rather than job seekers by embracing natural farming and fostering a deeper connection with nature. The Chief Guest, Shri Natabara Sarangi, Chairman of Loka Samabaya Pratishthan Odisha, highlighted the evolution of Indian agriculture from ancient practices to



contemporary challenges and the potential of natural farming to address issues like climate change and sustainability. He advocated for natural farming as a means to ensure long-term sustainability and resilience in agriculture. Prof. M.K. Mohanty, Chairman of BPCL Biofuel and Professor of

Renewable Energy at OUAT, Bhubaneswar, emphasized the transformative role of renewable energy in agriculture and waste management, including solar-powered irrigation and bio-energy from agricultural residues. He detailed how renewable energy can enhance efficiency, reduce environmental impact, and promote a circular

economy. Registrar Prof. N.C. Panda provided insights into traditional agricultural wisdom, particularly through the ancient text Krishi

Parashara, which covers comprehensive farming practices and continues to influence modern agriculture. He underscored the relevance of integrating traditional practices with contemporary techniques for sustainable agriculture. Prof. V. C. Jha, Advisor- Academic and Administration of CUO, spoke on natural farming and its importance in economic development. Dr. Manjushree Singh and Dr. Sanjay Kumar Pradhan served as organizing secretaries,

The event concluded with a vote of thanks from Dr. Sanjay Kumar Pradhan and the distribution of participation certificates by the Vice-Chancellor. Faculty members, scholars, and students actively participated throughout the seminar, which concluded with the national anthem.

## Subhadra Yojana: Applicants will not have to pay any fee

**Balasore (KCN):** Applicants under Subhadra Yojana will not have to pay any fee at any level for enrollment of their names under the scheme. This was stated by Balasore District Collector Suryawanshi Mayur Vikas while presiding over a review meeting on the implementation of Subhadra Yojana recently at the district Collectorate. Speaking to the officials he outlined the details of the scheme. With Prime Minister Narendra Modi all set to launch this scheme

September 17, the Collector urged the officials on proper implementation of the scheme. He stressed on ensuring a proper system so that the beneficiaries will be able to get proper information and can apply smoothly for enrollment of their names in the scheme. The application form for enrollment in Subhadra Yojana will be distributed to the applicants at Anganwadi centres, block offices, common service centre and Mo Seva Kendras. The filled-in application forms will be submitted at the

common service centre and Mo Seva Kendras. There the forms will be digitised and the applicants will receive a print acknowledging their submission of forms. He said that the BDOs and the tehsildars have been asked to keep enough number of forms so that the beneficiaries can apply with ease and hassle free. The Collector also stressed on putting up hoardings and banners at various strategic points in the district headquarters town, subdivisions and in block levels for proper awareness among the

beneficiaries. He also stressed on making proper publicity of the scheme and on its enrollment in various social media platforms, newspapers and electronic media for the purpose. ADM (S&G) Sudhakar Naik, Nilagiri Sub-Collector (in-charge) Subhashree Rath, district social welfare officer (in-charge) –cum-deputy Collector Gayatri Soren and senior district officials were present at the review meeting while all the BDOs and tehsildars attended the meeting through video conference.

## No end to jumbo menace in Keonjhar

**Keonjhar (KCN):** There is no let-up in jumbo menace in areas under Keonjhar forest division as hundreds of elephants moving in the district continue to give sleepless nights to residents by damaging their crops, houses and properties. According to sources, frequent incursions of elephants into human habitats have resulted in violent man-animal conflicts, with both sides experiencing heavy casualties. The conflict is mostly witnessed in areas under Patana, Champua, Telkoi, Bhuyan and Juang Pirha, Sadar and Ghatagaon forest ranges. The jumbo herds come out from the nearby forests in search of food and water and enter the villages by the nightfall. The herds destroy standing paddy crops, alleged some of the worried farmers who have suffered crop loss. Gaja Sathis (elephant squad), who have been deployed by the Forest department to monitor the movement of the jumbos and sensitise the villagers about the same and take steps to drive



them out of human habitations to forest areas, have failed to provide safety and security to the villagers, it was alleged. The elephant herds also destroy vegetable crops, houses and other properties. "We are toiling hard throughout the day in planting paddy seedlings in muddy farmlands but elephants stray into our fields in the evening and ruin the crops. We are spending sleepless nights to shoo away the jumbo herd and protect our lives and properties," said Sanatan Mohanta of Maidankel, one of the affected residents. Moreover, the Energy department is disconnecting power supply at night for hours fearing electrocution of pachyderms. Power outage for longer durations leaves people

of most of the villages groping in dark while children's studies have taken a beating. People are living in the dark and are forced to spend the nights on vigil with fire. Locals demanded the Forest officials to assess the damage and provide financial assistance to the farmers. On the other hand, the residents of the area have urged the Electricity department not to cut power supply at night on the pretext of electrocution of elephants as they are suffering a lot, despite paying the bills regularly. To protect them from the elephant menace, many a times the villagers are using fireballs or batons along with sticks to drive away the elephants. In order to drive away the elephants, very often they move closer to elephant herds, despite

alerts by the Forest department. They also tease the jumbo herds by throwing stones and sticks at them. Sometimes the villagers take drastic and inhuman steps that put the lives of elephants at risk. Irritated by these acts, the elephants march towards the villagers and destroy properties, crops and often kill the villagers. Meanwhile, environmentalists have appealed to the Forest department to take steps to stop the man-elephant conflicts. Divisional Forest Officer (DFO) Dhanraj HD said, "We are taking all possible measures to check human-animal conflicts by making the people aware, compensating the damages and deploying elephant protection force." According to official reports, 21 elephants have died in the last three years. While 11 jumbos have succumbed in 2022, seven have perished in 2023 and three in 2024 (till date). Out of them, six died of electrocution, one in road accident, three in train hits and the remaining 11 in natural causes.

# Prohibition of Benami Transactions Part 3

8. Transactions considered Benami Transactions: As per Clause 2(9) of Benami Transactions (Prohibition) Amendment Act, 2016 Benami Transactions are following:

a) A Transaction or an arrangement, where a property is transferred to, or is held by, a person, and the consideration for such property has been provided, or paid by, another person; and

b) The property is held for the immediate or future benefit, direct or indirect, of the person who has provided the consideration. (There are some exemptions as given below)

c) A transaction or an arrangement in respect of a property carried out or made in a fictitious name.

d) A Transaction or an arrangement in respect of a property where the owner of the property is not aware of, or, denies knowledge of,

such ownership;

e) A transaction or an arrangement in respect of a property where the person providing the consideration is not traceable or is fictitious.

9. Transactions NOT considered as Benami Transactions: As per Clause 2(9) of Benami Transactions (Prohibition) Amendment Act, 2016, the following are NOT considered as Benami Transactions if the property is held for the immediate or future benefit, direct or indirect, of the person who has provided the consideration when the property is held by –

(i) a Karta, or a member of a Hindu undivided family, as the case may be, and the property is held for his benefit or benefit of other members in the family and the consideration for such property has been provided or paid out of the known sources of the Hindu undivided family (ii) a person standing in a fiduciary capacity for

the benefit of another person towards whom he stands in such capacity and includes a trustee, executor, partner, director of a company, a depository or a participant as an agent of a depository under the Depositories Act, 1996; (iii) any person being an individual in the name of his spouse or in the name of any child of such individual and the consideration for such property has been provided or paid out of the known sources of the individual;

(iv) any person in the name of his brother or sister or lineal ascendant or descendant, where the names of brother or sister or lineal ascendant or descendant and such individual appear as joint-owners in any document, and the consideration for such property has been provided or paid out of the known sources of the individual.

(v) any transaction involving the allowing of possession of any property to be taken or retained in part performance of a contract referred to in section 53A of the Transfer of Property Act, 1882, if, under any law for the time being in force: (i) consideration for such property has been provided by the person to whom possession of property has been allowed but the person who has granted

possession thereof continues to hold ownership of such property; (ii) stamp duty on such transaction or arrangement has been paid; and (iii) the contract has been registered.

10. Consequences if any person is found with 'benami' property: The Act prohibits illegal benami transactions, and provides imprisonment up to seven years and fine for violation of the Act which may extend to 25% of the fair market value of the benami property. If any person is caught with 'benami' property, he may be prosecuted and punished. Providing false information about benami transaction may also lead to prosecution. The Act also provides for confiscation of the property and non-return of the property from the benamidar to the real owner. There is no compensation by the Government if the property is confiscated. The Act has tried to sort out the weaknesses of the existing provisions and is remarkable.

11. Highlights of the Act as amended in 2016: Some of the highlights of the Act are: a) Up to seven years' imprisonment and fine for indulging in Benami transactions.

b) Furnishing false

information is punishable by imprisonment up to five years and fine.

c) Properties held Benami are liable for Confiscation by Government without compensation, holding the benami property and then refer the case to Adjudicating Authority.

d) Adjudicating Authority will then examine evidence and pass an order.

e) Appellate Tribunal will hear appeals against orders of Adjudicating Authority.

f) High Court to hear appeals against orders of Appellate Tribunal. It may be noted that Prohibition of Benami Property Transactions Act, 1988 was amended in 2016 and further amended by the Finance (No.2) Act, 2019 as well as the Finance Act, 2021, Finance Act, 2023 and Finance (No. 2) Act, 2024.

12. Institutional framework for the implementation of the law: The main weakness of the earlier 1988 Act was that there was lack of an institutional machinery to carry out Benami transaction procedures in an effective manner. The amendments in 2016 have created the required institutional arrangements for implementation of the law. Under the Act, an Authority to acquire benami properties was to

be established by the Rules. The 2016 amendments have established four authorities to conduct inquiries or investigations regarding benami transactions: Initiating Officer, Approving Authority, Administrator and Adjudicating Authority. The Act gives the Initiating Officer the power to enquire into any person, place, documents or property in the course of investigation into any matter related to a benami property transaction. Interestingly, the Act covers all domestic benami property transactions conducted since 1988.

13. Penalty imposed if any person holds a benami property or enters into a Benami transaction: Anyone entering into a Benami transaction for whatever reason, to defeat the law, avoid payment of statutory dues or creditors or abetting such a transaction is liable for rigorous imprisonment for a period between one and seven years as well as fine up to 25 per cent of the fair market value of the property. Anyone providing false information or providing false documentation can get rigorous imprisonment

of six months to five years and may also have to pay fine up to 10 per cent of the fair market value of the property.

14. Steps taken by CBDT to catch benami properties: About 25 special units across India have been formed by the CBDT in 16 regional/zonal offices, across India have been formed to implement its action-plan against benami properties in India. These special units are formed only to investigate and take action against all those individuals and entities related to undisclosed domestic and foreign properties. Each unit will have four - five members, including 3-4 IT officials, one Additional Commissioner/ Joint Commissioner and one Deputy Commissioner. Each unit would be headed by the Additional Commissioner. The CBDT has issued Notification No. 36/ 2017 [S.O. 1621(E)], dated 18-05- 2017 in exercise of its powers conferred under section 28(2) read with section 59 of the Prohibition of Benami Property Transactions Act, 1988, and has directed that the Income-tax authorities u/s 116 of the Income-tax Act, 1961, having headquarters at the places specified in the said Notification dated

18.5.2017, to exercise the powers and perform the functions of the 'Authority', under the Prohibition of Benami Property Transactions Act, 1988, in respect of the specified territorial areas. The designated authority would be reporting to the respective Director General (DG) in that city, who would be in coordination with CBDT Chairperson on real time basis. The IT department has identified more than 200 benami properties. The main focus would be benami properties that include flats, apartments, bungalows, plots, bank accounts, jewellery etc. Action is contemplated against Shell Companies so as to prevent their misuse for money laundering and tax-evasion, especially in the context of unearthing black money. Income Tax Department has reopened completed assessment in many cases and Enforcement Directorate has initiated action under Prevention of Money Laundering Act (PMLA), 2002. Winding up process has been initiated in respect of many Shell Companies.

# Hindenburg Research: Conflict of Interest

With all guns blazing, New York based short-seller Hindenburg's latest salvo has raised doubts about SEBI's leadership, integrity and impartiality in regulating markets. On August 10, the Hindenburg research, based on whistle-blower documents, released a report claiming that Madhabi Puri Buch, the first female chairperson of the Indian securities market's regulator SEBI, and her husband, Dhaval Buch, were entangled in offshore entities tied to the Adani Group's alleged money siphoning scandal. As investors reacted, the shares of Adani Group companies fell up to 7 percent leading to investors losing around \$53,000 crore..

On June 2023, the US based short seller Hindenburg Research had also accused billionaire Gautam Adani -the founders of the mining-to-media conglomerate - of opaque operations and

financial irregularities such as propelling up his stocks by stock market manipulation through money laundering and round-tripping, undisclosed investment. The Adani Group's stocks have been on a rollercoaster ride in the past few years due to stock manipulation.

Some of its firms saw stock gains of more than 1,000 percent between 2020 and early 2023, leaving them valued at price-earnings ratios much higher than peer companies and firing speculation over which investors were bidding them up. However, Hidden burg's report sparked a \$150 billion meltdown in shares of Adani's publicly listed companies in 2022, which later recovered. Adani had denied allegations of stock manipulation and accounting fraud.

However, despite overwhelming evidence that the Indian corporate honcho was operating "the largest con in corporate history", as corroborated by 40 independent media investigations, the SEBI has not taken any public action against the Adani Group, rather Hindenburg was issued a 46-page show cause

notice from SEBI, alleging violations under the Prevention of Fraud and Unfair Trade Practices regulations. Hindenburg has dismissed these allegations as baseless and accused Sebi of attempting to throttle their activities.

While Hindenburg's report in January 2023 revealed the con in the corporate realm, the latest report has levelled allegations of conflict of interest against Madhabi Puri Buch, the chairperson of SEBI. However, the SEBI chairperson has strongly rebutted the allegation and termed them as an attempt at "character assassination".

A conflict of interest occurs when an entity or individual becomes unreliable because of a clash between personal interests and professional duties or responsibilities. The "Code on Conflict of Interests for Members of Board", espoused by the SEBI in December 2008, requires wide disclosures and even provides a procedure for the public to raise conflict of interests. The code defines "conflict of interests" as any personal interest or association of a member which is likely to

influence the decision of the Board in a matter, as viewed by an independent third party.

It requires members to disclose the shares held by them and their family, and also any interests which may conflict with their duties. Any connection between the regulator and the regulated must be publicly disclosed. In her defence, Buch has said that "all disclosures as required have already been furnished to SEBI", though, she has failed awfully.

The US based short seller has stated that it "suspects SEBI's unwillingness to take meaningful action against suspect offshore shareholders in the Adani Group may stem from SEBI Chairperson Madhabi Puri Buch's complicity in using the exact same funds used by Vinod Adani, brother of Gautam Adani. According to the recent report, the couple had hidden stakes in the exact same obscure offshore Bermuda and Mauritius funds, found in the same complex nested structure, used by Vinod Adani, the brother of Gautam

Adani.

According to documents, Madhabi Buch and her husband opened their account with IPE Plus Fund 1 on June 5, 2015. The "IPE Plus Fund," a minor offshore Mauritius fund established by an Adani director through India Infoline (IIFL), a wealth management firm with connections to the Wirecard scandal, Germany's largest ever fraud case. IIFL Wealth was alleged to have committed fraud in a takeover deal involving Wirecard, using a Mauritius fund structure, per a lawsuit in UK courts.

Vinod Adani, brother of Gautam Adani, reportedly used this structure for investments in Indian markets. The documents from the Directorate of Revenue Intelligence (DRI) alleged that Adani "grossly" overvalued the import valuation of key power equipment, using offshore shell entities to siphon and launder money from the Indian public.

In one intricate structure, a Vinod Adani controlled company had invested in "Global Dynamic Opportunities Fund" ("GDOF") in Bermuda, a British overseas territory and

tax haven, which then invested in IPE Plus Fund 1, a fund registered in Mauritius, another tax haven. The parent fund of Global Opportunities Fund ("GOF") – was used by two Adani associates to amass and trade large positions in shares of the Adani Group.

On March 27, 2013, Agora Partners Pvt Ltd was registered in Singapore as a "business and management consultancy" firm. Madhabi Buch was a cent percent shareholder, according to the company's 2014 annual return. In April 2017, Madhabi Buch joined SEBI as a whole-time member, and became Chairperson at SEBI on March 1st, 2022. Buch remained a cent percent shareholder of Agora Partners until March 16th, 2022, per Singaporean records. On March 16th, 2022, two weeks after her appointment as SEBI Chairperson, she quietly transferred the shares to her husband but continued to hold 99 percent shares in eponymous Indian firm Agora Advisory Pvt Ltd as per data March 31, 2024.

Agora Advisory Private Limited was set up in India on May 7, 2013. In 2022, this entity reported \$261,000 revenue from consulting, 4.4 times her disclosed salary at SEBI. In the last 7 years, it earned revenue of Rs 3.71 crore. Buch's holdings potentially violate a 2008, SEBI policy that prohibits officials from holding an office of profit, receiving salary or professional fees from other professionals' activities. She has not disclosed her business interest to the Sebi board too, which is a serious breach of conduct.

During Madhabi Buch's tenure as a whole-time member at SEBI, her husband was appointed as a senior advisor to a private equity colossus Blackstone in 2019. Blackstone has been one of the largest investors and sponsors of real estate investment trusts (REITs), a nascent asset class in India. During Dhaval Buch's time as advisor to Blackstone, SEBI has approved and facilitated major REIT regulations changes and approved its IPO.

Hindenburg's allegations have led to calls for Buch's

resignation, including from opposition leaders. Congress had demanded an investigation through the Joint Parliamentary committee. However, the integrity, and honesty of Hindenburg, Madhabi Buch and Adani is questionable and needs scrutiny. Hidden burg is a short seller. Short selling is an investment strategy with the underlying motive of buying low and selling high. It is a trading strategy where investors speculate on a stock's decline. So Hidden burg's motive is nefarious as it wants our share market to crumble. But the allegation of conflicting interest against Madhabi Buch is absolutely right. She has misutilised her position not only to amass illegal wealth but to help Adani to spur his stock prices illegally. Question is: despite the existence of thousands of mainstreams, reputable onshore Indian mutual fund products, why Madhabi Buch and her husband had stakes in a multi-layered offshore fund structure shrouded in obscurity and haziness

## CM Revanth Reddy alerts Ministers, entire State Administration, MLAs, MPs and MLCs

**Hyderabad, Sep 1 (KCN):** The Chief Minister A Revanth Reddy on Sunday reviewed the situation in the heavy rain-affected areas in the State. Holding an emergency review on incessant rains in the State, Chief Minister spoke to the ministers Bhatti Vikramarka, N Uttam Kumar Reddy, Tummala Nageshwar Rao, Damodara Raja Narasimha and Jupalli Krishna Rao over phone and enquired about the relief operations in the submerged areas. The CM held teleconference with top officials. Chief Secretary, DGP and the top officials of State Municipal Administration,

Energy, Panchayati Raj, HYDRA, Irrigation departments have been asked to be alert in the next 24 hours. The Chief Minister ordered district Collectors, SPs, Revenue, Irrigation and Municipal officials to conduct field visits in the flood-hit habitations. Specific instructions have been issued to all officials of the important departments to cancel their leaves and join relief and rescue operations immediately in the rain-ravaged districts. The officials of the emergency wings have also been asked to send updates on heavy rains at the field level to the CMO office from

time to time. The authorities are instructed to take immediate relief measures in the flood-hit areas. The Chief Minister appealed to people not to venture out of their homes unless in an emergency. Citizens living in the low lying areas are advised to be more vigilant and inform the authorities over phone in case of emergency or any assistance required. The CM directed the ministers, MPs, MLAs and MLCs to stay in their respective areas and take up relief operations. The Congress party workers are also requested to be on alert round the clock and contribute their services in the relief activities.

## "Expect To Contest Assembly Polls From...": Shyam Rajak Returns To JDU

**Patna (KCN):** Shyam Rajak, a former Minister in the Bihar government and veteran politician, marked a return to Nitish Kumar-led Janata Dal (United) on Sunday. He was welcomed back into the JD (U) fold by the party's Working National President Sanjay Kumar Jha. This marks Mr Rajak's 'second innings' with JDU, as he has previously served the JD(U) before switching sides to Rashtriya Janata Dal (RJD), some years ago.

After joining the ruling JD(U), he told media persons, "I expect to contest Assembly elections from Phulwari Sharif in 2025 polls, an opportunity which he was deprived of during his association with Lalu Yadav-led RJD in the



2020 Assembly elections. Mr Rajak resigned as the RJD National General Secretary and also quit the party on August 22 this year. Today marks his homecoming into the JD(U). Shyam Rajak had started his decades-long political career with the RJD, however, years later switched over to JD(U).

He rejoined RJD just before the 2020 Bihar Assembly elections, hoping to contest from the Phulwari Sharif Assembly seat but he was denied a chance. Despite his stature in RJD, the Phulwari Sharif seat was allocated to the Communist Party of India (Marxist-Leninist) Liberation (CPI-ML) as

part of a seat-sharing arrangement within the INDIA bloc alliance. Gopal Ravidas was declared as INDIA bloc candidate from the seat and the latter also won the Assembly election. This left him feeling "cheated and dejected". Shyam Rajak resigned from RJD on August 22 this year and declared his

next political innings with JD(U). "I remember Chandra Shekhar ji's words. He always advocated for keeping the last person in the row as the focal point in any decision-making. Such an approach will never fail you and will always guide you in the right direction," said Shyam Rajak, a day before joining Bihar's ruling party. His 'homecoming' also comes a day when senior leader KC Tyagi tendered his resignation as JD(U) National Spokesperson. His sudden exit from the position has fuelled murmurs of 'fresh differences' within the party, however, the senior leader ascribed his 'age factor' as the reason behind quitting the post.

## Politicians Assuring Death Penalty For Culprits Creating "Mob Rule": Supreme Court Judge

**Pune (KCN):** Justice Abhay Oka of the Supreme Court on Sunday said "mob rule" is being created as politicians capitalise on certain incidents and assure capital punishment for culprits, stressing that only the judiciary can pass legal verdicts. Addressing a conference organised by the Bar Council of Maharashtra and Goa in Pune, Justice Oka underscored the importance of maintaining the judiciary's independence

and delivering swift, just decisions. He also said the judiciary is "bombarded with criticism" for no reason in certain cases over granting bail. Justice Oka underlined the critical role of sensitivity among lawyers and the judiciary in ensuring adherence to the Constitution. "If the judiciary is to be respected, its freedom must remain intact. The Constitution will be followed only if the lawyers and judiciary remain sensitive. Lawyers play a major role in maintaining the

judiciary, and they must fulfil this responsibility; otherwise, democracy will not survive," Justice Oka said. He further commented on the current state of public discourse, saying a "mob rule" is being created wherein politicians capitalise on certain incidents and assure people of the death penalty for culprits even though only the judiciary has the power to pass legal verdicts. "We have created a mob rule. When an incident happens, political people capitalise on it. Political

leaders visit that particular place and assure people that the death penalty will be given to the accused, but the decision power rests with the judiciary," he said. Though Justice Oka didn't name any particular incident, his remarks came against the backdrop of the Kolkata rape and murder incident and the alleged sexual abuse of two girls at a school in Badlapur in Maharashtra, which triggered demands for the strictest punishment for culprits. Justice Oka further said the judiciary is

"bombarded with criticism" for no reason when bail is granted in certain cases. "Judges should give the decision as per the law which should be transparent". Notably, Union Minister Ramdas Athawale on Saturday demanded capital punishment for those involved in the alleged rape and murder of a doctor in Kolkata, days after West Bengal CM Mamata Banerjee promised an amendment to existing laws to ensure capital punishment to convicted rapists.



## Union Education Minister's comment on renaming of Ravenshaw University sparks war of words

**Bhubaneswar(KCN):** Union Education Minister Dharmendra Pradhan's remark regarding changing the name of Cuttack's Ravenshaw University has led to a war of words between the ruling BJP and the opposition Congress and Biju Janata Dal (BJD). The university established in 1868 was named after Thomas Edward Ravenshaw, the then commissioner of the Odisha division. "The people of Odisha as well as intellectuals should ponder upon the fact that, whether we need an institute named after Ravenshaw Saheb during whose tenure the 'Na' Anka Durbhikhsya (devastating famine in 1866) occurred in Odisha. What did the



administrative officials do during the famine in Odisha? Is the person who was helpful in tormenting Odia people a matter of pride for us?" said Pradhan earlier Saturday. He, however, said that it was his personal opinion and a debate should be held over the issue. Launching a scathing attack on Union Minister Pradhan over the issue,

BJD leader Lenin Mohanty said Ravenshaw University is a pride for each and every Odia. He said that Union Minister Pradhan should have read a little bit of history before linking 'Na Anka Durbhikhsya' (1866 Famine) to the university. The BJP also targeted the BJD, saying that the latter was earlier advocating for non-Odia administrative

officers while now it was raising its voice in support of a 'murderer' British officer. Meanwhile, Congress leader Smruti Ranjan Lenka accused Union Minister Pradhan of engaging in cheap politics and said that the BJP government was trying to evade its actual duty and responsibility by highlighting irrelevant issues instead of paying attention to the increase in the qualitative value of the education system. Notably, Ravenshaw University boasts a rich academic legacy with illustrious alumni including former Chief Ministers Harekrushna Mahatab, Nandini Satpathy, Biju Patnaik, noted historian Ramesh

Chandra Majumdar, former Chief Justice of Supreme Court of India, Ranganath Mishra, etc. Ravenshaw University was established in 1868 as a collegiate school and later converted to a full-fledged degree College in 1876 due to the efforts of Thomas Edward Ravenshaw, the then commissioner of the Odisha division. During Ravenshaw's tenure as the commissioner, the state witnessed a devastating famine in 1866, locally known as 'Na Anka Durbhikhsya'. Report suggests that more than one-third of Odisha's population was wiped out due to the dreadful famine of 1865-66.

## Odisha teen dies after consuming poison, family alleges harassment by school

**Jajpur(KCN):** The death of a 17-year-old boy, while undergoing treatment for consuming poison, has triggered an uproar with his family alleging mental harassment by his school in Odisha's Jajpur district. Ashish Kumar Panda, a Class 12 student of a residential school, allegedly consumed poison in his home Monday evening. He was accused of stealing a mobile phone of a hostel inmate. He was first taken to a

government hospital at Madhuban and later to the SCB Medical College and Hospital in Cuttack where he died late last night. His father filed a complaint with the Dharماسala police in connection with the incident Tuesday. According to the teenager's family, they received a call from the Renaissance Higher Secondary School on August 4 morning and the authorities said that Ashish stolen a mobile phone from a roommate

of the hostel. "We reached the school at about 10 am and our son appeared very stressed and pleaded he was innocent. The school authority directed us to take him home. When we asked them to show us the CCTV footage of our son's misdeed, they could not show it. We took him home on Sunday," said Banka Behari Panda, father of the deceased. Panda alleged that his son was mentally tortured by the school authorities. "My son could not bear

the humiliation and died by suicide," he said. Contacted, proprietor of the Renaissance Higher Secondary School B.B Rout said the parents of the student were informed about the incident and asked to come to the school. When the parents reached the school they were asked to take the boy to their home, he said. Based on the complaint, police have registered a case and further investigation is underway.

## High-Quality Patient-Centric Integrated Model for Emergency Care System to be developed in Puri


**Bhubaneswar, (KCN):** The Indian Council of Medical Research (ICMR) has launched a National Health Research Priority Project aimed at developing advanced emergency care systems. This project, which includes the district of Puri in Odisha, seeks to establish a High-Quality Patient-Centric Integrated Model for Emergency Care Systems across five districts: Puri (Odisha), Ludhiana (Punjab), Vidisha (Madhya Pradesh), Vadodara (Gujarat), and Pondicherry, said AIIMS Bhubaneswar Executive Director Dr. Ashutosh Biswas. The initiative will enhance emergency care by improving logistics, boosting healthcare provider competencies, integrating information technology and artificial intelligence tools, and mapping facilities. Key components of the project include improving ambulance services, increasing community demand, and training first-level responders. The project will address seven critical emergencies: heart attack, brain stroke, trauma, snake bite, poisoning, respiratory emergencies, and neonatal and maternal emergencies, added Dr. Biswas. AIIMS Bhubaneswar, in collaboration with ICMR and the state government,



is spearheading the project in Odisha. Dr. Ashutosh Biswas, Executive Director of AIIMS Bhubaneswar, emphasized the collaborative nature of the initiative during a National Level Consultation cum Review Meeting held at AIIMS Bhubaneswar. The meeting, themed "Collaborative Action: Strategies to Strengthen Emergency Care in India," gathered key stakeholders to discuss strategies for enhancing emergency care. A research team led by Dr. Arvind Kumar Singh, Additional Professor at AIIMS Bhubaneswar, has been formed to develop and implement this model in collaboration with the state government. Prominent attendees included Dr. Meenakshi Sharma (ICMR, New Delhi), Dr. Vishwajeet Kumar (CEL, Lucknow), Dr. Jeyaraj D Pandian (CMC Ludhiana), Dr. Sitanshu Sekhar Kar (JIPMER, Puducherry), Dr. Prasanta R. Mohapatra, Dr. Sonu Hangma Subba, Dr. Bhagirathi Dwivedi, Dr. Binod Kumar Patro, Dr. Arvind Kumar Singh from AIIMS Bhubaneswar, Dr.

Manu Ayyan (JIPMER, Puducherry), Dr. Hemant Kumar Patadia (Parul University), and Principal and Co-Principal Investigators from the five project sites. The Government of Odisha dignitaries included Dr. Bijay Kumar Mohapatra, Director Of Health Services, Dr. Nilakantha Mishra, Director of Public Health, Dr. Santosh Kumar Mishra, DMET, and Dr. Kaushik Mishra, Superintendent, SJMCH. State officials from other states joined online. Project team members from INDIA EMS and Regional Institute, AIIMS Bhubaneswar, also attended. Dr. Ashutosh Biswas unveiled the Vision Document of INDIA EMS and Training Manuals, advocating for the integration of geo-tagging systems, IT, HR, and HMIS. He emphasized improvements in transport, ALS facility ambulances, immediate response, and community education on basic life support. Dr. Bijay Kumar Mohapatra stressed the importance of enhancing

the emergency healthcare system in Odisha, and Dr. Nilakantha Mishra highlighted the need to integrate the INDIA-EMS with national programs and scale it across all districts. Dr. Santosh Kumar Mishra addressed the gaps in ambulance care, calling for better paramedic engagement and training. Dr. Meenakshi Sharma provided an overview of the INDIA-EMS project, highlighting the Hub & Spoke model and AI applications to tackle seven time-sensitive acute emergency conditions. world. But some of them now have to quickly transition from T20 to Test cricket after being selected in the team. And being part of different franchise-based tournaments has also meant they haven't had enough time to prepare for Test cricket. "Transitioning from white-ball to red-ball cricket is indeed a challenge, especially as the formats demand different skill sets. Test cricket is more about patience, temperament, and building pressure over long periods, which can be quite different from the fast-paced nature of white-ball cricket," Hashmatullah told Cricbuzz. "Our coaching staff has been working hard on helping the players adjust their mindset and



individual skills and team strategies. We've spent considerable time working on the specific demands of Test cricket, from conditioning to mental toughness," said Shahidi, before adding that separate squads for different formats could

help the team. "Having a separate squad for Test and white-ball formats could indeed make it easier to specialise and prepare for specific assignments. It allows players to focus entirely on the format they are selected for,

helping them to fine-tune their game accordingly. This is something we might consider in the future as we continue to evolve as a Test-playing nation," he said.

Shahidi said that playing in Noida gives them confidence as they are more familiar with the conditions than New Zealand, although he is aware of the quality in the opposition squad.

"Playing in Noida does give us some familiarity with the conditions, which can be advantageous. We understand the pitch behaviour and weather patterns, which might help our bowlers and batsmen to adapt more quickly. However, New Zealand is a top-class side that can adjust to conditions anywhere, so

while it may offer us a slight edge, we still need to perform at our best," said the left-handed batter. The Afghanistan captain said the biggest challenge for them will be to match their opponents as far as experience is concerned though he insisted that they are ready to give their best. "The biggest challenge for Afghanistan in the upcoming Test against New Zealand will be the experience gap. New Zealand is a seasoned team with a wealth of experience in Test cricket, whereas Afghanistan is stepping into this format against them for the first time. However, our team has been making remarkable progress, and the world has witnessed our growth and current performance. We'll

focus on playing our natural game and giving our best effort against the Kiwis," he said. The absence of premier legspinner Rashid Khan in the New Zealand Test is a big blow for them, admitted Shahidi, but he is hoping the others will step up. "Rashid's absence is definitely a significant loss for us, given his experience and skill, especially in spinning conditions. However, it also opens up opportunities for other players to step up and showcase their talent. "This could be a turning point for some of our young or less experienced bowlers to make a mark on the international stage. We believe in our squad's depth, and we're confident that the players chosen to replace Rashid will give their best," Shahidi insisted.

**New Delhi:** Alastair Cook, whose record for most Test hundreds by an England batter was broken by Joe Root, has showered praise on the latter calling him a "genius". With twin tons in the Lords Test against Sri Lanka, Root's hundreds tally went up to 34. "He is quite simply England's greatest, and it's right that he should have this record, on his own. We are watching a genius," commented Alastair Cook on BBC.

"I don't think there's a batsman that I can remember watching play...the sense of inevitability about scoring runs that Joe Root gives off. I called it when he was on about 6 today, that he was going to get 100. I know he's in great form, but it's just a pleasure to watch a master, a craftsman at work," he added.

Cook, who confessed to not having been impressed when he first saw Root in First Class cricket said that he had changed his mind by the time he saw him bat for the first time in Test



cricket. "The game was in the balance and he walked out to bat with his England cap on, looking 13, massive smile on his face. I watched his first few balls, and I was like, 'This bloke is here to stay.' I honestly said, 'He's scoring 10,000 runs.' I don't know who I said it to, but I know that I said it," he said. On his part, Root himself felt that the lockdown was a time where he could reassess his game. "That was a period where we were home for long and I sort of had a deep dive into what my strengths were, and where I was making similar mistakes and how could I become a more rounded player at the end

of it. It's nice when you get runs on the first tour back, feels like you're up and running," he said in a press conference and went on to shower praise on the team environment of the current setup.

"This environment and the way we look at the game now is fun to be around, to be part of. It's an environment where you see guys come in and thrive and even as a senior player that gives you so much energy. And wanting to add and evolve, to get better and put into the pot, I think it's product of what this team has created," he said.

"It is so easy to flourish in this environment- the way we look at the game and

the way we want to play it. Even as a 31-year old who has played over 100 games, you look at the game now completely different now compared to how you did," he added. While in the midst of breaking records for fun, the biggest of them all - Sachin Tendulkar's tally for most Test runs - is only 3544 runs away. Root chose to play it down when asked if it was on his mind.

"I just want to play, do my bit for the team, score as many runs for my team and see where we get to. There's no better feeling, I mean it's obviously amazing to score hundreds, you'd be lying if it wasn't a big part of why you started playing the game and what you love about it. But there's no better feeling than winning Test matches. The more you can impact game and add to the team the greater it is. That'll be the main focus. Hopefully, more days like this will come with that," he told ECB.

**Dhaka:** Bangladesh pace bowler Taskin Ahmed said on Saturday that it is great to be back in Test cricket but added that he still hasn't got the rhythm that he would have liked to play at this level. Bangladesh are trailing by 264 runs at the end of the second day after the opening day's play was washed out due to rain. Pakistan were bowled out for 274 following Taskin's three-fer and Mehidy Hasan's five-fer. Taskin returned to Test cricket after a gap of one and a half years as he wanted to recover fully from his shoulder injury and then finished with figures of 3-57 from his 17 overs.

Taskin earlier requested the board not to consider him for Tests and only recently he can play Test cricket with his present condition. "It's great to be back in Test cricket after one and a half year, I really enjoyed but I struggled a bit, it will be fine from the next innings there are some adaption things (that needs to be done)," Taskin told reporters after the second day's play. "I am working on different things like I am playing for a long time and have to adapt in different format and that is my duty as a experienced and senior bowler," he said adding that he liked the way he



got Abdullah Shafique out in the first innings. "That wicket( Abdullah Shafique) wicket was really enjoyable for me that wicket first I set him

with away ones while the last one I bring one in and that happened and that was intentional and that's why I am really happy about this wicket. You

know sometimes I won't get wickets but the process has to be same. Still I am learning and played almost ten years so that's how I learned," he

concluded, Taskin Ahmed credited the bowling unit to keep their nerve under pressure and end the day on a good note on the second day of the second Test as they bowled Pakistan out for 274 runs and that too after the home team had been well-placed on 99-1 at lunch. "Overall our whole bowling unit did well today they started pretty well after first wicket they had good decent partnership and we came back well and finished well. Match hasn't finished yet long way to go, result is the most important thing we are looking forward to it," Taskin said. "When we tried to attack

early on and they scored and had a good partnership and after lunch we had some meetings and plans and we executed them. The thing is you can do so many plans but you need to execute well and we executed well and according to plan we bowled and got them out," he said. "It is most important to take the lead because I feel the wicket is sporting and there is help for bowlers and batsman. Fast bowlers and spinners are getting help from it and it is important for the batsman. If we can put up a good total on the board by batting the whole day the result will

come in our way," he pointed out. "They have a very good bowling side as well I haven't seen them much but from what I saw in the first Test was really good. But still there are a lot to do like we have to bat well and bowl well in the second innings and win the game and nothing is finished yet. We did well we could have done better and we hope to do well," he said adding that he is impressed with pacer Nahid Rana. "Nahid Rana is great prospect for us he can bowl high 140 consistently and he can bowl around 150 so he is great prospect for us and he is getting better and learning," he said.
