Majhi says setting up HC bench in western Odisha under govt's consideration

Bhubaneswar: (KCN): A day after informing the Odisha Assembly that there is no justification for a High Court bench in the state, Chief Minister Mohan Charan Majhi Tuesday said that the issue of setting up the facility in the western region of the state is "under consideration" of the government.

Majhi said this in a statement in the Assembly before the commencement of the Zero Hour in the House. "The issue of setting up a High Court bench in Western Odisha is under consideration of the government," Majhi said. Stating that his government is committed to the delivery of speedy justice to the people, Majhi gave a clear message in the Assembly that his government was not averse to setting up

a high court bench in the state.

However, while replying to a written question in the Assembly, Majhi Monday had informed the House that "as per the Supreme Court verdict, there is no justification in having a bench of high court in any part of the state." Majhi's statement in the Assembly raised an outrage with members from the ruling BJP also protesting the idea. The opposition BJD and the Congress have criticized the state government over Majhi's statement in the House.

Senior BJP lawmaker and veteran leader from the western region, Jaynarayan Mishra has said: "We (BJP) have not withdrawn the demand for a HC bench in western Odisha. The CM has referred to the

Supreme Court judgment, but the state's population and HC cases are increasing. Why can't Odisha have an HC bench when Uttar Pradesh has three, and other states also have them?" BJD MLA from Bolangir Kalikesh Singh Deo who had asked the written question, said: "Today, the CM clarified that the matter is under consideration. He should give an assurance on the floor of the House on whether a circuit bench or a permanent bench of the HC will be set up in Bolangir and also mention the stipulated time frame." Singh Deo said the Supreme Court observation that the circuit bench demand had become obsolete with the passage of time and with the advent of technology while asking lawyers in Sambalpur to end their agitation after it had turned violent in November 2022.

"There was no verdict from the Apex Court on HC bench. Technology is not a replacement for a second bench or circuit bench. Bolangir has first right for a permanent bench since it had a bench in the pre-Independence era," Singh Deo said.



Vigilance arrests deputy director mines in disproportionate assets case

Bhubaneswar: (KCN): The anti-corruption vigilance sleuths Tuesday arrested a deputy director of mines for allegedly accumulating assets disproportionate to his known sources of income, an official statement said.

Dharanidhar Nayak, deputy director of mines, Talcher was found in possession of 2 multi-storey buildings, a 3-BHK flat worth Rs 1.30 crore and a duplex over 1,800 sqft area in Bhubaneswar, two market complexes with 19 shops, 11 plots,

deposits to the tune of Rs 53.53 lakh, household articles worth Rs 54.70 lakh and over Rs 9.85 lakh in cash, the vigilance statement said.

Nayak was posted as a mining officer at Koraput in 2014 and after seven years he

was transferred and posted at Talcher as a mining officer in 2021. He was later promoted to the rank of deputy director of mining. "Nayak has been placed under arrest and will be forwarded to the court today," the statement added.

Mamata Banerjee demands resignation of PM Modi as Bengal Assembly passes anti-rape Bill

Kolkata: West Bengal Chief Minister Mamata Banerjee Tuesday demanded the resignation of Prime Minister Narendra Modi, Union Home Minister Amit Shah and the chief ministers of all states that have "not been able to implement effective legislations to safeguard women".

Speaking in the assembly after tabling of the Aparajita Woman and Child Bill (West Bengal Criminal Laws and Amendment) Bill 2024, Banerjee said the Bill aims at quick investigation, fast justice delivery and enhanced punishment of the guilty. Once this Bill is passed, we will form a special Aparajita Task Force from among police to ensure time-bound completion of probe, the chief minister said.

Hailing the Bill as "historic and model for other states", Banerjee said that through this proposed legislation, her government has tried to plug the loopholes that exist in the central legislations in terms of speedy and effective disposal of justice to victims and their kin. When the BJP MLAs raised slogans demanding her

resignation, she retorted, "What if I raise slogans against the prime minister and the home minister for the same reasons you are raising slogans against me."

States like Uttar Pradesh and Gujarat have abnormally high crime rates against women whereas in West Bengal, tortured women are getting justice in courts, she claimed. Banerjee alleged that West Bengal was not consulted before passing BNS.

"We wanted discussions on it after the formation of the new government at the Centre," she said. Banerjee told the Opposition to ask the governor to sign the Bill without delay while asserting that it would be the state government's responsibility for its effective enactment.

"We want justice from the CBI and death by hanging of the guilty," Banerjee said over the rape and murder of the RG Kar medic while

expressing her sorrow over the gruesome crime. The Bill was later passed unanimously amid some chaotic scenes on the floor of the House.

The proposed amendments to the Bill moved by Leader of Opposition Suvenu Adhikari, were, however, not accepted by the House.

68 people killed in wild animal attacks in Odisha this year: Minister

Bhubaneswar(KCN): At least 68 people were killed in attacks by elephants and other wild animals in Odisha during the current year, state forest minister Ganesh Ram Singh Khuntia told the Assembly Tuesday. While replying to a written question of BJD legislator Arun Kumar Sahoo, the minister said besides human casualties, 1,087 houses and crops over 2315.79 acres were also damaged in incidents of the human-wildlife conflict in different forest divisions of the state during the current year. To prevent human habitations located near forest areas from elephant and other wild animal attacks, the government has been taking steps for the roll-out of an artificial intelligence (AI) supported e-surveillance project at Bharatpur area in Chandaka forest division, Hindol of Dhenkanal division and Bantala in Angul division on a pilot basis, he stated. With the help of AI, the forest officials can monitor the movement of

wild animals and accordingly, human habitations can be put on alert in advance, the minister said.

A maximum of 14 people were killed in such wild animal attacks in the Dhenkanal forest division, while eight such deaths were reported from the Keonjhar forest division, the minister said. Similarly, wild animal attacks claimed six human lives in each of the Bonai and Rourkela forest divisions, five people were killed in such attacks in the Angul forest division. The

Athagarh and Baripada divisions reported four human deaths each, he added.

Ram Singh Khuntia has informed that the government has so far received 9,168 complaints seeking compensation for the loss incurred due to elephants and other wild animals. The government has sanctioned compensation of Rs 51.92 crore, of which Rs 4.19 crore has been distributed to the affected families while Rs 99.58 lakh compensation money is yet to be distributed.

In another written statement to the House, the forest minister said there is a provision to provide compensation of Rs 20,000 per acre for damage to standing paddy and other cereal crops.

For commercial crops, the compensation amount is Rs 25,000 per acre, he said.

According to official sources, the forest department is also providing an ex-gratia of

Rs

6 lakh to the next of kin of the person, who died in the wild animal attack in the state.

focus on starting a family and having children, as their careers were already well-established.)"

"Similarly, Shammi uncle and Shashi uncle's wives, Geeta Bali ji and Jennifer aunty, unhone kaam kiya shaadi ke baad. Toh aisa kuch baat hai nahi ki Kapoor family mein shaadi ke baad kaam nahi kar sakte yaa Kapoor ladki kaam nahi kar sakti (Geeta Bali ji and Jennifer aunty continued working after marriage. So, it's not true that in the Kapoor family, you can't work after marriage or that Kapoor women aren't allowed to work. There was no restriction of that kind)," Karisma concluded.

The UP Files' director on making a film on Yogi Adityanath: Inspiring other leaders



'The UP Files' director Neeraj Sahai spoke to us about making a film based on the life of Yogi Adityanath, the current Chief Minister of Uttar Pradesh. He also talked about inspiring other state leaders with his cinema.

Director Neeraj Sahai, whose latest film 'The UP Files' is currently running in theatres, talked about making a film on the life and work of Yogi Adityanath, the current Chief Minister of Uttar Pradesh. In an exclusive interview with IndiaToday.in, he spoke about the need for making a political film, and the intention behind it.

Sahai said, "This is not about the life story of Yogi Adityanath ji. It is

inspired by his work for a state. This shows his journey as the leader of Uttar Pradesh. We are not talking about his personal life, we are talking about his work here. The intention is to make a film which can inspire the other state leaders to show the same courage as him." The director recalled the other films based in Uttar Pradesh. He said most of these films glorify UP as a criminal state and that irked him as a filmmaker and also as someone who belongs to the state. "Most of the films that are based in Uttar Pradesh show a negative side of the state. This is a positive film about its growth. We are not showing any

criminal activities. We are saying there's a leader who understood the essence of his state and worked towards growth," he said.

He added, "I am from UP. I know how the

state was infested with crime, gang wars, crimes against women. Many Chief Ministers came before Yogi ji but none of them cared to fix the problem. It was always about politics.

Yogi Adityanath is a saint. He only focussed on the transformation of this state. We felt there was a need to highlight the problem and to show how one man did the unthinkable."

For Neeraj Sahai, 'The UP Files' is an attempt to create cinema which can inspire and help transform other leaders in the country. "The idea also is to make other state leaders feel guilty and ashamed of their work. We want them to watch our film and feel inspired to do better work for the people of their state," he concluded.

The film features National Award-winning actor, Manoj Joshi playing the role inspired by Yogi Adityanath. It also stars Milind Gunaji, Anil George, Manjari Fadnis, Ali Asgar and Aman Verma, among others. The film is produced by Kuldeep Umraosingh Ostwal.

how the industry takes me is something I can't tell for myself."



Bulldozer Culture: It's merits and demerits



For the past few years, there has been much discussion in India about the 'bulldozer culture'. The current Chief Minister of Uttar Pradesh has even been nicknamed 'Bulldozer Baba' by some people. This culture has been used not only in Uttar Pradesh but in several other states as well. In such circumstances it is difficult to say how right or wrong it is to give this title to the Chief Minister of Uttar Pradesh. However, it is evident that in the recent situation, this term seems to be more of a political phrase and less of a social or administrative one. As far as I understand, the term 'bulldozer' is used to refer to

government actions against illegal constructions; that is, the use of government bulldozers to demolish illegal constructions, encroachments, or unauthorized structures. The main objective of this action is to protect government property, bring construction activities within legal boundaries, and regulate urban and rural development. Some political parties view it as a necessary step to maintain law and order, while others see it as a means of political retaliation and targeting specific communities. Political parties have differing opinions on the use of bulldozers. Opposition or critic parties believe that bulldozer actions are often carried out without any prior notice or legal process, violating the rights of affected people and leading to a waste of materials, labour, and money used in infrastructure.



Meanwhile, the parties in power argue that such actions help enforce the rule of law, instil fear in people with criminal tendencies, and free government property from encroachment. When, on whom, and how the 'bulldozer culture' will be used depends on the policies and intentions of the state and local governments. Nowadays, resorting to the bulldozer culture is becoming a complex and contentious issue. Therefore, before using it, several aspects need to be

considered, such as (1) legal process, (2) impartiality, (3) transparency, (4) impact on society, and (5) developmental aspects. If encroachments or illegal constructions obstruct public safety, traffic, or the rights of citizens and do not comply with regulations, they should be removed without discrimination. Many times, instructions to remove illegal structures are received from the courts. However,

when the bulldozer culture is used to target specific individuals, it becomes a matter of controversy and can lead to social tension and inequality. In any case, I believe that the bulldozer culture can only be a temporary and immediate measure in solving problems of encroachment and illegal construction, but it can never be a permanent solution. Therefore, all governments should work in a planned manner towards a permanent solution, rising above politics, and all officials and employees should

work without greed, fear, or bias. Urbanization should be planned, and there should be a system to ensure compliance with legal rules and procedures so that there is no need to resort to the bulldozer culture. A question always arises in everyone's mind: how do illegal occupations/constructions happen? What do the agencies responsible for inspection and monitoring do during the construction period? Why don't they see the illegal occupation and

construction? Who undertakes such constructions? Why is the bulldozer only used on the properties of criminals after they have committed heinous crimes? Can such problems not be solved through other measures like public hearings and community dialogue? Are strict actions taken against those responsible for allowing such occupations/constructions? Should governments consider making more effective rules, laws, and plans to prevent encroachment/illegal construction. In reality, there is a need to develop such a system where information about illegal acts can be obtained immediately, and legal action can be taken impartially and without discrimination. If this happens, there will be no need for the bulldozer culture.

informed that Kisan Mazdoor Panchayat will be held at Hisar, Haryana on 7th Sept, 2024. The farmers of Haryana and Jammu Kashmir will rally the people at large to Expose, Oppose and Punish BJP in the Assembly elections that will eventually ensure implementation of MSP@C2+50% with guaranteed procurement and comprehensive loan waiver across India with a priority to the small and middle farmers and agricultural workers.

The release claimed that the massive setback suffered by BJP across India in the just concluded 18th Lok Sabha elections- NDA lost in 159 rural constituencies- was mainly due to the anger among farmers, workers, youth and marginalised sections

agriculture and in defence of their livelihoods. The SKM alleged that the Haryana Chief Minister had attempted to misguide the farmers by falsely claiming MSP for 24 crops consciously hiding the fact that the procurement rate is not based on C2+50% but the current rate of

A2+FL+50%. The C2+50% rate of paddy, one of the major crops of Haryana is Rs.3012/qntl while the current rate is Rs. 2300/qntl means less by Rs. 712/qntl. Paddy farmers alone in Haryana had a loss of Rs.3851.90 crore in the year 2023-24. Similarly, though the workers movement were consistently in struggle

demanding minimum wage of Rs.26000/month, rolling back of four pro corporate labour codes and regularisation of their jobs in schemes including Anganwadi, Asha and Mid-Day meals, the BJP led State Government in Haryana and the Modi Government that rules Jammu Kashmir through the Lieutenant Governor had brutally ignored these huge mass sections.

SKM stated that by joining the 385 days long historic farmers struggle, 736 farmer martyrs made supreme sacrifice to save agriculture and forced the Union Government to repeal the 3 anti-national Farm Acts. CS Santi Kumari asked the collectors of these districts to make an advance plan and take precautions to avoid any loss of property or life. As there has been a downpour for the last four to five days, the situation is likely to be severe due to the heavy rains and the officials have been ordered to take strong measures in coordination with

the police and other departments. In view of the local conditions, the matter of declaring holiday for the educational institutions should be decided by the District Collectors. After opening the gates of Swarna and Kadem projects in Nirmal district the Collector was told to move the people of low lying areas to protected areas. She informed that a 31-member NDRF team along with four boats is being sent to Nirmal. At present 20000 cusecs of water is being released from the SRSP project. If this quantity of water increases, precautionary measures should be taken in the catchment areas on Monday. It is advised to coordinate with the Maharashtra authorities to know the quantity of water coming from the catchment area of Maharashtra from time to

Kolkata doc's rape-murder: Centre moves SC, alleges non-cooperation by WB govt

New Delhi (KCN): Centre Tuesday moved the Supreme Court alleging "unpardonable" non-cooperation by the West Bengal government in providing logistical support to the CISF, tasked with providing security at the RG Kar Medical College and Hospital in Kolkata, where a trainee doctor was raped and murdered.

Terming the alleged non-cooperation of the Trinamool Congress (TMC) government as an example "symptomatic of a systemic malaise", the Union Ministry of Home Affairs has sought a direction to West Bengal authorities to extend full cooperation to the Central Industrial Security Force (CISF).

The apex court August 20 termed the rape and murder of a doctor at the hospital as "horrific" and issued a slew of directions including setting up of a 10-member National Task Force (NTF) to formulate a protocol for ensuring the safety and security of doctors and other health care professionals.

Woman killed over refusal to serve 'handia'

The deceased was identified as Salke Hembra, wife of Mohan Hembra in the village. Speculations were rife that the murder might have taken place over suspected witchcraft

and sorcery as the family members have remained tightlipped and are yet to complain to the local police station. The villagers also refused to comment on the issue. Police rushed to the spot and launched an investigation after the deceased's brother Ghanashyam visited Ghashipura police station and complained, Monday. Police said the villagers attended a mass feast, Sunday. The incident occurred when Mohan and his family members

had gone to attend the feast leaving the woman and her elderly mother-in-law at house. Meanwhile, a person visited their house and asked the woman to bring her 'handia' from a local vendor. When she denied it, the man flew into rage and dragged her out of the house. There he hacked her to death with sharp weapons, her mother-in-law Sumi said. Despite being aware of his wife's murder, Mohan did not inform the police.

The matter came up before police after the deceased's brother visited the police station and lodged a complaint about his sister's murder. A police team led by Anandapur SDPO Prasant Kumar Behera visited the village and conducted an investigation, Monday. Police registered a case and detained a person in this connection while the actual reason behind the murder is yet to be ascertained, the SDPO said.

While playing her 100th Grand Slam match, she beat Liudmila Samsonova 6-4 6-1 to qualify for her 2nd US Open quarters. The Polish player not only won her last 33 out of 26 matches, but also registered her 8th consecutive sets win. Swiatek will next face Jessica Pegula in the next round at Flushing

Meadows.

"We played here two years ago. Playing against Jessica it's never easy. Pretty tricky game style. You have to work low on your legs and be ready for long rallies but also some intense hitting. She's a great player so for sure it's gonna be a challenge," Swiatek said at the on-court interview, as she realised the strength of her opponent.

Swiatek equalled Ema Navarro's record for

most hard court wins in the women's draw category as she registered her 29th win. The 16th seed was aiming for her first-ever Grand Slam quarter-final but couldn't get a single break point. She defended two break points in the fourth game, but could not get hold off Swiatek, who break the Russian to love in the 10th game.

The Russian was down 0-3 in the second

set, and fought off three break points in the 4th game. However, she handed Swiatek a break with the double fault. Swiatek closed it out on the second match point with her clinical play.

Uruguay football legend Luis Suárez has announced his retirement from international football, marking the end of an iconic career that saw him become the country's all-time top scorer. Suárez revealed his decision during a press conference on Monday, September 2, stating that he would retire after Uruguay's FIFA World Cup qualifiers against

Paraguay on September 6. Suárez will conclude his international journey as Uruguay's most prolific scorer, with an impressive 69 goals in 142 appearances across 17 years. Suárez made his senior debut for Uruguay on February 8, 2007, in a 3-1 victory over Colombia. He quickly became a vital part of the squad, playing a key role in securing Uruguay's spot in the 2010 FIFA World Cup in South Africa. By then, he had

already cemented his place in the team, featuring in 19 of the 20 World Cup qualifying matches.

"There is no better pride in oneself than knowing when the right moment to retire is, and luckily I am

confident that I am retiring from the national team because I want to take a step aside... I am 37 years old, and I know that it is very difficult to get to the next World Cup. It comforts me a lot that I can retire and not for my injuries to retire me, or to stop being called up," Suárez said in the press conference. "For me individually, it is very helpful for me to want to take that step aside and feel ready. It is difficult because the decision was not easy. But I go with the peace of mind that until the last game I gave my all, and that the flame did not burn out slowly and that is why I made the decision that it should be now," Suárez added.

"We've spoken to our bowlers about being ruthless, being disciplined and bowling with intent," he said. "And we just went away from our game plan and I've challenged the bowlers pretty strongly on that. We need to make sure that we're on each and every time because Test cricket can get away from you. The opposition is very good and I'm not going to shy away from saying Bangladesh played well. No question. But I know that our bowlers can do better in that situation than what they showed and we just need to make sure that execution is absolutely bang on each and every time.

Despite the situation that Pakistan find themselves in, Gillespie has defended the decision to leave out the senior pace duo from the XI for the second Test. "We looked at conditions and surfaces, what we thought the best combination was," he said. "We took into account what we saw before the game,
