## BJP hurts BJD Law body non starter

Bhubaneswar (K-**CN):** The Opposition BJP has hit the State's BJD Government where it hurts.

In the backdrop of the ensuing three tire panchayat elections scheduled in mid February, the saffron party has attempted to harp on the BJD's most popular Cheap Rice scheme and also the Mamata scheme targeting women voters.

Since both the issues are considered as the core of BJD's success in successive elections, the BJP that leads the Government at the centre, issued an advertisement in local dailies claiming that it is Centre which share most of the burden of the cheap rice scheme.

The Centre contributes Rs 19 per kilogram of rice while the BJD Government gives only Rs 2 and Rs 1 come from the beneficiaries.

This is certainly a clear attempt to target the BJD's popular scheme for which Chief Minister Naveen Patnaik used to get credit even during the previous UPA Government at Cen-

An advertisement with Prime Minister Narendra Modi's picture, explains that the Centre contributes most of the Cheap Rice scheme.

Similarly, Mr. Modi's recent announcement after completion of 50 days of demonetization, has also

uncomforted the BJD that used to sanction Rs 5,000 per pregnant women under Mamata Scheme.

However, Mr. Modi announced that the Centre would provide Rs 6,000 per

the state election commission alleging that the advertisement of PM's announcement was opposed to the model code of conduct in force since December



pregnant woman and the amount will be directly deposited in their bank/post office account.

These two issues have irked the BJD which on Monday drew attention of the State Election Commission here.

The ruling BJD alleged that the newspaper advertisement of Prime Minister Narendra Modi announcing packages for farmers, self-help groups and others is in clear violation of the model code of conduct which is in force for the three-tier panchayat elections in Odisha.

A party delegation led by BJD?Vice President Surjya Narayan Patro submitted a petition to

In its petition, the BJD said the Centre issued an advertisement in an Odia daily regarding launch of a scheme and announcement of packages for farmers, SHGs with the picture of Prime Minister in a "gross violation of the code of conduct in vogue in the state."

BJD requested the SEC to intervene and direct "forthwith the Centre to stop this propaganda and take stringent action against such violations."

Rejecting the ruling party's allegation, BJP leader K V Singh Deo said the packages announced by the PM were meant for the entire country and not just Odisha, where panchayat elections are due.

The State Election Commission had on Saturday imposed restrictions on campaigns promoting central government schemes in Odia newspapers and channels in view of the upcoming panchayat elections in the state.

The Commission

also restricted distri-

bution of leaflets and books highlighting the state government schemes at PDS distribution centres, involvement of government officials in election campaigns and backdated work orders. The SEC directive came in the wake of allegations made by the ruling BJD on two campaigns of the Centre - Ujjwal Yojana and Swachh Bharat Mission - carried in Odia print and electronic media after the model code of conduct came into force. SEC?Rabi Nara-yan Senapati has directed the Union government to stop promotion of its schemes in the local media at government expenditure as that



### China to ban ivory trade by end of 2017

**BEIJING(KCN):** China will ban trade and processing of all domestic ivory by the end of 2017 in a bid to save the fast dwindling tusker population in the country, a "historic move" hailed as a "game changer" for African elephants.

The decision came after China had imposed a three-year ban on ivory imports in March this year, in an escalated fight against illegal tradıng of wild animals and

"China gradually stop the processing and sales of ivories for commercial purposes by the end of 2017," the official Xinhua news agency said, citing a government state-

The move will impact China's 34 processing enterprises and 143 designated trading venues, with dozens to be closed by the end of March 2017, staterun Xinhua news agency quoted an official statement as

Before that deadline, law enforcement agencies will continue to clamp down on illegalities associwith elephant's tusk, an official told the

China's move, if implemented, strictly could a "game changer", specially the African elephant conservation as hundreds killed every year by poachers to feed into the burgeoning markets in China and Hong Kong.

As a result the numbers of Africa's savannah elephants dropped to 3.5 lakh thousand in 2014.

China's move to ban ivory trade followed a resolution at the Convention on International Trade in **Endangered Species** (Cites) in South Africa in October.

China has the biggest ivory market in the world - some estimates suggest 70 per cent of the world's trade ends up there. Ivory's price can reach USD 1,100 per kg in China.

Conservation group WWF welcomed the latest news, calling it a "historic announcement", signalling an end to the world's primary legal ivory market and a major boost to international efforts to "tackle the elephant poaching crisis in Africa", BBC reported.

Pepper, Elly deputy director of wildlife trade for the Natural Resources Defence Council, praised China for its 'great leadership" on the issue.

"Setting such an aggressive timeline to close - once and for all - the largest domestic ivory market in the world is globally significant, Pepper said.

"It's a game changer and could be the pivotal turning point that brings elephants back from the brink of extinction," she said.

While the international market in ivory has been closed since 1989, legal domestic markets have continued in many countries around the world.

A surge in the killing of elephants over the past seven years has seen populations across Africa shrink by a third, according to the recently published Great Elephant Census.

With a view to ensure that at least 40 percent bank notes were supplied to rural areas, the banks were advised to increase the issue of currency towards the main channels of dis-

chests to step up issuance of fresh notes to rural branches of Regional Rural Banks (RRBs), District Central Cooperative Banks (DCCBs) and commercial banks, white label ATMs and post offices on priority basis which are considered main rural channels of distribution," it said.

RBI asked the banks to issue notes in denominations of Rs 500 and below in rural areas with liberal issuance of existing stock of notes below Rs 100.

#### Sensex breaks seven day fall, but logs weekly loss

Mumbai (KCN): Breaking a seven-day losing pattern, the Sensex today reclaimed the key 26,000-mark by recovering 61 points, helped by gains in pharma, auto and capital goods, but both indices registered a weekly drop. For the week, the Sensex lost 448.86 points, or 1.69 per cent, while the broader NSE Nifty dropped 153.70 points, or 1.88 per cent.

This is their biggest weekly in five, which is since the week ended November 18. Domestic investors backed up and covering-up of short positions gave equities a push too. But a weak trend in Asia and a muted opening in Europe cast its shadow.

The rupee appreciated 21 paise intraday against the dollar, to 67.78, which had a positive influence too, brokers said. After a subdued opening, the Sensex dropped as foreign funds liquidated bets ahead of Christmas. but emergence of value-buying later meant it wiped off early losses before settling higher by 61.10 points, or 0.24 per cent, at 26,040.70.

The 50-share NSE Nifty ended up 6.65 points, or 0.08 per cent, at 7,985.75 points. Intra-day, it between shuttled 7,942.05 8,022.60.

Banks have mobilised an estimated Rs 14.9 lakh crore of deposits following demonetisation during the last 50 days. The interest rate cut is expected to boost sentiment, and spending, too, all of which have been hit because of demonetisation. Other banks are expected to follow suit in the coming days.

Deposit rates are also expected to slide further. The RBI has cut the policy rate the repo rate — by 175 bps since the start of 2015 but banks were slow in passing on the benefits to customers.

Prime Minister Modi had on Saturday advised banks to "keep the poor, the lower middle class, and the middle class at the focus of their activities" and act with the "public interest" in mind.

On Sunday, BJP president Amit Shah welcomed the cuts in a series of tweets posted on his official account.
