



Odisha celebrates Ram Navami with religious fervour

Puri(KCN): The famous festival of Ram Navami is being observed with religious fervour in the State after two years of strict Covid restrictions.

Thousands of devotees have been seen in crowds in temples across Odisha on the auspicious occasion. Since last two years, the devotees were not allowed inside religious institutions in view of the spread of deadly



coronavirus cases.

However, this year devotees were seen standing in long queues outside the temple since early morning.

Odisha Chief Minister Naveen Patnaik has wished the people of State and wrote "I greet the people of the state on the occasion of the ninth holy month of Ram. May the blessings of Lord Shriram make all people's lives prosperous and happiness, peace and prosperity," on his official Twitter account.

On the occasion of Ram Navami, sand artist Sudarsan Pattnaik has created a mesmerising sculpture of Lord Ram along with a miniature of Ayodhya's Ram temple.

"I have made an idol of Lord Ram along with a miniature of Ayodhya's Ram temple, its height is 6 feet. I pray the temple is built soon," said Patnaik.

Meanwhile, the Prime Minister Narendra Modi tweeted "Happy Ram Navami to the countrymen. May everyone get happiness, peace and prosperity in life by the grace of Lord Shri Ram."

The President of India has also extended wishes to the people of the country. He took to his official Twitter account and wrote "Happy Ram Navami to all the countrymen. Maryada Purushottam Shri Ram's life, his conscientiousness and high ideals are the source of guidance and inspiration for the entire humanity. Let us all take a pledge to contribute to nation building by imbibing the ideals of Lord Ram in our lives."

Ram Navami is celebrated to mark the birth of Lord Ram to King Dasharath and Queen Kausalya in Ayodhya in Treta Yuga on the ninth day of the light half of the month of Chaitra.

This festival is widely celebrated by the performances of Ram Leela (the sport of Rama) based on the famous epic Ramayana. Beginning from this day the performances continue for over a month. The Ram Leela, held in Asureswar of Cuttack district and Dasapalla of Puri district are well known.

On this day, people visit temples dedicated to Lord Ram, who is also known as "Maryada Purushottam", and pray to him to show them the right path in life and conduct.

Lord Ram was the seventh incarnation of Lord Vishnu. He established a welfare state for his people and set an example for everyone to follow. He was devoid of greed, hatred and vices, and stood for what was right, against powerful adversaries, and protected the weak. Devotees pray for peace, wealth, and success on this day, and seek Lord Ram's blessings.

Opposition fears power misuse by BJD govt to remove ULB chiefs

BHUBANESWAR(KCN): Even as the urban local bodies have formed their councils, the election laws empowering the State government to dismiss a directly elected mayor of Municipal Corporation or chairperson of municipality and notified area council (NAC) have run into controversy with Opposition political parties alleging they will be misused by the ruling party.

The power will be brought into effect where the council majority is with the ruling BJD and the chairperson belongs to Opposition, they alleged.

Of the 106 civic bodies, the BJP has 16 chairpersons, Congress seven and independents nine. The law provides that a resolution passed/supported by not less than two third of the total number of elected council is enough for the government to remove a chairman or mayor. The person holding the office of mayor or chairperson shall be deemed to have vacated such office with effect from the date the

resolution was passed and the same was published in the official gazette.

The apprehension of the Opposition is not without basis as it has happened in the past. In 1992, present BJP MP from Bargarh Suresh Pujari was directly elected to the post of chair-



man of Sambalpur Municipality as an independent candidate. The then ruling Janata Dal was in majority and the Congress had the second highest number of seats in the council. Caste certificate row: Rashtrapati Bhavan asks Odisha govt to take action

JAGATSINGHPUR January this year. The (KCN): President's Secretariat, New Delhi has recently directed the Odisha government

to take appropriate action regarding the issue of caste certificates to tribals in Odisso village of Jagatsinghpur district, which has reportedly been stopped for a year now. Last week, Officer on Special Duty (OSD), Rashtrapati Bhawan RK Sharma directed the Chief Secretary to take appropriate action regarding the matter after a petition was filed by a Scheduled Caste leader Sankar Das seeking intervention of President of India in this regard, in village Jagatsinghpur tehsil were not being issued caste certificates since last year.

Sources said, villagers of Odisso belonging to the Scheduled Tribes with sub-caste 'Matya' had applied for caste certificate in 1992 before tehsildar, Jagatsinghpur. They received the documents after due verification.

However, last year local tehsildar Anjali Tarai denied issue of caste certificates to these tribals citing lack of clarity on their sub-caste.

Written notice was not needed for Jharpada eviction: BDA

BHUBANESWAR(KCN): AS protests over demolition drive at Ganesh Bazaar haat in Jharpada intensified on Saturday, the Bhubaneswar Development Authority (BDA) claimed that a written notice was not required for eviction of encroachments. BDA Additional Commissioner for Enforcement Harish Chandra Nayak said mike (verbal) announcement, the usual practice, was made a day ahead of the eviction and ample time was given to the vendors to vacate the place.

The officials said they will convene a meeting with the representatives of the market and officials of Bhubaneswar Municipal Corporation (BMC) on Monday to discuss rehabilitation of the evicted vendors.

The meeting to be chaired by the BDA Secre-



tary will also be attended by representatives of BJP who are backing the evicted vendors. As many as three houses, 14 godowns, 25 polythene sheds and 97 shops - all tin structures - were razed during an early morning drive on Friday. Over 50 wooden/tin cabins were also pulled down by the joint enforcement squad of BDA and BMC in presence of Commissionerate Police during the drive despite stiff resistance from the shopkeepers and

BDA, which cleared the encroachments on the basis of the requisition filed by the General Administration department, on Saturday started installing boundary walls around the 3.207 acre government land.

Officials reiterated that the eviction was carried out as the plot had been allotted in favour of BDA for construction of a neighbourhood

BJP leaders, however, continued to dub the eviction drive as a political vendetta as their party's Dharitri Jena won the corporator seat from Ward 33.

An official from the BDA, however, said that the decision to carry out the eviction work was taken prior to the ULB elections.



Relevance of Digital Evidence Part

Contd from article published on 4th April

12. The sanctity and relevance of Digital **Evidence:** As in the case of written or oral evidence, digital



evidence can also be classified into three main categories:

a) Material evidence: Material evidence is any evidence that speaks for itself without relying on anything else. In digital terms,

this could be a log produced by an audit function in a computer system, the books of account maintained on a day-to-day basis on the computer, or any inventory management account maintained on the computer etc., if it can be shown to be free from contamination.

- b) Testimonial evidence: Testimonial evidence is evidence supplied by a witness. This type of evidence is subject to the perceived reliability of the witness. But if the witness is considered reliable, testimonial evidence can be almost as powerful as material evidence. For example, word processor documents written by a witness could be considered testimonial as long as the author is willing to depose that he wrote the same.
- c) **Hearsay:** Hearsay is any evidence presented by a person who is not a direct witness. Word processor documents written by someone without direct knowledge of the incident or documents whose authors cannot be traced fall in this category. Except in special circumstances, such evidence is not admissible in court of law. But even such evidence may constitute material and may be very relevant in Incometax proceedings, which are not bound by technical rules of evidences. Otherwise also, they can provide important leads for further investigation. Accordingly, merely gathering electronic evidence is not sufficient. Efforts have to be made to corroborate the contents therein visà-vis other evidence such as material and oral. Preliminary and detailed statements of the persons in control of computers/ electronic devices are always very important.

i) A person is in possession of **certain books** of account/ documents which are relevant for or useful to any proceedings under the Income-tax Act which the said person has not produced when asked to do so or there is a likelihood of such person not producing these documents/ books of account before Income-tax authorities, or

ii) The person is in **possession of money**, bullion, jewellery or other valuable article or thing (assets) which represent wholly or partly some undisclosed income.

- **b**) In the conventional search of a premises, the search team physically searches for the relevant documents/ books of account and assets in the premises. The relevant assets/ documents are also seized during the course of search. It is very easy to visualize the search operations involving a physical item including an asset or document other than an electronic document. The rules and procedures are also well laid out in respect of search and seizure of physical items. The authorized officers are also generally very clear about identification of relevant documents and assets which are required to be seized.
- c)The widespread use of computers in recent years has led to a new type of situation in searches of data stored on computer hard drives and other storage devices. The question is, how should provisions of section 132 of the Income Tax Act apply to the retrieval of data from data storage devices. The dynamics of computer searches turn out to be substantially different from the dynamics of conventional searches. The entire-search, identification of evidence, dynamic of premises searched is replaced by things like scan, acquisition, search and identification of digital evidence dynamics. Computer forensics analysis is typically performed subsequent to a search operation at the Income-tax or cyber forensics

laboratory. Weeks or months after the computer has been seized from the target's premises, an analyst may go through the world of information inside the computer and try to find the relevant evidence. The computer search and physical search of a place are similar fundamentally because the search team attempts to find and retrieve relevant evidence hidden inside the computer. Search of a computer is easy as well as difficult for many reasons. There may be thousands of folders. The authorized officer may not know as to in which folder relevant documents/information is lying. He can however, acquire/seize entire data if he chooses to. But identification of specific and relevant data is very time consuming job and possibly cannot be completed in the premise itself in most of the cases. The authorized officer's task, therefore is to first scan various devices to identify the device which may contain relevant evidence and acquire them, instead of acquiring each and every device containing digital evidence. It is required to be done in a manner that proper balance is struck between indiscriminate acquisition/ seizure of huge data which will make task of identification of relevant evidence tougher and at the same time ensuring acquisition of data from device wherever there is a possibility of locating relevant evidence. The copying procedure adopted by the Income tax department ensures that all relevant as well as irrelevant information stored on computer are acquired. Thus, identification of relevant devices is the key once a device containing relevant data is identified, copy of entire device is generally required to be made.

15. Recoding of Statement:

Statements of the persons in control of computers/ electronic devices (including system administrator) is recorded. In statements information regarding the hardware, operating systems, software and topography of the computers, various users and their roles and passwords are extracted. (Contd.)

deal with Digital Evidences: From the above discussion on the nature and legality of digital evidence, it is clear that investigation in an automated environment require standard methods and procedures for the following main reasons:

- a) Evidence has to be gathered in such a way that the same would be accepted by a court of law. This should be easier if standard procedures are formulated and followed. This would also facilitate exchange of evidence in cases having interdepartmental and international ramifications especially if investigators from other departments and countries collect evidence in similar manner. ii. Every care must be taken to avoid doing anything which might corrupt or add to the data, even accidentally or cause any other form of damage. The use of standard methods and procedures would diminish this risk of damage. In some cases, some data may be changed or over-written during the process of examination. Thus, there is need for a thorough understanding of technology which is being used by the investigator for examination and also need for its documentation so that it would be possible to explain the causes/ effects later on in a court of law. iii. Some of the most important reasons for improper evidence collection are poorly written policies, lack of an established incidence response plan, incidence response training and a broken chain of custody
- b) "Chain of custody" is the roadmap that shows how evidence was collected, analyzed and preserved in order to be presented as evidence. Establishing a clear chain of custody is critical because electronic evidence can be easily altered. A clear chain of custody would demonstrate that electronic evidence is trustworthy. Preserving a chain of custody for electronic evidence, at a minimum, requires that;
- i) No data has been added, changed, deleted from the seized information evidence.
- ii) The seized /information evidence was duplicated exactly and completely.
- iii) A reliable and validated duplication process was used.
- iv) All media were secure and safe.

Minor girl gang-raped and murdered in West Bengal; TMC leader's son booked

KOLKATA(KCN): A minor girl was allegedly gang-raped, who died later because of excessive bleeding, at a birthday party organised by the son of a local Trinamool Congress leader in Nadia's Hanskhali last Tuesday and the gruesome incident came to light after the victim's family lodged a complaint with police on Saturday night.

In a complaint lodged with Hanskhali police station, the family alleged the TMC leader and his associates forced them to cremate the body. Police arrested Brajagopal Goala, the accused and registered a case under the Protection of Children from Sexual Offences (POCSO) Act, 2012. The accused, the son of a local TMC dominated panchayat, was slapped with the charges of rape, murder and suppressing evidence. Police are investigating to ascertain who were the others involved in the incident.

"The family members of Brajagopal informed the girl's parents that she fell ill at the birthday party. They were also told not to take the girl to any state-run hospital or private healthcare unit. The victim's family took her to a quack doctor where she died," said an officer of Hanskhali police station.

ISLAMABAD: The change of government in Pakistan after the exit of hawkish Imran Khan and his likely replacement by hardcore realist Shehbaz Sharif may provide a

little window of opportunity for the leaders of India and Pakistan to reset their nearly frozen bilateral ties, according to experts.

As the younger brother of former three-

"Since India suspended the talks, the responsibility for its revival also lies on India. No government in Pakistan has opposed a meaningful dialogue," he said.

When Khan came to power in 2018, he promised to rebuild ties with India but soon the two countries came to blows in the wake of the Pulwama terror attack.

Though the storm passed but left behind jarring gaps in the relations with no possi-

bility of quick mending.

The revocation of the special status of Kashmir further alienated the two sides.

Time went by with little effort by either side to unfreeze the icy ties until a no-confidence motion by the opposition joint changed the situation.

Luckily India appeared only briefly in the vitriolic-ridden atmosphere leading to the removal of Khan.

Rather the Indian part was assigned to the US, which emerged as the whipping boy in the wake of a "letter" controversy.

The change could be an opportunity for resetting the ties between Islamabad and New Delhi, as Shehbaz has been saying that Khan damaged Pakistan's foreign policy. The main reason for hope is that the new prime minister should be seen as a continuation of Nawaz Sharif who still makes all political decisions of PML-N, and whose chemistry of relationship with Prime Minister Narendra Modi is not a secret.

There are also potential hurdles for Shehbaz and first of all he would be wary of being called as another 'Modi ka yaar' (friend of Modi).

Shehbaz may hold the reins for a brief period because several opposition leaders have indicated that new elections would be held soon after enacting necessary reform, especially those related to elections.

Any relaxation towards India in this short period would be blasted by Khan as a sell-

But the real hurdle is the 'K' word and it would be difficult for any leader in Islamabad to offer anything in the absence

of India showing flexibility on Kashmir. In fact, Shehbaz would be under pressure to match Khan's oratory on Kashmir.

Uzma Bokhari, a PML-N spokeswoman, said that Shehbaz after coming to power will push India to restore the special status of Kashmiris.

"Unlike Khan, India will speak to the serious political leadership of Pakistan led by Shehbaz and listen to our concerns," she

Samiullah Khan said that the PTI government failed to put pressure on India through the international community to restore the special status of Kashmir.

"Imran is even so confused that he is praising Indian foreign policy as 'independent' and indirectly is critical of Pakistan's," he said, adding Shehbaz would come up with a strong and pragmatic policy towards Pakistan's neighbours including India.

Askari said only limited space is available to the new leadership in Islamabad, adding that India should take lead and drop a hint to engage Pakistan.

"There is no indication as yet if there will be any impact of a change of government on the ties of the two countries. First, there should be an indication from India, which I don't see," he said.

But he didn't rule out improvement in the

coming years.

"In the long term, the two sides can engage and revive the dialogue," he said, adding that real change may come after fresh elections, which are expected before the end of this year. However, Bokhari is more hopeful about ties with India due to historical reasons. "It was our supreme leader Nawaz Sharif on whose invitation Indian premier Vajpayee had come to Lahore and peace efforts were launched between the two arch rivals." The strained ties dipped further after India's warplanes pounded a Jaish-e-Mohammed terrorist training camp deep inside Pakistan on February 26, 2019, in response to the Pulwama terror attack in which 40 CRPF jawans were killed. The relations deteriorated after India announced withdrawing the special powers of Jammu and Kashmir in August, 2019. India has repeatedly told Pakistan that Jammu and Kashmir "was, is and shall forever" remain an integral part of the coun-

Incidentally, Congress which remained in power in Odisha for several decades before losing its principal opposition status post 2019 general elections for Lok Sabha and State Assembly, has been losing its vote share since 2000 and its ratio falling with every election. The Congress vote share in 2000 was 35 per cent and in the 2019 Assembly polls it came down to 16.12 per cent votes. In the 2019 Lok Sabha polls, Congress secured 13.81 per cent of the votes against 26.38 per cent in 2014.

In the recent rural and urban polls, the Congress vote share has further declined to about 12 per cent thus virtually eliminating the old party from the political scenario of the state. Now, the Congress is no more a threat to Naveen's BJD,

The infighting within the party was one of the factors for the fall of Congress in the state. The party leaders ensured that they pulled down each other before the party finally lost the confidence of the people and became a signboard party. Therefore, Naveen has reasons to be happy as Congress reduced itself without any efforts from the ruling party.

Now, the BJP has re-

the same fate as that of Congress, since the infighting within the BJP came to the fore during the recent polls.

It is now evident that Union Minister Dharmendra Pradhan is considered as the face of the BJP and he has a pan-Odisha network while some other senior leaders are not ready to accept it. The party now has senior leaders like Aparajita Sarangi, Suresh Pujari, Pratap Sarangi, Baijayant Panda, Jaynarayan Mishra and above all Bijay Mohapatra.

All the senior leaders

are hesitant to endorse Dharmendra's softness towards the BJD Government in Odisha. Some believe that the party cannot grow in the state unless it adopts the West Bengal approach. Many of them feel that the BJP should rise to the occasion and give an impression to the people that they are the real opposition and there is no shadow boxing between the BJD and the BJP. They are restless for real political fights.

The BJP which won 297 Zilla Parishad seats in 2017 panchayat elections, ended up with just 42 seats in 2022. Similarly, the party also performed miserably in the urban polls thus indicating that the BJP's acceptability to the people has declined in comparison to the 2019 elections. Political observers feel that people at large are under the impression that the BJP and BJD are

fron government in the state.

Bhubaneswar MP Aparajita Sarangi was the first to blame the BJP's state leadership following the saffron party's debacle. Aparajita's attack was directly against Samir Mohanty, the state president. BJP Mohanty, in fact, operates on the line of Mr.Pradhan's dictum and therefore, identified with one group while others prefer to remain sidelined and do not put their best efforts for the party during the elections. Though Aparajita expressed her views in public, others preferred to remain silent and did not oppose her statement which indicated that they tacitly support her. It is said that "Moune Sammati Lakshnam" meaning 'silence indicates support'. Neither Baijayant Panda, nor Pratap Sarangi or others spoke on the issue. However, it was

Bijay Mohapatra, who was sidelined in the party for a long time, said the dismal performance of the party in the panchayat elections was expected. However, Samir Mohanty was to reject Mohapatra's statement and said the party still holds 30 per cent of the vote share and therefore, not rejected by the people.

Though Mr.Mohanty did not publicly oppose Aparajita's statement, he led a delegation of lawmakers to Delhi and apprised everything

an appointment with Prime Minister Narendra Modi and met him for apprising the situation in the state. Aparajita, called it a courtesy call. And there is no secret on Aparajita's move because her timing was just immediately after Mohanty's meeting with Nadda.

Aparajita, who resigned from the elite All India Civil Service, had joined the BJP with the blessings of PM Modi and it is obvious for her to draw the PM's attention when she faced problems within the party in Odisha. As such she was not made a Minister in the Modi government even as her batch mate Ashiwini Vaishnaw got the economic portfolios like Railways, IT and Communications. She is of strong view that the BJP can replace Naveen from the government for which well-planned strategy along with proper coordination of all the senior leaders are most essential. What Aparajita feels may be genuine, but keeping in view the prevailing political situation, Modi can hardly annoy Naveen!

The weakening of BJP in Odisha has made Naveen internally happy and he has to do less efforts to win the next polls in 2024. He knows that a faction-ridden party cannot win elections, which has happened in the case of his legendary father Biju Patnaik, who lost the elections in 1995 despite remaining at the height of popularity.

Mayawati rebuffs Rahul Gandhi, advises him to put his own house in order

LUCKNOW: In a strong rebuff to former Congress president Rahul Gandhi's claims that the party had approached Bahujan Samaj Party (BSP) for alliance in UP Assembly polls, BSP chief Mayawati on Sunday advised Gandhi to direct his concern on his own party rather than

Rahul Gandhi had claimed on Saturday that the Congress had even offered Mayawati the chief minister's post but she did not respond because she was under pressure from the Centre's investigating agencies like CBI and

Accusing Rahul Gandhi of following his father and former PM late Rajiv Gandhi in tarnishing the image of her party and its leaders, Mayawati asked him first to put his house in order before preaching to others.

Refuting the claims of Rahul Gandhi out rightly, Mayawati said his remark was the manifestation of the Congress party's inferiority complex, casteist mindset and hatred for the deprived and downtrodden along with the BSP. "Before making any reference to my party, Rahul Gandhi should throw a glance at his house which is in disarray. Even the BJP is taking advantage of that," Mayawati said while interacting with media persons here on Sun-

She further accused the Congress of blocking Dalit people's emancipation by denying them reservation benefits and diverting funds for the socially oppressed classes to other purposes. The BSP chief charged the Congress with trying every trick up its sleeves to weaken the movement for the downtrodden and deprived started by Dr BR Ambedkar and BSP founder Kanshi Ram. She reminded that once late Rajiv Gandhi had gone to the extent of calling Kanshi Ram a CIA agent. "He (Rahul) has only been following his father's footsteps by accusing BSP of having a tacit understanding with the BJP. This is completely unfounded," she said. Mayawati added that Congress' own record against the BJP had been dismal as the grand old party did not appear fighting against the saffron brigade and Rashtriya Swayamsevak Sangh (RSS), especially at a time when the ruling dispensation seemed to be eager to end democracy by making it a one-party system from panchayat to Parliament.

Mayawati said that when BSP came to power with an absolute majority in 2007, the then Congress-led UPA government at the Centre created hurdles in various projects initiated by her government. Mayawati claimed that at the time of the High Court judgement in the vexed Babari Masjid-Ram Janmbhoomi issue, the Centre did not provide Central security forces to ensure security and maintain law and order. "That was an indication of a conspiracy against my government and then imposing President rule to govern UP from the back door," said the BSP chief. She even asserted that Congress's alliance with the Samajwadi Party in 2017 led to the meteoric rise of the BJP in

Mayawati even took a jibe at Rahul Gandhi for hugging PM Narendra Modi in Parliament saying her party did not believe in dramatics as was done by Rahul Gandhi. In the recently concluded Assembly elections, the BSP stands decimated with just one seat and a vote share of a little over 12.9 per cent registering a decline of 9.35 per cent as compared to 2017. Similarly, the Congress party has also turned into a non-entity in the state which it ruled till 1989. The party could win with just two seats of 403 with a vote share of 2.33 per cent in 2022.

FAQ on taxation of crypto, virtual digital assets in works: Official

NEW DELHI: The government is working on an FAQ on taxation cryptocurrencies,

which will give a nuanced clarification on legal sanctity, law ministry's opinion is being sought to ensure that there is no loophole," the official told PTI.

the applicability of income tax and GST on virtual digital assets, an official said. The set of Frequently Asked Questions (FAQ), which is being drafted by the Department of Economic Affairs (DEA), RBI and Revenue Department, would also be vetted by the law ministry, the official added.

"FAQ on taxation of cryptocurrency and virtual digital assets is in works.

Although FAQs are for information purposes and do not have Department and the Reserve Bank are working to ensure that the taxation aspect is clear both for field tax offices as well as those who deal with cryptocurrencies and other virtual digital

assets. The 2022-23 Budget has brought in clarity with regard to levy of income tax on crypto

assets. From April 1, a 30 per cent income tax plus cess and surcharges will be levied on such transactions in the same cent TDS (tax deducted at source) on payments towards virtual currencies beyond Rs 10,000 in a year and taxation of such gifts in the hands of the recipient.

The threshold limit for TDS would be Rs 50,000 a year for specified persons, which include individuals/HUFs who are required to get their accounts audited under the I-T Act.

The provisions related to 1 per cent TDS will come into effect from July 1, 2022, while the gains will be taxed effective April 1.

From the GST perspective, the FAQ is likely to provide clarity on whether cryptocurrency is goods or service.

Currently, 18 per cent Goods and Services Tax (GST) is levied only on service provided by crypto exchanges and it is categorised as financial services.

The GST law does not clearly mention classification cryptocurrency.

In the absence of a law on regulating such virtual digital currencies, the classification has to take into account whether the legal framework categorises it as 'actionable claim'.

An actionable claim is a claim which can be made by a creditor, for any type of debt other than a debt secured by mortgage of immovable property. Separately, the government is working on a legislation to regulate cryptocurrencies, but no draft has yet been released publicly.

Gross revenue collection jumps 34 per cent in FY22

NEW DELHI: India's gross revenue collections for the financial year ending March 31, 2022, exceeded the budget estimates and revised estimates indicating a strong economic recovery, Revenue Secretary Tarun Bajaj said Friday.

As per the Government data, the gross revenue collection grew by nearly Rs 5 lakh crore to Rs 27.07 lakh crore, if compared with the budget estimates. The revised estimates for FY 22 were at Rs 25.16 lakh crore.

The tax collected in FY22 was 34% higher than the previous year. According to the Finance Ministry, 2021-22 marks the highest tax-GDP ratio of 11.7%, with direct tax to GDP ratio at 6.1% and indirect tax to GDP ratio at 5.6%.

"The tax buoyancy is at a very healthy figure of 1.9, with 2.8 for direct taxes and 1.1 for indirect taxes. The ratio of direct to indirect taxes recovered back to 1.1 in 2021-22 from 0.9 in 2020-21," the Secretary said while in-

30 APR For Property Return Submit

Bhubaneswar: As many of its employees are busy discharging election duty, the State Government has given another month's time to them to submit their property return details. Now, the government officers can submit their asset details before 30 April. The General Administration and Public Grievances Department has issued a circular to all the Departments, RDCs and District Collectors. The last date of submission of Property Statement by all the State Government employees for the period from January 1, 2021 to December 31, 2021 was extended up to March 31, 2022. However, it has come to the notice of the GA&PG Department that some of the employees could not submit their annual property statement, due to their preoccupation in the last Election to Panchayati Raj Institutions and Urban Local Bodies or some other difficulties, it said. Considering such difficulties, the Government has pleaded to allow extension of the timeline for submission of property statements online (Using HRMS portal) for the period upto 30 April, 2022, the circular said.

The senior officers have been requested to inform all of their subordinate offices about the extension of the deadline. The employees have been directed to not to wait till the deadline comes closer and file their property statement ahead of the timeline.

Earlier, the Government had extended the deadline thrice in view of the prevailing Covid-19 situation.

To pave the way for compulsory submission of property statements by all Government employees, the State Cabinet in its meeting held June 9, decided to amend Odisha Government Servants' Conduct Rules, 1959.

As per the provisions prescribed under Rule-21 of the Odisha Government Servants' Conduct Rules, 1959, every Government servant is required to make a true and complete declaration of all his assets movable and immovable and the value thereof.

However, with the amendment, now the statement can be placed in the public domain for information of the general public. A copy of the property statement will also be forwarded to the Lokayukta for his information.

period. He was removed from the post of chairman with two-third members recording their lack of confidence on him.

"Chances of dismissal of three mayors appear thin as the BJD has majority in all the three municipal corporations, but there is every possibility that the State government may encourage undemocratic process to remove the chairpersons from Opposition in those municipalities or NACs where the BJD is in majority," Pujari said.

The BJP parliamentarian said he had then questioned the legality of his removal when he was directly elected by the voters of the municipality. Since the members of the council had not elected him as chairman, they had no right under the law to remove him.

Senior Congress leader and former Finance minister Panchanan Kanungo, however, said the government always has the power to remove a directly elected mayor or chairperson. "It is to be seen if the government is following the due process of law in letter and spirit or bending the rules to oust the chairman on political grounds," he said adding, there should have a provision to recall as the civic bodies chiefs are directly elected by the people. teracting with the media. The gross corporate taxes during 2021-22 stood at Rs 8.6 lakh crore



as compared with Rs 6.5 lakh crore in the previous year.

During the year, the Income Tax department gave refunds of Rs 2.24 lakh crore. "During last two years, the effort has been to clear backlog of refunds to infuse liquidity into the hands of businesses. During the year, 2.4 crore refunds were issued that included 2.01 crore related to the year 2021-22, for which the returns were filed till March 31, 2021," the Finance Ministry official said.

With regard to indirect taxes, GST saw a robust growth during 2021-22 despite two waves of the Covid pandemic. CGST revenues grew from Rs 4.6 lakh crore last year to Rs 5.9 lakh crore in 2021-22. The average monthly gross GST revenue in 2021-22 was Rs 1.23 lakh crore as against Rs 94,734 crore in 2020-21 and Rs 1.01 lakh crore in 2019-20.

IPL 2022: Knightmare comes true for Kolkata

CHENNAI: Kolkata Knight Riders' strength this season have been their pacers picking wickets in powerplay and spinners — Varun Chakravarthy and Sunil Narine — choking the run-rate in middle-overs.

Umesh Yadav had bowled 11 overs for 51 runs, taking six wickets in the four games so far. Chakravarthy had operated at 6.43 runs per over while Narine had conceded only 4.75 runs per over. But, as they went up against Delhi Capitals, it seemed like the best of their attack could be playing into the hands of their opponents.

For starters, it was a day game, which meant the pacers had no help whatsoever from the conditions. Then there was Prithvi Shaw, the best batter in the first six overs this season — 76 runs in three innings while striking at 161.7 up until this clash.

If all this wasn't enough, they couldn't use spin against David Warner like other lefthanders early on as he feasts on them. Warner averages 87.28 against spin in their powerplay with a strike rate of 139.81 across 80 innings. It seemed like the battle was lost on match-ups before the contest even began. And that is exactly what happened as Warner and Shaw tore apart the Shreyas Iyer-led side at Brabourne stadium after being put into bat on Sunday afternoon. While the latter took a particular liking to Umesh, hitting 20 runs in his first two overs, Warner took care of his Australian counterpart, Pat Cummins, welcoming him with back-to-back boundaries. Shaw continued his onslaught, pulling Cummins over square-leg to bring up the 50run stand in just four overs.

Sticking to their game plan, Shreyas brought on Chakravarthy next. But, Warner, as expected, was all over the mystery spinner. It took just one delivery for the veteran to deposit Chakravarthy into the stands. As Delhi were flying at 11.8 runs per over, Shreyas had just one trump card in his pocket — Narine.

But much to Kolkata's misery, the West Indian was up against the two batters, who have dominated whenever they faced him: Shaw (166.66 SR, 0 dismissals) and Warner (average 83, SR 156.6). The duo brought out the reverse-laps and sweeps, taking on one of the best spinners in the history of the league. It felt like Kolkata's worst nightmare came



Shreyas had nowhere to go at this point. All that was left in his armour was Andre Russell and Venkatesh Iyer. Delhi kept the momentum going as Shaw brought up his half-century first in 27 balls. He eventually got out to Chakravarthy, but the damage was done as they had cruised to 93 for nil in 8.3 overs. Rishabh Pant wasted no time in settling down, smashing a 14-ball 27. Narine made inroads at the other end, but Warner was going strong, registering his first fifty of the season. Kolkata did manage to take a few wickets against the run of play. At one point, they had pulled things back a bit. Delhi were 167/5after 17 overs with Shardul Thakur and Axar Patel in the middle. It seemed like Kolkata still had a chance.

But, as seen in the past, Kolkata's best bowling phase was done and dusted. Their death bowling record is no secret — 11.06 average economy in overs 16-20 this year. And Sunday was no different. By the time Thakur and Patel helped Delhi register the highest total of the season so far 215/5, scoring 48 runs from the last three, the contest was all but over unless Russell pulled off a heist. Delhi managed to prevent that as Kuldeep took a four-fer against his former team, helping them win by 44 runs.


