



# Spread Happiness Foundation has become the backbone of Dadan workers

Bhubaneswar(KCN): :In Kerala, the body of a dead Dadan worker was taken to his ancestral village in Sorada block on 15th Apr 2022. The current Dadan problem is a major problem.Immigrants who leave their homes and live abroad to work for their livelihoods are sometimes tortured and their lives are lost in accidents. At such a critical juncture, Spread Happiness Foundation an expatriate Oriya voluntary organization formed by the efforts of Soumya Ranjan Mohapatra, a young man from Bellguntha, stood by the Dadan workers and repeatedly extended a helping hand to both the state government and the district administration.

The body of Kalu Nayak, a resident of Badbadangi village in Sorada block, who lost his life in a road accident on 20th February 2022, with the help of our organization, was transported to his hometown from Ernakulam,Kerala.

According to sources, a 23-year-old man named Gandhi Patra of Asurbandh Panchayat in Sorada block was seriously injured when he fell into a pouring machine while working as a day laborer in Kerala and died while undergoing treatment.

Gandhi's body was flown from Kerala to Bhubaneswar by air with the help of the Odisha government and the Ganjam district administration. Many members, including Soumya Ranjan Mohapatra, Chairman of Spread Happiness Foundation and Janakiballav Patnaik a young volunteer from Sorada, were helped in depart the body of late Gandhi and offered condolences to the bereaved families.

The efforts of the Government of Odisha and the Government of Kerala and Spread Happiness Foundation, which brought the dead body of the deceased to their ancestral village in such a tragic state, have been widely praised.



# **Relevance of Digital Evidence Part 4**

Contd from article published on 11th April 2022) 16. Some decisions regarding theadmissibility of digital evidence:

The Supreme Court in Anvar P.V. v. P.K. Basheer and others, AIR 2015 SC 180, clarified the law regarding the admissibility of digital evidence in India. In this case, departing from



its earlier ruling in State (NCT of Delhi) v. Navjot Sandhu, AIR 2005 SC 3820, the importance of Section 65B was recognised. Supreme Court observed that, "any documentary evidence by way of an electronic record under the Evidence Act, in view of Sections 59 and 65A,

can be proved only in accordance with the procedure prescribed under Section 65B, which deals with the admissibility of electronic record. The purpose of these provisions is to sanctify secondary evidence in electronic form, generated by a computer. The Section starts with a non obstante clause. Thus, notwithstanding anything contained in the Evidence Act, any information contained in an electronic record which is printed on paper, stored, recorded or copied in optical or magnetic media produced by computer shall be deemed to be a document only if the conditions mentioned under Section 65B(2) are satisfied, without further proof or production of original. The admissibility of such document, i.e., electronic record which is called as computer output, depends on the satisfaction of the four conditions under Section 65B(2) of the Indian Evidence Act. The Court also pointed out, "only if the electronic record is duly produced in terms of Section 65B of the Evidence Act, the question would arise as to the genuineness thereof and in that situation, resort can be made to Section 45A - opinion of examiner of electronic evidence".

In Abdul Rahman Kunji v. State of West Bengal, in C.R.A. Nos. 454 & 624 of 2009 decided on November 14, 2014, the Calcutta High Court has dealt with the issue of admissibility of emails as evidence. The Court pointed out that such evidences in connection with an email can be admitted as evidence only if it satisfies the conditions mentioned under Section 65B of Indian Evidence Act, 1872.

In Rakesh Kumar and Ors. v. State, Criminal Appeal No. 19/2007 decided on 27.08.2009, Delhi High Court while appreciating the reliance placed by the prosecution upon the Call Records, observed computer that generated electronic

records is evidence, admissible at a trial if proved in the manner specified by Section 65B of the Evidence Act.

In Dharmbir v C.B.I., 148 (2008) DLT 289 **d**) before Delhi High Court, the question was whether a hard disc can be considered as an electronic record or not. The Court pointed out, "While there can be no doubt that a hard disc is an electronic device used for storing information, once a blank hard disc is written upon it is subject to a change and to that extent it becomes an electronic record. Even if the hard disc is restored to its original position of a blank hard disc by erasing what was recorded on it, it would still retain information which indicates that some text or file in any form was recorded on it at one time and subsequently removed. By use of software programmes it is possible to find out the precise time when such changes occurred in the hard disc. Therefore, when Section 65B talks of an electronic record produced by a computer (referred to as the computer output) it would also include a hard disc in which information was stored or was earlier stored or continues to be stored.

In Jagjit Singh v. State of Haryana (2006) **e**) 11 SCC 1, the Speaker of the Legislative Assembly of the State of Haryana disqualified a member for defection. The Supreme Court considered the digital evidence in the form ofinterview transcripts from Zee News, Aaj Tak television channels and Harvana News of Punjab Today television channel. The Court held that, the electronic evidence placed on record was admissible and upheld the reliance placed by the Speaker on the recorded interview when reaching the conclusion that the voices recorded on the CD were those of the persons taking action.

In State of Maharashtra v. Dr. Praful B. f) Desai AIR 2003 SC 2053, the Supreme Court dealt with the use of Video Conferencing and the legality of evidence obtained therein in a criminal case was discussed, the Court observed that, "in cases where the attendance of a witness cannot be procured without an amount of delay, expense or inconvenience, the Court could consider issuing a commission to record the evidence by way of video conferencing".

g) In Twentieth Century Fox Film Corporation v. NRI Film Production Associates (P) Ltd., AIR 2003 Kant. 148, Karnataka High Court laid down several safeguards for recording evidence through audio-video Link. These are:

Link, witness is to file an affidavit or an undertaking duly verified before a notary or a Judge that the person who is shown as the witness is the same person as who is going to depose on screen. Copy of Identification affidavit is to be made available to other side.

The person who examines the witness on (ii) the screen is also to file an affidavit/undertaking before examining witness with copy to other sideregarding identification.

(iii) Witness has to be examined during working hours of Indian Courts. Oath is to be administered through the media.

(iv) The witness should not plead any inconvenience on account of time difference between India and USA.

Before examination of the witness, a set **(v)** of plaint, written statement and other documents must be sent to the witness so that witness has acquaintance with the documents and an acknowledgement is to be filed before the Court in this regard.

(vi) Learned Judge is to record such remarks as is material regarding the demur of the witness while on the screen.

(vii) Learned Judge must note the objections raised during recording of witness and to decide the same at the time of arguments.

(viii) After recording the evidence, the same is to be sent to witness and his signature is to be obtained in the presence of a Notary Public and thereafter it forms part of the record of the suit proceedings.

(ix) The visual is to be recorded and the record would be at both ends. The witness also is to be alone at the time of visual conference and notary is to give certificate to this effect.

(x) The learned Judge may also impose such other conditions as are necessary in a given set of facts.

(xi) The expenses and the arrangements are to be borne by the applicant who wants this facility. h) In Amitabh Bagchi v. Ena Bagchi AIR 2005 Cal. 11, Calcutta High Court held that, "it is to be remembered that by virtue of an amendment and insertion of Sections 65A and 65B of the Evidence Act, a special provision as to evidence relating to electronic record and admissibility of electronic records has been introduced with effect from 17th October, 2000. Consequential amendments are also made therein. Therefore there is no bar of examination of witness by way of Video Conferencing being essential part of electronic method".

In Bodala Murali Krishna v. Smt. Bodala Prathima 2007 (2) ALD 72, Andhra Pradesh High Court, dealt with the question of use of video conferencing in a civil case. Court observed, "When such facility is accorded in criminal cases, there should not be any plausible objection for adopting the same procedure in civil cases as long as the necessary facilities, with assured accuracy exist".

Arjun Panditrao Khotkar v. Kailash Kusahanrao Goryantal MANU/SC/0521/ 2020 (SC), Supreme Court held that the required certificate under Section 65B(4) is unnecessary if the original document itself is produced. This can be done by the owner of a laptop computer, computer tablet or even a mobile phone, by stepping into the witness box and proving that the concerned device, on which the original information is first stored, is owned and/or operated by him. In cases where the "computer" happens to be part of a "computer system" or "computer network" and it becomes impossible to physically bring such system or network to the Court, then the only means of providing information contained in such electronic record can be in accordance with Section 65B(1), together with the requisite certificate under Section 65B(4). It was observed that law declared by this Court in Anvar P.V. (supra), is the law on Section 65B of Evidence Act. The Apex Court ruled that judgment in Tomaso Bruno (supra), being per incuriam, does not lay down the law correctly. Also, the judgment in SLP (Crl.) No. 9431 of 2011 reported as Shafhi Mohammad (supra) and the judgment dated 03.04.2018 reported as (2018) 5 SCC 311, do not lay down the law correctly and are therefore overruled.

**Conclusion:** Digital frontier is rapidly 17. changing and it is an evolving environment. Further, in order to keep the integrity of data in secured condition, it is essential that no changes should be made while handling digital evidence. Moreover, due to the bar of self-incrimination under Article 20(3) of the Constitution of India, accused cannot be made a witness against himself. Hence, in such situation the question of admissibility of such electronic record is in peril. In future through judicial intervention, our judiciary may find a solution for this dilemma. Concluded)

Sun' and 'Washington ever happened to the State of Orissa and removed the greatest figure of our time at very climax of his career. Grief and shock swept across Orissa as news of his death spread. It was perhaps a tryst with destiny that Patnaik was cremated at Swargadwara, Puri. He was to rest in peace close to the abode of his Kalia (Lord Jagannath). Though he was not religious in the traditional sense, he had a sentimental attachment to Load Jagannath. While addressing public meeting in front of the Puri Jagannath Temple, he used to enter into a monologue with the Lord. "It may not be exaggeration to say that Biju Patnaik was the tallest among all leader from Orissa, who made their mark in national politics. A major reason why he acquired his status was undoubtedly his romantic, impulsive nature, which made him stand out even at a time when, with Nehru and J.P. at the height of their power and there was no death of colourful politicians in India". According to the veteran journalist, there is no epithet that is not used about him. "Why, volatile, flamboyant, dynamic, reckless, daredevil, damn efficient" and what not ? Perhaps all these suit him in one context or the other. But in the jungle of attributes his essential human qualities, his deep love for the people, are often missed. Once Patnaik is deeply moved by the peoples' distress, he will move mountains to give succour. When Government at the State and the centre were busy doing maths on relief expenditure. Biju pressed into service a private aircraft and himself started dropping food packets to the marooned thousands who would have perished, but for this prompt step. Tales and anecdotes about him are a legion. There is a story that Pt. Nehru once asked Dr. B.C. Roy -Have you met a man called Biju Patnaik". "I have heard about him : but not yet met him", was the reply of the Bengal Chief MINISTER. Nehru said, meet him sometimes. I like such forward-looking, brave people. The only difficult is that sometimes you don't know where he will land you. A giant transference of energy had taken place between him and his people. He delighted the people by his youthfulness of sprit and body and the people were attracted to his spontaneity and utter freedom from pompousness. In the end, his great strength far outweighed his weakness. Therefore when he died, even his most partisan adversaries felt compelled to acknowledge the immensity of the man they had opposed.



wealth of natural resources and yet it is the poorest and most backward state of India. Therefore for him any plan for the development of these vast natural resources, which shall help transform poverty into plenty may well serve as a model for other similarly situated areas in India.

Within that short period during which he took the stewardship of the State administration, Biju Patnaik laid the blue print for Orissa's development and the State was on the threshold of a new of industrial revolution. He not only accelerated the process of development, but was able to locate a number of new industries in the State - the MIG factory as Sunabeda, Balimela Dam, Public Corporations, Panchayat Industries, the Express High way and a lot many. His ambitious projects, which he named as "Decade of Destiny" was meant to elevate the State to a new height.

Biju could not tolerate red-tapism. He would have a thing done immediately and not suffer any delay. Result he was charged with administrative impropriety. To the officials his advise was, "be loyal to me not to the government but to the destinies of this State, to the prosperity of the people". There is a story that once when a speeding motor truck carrying stones for the Paradeep Port was stopped by a traffic policeman, the drives humorously replied that the speed suggested by the policeman would delay the port work by several years, when Biju Patnaik wanted everybody to work at top gear. The importance that Bijuj attached to Orissa's industrial development was reflected in his speech which he delivered at the inauguration of the Orissa Planning Board on June 15, 1962. He had said – "A people cannot grow unless the industries were developed and established here". Calling upon the bureaucrats to change their work-style, Patnaik said, "In the new set-up in the new adventure which we are going to embark upon, I would expect my officials to become thinkers and administrators in turn. I would expect them to collectively and

expect them to become leaders of men and not leaders of the longest notes on the files".

At the invitation of Biju Patnaik, Internationally known Biologist. Scientist and Philosopher Prof. J.B.S. Haldane accepted the post of the Director of the Biometry and Genetics Laboratory at Bhubaneswar, which was set up by the Government of Orissa. Prof. Haldane, who imparted to the Indian scientific scene a certain colour and character, became an Indian citizen in 1960 and devoted himself to assisting development of science in this rapidly developing country. He accepted Biju's offer because he (Biju) was 'capable of displaying great respect towards individuals whom he considered to be performing worthwhile work'. This genius died in Bhubaneswar on 1st December, 1964. After Biju Patnaik took the rein of the State administration, Orissa witnessed rapid strides in education. The period between 1961-67 is aptly described as the golden era in the history of education of the State. At his initiative the Regional College of Education was set up at Bhubaneswar. The Regional Engineering College at Rourkela was established in 1961, the Orissa University of Agriculture and Technology was set up and during the Chief Ministership of Biren Mitra (when Biju was the Chairman of the State Planning Board). Universities were established in Berhampur andSambalpur. Thus Biju is responsible for the giant leap forward of education in Orissa. When the Union government refused to construct the Paradeep Port, as the Chief Minister of Orissa he took upon himself to mobilize resources from within the State and built the Rs.14 Crore Port when the Centre did not show much interest in the project Patnaik's strong stand on the issue was vindicated when the Centre took over the Port after some years. Biju Patnaik proved his extraordinary organising ability by successfully holding the Congress Session in 1964 at Bhubaneswar. His dream was fulfilled when on 12<sup>th</sup> March 1966, the Paradeep Port was commissioned. A close confidant of Pandit Nehru, Biju enjoyed free access to Teen Murti Bhawan, the P.M's official residence. Nehru had entrusted him with the additional responsibilities of advising him on defense matters during the Chinese aggression and Patnaik was allotted an office near P.M's office in North Block. Pandit Nehru had asked him to visit the United States as an Advisory to the Ministry of External Affairs and discuss sensitive defense issues with the U.S. administration. During his stay in Washington. Biju gave interviews to 'Baltimore

that he had come to seek both ground to ground and air to air missiles along

with radars, which could conceivably be tied to a network of the South East Asian Treaty Organisation (SEATO). US newspapers also portrayed the Orissa Chief Minister as the corning defense Minister as the coming defence Minister, who will replace Y.B. Chouhan. The opposition charged Biju Patnaik with 'impropriety of revealing defence secrets, including details of the strength of the Indian Army'. There was a furore in Parliament and even the Lok Sabha Speaker Sardar Hukum Singh ruled that- 'it is not proper to disclose such information which is denied here'. But the Prime Minister strongly supported Biju and declared in the Parliament that whatever has been said by him to American newspaper 'did not harm us in any way'. This controversy highlighted how close Biju was to Pt. Nehru.

The Indian National Congress has split in 1969. In May 1970 Biju Patnaik and his followers left the Congress (R) in protest against "naked bossism" and central imposition after he had been denied a ticket to Rajya Sabha by the Congress High Command; although his case was sponsored by the Provincial Congress Committee. In 1970 he resigned from Congress Party and subsequently formed a regional party Utkal Congress. In the 1971 election, no party came out with a clear majority. Biju Patnaik and the Swatantra leader R.N. Singh Deo joined hands. This came as a surprise to political observers, as Singh Deo was a bitter critic of Biju. And with the support of the Jharkhand Party, they formed a United Front. Biju successfully persuaded the 82 years Old veteran Politician Biswanath Das to become the Chief Minister, after his long spell of Political retirement.

A Biju critic says that he functioned in an arbitrary and autocratic manner "I am the party and I am the government" - he used to say "Am I not enough ?" What was his reaction when immediately after being sworn in as Chief Minister in 1990 he was asked, how long it would take for him to choose other members of the cabinet. Biju has a painful feeling that in spite of being so rich in natural resources. Orissa has remained one of the poorest and most backward states in India. The quality of its administration has steadily to the disgust of the voters. The final phase of Biju's political career was perhaps an unhappy chapter to his long, checked political career.

A long illustrious career came to an end on 17<sup>th</sup> April, 1997 when Biju Patnaik passed away at Delhi. His death one of the worst tragedies that had







most of the state governments were not opposed to the NEP irrespective of their political leanings.

"Local language is given utmost importance in the NEP. Does this government look at things in a different way? Doesn't the Bengal government wish to raise employability of its people? NEP 2020 stands for knowledgebased employability," Pradhan said.

He said that the state government is welcome to add more value to the NEP, which is a "basic document". "I hope this decision (opposition to NEP) is not prompted by political considerations," Pradhan added.

The Union minister said he has learnt that the West Bengal government has recently formed a panel to look into aspects of the NEP. "It is unfortunate if they are opposed to the spirit of the draft. There is a growing perception that the West Bengal government wants to oppose every move by the Centre," he said.

West Bengal Education Minister Bratya Basu recently said education is on the concurrent list and the TMC government will never accept imposition of the NEP as the state has its own culture and education system.

The state government has formed a 10-member committee comprising experts in various fields to get feedback about the NEP and formulate an education policy tailored to the needs and interests of students of West Bengal. A top educationist told PTI that the new policy underscores teaching all subjects, including technical ones, in the mother tongue which is impractical. After the NEP was unveiled two years back, former state education minister Partha Chatterjee had said that it is the agenda of the RSS to give importance to subjects related to Vedic philosophy and ancient Indian tradition. He had said this will encourage corporatisation of the education system and destroy the statefunded education sector from school to university levels. In a vast country like India, which has a diversified socio-economic condition, a common yardstick cannot be applied to all states, especially at the primary and secondary levels of education, Chatterjee had said. The NEP replaced the National Policy on Education framed in 1986. It is aimed at paving the way for transformational reforms in school and higher education systems to make India a global knowledge superpower. On the CBI probe ordered by the Calcutta High Court into alleged irregularities in state government aided schools, Pradhan said, "Though education is on the concurrent list, the issue you are raising is in the domain of the state. I can only say that for future citizens of the country, there should not be any irregularities in teacher recruitment....Law will take its own course." Pradhan said he has asked IIT Kharagpur authorities to turn its research and development centre at Rajarhat near here into a Start-Up Incubation Centre. "Kolkata is the natural point for economic activities in eastern India. The start-up incubation centre will help not only IITians but also other entrepreneurs to float start-ups," Pradhan said.

Okinawa Autotech on Saturday said it will voluntarily recall 3,215 units of its Praise Pro scooters to fix any issues related to the battery in the vehicle.

## Fuel sales fall in first half of April amid record rise in prices

NEW DELHI: India's fuel sales fell in the first half of April as a record rise in prices in a short 16-day period dented demand, preliminary industry data showed on Saturday. Petrol sales fell almost 10 per cent in the first half of April when compared with the same period in the preced-ing month, while diesel demand slid 15.6 per cent. Even cooking gas LPG, which had consis-tently shown growth even during the pandemic period, saw a 1.7 per cent month-on-month fall in consumption during April 1-15.

State-owned oil firms on March 22 ended a 137day hiatus in rate revision and began passing on a USD 30 per barrel increase in cost of raw material (crude oil) during that period when five states including Uttar Pradesh went to polls. Petrol and diesel prices rose by Rs 10 per litre

between March 22 and April 6 -- the highest ever increase during a 16-day period since fuel prices were deregulated two decades back.

On March 22, cooking gas prices too were hiked by Rs 50 per cylinder to Rs 949.50 -- the highest-ever rate for the subsidised fuel. Jet fuel prices too climbed to the highest-ever Rs 1,13,202.33 per kilolitre, resulting in a 20.5 per cent fall in sales month-on-month.

In the first two weeks of March, dealers as well as the public topped up their tanks in anticipation of an increase in prices that had been on hold in the run-up to the elections in states like Uttar Pradesh. While daily price revisions restarted on March 22, the increases were calibrated. The price increases moderated the consumption.

Petrol sales by state-owned fuel retailers, which control roughly 90 per cent of the market, at 1.12 million tonnes during April 1-15 were nearly 12.1 per cent higher than the same pe-riod last year and 19.6 per cent higher than the period in 2019, preliminary industry data showed.

However, the consumption was 9.7 per cent lower than the 1.24 million tonnes sales in the same period in March 2022.

Diesel, the most-used fuel in the country, saw sales jumping 7.4 per cent year-on-year to almost 3 million tonnes. This was 4.8 per cent higher than sales in March 2019, but 15.6 per cent lower than 3.53 million tonnes consumption during March 1-15.

cular. Probably, the traditional supporters of Congress have already changed their minds and find no point in wasting their precious votes

In the civic elections, the party managed to win only seven of the 108 urban local bodies (ULBs), down from 13 in the 2013-14 polls. It failed to open its account in the Bhubaneswar Municipal Corporation election, won 01 of the 42 Corporator posts in Berhampur Municipal Corporation, and 08 of the 59 posts in the Cuttack Municipal Corporation. Of the total 1,716 Councilor posts across the state, the party bagged only 134. Similarly, in panchayat polls, the Congress ended up as a poor third winning just 37 of the 853 Zilla Parishad seats. In the 2017 elections, the party had won 60 seats. The grand old party has remained out of power in the state since 2000. In the 2014 state polls, it won 16 of the 147 Assembly seats. The tally plummeted in five years as the party bagged only nine constituencies. In the 2019 Lok Sabha elections, the Congress won just one (Koraput) of the 21 parliamentary constituencies. Since 2000, the party's vote share in Odisha has nosedived from 35 per cent to below 20 per cent. In the 2019 Assembly polls, the party received 16.12 per cent votes, a drastic decline from the 25.7 percent votes it secured in 2014. In the 2019 Lok Sabha polls, the Congress got 13.81 per cent of the votes, down from 26.38 percent five years earlier. Since 2000, the Odisha Pradesh Congress Committee (OPCC) has had nine Presidents. Patnaik is among the three OPCC chiefs to have led the state unit twice in this period. He first led the party from 2011 to 2013 while his current tenure began in April 2018. Now that Niranjan is all set to relinquish the top post in the OPCC, the party has started looking for abetter alternative. Former OPCC President Sarat Patnaik, Member, Congress Working Committee Bhakta Charan Das, and INTUC Leader Ramachandra Khuntia are in race. However, Cuttack-Barabati MLA Mohammed Moquim has also expressed interest to take the reigns of the party while Jaydev Jena and Chiranjib Biswal have kept them-selves away from the race. It is believed that Mr.Jena and the Mr.Biswal believe that it needs a lot of money to run the party and manage 2024 General Elections for Lok Sabha and the State Assembly. As such, the AICC has Petrol and diesel sales had risen 18 per cent and 23.7 per cent respectively in the first half of March when most of the hoarding on price hike expectations took place. Diesel sales during March were the most in any month in the last two years and more than the total volume of diesel sold in April 2020 when the country was under a complete lockdown.

Industry sources said while there was panic buying by individual vehicle owners in the first half of March, petrol pump dealers topped up not just their storage tanks but also any mobile browser or tanker truck they had.

The dealers hoped to make a quick buck by buying fuel at a lower rate and selling at revised higher prices. As prices were raised, consumption fell. Petrol and diesel prices hit the freeze button just as electioneering in five states including Uttar Pradesh picked up in early November 2021.

The record 137-day freeze ended on March 22. Jet fuel (ATF) sales rose 9.8 per cent to 231,400 tonnes in April 1-15 but were 25.9 per cent less than pre-COVID levels of 2019. However, the sales were 1.7 per cent less than 235,400 tonnes sales in the first half of March 2022

ATF sales are expected to pick up with the complete opening up of air travel last week. India went in for a complete lockdown, stopping flights, halting rail and road movements and shutting businesses, in the last week of March 2020 to contain the spread of coronavirus.

The March 2020 period was near normal as COVID restrictions were just kicking in. The government gave free LPG cylinders during 2020 to help poor fight the fallout of the strin-gent lockdown. This helped state oil firms register growth month after month even as other transport fuels saw severe demand contraction. But in the first half of April, LPG consumption fell 0.7 per cent year-on-year to 1.02 million tonnes. This was 4 per cent lower than April 2020 and 20.5 per cent lower than 1.3 million tonnes demand in March 1-15, 2022.

Cooking gas sales moderated after a Rs 50 per cylinder hike in prices on March 22. LPG sales had risen by 17 per cent in the first half of March. But compared to the first fortnight of April 2019, the sales were up 16.5 per cent, the data showed.

The Congress now needs to high-light this weakness of the two parties to garner support from among the people. The voters across the state need to realize that Congress could be an alternative to the two symbiotic parties. This tough job can only be handled by a new leader, having face value and credibility. If the Congress leadership is really interested to bring change in Odisha, it has to find a leader, who has charisma and acceptance among the people. If required, there is nothing wrong to rope in a leader from some other party and make him/ her the OPCC President giving full authority. All the Congress leaders are neck deep in personal business affairs without having politics as their prime occupation. Former Chief Minister J B Patnaik was probably the lone politician in Congress who did not have business interest like BJD President and Chief Minister Naveen Patnaik. Only a pure political person can do the top job and not anyone else now available in Congress. Anyway, going for a change in the OPCC top post for change's sake will not solve the problems, rather than aggravate it. This is high time for Sonia Gandhi and Rahul Gandhi to think seriously about Congress in Odisha which remains out of power for more than two decades. Ace political strategist Prashant Kishor once suggested to Sonia Gandhi on this line, when he was being consulted for restructuring Congress, which could not be worked out.

The relations further deteriorated after India in August 2019 announced withdrawing special powers of Jammu and Kashmir and bifurcation of the state into two union territories.

"The government's consistent position has been that India desires normal neighbourly relations with Pakistan and is committed to addressing issues, if any, bilaterally and peacefully in an atmosphere free of terror, hostility and violence," Minister of State for External Affairs V Muraleedharan said in Parliament on April 7 while replying to a question.

"The onus is on Pakistan to create such a conducive atmosphere," he added.


