### **Coal shortage hits NALCO** Truck owner association urges to stop laying of sorry pipe lines

Bhubaneswar(KCN): With the Aluminium Major, National Aluminium Company (NALCO) facing acute shortage of coal, Odisha Government Wednesday said it would

hold a discussion with Mahanadi Coalfields Limited(MCL) to resolve the coal crisis. Steel and Mines Minister Prafulla Kumar Mallick said: "I will hold discussions with



the authorities of NALCO and also the MCL and ensure that the Aluminium Major's production is not affected due to shortage of coal." While the NALCO Bosses are tight lipped over the crisis as both the Mines and Coal Ministries are handled by one Union Minister, several workers' union of NALCO have raised concern over the coal crisis in its smelter plant at Angul. Former NALCO CMD, Tapan Kumar Chand said: "The MCL was supposed to provide 5.6 million tons of coal per annum to Nalco. However, the MCL has not been able to supply the agreed amount of coal. Shortage of coal will affect NALCO's productivity and also its profitability."



## Russia pressures Mariupol as it focuses on Ukraine's east

KYIV(KCN): Russian forces pressured a stubborn pocket of resistance in Mariupol amid renewed hopes Wednesday for an evacuation of thousands of civilians from the shattered port city that is a key battleground in Moscow's new onslaught to take control of Ukraine's eastern industrial heartland.

In addition to pounding Mariupol, Russian forces have intensified their attacks along a boomerang-shaped front hundreds of miles



long in what is known as the Donbas, home to coal mines, metal plants and factories vital to Ukraine's economy.

If successful, the offensive would give President Vladimir Putin a badly needed victory following the failed attempt by Moscow's forces to storm the capital, Kyiv, and stronger-than-expected resistance in the nearly twomonth war.

Ukrainian troops said Tuesday the Russian military dropped heavy bombs to flatten what was left of a sprawling steel plant "believed to be the last holdout of troops defending Mariupol" and hit a makeshift hospital where hundreds were staying. The reports could not be independently confirmed.

Elsewhere, Russian Defense Ministry said Wednesday its forces kept up intense attacks on Ukrainian targets, hitting 1,053 with artillery and 73 with airstrikes.

Ministry spokesman Igor Konashenkov also

said there had been missile strikes on concentrations of Ukrainian troops and vehicles in the Kherson Region in southern Ukraine. Those claims could not be independently verified.

The General Staff of Ukraine's military said in a statement

that taking control of the Azovstal steel mill and thus fully capturing Mariupol remains a top Russian priority. But it added that Moscow's forces were continuing to mount offensives across the east as its forces probe for weak points in the Ukrainian defensive lines.

A siege on Mariupol since the early days of the war has flattened much of the city on the Sea of Azov and inflicted some of the most dramatic suffering of CONTINUED ON: P-7

A small watercolor recently acquired by for sketching bustling street life in the National Galleries of Scotland could be one of the earliest known portraits of

Painted by David Allan between the mid-1780s and early 1790s, the work on paper-titled Edinburgh Milkmaid With Butter Churn-depicts a woman in a white and blue dress. She stands alone, barefoot, in the center of an Edinburgh street, resting one hand on her hip while locking eyes with the viewer.

Based on the large vessel at her feet, scholars have concluded that the portrait's subject was likely a servant or milkmaid. Clues regarding her name and other identifying details are scarce, but experts are researching the work and hope to uncover more information about it in the months to come, BBC News reports.

Biographical details about the portrait's painter are more readily available. Born in the Scottish town of Alloa in 1744, the artist relocated to Italy in 1767, remaining there for the next decade or so, according to the National Galleries (a consortium of five Scottish museums). His most famous paintings from this period depict scenes from classical antiquity, including Cleopatra Weeping Over the Ashes of Mark Antony (1771) and Hector's Farewell From Andromache (1773), reports Shanti Escalante-De Mattei for ARTNews.

workers, posed with the tools of their trade and framed against the backdrop of the contemporary city. The artist often used these generic "characters" to populate his panoramic renderings of Edinburgh's busy streets, including High Street From the Netherbow (1793).

Despite Allan's propensity for drafting generic "types" of people, curators believe that the recently acquired watercolor was based on a real model. As researchers say in the statement, the milkmaid's detailed facial features and clothing indicate that the work is "clearly a portrait of a specific person."

People of color appear frequently in European early modern fine art but are often relegated to marginal or subservient roles. Milkmaid is somewhat unique in that its subject takes center stage in the composition.

The woman pictured in Allan's watercolor could have been one of the many people of African descent who settled in Europe during the 18th century as a result of the transatlantic slave trade. Scottish scholars have been slow to reckon with their country's participation in the slave trade, wrote Alasdair Lane for NBC News last year. But many Scots made their fortunes through the capture, sale, deportation and exploitation of African people throughout the 18th and 19th centuries, notes the National Library of Scot-



Study of the Legacies of British Slavery, "[W]ealth poured into Scotland from the labor and suffering of enslaved Africans in Jamaica."

By the time that Allan painted this work in the late 18th century, many formerly enslaved people in Scotland were fighting for their legal rights in the courtsincluding Joseph Knight, who was enslaved in Jamaica but moved to Scotland, reports Martin Hannan for the National. Knight won his freedom in a landmark case against his one-time enslaver, John Wedderburn of Balindean. After two appeals, the Scottish Supreme Court ruled in favor of Knight, effectively deeming slavery illegal in the country in 1778, according to the National Records of Scotland.

The principal object of the First Information Report to set a criminal law in motion from the point of view of the investigating authorities has to obtain an information and thereafter the investigating authorities will be able to take a suitable information report does not constitute an indefensible evidence though its importance conveying the earliest investigation relating to the occurrence of an offence cannot be questioned. The statement of the First Information Report should be corroborated to its maker under Section 157 of the Indian Evidence Act or contradicting him under Section 145 of the Evidence Act. The conduct of any party, or of any agent to any party, to any suit or proceeding, in reference to such suit or proceeding, or in reference to any fact in issue therein or relevant thereto, and the conduct of any person an offence against whom is the subject of any proceeding, is relevant, if such conduct influences or is influenced by any fact in issue or relevant fact, and whether it was previous or subsequent thereto." such a form as the State Government draw the adverse inference against the may prescribe and the said book is called or known as "General Diary". It is also called "Station Diary" or the "Station House Register". The FIR contains (i) the name and address of the victim; (ii) The exact date and the time of the offence that has occurred and is being reported; (iii) Accurate facts of the offence that has occurred; (iv) Detailed particulars of the persons or person involved in the offence; (v) The location or the place of the offence so committed. The registration of a FIR provides a basis in criminal proceedings and the same be registered promptly or without any delay after the occurrence of the offence. The cognizance on the basis of the FIR is the paramount duty of the State or the investigating authorities so that the victim would get justice without any negligence.

In the case of 'Surjeet Singh @ Gurmeet Singh Versus State of Punjab (1993) Suppl. (1) SCC 208', the Hon'ble Supreme Court on the First Information Report has held that it is not an encyclopedia of the entire case and has even not a substantive piece of evidence. Its value is unquestionably for the purpose of corroborating or contradicting the maker.

(iii) If the inquiry discloses the commission of a cognizable offence, the FIR must be registered. In cases where preliminary inquiry ends in closing the complaint, a copy of the entry of such closure must be supplied to the first informant forthwith and not later than one week. It must disclose reasons in brief for closing the complaint and not proceeding further.

- (iv) The police officer cannot avoid his duty of registering offence if cognizable offence is disclosed. Action must be taken against erring officers who do not register the FIR if information received by him discloses a cognizable offence.
- The scope of preliminary inquiry  $(\mathbf{v})$ is not to verify the veracity or otherwise of the information received but only to ascertain whether the information reveals any cognizable offence.
- (vi) As to what type and in which cases preliminary inquiry is to be conducted will depend on the facts and circumstances of each case. The category of cases in which preliminary inquiry may be made are as under:
  - Matrimonial disputes/ family disputes
  - Commercial offences
  - Medical negligence cases

"5. The High Court has dealt with the case of Madhusudan Singh in para 23 of the judgment. "In view of the aforesaid discussion, we hold:

- (i) Registration of FIR is mandatory under Section 154 of the Code, if information discloses the commission of a cognizable offence and no preliminary inquiry is permissible in such a situation.
- (ii) If the information received does not disclose a cognizable offence but indicates the necessity for an inquiry, a preliminary inquiry may be conducted only to ascertain whether cognizable offence is disclosed or not.

- Corruption cases
- Cases where there is abnormal delay/laches in initiating criminal prosecution, for example, over 3 months delay in reporting the matter without satisfactorily explaining the reasons for delay. The aforesaid are only illustrations and not exhaustive of all conditions which may warrant preliminary inquiry.
- While ensuring and protecting the vii) rights of the accused and the complainant, a preliminary inquiry should be made time bound and in any case it should not exceed 7 days. The fact of such delay and the causes of it must be reflected in the General Diary entry.
- viii) Since the General Diary/Station Diary/Daily Diary is the record of all information received in a police station, we direct that all information relating to cognizable offences, whether resulting in registration of FIR or leading to an inquiry, must be mandatorily and meticulously reflected in the said Diary and the decision to conduct a preliminary inquiry must also be reflected, as mentioned above.

## 'Tulsi-bhai': WHO chief Dr Tedros Ghebreyesus 'I was demeaned, berated by ex-wife Amber Heard', testifies Johnny Depp

FAIRFAX: Actor Johnny Depp scoffed at the notion during court testimony on Wednesday that his constant quarrels with ex-wife Amber Heard would ever prompt him to hit her. "Violence isn't necessary," he said from the stand during his libel lawsuit against Heard.

"Why would you hit someone to make them agree with you? Heard has accused Depp of physically and sexually assaulting her on multiple occasions before and during their brief marriage. Depp sued after Heard made an indirect reference to those accusations in a 2018 op-ed piece she wrote for The Washington Post. Depp began to address Heard's accusations in detail on Wednesday.

Heard has said the first time she was assaulted was when Depp slapped her in 2013 after she made fun of a tattoo he had - one that used to say "Winona Forever" when he was dating the actress Winona Ryder that he altered to "Wino Forever" after they broke up.

"It didn't happen. Why would I take such great

an opiate to which he admits he was addicted at the time - and locked himself in the plane bathroom and fell asleep to avoid her badgering. He took great lengths to explain the difference between falling asleep on opiates and blacking out on alcohol, and insisted throughout his testimony that he was never addicted to booze.

Most of his Depp's Day 1 testimony in Fairfax County Circuit Court focused on his descriptions of a difficult childhood, his rise to fame as an actor after an aborted music career and his early relationship with Heard after meeting her on the 2011 film "The Rum Diary".

The two married in 2015 and she filed for divorce a year later. Taking the stand for a second day, Depp said things began to change in his marriage when he felt that he "was suddenly just

Later, he addressed an alleged assault on a private plane flight in 2014 from Boston to Los Angeles when he was filming the movie "Black Mass". Heard has said Depp became blackout intoxicated and assaulted her on the plane ride. Depp testified he took two roxycodone pills -

wrong about everything" in Heard's eyes. Depp said that Heard made little digs at him to demean him. "The insults escalated into fullfledged circular arguments from which there was no way in or out. It was sort of a rapid fire, sort of endless parade of insults. Ms. Heard was unable to be wrong. It just didn't happen. She couldn't be wrong," Depp said.

He said that he was constantly being told about how wrong he was about various aspects of his life, including his 30-year acting career. "I was sort of not allowed to be right. Not allowed to have a voice," he said. Violence would often ensue, sometimes with a slap or a shove from Heard or his wife throwing a television remote control or a glass of wine in his face, Depp said. "There were times when I would just go and lock myself in the bathroom or a place where she couldn't get to. Why did I stay? I stayed I suppose because my father stayed (with my mother) - I didn't want to fail. I wanted to try to make it work. I thought maybe I could help her. I thought maybe I could bring her around," Depp said. Depp said that he used drugs and drank alcohol as a way to cope with Heard's abuse and said she was also a heavy drinker. He added: "I had to have something to distance me and distance my heart from those verbal attacks. I had to have something to be able to maintain me." Depp said he at one point stopped drinking to try to save the relationship. But Depp said Heard refused to abstain, even when he asked her to help him in his sobriety. Depp sued Heard after she wrote a 2018 op-ed piece in The Washington Post in which she referred to herself as a "public figure representing domestic abuse". She never mentioned Depp by name, but Depp and his lawyers said it was a clear reference to accusations Heard made in 2016 when the couple divorced and she sought a restraining order against him. Depp said the accusations and the article contributed to an unfairly ruined reputation that made him a Hollywood pariah and cost him his role in the lucrative "Pirates of the Caribbean" movie franchise. Heard's lawyers say the article is accurate and does not defame him. They say Depp's ruined reputation is the result of his own bad behavior, including drug and alcohol abuse. On the stand Tuesday, Depp called the accusations of drug addiction "grossly embellished", though he acknowledged trying every drug known to man and that he started abusing medication at age 11 when he snuck his mother's "nerve pills". His testimony Tuesday featured long, stream-of-consciousness responses to his lawyer's questions, often wandering well beyond what he was asked.

The AIMIM chief also sought to know how could a procession be taken out in Jahangirpuri on Hanuman Jayanti without getting permission from the police.

Bulldozers tore down several concrete and temporary structures close to a

mosque in Jahangirpuri as part of an anti-encroachment drive by the BJP-ruled civic body, days after the northwest Delhi neighbourhood was rocked by communal violence. The Supreme Court

As per the official data, about 69.24 lakh tonnes of wheat has been purchased by the government agencies till April 17 of the ongoing 2022-23 rabi marketing season (RMS) as against 102 lakh tonnes in the yearago period. The rabi marketing season runs from April to March but the bulk of procurement ends by June. State-owned Food Corporation of Inminimum support price to meet the requirement under the Public Distribution System (PDS) and other welfare schemes.

The Centre has set a target to procure record 444 lakh tonnes of wheat in the 2022-23 marketing year as against an all-time high 433.44 lakh tonnes in the previous marketing year. The official sources attributed the fall in wheat procurement so far to increased buying activities by private players, especially in Haryana Madhya and Pradesh.

Downing Street has stressed that the UK would not look to "lecture" India over its neutral stance in the United Nations or its decision to hike Russian oil imports.

"This visit is not framed on the Russia-Ukraine crisis. Obviously, that is really important but this is a visit we have planned for a very long time. India is an incredibly important partner," Johnson's official spokesperson, who is accompanying him to India, told reporters at Downing Street.

"The Prime Minister has been wanting to make this trip to build our partnership across trade, investment, security and defence, and green energy. We will be discussing all those issues and it is expected that Russia-Ukraine will be on the agenda. But we won't be seeking to sort of lecture India or try and persuade them into one position or another. We will be seeking to work together constructively as an important international partner," the spokesperson said. Asked if the issue is likely to dominate the closed-door discussions between the two Prime Ministers, the spokesperson asserted that it would be one of many topics.

"Obviously, Russia-Ukraine is a huge priority for the UK at the moment and for the world. It's a global issue that has destablised the economy, the oil markets and international security. So, it would absolutely be on the agenda," the spokesperson said. Downing Street has reiterated the position that "different countries are in a different position" when it comes to energy security and that the UK accepts that dynamic in relation to levels of Russian oil imports, whether it is in Europe or in India. Meanwhile, with the third round of free trade agreement (FTA) negotiations scheduled in Delhi for next week, Johnson's first visit to India as Prime Minister is also expected to push forward trade talks towards an end of the year agreement timeline. "Both countries have set out an intention to reach an agreement by the end of this year. It's not a fixed deadline, we won't rush it. We would take as long as it takes to reach a good deal for both countries," his spokesperson said. Thursday, the first day of the visit, will be focused on trade and investment and commercial matters in Ahmedabad, involving a visit to a university and a new business as well as some cultural sightseeing. In New Delhi on Friday, the UK Prime Minister is scheduled for a ceremonial day of greetings and meetings with Modi and business leaders.

Deputy Prime Minister Iryna Vereshchuk said that there was a "preliminary" agreement to open a humanitarian corridor for women, children and the elderly to leave Mariupol and head west to the Ukraine-controlled city of Zaporizhzhia on Wednesday afternoon.

Mariupol Mayor Vadym Boychenko urged locals to leave the city, though previous such agreements have fallen apart, with Russians preventing buses meant to pick up evacuees from entering the city or shelling escape routes.

"Do not be frightened and evacuate to Zaporizhzhia, where you can receive all the help you need - food, medicine, essentials, and the main thing is that you will be in safety," he wrote in a statement issued by the city council.

The recent state wide driver's strike has also adversely affected coal supply to the company, Nirmal Chandra Satpathy, a worker union leader at NALCO's smelter plant in Angul, said adding that the existing coal stock will be consumed in only five/ six days.

As per an agreement between the NALCO and the MCL valid from April 2018 to March, 2023, the later would supply 47.16 lakh Metric Ton(MT) linkage coal and 9 lakh MT of bridge linkage coal to former per annum. However, MCL could supply only 39 lakh MT linkage coal and 3 lakh MT bridge linkage coal in 2021-22, which is less by 14 lakh MT from the agrred volume.

Inadequate supply of coal to NALCO has forced the aluminium major to purchase 200 Mega Watt of power from the State Grid every day between July, 2021 to March, 2022. Of the 19 units of NALCO's Captive Power Plant (CPP), eight become functional and generating about 920 MW to 915 MW of power. If the coal supply is not made regular, the more units of CPPs will be closed, the worker union leaders apprehand.

A few thousand Ukrainian troops, by the Russians' estimate, remained holed up in the steel plant. The deputy commander of the Azov regiment, who was among the troops remaining in Mariupol, said the Russian military dropped heavy bombs on the steel plant and hit an "improvised" hospital.

Serhiy Taruta, the former governor of the Donetsk region and a Mariupol native, also reported the bombing of the hospital, where he said 300 people, including wounded troops and civilians with children, were sheltered. Both sides have described stepped-up assaults along a broad front in the east that began Monday as a new phase of the war.

Ukrainian President Volodymyr Zelenskyy said the Russian military was throwing everything it has into the battle, with most of its combat-ready forces now concentrated in Ukraine and just across the border in Russia. "They have driven almost everyone and everything that is capable of fighting us against Ukraine," he said in his nightly video address

lations like Health Care providers, educational institutions, residential hostels etc. pointed out Dr.Mishra.

"There should be in-house strengthening of testing, surveillance and treatment mechanisms to face any upsurge of cases and to integrate it into a comprehensive health care system," he added.

All non-Covid health care services are to be fully operationalised. Adequate IEC, community sensitization and information sharing system should be in place to prevent mis-information and panic, he further told the Collectors.

Wearing a face cover is compulsory in public places, in work places and during transport. Individuals must maintain an adequate distance in public places, workplaces and avoid overcrowding, the Director said in his letter. Dr.Mishra further advised that spitting in public places should be discouraged. Provision of hand wash or sanitizer should be made mandatory at work places. Proper ventilation to be ensured, particularly in closed spaces, he added.

Many previous evacuation efforts relied on civilians using private cars after efforts to bring buses from Ukraine-held territory into the city failed.

But with fuel supplies and the number of such vehicles dwindling in the city, that is becoming increasingly difficult. There was no immediate confirmation on the evacuation from the Russian side, which issued a new ultimatum to the Ukrainian defenders to surrender Wednesday.

The Ukrainians have ignored previous demands to leave the sprawling steel plant's warren of tunnels and bunkers. The Russian Defense Ministry said those who surrender will be allowed to live and given medical treatment.

Capturing Mariupol holds strategic and symbolic value for both sides.

The scale of suffering there has made it a focal point of the war for many outside Ukraine, and Russia's difficulty in definitively taking it is a prime example of the ways an undergunned Ukrainian force has stymied Moscow's troops. Mariupol's fall would also deprive Ukraine of a vital port, complete a land bridge between Russia and the Crimean Peninsula that Moscow seized from Ukraine in 2014 and would also free up Russian troops to move elsewhere in the Donbas.

Despite claims that they are hitting only military sites, the Russians continue to target residential areas and kill civilians, he said.

"The Russian army in this war is writing itself into world history forever as the most barbaric and inhuman army in the world," Zelenskyy said. He also said the Kremlin has not responded to a proposal to exchange Viktor Medvedchuk, the jailed leader of a pro-Russia party, for the Mariupol defenders.

Weeks ago, after the abortive Russian push to take Kyiv, the Kremlin declared that its main goal was the capture of the mostly Russianspeaking Donbas, where Moscow-backed separatists have been fighting Ukrainian forces for eight years.

Military experts said the Russians' goal is to encircle Ukrainian troops from the north, south and east.

Moscow has poured thousands more troops into Ukraine's south and east in recent days, including foreign fighters, according to Western officials. Eyewitness accounts and reports from officials have given a broad picture of the extent of the Russian advance.

But independent reporting in the parts of the Donbas held by Russian forces and separatists is severely limited, making it difficult to know what is happening in many places on the ground. Western nations, meanwhile, are boosting their donations of military supplies to Kyiv.

US President Joe Biden is expected to announce a new weapons package in the coming days that will include additional artillery and ammunition, according to a US official, who was not authorized to comment publicly and spoke on the condition of anonymity. Canada and the Netherlands also planned to send more heavy weapons, their prime ministers said.

As he is closing in on his 35th birthday, Pollard knows that he would need to maximise his earnings by playing leagues all over the world and in the post COVID world, it is very difficult for a family man to hop from one bio-bubble to another with additional burden of international cricket making the job doubly difficult.
