NEW DELHI(KCN): India's deal with the Philippines to supply the BrahMos missile is a bilateral transaction and it will not be impacted by the sanctions against Russia, Indian

Ambassador to Manila Shambhu Kumaran has said. The Philippines also sought a clarification from India on the BrahMos missile following last month's incident of the accidental firing of an Indian missile that landed in Pakistan, the envoy suggested.

BrahMos Aerospace, an India-Russian joint venture, produces supersonic cruise missiles that can be launched from submarines, ships, aircraft, or land platforms.

In January, India sealed a USD 375 million deal with the Philippines for supplying three batteries of the BrahMos cruise missile.

When asked about the possible impact of the Western sanctions on Russia on India's deal with the Philippines to supply BrahMos missiles, Kumaran said at an online event on Tuesday that it is a bilateral transaction between Manila and New Delhi.

### Car rams Russian Embassy gate in Romania, driver dead

BUCHAREST(KCN: A car crashed into the gate of the Russian Embassy in the Romanian capital early Wednesday, bursting into flames and killing the driver, police said.

The sedan rammed into the gate at about 6 am Wednesday but did not enter the Bucharest embassy compound. Video of the aftermath showed the car engulfed in flames as security personnel ran through the area.

According to police, firefighters who arrived at the scene were able to put the fire out but the driver died at the scene. There was no immediate information on a possible motive or other details.

In a statement after the incident, the Russian embassy expressed condolences to the family of the driver. "We must state with regret that whatever the motives of the driver," the statement read.

"There is no doubt that he committed this act under the influence of an explosion of anti-Russian hysteria in connection with a staged provocation in the city of Bucha." The embassy said no employees were injured.

Romania, which shares a long land border with Ukraine, has taken in more than 600,000 r gees since Russia invaded its neighbour.

Since the war started Feb.24, protesters have gathered outside Russia's embassy in the capital to call an end to the Russian aggression. On Tuesday, Romania ordered 10 diplomats from the embassy CONTINUED ON: P-7

### Such bipartisanship augurs well for India at world stage: PM Narendra Modi on Ukraine discussion in Lok Sabha

### Srimandir kitchen vandalism: Suspect detained

PURI(KCN): Puri Police nabbed a youth suspected to be involved in the vandalism of earthen stoves in the kitchen of Srimandir, SP K Vishal Singh said on Tuesday night. In a tweet, the Puri SP said the youth was appre-

hended by IICs of Baseli Sahi and Town police basing on CCTV footage inside Srimandir. The detained youth was identified as Jagan Mahapatra of Deuli village in Khurda district. Police nabbed him from his village. Earlier, a police team comprising five senior officers was formed to

nab the miscreant involved in vandalising at least 43 chulhas (earthen stoves) used for cooking Mahaprasad in the kitchen of Shri Jagannath temple on Saturday night.

After the youth was spotted in the footage of CCTV camera, his photo was shared with all police stations. Police also questioned four personnel of Jagannath temple police (JTP) who had driven the youth out of the shrine complex on Saturday night.

The JTP personnel revealed that they found the youth inside the temple compound and evicted him at around 1.15 am. The CCTV footage had shown the JTP personnel escorting the youth out of the temple through Simhadwar. It is believed that the kitchen was vandalised before 1 am and the temple security guards were unaware of it.

As per tradition, after Badasimhar ritual and



closing of the sanctum sanctorum, JTP personnel search the temple complex to clear all humans from the shrine premises. If any devotee is found sleeping in the compound, they are escorted out. This exercise is called 'Sodha'. The Shree Jagannath Temple Administration (SJTA), which is conducting an internal inquiry into the incident, has asked the four JTP personnel to explain the cause of dereliction of duty, within three days.

On the day, Puri Collector Samarth Verma and Singh visited the police control room at Simhadwar. Verma said security in and around the temple has been tightened.



## India's Art History United in a Single Source



The history of art in India, going back 10,000 years to the Bhimbetka cave drawings, has long been told through a Western lens or written by Indian scholars in a dense, academic style that felt inaccessible to many.

But that will soon change, when the MAP Academy Encyclopedia of Indian Art arrives online on April 21. With over 2,000 initial entries, peer-reviewed by some of the world's leading art historians and experts on South Asia, it is a project whose scope has not been tried before.

"If there is an encyclopedia of Indian art in Antarctica I don't know about it, but it's definitely not in India," said Abhishek Poddar, along with images, and will cover every-

thing from paintings, photography, textiles and craft up through contemporary art from the ago, said he had two main goals: providing last decade.

The encyclopedia is broad in scope, in terms of both its content and those it hopes to reach. That audience includes not only collectors, both new and seasoned, but also academics, curators, students and anyone with a passing interest in learning about art from the region.

"This encyclopedia really is pivotal," said Ayesha Bulchandani, a New York-based collector of Indian art who is both on MAP's advisory committee and a trustee of the Frick Collection. "The digital presence of this encyclopedia really connects global

cultures. It will inform libraries, curatorial staff, educational staff and the membership community because it just opens up dialogue across platforms."

In many ways, the story of the encyclopedia

For now, the encyclopedia will be in English, but ultimately it will be in regional languages as well. The project will also focus on translating historical texts from local languages into English for a wider audience to appreciate. cialized academics who write books that most people cannot understand," Mr. Gaskell said in a video call. In-

dian art history, he added, was "not just kings and rulers but also local artisans" and those who worked in community art.


To write the encyclopedia, the academy hired over two dozen early career Indian academics and art historians to research and write the entries, which are then reviewed by international experts.

"The MAP team had been using some of my books for reference and asked me if I could check their textile entries for accuracy," Rosemary Crill, a former senior curator at the Victoria and Albert Museum in London, wrote in an email. "In a confusing world of Wikipedia and other random bits of information, this could become the first point of inquiry for people wanting to know more about specific aspects of Indian art and culture."

Geopolitical boundaries have, of course, shifted over the centuries, so the encyclopedia embraces not only the art history of India but also that of the entire subcontinent.

The articles are specifically written in a straightforward and easy-to-understand style, something that has been lacking, said Anirudh V. Kanisetti, an editor of the encyclopedia and author of "Lords of the Deccan: Southern India From the Chalukyas to the Cholas."

"I'm convinced that South Asia needs more



Ms. Klein added that the encyclopedia, which hopes to add about 1,500 entries a year, could become a critical resource for young collectors who want to learn more about how art developed across the subcontinent. "The art market is very strong for South Asia and it is only getting bigger," she said. "When people are spending \$500,000 and above, one is also thinking, 'OK, what am I spending this on? I need to have a little more understanding of what I am getting involved with."

Ms. Bulchandani agreed, saying that the encyclopedia will add to the "connoisseurship and scholarship" not only among more seasoned collectors but also for newer ones who have a different take on collecting.

"I was talking about this project with younger collectors," she said. "They don't go to libraries. They aren't buying books. They are not collecting stuff the way our generation did. Everything for them is digital." This encyclopedia, she said, "is a groundbreaker."

The Encyclopedia of Indian Art, arriving online next month, aims to be comprehensive and yet accessible to experts and students of all kinds.



an effect on boys,' said study author Dan Romer and research director of the Annenberg Public Centre Policy (APPC) from the University of Pennsylvania in the US. The reanalysis found that the increase in the suicide rate for boys observed in the original study by Jeffrey Bridge and colleagues for three months after the series' release was no longer evident after controlling for the

ongoing trend in ado-

lescent suicide.

In addition, the increase seen during the first month of the release began the month prior to the release, making it difficult to attribute the rise to the show. The reanalysis found no effects in the subsequent months of that year.

The original time-series analysis of suicide rates found an additional 195 suicide deaths among boys ages 10 to 17 during the nine months following the series' release, on March 31, 2017, but did not find a similar result among adolescent girls.

Romer said he questioned that finding for two reasons: "First, contagion would be expected to be stronger for girls than boys because this show focuses on the suicide of a high school girl. Second, the prior analysis didn't take into account strong secular trends in suicide, especially in boys from 2016-2017."

When the first season of the Netflix show appeared in 2017, it created widespread concern that its graphic portrayal of a teenage girl's suicide

would lead to imitation among vulnerable young people, especially adolescent girls.

The first such study found evidence of a jump in suicides among boys ages 10 to 17 in the three months following the show's release, but no effect for girls.

Romer said that analysis relied on a forecasting method to project the likely trend in suicide for 2017. But that forecast failed to anticipate the actual trend. A second study by different researchers, published in JAMA

Psychiatry had a similar problem, Romer said.

That study found an effect in boys and girls 10 to 19 years old in the three months following the series' release.

But it similarly failed to control for the secular trend in suicide, again making it difficult to separate the effects of the show from the trend. APPC's reanalysis did find a modest rise in the suicide rate among adolescent girls during the first month following the release of "13 Reasons Why," but it was not statistically reliable, the researchers

Hon'ble Shri Narendra Modi Prime Minister of India The Hon'ble Chief Ministers of Kerala and Tamil Nadu And Hon'ble Members of Parliament and political leaders

Hon'ble Sir,

**Sub:** The risk of the failure of the Mullaperiyar dam and the total wiping out of the Districts of Cochin, Alleppey, Kottayam and the loss of lives of not less than 60lakhs of common citizens of this country is real and imminent, and the on-going litigation in the Supreme Court where I appear for the common citizens is all certain to be a futile exercise.

- 1. I address this letter inviting your excellency's immediate personal attention because there could be few issues which deserve your attention than the instant one, which I am afraid to say has received none.
- The Mullaperiyar dam which is made of limestone and surkhi was commissioned in the year 1895. It was meant to last for 50 years. However, today, it remains not yet decommissioned, even after 127 years of its construction, posing the risk of its imminent failure. I consciously used the word imminent because a dam which is made of limestone and surkhi at a time when dam technology was at its infancy, certainly cannot be considered to be safe. Mullaperiyar falls under seismic zone-III and, therefore, is not immune from earthquakes. The Mullaperiyar dam even finds its place in the list of endangered dams prepared by international bodies such as the United Nations University.
- Anywhere else in the world if the safety of a dam is under doubt, which certainly is the case with Mullaperiyar, a new dam would be constructed and the old dam would be decommissioned. However, in the case of the Mullaperiyar, even that is not required, because as suggested by our 'Metro man', E Sreedharan, at minimal cost a tunnel could be dug at the level of 50ft from the floor of the dam to draw water from the Mullaperiyar dam to the Vaigai basin in Tamil Nadu. In other words, to avoid the risk involved with storing huge quantity of water at the Periyar reservoir at 2800 ft from sea level, by constructing a tunnel at the bottom of the dam, the water could be stored at the reservoir at 100 ft from seal level. There is no difficulty to augment the storage capacity of the Vaigai dam. This is the simplest and most inexpensive solution, and there is no rationale or reason to oppose the same.
- 4. As aforesaid, the other alternative is to construct a new dam downstream, in Kerala, which may cost maybe 1500 crores which the Government of Kerala is more than willing to spend. However, Tamil Nadu outrightly rejected the same as recorded by the Supreme Court.
- 5. In short, Tamil Nadu is neither willing to construct a tunnel which will help them to draw more volume of water from the Periyar reservoir and store it at the base in the Vaigai dam, utilize it for agriculture or if at all needed, allow the water into flow into the Vaigai river, nor to allow Kerala to construct a new dam to prevent the catastrophe in case the Mullaperiyar fails.
- 6. Two things are infinite, said Albert Einstein, the stupidity of humans and the infinity of the universe. And the latter, Einstein said he is not sure of. It appears that the sole basis of the stubbornness of Tamil Nadu is the judgment of a 5-judge constitution bench of the Supreme Court in State of Tamil Nadu v. State of Kerala, 2014.
- 7. In the said case the principal issue framed was whether the structural safety which the Kerala Government raised could even be allowed to be raised, it being barred by the principle of res judicata. Res judicata is a fundamental principle of law evolved by Roman lawyers, particularly, Ulpian, who lived in the 1st century AD. The core of the principle is that to avoid multiplicity of litigation and ensure finality of judicial decisions, even erroneous decisions are to be given full effect. For instance, a

- Court of final appeal, in a case between A and B holds that 1+1=0, that decision is to be treated as truth, though ex facie erroneous. Applying this principle, if a Court finds an innocent man guilty of murder and orders him to be hanged, he will be hanged.
- Res judicata is a principle of public policy for the larger public good and also to avoid the evil consequence of parties being able to re-agitate an issue which was finally adjudicated. This principle is primarily applicable to 'actions in personam' and to 'real actions' with certain exceptions. It can have no application in a situation as the instant one involving the lives of millions of people. For the doctrine of res judicata to be applied, one ought to be party to the legal proceedings. The millions of common citizens in Kerala who may perish if the dam were to collapse were not parties to the Mullaperiyar case. Further, for the doctrine to apply, the cause of action ought to be the same. The safety and vulnerability of dam is a continuing cause of action. Therefore, res judicata can have no application.
- A 3-judge bench of the Supreme Court in 2006 in the Mullaperiyar Environment Protection Forum case, based on the report of a Committee formed by the Court came to the conclusion that the dam was structurally safe and allowed the water level to be raised to 142 ft from 136 ft, which was what Kerala is willing to permit. The Court arrived at the said finding primarily based on three factors. Namely, (a) that the Idukki dam despite the "copious rain" is not filled to its full capacity, that against 70.500 TMC it was only filled to the extend of 57.365 TMC, (b) that the recent earthquakes that the reservoir area had experienced had caused no damage to the dam, and that (c) in the event of the Mullaperiyar dam giving away, the flood waters will flow to the Idukki reservoir and that it has the capacity to contain the extra inflow.
- 10. It is shocking that the 3-judge bench of the Supreme Court came to the conclusion that the Mullaperiyar dam is safe and that in the worst scenario of the dam bursting, the flood waters will flow downstream into the Idukki reservoir and that the Idukki reservoir has the ability to contain the flood waters without any study ever having been conducted as to the what direction the flood waters would flow. The Mullaperiyar dam is situated at 840 meters from sea level. It flows downstream towards and the west and takes a turn towards the north-west after a distance of 2.8 kms because of a small hill which is at an elevation of 842 meters. Just two meters above the natural ground level (NGL). However, in the event of the collapse of the dam huge volumes of water wiping out everything in its path will be forced to gush down at great speed towards the west, because there are huge mountains on the north and the south sides. For water which is gushing down in such quantity and with such immense force, the two-meter elevation will be of no consequence. In its westward flow from a height of 789 meters it will with unthinkable force fall to a depth of 160 meters from sea level. That would mean a waterfall from the ridge of the western ghats with a height of 629 meters, i.e., 2064 ft. To compare, 57 meters, i.e., 188 ft is the height of the Niagara Waterfalls.
- 11. The Supreme Court in 2006 held that in the event of the dam breaking the flood waters will flow to the downstream Idukki reservoir located downstream at a distance of 25 km. How insensitive and casual the Court has been is obvious from the fact that it is not bothered in the least about the ten thousand people living on the banks of river Periyar who will be washed away in the event of the dam giving away. Our political executive maybe corrupt and inefficient. But they can be criticised and made to see reason. Our courts on the other hand consider any form of dissent as contempt. They speak of freedom of speech and expression on one side and use the law of contempt, which belongs to the

- dark ages and which has fallen out of practice in most countries except India and Pakistan, to suppress any dissent, nay, much needed constructive criticism.
- 12. The constitution bench of 5-judges in 2014 on a total misconception of the doctrine of res judicata held that the judgment of the Court of 2006 "operates as res judicata in respect of the issue of safety of the dam" and, therefore, it is not open for Kerala to question the safety of the dam any longer. It pronounced a judgment that the dam is safe because a 3-judge bench held so in 2006 and held that it cannot be re-agitated. It held "... and the structural safety of the Mullaperiyar have been finally decided by the judgment of this Court dated 27.2.2006 and Kerala is estopped from raising or re-agitating these issues in the present suit." The meaning of res judicata is not what the learned judges have understood it to be. Even between the same parties, a difference in the cause of action will give a distinct right for action. Res judicata can apply only if the parties in previous case and the present are the same and the cause of action is the same, and the cause of action has been fully adjudicated on merits. The Governments cannot be said to represent the individual citizens whose lives are at risk. Further, res judicata is in the realm of procedure or evidence, a matter of public policy, for the welfare of the people at large. There is no estoppel (res judicata) against fundamental rights. There is no res judicata or estoppel against statute. Yet, the Supreme Court, erroneously, declared unconstitutional, the amendment that Kerala brought to the Water Conservation Act on the ground that it is hit by res judi-
- 13. There is a fundamental difference between the decision of a Court and an Act of Parliament. The decision of a Court binds only and only the parties before it and not the public large, because it is against the principles of natural justice to bind one to a decision where he is not a party. On the contrary, a law enacted by the Parliament binds every citizen, because it is presumed to have received the consent of the citizens because all citizens are present in the Parliament through their representatives. Unfortunately, in India, the supremacy of the Parliament has been undermined by judicial decisions which hold that the ultimate power is vested in the Court.
- 14. The instant is a classic example of the Courts erring so unthinkably on issues of life and death, influenced by hyper technical considerations which the political executive, who is responsible to the electorate cannot remain a mute spectator. The Court cannot be entirely blamed for committing errors like the instant one. We had a period of weak political executive due to coalition governments. With the executive becoming weak, certain powerful lobbies in Delhi began to increasingly govern the country through so-called "PILS". Matters of governance of great import were allowed to be brought to court and decided by the Courts. The Mullaperiyar is a tragic example of the said trend. The only difference is that the Mullaperiyar dam case is an issue concerning life and death in its most literal sense. It is only providence that the dam did not collapse during the unprecedented floods of 2018. It should have been an eye-opener for the Governments and the Courts that the issue is not about res judicata, which does not apply here at all! The issue is what is the fallout in the event of the dam break-
- 15. As I have indicated above, if the dam breaks, which is a certainty, only the date is unpredictable, it can happen at any moment, today or tomorrow, what is its consequence? The Mullaperiyar dam is around one-third of the Idukki dam in terms of storage capacity, and thus is not a very small dam. In the event of its collapse, the waters will flow towards the west and fall from the mountain ridge to the valleys from a height of more than half a kilometer. The impact will be unimaginable.

- 16. Shri Roy George, who was an engineer of the KSEB has conducted an extensive study of the likely flow of the water in the event of the breaking of the dam. The Governmental agencies are yet to conduct any study. The study which is conducted indicates that the water from the Perivar Reservoir will flow downstream towards the west and will fall to the valleys from a point near to Manjumalla to Korithodu in Kottayam District, wiping out everything in its path. Kanjirapally, Mundakayam, Erumelli, Pala, Thiruvalla, Alapuzha, all will be washed away. Due to the topography, the flood waters will inundate the entire districts of Ernakulam, Kottayam and Alleppey. Not less than 60 lakh people of this country will perish. A copy of the findings of the study conducted by Shri Roy George is enclosed.
- 17. Inspite of the unthinkable catastrophe that awaits, no serious concern is paid by the Governments and the Court. So far as the Courts are concerned it is all about the finality of its judgments and the duty to obey the judgments of larger benches. The need of the hour is to reduce and maintain the water level at 120 ft instead of the 142 ft which is permitted today, no matter what the economic costs to Tamil Nadu. Because nothing is more precious than the lives of the people. The Supreme Court took up the issue in 2018 and ordered the constitution of committees by central and state governments, separately, under the Disaster Management Act. The common man has absolutely no faith in these "Committees", especially committees lead by retired judges of the Supreme Court, for the very simple reason that they are not experts in these highly technical issues. For the people of Kerala their opinion is of little solace.
- 18. The immediate reason why I am addressing your Excellency is that instead of realizing that emergent measures are needed and that in the event of the dam collapsing, no committee, no number of hearings, no measure under the Disaster Management Act can work, the Court is now considering entrusting the functions of the authorities under the Dam Safety Act, 2021, to the Supervisory Committee constituted in terms of the 2006 judgment till the National Dam Safety Authority under the 2021 Act is established. This is no solution. Even the 5-judge bench of the Supreme Court refused to re-open the issue of the safety of the Dam on the ground that the 2006 judgment is res judicata on that aspect. For that reason alone, the 5judge bench rejected Kerala's plea to limit the water level to 136 ft, so too, Kerala's offer to construct a new dam at its expense.
- 19. What I apprehend is a scenario which is extremely horrific. The entire population of the districts of Ernakulam (cochin), Kottayam and Alleppey, being wiped out, me and my family included. Inspite of the gravity of the situation, there is hardly any seriousness or sense of urgency. The solutions are simple. Bring down the water level to less that 120 ft as an emergency measure. And as a long-term solution, either construct a new dam which the Kerala government had offered to do, which for reasons unfathomable, Tamil Nadu refused. Or simpler still, to construct a tunnel at 50 ft or so, from the bottom of the dam to draw water to keep the Periyar reservoir level below 120 ft at all times, which will substantially lower the risk of a dam collapse. All that is to be done is augment the capacity of the Vaigai dam at the base.
- 20. Sir, as the Prime Minister of the country your good-self possess enormous power and influence. If your good self could convene a meeting of the Chief Ministers of Kerala and Tamil Nadu that can bring a solution to this controversy, and the long-drawn nightmare of the people of Kerala can be put to rest, effortlessly.

## Black boxes from China Eastern crash sent to US for analysis



BEIJING: Both black boxes from a passenger plane crash in southern China last month that killed 132 people are being analyzed by US experts at a government lab in Washington, DC.

The National Transportation Safety Board said Tuesday it is helping its Chinese counterparts download information from the flight data recorder.

American agency said last week it was doing the same for the cockpit voice recorder. Both may have been damaged by the impact of the crash.

If the information on them can be recovered, it could shed light on why the China Eastern Boeing 737-800 went into a sudden nosedive slammed into the ground in a mountainous area on March 21.

The crash left a 20metre-(65-foot)- mountainside, shattered the plane and set off a fire in the surrounding forest.

More than 49,000 pieces of plane debris were found. It took two days to find the cockpit voice recorder and six days for the flight data recorder, which was buried 1.5 meters (5 feet) underground.

US accident investigators arrived in China last weekend to assist the investigation by the Civil Aviation Administradeep crater in a tion of China. The NTSB team is taking part because the plane was manufactured in the United States.

Chinese officials have said a preliminary investigation report would be completed within 30 days of the crash.

Flight MU5735 with 123 passengers and nine crew members was headed from the city of Kunming in southwestern China to Guangzhou, a provincial capital and export manufacturing hub near Hong Kong in the southeast.

nancial obligations. The European Commission's proposed ban on coal imports would be the first EU sanctions tarditional sanctions, including on oil imports. She didn't mention natural gas, with consensus among the 27 EU countries on targeting the fuel used to generate electricity and heat homes difficult to secure amid opposition from gasdependent members like Germany, the bloc's largest

economy. But European Council President Charles Michel said the bloc should keep up the pressure on the Kremlin, suggesting that an embargo on gas imports should also be required at some point in the future.

"I appreciate the strengthening of the 5th EU sanctions package: bans on Russian coal, vessels accessing EU ports, and road transport operators," Ukraine Foreign Minister Dmytro Kuleba wrote on Twit-

"But it will take a gas/ oil embargo and de-SWIFTing of all Russian banks to stop Putin. Difficult times require difficult decisions." Western allies have already cut out several Russian banks of the SWIFT financial messaging system, which daily moves countless billions of dollars around more than 11,000 banks and other financial institutions around the world

### Amnesty International India chief Aakar Patel stopped from flying abroad over FCRA case

NEW DELHI: Amnesty International India chief Aakar Patel was on Wednesday stopped from leaving the country at the Bengaluru international airport in the wake of a CBI look out circular (LOC) issued on December 31 last year in an FCRA case, after which he moved a special court in Delhi challenging it.

The court has sought a response from the CBI by Thursday when it will again hear the plea by Patel who claimed that the action was taken despite an order by a Gujarat court permitting him to travel to the US.

According to agency sources, the LOC was issued on the basis of a charge sheet filed by the CBI in a special CBI court in Delhi on December 31, 2021 for the alleged violation of the Foreign Contribution (Regulation) Act,

Earlier in the day, Patel said that when he went to the Kempegowda International Airport, Bengaluru on Wednesday morning to catch a flight to Boston, Immigration officials stopped him citing a lookout circular by the CBI.

He claimed that he was not aware why the circular had been issued against him and said that he wanted to fly to the US to deliver lectures in three universities.

CBI sources said the look out circular was issued against him on the basis of its charge sheet with a request to port authorities to "prevent him from leaving the country".

The charge sheet was filed by the agency in the special CBI court at Rouse Avenue against Patel and Amnesty International under Section 11 read with Sections 35 and 39 of the Act after a two-year probe into alleged violations, they said.

"I don't know why I am on the lookout circular. I did not know about it that I could not fly. I missed my flight and now I am back home. They (Immigration officials) did not let me go," Patel told PTI.

He said that there was a case filed against him by a BJP MLA in Surat for which his passport had been impounded.

"The court released my passport. I got my visa. I went to the airport. I was stopped at Immigration. I was told that I am on a lookout circular, that's the word that was used, from the CBI for the case that they had filed against the Amnesty in which I have neither been arrested nor I am on bail," the Amnesty International India chief said.

The CBI had raided the human rights watchdog's offices in Bengaluru and New Delhi in November 2019.

In 2018, the Enforcement Directorate had raided the Amnesty International India office in connection with a foreign exchange contravention case.

Back then, the organisation had alleged harassment and had claimed that it stands in full compliance with Indian and international law. "Last time they (CBI) had called me was 14 months ago and I went there," Patel added. Patel later approached a special court after which Chief Metropolitan Magistrate Pawan Kumar issued notice to the probe agency and sought its reply by Thursday when the court will hear the matter further.

He has sought the court's permission to visit the USA to take up his foreign assignment and lecture series organised by various universities till May 30.

The case was registered against Amnesty International India Pvt Ltd (AIIPL), Indians For Amnesty International Trust (IAIT), Amnesty



International India Foundation Trust (AIIFT), Amnesty International South Asia Foundation (AISAF) and others in November 2019.

It was alleged that the provision of the FCRA and IPC were contravened by the aforesaid entities by receiving foreign contributions from Amnesty International UK through AIIPL even though prior registration or permissions were denied to AIIFT and other trusts under FCRA, the officials said.

According to a complaint filed by the Home Ministry to the CBI, AIIPL is a 'for-profit' company.

It was observed that London-based Amnesty International worked through four companies, which have been named by the CBI in the case. It is alleged that a payment of Rs 10 crore, classified as Foreign Direct Investment, was remitted to Amnesty India from the London office without taking the home ministry's approval.

Another Rs 26 crore has been remitted to Amnesty India, "primarily from the UK based entities".

"All such receipts have subsequently been expended on Amnesty's NGO activities in India, in violation of FCRA".

It alleged that Amnesty made several attempts to obtain prior permission or registration under FCRA, failing which, it used "commercial methods to evade FCRA".

It further alleged that Amnesty India received funds for purposes like 'service contract', 'advance income' and FDI through the automatic

Out of the Rs 36 crore received, Rs 10 crore were remitted as FDI, Rs 26 crore as payment for consultancy services, it claimed.

The UK-based Amnesty International invested Rs 10 crore to AIIPL on September 24, 2015. The amount was classified as 'compulsory convertible debenture' but was shown in Income Tax returns as "long-term borrowing". While forwarding the complaint, the home ministry had directed the CBI to rope in Income Tax and Enforcement Directorate in case violations of relevant acts were found during the investigation.

### Berhampur: Record haul of illegal wildlife items, one held

BERHAMPUR: In a major haul, sleuths of Berhampur forest division seized record quantity of illegal wildlife items including two leopard hides and the skin of a spotted deer from a



house in Titigaon village under Surangi panchayat of Patrapur block here on Tuesday. On a tip off, a raid was conducted at the house of one Balaram Sahu (32) in Titigaon village under Samantiapalli range. During search, two leopard hides, skin of a spotted deer, two deer antlers, 38 porcupine quills, seven wild boar teeth, a pangolin scale, five leopard teeth, a leopard claw, hoof of mouse deer, leopard bone and tissue were recovered from the house, assistant conservator of forest (ACF) Ashok Kumar Behera said. Besides, a tractor-laden with timber planks of different sizes was also seized. Balaram had stored the wildlife items since some time and was searching for a buyer. The raid was carried out by Samantiapalli forester Rajat Kumar Mishra and his team along with Patrapur tehsildar Amit Kumar Nayak. Divisional forest officer (DFO) of Berhampur Amlan Nayak said it is one the largest single seizure of wildlife items in the last one decade in the division. Balaram was arrested and produced in court after interrogation. Search is underway at his house. The DFO confirmed that most of the seized wildlife items are old but one of hides is fresh. "We will appeal in the court to take Balaram on remand for further investigation," Nayak added. On the other hand, Balaram pleaded innocence and said the items seized from his house were collected from the forest during a period of five years. Sources in the Forest department said investigation is underway to ascertain if Balaram is part of any organised wildlife smuggling racket. Poaching of leopards, a Schedule I animal under the Wildlife Protection Act, 1972, has increased in the State. At least 60 leopard hides have been seized by the enforcement wings of police and Forest department in the last two years.

## SEBI comes out with new guidelines for KYC Registration Agencies

NEW DELHI: Capital markets regulator Sebi on Wednesday issued fresh guidelines for KYC Registration Agencies

(KRAs) whereby such agencies will have to independently validate KYC records of all clients from July 1.

The move comes after Sebi, in January, notified new norms to make KRAs responsible for carrying out independent validation of the KYC records uploaded onto their system by Registered Intermediaries (RIs).

Under the notified rules, such agencies will have to maintain an audit trail of the upload/modification/ download with respect to KYC records of clients.

In a circular, Sebi said KRAs will indepenvalidate dently records of those clients (existing as well as new) whose KYC has been completed using Aadhaar as an Officially Valid Document (OVD). The records of those number.

"The validation of all KYC records (new and existing) shall commence from July 1, 2022," the Securities and Exchange Board of India (Sebi) said.

According to the regulator, clients whose KYC records are not found to be valid by KRA after the validation process will be allowed to transact in securities market only after their KYC is validated.

The regulator has put in place the additional guidelines on KRAs in order to implement the regulations effectively.

KRAs will continue to act as repository of KYC data in the securities market and will be responsible for storing, safeguarding and retrieving the KYC documents.

The systems of RIs and the KRAs will be integrated to facilitate seamless movement of KYC documents. KRAs will promptly inform the respective RIs of deficiency/inadequacy in client's KYC documents, if any, that is observed

identifier will be assigned by KRA to the client.

Such a KRA identifier may be used by the client for opening of account with any other intermediary, without repeating the KYC process.

The KYC records of new clients, who have used Aadhaar as an officially valid document, will be validated within two days of receipt of KYC records by KRAs.

The records of all existing clients will be validated within a period of 180 days from July 1.

KRA will have to intimate about the KRA identifier to the client within two working days of receipt of KYC records.

This has to be done by post or e-mail, and the KRA concerned will have to maintain the proof of dispatch.

### RBI's Monetary Policy Committee starts discussions on next bi-monthly policy

MUMBAI: The Reserve Bank of India's rate-setting panel on Wednesday started discussions to firm up the next bi-monthly monetary policy amid expectations that it might retain status quo on interest rate but change its monetary policy stance amid rising inflation on account of geo-political developments. The Monetary Policy Committee (MPC), headed by RBI Governor Shaktikanta Das is holding its first meeting in

Committee (MPC), headed by RBI Governor Shaktikanta Das, is holding its first meeting in the current financial year.

The meeting will be on from April 6 to 8 and the outcome will be announced on April 8. In the last 10 meetings, the MPC left interest rate unchanged and also maintained an accommodative monetary policy stance. The repo rate or the short-term lending rate was last cut on May 22, 2020. Since then, the rate remains at a historic low of 4 per cent. In a report this week, State Bank of India (SBI) said the central bank may increase its inflation projections for fiscal 2022-23 considerably and also lower growth projections. It expects the RBI to continue with a pause on short-term lending rate (repo).

"Prolonged growth supportive stance may have created a signal extraction and coordination problem with administered rates being cut even as inflation has continued to tread up," SBI said in the report. According to the report, real rates have been negative for a persistent period and "the RBI may like to create a discordant note by emphasising inflation as a threat but at the same time emphasising it is fully seized of it!" Industry body PHD Chamber's President Pradeep Multani on Wednesday said the economy is still in the recovery process from the daunting impact caused by the coronavirus pandemic and that an accommodative policy stance at this that an accommodative policy stance at this juncture would be inevitable to strengthen the economic fundamentals.
"The recent geopolitical developments though

stoke inflation, status quo of the policy rates will help the economy to cope up the impact of external shocks," he said.

The ongoing Russia-Ukraine conflict and surg-

ing oil prices are pushing the cost of commodities higher, resulting in rising inflationary trends. The government has mandated the central bank to keep inflation at 4 per cent, with an upper and lower tolerance level of 2 per cent.

After the February MPC meeting, the RBI had decided to hold its key lending rates steady at record low levels for the 10th straight meeting to support a durable recovery of the economy.




