## 30 Congress leaders resign, raising questions on party's revival in Odisha


BHUBANESWAR(KCN): As many as 30 Congress leaders including some former state office-bearers resigned from the party on Tuesday dealing a blow to the party's attempts for organisational revival in the State. Announcing the decision, the leaders

Pradesh Congress Committee (OPCC) Sarat Pattanayak, the dissidents alleged that it seems he has joined hands with the ruling BJD. The new president is only busy organising programmes as directed by the All India Congress Committee (AICC) without

taking any initiative for the revival of the organisation Odisha, they also said.

The mass resignation of so many leaders is seen as a reaction against the appointment of Pattanayak as the OPCC president ignoring the claims of other contenders. Sources say that the resignations have the

blessings of top leaders of the party though nobody came to the fore on Tuesday. Those who resigned include former MP Radhakant Digal and ex-MLA Rabindra Kumar Behera. The OPCC president, however, said the resignations will have no impact on the party. The resignations have a BJD hand to it, Pattanayak said, adding the ruling party has resorted to such a tactic as Congress has changed its approach in the State. Meanwhile, the party led by Pattanayak took out a rally from Janata Maidan in the city as part of the Azadi Ki Gaurav Yatra celebrated by the party across the country.



BHUBANESWAR(KCN): A day after Union Home Minister Amit Shah claimed that the BJP will come to power in Odisha in 2024, both the ruling BJD and Opposition Congress dismissed it as a day dream. The claim to form the next government in Odisha is simply an act of day dreaming by the BJD, former minister Sudam

Marndi told media persons here.

"They will never be able to come to power in the State as long as Chief Minister Naveen Patnaik remains our leader," he said. Dismissing BJP's 'Mission 120' as unachievable, Marndi said the saffron party had also claimed that it would win at least 120 of the 147 seats in the Odisha Assembly in 2019 elections. "Everybody knows what was the outcome," he said.

For over a half-decade after 1751, the Marathas controlled the region. The region was ceded to the British Empire in 1803. The British partitioned the area into sections of vari-

ous provinces. Odisha was established in 1936 as a province based on the population of Odia-speaking people.

Pattachitra is a traditional painting based on Hindu mythology that is one of Odisha's oldest and most popular art forms. Raghurajpur village in Puri is wellknown for its artists, and it's fascinating to note that practically every family has at least one member participating in the art form.

Palm Leaf Painting, also known as Talapatra Chitra in Odisha, is an old style of art. This is regarded as one of the sacred art forms in the state.

Odisha is also known for its sand sculptures. Sand Art is clearly one of the worldfamous artworks that can be found in Puri, Odisha. In fact, the state conducts an International Sand Art Festival every year. The appliqué work is a frequent thing in every dwelling, street, and shop in Pipli, a tiny village located near Puri. In the hamlet itself, visitors may watch the process of creating umbrellas and canopies, as well as see the finished products. Artists weave small mirrors on the applique motifs to make it more eye-catching!

Dokra is a very old style of craft that originated approximately 4500 years ago. It is structed entirely of black stone and is adorned with exquisite decorations that are unique to the state!

Most of Odisha's arts have received international acclaim, and Papier Mache is one of them. The art involves the use of



discarded cloth, natural fibers, and papers and is practiced in practically every region of the state.

Ikat, also known as Bandha, is a textile art form in which patterns are formed by dyeing cotton or silk before weaving the fabric. Though it is available in a variety of locations, Sambalpur is a popular destination for this type of art. While Ikat works may be found all over India, single ikat, double ikat, and a combination ikat of both warp and weft threads are very popular in Odisha.

#### **Architecture of Odisha**

Culture of Odisha is characterized by a plethora of temples and monuments. These temples are proof of the region's beautiful architecture. The first monuments were constructed in the third century B.C. The lion capital of an Ashokan pillar, now in the State Museum, and the fragment of an Ashokan pillar, converted into a Shiva



Lingam and ensconced in Bhaskaresvara temple in Bhubaneswar, tell eloquently of Odisha's previous splendor. The second phase of Odisha art is represented by the rock-cut caves of Khandagiri and Udaygiri, as well as inscriptions documenting Kharavela's brief but eventful rule in the first century B.C. The Naga and Yaksha images discovered in Bhubaneswar are from the post-Kharavela period. During the seventh to thirteenth centuries A.D., Odisha was at the pinnacle of her creative grandeur, the Temple Architecture in Odisha. The temples of Orissa have a distinct design that has evolved through time to include a more complicated plan, highly ornamental plastic figurines, and higher sikharas. (To be continued)



Arjun (Nithiin) and Anu (Keerthy Suresh) are childhood buddies and neighbours, who endure a love-hate relationship. He's a student with poor academic records, she's studious, thoughtful and attention-seeking. They grow up together for 20-odd years and for Arjun, Anu is one annoying friend everyone has in their life and is also someone his parents (Naresh VK & Kausalya) love more than him. Arjun bears the brunt of his father for Anu's achievements and he steadily develops a strong dislike for her. He wants to stay away from Anu so that his father stops comparing him to her. Anu, on the other hand, assumes Arjun shows real affection for her and falls for him. What happens next? The first hour of the film draws its strength from

the sheer charm of its lead pair. Director Venky Atluri has succeeded in maintaining a light and breezy tone throughout and generates laughter out of most natural situations. Even the routine slang jokes are presented with a dash of freshness and in

doesn't translate effectively on screen. The director couldn't build enough tension as we watch how Arjun-Anu's friendship turns sour. He occasionally struggles to haul up a coolness that the script doesn't possess. The real problems surface when Venky arms up the melodrama and resorts to using tired cliches to milk the emotional conflict between the lead characters. For example, Anu's mother (Rohini Molleti) encourages Arjun and his wrongdoings but doesn't support her daughter's goal to study abroad. The humour dries up and the narrative goes off the rails about ten minutes into the second hour. The sub-plot involving Vineeth and Abhirami too lacks real depth and it stretches the narrative needlessly. The climax scene in which Arjun makes the confession to Anu fails to pack an emotional wallop. Yet you are willing to overlook all these loopholes because all the characters have their own insecurities, which make them endearing and relatable. 

While the government had put on offer spectrum in 10 bands, it got no bids for high-priced airwaves in 600 MHz, 800 MHz and 2300 MHz bands.

At the end of the auc-

tion, the mop-up from the 5G spectrum is estimated to be almost double of the Rs 77,815 crores worth 4G airwaves sold last year, and triple of the Rs 50,968.37 crores garnered from the 3G auction in 2010. "About two-thirds of the bids were offered for the 5G bands (3300 Mhz and 26 GHz), while more than a quarter of the demand came in the 700 Mhz band -- a band that had gone unsold in the previous two auctions (2016 and 2021)," the sources added. trum action kicked off last Tuesday with bidding over Rs 1.45 lakh crore on Day 1. Allahabad, Varanasi, Gorakhpur, Kanpur -- saw bidding activity pick up once again for 1800 MHz, a band primarily used by telcos for 4G services. UP East -which has over 10 crore mobile subscribers -- accounted for all the incremental spectrum sales on Sunday, amid a pitched battle for radio waves among players such as Reliance Jio and Bharti Airtel.

As of May this year, Reliance Jio had 3.29 mobile subscribers in UP East, Bharti Airtel (3.7 crore) and Vodafone Idea (2.02 crore). "The bidding intensity for 1800 MHz band in Uttar Pradesh East circle had peaked between Wednesday and Friday, then subsided somewhat Saturday. On Sunday, however, renewed interest was seen and demand flared once again outstripping the spectrum supply," the sources said.

## Cognizant's acquisitions to strengthen digital offerings

HYDERABAD: Cognizant, one of the world's leading professional services companies, is looking at acquisitions in the next six months as it seeks to expand its presence in digital technologies.

"We will continue to look for opportunities on the M&A front. We bought several companies last year. This year too we expect to have some movement on this front," Rajesh Nambiar, executive vicepresident, chairman and managing director of Cognizant India, told Deccan Chronicle on Thursday, after announcing the company's second quarter results. It has forecast a 100 basis point growth in revenue through the inorganic contribution.

In 2021, the company had spent \$970 million on acquisitions, while the year before it had used \$1.12 billion to fund its inorganic growth strategy.

According to Nambiar, the company would be looking at further strengthening it's digital portfolio through the acquisitions. "Going forward, all our service offerings could have a digital element," he said, laying emphasis on the company's digital strategy. During the April-June quarter, the company reported a seven per cent growth in revenue at \$4.91 billion compared to \$4.58 billion in the yearago period. This year for the second consecutive guarter 50 per cent of Cognizant's revenue have come from their digital business.

Despite unprecedented labour market conditions in the technology space, Cognizant has reported a healthy growth of 30 basis points in operating margin. "In a period of unprecedented labour market conditions characterised by elevated attrition and significant wage inflation, we focused on our client commitments and delivered balanced financial results in the second quarter," said Brian Humphries, Chief Executive Officer. "As we position the company for sustained success, we will continue to invest in our talented employees, our clients and our capabilities," he said. At the end of the April-June quarter, the company had 3,41,000 employees on its rolls. During this period, the company had seen a 31 per cent voluntary attrition, caused mainly due to an industry-wide talent shortage seen since the Covid pandemic. Nambiar said the company has been taking several initiatives to stabilise attrition. As part of this, the company had promoted 33,000 employees and is planning to hire 50,000 freshers through campus recruitment.

## Telangana 2nd in Niti's innovation index

Hyderabad: A day after cracking the list of best states for start-up ecosystems, Telangana on Thursday ranked second among 'major states' in the NITI Aayog's India Innovation Index 2021 and also ranked first in the 'performers' category.

Telangana was preceded by Karnataka and followed by Haryana in the innovators under the 'major states' category, which comprised 17 states, with other categories including 10 north-east and hill states, and nine Union territories and city-states.

said. NITI Aayog member V.K. Saraswat said that innovation is the key to sustainable and inclusive growth. "It can help us solve the biggest challenges of our times, bringing millions out of poverty, generating livelihood opportunities, and paving the way

for an Aatmanirbhar Bharat," he said.

The first and second editions of the India Innovation Index were released in October 2019 and January 2021.

An official statement

said that the third edition strengthens the scope of innovation analysis in the country by drawing on the framework of the Global Innovation Index (GII). The new framework presents a more nuanced and comprehensive outlook for measuring innovation performance in India, with the introduction of 66 unique indicators, as compared to the 36 indicators used in the previous edition (India Innovation Index 2020), it added.

## Four-time Grand Slam champion Naomi Osaka Bhavani Devi wins gold, defends Comexits match at Toronto Open with back injury

TORONTO: Naomi Osaka's recent struggles continued Tuesday with an early exit at the National Bank Open.

The four-time Grand Slam champion retired from her first-round match with a back injury. She was trailing 7-6 (4), 3-0 against Silicon Valley Classic. That was her first tournament since the French Open as she recovered from an Achilles injury. Prior to that run, she had her best tournament of the year making it to the final of the Miami Open in early April before losing to top-ranked Iga Swiatek.

Tomljanovic of Russia, Amanda Anisimova of the United States, and Zhang Shuai of China also advanced.

Osaka struggled with unforced errors and had four of her five double faults in the first set. She won the first game with the help of three unforced errors from past the baseline. Kanepi built on that momentum in the second set, taking advantage of Osaka's mishaps and firing sharp forehands past the Japanese star.

After hitting her second ace of the match earlier in the final game, Kanepi closed out with



Estonia's Kaia Kanepi when she withdrew from the contest.

"I felt my back from the start of the match, and despite trying to push through it, I just wasn't able to today," Osaka said. "I'd like to pay credit to Kaia for playing well and want to wish her all the best for the rest of the tourna-

Entering the tournament, Osaka had been eliminated from her last three competitions in the first or second round, including a straight-sets loss to Coco Gauff at last week's Mubadala Tormo of Spain, Ajla her set point on a shot in the second round.

31st-ranked The Kanepi will next play No. 8 Garbine

Muguruza of Spain. In other matches, 10th seeded Gauff beat fellow American Madison Brenglem 6-1, 6-3; China's Zheng Qinwen got past Canada's Rebecca Marino, 3-6, 7-6 (5), 6-4; Italy's Camila Giorgi defeated ninth-seeded Emma Raducanu of England, 7-6 (0), 6-2; and Bianca Andreescu of Canada beat Daria Kasatkina of Russia, 7-6 (5), 6-4. Elise Mertens of Belgium, Sara Sorribes Kanepi, but the fourtime Grand Slam champion lost her momentum after going up 2-1.

Kanepi won four of the next seven games to go up 5-3. From there, Osaka had to fight her way out of two set-point opportunities from Kanepi. With a mix of a strong backhand and multiple errors from Kanepi, Osaka was able to tie it up and send the set to a tiebreaker. With the tiebreaker tied 3-3, Kanepi turned up her level of play taking four of the next five points as Osaka handed a strong serve that Osaka returned high and wide.

Andreescu won this event in 2019 before taking the U.S. Open title in what was a breakout year for the 22-year-old. She hasn't won a tournament since, having battled through injuries and taking a "mental break" at one point in 2021. Andreescu's lone final appearance this year has been at the Bad Homburg Open where she fell to Caroline

# monwealth Fencing Championship title



LONDON: India's Bhavani Devi won the gold medal in the ongoing Commonwealth Fencing Championship here, defending the title she won last time.

The 42nd-ranked Indian fencer defeated second-seeded Australian Veronika Vasileva 15-10 in the senior women's sabre individual category final on Tuesday. Since becoming the first Indian fencer to qualify for the Olympics, the Chennai-born Bhavani has had a steady rise in her sport.

The year began with the World Cup in Istanbul where she finished 23rd after missing out on a spot in the last 32. Thereafter Bhavani's World Championship campaign in July at Cairo ended in the second round. The Commonwealth Fencing Championship is her 10th international tournament this year.

Speaking after her win, Bhavani said, "It was a

tough final and I am glad I could add another gold medal for India this year. It has been a great journey for me this year and I would like to continue this momentum for the upcoming tournaments. The support back home has been great for me throughout."

Rajeev Mehta, Secretary General of the Fencing Association of India, sees her as the torchbearer of fencing in the country. "She has been an inspiration to every fencer in India, and it is because of her that many youngsters now dream of making it big on the global fencing map."

"This gold medal only adds to our belief that fencing in India is growing and I am confident that the day is not far away when we will have Indian fencers competing at the top international tournaments regularly including the Olympics," said Bhatia.

### Qatar World Cup to start a day earlier than planned: Sources



DOHA: The opening match for this year's World Cup, between hosts Qatar and Ecuador, will be brought forward by one day to November 20, World Cup sources told AFP on Wednesday.

The move, which should be approved by the FIFA Council before the 100-day countdown starts this week, will retain the tradition of the first match featuring the host country.

Under the existing arrangement, Senegal and the Netherlands play the first game on November 21, followed by the official inauguration match between Qatar and Ecuador later that day.

The World Cup sources said that confirmation of the change was expected soon. FIFA and the Qatari organising committee declined to comment.

"There were discussions and agreement between the two respective teams and there was a request from CONMEBOL -- the South American confederation," one World Cup source told AFP, speaking on condition of anonymity as no official decision has been announced.

"We wanted to follow the tradition that either the reigning champions or the host country be in-

volved in the opening match," the source added.

For fans who have tickets for the November 21 game, "any disruption will be dealt with so impact is minimal", another tournament source told AFP.

Under the change, Netherlands v Senegal would be moved from 1:00 pm (1000 GMT) on November 21 to a 7:00 pm start. "It is a better slot for both teams for television and other areas," said the World Cup source.
