However, the Raj Bhavan has officially not confirmed the development.

Reacting to the development, AICC general secretary in-charge of Jharkhand Avinash Pande said the Congress will welcome whatever decision the Election Commission takes on the matter.

"However, it is not hidden from anyone that from the day the 'Mahagathbandhan' governtutions such as the Enforcement Directorate, the Central Bureau of Investigation and oth-

"It is trying to create obstacles in development work using the constitutional institutions," he said.

"After the decision, all alliance partners will hold discussions and devise a strategy on the way forward," Pande said.

"We want our bigger alliance partner to take all constituents (of the government) with it in a respectable manner and move towards fulfilling our promise to the people to serve them for five years. As far as the Congress legislative party is concerned, it is united,"

he said. The EC sent its opinion to Governor Bais earlier this morning on the plea seeking Soren's disqualification for violating electoral norms by extending a mining lease to himself.

The Jharkhand government consists of the Jharkhand Mukti Morcha (JMM) which has 30 MLAs in the 81-member Assembly, the Congress with 17 legislators, and the Rashtriya Janata Dal (RJD) with one.

The main opposition BJP has 26 MLAs in the House.

Though Bhubaneswar Municipal Corporation (BMC) has engaged new agencies, a majority of them are facing teething problems in commencing opera-tions, leaving daily sanitation exercises badly hurt. To carry out sanitation work effectively, the BMC which in the past operated with just three agencies - Jagruti, Ramky and PMR Consortium - roped in seven new ones this year.

Though work was supposed to be taken up by the new agencies last through the old agen-

As a result, garbage heaped up on the road has become a common sight. "The stench emanating is unbearable. The waste poses health hazards during the rainy season," rued a resident of Jayadev Vihar.

A hassled BMC hasalready been slapped show cause notice on one agency for poor performance, said a BMC official.

Sanitation work was affected in the city after Ramky allegedly did not poor preparedness of some of the agencies.BMC Commissioner Vijay Amruta Kulange said the new agencies have been asked to start their services at the earliest. The operation of two agencies has been affected due to legal hurdles, he

BMC recently came up with a fresh standard operating procedure (SOP) making it mandatory for eateries, commercial establishments as well as residential societies and in-

While enforcement at marketplaces has started, residential areas are waiting and that is where the garbages are piling up. A resident wondered why a fine is not being imposed on households dumping waste on the roadsides. Officials of the BMC sanitation wing said enforcement against waste dumping will start soon. "We have started it for commercial areas and will form squads for residential areas," said BMC deputy commissioner Suvendu Sahoo.

Learning Life Saving Simple CPR Skill, need of Hour: Dr. Ashutosh Biswas

Bhubaneswar(KCN): One in four deaths in India are due to cardiovascular diseases. Heart disease is the leading cause of death in India. In the recent past the country has witnessed many deaths due to sudden cardiac arrest outside hospital. As per studies, after heart attack cardiac arrest at home have increased from 60 to more than 90 per cent, with sedentary lifestyle during COVID. Not only car-



diac diseases, cardiac arrest can be the terminal stage of any life-threatening conditions, said experts on the occasion of launching Community CPR education in India building a Nation of Lifesavers with a collaborative effort of American Heart Association (AHA) and AIIMS Bhubaneswar.

Intervening within 2-3 minutes of cardiac arrest is crucial to maintain blood circulation to the brain and get time for availability of immediate medical facility or an ambulance. In such scenarios the role of bystanders (life saver) becomes vital to make sure the brain survives until medical services are available. Survival from cardiac arrest largely depends on how quickly CPR is started and the quality of CPR given. To answer the critical need



for community cardiopulmonary resuscitation or CPR education in India where it is estimated that 98% of the residents are not trained in CPR.

Cardiopulmonary Resuscitation (CPR) is an easy hand technique to maintain the heart function, said AIIMS Bhubaneswar Executive Director (Co-Convener AHA-AIIMS Collaborative) Dr. Ashutosh Biswas. Providing Life Saving Simple CPR training in the community can help to large extent for the above purpose. In this context, AHA & AIIMS Bhubaneswar will train more than One lakh Community Members over two years, added

Five hundred master trainers trained in this programme. Each trained volunteer will train at least 75 community members in Handsonly CPR. Through this effort more than One Lakh community members will be trained in the next two years.

Two elephants electrocuted in Odisha's Keonjhar district



KEONJHAR(KCN): In a shocking incident, two elephants were electrocuted in the OUAT campus in Keonjhar under the Keonjhar Sadar range on Thursday morning.

Both were females and had given birth to two calves less than a month back.

The two, about 25year-old, were part

of a group of nine elephants roaming in Judia of Sanaghagara forest area. For the past few days, the group has been living in this forest. On Thursday morning, a group entered the OUAT premises and came in contact with 11 kV wire which led to their death. DFO HD Dhanral and Sadar Ranger Bijay Kumar Mahant rushed to the spot.

The incident has exposed a glaring lack coordination among forest, energy and other government agencies in securing elephants' movement. Herds of elephants have been living in the region but no remedial measures were taken.

Odisha has of late grabbed headlines over a spate of elephant deaths and suppression of the incidents. Poaching too has been a cause of concern.

Electrocution deaths though are not new. The state reports one of the highest numbers of elephant electrocution in the country.



Herbal Remedies for Sun-Tan in Monsoon

Many people skip applying sunscreen during the monsoon season because they believe the dark, grey skies won't have the same damaging effect as a bright summery one.



If you're under the impression that there's no sun amid the cloudy weather, then you couldn't be more wrong. Even if you do not see sunrays in the monsoon, they affect

Simply put, as long as there is daylight enough to distinguish the time of day from night, there is sunlight. And if there is sunlight, there are sun rays.

These rays easily pass through clouds in monsoon season and hit our skin. Clouds do not prevent us from UV rays

Sunrays consist of harmful UV and infrared rays that can cause a host of skin conditions like tanning which can happen during monsoon also.

Sun tanning is one of the immediate effects of sun exposure during monsoon. What causes tanning? Exposure to the sun increases the production of melanin, which is the skin's pigment, or colouring matter. Melanin actually protects the skin from the sun's harmful ultraviolet radiation. Once melanin is produced in the the skin surface. Since it is dark in colour, the skin also becomes tanned.

Since the sun is playing hide and seek these monsoons, let's find out some easy ways on how to remove tan with these natural remedies that can be easily made at home. They will help repair the affected cells, revive sunburn skin and make it glow as well.

Using a facial scrub is useful. You can buy a facial scrub according to skin type. If the skin is dry, a scrub should be used only once a week, but for oily skins, it may be used more often. The scrub should be applied and rubbed gently on the skin with small circular movements. Then wash it off with plain water. This helps to remove dead skin cells, along with their contained pigment. The skin becomes brighter and the tan is gradually removed. You can make scrubs and packs at home with kitchen ingredients. In fact, many such ingredients can be applied on the skin to gradually remove tan and also soothe the skin, in case of sun burn.

Scrub: Ground almonds (badaam) make a good facial scrub. Soak the almonds in hot water till the skin comes out easily. Then allow them to become totally dry. Grind them into a powder, making sure to follow absolute hygiene and cleanliness. Keep this powder in an airtight jar. lower layers of the skin, it moves up to Every morning, add a little curd or cold

To remove tan: Add a pinch of turmeric (haldi) to curd and apply daily. Wash it off after 20 to 30 minutes. Or, mix one teaspoon honey with two teaspoons lemon juice and apply daily on the face, washing it off with plain water after 20 min-

Take the sandalwood powder and make it into a paste with the help of tender coconut water. Apply it to the tanned skin and wash it off with water after a while. You may replace coconut water with rose water or use the juice of cucumber in-

To remove tan on oily skin: Mix cucumber pulp with yoghurt and apply it on the face daily. Wash it off after 20 minutes. It will suit oily skin, since cucumber is an astringent.

For oily skin: Mix tomato pulp with one teaspoon honey and apply daily for 20

For sunburn: Cold milk applied daily, using cotton wool, not only helps to soothe the skin, but also keeps it soft. It also makes the skin colour lighter over a period of time, if used daily. It would suit normal to dry skins.

To soothe sunburn: Another remedy to

Should the world have voiced its religious madness sentiments louder against the stabs that

religious

fanaticism has stretched its ugly claws. Should there be a sensible effort to quell the madness that distorted spiritual theories pounce on the world with? Can there be a solution at all in this regard? I suspect the laxity with which the world deals such ruthlessness. Universal epithets to narrate freedom of speech and expression could be seen fading into insignificance. The effect of such live narratives is not probably meant for religions with exclusive mindset. The slow death of Salman Rushdie would accentuate the power centers that enjoy decreeing fatwas and essentially their belligerence would grow manifold and unquestioned. The New York stabbing on one of the most celebrated writers would leave an ugly question destined to remain unanswered forever. Why do clerics go scot-free after every fatwa and the execution that follows? A life in exile since 1989, Salman Rushdie must have known the real threat that awaited him. The Ayatollah fatwa took 33 years to spill blood, slitting the old man's wrinkled skin. Though he kept ascending to fame after every book that he wrote, the inner core of the writer must have sensed the dead man in him. Rushdie's wounds would make people sense the abnormality that is plaguing the contemporary world. His book the Satanic Verses for which he was awarded a fatwa profoundly spoke of the anomalies and hypocrisies that the world of faith sinking us in.

Another instance of brutality, loaded with

There are many examples of violent extremism to that effect and can be narrated here. But there is a question that significantly sticks out silently with remorse and reprisal. Is violence a legitimate response to religious offence? Can religions easily discard human rights in a world that stands more scientific than religious? A world mostly pluralistic in essence cannot justify disrespect of any religion. But why such instances should not be treated with civility within the framework of modern and available judicial processes? Of course the essential impact of a radical outrage by anybody cannot be narrated as the common behaviour of a particular community. The absence of a civil dialogue in a world of diverse tendencies must be seen as one reason. But the solution should not be limited to a controlled periphery but there should also be consistent cultural exchanges among diverse beliefs. What happened to Charlie Hebdo cannot be singled out. There were selective attacks on writers and news offices multiple times before. The 'Lajja' author Taslima Nasreen also had the same fate. Rushdie, one of the most celebrated writers with some of the finest writings,

has been identified as anti-Islamic. The agony of the Booker Prize winning writer with his best ever written novels Midnight's Children, Shame, The Moor's Last Sigh and The Enchantress of Florence literally evokes the quest for freedom that no religion would probably dare to slit open to wounds. The Indian born writer's misery is the price that he pays for his literary brilliance and eminence. The Rushdie experience and the exile that Taslima Nasreen was forced into pose significant challenges to all the

have lived in exile liberal democracies across the globe. The idea of freedom among cultures and the freedom of speech that the world is Islamic fundamentalism is penetrating into the social jurisdiction of societies terribly pulling the edifice of coexistence. Is there a glimmer of hope when countries like Saudi Arabia steps in for elementary changes giving more freedom to its citizens to express and expose? A religious ruling by Sheik Abdul Rahman al-Barrak calling for the execution of two writers for apostasy in Saudi was met with severe criticism. The act was termed as 'intellectual terrorism by clerics of darkness' and the criticism was documented with more than 100 human rights activists daringly putting their signatures from the region. A world bouncing in tandem with the madness of radicalism is truly thickening around. The assassination of the Egyptian writer Farag Foda in 1992 was a result of a fatwa by radical Muslim clerics and an attempt to murder the Egyptian Nobel prize-winner Naguib Mahfouz in 1994 was the effect of another fatwa. With its largest pluralistic population, India should have reacted to what the Rushdie incident has provoked. But there was a studied silence among the political leadership in the country which probably thought not to condemn the brutal violence on the India born writer. We should have stood in solidarity with the writer. Our choosing to remain passive on the crime tells us those unwritten facts of compulsion that the world's largest democracy is in. India's celebrated 'freedom of speech' seems to have become a paper tiger.

Workshop on 'Gender Sensitive Reporting and Writing' organized for scribes

Bhubaneswar(KCN): With an aim to promote equal and sensitive representation of gender in the media UNICEF Odisha organized a workshop on Gender Sensitive Reporting and Writing for journalists in Odisha today.

At the outset of this workshop, Ms. Radhika Srivastava, Communication and Advocacy Specialist, UNICEF, Odisha gave the welcome address and set up the context. Dr Monika Nielsen, Chief of Field Office, UNICEF Odisha also addressed the media and spoke of UNICEF's commitment to gender equality. Ms. Madhuri Das, Gender Specialist, UNICEF, Delhi delivered key notes on becoming more gender sensitive. Ms. Kasturi Ray, Senior News Editor, The New Indian Express moderated the entire workshop.

The workshop started with an informal discussion on what the reporters/ journalists expect from this event. According to global data presented at the workshop, only 23% content in the media related to women while less than half of stories were reported by women. Data also showed that among spokesperson's quoted, only 19% were women¹. A checklist for media was presented at the workshop, giving tips to journalists on how they can make their stories more gender sensitive, challenge social norms and ensures that voices of women are equally heard. Legislations such as The Indecent Representation of Women (Prohibition) Act, 1986 exists to prohibit indecent portrayal of women through advertisements, publications, writings, paintings etc.

The check list also includes gender sensitive methods on reporting on crime against women and emphasizes on publishing follow up stories to write on the issue even as the focus is on the crime survivor.

The participants discussed the various challenges and barriers they face within their workspace and in the external environment related to gender sensitive reporting, especially since most women do not make it to decision making positions within media organisations.

Addressing the media Dr Monika Nielsen, Chief of Field Office, UNICEF Odisha said, "Gender equality is essential to realizing the mandate of UNICEF to uphold the rights of all children. Gender norms harm both girls and boys. Harmful practices such as child marriage, exploitation, child labour are often a result of behaviours and practices stemming from gender norms. As we recover from the pandemic, it is a critical time to discuss Gender equality, shifting power relations between genders and addressing discriminatory norms and gendered barriers. Speaking on the role of media on gender, Ms. Srivastava said, "Media plays a crucial role on changing mindsets and perceptions .and a gender sensitive media can promote greater gender equality and challenge patriarchal system of our society."

She urged media houses to include sources who are women and are able to provide a woman's perspective while ensuring equal representation from women. She said it is important to explore an issue from a woman's perspective, and report on how women are impacted by it. This is especially important during disasters which Odisha so often faces, she said.

Ms. Das explained the various stages of gender equality. She said, "Gender must be considered at all levels of news production: from the editorial department where decisions are made about what stories to cover, to the field where stories are gathered, to the final publication of the story with headlines and visuals. Our goal is to create a gender equal society and in this the media can play a very constructive role. Charity begins at home. So as a media house, all need to be very mindful of the impact of gender sensitive reporting. Media houses should not do something just for the sake of sensation and high earned TRPs."

During this workshop, a group activity was also conducted among the scribes present in the house. The working journalists shared their thoughts and challenges in gender stereotype reporting and writing. The participants were felicitated with participation certificates.

Where Ukraine war stands after six months

KYIV: When Russian President Vladimir Putin invaded Ukraine on Feb. 24 in an unprovoked act of aggression, many expected a quick victory.

Six months later, the largest military conflict in Europe since World War II has turned into a grinding war of attrition. The Russian offensive has largely bogged down as Ukrainian forces increasingly target key facilities far behind the front lines, including in Russiaoccupied Crimea.

A look at where things stand:

A BOTCHED BLITZ

When Putin declared the start of the special military operation, he urged Ukraine's military to turn against the government in Kyiv, reflecting the Kremlin's belief that the population would broadly welcome the invaders. Some of the Russian troops coming in from Moscow's ally of Belarus, just 200 kilometers (about 125 miles) north of the capital, The Russians have taken control of the entire Luhansk region, one of two provinces that make up the Donbas, and also seized just over half of the second, Donetsk. Russia currently occupies about 20% of Ukraine's territory.

Putin will try to bite one piece of Ukrainian territory after another to strengthen his negotiating stand, said Mykola Sunhurovskyi, a military analyst with the Kyiv-based Razumkov Center think-tank. His message to Ukraine is: If you don't sit down for talks now, things will get worse and we will take even more of your territory and kill even more of your people. He's trying to raise not only external but also internal pressure on the Ukrainian government.

The Donbas offensive has slowed as Moscow was forced to relocate some of its troops to Russia-occupied areas in the south to fend off a potential Ukrainian counteroffensive.



reportedly brought their parade uniforms with them in preparation for a quick triumph.

Those hopes were quickly shattered by fierce Ukrainian resistance, backed by Western-supplied weapons systems to the government of President Volodymyr Zelenskyy.

Airborne troops sent to seize airfields aroundKyiv suffered heavy losses and armored convoys stretching along the main highway leading to the capital were pummeled by Ukrainian artillery and scouts.

Despite numerous attacks on Ukrainian air bases and air defense assets, the Russian air force has failed to win full control of the skies and suffered heavy losses, limiting its ability to support ground forces.

One month into the war, Moscow pulled its troops back from areas near Kyiv, Kharkiv, Chernihiv and other major cities in a tacit acknowledgment of the blitz's failure. SHIFTING BATTLEGROUNDS

The Kremlin then shifted its focus to the Donbas, Ukraine's eastern industrial heartland, where Moscow-backed separatists had been fighting government troops since 2014 following Russia's annexation of the Crimean Peninsula.

Relying on their massive edge in artillery, Russian forces inched forward in ferocious battles that devastated the region. The strategic port of Mariupol on the Sea of Azov that became a symbol of Ukrainian resistance fell in May after a nearly three-month siege that reduced the city to ruins.

More than 2,400 Mariupol defenders who holed up at the giant Azovstal steel mill later surrendered and were taken prisoner. At least 53 of them died last month in an explosion at a prison in eastern Ukraine that Moscow and Kyiv blamed on each other.

Russian troops seized the Kherson region, north of Crimea, and part of the neighboring Zaporizhzhia region early in the conflict. It has installed pro-Moscow administrations there, introduced its currency, handed out Russian passports and launched preparations for referendums to pave the way for their annexation.

But Ukrainian forces recently reclaimed some ground, striking bridges and targeting munitions depots.

Meanwhile, both sides have traded accusations of shelling the Russia-occupied Zaporizhzhia nuclear power plant, Europe's largest, raising fears of an atomic disaster.

Ukraine has forced Russia to conduct a massive redeployment of forces and spread them all along the front line, from Kharkiv to Kherson, said Ukrainian military expert Oleh Zhdanov. It's very hard to stretch them along such a big distance.

Although Kyiv doesn't have enough weapons to launch a big counteroffensive, time plays in Ukraine's favor, he said. The longer the pause lasts, the more weapons Ukraine will receive from its allies.

UKRAINIAN SUCCESSES

Western weapons, including U.S. HIMARS multiple rocket launcher s, have boosted Ukraine's military's capability, allowing it to target Russian munitions deports, bridges and other key facilities with precision and impunity.

In a major symbolic victory in April, the flagship of Russia's Black Sea Fleet, the Moskva missile cruiser, exploded and sank while on patrol after reportedly being hit by a Ukrainian missile. That dealt a heavy blow to Russia's pride and forced it to limit naval operations.

Sameer Mahendru: From CBI witness in 2013 graft case to accused in Delhi excise 'scam'

NEW DELHI: Indospirit's Managing Director Sameer Mahendru, who is being probed by the CBI for alleged bribery to influence Delhi's excise policy, was once the agency's key witness against two infrastructure and development officials convicted for graft in 2013, according to officials.

As a prosecution witness (PW-34) for the CBI, Mahendru had testified against the two officials of the Delhi State Industrial and Infrastructure Development Corporation Ltd.

(DSIIDC) who were demanding four to five expensive liquor bottles from distributors every month for granting various favours.

His testimony was one of the clinching evidences that nailed the role of the two DSIIDC officials --Sushanta Mukherjee and Amrik Singh -- and they were convicted by the special CBI court in 2013. The same CBI unit -- the Anti Corruption Bureau, New Delhi -- that probed the 2008 FIR number 15A/ 2008/CBI/ACB/ND is now investigating the bribery charge against Mahendru, and 14 other including Delhi Deputy Chief Minister Manish Sisodia.

The case registered on March 31, 2008 on sourcebased information pertained to large scale corruption by two officials of DSIIDC who were regularly seeking bribes and liquor from distributors in Delhi. Mukherjee had retired from the DSIIDC but was inducted as an Officer on Special Duty in its Indian Made Foreign Liquor unit between June 1, 2006 to December 31, 2007 with wide ranging duties from policy to procurement of liquor.

How the controversy over the Delhi Liquor Policy

Amrik Singh was the assistant manager (enforcement) and used to flaunt his cordial relations with Mukherjee and say he could get any work done through Mukherjee in the IMFL division.

Armed with telephone call intercepts, witnesses and evidence, the CBI filed a chargesheet against

Mukherjee and Singh in 2011. Two years later, the strong case presented by the

CBI resulted in their conviction. During the trial, Mahendru testified against

Mukherjee as a CBI witness and identified both the accused in the court room.

"The fact that the liquor bottles were picked up/ obtained from DSIIDC vends by the accused persons despite protest by the suppliers and that the suppliers were made to pay for the same, is borne out from the testimony of PW-34 Sameer Mahendru," Special Judge Poonam A Bamba had noted in the

She had said it is also made out that such illegal gratification was obtained by the accused persons for expediting the release of payments to them. When intercepted calls were played in the court,

Mahendru recalled the telephonic conversation with Mukherjee.

"PW-34 deposed that during the period 2007-2008, he was working as an attorney and C and F Agent for Skol Beverages Ltd. and had been supplying its brands to various outlets of DSIIDC. He knew both the accused persons and identified them in the court," the Judge had noted.

Mahendru now stands accused of making illegal payments of Rs 4-5 crore to two "close associates" of Sisodia on different occasions.

The agency has accused Mahendru as one of the businessmen who were "actively involved" in alleged irregularities in framing and implementation of the excise policy of Delhi government for the year 2021-

Her 10-year-old granddaughter Geeta, who was shifted to a high land on the river's embankment, does not realise the plight of the villagers.

The girl was heard reciting an Odia poem from her textbook when a PTI reporter visited the river bank in Baliapal block.

"The administration has not provided safety to the people. It is foolish to expect drinking water from them," said the dejected elderly

The Balasore district administration, however, said it is providing food to over 7,000 evacuated people who are lodged in 40 shelter homes.

Of the 136 marooned villages in Balasore district on Wednesday, 115 are in Baliapal

The situation is more or less similar in other affected blocks like Bhograi, Basta and Jaleswar, said Harish Behra, a local school teacher.

There is scarcity of drinking water, polythene sheets and healthcare services for the elderly and pregnant women, he said.

Women in groups are going on boats in search of a place where they can attend to nature's call.

"Now only the blessings of Indra Dev (Rain God) can save us," said Mamata Patra, sitting in a makeshift tent on an embankment in Bhogarai area.

Director of Public Health Service, Dr Niranjan Mishra, said in Bhubaneswar that as many as 900 cases of diarrhoea have been reported from 14 flood-affected districts.

The disease spreads due to the consumption of contaminated water, he said.

Odisha floods: 48 free kitchens, yet the marooned have no food

The Water Resources Department said that the flood situation has improved in the Mahanadi and Subarnarekha river system.

The peak flood water has already passed, but it may take time for the water to recede from villages in low-laying areas, the department's chief engineer B K Mishra said.

Residents of Ganjam district have sent three truckloads of essential materials such as water bottles, dry food packets, medicine kits and other items for the flood-affected people of Balasore district.

North Korea sees suspected Covid-19 cases after victory claim by Kim Jong Un

tight restrictions and quarantines until health workers determine the cause of the illness. KCNA said health authorities were giving extra attention to the cases because none of the four patients had a history of coronavirus infections.

The country's emergency anti-virus headquarters dispatched "talented epidemiological, virology and test experts to the area" and is taking steps to "trace all persons connected with the suspect cases, and persons going to and from the relevant area and keep them under strict medical observation, KCNA said.

North Korea said there have been no confirmed COVID-19 cases in any part of the country since Aug. 10 when Kim declared victory over the virus, just three months after the country acknowledged an outbreak.

Even as he ordered preventive measures eased, Kim called for vigilance and the maintaining of tight border controls to prevent the virus from reentering the country. Ryanggang province is one of the border areas where North Korean officials for years struggled to clamp down smuggling activities with China.

An official from South Korea's Unification Ministry, which handles inter-Korean affairs, said Seoul isn't ruling out the possibility that the virus could reemerge in the North.

"North Korea may additionally report on the situation, including whether the fevers were confirmed as COVID-19, and we would need to wait for that before making judgements," said the official, who spoke on condition of anonymity during a background briefing.

While Kim claimed that the country's success against the virus would be recognized as a global health miracle, experts believe the North has manipulated disclosures on its outbreak to help him maintain absolute control. The victory statement signals Kim's aim to move to other priorities, including a possible nuclear test, experts say. After admitting to an omicron outbreak of the virus in May, North Korea reported about 4.8 million 'fever cases' across its mostly unvaccinated population of 26 million but only identified a fraction of them as COVID-19.

It claimed just 74 people have died, which experts see as an abnormally small number considering the country's lack of public health

Kim's declaration of victory over COVID-19 during a national meeting in Pyongyang was followed by a combative speech from his powerful sister, who said Kim had suffered a fever himself while steering the anti-virus campaign and laid dubious blame against South Korea while vowing deadly retaliation. North Korea claims that its initial infections were caused by anti-Pyongyang propaganda leaflets and other items carried across the border by balloons launched by South Korean activists, a claim the South has described as 'ridiculous' and unscientific.

Outside experts believe it's more likely that the virus spread when the North briefly reopened its border with China to freight traffic in January and surged further following a military parade and other large-scale events in its capital, Pyongyang, in April.

There are concerns that the threats by Kim's sister portend a provocation, possibly a nuclear or missile test or even border skirmishes.

Some experts say the North may try to stir up tensions as South Korea and the United States hold their biggest combined military training in years to counter the growing North Korean nuclear threat.

The Ulchi Freedom Shield exercise, which involves aircraft, tanks and warships, continues in South Korea through Sept.1.

Diplomacy between Washington and Pyongyang to defuse the nuclear standoff has stalled since 2019 over disagreements in exchanging crippling U.S.-led sanctions against the North for the North's denuclearization steps.


She played an integral role in helping England women lift their first ever major trophy, scoring two goals during this summer's homehosted tournament.
