No need for any High Court bench in Odisha, rules Supreme Court

Bhubaneswar(KCN): The Supreme Court, while hearing the plea related to protest by lawyers demanding a permanent bench of Orissa High Court in Sambalpur, today ruled that there is no need for establishment of such bench.

"The passage of time and use of technology has made the demands obsolete. The use of technology is quite widespread now and monitored by the Orissa HC. "There is no hope for formation of a bench. Even if there was a remote possibility, it is lost now with the conduct of the agitating



lawyers," the Supreme Court said. As directed by the apex court, Odisha DGP and police officer in-charge of Sambalpur district appeared before it virtually today.

"The DGP and IG have stated that they will keep the situation under control. They would be closely watched by us," the bench said.

February 6, 2023. Notably, the Central Action Committee of All Bar Associations of Western Odisha yesterday suspended its ongoing agitation demanding establishment of Orissa High Court's permanent bench in Sambalpur.

The Bar Council of India has suspended practice license of 43 lawyers of the district bar association for 18 months who had allegedly resorted to violence during the agitation. It has also suspended all members

district functionality of the association till further orders.

Sambalpur police have so far arrested 17 agitating lawyers over their alleged involvement in vandalism on the premises of the District Court. They have been arrested under Sections 147, 341, 323, 353, 332, 506, 186, 188 and 149 of the IPC. The accused lawyers had allegedly resorted to vandalism inside the chamber of a district judge.

The number of arrests is likely to increase as police were examining CCTV footage of the court premises to identify others involved in the offence.Prohibitory order under Section 144 of CrPC has been clamped at the Kacheri Chhak, where the lawyers had staged protest, to avoid any further untoward incident.



An artist in every home: How a village in Odisha keeps local art and dance alive

Barfi pink. Bright blue. Deep ochre. Violet more lustre and eyeand saturated orange. Etches and paintings of gods and goddesses. Green parrots flying on a wall. The source of Odissi dance. Lush greenery.

Welcome to Raghurajpur in Puri district, home to over 300 artisans who have learned and still practice various traditional art forms handed down over the generations. A family of artists lives in each of

popping colour to the village.

The front room of each home serves as both studio and exhibition space. Surprisingly un-commercial, the artisans, men and women speak in Odiya, keenly showing their work and explaining the tradition, narrative and techniques they apply.

Home to performing artists



curd, casein and local herbs such as trifala and bel. To boost rural tourism they were encouraged to paint their homes to

showcase and display their art. Dance teacher and artist Guru Gangadhar Nayak spoke about his efforts to pass on Gotipua. No longer able to see well enough to do the artwork of which he was also a master, today he trains young boys to perform this local dance tradition. This is his passion. In Gotipua, young boys dress as females and also sing devotional songs while performing the dance. It is embedded in the Sakhibhav movement where devotees consider themselves cohorts of Lord Krishna. The songs that are sung to accom-

pany the dance are generally compositions

of Vaishnav poets. Artist's haven

Nayak recounts his version of how Raghurajpur evolved as an artist's haven. "A Chaitanya bhakt from Bengal came and settled here which was then a jungle," he told VillageSquare.in. "He made a representation of Jaganath. He coloured the face of the Lord from coal, which is why Jaganath is still represented with a black face. This sage was the first artist of the village. In pursuit of the Divine he experimented with limestone and then color and this was the way our village evolved and became an artist's village. The art form Chitrakala developed here."

Nayak also recounted that an American woman, Helen Jerry, was among the first people to recognise the artistry of the community. She worked to publicise their art and also bought and had much of their works Digital village

This year, Raghurajpur was adopted by the Bank of India as a digital village and 20 points of sale machines have been installed by the bank in addition to opening two hundred savings bank accounts. There is also an ATM machine and a few artisans accept PayTM.

Raghurajpur has been included in the ideal crafts village scheme and online sources state that the Center has sanctioned Rs 100 million for overall development of the village. None of the people we spoke with knew much about this development of which three crore has apparently already been released. As part of this initiative the state government is planning to design the doors of every house and strengthen water and sanitation facilities. Plans for a guesthouse are also supposedly in the works.

Artistic effervescence

Over time, the government has been called Raghurajpur a "Crafts Village", a "Heritage Village" and now a "Digital Village." The changes in nomenclature have not effected the artistic effervescence nor the pace and style of life which still seems idyllic compared with the material and physical poverty of many of our villages and the commercial, mass produced quality of so many of our traditional arts. Here, as Guru Mohapatra had once said about dance, ar not only gives purpose to one's life, but is life itself.

Spending time in Raghurajpur provides a glimpse into another world where art is the

organizing principle of the village. It structures daily life. With some intervention from arts and cultural organisation the skills of artists and artisans have been refined, a market is being developed for their work, and the artists can interact directly with the customers to maximise the proceeds from their works. As Nayak told VillageSquare.in,

"Today we show and sell our works across the world. People abroad appreciate our talents and traditions, and ready to pay to acquire our creations."

Raghurajpur is truly a national treasure. To make it part of the rural tourist map, while safeguarding its artistic integrity, demands deft and delicate maneuvering.



the 100 or so painted, yet modest households, which face one another. A series of temples dedicated to local and Hindu Gods and courtyards occupy the lane between the homes. Here, in Raghurajpur, worship and art are one – each breathes life and gives meaning to the other.

The chitrakars (painters) are the most famous and numerous among Raghurajpur artists. They paint brightly coloured mythological stories about Jaganath and other gods, especially Krishna. Derived from the Sanskrit word patta (canvas) and chitra (painting), pattachitra has its roots in the 12th century.

Painstaking workmanship

Men and young boys portray dramatic mythic themes and flamboyant processions. Historically, women painstakingly prepared the canvases. Today, men and women learn the art of designing and executing pattachitra paintings from their parents and grandparents and proudly display numerous national awards for their excellent workmanship.

This artist's village is also known for intricate palm leaf folded pictures etched in black with cutouts, delicate brushwork on tussar silk, stone and woodcarvings. The stories are ubiquitous. Colourful painted coconuts reveal stories, as do painted birds, papier-mâché toys, masks and painted boxes that are displayed on meticulously clean stone front porches. Fashioned from local materials – palm leaf, coconut, local dyes, mouse hair, stone and wood – this range of art works have a unique beauty and guileless charm. The art works bring even

Raghurajpur is also home to performing artists, most notable being the late Guru Kelu Charan Mohapatra. His father was a painter and mrudangam player. Kelu Charan trained in the Gotipua dance tradition in Raghurajpur, and became renowned as the leading proponent of Odissi dance. He is credited for reviving this ancient dance form. For Guru Mohapatra, dance was worship. Today there is a dance studio in Raghurajpur in where young students still receive training in Gotipua, an acrobatic

dance form that is a precursor to Odissi. Students from Raghurajpur participate in national dance festivals and public events.

This dense concentration of skilled artists, keeping alive several Odissi art forms, is truly unique. Not surprisingly, Raghurajpur was recognised as a Heritage Village in 2000. Since 2000, INTACH ICCI.

NORAD, India Foundation for the Arts, Benguluru and Government of India, Odisha, worked in tandem to develop Raghurajpur as a craft's village.

They trained artists to relearn traditional techniques and apply them in their art works. For example, they were retaught how to apply plaster made of lime, jute, sold abroad.

Ever since Raghurajpur was chosen as a heritage village, many more tourists, from India and abroad, have come to admire their art and purchase it directly from the artists. A few visitors come to learn traditional art techniques. On the day we visited, we were the only tourists there.

Three films with India connect chosen for 2023 Sundance Film

MUMBAI: Three films with an India connection have been selected for the 2023 edition of the Sundance Film Festival -- "Poacher", a drama directed by Richie Mehta of "Delhi Crime" fame, Reema Maya's short "Nocturnal Burger", and Shalini Adnani's "White Ant". The boost for Indian independent cinema circuit comes after Shaunak Sen's "All That Breathes" won the World Cinema Grand Jury

Prize: Documentary the 2022 Sundance.

The upcoming edition will be held from January 19 to January 29 in Park City, Utah, in the US.

It is presented by Sundance Organisation, a nonprofit that discovers and supports independent artists, and introduces audiences to their work.

According to the gala's website, Mehta's "Poacher" will have its world premiere in the Indie Episodic segment.

About 85% of flowering plants on our planet are dependent on these insect pollinators for their survival and maintaining the balance of our ecosystem. Global bee populations are showing an alarming decline due to a number factors like environmental pollution, indiscriminate use and over applications of various agro-chemicals, industrial agricultural practices detrimental to nature, changes in the land use patterns; and parasitic diseases of bees as well as lack of adequate supply of nectar and pollens for different bee species due to lack of suitable of bee foraging plants. The yield loss due to lack of suitable pollinators for cross pollination is a agriculture as well as for like Sri Lanka, Maldives, maintaining the balance our natural ecosystems.

The greatest impacts on both honey bees and native bees have been reported from highly industrialized countries. These include mainland USA and Hawaii, Canada, Australia, New Zealand, China, Japan, South Korea, Taiwan, Israel, Turkey, European Union (UK, France, noticed in developed Belgium, Switzerland,



Spain, Portugal, Italy, Poland, Greece, Netherlands, Denmark). Outside the EU, bee declines have also been reported from Russia Ukraine, Belarus the Balkan Peninsula. Bees like other insects have the habit of cleaning their antennae; and through this process they intake toxic pesticides inside their system killing them. Often these chemicals impact their nervous system impacting their precise sense of orientation causing them to land at inappropriate sites causing deaths. Cross contamination with bees having pesticides with them wth others in the hives or nest also causes an epidemic resulting in mass deaths of honey bees as well as native bees. Sustainable concrete construction is a step toward greener and more environmentally friendly concrete construction practises in order to reduce global environmental problems. Instead of traditional concrete, landscape designers and architects experts recommend using fly ash, a byproduct of thermal power plants, as a cementing material. The use of recycled materials such as crushed glass and woodchips reduces the production and consumption of cement, lowering the carbon footprint. Green building is one of the concept plays important role in reducing carbon footprint in construction industry. Green building, through its design and construction, has a positive impact on climates and the natural environment. It consumes less energy, water, and natural resources, generates less waste, and is healthier than traditional construction. Low maintenance and operational costs, energy efficiency, improved indoor environment quality, water efficiency, better health, material efficiency, a cleaner environment, and less strain on local resources are all advantages of green building construction. Green architecture can help to reduce the use of natural resources and fuels, as well as improve water and material efficiencies and air quality both inside and outside of structures. The use of geopolymer technology in construction has significantly reduced cement consumption, resulting in significant reductions in carbon pollution. Furthermore, geopolymer cements are being deployed to improve structural performance by enhancing durability and compressive strength, improving resistance to acid, and structural performance under elevated temperature curing conditions, in order to address concerns raised by the disposal of industrial materials by processing and repurposing them in geopolymer production. To improve the carbon footprint of new buildings, producers and contractors alike are now increasingly being expected to preserve natural resources while continuing to produce quality products, and are, as a result, looking for construction methods, practises, and products that will improve the sustainability of new buildings and infrastructure. Finally, the use of recycled or waste materials in the concrete industry is a viable option for achieving global sustainable development goals.

Keeping in mind the environment obligation every citizen possessing, our smart cities concept and all other ongoing construction and upcoming constructions projects should use imperatively environment friendly construction methods to play the part in reducing carbon footprint in the country.

6892 Cr PMAY funds

New Delhi: For construction of pucca houses for poor people in rural and urban areas of Odisha, the Government of India has released a total of Rs 6892.19 crore to the State during the past

three financial years. This was informed by Minister of State (MoS), Rural Development, Sadhvi Niranjan Jyoti in Lok Sabha on Tuesday.

Giving a written reply to a question asked by Congress MP from Koraput, Saptagiri Sankar Ulaka, the Union Minister said Rs 6031.07 crore has

been released to Odisha during the financial years 2019-20 to 2021-22 under Pradhan Mantri Awaas Yojana-Gramin (PMAY-G).

Similarly, a total of Rs 861.12 crore has been given to the State Government under Pradhan Mantri Awas Yojana-Urban (PMAY-U) during the last three financial years, she said. Both the Central schemes are being implemented in all 30 Districts of the State.

Under PMAY-G, the Centre has released Rs 2197.33 crore during the financial year 2019-20, which was increased to Rs 2821.87 crore in 2020-21. However, the Government of India has drastically reduced funding for Odisha to Rs 1011.87 crore under the major rural housing scheme in 2021-22.

As per the reply of the MoS, the Ministry of Rural Development has released Rs 274.60 crore, Rs 295.52 crore and Rs 291 crore to Odisha under the PMAY-U scheme during 2019-20, 2020-21 and 2021-22, respectively.

Replying to other questions asked by Odisha MPs Basant Jyoti said construction of a total of 8,53,436 houses under PMAY-G have been completed in Odisha so far.

The total expenditure made under the PMAY-G scheme including Central share and State



Government's share, during 2019-20 was Rs 5460.06 crore. The utilisation under the scheme in Odisha during 2020-21 and 2021-22 was remained at Rs 4556.46 crore and Rs 1122.72 crore, respectively.

Though only three and half months left until the end of the current financial year 2022-23, the Government of India has yet to release any funds to the State under the PMAY-G scheme till December 7. However, the State Government has utilized Rs 235.76 crore from its own resources.

Informing about the major shortcomings faced till date by the PMAY-G, the Union Minister said there is delay in construction of houses due to Covid-19 induced restrictions, delay on part of States/ UTs in releasing of Central & State Share from State Treasury to State nodal account of PMAY-G, delay in allotment of land to landless beneficiaries by the States/UTs, cases of unwillingness of beneficiaries, permanent migration, disputed succession, unavailability of building materials and at times general/

Royal Bengal tiger's skin seized from Odisha's Similipal Tiger Reserve

BHUBANESWAR: The Special Task Force (STF) of the Crime Branch seized the skin of a Royal Bengal Tiger from the fringe areas of the national park during the wee hours of Wednesday.

The tiger may have been poached in about a month's time, say experts. The claws were intact on the skin which had not completely dried.

Sources also said that Patra could possibly have been a middleman who was waiting to hand over the tiger's hide to a customer when the raid was conducted by the STF.

The STF is making efforts to arrest the poacher, too.

Meanwhile, Principal Chief Conservator of Forests (Wildlife) SK Popli said it would be premature to say the big cat was poached in Simlipal Tiger Reserve. "The matter will be jointly investigated by STF and the Forest Department," said Popli.

The recent spate of incidents including the poaching of elephants raised a question mark on protection measures in the tiger habitat.

In the 2018 tiger enumeration, STR had about 28 tigers.

This is the first time that the STF has seized a tiger hide in Odisha.

ADB retains India's growth forecast at 7 pc in FY23, 7.2 pc in FY24

CHENNAI: Asian Development Bank has retained India's growth forecast for FY23 at 7 per cent and FY24 at 7.2 per cent. Inflation in India is expected to rise to 6.7 per cent in FY23 before falling back to 5.8 per cent. Despite recent global headwinds, the Indian economy is expected to grow by 7 per cent, as projected earlier, supported by a strong domestic base. In India, the economy grew by 6.3 per cent in Q2 of FY2023, reflecting contraction in public consumption of 4.4 per cent even as

exports grew by 11.5 per cent despite the global slowdown.

Among the developing economies of Asia, lower export orders point to continued weakness going forward. Among the 11 economies for which data on new export

orders is available with ADB, 10 recorded readings below 50 in November, indicating declines from the previous month. However, India was the only exception.

Similarly, PMI readings indicated softening economic activity in most economies, while India saw it improving in November.

On the supply side, growth in FY23 was led by service sector growth at 9.3 per cent, contributing 4.6 percentage points to GDP growth. Industry, by contrast, suffered a small contraction by 0.8 per cent, ADB said in its latest estimate.

Going ahead, some recent high-frequency indicators are more favourable than expected. This includes, consumer confidence, electricity supply, and purchasing managers' indexes. However, others are a little less favourable, in particular exports, largely textiles and iron ore, and the index of industrial production of consumer goods. ADB has retained the growth forecast for FY24 at 7.2 per cent, sustained by positive effects from structural reform and from public investment catalyzing private investment.

> ADB also expects India's inflation to rise to 6.7 per cent in FY23 before falling back to 5.8 per cent, as projected earlier. For 22 of the 28 economies in developing Asia with monthly inflation data, inflation has now come

down from peaks reached earlier in the year, including in the largest economies like China, India, Indonesia and the Republic of Korea. In India, monthly inflation was 7.4 per cent in September and it has cooled down to 6.8 per cent in October. However, in contrast, the inflation projection for South Asia is increased marginally for 2022 from 8.1 per cent to 8.2 per cent and more substantially for 2023 from 7.4 per cent to 7.9 per cent. The sub-regional revision for 2023 largely reflects higher inflation forecasts for Bangladesh, Nepal, Pakistan, and Sri Lanka.



Moscow: Russia has welcomed India's decision to not support the price cap on Russian oil announced by G7 and its allies and offered it cooperation on leasing and building large-capacity ships to overcome the ban on insurance services and tanker chartering in the European Union and Britain to continue buying discounted oil.

The offer came as Russian Deputy Prime Minister Alexander Novak held a meeting with the Indian Ambassador to Moscow, Pavan Kapoor, on Friday. "The Deputy Prime Minister welcomed India's decision not to support the price cap on Russian oil, which was imposed on December 5 by the G7 countries and their allies," the Russian Foreign Ministry said in a statement. India's appetite for Russian oil has swelled ever since it started trading on discount as the West shunned it to punish Moscow for its invasion of Ukraine.

Novak noted that even amid the energy crisis, Russia is responsibly fulfilling its contractual deal in the interests of the Indian people, and that is exactly what we are trying to do," he said.

The executive body of the European Union has asked its 27 member countries to cap the price of Russian oil at USD 60 a barrel as part of the West's attempt to squeeze Moscow's oil revenues and limit its ability to wage war in Ukraine while keeping global prices and supplies steady.

From December 5, western shipping and insurance companies are prohibited from handling Russian oil sold above the price cap.

However, ships loaded with Russian oil before December 5 and unloaded at their destination before January 19, will not be subject to the price cap. A top government official said India can continue to buy Russian oil if it can send ships, cover insurance and devise a mode of payment.

?The introduction of a price cap on Russian oil is an anti-market measure. It disrupts supply chains and could significantly complicate the situation in

global energy markets,'

Novak said. 'Such non-market mechanisms disrupt the international trading system as a whole and set a dangerous precedent in the energy market. As a result, the problem of energy poverty is being aggravated not only in the developing world, but also in the developed countries of Europe,?

The two sides noted the record growth in trade between the two countries and expressed the desire to continue this interaction, increasing cooperation on trade in energy resources, such as oil, petroleum products, liquefied natural gas, coal and fertiliser.

Novak said.

In 2021, bilateral trade between Russia and India increased by 46.5 per cent, exceeding USD 13.5 billion, the Russian Foreign Ministry statement said. In January-September 2022, trade exceeded the figure for all of last year, totalling USD 20.4 billion. Over the first eight months of 2022, Russian oil exports to India grew to 16.35 million tonnes. Deliveries of oil products and coal also increased. Meanwhile, Russia has for the second month in a row remained India's top oil supplier in November, surpassing traditional sellers Iraq and Saudi Arabia, according to data from energy cargo tracker Vortexa.

Russia, which made up for just 0.2 per cent of all oil imported by India in the year to March 31, 2022, supplied 9,09,403 barrels per day (bpd) of crude oil to India in November, the Russian Foreign Ministry statement said.

It now makes up for more than a fifth of India's oil

supplies.

Novak has also invited Minister of Petroleum and Natural Gas and Housing and Urban Affairs of India Hardeep Singh Puri to take part in the international forum, Russian Energy Week 2023, which will be held from October 11-13 next year in Moscow.

VIJAYAWADA: The state Cabinet on Tuesday gave its approval to Jindal Steel for the construction of the Kadapa steel plant. The long-pending steel plant would aim at a two-million tonne output. It also got the approval for creation of necessary infrastructure to achieve a production of another 2.5 million tonnes in future.

He said JSW would invest Rs 8,880 crore for the Kadapa Steel Plant and this create employment opportunities for 6,500 persons directly or indirectly. The Kadapa steel plant is a longpending proposal for which three chief ministers had laid

Pope says spend less on Christmas, give to Ukraine



VATICAN CITY: Pope Francis on Wednesday called on people to spend less on Christmas presents celebrations, and donate the money saved to those in war-ravaged Ukraine.

"It is nice to celebrate Christmas. But let's lower the level of Christmas spending a bit," Francis said in his weekly general audience at the Vatican.

"Let's have a more humble Christmas, with more humble gifts. Let's send what we save to the Ukrainian people, who need it," he said. Nearly 10 months into the war, hardship from the fighting has

compounded winter sets in and Russia pounds Ukraine's energy infrastructure.

Missile strikes have been crippling -resulting in the periodic loss of electricity, heating, water and phone service across swathes of Ukraine. The Ukrainians "are suffering so much.

They are hungry, cold. So many people are dying because there are no doctors or nurses," the pope said.

On Tuesday, Ukraine's Western allies pledged an additional one billion euros (USD 1.1 billion) in emergency winter aid to help the country withstand Russia's onslaught.
