Tech the way for youths of

BHUBANESWAR(KCN): Till five years back, computer education was an alien concept for the people of Malkangiri's erstwhile cut-off region where even the basic amenities were a distant dream. Things have changed since Gurupriya bridge opened in 2018 which mainstreamed the cut-off region, now Swabhiman Anchal. People's access to health and social security has become easier and youths who were earlier soft targets of Maoists, are now being diverted towards education and skilling.

Taking a step forward, the district administration and Border Security

Force (BSF) have now started extending computer education to youths in the area. BSF has set up a computer skill development centre at its operating base at Jantapai in collaboration with the district admin-

istration. Twenty youths of Jantapai and nearby areas have enrolled for computer training at the centre which has five computers. Two BSF personnel

he said, adding that this is the first such collaboration between the administration and BSF.

BSF officers added that computer education will open up new avenues of education and employment for the Swabhiman Anchal youths. They will be able to fill up forms of various educational institutions, and courses and know about job offers once they become acquainted with the use of computers and the internet. "Under the guidance of the BSF, the youths will gain expertise in computer skills and they will be able to get jobs like data entry operators, typists, and others," an officer added.

> Students of schools having computer labs can also visit the centre to enhance their computer skills. Although upper primary and high schools in the Swabhiman Anchal have computer labs, the internet has remained patchy.

"We have got an overwhelming response from the youths and students of Swabhiman Anchal. Every day, training is being provided to them between 3 pm and 6 pm. As the response is very encourag-

Our govt removed all obstacles thwarting North East India's development: PM

SHILLONG(KCN): Prime Minister Narendra Modi on Sunday said that his government during its eight-year tenure has removed all obstacles that came in the way of development of the North East region. Addressing a public meeting on the occasion of the golden jubilee of the North East Council (NEC) here, he also said that improved air connectivity provided to the region has been helping export of agricultural produce, benefiting farmers. Ahead of the FIFA World Cup final in Qatar, Modi also said that the NDA "government has shown the red card to many obstacles that came in the way of development for the North East."

"Obstacles such as corruption, discrimination, violence and vote bank politics were removed," the PM said in his 26-minute speech.

"Earlier, attempts were made to divide NE. Now, we are removing these divisions," Modi said at the meeting.


He also inaugurated, dedicated and laid the foundation stone for multiple projects.

Among the projects inaugurated, one is the sprawling campus of the IIM-Shillong at the New Shillong Township.

The Prime Minister, who arrived here in the morn-

ing, earlier attended the golden jubilee celebrations of the NEC at the State Convention Centre, along with Union Home Minister Amit Shah and several other union ministers and dignitaries.

Modi, on the occasion, released 'Golden Footprints', a commemorative volume chronicling NEC's



In that closed-door meeting, Modi hailed the contribution of NEC to the development of the region. Describing the eight states of the region as 'Asht

Lakshmi' (eight forms of the goddess of wealth), he said that the government should work on eight foundation pillars for the development of NE.

The eight 'foundation pillars' are peace, power, tourism, 5G connectivity, culture, natural farming, sports and potential.

The Northeast is our gateway to South-East Asia and can become a

centre for the development of the entire region. And to realise this potential of the region, work is going on the projects like Indian-Myanmar-Thailand trilateral highway and Agartala-Akhaura rail project,"

according to an official statement.

Many peace agreements have been signed, interstate boundary agreements have been done and there has been a marked reduction in instances of extremism, he said.

In the last eight years, the number of airports in the region has jumped from nine to 16, and that of flights has increased from about 900 before 2014 to around 1900, he said adding that many NE states have come on the railway map and efforts are being done to expand the waterways also.

The length of national highways has increased by 50 per cent since 2014 in the region.

Modi also talked about the potential of the region in the hydropower and tourism sectors.

The North Eastern Council is the nodal agency for the economic and social development of the North Eastern Region which consists of the eight States of Arunachal Pradesh, Assam, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim and Tripura.

The North Eastern Council was constituted in 1971 by an Act of Parliament.

However, it was formally inaugurated on November 7, 1972.



New Delhi(KCN): Secretary, Department of School Education and Literacy, Sanjay Kumar, pointed out that India needs to catch up with other countries in terms of skilling



the workforce through formal vocational training during the student years. NEP 2020 has identified such issues and has suggested remedial measures, he added.

Shri Kumar pointed out that as per NEP, 2020 Vocational Education needs to be integrated into all schools and higher education institutions in a phased manner over the next decade. Trades and Courses shall be chosen based on skills gap analysis and mapping of local opportunities to make it demand driven. Concerted efforts from all stakeholders will be required to de-stigmatizeVocational Education and make it aspirational.

The National Credit Framework, currently under finalization by the Ministry of Skill Development and Entrepreneurship will also eliminate traditional hierarchies and silos between different areas of learning. It will help in removing complex separations between arts and sciences, between curricular and extra-curricular activities, between vocational and academic streams, etc. By providing credits for academic, extra-curricular and experiential learning, NCrF will help dropouts from the formal education system

to get reintegrated by aligning their practical experience with the appropriate Framework level. The consultations were also addressed Dhuwarakha by Sriram Chief of Generation Unlimited (YuWaah), Youth Development and Partnerships and Mr. Terry Durian, Chief

of Education, UNICEF. Various ideas related to

Orissa HC asks chief secy to look into WODC HQ plea

CUTTACK(KCN): The Orissa High Court has directed the chief secretary to treat a writ petition filed by one Haripriya Patel seeking relocation of Western Odisha Development Council (WODC)'s headquarters from Bhubaneswar to the western region of the state, as a representation. While issuing the order, the division bench of Chief Justice S Muralidhar and Justice MS Raman expected chief secretary Suresh Chandra Mahapatra to pass a reasoned order not later than March 1 after hearing on the petition/representation on a date within the next six weeks, intimating the petitioner 10 days in advance and eliciting the view of the chairperson. "The order shall be communicated to the petitioner not later than March 8, 2023," the bench specified in its order on December 13.

WODC was formed in 1998 to look after interests of the western region of the state. It comprises of 10 districts - Bargarh, Balangir, Boudh, Deogarh, Jharsuguda, Kalahandi, Nuapada, Sambalpur, Sundargarh and Athamallik sub-division of Angul district. The WODC headquarter has since been located in Bhubaneswar. The bench issued the direction after it was informed by the state counsel that in two identical petitions the court had passed orders directing the state government to consider representations of the petitioners seeking similar reliefs. While one order was passed on August 3, 2021, the other was issued on January 7, 2022. The fresh direction comes at a time when there

has been over the years demand for locating the WODC headquarters to the western region, but the council has failed to take an unanimous decision. In fact, the WODC in its last council meeting in May this year had decided to maintain status quo for the next three years, which means the headquarter will remain in Bhubaneswar at least till 2025.

Money laundering: Actor Nora Fatehi appears before ED in case against conman Sukesh CLASSIFIED

The agency has alleged that Chandrashekhar,

NEW DELHI: Actor Nora Fatehi on Friday complaint. appeared before the Enforcement Directorate (ED) here for recording her statement in 32, used illegal money to purchase gifts for

connection with an ongoing money laundering probe against alleged Sukesh conman Chandrashekhar and asofficial sociates, sources said.

Fatehi, 30, has been questioned by the federal agency in the past. Sources said the actor, known for her dance numbers in Bollywood

films, will be questioned about Chandrashekhar and her statement will be recorded under the sections of the Prevention of Money Laundering Act (PMLA). The ED, in her earlier charge sheets filed in this case, had named actor Jacqueline Fernandez as an accused while Fatehi's statement was included in the same prosecution



Fernandez which he had extorted by cheating high-profile people including former Fortis Healthcare promoter Shivinder Mohan Singh's wife Aditi Singh to the tune of about Rs 200 crore. He was arrested by the ED. In February, the ED filed its first supplementary prosecution complaint against Pinky Irani, an alleged aide of Chandrashekhar who

introduced him to Bollywood actresses like Nikita Tamboli, Chahat Khanna, Sophia Singh, and Arusha Patil, in Tihar Prison.

It had been alleged in the charge sheet that Pinky Irani used to choose costly gifts for Fernandez and later used to drop it at her house after the payments were made by Sukesh Chandrashekhar. Sukesh has spent around Rs 20 crore on different models and Bollywood celebrities. A few had refused to take the gifts from him. In September this year, a team of the Economic Offences Wing took actresses Nikki Tamboli and Sofia Singh to the Tihar's central jail number one to "recreate" their meetings with the 'conman' as part of the ongoing probe.

The probe has also revealed that Chandrashekar had fully-functional office inside the prison with a television, sofa, carpet and other amenities. On October 19, Delhi Lieutenant-Governor Vinai Kumar Saxena granted permission to the EOW to investigate 82 prison officials for their alleged involvement in the extortion racket.



As per section 69C, in any financial year if an assessee has incurred any expenditure and no explanation is offered about the source of such expenditure or part thereof



or if any explanation offered is not satisfactory in the opinion of the A.O., the amount covered by such expenditure or part thereof, may be deemed to be the ofincome the assessee for such

financial year. It may be noted that any unexplained expenditure which is deemed to be the income of the assessee shall not be allowed as a deduction under any head of income. It is taxed effectively at higher rate of 75 per cent plus education and Health cess under section 115BBE.

1. Pre-conditions for invoking section 69C: Section 69C is attracted in the

following circumstances:

An expenditure has been found to a) have been incurred by an assessee in any financial year, and

The assessee fails to explain the b) source of such expenditure or any part thereof, to the satisfaction of the A.O.

In CIT v. Bhagwati Developers (P) Ltd. [2003] 261 ITR 658 (Cal.), it has been held that section 69C deals with unexplained expenditure. If from documents it appears that there was expenditure, unless its source is satisfactorily explained, it would also be deemed to be the income of the assessee for such financial year. The question of addition depends on the satisfactory explanation of the source. It cannot be negated simply because the expenditure was actually incurred. On the failure to explain the source of the expenditure, it is liable to be added to the income of the assessee.

Letter to Editor Awareness on Grey water reuse needed

Water is widely recognised as a vital resource for humans. It is a resource that must be preserved for 2. Under what circumstances the A.O. can make an

addition for unexplained expenditure for *marriage expenses:* Marriage expenses is an important item, in respect of which addition can made u/s 69C in many cases. The general rule for ascertaining the marriage expenses and the addition to be made should be based upon normal and moderate standards. There should be a definite and tangible basis for making such estimate as such a estimate by the fact-finding authorities must be satisfactory and desirable and cannot be on fictional basis, capricious or arbitrary.

In Yadu Hari Dalmia v. CIT [1980] 126 ITR 48 (Del.) is relevant, it was held that in India, it is customary that the expenses incurred on various rites and rituals in different marriage functions are met not only by one person but by members of paternal and maternal relations of both the bride and the bridegroom. In case where there is direct and clear evidence to show that the assessee himself has incurred some expenditure on a particular item which he has not recorded in his books or which exceeds the amount recorded and the assessee fails to furnish any explanation for the same or the explanation furnished by him is not satisfactory to the A.O., section 69C can be invoked. Even where there is no such direct evidence, it is possible for the authority to make a fair and honest estimate based on certain relevant materials, but the estimate should be based on detailed enquiries, surveys or investigation.

The High Court further held that where additions were made on the ground that the expenses on the marriage of the assessee as shown in the books of the HUF to which he belonged were low, even though the estimate of expenditure was reasonable and conservative and there was no particular reason to assume that the unaccounted expenditure was met out of the assessee's undisclosed income and not by the assessee's father or by the HUF itself, the addition was not sustainable. The addition was deleted on giving the assessee a benefit of doubt as there was no reason to assume that the extra expenditure came out of the assessee's funds and not from those of his family.

Basically, the exact expenditure or even a proper estimate of expenditure would only be in the knowledge of the assessee. If the assessee chooses to give evasive answers, then the ITO can draw an adverse inference regarding the suppression of material facts. He can also take into account what might be the reasonable expenditure on a marriage of that type.

In the case of Smt. Shanti Devi Jalan v. CIT [1983] 139 ITR 288 (Cal.) the estimated addition on account of unexplained marriage expenses was upheld as the estimate was reasonable and based on sufficient materials.

The Delhi High Court in the case of CIT v. C.L. Verma [1995] 78 Taxman 231 (Del.) held that the deletion by the Tribunal of the addition made on account of unexplained expenditure has been upheld on the basis of the evidence collected during the course of penalty proceedings.

Can AO disallow entire purchases in case the assessee having transaction with such supplier? What are the other judicial pronouncements on bogus purchases: Different pronouncements on bogus purchases are as under:

decisions in favour of Assessee :

The fact that the supplier admitted to issuing bogus bills does not necessarily mean that he had issued accommodation bills to the assessee. There is subtle but very important difference in issuing bogus bills and issuing accommodation bills to a particular party. The difference becomes very important when a supplier in his affidavit admits supply of goods. As far as sales are concerned there is no doubt about the genuineness of such sales. It is also a fact that suppliers were paying VAT and were filing their returns of income. In response to the notices issued by the AO u/s 133(6) of the Act, the supplier admitted the genuineness of the transaction. Accordingly, the purchases cannot be treated as bogus- Shantivijay Jewels Limited v. DCIT ITA No 1045/Mum/2016 order dated 13.04.2018; ACG Arts & Properties (P.) Ltd. v. If the AO has not rejected the books of account and has only doubted the genuineness of the suppliers but not the genuineness of the purchases and if the payments are made by account payee cheques, sec. 69C is not attracted. Sec. 69C cannot be applied where all purchases and sales transactions are part of regular books of account. The basic pre-condition for invoking sec. 69C is that the expenditure incurred by the assessee should be out of books of account. Where in order to prove genuineness of purchases, assessee had furnished copies of purchase bills, delivery challans, confirmation of ledger accounts of suppliers, sales tax returns and sales tax challans of suppliers and their income tax returns, merely returning of notices u/s 133(6) sent to those suppliers could not be sufficient to make additions u/s 69C - Fancy wear v. Bhubaneswar: The good news is that Odisha's economy is projected to register higher growth of about 8% in 2022-23 as well as in 2023-24. One of the high growth states in the country has outperformed the other states and even the nation. While the global economy is projected to grow 3.2% this year, the Reserve Bank of India has projected India's growth at around 7.2%. However, Odisha has been eyeing for a bigger growth rate in the coming years.

The state's economy has seen a rebound in the year 2021-22 despite the second wave of Covid-19, and real GSDP has grown at a rate of 10.1% as per advanced estimate which is much higher than the national growth rate of 8.8 %. Capital outlay to GSDP ratio has increased from 3.8% in 2019-20 to 4% in 2022-23.

Capital outlay has been in tandem with the developmental needs of the state. About 63% of total outlay has been allocated for developmental sectors such as major and medium irrigation, flood control, transport infrastructure, etc.

However, the economic analysts are skeptical about the projected growth as a number of issues concerning the states in general and specific issues pertaining to the economy and finances of the state remain unresolved. Unless the Centre revisits its Centre-State policy, it will be a daunting task for the state administration to maintain its high growth trajectory.

In recent years Odisha's Own Tax Revenue (OTR) as a percentage of Gross State Domestic Product (GSDP) has declined, especially since the introduction of the Goods and Services Tax (GST). The period of GST compensation has ended on 30 June, 2022. The decisions of the Government of India to reduce the tax rates of the Union Taxes and contraction of economy during 2020-21 have resulted in contraction of the divisible pool, resulting in reduction in the devolution of Central Share Tax to the State to the tune of 2.18% of GSDP from 2015-16 to 2020-21.

Now the state has little space to enhance its tax revenue in order to fill the resources gap due to cessation of GST compensation to the states from July 2022 onwards. It has been estimated that the shortfall in own revenue for Odisha will be around Rs.65,000 crore in next Five Years. If central policy is not revised Odisha will not be able to maintain the level of spending in priority sectors, analysts feel.

Narendra Modi is on record expressing that the collective efforts of all the states in the spirit of "Cooperative Federalism" were the force that helped India to emerge from the pandemic. Both the state and the centre worked in tandem during the pandemic period.

According to economic advisors in planning, designing and finalizing the criteria for allocation for Centrally Sponsored Schemes (CSS) the states should have a greater say. And most importantly, the Union Government is needed to provide advance indication about the allocation, so that the state may prepare



the Annual Budget on a realistic basis.

Sadly, this exercise is absent and there is irregular flow of funds in some schemes and in some others the actual central assistance is substantially lower than approved for the financial year. The state is asked to bear the balance on a 100% basis. Of late this is happening and Odisha is facing a tough time, officials claim. So, in practice, the state has to bear much higher than its 40 % share.

Economists advise that the Government of India needs to evolve a single window system for communication of annual allocation and sharing pattern of CSS to the states and ensuring release of central assistance as per commitment. One of the major concerns of the state administration is that the geo-climatic conditions of Odisha make it vulnerable to multiple and frequent natural disasters. During About the Covid-19 period, Prime Minister 1900 to 2022, the state has experienced di-

sasters like flood, cyclone, and drought every year. These natural calamities pose a serious challenge to the economy of the State. Odisha has recently requested that "Natural Calamity" should be made one of the criteria for according "Special Category Status" to Odisha, so that it will avail facilities similar

to North Eastern and Himalayan states. Many states are facing major natural calamities and those vulnerable to such disasters are needed to be declared as "Special Focus State" and granted benefit of SPS for a specific period. This will help reconstruction of infrastructure and restoration of livelihood. Article 270 of the Constitution of India provides for sharing of proceeds of All Union Taxes between the Union and States. However, the cess and surcharge levied by the Government of India as per Article 271 of the Constitution of India, which do not form a part of 'Divisible Pool'.

The share of cess and surcharge in Gross Tax Revenue of the Union Government increased from 7.5% on 2000-01 to around 20% in 2022-23. This has resulted in reduction of the devolution of Central share from 7.18% of States' GSDP in 2015-16 to 5.07% during 2020-21 and 5.98% during 2021-22.

This policy needs a revisit and at least flagship centrally sponsored Schemes like PMGSY, PMKSY, JJM need 100% funding, so that the state will be in a comfortable funding scenario to implement these major programs.

Another major concern area is Capital Expenditure (CAPEX). One of the most important initiatives taken by the Union Government is to boost CAPEX in states with the introduction of the Scheme of Financial Assistance to States for Capital Investment from 2020-21.

Financial analysts opine that the CAPEX guidelines are complicated and laced with many conditions, for which large chunks of funds allocated in CAPEX are remaining unutilized. Simplification of procedures is the need of the hour and once simplified, both the state and centre will reap benefits. In fact, complicated guidelines have defeated the objective of the grand scheme to enhance

312 track maintenance Railways staff died on duty in last four years

NEW DELHI: Over 300 Railway Track Maintenance (RTM) personnel have lost their lives on duty after being by trains in the last four years over the Indian Railways. The highest



number of RTM staff had died on duty from different railway sections in Uttar Pradesh from 2018 to December 5 in 2022

The Railways informed the Rajya Sabha (RS) that a total of 312 track maintenance staff had died in the last four years on duty in different parts of the country.

Union Railway Minister Ashwini Vaishnaw on Friday in a written reply said that ex-gratia compensations were paid to the families of Railway track maintenance staff who lost their lives while performing bonafide official duties after being hit by trains.

"We are conducting regular counselling of track maintenance staff for 'personal safety first' while working near the tracks. They have also been equipped with protective equipment, safety helmets, and retro-reflective high visibility jackets for duty", the minister

> informed the House, adding that work site remote control hooters and whistles were provided to track maintenance staff. The minister also said that periodic medical examination is regularly being conducted to ascertain the fitness of track personnel.

The most notable information the minister gave in the Upper House was that the government has sanctioned the very high frequencybased 'Approaching Train Warning System', which is also called 'Rakshak', on the Golden Quadrilateral-Golden Diagonal routes on Indian Railway. "For this system, Rs 91.21 crores have been sanctioned", the minister added. According to data shared by the minister in the RS, 61 track maintenance personnel lost their lives after having been hit by trains during duty in Uttar Pradesh from 2018 to December 5 in 2022. 48 track maintenance personnel died in Maharashtra during duty in the same period.

The King was also a learned and knowledgeable patriot and great patron of the Odia language and presided over the first meeting of Utkal Samilani held on 3 December 1903 due to which he along

Automobile industry looks to sustain growth momentum in 2023

NEW DELHI: The Indian automobile industry is setting out on a journey with hopes for a sustained growth momentum in 2023 and further embracing clean technology amid the lurking speed breakers of rising interest rates and cost increases due to new emission and safety norms, having witnessed a strong comeback from the COVID-led downturn this year.

While the passenger vehicles (PV) segment is set for record sales in 2022 despite the lingering effects of supply chain constraints and semiconductor shortages, the two-wheeler space is yet to see sustained sales buoyancy after having suffered for most of the year.

According to industry estimates, PV sales can reach around 38 lakh units this year.

The three-wheelers and commercial vehicles segments have also witnessed good growth in 2022 compared to 2021, albeit on a low base of last year, which was affected by the second wave of

of COVID-19, Menon stated.

Mahindra & Mahindra (M&M) Executive Director (Auto and Farm Sectors) Rajesh Jejurikar, however, remained confident about the industry maintaining the current sales momentum.

"At M&M, all models will comply with BS-VI.2 norms as per timelines set by the government and the price / cost difference may not be as steep as it was for the BS-IV to BS-VI transition," he asserted.

While acknowledging that the semiconductor shortage continues to be dynamic and rising input costs and interest rates are some other challenges that the industry is managing, he remained optimistic about sales momentum continuing next year.

"Apart from these headwinds, we look forward to an action-packed 2023 on the back of huge demand from customers," Jejurikar said.

"I would say that the growth is going to be high this year but next year on a very high base, with the interplay of so many tailwinds and headwinds, it would be still growth, but to what extent that growth would

COVID-19 and manufacturers will be keen to carry forward the momentum to the new year.

As per industry observers, 2023 will also see acceleration in adoption of electric vehicles, which has already started taking root in 2022, especially in the two-wheelers segment.

For potential passenger vehicle buyers, 2023 may not ring in the best news as vehicle prices are set to increase next year as companies prepare to conform to stricter emission norms which kick in from April 1, 2023.

Many manufacturers like Maruti Suzuki, Tata Motors and Hyundai have already announced plans to increase prices from January next year.

Besides, rising interest rates and not so bright global economic situation and its impact on India in the days to come are some of the factors which are keeping the industry in a cautious mode.

"Increase in price always has a certain negative impact on sales. But we still do not know how much the prices will go up and what will happen to input cost and foreign exchange. These are uncertainties which will always be there," Maruti Suzuki India Chairman R C Bhargava told PTI.

He, however, stated that the domestic car industry has revived in the last few months and the semiconductor shortages are also going to abate in 2023. "Putting it all together, our estimate would be that next year would probably be a reasonably good year for the industry. I think we should do at least as well if not better than 2022," Bhargava said. The country's largest carmaker will keep bringing in cars, especially more SUV models, to cater to the customer demand, he noted. Industry body Society of Indian Automobile Manufacturers (SIAM) Director General Rajesh Menon said the passenger vehicle industry adopted the second phase of fuel efficiency regulations this year from April 2022 and is gearing up to meet the stringent second phase of BS VI emission norms from April 2023. Discussions are also underway to implement various new safety regulations for passenger vehicles in 2023, he said. "Implementation of these new regulations could raise the cost of the vehicles and this coupled with global recessionary trends are of concern going forward in the year 2023," Menon pointed out. Besides, with rising inflation, the RBI was compelled to increase the reportates a couple of times this year and this increase in interest rate can impact the demand trends for all vehicle segments, he cautioned. Though the overall numbers from January to November 2022 have shown appreciable growth for all segments including passenger vehicles, this has been achieved in the backdrop of a low base in 2021, which was affected by the second wave be on the high base, that will be seen," he noted. Kia India Chief Sales Officer Myung-sik Sohn said stricter emission norms are a positive for the industry's collective efforts of trying to minimise pollution from vehicles.


However, they will surely have an impact on vehicle prices.

"You will see a hike in prices across all OEMs, but looking at the high demand for cars currently, we expect little impact on sales momentum," he noted. Automotive dealer's body Federation of Automobile Dealers Associations (FADA) noted that the PV segment still continues to hold a strong order book for several models which is expected to continue for a few months.

"The OEMs (original equipment manufacturers) need to continue with the creation of excitement through new launches, product upgrades etc. We expect the production soon to be back to normal and we can bring down the long waiting period to normal," FADA President Manish Raj Singhania stated.

The long waiting period and flexible consumer behaviour during the festive season have helped the industry to see movement in the segment, but once the demand and supply balance is restored, the slow-moving models will be a challenge for the industry, Singhania said.

BJP has Dhamnagar model to counter BJD: Dharmendra Pradhan

With the BJD asserting replication of the Padampur model across the state during the next Assembly election, the BJP has propped the Dhamnagar and Gujarat models to give the regional party a tough fight.

Talking to mediapersons before a party meeting of state and district functionaries here, Union Minister Dharmendra Pradhan said the lessons learnt from the back-to-back fight in the two by-elections will put the party in good stead during the next round of battle with the BJD in 2024.

"We have Dhamnagar model (to replicate). Both Dhamnagar and Padampur bypolls have taught BJP how to face 2024 general elections. As the main Opposition in the state, people want BJP to bring the state government's failure to the fore," Pradhan said.

He said corruption, inefficiency of the BJD government will be the main issues for the BJP. Also taking a jibe at the BJD, BJP MP from Bhubaneswar Aparajita Sarangi said, "When it comes to good governance, Gujarat is the best model. The Padampur model of BJD is the model of corruption and there is nothing to boast about." The meeting chaired by BJP state unit president Samir Mohanty took stock of the two bypolls and discussed strategy how to counter the money power of the BJD in the next Assembly and Lok Sabha elections.

"Many important issues were discussed. Apart from the recently held bypolls in Padmapur and Dhamnagar, the meeting discussed the all-round failure of the state government, its anti-farmer policy and growing unemployment in the state," said party general secretary Prithiviraj Harichandan after the meeting.

He said the party has decided to launch a series of agitational programmes to expose corruption and failure of the government. These agitations will continue till the next elections. A committee has been constituted to prepare a list of programme and finalise dates for holding agitation on different issues. BJP national general secretary and Odisha election-in-charge Sunil Bansal suggested measures to be taken on a time bound manner to strengthen party organisation from booth level. Party's national general secretary and Odisha in-charge D Purandeswari said India taking the presidency of the G20 and three events scheduled to take place in Odisha, the party should grab the opportunity to further its prospects in the state.

Commenting on the sales growth outlook, ICRA Vice President and Sector Head Corporate Ratings Rohan Kanwar Gupta said the rating agency expects the industry demand to remain steady and volumes to grow by 6-9 per cent in FY2024.

"The capex outlay for OEMs is estimated to remain heightened (an estimated outlay of Rs 650 billion over FY2023-FY2025, with the OEMs also budgeting for a substantial outlay towards new product development, including development of capabilities/platforms for electric vehicles," he added.

Elaborating on the luxury car segment, Mercedes-Benz India's outgoing Managing Director and CEO Martin Schwenk said, "We have to see how the overall economic climate is there. Overall, confidence is there that 2023 should be a good year. The world is dynamic but at the moment, we are starting with a positive momentum into next year."

As for the two-wheeler segment, Menon said while an increase in interest rate can impact the demand trends for all vehicle segments, the government has also hiked the long-term insurance premium, which specifically impacts the two-wheeler segment.

"Two-wheeler demand has remained weak over the past few years, with consumer sentiments impacted by factors such as income uncertainty during the pandemic period and a persistent hike in two-wheeler prices led by both regulatory changes and inflationary pressures," ICRA's Gupta said.

Centre cuts windfall tax on domestic crude oil

New Delhi: The Centre has cut the windfall profit tax on domestically produced crude oil. Along with this fortnightly revision in windfall tax, the Centre has also slashed the levy on diesel. As per updates, these changes come into effect from Friday, according to an order issued by the government on Thursday late night. The move of the government comes at a time when global crude prices has witnessed almost 14 per cent slump since November. As per global estimate, India is the world's third largest consumer and importer of oil. According to the revised prices, the windfall tax on crude oil produced by firms such as the stateowned Oil and Natural Gas Corporation (ONGC)

has been reduced to Rs 1,700/tonne from the previous Rs 4,900/tonne. Before the previous revision, this amount was Rs 10,200 per tonne.

The government has also cut the rate on export of diesel to Rs 5 per litre from Rs 8 per litre. Before the previous revision, this rate was Rs 10.5 per litre. The new levy also includes Rs 1.5 per litre as road infrastructure cess, like in every case.

On July 1, India imposed the windfall tax on crude oil producers and levies on exports of gasoline, diesel and aviation fuel after private refiners sought overseas markets to gain from robust refining margins, instead of selling at lower-than-market rates in the country Zelensky said the strikes hit power and water supplies in Kyiv and 14 regions.

Regional officials said their air defence forces had shot down 37 out of 40 missiles.

In the central city of Kryvyi Rig, where Zelensky was born, Friday's air strikes hit a residential building.

The missiles killed a 64-year-old woman and a young couple with a son, governor Valentyn Reznichenko said Saturday, wounding 13 others. In the south, fresh Russian shelling in Kherson, recently recaptured by Ukraine, killed a 36-year-old man and injured a 70-year-old woman, governor Yaroslav Yanushevich said Saturday morning.

A separate strike hit a geriatric centre in the village of Stepanivka just north of Kherson, he added later, but there were no casualties reported.

Kherson has been subjected to persistent Russian shelling since Moscow's forces retreated in November, and power was cut in the city earlier this week.

Protracted war

Moscow has said the strikes on Ukrainian infrastructure are a response to an explosion on the Kerch bridge connecting the Russian mainland to the Crimean peninsula, annexed from Ukraine in 2014.

Ukrainian defence officials said this week that their forces had downed over a dozen Iranian-made attack drones launched at Kyiv, a sign that Westernsupplied systems are having an impact.

The country's military leaders have also warned Moscow is preparing for a major winter offensive, including a fresh attempt to take Kyiv.

Russia meanwhile on Saturday accused Moldova of "political censorship" after it suspended the broadcasting licence of six television channels over accusations of misinformation.

Moldova -- which sits on Ukraine's southwestern border -- said on Friday the decision was made because of the "lack of correct information" in their coverage of national events and Russia's military campaign in Ukraine.

Moscow also responded to the EU's decision Friday to impose further sanctions, adding restrictions on the export of drone engines to Russia or countries like Iran looking to supply Moscow with weapons.

The new package of "illegitimate unilateral restrictive measures" would not achieve its goal, Russia's foreign ministry said Saturday.
