Balangir(KCN): Govind Sahu, prime accused of sensational Mamita Meher murder case, reportedly died by suicide inside the Kantabanji Sub-Jail in Odisha's Balangir district, today. According to reports, Sahu was found hanging from a tree on the jail premises with a gamcha, following which he was rushed to Kantabanji Subdivisional Hospital by prison authorities.He was declared dead at the across the state. Mamita went missing on October 8, 2021. Alleging Govind Sahu behind her missing, Mamita's family members had lodged a complaint with police. On October 19, 2021, bones of Mamita's body were exhumed from a stadium construction site of the his alleged links with

police.Sahu allegedly murdered Mamita, chopped off the body, set it on fire and dumped it under the ground. He also torched her bag, mobile phone and other belongings to eliminate the evidence.

Police said Mamita had threatened Sahu to expose his extramarital affairs, over which he strangled her to death inside his car on October 8, 2021.

BJP MPs meet Goyal More Funds for PLISFPI

New Delhi(KCN): A day after BJD MPs met representatives and officials of the Odisha Union Minister Piyush Goyal demanding release of pending food subsidy dues of Rs 14,292 crore, BJP MPs from Odisha met Goyal alleging gross irregularities in procurement of paddy in the State.

A delegation of the BJP Parliamentarians led by Union Minister Dharmendra Pradhan met the Union Food Minister and sought his intervention to deal with alleged corruption in paddy procurement and denial of MSP to farmers in Odisha.

In a memorandum to Shri Goyal, the leaders accused the State Government of scuttling paddy procurement and causing great distress to farmers.

They said the Centre's attention was earlier drawn to corrupt practices prevalent in Regulated Markets Committees (RMC), Primary Agriculture Credit Societies (PACS) and Paddy Procurement Centres (PPCs) in Odisha. It was also corroborated in the reGovernment, it said.

The MPS also alleged that the centralised token system for the paddy sale is being exploited by Secretary PACS/PPC to summon a farmer on a particular date to bring his Paddy for sale leading to favouritism and many tokens belonging to small and marginal farmers getting lapsed.

As mandis are not being opened at all in some RMCs, irregular lifting of rice at Mandi has created an additional issue of storage of the grains for farmers in open, they said.

Claiming that farmers are not getting MSP of Rs 1940/- per quintal due to cut in weight over FAQ, it said mandis are not maintaining separate register & accounts and surplus paddy is adjusted as FAQ and value is being misappropriated by those involved in the procurement system.

A nexus of millers and officials of the Food Supplies and Consumer Welfare department

New Delhi(KCN): The Ministry of Food Processing (MoFPI), is implementing a Central Sector Scheme- "Production Linked Incentive Scheme for Food Processing Industry (PLISFPI)" with an outlay of Rs. 10,900 crores over a six-year period from 2021-22 to 2026-27.

The scheme, inter alia, helps create of global food manufacturing champions commensurate with India's natural resource endowment and supports Indian brands of food products in the international markets.

The export of agri-food products (ITC Chapters 2-23 excluding 5,6,14) has increased from US\$ 29.67 billion in 2015-16 to US\$ 46.11 billion in 2021-22 showing a Compound Annual Growth Rate (CAGR) of 7.62% and the export of value added processed-food products (ITC Chapter 16-23) increased from US\$ 4.855 billion in 2015-16 to US\$ 10.420 billion in 2021-22 showing a CAGR of 13.57%.

In order to ensure overall development of Food Processing sectors across the country, MoFPI has been implementing Central Sector Umbrella Scheme – Pradhan Mantri Kisan SAMPADA Yojana (PMKSY), centrally sponsored PM Formalisation of Micro Food Processing Enterprises Scheme (PMFME) and Central Sector Production Linked Incentive Scheme (PLISFPI). Under component schemes of PMKSY, MoFPI provides mostly credit linked financial assistance (capital subsidy) in the form of grantsin-aid for setting up of food processing industries/ units/ projects. Ministry provides financial, tech-



nical and business support for setting up/ upgradation of micro food processing enterprises through PMFME scheme, whereas, PLISFPI is targeted to facilitate expansion of food processing capacity by creating champion brands in Food Processing Sector. This information was given by the Minister of State for Food Processing Industries, Prahlad Singh Patel in a written reply in Lok Sabha today.

Unfortunately, the Government of Odisha seems to have ignored the findings of the report as the same issues are yet again plaguing the paddy procurement process in the state of Odisha, said the MPs.

While the Kharif Marketing Season commences from October to facilitate smooth paddy procurement, mandis have not opened so far except for a few districts.

"In Odisha except for a few districts, Mandis have not opened till now even in 3rd week of December. This is severely curtailing the actual procurement window to 40-43 days against the official 151 days window creating panic among small and marginal farmers," read the memorandum submitted by the MPs to Shri Goyal.

Noting that a restricted procurement period disables farmers from bringing their produce to the mandi for sale and generate income, the memorandum said a recent drone survey has pointed out that the harvesting has been completed in around 35% of the cultivated

However, mandis in most coastal districts have not been opened yet and the Odisha government is shifting the blame to District Level Paddy Procurement Committees (DLCP) in the name of decentralisation. Ironically, these are indirectly controlled by has made the paddy procurement automation system (P-PAS) a mockery by allowing unscrupulous traders farmers to snatch away the benefits from genuine registered farmers.

The MPs also said that if sources are to be believed, millers are not lifting stocks from the mandis as the Civil Supplies Officers (CSOs) have not issued miller authority slips. The millers are playing to the tunes of the CSOs who tag them to mandis and decide the quantum of paddy to be allocated for custom milling.

Unscrupulous traders and landless farmers / proxy farmers, who do not cultivate, in collusion with the members of PACS, have been siphoning the MSP of the government by getting tokens for paddy sale, alleged the memorandum, copy of which was released to the media.

This Kharif season around 5,54,679 acres of land has been identified as fake in the satellite survey for which proxy/non-farmers were eligible to receive MSP support to the tune of Rs 1715 crore, it alleged. "We would like to request you for your personal intervention to resolve the issues on alleged mismanagement and corrupt practice in the State of Odisha in Paddy Procurement Operation which is continuing to persist till today despite recommendation & suggestion given by Government of India, resulting harassment to the poor farmers of the State," it added.

BJP-BJD spar over tardy procurement of paddy

BHUBANESWAR(KCN): With farmers of some western Odisha districts staging dharna to protest inordinate delay in paddy procurement, the BJP on Monday announced to launch a 'Mandi Chalo' abhiyan from December 22 to 28 to expose the alleged nexus between millers and supply officials. Addressing mediapersons, BJP state general secretary Prithviraj Harichandan said as part of the campaign, the party's workers will stage protests in front of the offices of 58 sub-collectors in the state. "We will not tolerate the continuous neglect and ill-treatment of our 'annadatas' (farmers). The party will submit memorandum to the sub-collectors for immediate purchase of paddy failing which a state wide agitation will be launched," he warned. Farmers of western and eastern regions of the state have suffered significant losses due to distress sale of paddy to agents of millers from Chhattisgarh and Andhra Pradesh. The farmers are selling their produce for Rs 1,300-Rs 1,400 per quintal against the minimum support price of Rs 2,400 per quintal, Harichandan alleged. As per the food and procurement policy for the 2022-23 kharif marketing season, a five-month window was opened beginning November 1 for procurement of kharif paddy through designated state agencies mostly PACS. "Mandis were opened 15 days after the scheduled

date in Bargarh district in view of the by-election to Padampur but the same are yet to be opened in coastal districts. Generally, paddy purchase centres (PPCs) are opened on December 1 because of late harvesting," Harichandan said.

He said this is a deliberate attempt to force farmers to sell their stock to rice millers' agents for recycling. A substantial amount of the benefits earned by the millers goes to the coffers of the ruling BJD, the saffron party leader alleged. Brushing off the allegations, food supplies, consumer welfare and cooperation minister Atanu Sabyasachi Nayak said there is not a grain of truth in BJP's allegations as the government has already procured paddy worth Rs 1,104 crore from 1.24 lakh registered farmers. "The food supplies and cooperation department has nothing to do with finalisation of dates for opening of mandis as the process has been decentralised. The district level procurement committees (DLPCs) headed by respective district collectors and represented by local MLAs decide when to start procurement which depends on harvesting of paddy," the minister said. Nayak said all mandis are operational in western Odisha districts and steps are being taken to open PPCs in coastal districts by end of this month.





'Joram', 'Moha', 'All India Rank' among Indian films at International Film Festival Rotterdam 2023

NEW DELHI(KCN): The 2023 edition of the International Film Festival Rotterdam (IFFR) will witness a heavy presence of Indian films, including the Manoj Bajpayeestarrer "Joram" and writer Varun Grover's directorial debut "All India Rank".

Films in various Indian languages feature in diverse segments of the festival, being held in the port city of the Netherlands for the past 52 years.

This year, the film gala will run from January 25 to February 5.

Manoj Bajpayee's "Joram" will be screened as part of Big Screen Competition, which aims to bridge the gap between popular, classic and art house cinema.

"Joram", which reunites Bajpayee and film-

maker Devashish Makhija after the success of their 2019 movie "Bhonsle", is a survival-thriller about a displaced indigenous man.

"Bhonsle" was also screened at the festival back in 2019.

"The film 'Joram' is a riveting story of a man torn between his past and present. I loved playing the intricate character, Darsu, whose past and present have a

significant contrast. On the outside he looks like an ordinary man that people may not even notice, but in no way is he a common man! A brilliant story with such impactful characters," Bajpayee said in a statement.

Grover's "All India Rank", part of Bright Future segment that showcases featurelength debuts, is a semi-autobiographical tale, centers on a middle class boy named Vivek, enrolled in coaching classes for the notoriously competitive entrance exams of the Indian Institutes of Technology (IITs). The film, produced by Matchbox Shots, will serve as the closing film of the festival.

"Vivek's father, who sees an IIT degree as a moral certificate, ships his only son off to a residential preparatory school in Kota, the Mecca for IIT coaching. Over two years, Vivek goes through the motions of Indian adolescence, but it is his parents who do the growing up," the official plotline read. Taking to Twitter, Grover said he is beyond thrilled with the world premiere of his debut feature at the IFFR.

Should we get rid of air miles for climate change?

Flying is very far from being a green activity. A return flight from Lisbon to New York generates nearly the same level of CO2 as the average person in the EU does by heating their home all year round.

Compared with land transport, a plane requires a lot more energy, says Agnes Jocher, a professor at the Technical University of Munich, whose research explores sustainable future mobility. The result is a disproportionate climate impact compared to alternatives (trains and ferries, to name a few).

In a 2019 report on reducing emissions through behaviour change, Richard Carmichael, a social sciences researcher at Imperial College London, observed that flying was a "uniquely high-impact activity" and "the quickest and cheapest way for a consumer to increase their carbon footprint".

Rather than simply capping travellers' ability to fly, Carmichael suggested an alternative: to limit the perks that travellers get from airlines. Among his recommendations, Carmichael proposed an outright ban on air miles and frequent flyer loyalty programmes that he says incentivise "excessive" flying.

By one estimate, trips taken using air miles account for around 10% of overall bookings. But could axing these schemes curb rising aviation emissions? Or would such a policy be fruitless – and efforts to reduce aviation

Airline execs seem content with doling out miles. But how do they feel about people redeeming them?

If each passenger cashed in on their unspent miles, carbon emissions would jump. But those trips can only be taken if miles can be redeemed without restrictions (e.g. for any flight, at any time, without any additional fees). And airline execs make sure that's almost never the case.

The reason? Fare-paying passengers are more valuable to carriers than freeloading flyers. If an airline thinks a seat can be sold for more than the miles equivalent, it will make trading miles for that seat hard, if not impossible. Data backs up this sentiment. Over time, the share of flights paid in miles has fallen and a recent experiment from CBS News in the US found no seat availability for miles in key markets for 45 days straight.

Carmichael says he supports flights that do fly being full rather than having lots of empty seats, since it's more efficient. But "how that is achieved fairly without stimulating demand for flying" requires more scrutiny, he says. Work is also needed to see which miles and rewards schemes incentivise extra flying, he

Carmichael and others also stress the need to reduce energy-intensive activities like flying altogether. The International Energy Agency, for example, has pointed to the need to reduce demand for flying through measures such as taxes on flights, as part of reaching net-zero emissions by 2050. Some campaigners and researchers have called for a policy that amounts to the very opposite of frequent flier rewards – a "frequent flier levy" whereby the more someone flies, the higher a tax they have to pay on each flight.

But could air passengers ever go along with

measures to reduce flying? Lucia Reisch, professor of behavioural economics and policy at the University of Cambridge, thinks so. "The past years have seen a general tendency of consumers to be more interested in and engage more in sustainable consumption," she says. Alongside taxes or regulations, so-called "soft policy tools" - like simply providing people with information or nudges towards flying less – are one way to do this, she says, and "can be very successful, ef-

fective, [and] are often highly accepted". Frequent flier programmes might seem like an obvious target, but in reality, their contribution to aviation emissions is small compared with the emissions reductions we need.



Passengers can opt for hotel nights, electronics, gift adds. cards or even football shirts.

And then of course there's what many travellers consider the biggest attraction: upgrades to premium cabins on an airplane. With enough miles on hand, you can move from the back of a jet to the front: from a place where cuts, squeezes and exasperation are the norm to a space where courtesy abounds, champagne flows freely and Michelin-starred meals await.

Aviation loyalty programmes are around 40 years old. Texas International Airlines, a nowdefunct carrier, created the first one in 1979. At the time, governments were easing restrictions over which carriers could fly, where they could fly to, and when, so competition between carriers intensified. Airline execs needed new ways to boost their brand. One solution? Offer flyers something extra to secure their loyalty – an IOU that could be cashed in later.

Paying passengers would earn "miles" based on how often and how far they flew, which could then be exchanged for a complementary trip. Although these programmes have since evolved (today's flyers are also rewarded based on how much they spend), the underlying premise remains the same.

Some climate activists suggest that it's time to scrap these schemes. "The very last thing we should be doing is reward frequent flyers," says Herwig Schuster, a transport campaigner for Greenpeace. "Frequent flyer programmes are not fair to the climate and the majority of people worldwide who almost never fly. We cannot allow airlines to incentivise a lifestyle that's destroying the planet while they receive major tax cuts and subsidies, and fill their pockets by selling more flight tickets."



UK government refuses to give way on pay as nurses, medics strike

LONDON: The British government said Tuesday it will not offer more money to that are piling pressure on an already overstretched health system.

Prime Minister Rishi Sunak's Conservative administration is under pressure to increase its pay offer to health care staff who are seeking big raises in the face of decades-high inflation that was running at 10.7% in November.

Thousands of nurses walked off the job Tuesday in their second 24-hour strike this month. Ambulance drivers, paramedics and dispatchers are set to strike on Wednesday and again on Dec. 28.

They are joining railway staff, passport officers and postal workers in the U.K.'s biggest strike wave for decades, a response to a cost-of-living crisis driven by soaring food and energy

prices in the wake of the COVID-19 pandemic and Russia's invasion of Ukraine. Pat Cullen, head of nurses union the Royal College of Nursing, urged Sunak to "step in now and do the decent thing on behalf of every patient and member of the public of this country" by negotiating over pay. The union has asked for a raise of 5% above inflation but says it is willing to accept less.

The union says it will stage more strikes in January if there is no deal. Nurses have agreed to staff key areas including critical care and cancer services during the strikes, but thousands of operations and procedures have been canceled in England, Wales and Northern Ireland. Nurses in Scotland are not on strike.

The government says it will dispatch 1,200 troops to fill in for striking ambulance drivers and border staff, who are due to walk out later this week.

The government insists it can't get directly involved in pay talks between unions and nurses and ambulance crews to end strikes employers — but Sunak also told the Daily Mail that double-digit public sector raises would drive inflation even higher, which would "make people poorer in the long

The government is calculating that public opinion will turn on the unions as people across the U.K. face postponed hospital appointments, canceled trains and travel delays during the winter holiday season. But opinion polls show a high level of support for the workers — especially nurses. Britain's health system is under strain from surging demand as pandemic restric-

tions ease, alongside staff shortages from burnout and Brexit, which has made it harder for Europeans to work in the U.K.

Official statistics show that ambulances in many ar-

eas are stuck waiting outside hospital emergency departments, sometimes for hours, because there are no beds for the patients.

Rachel Harrison, national secretary of the GMB union that represents ambulance staff, said the delays and backlogs were "having a devastating effect on our members — frustration, stress, burnout, exhaustion, low morale, mental health."

On a picket line outside St. Thomas' Hospital in London, nurse Rosie Wood said many of her colleagues were exhausted because of staff shortages.

"Nobody feels safe, because you're always worried that you've missed something," she said. "It's not meant to be painful and stressful and horrible to come to work. So many people are unhappy in their jobs right now because they don't get the joy out of caring for people because they just don't feel they can do it properly."

MVA demands resignations of Maharashtra UP Congress leader Ajai Rai booked over his 'latke-jhatke' jibe against Smriti Irani

LUCKNOW: The Uttar Pradesh police have booked senior Congress leader and party's provincial president Ajay Rai over his 'misogynistic' remark against Union Minister



and Amethi MP Smriti Irani.

Rai was booked on the basis of a complaint filed by BJP women's wing leader Pushpa Singh at the Robertsganj police station in Sonbhadra district on Tuesday.

The raging controversy comes after the Uttar Pradesh Congress leader, on Monday, took a jibe at Smriti Irani, saying she only comes to her constituency to show "latke-jhatke" (for pomp and show) and the real work was done when Amethi had an MP from Gandhi family. The FIR against Rai was lodged under Sections 354(a) (making sexually coloured remarks), 501 (printing or engraving matter known to be defamatory) and 509 (word, gesture or act intended to insult the modesty of a woman) of IPC.

However, Rai stood firm in his statement and refused to extend an apology saying that he did not use unparliamentary language against Irani.

"Why should I apologise? I did not use any unparliamentary language. 'Latke-jhatke' is our 'bolchal ki bhasha' (colloquial slang) which means that somebody suddenly appears and says something and then disappears," said Rai while talking to media persons in Chandauli district, adding that he had no intention to insult anyone.

"Some people are unnecessarily trying to exert pressure on me. I did not intend to insult anyone with the word Latke-Jhatke. I have always respected women and will continue

to do so," said Rai while reiterating his claim that the party's Waynad MP Rahul Gandhi would contest the 2024 Lok Sabha polls from Amethi.

"The people of Amethi got overawed by the latke-jhatke, so they elected someone other than Rahul in 2019, but now they have realised and

want Rahul Gandhi back," he claimed.

The Congress leader went a step further saying he himself was ready to challenge PM Narendra Modi in Varanasi in 2024. "PM Modi has not done any such work in Varanasi that the public will re-elect him in 2024. My vote percentage has increased significantly in the last election, so imagine what will happen in 2024," he said.

Meanwhile, the National Commission for Women took cognisance of Rai's remarks and summoned him to appear at a hearing scheduled for December 28.

"The Commission has taken cognisance of the misogynistic remark made by Ajay Rai. The remarks are outrageous and extremely derogatory and the Commission strongly condemns such statements," the NCW said in a statement.

Rai's controversial statement also evoked a sharp response from Smriti Irani who accused the Congress of misogyny and took potshots at Rahul and Sonia Gandhi on Twitter. Irani tweeted, "Heard that Rahul Gandhi has got the announcement on his Amethi contest made via a party leader. I hope you will not run to contest another seat, and won't get scared. PS: You & Mummy ji need to get your misogynistic goons a new speechwriter."

adequate focus on the manufacturing sector. Mr Jaishankar said not much attention was given to the MSME sector and building supply chains as well after India opened up its economy in 1991.

"When somebody says why imports are coming out of China, there are imports coming out of China because for 30 years, you did not give your industry the kind of support and protection you should have," Mr Jaishankar said. "It is only now in recent years that you have started to do it. Now you cannot reverse in five or 10 years what you have done in 30 years," he said.

The Lok Sabha, meanwhile, passed the Anti-Maritime Piracy Bill to make special provisions for the repression of piracy on the high seas, with the government adding life imprisonment along with the provision of death penalty for those convicted of the crime. Some amendments moved by Opposition MPs were negated and the bill was passed by a voice vote.

Mr Jaishankar said keeping in mind the observations of the Supreme Court that the death penalty should be in rarest of rare cases and the fact that many nations do not extradite the accused in view of the provision of capital punishment, the government was including the option of life in prison.
