## President of India to visit Rashtrapati eAbkari bags award Nilayam, Secunderabad for Winter Sojourn

NewDelhi (KCN): The President of India, Smt Droupadi Murmu will visit Secunderabad, Telangana for winter sojourn at Rashtrapati Nilayam from December 26 to 30, 2022.

On December 26, 2022, the President will visit Srisailam Temple in Andhra Pradesh and inaugurate projects related to the development of Srisailam Temple under PRASHAD scheme of Union Ministry of Tourism. She will also visit Sri Shivaji Spoorthy Kendram at Srisailam, before reaching to Rashtrapati Nilayam.

On December 27, 2022, the President will address the students and faculty members of Keshav Memorial Educational Society in Hyderabad. On the same day, she will visit Sardar Vallabhbhai Patel National Police Academy to address the Officer Trainees of Indian Police Service (74th RR Batch). She will also inaugurate the Wide Plate Mill of Mishra Dhatu Nigam Limited (MIDHANI) at Hyderabad.

#### Gobinda Sahu's postmortem report indicates suicide

BHUBANESWÂR(KCN): The Crime Branch received the postmortem report of Gobinda Sahu on Saturday which indicates that it was a case of suicide. Šources said, Sahu's postmortem was conducted in Kantabanji hospital with the assistance of doctors of Veer Surendra Sai Institute of Medical Sciences and Research. CB had earlier seized



the DVDs consisting of photographs and videos of Sahu's inquest and postmortem. On the day, the agency's officers visited Mahaling Anchalika College and seized the

The agency's officers are of the opinion that the seized register may have several resolutions and signatures of Sahu. They examined a few staff of the college including the governing body's secretary Kiran Kumar Singh and clerk Josabant Bagh. CID-CB's team investigating the case in Kantabanji visited Sahu's house at Mahaling in Kalahandi district on Saturday. They seized an old note book of Sahu and questioned his family members - wife Susama and their daughters.

They also questioned some villagers of Mahaling including Santosh Kumar Sahu and Tarini Sahu. The CB officers are questioning the Kantabanji sub-jail inmates too as part of their investigation.

Bhubaneswar(KCN): It is clear that the Biju Janata Dal (BJD) and Opposition Bharatiya Janata Party (BJP) have already started flexing their muscles in Odisha ahead of the 2024 General elections for the Lok Sabha and State Legislative Assembly. The warring parties are trying to improve their vote banks. Interestingly both BJD and BJP have now set their eyes on the Congress votes. The saffron party has expanded its mass base in the nook and corner of the state and also strengthened its booths in many places, as evident from their securing around 40 per cent of the votes.

At the same time, BJD headed by Chief Minister Naveen Patnaik also added to its strength continuously. The regional party boasts of one crore members out of the state's 3.29 crore voters. The party's vote share in a majority of constituencies remains at around 50 per cent. The state's oldest party, the Congress, however, struggles with around 15 per cent votes and the ratio is on the decline.

Evidently Congress's votes are steadily being captured by both the two parties. Though Naveen's party took a chunk of Congress votes in the recently concluded Padampur by-poll in Bargarh district, BJP too gained a certain portion of traditional Congress votes. Both the BJD and BJP are in a race to wrest the Congress votes. The party which will be able to transfer more Congress votes in its favour will certainly win the 2024 elections.

Interestingly OPCC President Sarat Pattnayak claims that Congress will increase its seat number in Odisha Legislative Assembly from 9 to 90. Pattnayak as President of OPCC has faced at least three by-polls in Brajrajnagar, Dhamnagar and Padampur. One may say that the Congress fielded a very weak candidate in Dhamnagar, but the three times MLA Satya Bhusan Sahu was a strong can-



didate in Padampur and he too lost the deposit in the by-poll.

Therefore, it can be easily said that Congress has failed to retain its traditional votes even as there have been frequent changes of guards at the OPCC top post. The party lost in all the six by-polls held since 2019 and Pattnayak's CONTINUED ON: P-7

### At Christmas, Pope urges end to 'senseless' Ukraine war

VATICAN CITY (KCN): Pope Francis on Sunday appealed for an end to the "senseless" war in Ukraine, in his traditional Christmas Day message broadcast

around the world. The head of the Catholic Church addressed thousands of people gathered in St Peter's Square, some of them holding Ukrainian flags, before delivering the "Urbi et Orbi" blessing ("to the city and the world").

A call to peace is traditionally the focus of the pope's message at Christmas, the holiday marking the birth of Christ, which he delivers from the central balcony of St Peter's Basilica and is broadcast live worldwide.

The 86-year-old on Sunday first turned to "our Ukrainian brothers and sisters who are experiencing this Christmas in the dark and cold, far from their homes". "May the Lord inspire us

to offer concrete gestures of solidarity to assist all those who are suffering, and may he enlighten the minds of those who have the power to silence the thunder of weapons and put an immediate end to this senseless war!" he

During one of the initial scenes, Sura asks his allies to list the crimes committed by his son. For some strange reason, the goons start performing a clumsy mime in an attempt to recreate the crimes, without just listing them out. Many such 'innovative' ideas come across as silly humour.

Laththi relies on its lead actort o do much of the

spite showing effort--especially his Moondram Pirai-esque act in the climax that only ends up highlighting his limitations as a performer. Sunainaa is probably the only actor who doesn't give in to the over-the-top tone of the film. She delivers a sensible performance as a doting mother and wife.

Right from the title announcement, it was clear that the film would be about a laththi-happy policeman, and the protagonist tries to do jus tice to the title by charg-

ing at way too many people on screen. But the film doesn't take a clear stand on police brutality. Though there are stretches where Muruganandham dreads executing custodial violence, and mouths preachy dialogues like, "Kandika dhaan na adikanum, dhandika illa!" you also learn that he has always enjoyed beating the criminals to a pulp. The much-hyped fight sequences of this film fee

heavily rushed and the exciting weapon-reveal sequence too is force-fit into a background song Though Laththi tries hard to be an edge-of-theseat thriller, it's not a good sign that you're laughing for most of it.



In today's digital era, where privacy has become a luxury for many, scandalous videos being leaked online is an everyday thing. It's a pertinent, universal subject that has been explored in several films worldwide. With his latest film, Ariyippu, writer-director Mahesh Narayanan also attempts the same by interweaving it with a few other relevant topics like imbalances in marital life, patriarchal conditioning, migration among skilled labourers, and the crumbling economy during the pandemic.

Unlike his previous films, Mahesh has eschewed all the so-called commercial elements in Ariyippu, and as intended, the film has had a successful run in several international festivals across the world. It all started with its world premiere at the 75th Locarno International Film Festival, followed by screenings at the British Film Institute, Busan International Film Festival, IFFI, and IFFK. Despite the successful run at the festival circuit, Mahesh feels that the

'real test' is on December 16, when the film comes out for public viewing on Netflix. "So far, the reception has been great, but unless and until it reaches the common audience, we can't be complacent. December 16 is the D-day."

Mahesh, an editor-turned-filmmaker is known for helming hard-hitting films like Take Off, CU Soon, Malik, and Malayankunju. There's an interesting pattern



to all his films—he borrows inspirations from real-life incidents, craftily blends them with fictitious elements and then sets them in distinctive terrains. Mahesh admits that Ariyippu also germinated from a similar thought. "It was sometime in 2015 during the Take Off days when I accidentally came across this news article about a bank employee in Mumbai approaching the high court about a lookalike video circulating through porn websites. She wanted the judge to issue a declaration stating that she wasn't the same woman. The judge was sarcastic saying that it can't be used as a legal document anywhere. But the woman was determined, and she got it issued. This incident sparked an idea."

When asked about how the pandemic and migrant labour issues came into the picture, Mahesh explains in detail the chain of events that lead to the making of Ariyippu. "A certain incident should affect me, and then I'll let it marinate and travel with me for some time. That's how most of my films are born. This incident of a woman's fight for a declaration stayed with me for long. I initially thought of setting the story in a bank, but changed it later because I'm someone who keeps rewriting my drafts every six months to ensure it stays relevant. During the pan demic, I visited a few factories in Kochi and interacted with the workers there. They were among the first to ring the bell saying that, 'look, there's something ominous coming our way'. They sensed it from the unusually huge quantity of orders and their long work shifts. From there, I also heard stories about how these skilled labourers migrate to other Asian countries like Malaysia, Indonesia and Thailand. They don't take the usual route through Mumbai or Chennai. They move to places like Delhi, where most of the embassies are, live in the city's outskirts, work there for 6-8 months, attend recruitment programmes and then get the paperwork done. I found their journey interesting. What if such a couple with the intention to move abroad are caught in this video scandal and get stuck in an alien environment? How would they cope with it? That was my trigger for Ariyippu."

# Tax Treatment of Unexplained Expenditure-Part 2

4. Some more decisions in favour of Assessee:



a) The AO is not entitled to treat the purchases as bogus merely on the basis of information from the sales-tax department. He has to make independent inquiry, The fact that the vendors did not respond to notices u/

s 133(6) and the assessee did not produce them is not sufficient if the documentation is in order and payments are through banking channels – Geolife Organics v. ACIT [2017] 88 taxmann.com 756 (Mumbai - Trib.)/ [2017] 58 ITR(T) 297 (Mumbai - Trib.). b) Addition cannot be made on the basis of a hand written loose paper which does not indicate if it pertains to the assessee and if AO has not brought on record any forensic evidence to prove the handwriting of the assessee, an addition cannot be made on the basis of suspicion and guesswork and without bringing corroborative material on record -Saamag Developers (P.) Ltd. v. ACIT [2018] 90 taxmann.com 20 (Delhi -Trib.); CIT v. Praveen Juneja ITA No 57/2017 Delhi High Court Order Dated 14.07.2017.

c) An admission of assessee, which is retracted cannot be the basis of addition. The allegations made by the authorities have to be supported by actual cash passing hands. The addition cannot be sustained in the absence of material which would conclusively show that huge amounts revealed from the seized documents are transferred from one side to another and if the Revenue did not bring on record a single statement of the vendors of the land in different villages and if none of the sellers has been Revenue that extra cash has actually changed hands. Where seized documents were not in name of assessee, no action could have been undertaken in case of assessee u/s 153C and further entire decision

being based on huge amounts revealed from seized documents not being supported by actual cash passing hands, additions u/s 69C were not sustainable - CIT v. Lavanya Land Private Limited [2017] 83 taxmann.com 161 (Bombay)/[2017] 249 Taxman 275 (Bombay).

d) Where all purchase transactions with parties were made through account payee cheques and same were confirmed u/s 133(6) proceedings by said parties, addition made on account of bogus purchases was to be deleted - ACIT v. Lumens India [2017] 88 taxmann.com 614 (KolTrib).

e) In the case of CIT, Surat-I v.Tejua Rohit Kumar Kapadia ALP Diary No. 12670/2018 dated 20.06.2018 (SC), Investigation Wing reported that Shri K, who was running shroff business and he in his statement on oath stated that he issued acknowledgment to the beneficiary on receipt of cheque and delivered cash and the assessee was one of the beneficiaries. Purchases of the assessee were duly supported by bills and all the payments were made by account payee cheques. The entire purchases made from the company of Shri Kulwant Singh Yadav were found to have been sold and sales were also accepted by the Assessing Officer. In the absence of evidence to draw the conclusion that the entire purchase consideration which the assessee had paid to M/s. Raj Impex had come back to the assessee in cash, addition on account of purchases cannot be sustained. Similar view has been expressed in **Assistant CIT**, Mumbai v. Haware Construction (P.) Ltd. [2019] 101 taxmann.com 168 (Mumbai - Trib.); Smt. Sudha Loyalka v. ITO, Ward 35 (2), New Delhi ITA 399/DEL/2017 available in <a href="https://">https://</a> indiankanoon.org/doc/116187612/.

Dy CIT 72 taxmann.com 289(Guj) was also considered. Also refer John's Pack v. ITO ITA No 497, 499 & 500/MUM/2017 Order dated 17.08.2017, Kimaya Impex (P.) Ltd. v. Income-tax Officer\* [2022] 136 taxmann.com 117 (Mumbai - Trib.).

b) Similar view has been expressed in case of ACIT v. Akshay Rajesh Samdariya ITA No 2076/PUN/2016 order dated 13-12-2018, wherein it has been held that Assessing Officer during assessment proceedings has not discarded total sales of the assessee. In other words, the sales of the assessee have been accepted by the Department. Without purchases, there cannot be sales. Thus, entire alleged bogus purchases cannot be added in the hands of the assessee. Under such circumstances, the possibility of assessee purchasing the goods from grey market and procuring bills from the Hawala dealers cannot be ruled out. The CIT(A) after considering catena of judgments on various facets including the GP ratio to be applied in different set of industries estimated 3% of GP addition on account of bogus purchases in the hands of the assessee. We find the impugned order is reasoned and hence, requires no interference.

Also refer DCIT v. DBM Geotechnics and Construction (P.) Ltd. [2022] 136 taxmann.com 345 (Mum), Rollon Hardware India Pvt. Ltd., in ITA No. 1621/Mum/2018 order dated 05.11.2018.

6. Decisions in favour of Revenue:

a) Where certain additions were made on account of inflated purchase price and alleged sellers were not traceable and though payments had been made by account-payee cheques, entire amounts so deposited had been withdrawn by bearer cheques, Tribunal was justified in

sustaining addition.- Sanjay Oilcake Industries v. CIT [2009] 316 ITR 274 (Guj).

- 7. Whether money earned abroad can be sufficient basis to make addition u/s 69C: The Madras High Court in the case of R. Kanakammal v. CIT [2000] 244 ITR 152 (Mad.) held that in the absence of any proof of linkage between the funds earned abroad and the amounts spent in India, mere fact that there is proof of earning outside India will be insufficient to hold that the monies spent in India are, in fact, from the amount earned abroad and remitted into India.
- 8. To whom the notice may be issued u/s 69C: Notice u/s 69C, being in the nature of a show cause notice, is issued by the A.O. to those assessees who have incurred certain expenditure during the financial year and the A.O. is of the view that the source of the same is required to be explained by the assessee concerned. The purpose of the notice so issued is to give an opportunity to the concerned assessee to give an explanation as to the source of such expenditure incurred by him during the financial year as may be specified in the notice.
- Consequences of failure to comply with the notice proposing addition u/s 69C: In case the assessee, who is in receipt of a notice u/s 69C fails to appear before the A.O. either personally or through his Authorised Representative or even fails to give the explanation in writing about the source of such expenditure, the A.O. may treat such expenditure as the income of the concerned financial year and bring the same to charge to tax in the assessment of the assessee for the assessment year immediately following that financial year. Similarly the A.O. can make addition u/s 69C even in a case, where the assessee has complied with the notice but the explanation given by him or the evidence produced by him is not satisfactory, in the opinion of the A.O. ( to be contd)

JAMMU: Various measures are in place at the famous Mata Vaishno Devi Shrine atop Trikuta hills in the Reasi district of Jammu and Kashmir to tackle heavy rush of pilgrims and avoid any untoward incident, an official said on Sunday. Shri Mata Vaishno Devi Shrine Board

(SMVDSB) has also issued guidelines for strict adherence to the COVID-19 guidelines as a precautionary measure, the official said.

In a first-ever stampede at the shrine on January 1 this year, 12 pilgrims lost their lives and 16 were injured, prompting the shrine board to intro-

duce Radio Frequency Identification (RFID) as part of various projects sanctioned for the convenience of the pilgrims, better crowd management and tracking of the yatris along the 13-km track and the 'Bhawan' (sanctum sanctorum).

"The shrine is ready to meet heavy rush of devotees around New Year. A strategy has been chalked out to ensure smooth regulation of expected influx of pilgrims, decongestion of entire track, particularly the Bhawan area, and all-time surveillance through CCTV dedicated network of over 500 cameras," a shrine board official said.

He said enforcement teams of the board are being deployed for four days at the Bhawan from December 30 to January 2 to keep an eye on the number of pilgrims to avoid crowding.

The dedicated teams will also ensure that the pilgrims, except those having valid accommodation slips, return to the base camp Katra immediately after having 'Darshan' at the

The official said the shrine board has also identified four holding areas, one each at Katra, Ardhkuwari, Sanjichha and Manokamana area, to accommodate the pilgrims if their number increases beyond the daily limit of 50,000.

Earlier, Chief Executive Officer, SMVDSB

Anshul Garg said the RFID-based yatra registration cards have been started with the focus to enhance not only the security but also ensure real-time tracking of pilgrims on the track en route Bhawan for better regulation of the pilgrims in accordance with the holding capacity of the trek and the shrine area



(Bhawan).

He emphasized that security agencies not allow any pilgrims without a valid RFID card for which additional handheld scanners may be put to use with sufficient staff to plug any shortfall.

On the concern about COVID-19, the official said all the stakeholders have been advised to wear masks while dealing with the yatris.

The shrine board has made wearing face masks mandatory for every pilgrim attending the 'Atka Arti' and in the 'darshan queue', the official said.

On Friday, Chief Secretary Arun Kumar Mehta at a meeting had said there is no need to panic given rising COVID-19 cases in neighbouring countries as no surge has been reported so far in the Union Territory.

However, Mehta enjoined upon the health experts to take preemptive measures so that the administration is fully prepared to meet any contingency. He asked them to activate all the Covid testing facilities so that any person desiring to test finds the facility nearby. He impressed upon them to create ample awareness among the public so that no unnecessary scare is created among them. According to officials, there is currently no bed occupancy related to Covid in the health facilities in the Union Territory.

JOHANNESBURG: The death toll from a fuel tanker explosion in a South African city east of Johannesburg has risen to 15, the health



minister said Sunday.

"Yesterday (Saturday), the death toll was at 10 people and now we are sitting at 15 as of this morning," Joe Phaahla told reporters at Tambo Memorial Hospital.

The tanker, transporting liquefied petroleum gas (LPG), was caught beneath a bridge close to the hospital and houses on Saturday morning in Boksburg, east of Johannesburg.

The minister said three hospital employees, two nurses and a driver, died later from severe burn injuries.

Thirty-seven people were injured, including 24 patients and 13 staff members who were in the hospital's accident and emergency unit at the time of the blast.

They "sustained severe burns and have been diverted to neighbouring hospitals", Phaahla

Others were hit by shattered glass, he added, while some were hurt as they were in the parking lot or in front of the hospital.

"We send our deepest condolences for the families that lost their loved ones," he said.

## hina stands ready to work with India: Chinese Foreign minister Wang Yi

BEIJING: Chinese Foreign Minister Wang Yi said on Sunday that China is ready to work with India for the "steady and sound growth" of bilateral ties and the two countries are committed to upholding stability at the border areas where tensions have prevailed since 2020.

Addressing a symposium on the international situation and China's foreign relations in 2022, Wang said both countries have maintained communication through diplomatic and military-to-military channels.

"China and India have maintained communication through the diplomatic and military-to-military channels, and both countries are committed to upholding stability in the border areas," said Wang, who has been elevated to the ruling Communist Party of China's (CPC) high-power political bureau during the recent party Congress. "We stand ready to work with India in the direction toward steady and sound growth of China-India relations," he said at the symposium. Wang, along with National Security Advisor Ajit Doval, is the Special Representative of the India-China boundary mechanism which has remained dormant in the present set of border standoffs.

In his lengthy address on China's diplomatic work, Wang focused more on China's troubled ties with the US and burgeoning relations with Russia, despite the Ukraine war.

He briefly touched on India-China relations that have been bogged down since April 2020 when China tried to move a large number of its troops to the disputed areas in Easter Ladakh, resulting in a prolonged military standoff.

India blames China of trying to alter 'status quo', Beijing downplays Arunachal border clash

The two countries have held 17 rounds of talks so far to resolve the standoff.

The 17th round of the India-China Corps Commander Level Meeting was held on December 20 during which the two sides agreed to stay in close contact and maintain dialogue through military and diplomatic channels and work out a mutually acceptable resolution of the remaining issues at the earliest, according to a joint press release issued after the talks.

Ever since the once-in-a-five-year Congress of the CPC in October which re-elected President

Xi Jinping for an unprecedented third fiveyear term, speculation is rife about Beijing's future course of India policy, especially in 2023 and whether it will normalise relations and restore stability at the 3,488-km long Line of

Actual Control (LAC) which has been witnessing tensions between the two militaries.

According to observers, this month's clash between Indian and Chinese soldiers at Yangtse in Arunachal Pradesh, barely weeks after Xi began his new term, spelled danger that 2023 too will end up as yet another blank year in the bilateral ties.

Tensions at LAC persist as India, China hold 17th round of high-level talks, first since Tawang clash It was the first major clash between the Indian and Chinese armies since the fierce face-off in the Galwan Valley in June 2020 that marked the most serious military conflict between the two sides in decades.

The ties between the two countries froze since then, with India making it clear that peace and tranquillity at the border is the sine qua non for the overall development of bilateral ties.

The PLA's move at Yangtse taking place after the completion of disengagement from many friction points was seen as the reflection of the dilemma prevailing in the Chinese political and military ranks on how to deal with India which is on political ascendency internationally.

In his address on Sunday, Wang spoke about China's opposition to "bloc confrontation".

Beijing has been opposing the formation of the Quad alliance comprising the US, India, Australia and Japan, as well as the AUKUS alliance of the US, Australia, and the UK.

China claims that such blocs are aimed at con-

The BRICS (Brazil, Russia, India, China, and South Africa) has become the most influential platform for South-South cooperation.

A host of emerging markets are taking great

strides to catch up in terms of global governance, turning from followers to forerunners, he said. In his address, Wang also briefly touched on China's ties with Pakistan, saying the two countries have "continued to firmly support each other, uphold the invaluable all-weather strategic partnership, and consolidate the iron-clad friendship". On the China-US ties, which continued to witness turbulence, Wang said, "we have firmly rejected the United States' erroneous China policy and have been exploring the right way for the two countries to get along with each other".

"As the United States has stubbornly continued to see China as its primary competitor and engage in blatant blockade, suppression and provocation against China, China-US relations were plunged into serious difficulties," Wang said.

On the Taiwan issue, Wang said China has not been intimidated by US bullying.

"We have not been intimidated by any hegemonic power or its bullying, and have acted resolutely to safeguard China's core interests and national dignity," he said.

He, however, spoke highly about the development of China-Russia ties, notwithstanding Moscow's involvement in the Ukraine war.

"We have deepened good-neighbourliness, friendship and cooperation with Russia, and made China-Russia comprehensive strategic partnership of coordination more mature and resilient," Wang said.

"Over the past year, China and Russia have firmly supported each other in upholding respective core interests, and our political and strategic mutual trust has been further consolidated," he said.



mass-scale for farmers of Odisha.

Additional chief secretary, Forest, Environment and Climate Change department Mona Sharma inaugurated the two facilities on the RPRC premises in presence

PCCF and RPRC chief executive Pusazhule Mekro, senior scientist Nihar Ranjan Nayak and other delegates. Set up at an investment of Rs 4 crore with the help of Agriculture department, the Orchid Cultivation and Breeding Centre will be a platform for the floriculture farmers to know about orchid and the new technologies used in its farming. Besides, it will also help RPRC scientists undertake ies from the existing species in the country, that can be supplied to the farmers.

The newly inaugurated facility has three orchid cultivation chambers in which lowcost technology has been adopted for cultivation of three varieties of Dendrobium (Earsakul, Singapore White, and Sanan

White). Around 300 different orchid species and cultivars have also been collected by the RPRC for development of new hybrids at the breeding centre.

On the other hand, the Tissue Culture

Production facility, set up by the Forest department at a cost of Rs 3 crore with support from the centre under Rashtriya Krishi Vikas Yojana, will help produce around 5 lakh banana saplings using tissue culture technology for farmers of the state. The facility has already been approved by the National Certification System for Tissue Culture Raised Plants (NCS-TCP) under Centre's Biotechnology department.

## Buoyant tax collections cushion Govt on fiscal front, ITR reforms likely next year

NEW DELHI: Riding on the back of a 26 per cent surge in tax collections, the government is set to unveil the next set of reforms in tax administration by pruning the number of forms available for filing Income Tax Return (ITR) to improve taxpayers' experience and reduce the time taken to file returns. Both direct and indirect tax collections have been buoyant in 2022, a clear indication of the revival of the economy after the pandemic and also as a result of government efforts to plug tax leakages. Going forward, as it seeks to tighten the noose around evaders, the government may also look at stricter tax deduction norms for e-commerce and online service providers, besides online gaming.

Taxation of the digital economy, ensuring developing countries get their fair share of taxes and global coordination for taxation of cryptocurrencies would be one of the priority areas as India is all set to host the leaders of G-20 countries next year.

The rationalisation of long-term capital gains tax structure is also expected to bring parity in the holding period between similar asset classes. Currently, shares held for more than one year attract a 10 per cent tax on long-term capital gains. Gains arising from the sale of immovable property and unlisted shares held for

more than 2 years and debt instruments and jewellery held for over 3 years attract 20 per cent long-term capital gains tax.

Some tweaking in the new tax regime is also expected next year as the government wants to make the exemption-free tax regime more attractive to individual income taxpayers. In the longer run, the government wants to do away with the complex old tax regime by establishing a new system, devoid of exemptions and deductions.

Moving in that direction the government in Union Budget 2020-21 gave the option to taxpayers to choose between the old regime with various deductions and exemptions and the new tax regime that offered lower tax rates without exemptions and deductions.

Even after two years of it coming into effect, the new tax regime has not taken off and the I-T department is now considering some tinkering with it so that more taxpayers shift to it. The gross collection of direct taxes (before adjusting for refunds) till December 17 of the current fiscal year stood at Rs 13.63 lakh crore, a rise of 26 per cent over the same period of 2021-22 on robust growth in advance tax payment and TDS deductions.

After adjusting for refunds, the net collection of tax on corporate and individual earnings has jumped nearly 20 per cent to Rs 11.35 lakh crore, which is about 80 per cent of the full-year budget target.

The tax authorities are working on a common ITR form for most taxpayers and the forms (ITR-1 and 4) for individual taxpayers will continue. The taxpayers filing ITR-1 and ITR-4 will get an option to choose which form they want while filing their tax returns - the proposed common ITR form or the existing one.

Currently, there are 7 types of income tax return (ITR) forms which are filed by different categories of taxpayers. Rising tax revenues also give a cushion to the government on the fiscal front as it more than makes up for the shortfall in the budgeted disinvestment target set for the current fiscal year. Nangia Andersen LLP Partner Sandeep Jhunjhunwala said this budget is unique being the post-COVID-19 recovery budget and the last full-year budget from the second term of the current government ahead of the Lok Sabha elections to be held in 2024.

"As the disparity between the personal tax rates and corporate tax rates has widened over the years, it would only be fair if the grief of the common man is allayed and the overall personal taxation system for individual taxpayers is made more sparing. This would indirectly help the government widen the tax collection net by paving way for increased voluntary

The completion of half a decade of the GST regime was significant as the compensation paid to states for revenue loss ended this year and also the term of the National Anti Profiteering Authority (NAA) ended with its job getting transferred to antimonopoly watchdog Competition Commission of India (CCI).

GST collections, which are a barometer of the economy's performance, have been showing improving signs and are stabilising around Rs 1.4 lakh crore on the back of a vibrant economy.

As the government stepped up compliance checks and data sharing among departments, the tax revenues have improved over the year and this fiscal is likely to exceed the budget target of Rs 27.50 lakh crore by about Rs 4 lakh crore, helping the government to keep its fiscal deficit in 2022-23 within the budgeted level.

Keeping a hawk eye on the areas which can garner more taxes, the government this year brought in a 30 per cent tax on transactions in virtual digital assets or cryptocurrencies. Also to establish the money trail, a 1 per cent Tax Deducted at Source (TDS) too has been brought in. This tax has somewhat dampened investor sentiment in highly

Moscow.

However, he has been criticised in some quarters for not being more explicit in blaming Russian President Vladimir Putin.

In a magazine interview published last month, the Argentine pontiff denounced the cruelty of Russia's troops in Ukraine, drawing a formal protest from Moscow.

On Sunday, the pope also urged those celebrating Christmas to remember those "who go hungry while huge amounts of food daily go to waste and resources are being spent on weapons".

"The war in Ukraine has further aggravated this situation, putting entire peoples at risk of famine, especially in Afghanistan and in the countries of the Horn of Africa," he said.

"We know that every war causes hunger and exploits food as a weapon, hindering its distribution to people already suffering.

"On this day, let us learn from the Prince of Peace (Christ) and, starting with those who hold political responsibilities, commit ourselves to making food solely an instrument of peace."

Meaning of Christmas

On Saturday evening, the pope led the traditional Christmas Eve mass at St Peter's Basilica, using a wheelchair as he continues to struggle with knee pain.

He prayed for "the children devoured by wars, poverty and injustice" and lamented that "men hungry for power and money swallow up their loved ones, their brothers".

He called on people to "abandon the warmth of worldliness" and "rediscover the meaning of Christmas" in the face of "consumerism", advocating for a Church that serves the poor.

The Vatican put the crowd Sunday at 70,000, while 7,000 people attended Saturday evening's mass, with more following the service on screens outside. "It's very inspiring to be here with all these people," Victoria Machado, who travelled with her family to the Vatican from Mexico, told AFP.

"We're happy and moved to see the pope, even if we're outside, and to feel this connection between each other," the 19-year-old added.

Julie, a 50-year-old who manages a business in France, said the pope was a "very humble man, I think he's capable of offering a message of peace and trying to unite people and ease tensions".

Also, the 'windfall profit tax' was introduced to tax 'above-average profits' earned by the domestic oil and gas companies after crude prices skyrocketed following the Russia-Ukraine war.

To tax the above-normal profits earned by upstream oil companies, India imposed a windfall tax on oil producers in July 2022 and reviews it every fortnight.

Besides, the concept of updated returns has been introduced this year to enable taxpayers to disclose omitted income and correct mistakes made in income tax returns within a two-year window.

An additional 25 per cent on the due tax and interest would have to be paid if the updated ITR is filed within 12 months, while the rate will go up to 50 per cent if it is filed after 12 months, but before 24 months from the end of relevant Assessment Year. KPMG in India Partner Indirect Tax Abhishek Jain said the forthcoming year will be an exciting one for indirect taxes with the much-awaited new Foreign Trade Policy and the DESH bill expected to be launched.

claim of 9 to 90 appeared to be just a slogan and nothing more than that. Political Pundits do not see a future for Congress as its leaders and workers are in a demoralized state.

Insiders said that the BJD has already set a separate strategy on how to maximize Congress votes to its kitty and at the same time ensure that the BJP do not gain from the weakening of the country's oldest party. The BJD has adopted the similar approach of BJP which was implemented by Saffron Political Master Strategist, Amit Shah in Assam. Himanta Biswa Sarma is now the BJP's Chief Minister in Assam and. He was a strong aide of former Congress CM Tarun Gogoi. However he was roped in to the Saffron Brigade and his acumen helped in installing BJP Government in 2016. With help of Sarma, the BJP brought down Tarun Gogoi's 15 years rule from 2001 to 2016 and installed the Sarbananda Sonowal government. In the 2021 elections in Assam Sonowal was sent to centre and Sarma became the Chief Minister. Assam is a classic example of BJP poaching Congress leaders and thus bringing down its government.

However, Shah's formula is unlikely to become beneficial for BJP in Odisha as the saffron party realized the importance of Congress votes very late. The BJD has already taken many Congress leaders to its fold and they now come handy for the party to bring votes from the oldest party. Odisha's health minister Naba Kishore Das for instance was instrumental in the victory of BJD candidate Barsha Singh Bariha in Padampur. As a former Congress stalwart in the region, Shri Das knows who are the vote catchers for their party in Padampur area.

He first convinced the grass root level Congress leaders that voting for their party candidate will instead help the BJP candidate Pradip Purohit. For remaining out of power for two decades, many Congress leaders have changed their party affiliation, shifted to either BJD or the BJP. It is very easy for the BJD to motivate Congress supporters to cast their votes to conch symbol in order to oust BJP. This apart, being in power in the state, BJD also assured many Congressmen of help in different ways.

Nobody can deny that the Congress has a certain percentage of votes in each assembly segment and they will play a vital role in the ensuing 2024 elections. BJP candidate in Padampur assembly segment Pradip Purohit, who is considered as a strong leader having a mass base, in his first reaction claimed that the victory of BJD was surprising for him. He claimed that Barsha won as the BJD purchased Congress votes. Hence, there should be no doubt that Congress votes decide the fate of candidates in the assembly elections.

Therefore, both the BJD and BJP have been eyeing on the Congress vote as they may be a deciding factor. BJD and BJP are fighting almost near zone but the party which gets a major share from Congress's fixed votes, will win the 2024 elections. Two MLAs – Suresh Routray and Mohammad Moquim-have now been served with show cause notices by the OPCC for uttering words on transfer of Congress votes to BJD. The Congress leadership may not admit it openly, but the fact remains that the party votes are being transferred either to the BJD or the BJP.

Can Congress leaders retain the party's vote share in 2024? They may give slogans like 9 to 90 seats, but the ground reality is something else. Congress can be 'King Maker' in 2024 if it retains its vote. But, nobody knows how much the Congress workers and supporters at ground level resist the onslaught of BJD and the BJP. Many Congress leaders in strategic zones like Coastal and Southern Odisha are being targeted by BJD to be roped in before elections. Like Naba Kishore Das they will be playing a key role in strengthening vote banks of the regional party. Time will tell, whether Congress becomes a 'King Maker' or exposes itself for sale in the electoral market as alleged by two veteran Congress lawmakers. So, all eyes are on Congress votes.
