ICAR-CIFRI celebrates world soil day

Kolkata(KCN): ICAR-CIFRI celebrated 'World Soil Day-2022' on Monday (December 5, 2022) with the theme 'Soils: Where the food begins' by inviting eminent scientists and professors of soil science, and 50 farmers.

Dr. B.K Das, the Director of the Institute emphasised on the need of balanced use of manures, fertilisers, other chemicals and maintenance of soil health towards achieving sustainable production. As Guest-of-Honour Dr. J. C. Tarafdar, former National Fellow and Principal Scientist, ICAR-CAZRI delivered a highly informative lecture on 'Nanofertiliser: Key Player for Global Food Production' in which he narrated with experimental results how the nanofertilisers could be highly effective in terms of enhanced nutrient use efficiency, increased crop yield, reduced expenditure and less environmental pollution.

Dr. R. K. Basak, retired Professor, Bidhan Chandra Krishi Viswavidyalaya (BCKV) and the Chief Guest of the programme spoke on the farmers who came here from different districts of West Bengal and are engaged in farming as well as aquaculture. He stressed upon the immediate need of applying organic matter in the form of FYM, compost, vermi-compost, poultry manure and other possible sources to improve the soil health which detoriated over the years in most parts of the county due to continuous use of inorganic fertilisers. He, however, cautioned about the form and the dose of the manures to be applied to get the desired result. Prof. Basak also discussed the management of pond soils and emphasised the need of soil and water testing before adopting any remedial measure. On the occasion ICAR-CIFRI distributed Water and Soil Health Cards with the recommendation of the measures to be taken to maintain the water quality and soil health to the managers of the eight wetlands in West Bengal viz. Moyna (Purba medinipur district), Khalsi & Bhomra, (Nadia District), Akaipur, Duma, Chamta, Sindrani & Beledanga (North 24 Parganas district).

The farmers also participated in the discussion followed by a presentation and cleared their doubts.

At her debut concert, Qala is upstaged by a talented young singer named Jagan (Babil Khan). Urmila takes the scrawny orphan under her wing, welcoming him into their home and sowing the seeds of bitter rivalry in the girl's head. In the present timeline, we see Jagan returning to Qala in haunting flashes. Is he a wraith, a dream, a product of her own troubled, guilt-ridden mind? We're watching a mental health movie—at least this much is

feeling of staging a spooky ghost story. Like Bulbbul, Qala is beautifully assembled and shot. A lone boat gently drifts along an inky river, swathed in the moonlight. There are gargoyles and gramophones. The Howrah Bridge-the most clichéd of Calcutta images—is seen under construction. The frames are exceedingly prettyoverwhelmingly so. At one point, I was so lost in admiring the intricate traceries on Qala's bedroom wall and the lively interplay of harsh and soft shadows that I pened more than once. The design of Qala, after a point, starts distracting from its substance. The film is also heavy by way of metaphor, all mazes and moths and mercury.

History gently ruffles the curtains of this vintage world. A star performance is thinly attended because Mahatma Gandhi is in Shimla. "An artist has no caste," Urmila assures an impresario. companies is collected, processed and stored for single use. It is often never reused. This can be numerous nearly identical images stored in Google Photos or outdated spreadsheets from a company that will never be used again, or useless sensor data from the Internet of Things - this is known as dark data. The energy that this "dark data" requires keeps an individual grounded in reality. Data that is stored but never used again takes up space on servers, which are often huge banks of computers housed in warehouses. These computers and storage consume a lot of electricity. Therefore, pollution is increasing due to this obscure unused data. While most climate protection activists focus on reducing emissions from the automotive, aerospace and energy industries, digital computing is already on par with these industries and growing. It is expected that digitization would account for 5% of global greenhouse gas emissions by 2023. The production of digital data is increasing rapidly; The world is expected to generate 100 trillion gigabytes of data this year.Could almost double to 200 trillion gigabytes by 2025, according to environmental studies. As a result, it is surprising that reducing the digital carbon footprint of organisations has received little attention. To reduce this footprint, the idea of ??"digital decarbonization" is introduced. This does not mean using phones, computers, sensors and other digital technologies to reduce a company's carbon footprint. Rather, it refers to reducing the carbon footprint by deleting own digital data which is no longer required. To illustrate the magnitude of the dark data situation, data centers they have a larger carbon footprint than the airline industry. A typical data-driven company like insurance, retail, or banking with 100 employees could generate 3,000 gigabytes of dark data per day. If they kept that data for a year, it would have a carbon footprint similar to six flights from Mumbai to Chicago. Any files stored in Apple iCloud or Google Photos contribute to digital carbon footprint. One can reduce dark data production and contribute to the digital decarbonization movement by removing unwanted stored data.

Philippine Lawmakers propose USD 4.9 bn Kisan Congress chief writes to PM sovereign wealth fund chaired by Marcos Modi, says Centre 'betrayed' farmers

MANILA: Philippine lawmakers have proposed a \$4.9 billion sovereign wealth fund to be chaired by President Ferdinand Marcos Jr to boost growth, but critics warn it will be prone to graft and risk Filipino pensions.

Congressmen Sandro Marcos and Martin Romualdez -- the president's son and cousin respectively -- are among the six authors of the bill



filed to the House of Representatives and will be examined by several committees before being debated in the house.

The "Maharlika Investments Fund" (MIF) would be seeded with 275 billion pesos from government financial institutions, including two pension funds and two banks, according to the latest version of the bill.

It would help the Marcos administration achieve its goals of getting the Philippine economy to "soar to greater heights in spite of external shocks," the authors wrote.

The word "maharlika" is widely associated with Marcos Jr's late dictator father and namesake, who presided over widespread human rights abuses and corruption during his two decades in power. He was ousted in 1986.

Marcos Sr claimed to have led an anti-Japanese guerrilla unit called Ang Mga Maharlika during World War II, but he has been accused of lying about his war record.

The MIF has been met with concern from business groups, economists, activists and opposition figures, who have questioned the need for a sovereign wealth fund in the debt-laden country. They argue pension funds were already being invested and that diverting them to the MIF would expose them to additional risk. Even the president's own sister, Senator Imee Marcos, said it was "risky to gamble" retirement funds.

"We all know about our neighbour Malaysia where their 1MDB was a real disaster where the money was looted," she said, referring to the graft scandal that involved billions of dollars of state funds.

A lack of safeguards also meant "the potential for corruption is almost limitless," Vincent Lazatin, former executive director of the Transparency and Accountability Network, told AFP Tuesday.

ALSO READ Indonesia's Parliamentcriminalises adultery, cohabitation of unmarried couples 'A lot of questions' The bill's proponents highlighted Indonesia as an example of a sovereign wealth fund successfully being used to attract direct investments into infrastructure and emerging industries. But Natixis senior

economist Trinh Nguyen said Indonesia's fund has a "very clear" investment objective, while the Philippine proposal "lacks a direction."

"There are a lot of questions... How is it going to benefit the longer-term development objective of the Philippines because it's not very clear to me that it would," she said.

Under the proposed bill, MIF funds would be "exempt from any regulatory restrictions."

Investment options would include financial derivatives, equities, infrastructure projects and "other investments as may be approved by the Board."

Congressman Joey Salceda, who leads the technical working group examining the bill, told AFP the fund's governing board would be chaired by the president.

Former president Gloria Arroyo, who has backed the bill, said it was a "powerful statement that the highest official of the land will hold himself as ultimately accountable to the Filipino people for the performance of the Fund."

But Lazatin noted that the country had a dismal record of punishing elected officials for corruption. "Our laws are good on paper, but in practice...we have not been able to hold public officials accountable," he said. An estimated \$10 billion was stolen from state coffers over the course of Marcos Sr's rule, while the family has been accused of owing more than \$3.6 billion in estate taxes. No one in the clan has been jailed.



BRUSSELS: The European Union reached an agreement Tuesday to ban the import of products including coffee, cocoa and soy in cases where they are deemed to contribute to deforestation.

The draft law, which aims to ensure "deforestation-free supply chains" for the 27nation EU, was hailed by environmental groups as "groundbreaking."

It requires companies importing into the EU

The European Union is the second-biggest market for the consumption of targeted products after China.

Pascal Canfin, chairman of the European Parliament's environment committee, hailed the agreement, and how its impact would feed through to everyday items Europeans consume.

"It's the coffee we have for breakfast, the chocolate we eat, the coal in our barbecues, the paper in our books. This is radical," he said.


