Bhubaneswar (KCN): A special education needs (SEN) has been inaugurated in KiiT International School on 12th December 2021.








NEW DELHI(KCN): Taking a swipe at previous regimes, Prime Minister Narendra Modi said on Sunday that his government believes in solving problems and not avoiding them. He said this while speaking at a function on the theme "Depositors First: Guaranteed Timebound Deposit Insurance Payment up to Rs 5

Observing that any country can save the problems from getting worse only by their timely resolution, the Prime Minister said that for years there was a tendency to avoid problems. "Today's new India strives for solving problems, today India does not avoid problems,"

There was a time when depositors would have to wait for their own money for ages from the



stressed bank, he said, adding that the government by amending laws has made it mandatory for refund up to Rs 5 lakh of their deposits within 90 days of imposition of moratorium or restrictions.

Recalling his days as chief minister of Gujarat, Modi said, he had to deal with so many depositors but could not do much for them.

> Government of India then about the plight of such hapless depositors and requested for raising deposit insurance cover to Rs 5 lakh from Rs 1 lakh. However, the previous regime ignored it, Modi said, adding, "the then government did not listen to people so they

changed the government and brought me as the Prime Minister.

I raised the deposit insurance cover in the interest of people".

Deposit insurance up to Rs 5 lakh covers all deposits such as savings, fixed, current and recurring deposits in all commercial banks. Deposits in state, central and primary cooperative banks, functioning in states and Union Territories are also covered.

With a deposit insurance coverage of Rs 5 lakh per depositor per bank, the number of fully protected accounts at the end of the previous financial year constituted 98.1 per cent of the total number of accounts as against the international benchmark of 80 per cent.

Last year, the government increased the insurance cover on deposits by five times to Rs 5 lakh.

The enhanced deposit insurance cover of Rs 5 lakh came into effect from February 4, 2020. Every bank used to pay 10 paise as an insurance premium per Rs 100 of deposit.

It was raised to 12 paise per Rs 100 in 2020. It cannot be more than 15 paise at any point in time per Rs 100 deposit. continued on: P-7

# On the occasion of 50th Anniversary of Bangladesh Liberation

Kolkata(KCN): As part of celebration on the occasion of 50th Anniversary Bangladesh Liberation, BSF has been organising a series of events (jointly with Bangladesh) on the Indo-Bangladesh border. In this connection, a 'Joint Cultural Programme' is going to be organized at ICP Dawki under BSF, Meghalaya Frontier on December 13, 2021 in which Mukti Yodhas, historians and eminent speakers from both the countries will participate.

India's relation with Bangladesh dates back to 'Bangladesh Liberation War of 1971', during which India provided extensive aid, training and shelter for the exiled government of

Bengali nationalist Mukti Bahini guerrilla force that was fighting the Pakistani Army and about 8 to 10 million refugees poured into India during 1971.

Bangladesh and

At the outbreak of the Indo-Pakistani War of 1971, the Joint Force including regular army of Bangladesh, Mukti Bahini and the Indian Military liberated the then East Pakistan, leading to the establishment of Bangladesh. India's role in the independence of Bangladesh led to the development of strong bilateral relations between both the countries. The relations were further cemented with the signing of the 'India-Bangladesh

Treaty of Friendship,

Cooperation and Peace' a 25-year treaty that was signed on 19 March 1972 forging close bilateral relations between India and the newly established state of Bangladesh. The treaty was also known as the Indira-Mujib Treaty, named after the signatories of the treaty.

Border Security Force, though still in its infancy stage in 1971, got involved in the Bangladesh Liberation War as soon as the genocide by Pakistanis started in what was then East Pakistan. The BSF not only lived up to its mandated wartime role of being the "first line of defence" but also proved its mettle in offensive operations. Before the outbreak of war, on December 3, 1971, BSF trained and coordinated operations of the Bengali guerrillas of the Mukti Bahini. Aggressive shelling of West Bengal's Hili border areas by the BSF's 77 Battalion in April 1971 forced the Pakistanis to show flag and request for truce. Later in November 1971, the unit launched an attack and captured the enemy BOP at Khanpur.

Slogans of "Long Indialive Bangladesh friendship" resonated in the air when troops of the battalion entered Rajshahi in East Pakistan, forcing Pakistanis to retreat. The 83 Battalion BSF fought off two fierce attacks by the Pakistanis at Killapara in West Garo Hills in May 1971. Their valour denied the enemy control over strategic Dalu-Tura road. Similar acts of bravery were displayed by troops of 84, 85, 86, 87, 92, 93 and 104 battalions Meghalaya, Silchar (south Assam) and Tripura sectors against the regular

Pakistani army.

The BSF thus played a very important role in the 1971 Liberation War of Bangladesh right from the beginning and fought shoulder to shoulder with the Indian Army. Twenty-three BSF units were deployed under the Army's operational control and they displayed their metal in both defensive and offensive actions against enemy positions independently, as well as in conjunction with the Army. The important role played by BSF in many other fields like collection and dissemination of accurate information, assistance to the Army in familiarization of area, etc, were of vital importance for operations.

India and Bangladesh share a 4096 Km long International Border, the fifth-longest land border in the world which is manned by Border Security Force in India side and Border Guard Bangladesh in Bangladesh side. It is also considered to be one of the most peaceful International Border as both the countries ensure to maintain good relations which are reflected during the various levels of flag meetings of the border guarding forces of the two nations.



# Stay of Income Tax Demand Part 3

Narayan Jain

(Contd from earlier articles published on 29.11.2012and 6.12.2021)

- 23. Extension of time for payment of demand or for payment in **instalments:** As per section 220(3), an assessee can make an application to the Assessing Officer (A.O.) before due date for the payment of demand for extension of time or he can also apply for payment of demand in instalments. On receipt of such application A.O. may grant extension of time for payment of demand or he may allow the payment of demand in installments subject to the conditions as he may deem fit. In case the relief is to be denied, the principles of natural justice would require that an opportunity of hearing be given to the assessee - Kuku Rice Mills v. Assessing Authority-cum- I.T. Authority [1992] 196 ITR 326 (P&H).
- 24. Application for stay of payment of disputed tax demand: The assessee should write to A.O. in case he has filed an appeal, requesting him not to treat him in default. The petition for stay u/s 220(6) should be well formulated keeping in mind the following points:
- a) The petition should state the prima facie merits of the appeal. The test of merit of appeal lies much upon the grounds of appeal, which should be strong enough.
- b) The hardship involved in the recovery of the disputed demand should be clearly and precisely stated. The petition should state why and how the balance of convenience is in favour of the stay, e.g., bad effect on the liquidity position of the business, jeopardy of the employment of employees through possible closure of business and possibility of dead-lock in wage payment etc. as the case may be.
- c) Copy of the grounds of appeal as well as statement of facts should accompany the petition to show the prima facie merit of the appeal.

Further this petition should be submitted before A.O. within 30 days of receipt of demand notice.

Section 220(6) empowers the A.O. not to treat the assessee in default and allow stay for payment subject to the conditions, which he may impose. For

example, he may ask for part payment of disputed demand or may allow payment by instalments. CBDT has also issued Instructions as discussed in next para.

The Calcutta High Court in the case of Gouri Shankar Awasthi v. ITO 78 ITR 784 (Cal.) has held that stay of realisation cannot be granted simply because an appeal has been preferred. In Pawan Kumar v. ITO [1998] 146 CTR (P&H) 152 it was held that the ITO is required to afford an opportunity of hearing to assessee and pass a speaking order while deciding the application filed by the assessee u/s 220(6) - World Vision India v. Commissioner of Income-tax, (Exemptions), Chennai [2018] 89 taxmann.com 193 (Madras).

In M.L.M. Mahalingam Chettiar v. Third ITO [1967] 66 ITR 287 (Mad.) it was held that the discretion vested in the ITO u/s 220(6) is not merely a naked and arbitrary power but a power coupled with a responsibility and the concerned officer should take all the circumstances into account and all the considerations that could be urged or are urged by the assessee as to why he should not be treated 'as not being in default', and then make such order as is appropriate to the facts of the case.

In Prem Prakash Tripathi v. CIT [1994] 208 ITR 461 (All.) it was held that the CIT(A) is also vested with the powers of granting stay order, which is not only necessary but expedient for effective adjudication of appeal.

If the amount mentioned in notice of demand is neither paid within the time or within the time extended u/s 220(3) nor any action is taken for stay of demand u/s 220(6), the assessee shall be deemed to be in default.

The CBDT has issued guidelines on stay of demands disputed in appeal as discussed in next para.

**25. CBDT Guidelines for granting of stay of demand:** CBDT vide its Office Memorandum No. F.NO.404/72/93-ITCC, dated 31-7-2017 has modified its earlier Instruction and directed that in order to streamline the process of grant of stay and standardize the quantum of

lump sum payment required to be made by the assessee as a pre-condition for stay of demand disputed before CIT (A), the following is extract of modified guidelines have been issued in modification of Instruction No. 1914:

- (A) In a case where the outstanding demand is disputed before CIT (A), the assessing officer shall grant stay of demand till disposal of first appeal on payment of 15% (20% vide Office Memorandum No. F. NO. 404/72/93-ITCC, dated 31-7-2017) of the disputed demand, unless the case falls in the category discussed in para (B) hereunder.
- (B) In a situation where,
- a) the A.O. is of the view that the nature of addition resulting in the disputed demand is such that payment of a lump sum amount higher than 20% is warranted (e.g. in a case where addition on the same issue has been confirmed by appellate authorities in earlier years or the decision of the Supreme Court or jurisdictional High Court is in favour of Revenue or addition is based on credible evidence collected in a search or survey operation, etc.) or,
- (b) the A.O. is of the view that the nature of addition resulting in the disputed demand is such that payment of a lump sum amount lower than 20% is warranted (e.g. in a case where addition on the same issue has been deleted by appellate authorities in earlier years or the decision of the Supreme Court or jurisdictional High Court is in favour of the assessee, etc.), the A.O. shall refer the matter to the administrative Pr. CIT/CIT, who after considering all relevant facts shall decide the quantum /proportion of demand to be paid by the assessee as lump sum payment for granting stay of the balance demand.
- (C) In a case where stay of demand is granted by the assessing officer on payment of 20% of disputed demand and the assessee is still aggrieved, he may approach the jurisdictional administrative Pr. CIT/CIT for a review of the decision of the assessing officer.

- (D) The A.O. shall dispose of stay petition within 2 weeks of filing of the petition. If a reference has been made to Pr. CIT/CIT under para 4 (B) above or a review petition has been filed by the assessee under para 4 (C), the same shall also be disposed of by the Pr. CIT/CIT within 2 weeks of the A.O. making such reference or the assessee filing such review, as the case may be.
- (E) In granting stay, the A.O. may impose such conditions as he may think fit. He may, inter alia,-
- (i) require an undertaking from the assessee that he will co-operate in the early disposal of appeal failing which the stay order will be cancelled;
- (ii) reserve the right to review the order passed after expiry of reasonable period (say 6 months) or if the assessee has not co-operated in the early disposal of appeal, or where a subsequent pronouncement by a higher appellate authority or court alters the above situations;
- (iii) reserve the right to adjust refunds arising, if any, against the demand, to the extent of the amount required for granting stay and subject to the provisions of sec. 245.
- 26. Whether stay of demand can be granted for an amount lower than 20% of demand or without paying any demand: it has been held in the case of Jagdish Gandabhai Shah v. Pr. **CIT [2017] 81 taxmann.com 45 (Guj.)** that payment of 15% (now amount prescribed by CBDT is 20%), tax is not a pre-requisite for making stay petition or granting stay. It was held in the case of Flipkart India Private Limited v. **ACIT** [TS-97-HC-2017(KAR)] that, where payment of 15% (now 20%) will cause genuine hardship and the assessment made by the A.O. is an high pitched one, the Pr. CIT may grant stay without paying any demand or paying a lower sum. Also refer: Suresh Anuradha v. CIT [2020] 115 taxmann.com 73 (Mad).

### Kolhi, the Cricket Legend: Still scripting the History

Taking on the mantle of ODI captaincy from MS Dhoni back in 2017, Virat Kohli was equally competent and one of the most



successful captains in the history of Indian cricket, To the shock of his myriad fans, Kohli, on 8th December (2021) was sacked from the ODI captaincy as Rohit Sharma was assigned the ODI captainship. Kohli, in fact, he had

expressed his desire to continue leading the 50 over side until the 2023 World Cup. But the selection committee and the BCCI were determined in handing over the baton to Rohit. Kohli had earlier given up Team India's T20I captaincy following India's debacle in the 2021 T20 World Cup.

Although India failed to win any major ICC tournament under Kohli, he nonetheless registered some astonishing numbers in his captaincy carrear. Out of 95 ODIs that Kohli captained, India won 65 matches, lost 29, tied in 1 match and 2 No Result games with a staggering high win percentage of 70.43.

His win-loss record in the 50 over format was only behind Ricky Ponting (Australia), Cronje (South Africa) and Clive Lloyd (West Indies). As a batter he had the best average for any captain who scored a 1000 plus runs. In terms of centuries as a captain he was only behind Ricky ponting. He had scored 5449 runs as a captain at an average of 72.65 with strike rate of 98.28 with 21 centuries and 27 half centuries.

Kohli was out there, brash. He is every young Indian's dream boy. He showed the world what aggression is, take on anybody you feel like and be self-confident about it and that's why people loved him. Every youngster who watched the sport wanted to be a Kohli because 'I am in everybody's face' and then he matched it with his skills in batting which was the beauty.

So, what really drove Virat Kohli as a captain and made him unique? He was a natural leader who is driven by his own excellence and tough, immaculate work ethic — the much talked about yo-yo test results of the past that ended a few illustrious careers. He is a competitor to the core, who wants to win, win and only win. Cricket observers have noted that Kohli had also departed from the image of the gentleman's game,

an image of Indian cricketers of the past – an image that began to change with Sourav Ganguly, when he famously waved his shirt at Lord's balcony. Former England skipper Nasser Hussain has revealed that most players don't like to play against him as he gets under the skin of the opposition, again something that Ganguly used to do in his time. Kohli's on-field behavior has perhaps been talked about just as much as his batting and captaincy. He is also a skipper that opposition fans love to hate, but that doesn't bother him. His extroverted expression and nature on the field seems perfectly suited for the TV cameras as they put on him when an opposition wicket falls, or a catch goes down, he lets the world know exactly how he feels about it.

Virat Kohli's unrelenting intensity on the field is infectious on the other teammates. He fired up his team with his exuberant energy and youthful dynamism to many dramatic wins in recent times. He transformed the atmosphere within the dressing room and made it more confident and determined in its desire to triumph. With a sharp focus, Kohli knew exactly where he was going with his team. Back in 2015 he had declared: "I want this to be the fittest

team, I want us to be the greatest team on the planet, knowing that we can play away from home, knowing we can beat anyone and it's going to take a very good bowling attack to do so."

Definitely Kohli deserves some credit for his tunnel vision and firry leadership. He is as much a chest-thumping leader of men, as an orthodox traditional cricket captain, who quietly makes the strategy from the covers region. And his attacking and aggressive brand of leadership will remain his greatest legacy. Today India, as a team, across the three formats, stands superb and looks destined to dominate world cricket for a long period of time to come, thanks to Kolhli's contribution and consolidation. And now with the monkey off his back by not having the burden of captaincy in ODI, T20 format one can expect he will play freely, dominating cricket which he is known for. He was and will remain always a fighter despite one's likes or dislikes – there can be no disagreement on that. He will be crafting history of Indian Cricket for many more years! Best Wishes Kohli and Best of luck Indian Cricket!

LUCKNOW(KCN): Varanasi, the land of holy Ganga to inaugurate the project worth over Rs 700-crore, the three-day extravaganza on December 12, 13 and 14 will be celebrated



Vishwanath Corridor, the dream project of Prime Minister Narendra Modi who would inaugurate the ambitious Rs 900-crore project in his parliamentary constituency Varanasi on Monday.

On Tuesday, the Prime Minister will address the chief ministers of BJP ruled states giving them the tips on good governance in Varanasi. As per the state government sources, the KV Corridor project ensconced in a sprawling 5 lakh square feet, will complement the Purvanchal Development Corridor

and "will be a glorious reflection of the rich cultural and historical heritage of Kashi."

The inauguration ceremony will be aired live in 20,000 temples across the country.

The PM will reach the venue on a boat via

like Diwali and Dev Deepawali with huge participation by people of Varanasi.

A direct access to Kashi Vishwanath Dham temple from the side of river Ganga has become possible with the completion of project The Corridor has been carved out by decongesting around 400 houses and small temples present insides the houses around the temple complex which was originally present in just 3500 square ft area. The State government to give shape to the ambitious project bought all those houses surrounding the temple complex on three sides.

As per the state government sources, total Rs 451.90 crore were spent to purchase the surrounding properties and rehabilitating over 1100 familes. The total length of the newly

constructed corridor now stands at 900 metre with its width being 75 metre. While constructing the corridor, while 24 new

structures were built as part of the project, 43 old structures were restored along with the

"The temple will be inaugurated on December 13 at an auspicious time," Nagendra Pandey, one of the priests at Kashi Vishwanath eemple, said.

According to Varanasi divisional commissioner Deepak Agarwal, Varanasi residents have been asked to decorate their homes and create a festive environment resurrecting the ambience of 'Dev Deepawali' on the evening of inauguration. Special decorations of ghats and prominent buildings of Kashi has

been done as part of the 'Bhavya Kashi, Divya Kashi' programme on December 13.

After December 13, there would be a doorto-door distribution of 'prasad' of Kashi Vishwanath temple and a booklet on the history of the temple. Divisional commissioner Deepak Agrawal said that the PM was expected to reach KV Dham via Ganga on December 13 and enter the project area from Jalasen Ghat, the entry point of the corridor at the river bank. After reaching KV Dham campus, he would perform the rituals of opening this ambitious project at Mandir Chowk.

Uttar Pradesh tourism minister Neelkanth Tiwari said the project would take the dignity of Kashi forward giving a fillip to religious and spiritual tourism of holy ancient city. "The tourism sector is expected to grow significantly," Tiwari said.

Prime Minister Narendra Modi had laid the foundation stone of the corridor in March 2019. The idea behind the Corridor project has been to preserve the existing heritage structures, provide new facilities around the temple complex, decongest the traffic and movement of people around the temple. The idea was to connect the temple with ghats with direct visibility, said the authorities concerned.

The project, which has come up on publicprivate partnership model, ensures easy walking passages for devotees, utility zones as well as procedures in place for crowd management and emergency operational procedures, said Bimal Patel, the project architect.

Patel claimed that the facilities for tourists were enhanced without tampering with the original structure of the temple. "The project encompasses construction of Temple Chowk, Varanasi city gallery, museum, multipurpose auditoriums, hall, devotee facilitation centre, public convenience, salvation home, Godowlia gate, Bhogshala, shelter for priests and sevadars, spiritual book space, and others," Patel said.

Sharing more details about the project, Patel said that around 70 per cent of the total project area has been kept open for the green cover. A statue of Maratha queen Maharani Ahilyabai Holkar, who has reconstructed the Kashi Vishwanath temple, would also be installed as part of the corridor. As per the estimates, over 70 lakh devotees and tourists visit the Kashi Vishwanath Temple every year with a daily footfall of 10,000 mostly from Varanasi and adjoining areas.

The Corridor project is made secured by equipping it with state-of-the-art facilities. An integrated command and control room would ensure foolproof security of Kashi Vishwanath Corridor, said Commissioner of Police A Satish Ganesh.

Speaker Surjya Narayan Patro, who is a seasoned politician having about 40 years of experience in the legislative proceedings, finally expressed helplessness, saying that he could not do anything if all the members become unruly. He said the Speaker can take action against one, two or six members, but what he can do if all the members become unruly.

A senior lawmaker recalled the tenure of JB Patnaik when the opposition firebrands like Ashok Das, Bijay Mohapatra, Nalinikanta Mohanty and Srikant Jena made point blank attacks on the then chief minister. Then also House functioned as JB used to say that opposition would always remain in a democracy and they need to be taken along for the development of the state. Such thinking helped for the smooth conduct of the House after disruption for some time or some days. JB could do this because of the support from the Treasury Bench.

However, in the recent case when the opposition bayed for blood of Minister of State for Home, the ruling party members remained adamant and took steps to irritate the opposition. Instead of asking the minister to maintain a low profile in view of the prevailing situation, the government allowed him to give written replies to the questions asked to the Chief Minister.

Both the Treasury Bench and Opposition chose to enter the fray throwing all dignities to the wind. When the opposition members displayed placards, the BJD members next day wore masks to protest the BJP-led Centre's refusal to accord the First War of Independence status to the Paika Bidroha.

As the opposition members sprinkled Ganga Jal and cow dung water to purify the House alleging that the House had become polluted due to presence of tainted ministers, the ruling BJD retaliated with the same mode of protest. There was a race between the ruling and opposition parties to grab the media focus. The parties also hit the streets on some issues or the other outside the assembly, with an eye on the ensuing three-tier rural and urban polls.

What actually went wrong for which the House was declared sine die 20 days ahead of the schedule without holding any discussion on the burning issues like the cyclone Jawad, farmers' issues, law and order situation and even the Kalahandi woman teacher's murder case? The answer is very simple. There was no such visible effort from the Parliamentary Affairs Minister to bring back normalcy.

Neither the Minister nor the Government Chief Whip made any effective attempt to bring the angry opposition members to the discussion table. Instead, Treasury Bench publichearing was conducted on 10th December with ambiguities without any information to the public as per procedure, claims. According environmentalists, The environmental



clearance process comprises fourstages, namely, Stage (1) Screening; Stage (2) Scoping; Stage (3) Public Consultation and Stage (4) Appraisal. But, these activities are not followed with due knowledge of the public is a matter of concern. People are unhappy in K. C. Pradhan's public hearing saying that only a few people of their choice were invited to the meeting ignoring others. Thesepeople were bribed to speak in support of mines ignoring the main issues of environmental impact. The mining authority have not shown any concern of local employment and other welfare activities required for inhabitation established there. As per information locals are preparing themselves to take shelter at apex court or may file one PIL against this hearing.

Members issued statements against the opposition parties which further aggravated the situation instead of pacifying it. Speaker Surjya Narayan Patro convened three allparty meetings, but those sittings did not yield any result.

The decision makers in the ruling party failed to read the opposition mood as they thought that a statement by the Chief Minister would pacify the situation. The attempt failed because the Chief Minister gave the statement through virtual mode instead of physically coming down to the House. The opposition also took umbrage at the CM's physical absence in the House.

In the statement, the CM blamed the opposition and accused them of "politicizing" the issue. Was it appropriate for the Chief Minister? Naveen is known for his soft and suave nature and democratic principles. He has always been respected for his democratic approach. However, Naveen's accusation of an angry opposition instead of assuaging them aggravated the situation, feel political ana-

And above all, the BJD leaders earlier have also accused the opposition with such allegations. When the particular word came from the CM, it in fact hurt the opposition, pointed out a veteran lawmaker, who adores Naveen Patnaik for his gentle approach towards all. It is another matter that Naveen in his statement appealed to the opposition to cooperate for the smooth functioning of the Assembly. But the tenor of the statement irked the opposition rather than motivating them to shun agitation and cooperate for smooth functioning of the Assembly.

Opposition this time too focused only on one issue (minister's resignation demand) after forgetting their responsibility towards the people of the state as well as their constituents. The farmers this time have been at the receiving end after their matured crops got damaged due to cyclone induced rains.

It should also be remembered that the farmers had already struggled due to inadequate rainfall during the peak monsoon in July and August. This apart, the state's prevailing law and order issue was also ignored as the entire opposition kept itself engaged demanding ouster of the minister both outside and inside the Assembly.

The political acrimony among the major parties has now reached its zenith and all are fighting with each other ahead of the rural and urban polls leading to a situation where we have landed now. This is high time for all the parties to remain under the purview of the democratic set up and tolerate each other instead of losing patience on all issues. Negotiations and dialogue are two major tools for efficient democratic conduct. Both opposition and ruling party have specific responsibilities and they should perform it.

NEW DELHI: The country's largest private health insurer Star Health and Allied Insurance, backed by ace investor Rakesh Jhunjhunwala, made a weak debut on the Indian exchanges on Friday, listing at a discount of 6% at Rs 849 on the BSE compared to its issue price of Rs 900. This is the second time in quick succession when a large IPO is entering the public market at a discount. Last month, Paytm, which had issued India's largest IPO worth Rs 18,300 crore, entered the stock exchanges on Thursday at a dis-

Information on ownership and encroachment of land at other places were not known to the temple administration, it said.

The executive officer (EO), Shree Lingaraj Temple intimated the audit that 36.370 acres out of 69.423 acres of land in Bhubaneswar, were under encroachment. Of this, in 23 cases, encroachment involved more than 0.30 acres of land in each case.

The EO of Shree Lingaraj Temple had filed 272 cases against the encroachers between 1990 and 2010. The Commissioner Of Endowments (EC) had disposed off 222 cases as of October 2019. Of this, the EC forwarded 196 cases to the District Collector, Khurdha for eviction of encroachments.

On the remaining 26 disposed off cases, actions to be taken were not on record. Of the 196 cases referred to the Collector, 79 cases related to Bhubaneswar Tahasil only. Of this, possession was recovered in 15 cases and 17 were pending for want of action at the level of District Collectors.

In the remaining 47 cases, it was reported (January 2017) that eviction was not possible by demolishing/ evicting dwelling units or shops constructed in the encroached lands due to probable law and order situation which might arise.

The CAG further pointed out that land measuring 5.988 acres situated in Gautam Nagar under Bhubaneswar Municipal Corporation area was in the name of Shree Lingaraj Mahaprabhu Marfat Trust Board in the Sabik

In 1995, the land was settled in the name of a former trustee of the trust board. The market value of the land, as reported by the EO of the temple in November 2019, stood at Rs 62.87 crore.

The above facts indicated that the trust boards and EOs had not taken appropriate action to safeguard the valuable landed property of the RIs, the auditor said.

The CGA has recommended that Government may charge penal rent on the occupants of encroached land in case eviction is not possible. In addition, the EC may advise the RIs to plan for utilisation of lands lying vacant under their possession to avoid cases of further encroachment, etc.

It is to be noted that the enhanced deposit insurance cover of Rs 5 lakh is effective from February 4, 2020.

The increase was done after a gap of 27 years as it has been static since 1993.

Observing that banks play a major role in the prosperity of the country, Modi said, for the prosperity of the banks, it is equally important for the depositors' money to be safe.

"If we want to save the bank, then depositors have to be protected," he said.

Over the years, by merging many small public sector banks with large banks, their capacity, capability and transparency have been strengthened in every way, Modi emphasised. When RBI monitors co-operative banks, it increases the confidence of the common depositor in them, he said while talking about another legislation that brought cooperative banks under the control of the central bank.

The Prime Minister said the problem was not only about the bank account, but also about the delivery of banking services to the remotest villages in the past.

Today, in almost every village of the country, the facility of a bank branch or a banking correspondent has reached within a radius of 5 km, he said, adding, the common citizen of India is able to do even the smallest transactions digitally anytime, anywhere, 24 hours a day.

Stressing that there are many such reforms that have helped India's banking system run smoothly even in the biggest calamity in 100 years, Modi said, "when even the developed countries of the world were struggling to provide help to their citizens, India provided direct help to almost every section of the country at a fast pace."

He said that measures initiated in the last few years have taken the facilities like insurance, bank loans and financial empowerment to a large underserved segment of the poor, women, street vendors and small farmers.

Pointing that banking had not reached women of the country in a significant way earlier, the Prime Minister said this was taken as a priority by his government.

Of the crores of bank accounts opened under Jan Dhan Yojana, more than half belong to women, he said.

"The effect these bank accounts have on the economic empowerment of women, we have also seen in the recent National Family Health Survey."

#### BJP members protest House adjournment, meet Odisha Governor

BHUBANESWAR: BJP legislators on Saturday called on Governor Ganeshi Lal to protest the decision of Speaker Surjya Narayan Patro to adjourn the winter session of the Assembly sine die, 29 days ahead of schedule and the prolonged absence of Chief Minister Naveen Patnaik from the House. A delegation of the party's legislators met the Governor at Raj Bhawan here and complained against the Speaker for allegedly perpetrating a constitutional crisis by shortening the length of the Assembly sessions without taking the members into confidence. Terming Patro's decision to adjourn the winter session sine die as 'undemocratic' and 'unconstitutional', the BJP lawmakers alleged that the former is not running the House in an impartial manner.

As per Article 174 of the Constitution, the Assembly should meet for at least 60 working days over three sessions in a calendar year to discuss matters of public interest. But the 16th Assembly has been deviating from the rules of procedure and conduct of business for the last three years, the BJP MLAs said.

The party's memorandum stated that the Assembly had conducted business for only 112 working days against the stipulated 180. It was disappointing that all the sessions of

the Assembly were terminated ahead of schedule without consulting the Opposition. What is more disappointing is the Chief Minister's absence in the Assembly for the last two years, it read.

"The Chief Minister is travelling across Odisha and attending various programmes including the recently concluded Men's Junior Hockey World Cup but skipping the As-



sembly at a time when the Opposition wants his reply on the deteriorating law and order situation in the State and the Mamita Meher murder case," said deputy leader of Opposition Bishnu Sethi.

After venting their grievances against the Chief Minister and the Speaker for running the Assembly in an undemocratic manner, the saffron party's legislators visited Sri Jagannath temple, Puri, and prayed to Lord Jagannath to "infuse better sense in the Chief Minister and protect the women and children of the State from the evil administration of the BJD government."
