State clears AMNS Steel Project

PARADIP(KCN): A day after JSW declared a special rehabilitation and resettlement (R&R) package for the project affected people, anti-industry activists alleged that the decision was arrived at without taking public opinion into consideration.

JSW announced a compensation package for people losing land in villages of Nuagaon, Gadakujang and Dhinkia gram panchayat. However, the locals said this was done without conducting a meeting with the Rehabilitation and Peripheral Development Advisory Committee (RPDAC). Unhappy, villagers said their demands have not been met.

While they had asked for Rs 20,000-25,000

per decimal towards compensation for betel vine, JSW has decided to give Rs 17,500 per decimal. Labourers will get Rs 88,000 in two installments as opposed to the amount decided in the 2010 RPDAC meeting which now amounts to Rs 27 lakh per person. Similarly, prawn ghery owners will be getting Rs 2.5 lakh against the proposed Rs 5-6 lakh.

In a press release, COO of JSW Ranjan Nayak said, "The proposed compensation has emerged through a series of collaborative discussions at the district, gram panchayat and village level with extensive participation of villagers, district administration and other stakeholders to elicit public opinion.

Bhubaneswar(KCN): The High-Level Clearance Authority (HLCA) of the Government of Odisha, headed by Chief Minister Naveen Patnaik on Friday approved ArcelorMittal Nippon Steel's (AM/NS) proposal to set up mega steel plant at a cost of Rs 1.02 lakh crore. The company has proposed to set up a 24 MTPA integrated steel plant at Mahakalpara block of Kendrapara district. This mega project will generate direct employment opportunities to 16,000 persons and create sig-

nificant indirect employment opportunities through ancillary and downstream industries and services. The approved project is the largest project in the manufacturing sector in the country. At its Kendrapara complex, ArcelorMittal Nippon Steel (AM/NS) will produce 24 MT of various grades of steel with its latest green steel making technol-

ogy. It will also produce high value added Steel downstream products.

This facility will also produce 18.75 MT of cement annually, making it one of the largest cement manufacturing plants in the country and will boost the infrastructure development in the region.

Along with the steel complex, the company will also develop a downstream industry park to promote the MSMEs and help import substitution. A large Number of ancillary manufacturing companies are expected to put up their units in this region to support the huge steel making facility.

The infrastructure to be developed for the Kendrapara projects facility will give a boost to the logistics and overall development of the region. This modern, green & environment friendly steel making facility will put Kendrapara and Odisha on the world steel map. A number of international equipment manufacturers will be stakeholders in this project and catalyse more employment opportunities to the State.

Through this investment, the state government will give push to extensive socio-economic development across the region. This mega



project will get completed in 7 years in phases. The logistic infrastructure, power and water utilities and all the clearances for the project will be provided in a time bound manner by the government agencies, which will be monitored by a High Power Committee chaired by Chief Secretary, Odisha.

With this massive investment, Odisha has garnered investments worth Rs 2.70 lakh crore in the past 12 months, creating potential employment opportunities for over 77,000 persons.

Odisha is enjoying the tag of largest steel producing State in the country and such projects will further enhance the production to cross the 100 MT Steelmaking capacity by 2030.



There's another quest for a soulmate in this film, one undertaken by Vellaiyan (a wonderful Mouli), one that is later taken over by Maara. The film is a reinforcement of the power of stories, of the stories each of our lives are. This is why there are multiple characters with their own short stories, including those of Selvi (Abhirami), the sex worker, and Kani (Sshivada), the guilt-ridden doctor. The implication is that no one story is necessarily more important than another. I got the sense that Maara doesn't think of himself as a hero or a saviour, even if those around him seem to

believe that. He's merely a tool, a per-son who breezes through life hoping to repay the extraordinary help that Vellaiyan has done to him. I loved this unrelatable—which would have gone against the point of the film itself. This way, there's a reason for why Maara is the way he is, why he can't afford to stay at one place for too long. I quite enjoyed that Madhavan plays this character without

kites, in the sketch-book and its pencil illustrations, in the sculptures... hell, even in the blotches of Maara's acid-wash hoodies. There's a call through this film, through its characters, to refuse to fall into the trap of mundanity and indif-

The film is almost a homage to art—and the dreaminess inherent in it. This can be spotted throughout the film: In the pretty

ference, into routine and repetition. Maara is pretty much the film equivalent of 'Follow the white rabbit'. That's perhaps why during a conversation between Maara and a thief (Alexander Babu), you can see a neon sign in the background that reads 'White Rabbit'. The usual response to such a call is to cite a lack of financial security, and while that is a reason to be empathetic about especially given the enviably cushy workfree existence Paaru seems to be leading in this film—we could also note how Maara, who's hardly a

most mystical beauty of existence. It's also likely that this is why the film's many shots are lit as they are, with many faces often aglow, as though in the presence of a halo.

This is why the coincidences in this film become palatable. The central idea at the heart of this film is of two lonely souls in search of each other. Take note of that inexplicable attraction little Paaru feels as she sees a speeding train from within her bus. Or take note of that instinctive smile from Maara as he steps into his room, a room that Paaru has lived in briefly. In

does many times in this film, underplays this notion that he's a mystical being. It's his understanding and you will see it from his eyes when he's engaged in conversation with every single characterthat each of us is magical, as are our

stories. In this film with performances that range from great to overthe-top, I loved Mouli in particular, who plays Vellaiya, an old man consumed by his unrequited love. Watch him in that scene with Paaru as he brings to her an old photo of his beloved, Meenakshi, but hesitates after seeing her

about Meenakshi; watch his eyes grow wide in surprise, and almost well up under the weight of decades of mourning. Ghibran's background music and Thamarai's evocative lyrics add so much to such scenes as well. It's wonderful that films like Maara are able to offer elderly characters like Mouli's as much purpose and are able to see them for the individuals that they are, instead of simply as a crutch for a lead character. Of course, much of this credit must go to the original film, Charlie.

In a world that is in a tearing hurry, at a time when films and stories are designed to be rapid for fear of making audiences impatient, films like Maara come as a welcome relief. In this film, at least two important exchangesbetween Vellaiya and Paaru, and later, between Maara and Kani—happen as wood slowly burns to ember, as tender faces are lit by the warm glow of a fireplace. It's for such moments that I'll remember this film, even if some inconsistent performances and some synthetic moments stop it from being truly great. Nevertheless, it's a film that has heart and that encourages empathy towards those around us, and if possible, to note that magicality doesn't need to be thought of otherworldly trait, if only we cared to pay more attention to the beauty around us.

Why This Kolaveri di? We are Pastoralist

"Your life begins to end the moment you start being silent about the things that matter" - Martin Luther King, JR.

Livestock, a multiple-value resource, supports the livelihood of nearly one billion smallholder producers in developing nations. In many developing



countries, s m a l l h o l d e r livestock producers contribute significantly to the food security of the population, providing local markets with animal sourced food produced in a

sustainable way. Livestock sector in India contributes 4.11% to GDP and 25.6% of total Agriculture GDP. In India about 20.5 million people depend upon livestock for their livelihood and provides livelihood to two-third of rural community. It also provides employment to about 8.8 % of the total population of India. With its vast livestock resources, India stands first in milk production, second in buffalo meat production third in egg production and so also is the second largest poultry market in the world. The credit of all these impressive figures are attributed to diverse livestock farming system practised in different agroclimatic zones through India. Irony is that one of the important livestock production system through which India meets 53 per cent of its milk and 74 per cent of its meat requirement is being constantly ignored, and that is pastoralistic system of livestock rearing. Pastoralism makes a significant contribution to the economy of our country both in terms of providing employment and income opportunities and in supplying nutrition to the rural poor. Pastoralism is not recognised as a sector or even a sub-sector of the agriculture economy in India. The global report released by the non profit organization "League for Pastoral Peoples and Endogenous Livestock Development" (LPP), September 30, 2020 stated, in its special section on India, "Pastoralism is not an official category in India. No official definition exists. Officials are aware of its existence but do not recognise it as a distinct management system. The Ministry of Fisheries, Animal Husbandry and Dairying nor the Ministry of Environment, Forest and Climate Change, nor the NITI Aayog have any information, data or scheme, or even recognition about them. The National Agenda on Doubling Farmers' Income does not expend even one word on them. The term "pastoralism" is rarely used and remains so far an almost unknown category used neither by anthropologists nor animal husbandry people. The first usually talk in terms of "nomads", a category, which in India contains a large number of non-pastoral groups. For animal husbandry professionals, animal keeping outside "western models" (i.e. either for dairy purposes or production of meat, egg wool etc) has barely recognised except a very few and for the rest term "pastoralist" is new. There is no official definition of pastoralism in India exist so far, so we take into consideration the work of different scholars and NGOs working in this field, in Indian context, pastoralists can be defined as "members of caste of ethnic groups with a strong traditional association with livestock keeping, where a substantial proportion of the

group derive over 50 percent of household consumption from livestock products or their sale, and where over 90 percent of animal consumption is from natural pasture or brouse, and where households are responsible for the full cycle of livestock breeding". According to a semi-popular magazine, between 14 to 35 million that is 1 percent of the country's total populatiin are engaged in pastoralism. Since Independence, population censuses no longer collect data based on caste adherence, besides, not all members of pastoral castes are actually engaged in livestock keeping. Only a small proportion of young people from pastoral backgrounds have the opportunity or interest to become livestock herders and are engaged mainly in unskilled labour in cities.

A wide range of pastoralist systems exist in India, from fully mobile to transhumant (seasonal movement of livestock between fixed summer and winter pastures) and sedentary. A tremendous variety of sub-systems exists within these broad system depanding on agroclimatic conditions and other sociocultural factors. It includes nomadic and semi-nomadic movements, and village-based herding. Village-based pastoralism is the type of pastoralism usually practiced by owners of small to medium sized sheep, goat and pig owners and also by some cattle herd keepers. Here herds usually return to the village for the night, although they may stay away for several days or weeks, if more distant pastures are to be utilized or fields that are farther away are to be fertilized. With high demand of milk and its products in large cities a new form of pastoralism was in practise and that is urban pastoralism, it refers to the keeping of buffalo and cattle in and at the periphery of large cities for milk Since they are cut off from the main stream development policies and so also are laggards in context of adoption to modern technology like Artificial Insemination, according to one count a significant proportion of India's native livestock breeds (73 out of 200) officially recognized breeds are with pastoralists. These breeds are very special, being on the one hand very alert, resilient, hardy and independent. Pastoralism is important for crop cultivation and long-term soil fertility. The animals distribute manure directly on the fields where they are penned overnight. The value of this manure as a source of nitrogen, phosphorus and potassium has been estimated at a massive 45 billion US dollars a year. Pastoralists also play an important role in conserving wild biodiversity, their livestock convert native vegetation directly into food, without having to go through the intermediate stages of clearing land, ploughing and raising crops. The animals also disperse seeds that get caught in their wool or hides and then fall off elsewhere. Pastoralists have learned to live with wildlife, including predators. In a changing world with increasing variability in climate patterns and natural resources pastoralism secures continuous flow of animal source foods such as meat and milk with climate resistant production system and act as a buffer for protecting national economy and reducing demand for food import at the time of natural calamities. Pastoralism is a complex activity, hinging on a fine balance between human population, animal population

and natural resources. They have been deeply affected by poor understanding of their livelihood system and nonrecognition of their immense contribution not only to agricultural economy but also to nutritional security. Due to the problem of their cultural stereotyping, small population and migratory lifestyle, the pastoralists are ignored in various policy level decisions. Non-participation and ignorance of their due rights and status in Indian have these seriously marginalized communities. Modern development leaves the animals of pastorals nowhere to forage. Customary grazing lands are being enclosed and alienated at an everincreasing pace. Throughout India, the establishment of wildlife sanctuaries, the expansion of irrigation, the construction of buildings and highways are forcing pastoralists to sell off their herds and seek new livelihoods often with little success. Rapid urbanisation, expansion of roads and better connectivity which increases human activity force the pastoralists to frequently alter their migratory routes and face problems of livestock being killed on roads, thefts and a constant pressure to move. Ironically purest of livestock commodities like milk, cheese, meat etc. of highest quality which we often level as close to nature or organic in our modern day terminology are produced only by these pastoralists at the cheapest rates. Unfortunately they either don't find appropriate buyers or it is the middleman (traders) who capitalise upon the product quality and obtain the financial gains. Due to their migratory habits, poor economic condition and social marginalisation pastoralists do not have access to modern animal health care service and they generally rely upon their traditional knowledge for preventing and treating sick animals production with market purchased which is not sufficient enough to keep their animals healthy and productive. Many a times they face huge loss both in terms of production and death of animals due to disease outbreak because of poor on nil vaccination. Neither the insurance sector (for risk coverage) nor the banking sector (for credit facilities) supports them because of their movable assets and poor or almost nill land holdings which makes these pastorals valuerable to risk and restricts their economic growth. Like the situation at international and national level, same scinario prevails here in our state for these pastoralistic communities. There is no official data or document available regarding their population, classification, migration habit, types of herd rearing, etc. The major departments of Government of Odisha who work for the welfare and development livestock farmers and are involved in the management and conservation of natural resources like Fisheries and Animal Resources Development Department (FARD), Forest, Environment and Climate Change Department and ST & SC Development, Minorities and Backward Classes Welfare Department don't have any specific policy for these marginalised people. Neither the Odisha Economic Survey report nor the Odisha State Livestock Sector Development Policy, mentions anything about pastoralist. The various subsectors having there contribution in socioeconomic upliftment of the rural poors through management of natural resources and promoting indigenous technical knowledge like the component of National Livestock Mission (NLM),

Odisha Livelihoods Mission (OLM), The **Orissa Watershed Development Mission** (OWDM) and NGOs like PRADAN, BAIF had no policy directed specifically for the welfare of these pastoralistic community. With scanty or allmost no records available about the pastoralist in Odisha, whatever prediction or estimation is possible is only through collection of information from indirect sources. Unlike other parts of the country typically the northern cold Himalayan region, western dry land and north eastern hilly areas where extreme and a variety form of pastoralism like permanent movement and movement of long distance in search of pasture and water are found, here in our state mostly the village based pastoralism is prevalent though some herd keepers and other tribal peoples move long distance with their livestocks. Pastoralism in Odisha is interwoven with the culture of itinerants (groups who move around supplying services to fixed communities). They are known under a variety of names like Gola, Ghusuria, Manisiala, etc and associated with a variety of traditional occupations and some of them play an important role in livestock farming. They fall into casted, endogamous groups and are often stereotyped as ethnically distinct, as are pastoralists, whom our governments often put into the same catetogory as schedule cast or schedule tribe catagory. The Odisha State Livestock Resources Development Society (OLRDS) under FARD, working constantly for the conservation of native germplasm in different parts of the state is supporting these nomadic pastoralistic community who preserve our precious native germ plasm and hence helps in resolving some of the issues related to these specific communities. The watershed Support Services and Activities Network (WASSAN) foundation in collaboration with FARD, is also doing respectable job in this regard. While discussing pastoralism in the context of Odisha it's a moment of pride to mentation the name of Dr.Balaram Sahu, Ex, Joint Director, FARD, Government of Odisha, the Pioneer of 'Pathe Pathasala' who has got international recognition, had done a commandable job for the pastoralist in Odisha. His publication " Pig Pastoralism in Odisha - A Study" is a master piece in this regard. The issue faced by of pastoralist is universal phenomenon because the policy makers, conservationists and animal scientists have failed to recognize the importance of these long-standing human-animal-landscape associations, for biodiversity conservation and for rural livelihood. As far as pastoralists are concerned Afghanistan is a bright spot, with the community getting legal recognition and economic support from the government. They get financial support like funds and shelters when they migrate from one place to another. The former Afghan president Hamid Karzai belongs to a pastoral community himself and as a result made pastoralistfriendly policies during his tenure. The future of pastoralism in India will depend heavily on policy decisions made by the State and Central Government. However, working with pastoralists, based on a thorough understanding of their traditional production systems, indigenous knowledge, traditional strategies and practices, could empower the pastoralists and maintain their capacity to produce food on marginal lands.

ArcelorMittal Nippon to set up Rs 1 lakh crore steel plant in Odisha, gets state govt nod

BHUBANESWAR: The ArcelorMittal Nippon Steel (AM/NS) has revived its plan to set up a steel plant in Odisha at Mahakalpada block of Kendrapara district with a huge investment of Rs 1,02,275 crore.

The proposal for the 24 million tonne per an-num capacity plant was cleared at the meeting of the High-Level Clearance Authority (HLCA) headed by CM Naveen Patnaik on Friday. The mega project is expected to generate direct employment opportunities for 16,000 persons and create significant indirect employment opportunities through ancillary and downstream industries and services.

The project will be completed within seven years in phases. The logistic infrastructure, power and water utilities and all the clearances for the project will be provided in a time-bound manner by the government agencies, which will be monitored by a high power committee headed by the chief secretary.

The approved project is the largest project in the manufacturing sector in the country. At its Kendrapara complex, the AM/NS will produce



seven-day rolling average of daily new cases has risen steeply over the past two weeks from 8.59 new cases per 100,000 people on Dec. 2 to 39.11 new cases per 100,000 people on Dec. 16.

More than 78% of the new cases are from the omicron variant, Health Minister Joe Phaahla said in a briefing Friday.

Hospitalizations and deaths from COVID-19 have increased somewhat but not at rates comparable to the sharp upward curve of new cases, health experts said. In South Africa, omicron has so far resulted in more mild cases than the previous wave, driven by the delta variant, according to health experts. The population's exposure to the coronavirus, as shown by blood tests for be at 72%, could be contributing to the less severe symptoms from omicron, experts said Friday.

South African scientists say that their analysis of data suggests the Pfizer vaccine offers less defence against infection from omicron and reduced, but still good, protection from hospitalization.

Despite the increased number of COVID-19 cases, the government hasn't announced an increase in restrictions.

In contrast to many other African countries, South Africa now has adequate supplies of vaccine doses, estimated at 19 million, but the number of people getting vaccinated has slowed dramatically. Just 12,500 shots were given Thursday, according to official figures, down from an average of about 120,000 per day in November.

More than 15 million South Africans are fully vaccinated, representing 38% of the adult population, according to official statistics.

"We are very worried about the drastic decline in the uptake of vaccinations, especially in the last seven to 10 days," Health Minister Joe Phaahla said in a media briefing Friday. He urged South Africans to get vaccination shots before the holidays. "Jab before jive!" Phaahla said. The PM had visited the state thrice this month so far — to Gorakhpur for inaugurating AAIMS and a fertilizer factory in Gorakhpur on December 7, unveiling the national irrigation project—Saryu Canal National project in Balrampur on December 11 and launch of the first phase of Kashi Vishwanath Corridor project on December 13-14.

In November, the PM had visited Sultanpur to launch Purvanchal Expressway on November 16, to inaugurate the Jhansi node of the UP Defence Corridor on November 19, participated in the DGs conference from November 19-21 and lay the foundation stone of Jewar International Airport in Greater Noida on November 25.

Ganga Expressway project is tipped to be the longest expressway project of the country joining Meerut in western UP to Prayagraj in eastern UP and it is to be finished by 2025. The road will cross 12 districts from West to East UP and the state has acquired 94% of the 7,386 hectares of land required for the project. The project will cost Rs 36,230 crore and the bids have been finalised for it.

Originally a six-lane project, it could be expanded up to eight lanes and extended till Hardwar in Uttarkhand and also till Ballia in the east in the second phase. On December 21 event, the PM would address the UP government's women employees from across the state. Sources said discussions are on about raising the salary of Accredited social health activists (ASHA), Auxiliary Nurse Midwife (ANM) and Anganwadi workers who treaded inaccessible paths to ensure Covid vaccination and ANM services. Bank Sakhis too have been invited.

On December 23, the PM will again be in Varanasi to address a conference on his vision for the agriculture sector and for farmers. On December 28, the PM would travel to Kanpur to inaugurate the 9-km long first leg of the Kanpur Metro Project and attend the annual convocation of IIT Kanpur.

Harmanpreet's double strike hands India 3-1 win over Pakistan in ACT hockey, takes team closer to semis

DHAKA: Vice-captain Harmanpreet Singh scored a brace as Olympic bronze-medallists India defeated arch-rivals Pakistan 3-1 to register their second consecutive win and virtually qualify for the semifinals of the Asian Champions Trophy men's hockey tournament here on

Harmanpreet (8th, 53rd minutes) converted two penalty corners, while comeback-man Akashdeep Singh, who couldn't make the Tokyo Olympics squad, found the net from a field effort in the 42nd minute for his second goal of the tournament.

Pakistan's lone goal was scored by Junaid Manzoor in the 45th minute.

It was India's second win in the tournament after their 9-0 drubbing of hosts Bangladesh, while Pakistan are still winless, having drawn goalless against Japan in their opening match. India had earlier drawn 2-2 against Korea in their tournament opener.

India is currently leading the points table with seven points from three games and will take on Japan in their last round-robin match of the fiveteam tournament on Sunday. Pakistan, meanwhile, has just one point from two games.

India and Pakistan were the joint winners in the last edition of the tournament in Muscat after the final was washed out. The Indians completely dominated possession in the first two quarters while Pakistan preferred to sit back. But they defended admirably save for Harmanpreet's lone strike.

The play was mostly on the Pakistan half in the first two quarters as Indians pressed hard from the onset and created a couple of chances but credit must go to goalkeeper Mazar Abbas who was brilliant overall. But expectedly, it was India who took the lead in the eighth minute when Harmanpreet converted the team's first penalty corner with a powerful low flick to the left of the Pakistan goalie.

Four minutes later, skipper Manpreet Singh' deflection from outside the circle was saved by an alert Abbas.

The second quarter continued in the same manner as India made numerous inroads but the Pakistan defence was up to the task. While Pakistan defence stood out, the team's forward line looked unimpressive as it failed to register a single shot on the goal or secure a penalty corner.

Leading 1-0 at halftime, the Indians kept up the pressure on the Pakistan goal and increased their lead in the 42nd minute when Akashdeep slapped in Sumit's drive from the left flank with a reverse hit.

But the fighting Pakistanis didn't give up hope and upped their game from here on, reducing the margin 27 seconds from the end of the third quarter through Manzoor's diving deflection from Abdul Rana's pass.

If the first three quarters belonged to India, Pakistan gave Manpreet and his men a run for their money in the final quarter, which produced endto-end enthralling hockey.

Pumped up by the goal, Pakistan went on the offensive and secured their first penalty corner of the tournament in the 47th minute, which was rejected after India asked for the referral.

Pakistan didn't lose hope and continued to press hard and secured two more penalty corners in quick succession but young Indian custodian Suraj Karkera made two brilliant saves to keep his side's lead intact.

In between, India secured their second penalty corner and once again Harmanpreet was precision personified with his drag-flick.

India earned another penalty corner just three minutes from the final hooter but Varun Kumar's effort was saved by the Pakistan goalkeeper.
