BHUBANESWAR (KCN): Even as the State government has urged the Centre for sanction of additional 15 lakh houses under the Pradhan Mantri Awas Yojana (PMAY), nearly 37,000 landless families and 8,575 families under Primitive and Vulnerable Tribal



Death toll rises to 375, 56 missing after Typhoon Rai slams Philippines

MANILA (KCN): The death toll from the strongest typhoon to batter the Philippines this year climbed to 375, with more than 50 others still missing and several central provinces struggling downed communications and power outages and pleading for food and water, officials said Monday. At its strongest, Ty-

phoon Rai packed sustained winds of 195 kilometres (121 miles) per hour with gusts of up to 270 kph (168 mph) before blowing out into the South China Sea on Friday.

At least 375 people were killed, 56 were missing and 500 were injured, according to the national police. The toll may still increase because several towns and villages remained out of communications and power outages, although massive cleanup and repair efforts were under-

Many were killed by falling trees and collapsing walls, flash typhoon, said Rai's ferocity on her island province of more

than 130,000 people was worse than that of Typhoon Haiyan, one of the most powerful and deadliest typhoons on record

M Opens Longest Bridge

(KCN, Bureau): Chief Minister has inaugurated T-Setu, State's longest bridge constructed over Mahanadi in Cuttack district at a cost of Rs 111 crore. The 3.4 km-long bridge, connecting B a d a m b a Narasinghpur and Baideshwar Cuttack district, has been built in the English alphabet 'T' shape.

The bridge will shorten the distance between Badamba and Banki Baideswhar by 45 km and connect Shinghanath temple, officials said.

The High Level Bridge over River Mahanadi Gopinathpur connecting Singhanathpeetha and Baideswar in the district of Cuttack is the longest bridge in the state of Odisha. The bridge is having 86 spans of 36.5 mtr each. Each span consists of 3 prestressed girders and RCC deck slab. The carriageway width is 7.5 mtr i.e. two lane with 1.5 meter raised pedestrian footpath on both sides.



Who was obstructing the workings of justice in the Ram Mandir-Babri Masjid Dispute?

dispute over the construction of the Ram temple in Ayodhya. This issue has been ongoing for centuries. However, only a few people know that when the hearing for the case on the issue of the Ram Mandir-Babri Masjid began in the Supreme Court, there were several direct and

indirect efforts made to postpone the proceedings and decisions regarding it. These underhanded tricks aimed at either halting or terminating the construction of the Ram temple in Ayodhya.

Now that the establishment of the Ram temple in Ayodhya has finally commenced, it is a sensational revelation that the construction of the Ram temple was disliked by some elements. This disclosure was made by the person himself, who was a member of the Supreme Court bench hearing the Ram Mandir-Babri Masjid dispute and the Chief Justice of the country's highest

We are talking about former Chief Justice of India, Ranjan Gogoi. A recent book written by Ranjan Gogoi was published. Its name is 'Justice for Judge'. In this, Ranjan Gogoi explains very clearly and boldly that in the Ram Janmabhoomi case, they advocate for the Muslims Rajiv Dhawan kept making such absurd demands so that the trial of the case could His fundamental motive was that no decision should be arrived upon while Ranjan Gogoi remained the Chief Justice of the Supreme Court so that he could figure out a way to handle his successor post his retirement. Ranjan Gogoi had announced that the Supreme Court would hear the Ram Janmabhoomi dispute case every week from Monday to Friday. It was evident from this decision that the Supreme Court wanted to give its verdict on this sensitive matter before the second week of November 2019.

Meaning the decision for this case would be made before Chief Justice Ranjan Gogoi retired on 17th November 2019. Gogoi's decision meant that a five-member bench of the Supreme Court would have to conduct daily hearings for 48 days. There was ample time because, in this case, one side Nirmohi Akhara had completed its argument. The Supreme Court had also made it clear that after the arguments of all the parties are over, they will get one more chance to respond. After all these measures, both parties of the case should have been happy with this decision that aimed at concluding a pending case. But that didn't happen. Rajiv Dhawan already started claiming that he would not be able to cross-examine for five consecutive days and they needed a break in between. Then the Supreme Court ruled that he can take leave on Wednesday but on that day some other lawyer would have to come in his place.

In any case, the Supreme Court wanted to complete the hearing within the stipulated time. Due to this, they had extended his daily working time to 4:00 pm and then further till 5:00 pm despite the work of the Supreme Court being usually over by 3:00 pm in the day. The whole country is aware of the fact that when the hearing on the Ram temple dispute was going on in the Supreme Court, Chief Justice Ranjan Gogoi was accused of sexual harassment by his former junior assistant. This happened or was made to happen so that in some manner this matter could be delayed. On the allegation of sexual harassment, Ranjan Gogoi said that the independence of the judiciary is in grave danger and this is a "big conspiracy" to destabilize the judiciary. Some even go so far as to say that there were some big forces and money in play behind the woman who accused him of sexual harassment.

The woman who made the allegation had sent a letter from the Supreme Court to all the 22 judges, alleging that Justice Gogoi had sexually assaulted, fired from her job if she did not agree to it, and later harassed her and her family in various ways. All this was happening only to influence the verdict on the Ram Janmabhoomi dispute. However, after 40 days of hearing on the matter from August 6 to October 16, 2019, the Supreme Court had reserved its decision. On 9 November 2019, the Supreme Court, after a lengthy hearing, gave its verdict on the templemosque dispute in Ayodhya. This dispute, which had been going on for more than 100 years, was given an all-out verdict by the Constitutional Bench headed by the then Chief Justice of India, Ranjan Gogoi, that Hindus have the right over the disputed land. In this way, the most significant and more than 5-century old dispute was brought to an end. A five-judge constitution bench headed by Chief Justice Ranjan Gogoi delivered the verdict unanimously.

Under this, the entire disputed land of 2.77 acres of Ayodhya was allotted for the construction of the Ram Mandir. Those who know, know that every possible effort was being made by the present leadership of the Congress to deter the Supreme Court's decision. That is why the proceedings of the Supreme Court were

continuously disrupted.

Now, Congress leader Rahul Gandhi is preaching knowledge on Hinduism and Hindutva. The country wants to know, that if he is indeed a Hindu, he should provide proof to substantiate his claims. If the people of his family have celebrated any Teej-festival of Hindus, he should share that as well. Wasn't his mother Sonia Gandhi married Christian only after converting to his father's religion and name? How did one whose parents are not Hindu become Hindu?

Did Congress contribute to the construction of the Ram Mandir? Or did they extend any help in the construction of the temple? Rahul Gandhi is working on a strategy to divide Hindus. Rahul Gandhi should know that someone who is a Hindu, is also a Hindutvawadi. If not, then what right does he have to talk about Hinduism and Hindutva?

Linc Pen reads writings on the wall

With schools, colleges and other educational institutions gradually re-opening, Kolkataheadquartered Linc Pen & Plastics Ltd (which is in the process of rechristening itself as Linc Pen) is hoping to reach pre-



Covid level by the end of the current fiscal and move up further from there. The four and a half decade old company, which makes one of the top three writing

instrument brands in India, is also gearing up to tap new price segments and new geographies outside India through innovation. ramp it up by way of Speaking to Ritwik Mukherjee, Deepak Jalan, Managing Director, Linc Pen, tries to read the writings on the wall and shares his thoughts on how he plans to take this homegrown brand to the next level. Excerpts:

RM: What is the current overall market size of the writing instrument industry in India and what are the shares of organised and unorganised sector in that market?

Jalan: The overall market size of the writing instrument industry in India, at this point in time, is estimated to be nearly Rs 4000 crore. Of this overall market, 70 per cent would be organised and the remaining 30 per cent would be unorganised sector's contribution.

RM: At what rate the industry is growing? And what would be Linc Pen's growth rate? Jalan: The overall writing instrument industry is growing at 6-8 per cent. And Linc Pen is growing at more or less the same rate. RM: What is Linc Pen's current market

share? Jalan: Our current market share is 8-10 per

RM: How did the Covid pandemic impact

your business? How are things now? Jalan: The Covid pandemic and prolonged lockdowns did hit us hard. With school and college students being our core target groups, we were impacted very badly. All the institutes remained closed for long and our consumption went down drastically as students were pursuing online classes for this entire period. In 20-21, we notched up 65 per cent of our normal revenues. The first two months of the 21-22 were also bad. We were at 75 per cent of our pre-Covid level. Things have started looking up. And we hope to be at close to pre-Covid level by the end

of the current fiscal. RM: Does the digitization spree pose any serious challenge to the writing instrument industry? Do we need pens anymore?

Jalan: I don't think so. People have been talking about this for more than ten years now. The growth rate of pen and other writing instruments may have slowed down, but the market is still there. Pen is still needed and will be needed. No matter how much we Jalan: Yes we distribute Mitsubishi Uni-ball

digitalise, pen and paper will never go out of fashion. They will always be needed for writing notes of various kinds, signature purposes and others.

RM: So what is your current capacity? Do you have any plans to putting up new plants?

Jalan: We have two full-fledged manufacturing units. Our current overall capacity is to make 50 mn pens/month. Besides our own manufacturing units, we also get job works done from several other units, with whom we have contractual agreements. Therefore if we have larger demands, we can always get them manufactured. If the market so demands and we think it fit, we can always think of putting up another plans and ramping up capacity at the existing ones.

RM: At one point of time you had forayed into retailing by way of putting up own signature outlets like Just Linc, Linc Of-

fice and so on. What is the current status? Do you still nurture the same ambition? Jalan: Yes we had started this. But it did not take off the way we had originally envisaged it and then market situations and dynamics also changed. At present we have four company owned signature outlets in Kolkata. It's still too early to expand on this front through the franchise model. However, we are still open to the idea of adding few more company-owned outlets. Hopefully, within next 3-4 months, things will be clearer. We will also have a clearer picture to take a call on this.

RM: Do you still deal with Mitsubishi Uniball, from the stable of Mitsubishi Pencil?

If so, how much of your topline comes from that brand?



in India. As of now, as much as 15 per cent of our overall revenue comes from Mitsubishi UNi-ball.

RM: Do you have any plans to bring in any premium range from your own stable? Jalan: No, not in near future.

RM: Have you taken any move/initiative to make up for whatever de-growth the writing instrument industry has been experiencing?

Jalan: As a de-risking option, we have started marketing and distributing office stationery products (calculators, desk organisers and other desk items etc), under the 'Deli' brand across the country. At present, it contributes around 5 per cent of the turnover. Adjacencies like sanitisers have also been launched recently. Earlier, we had rolled out a sterilising pen (touch-free device for surfaces like ATMs and lift buttons).

RM: What about exports? Do you export

your products also? Jalan: Yes we export our products to as many as 40 countries, mostly in South East Asian

and African countries in our own brand name. Currently, 20 per cent of our total turnover comes from exports. Going forward, we will explore and tap new geographies. And our focus will be on selling products under our own brand name.

RM: What about fountain pens?

Jalan: Fountain pen usage has become insignificant, almost negligible. It has become collectibles or collectors' item. Currently we don't deal in fountain pens.

RM: What is the key challenge to stay competitive in the market?

Jalan: One of the biggest challenges is to offer the best quality products at competitive prices. The market and consumers' perception is that Linc is a mass market brand despite making high quality products. We

have to honour that perception. RM: In the past also you had laid thrust on innovation and came up with new and innovative products. What are you doing now? Jalan: Recently, we launched our brand, Pentonic, to give users a new feel of a pen. We launched this pen to attract professionals. We made it sleek and long, with a body black in colour in order to give it a different appearance from other pens. But we were surprised to see that besides our target segment, school students liked it a lot and demand for these pens grew. We have lined up plans to extend Pentonic's range to gel ink pens shortly.

Typically, India has seen a flourish of pens in the Rs 5-7 price brackets. Margins on most of these are negligible and brands compete on volume. Linc, through Pentonic (priced at Rs 10 & upwards) is looking to shore up volumes and margins. We are targeting kiranas and mom-and-pop stores with a set of pens under Pentonic brand. The brand has been amongst the highest contributors in terms of value (and margins) to Linc's overall portfolio. One out of every three kiranas has shown interest in stocking Pentonic. The target is to add another 250,000 outlets by the end of this fiscal. This will help us recover some sales volumes.

We are now looking at Rs 30 and above price segment and are gradually building up Pentonic as an aspirational brand. We will soon be rolling out Pentonic BRT and will position it as the smoothest pen in India.

The brokerage firm said it believes that EVs will disrupt the ICE (internal combustion engine) segment rather than expand the underlying market and, therefore, value migration is expected from ICEs to EVs.

Thus, the incumbent OEMs would see the loss in value in the existing ICE business as electrification catches up.

Net value accretion could occur from the EV disruption for the incumbent OEMs

from an increase in segmental market share and/or sub-segment expansion due to inter-segmental changes, according to the report.

In two-wheelers, the scooter segment is the most vulnerable to electrification as around 35 per cent EV penetration is expected by FY27E, it said.

The report added that in the domestic threewheeler segment, it estimates EV penetration of around 19 per cent by FY27E. In CVs, the brokerage firm said it expects buses (around 23 per cent EVs by FY27E) and light commercial vehicles (around 18 per cent) to see reasonable EV penetration by FY27E.

According to the report, globally, pure EV OEMs are richly valued, driven by the expectation of rapid value migration from ICEs to EVs across segments.

Even in India, the recent fundraisings in the EV segment have been at rich valuations for businesses that are at their nascent stage of evolution, it stated.

The model code of conduct comes into force the day the election is announced. However, for panchayat polls this time, announcement and notification is likely to be done simultaneously. The model code of conduct issued by the SEC does not contain any guidelines taking into account the Covid-19 pandemic and restrictions on campaigning, public meetings or other modes of campaign.

As per the model code, the parties and candidates will refrain from resorting to character assassination of their rivals by referring to their private life during the campaign. The criticism should be confined to policies and programmes of all contestants in the elections, it added.

The SEC warned that any criticism based on unverified allegations or distortion will be considered as violation of the model code of conduct and viewed with a serious note. Besides, political parties or candidates should refrain from alluring the voters in any form. The code also stated that election meetings or

campaigns would not be allowed in any religious and government institutions. Permission for public meetings, processions and rallies will be given to political parties and candidates on a first come, first serve basis.

There will be no campaigning from 8 pm to 7 am and the campaign with a public address system will come to an end 36 hours before the election date. Elections will have to be held by March 2022 since the term of all the panchayatiraj institutions will be over by that

are the poorest of poor, the government had decided to modify the existing norms to either regularise the land under their occupation or find suitable land to accommodate them. "It is easier said than done. It needs a policy decision. Departments whose land is under unauthorised occupation can not take any decision without approval of the government," sources familiar with land laws said. The district collectors are also facing difficulty in identifying suitable land in areas where these landless families are required to be accommodated, they added.

As the delay in allotment of housing plots to landless families is defeating the cause of 'Housing for All by 2022', the Ministry of Rural Development had instructed the State government to buy land for these poor people. Similar is the problem for sanction of housing assistance to the 8,575 PVTG families who are residing on forest land. "The State government has distributed a record number of land pattas to forest dwelling scheduled tribes and other traditional forest dwellers under Forest Rights Act. Allotment of land for these 8,575 people should not be a big deal. This shows the lack of concern of the district administrations," said tribal BJP MLA Mohan Majhi.

Many more would have died if thousands of residents had not been evacuated from highrisk villages.

Dinagat and several other typhoon-hit provinces remained without electricity and communications and many residents needed construction materials, food and water. Bag-ao and other provincial officials travelled to nearby regions that had cellphone signals to seek aid and coordinate recovery efforts with the national government.

More than 700,000 people were lashed by the typhoon in central island provinces, including more than 400,000 who had to be moved to emergency shelters. Thousands of residents were rescued from flooded villages, including in Loboc town in hard-hit Bohol province, where residents were trapped on roofs and in trees where they went to escape the rising floodwaters.


Coast guard ships ferried 29 American, British, Canadian, Swiss, Russian, Chinese and other tourists who were stranded on Siargao Island, a popular surfing destination that was devastated by the typhoon, officials said.

Emergency crews were working to restore electricity in 227 cities and towns, officials said. Power had been restored in only 21 areas so far. Cellphone connections in more than 130 cities and towns were cut by the typhoon but at least 106 had been reconnected by Monday, officials said. Two local airports remained closed except for emergency flights, but most others have reopened, the civil aviation agency

Bag-ao and other officials were concerned that their provinces may run out of fuel, which was in high demand because of the use of temporary power generators, including those used for refrigerated warehouses with large amounts of coronavirus vaccine stocks. Officials delivered vaccine shipments to many provinces for an intensified immunization campaign, which was postponed last week due to the typhoon.
