

### Odisha sustains agricultural damage as deep depression triggers heavy showers

BHUBANESWAR(KCN): Odisha sustained agricultural damage as heavy rainfall lashed some parts of the State for the second consecutive day on Sunday under the influence of a deep depression which is remnant of post monsoon season's maiden tropical storm Jawad.

Khallikote in Ganjam district received very heavy rainfall - 158 mm and eight other places recorded heavy rainfall in the last 24 hours ending at 8.30 am on Sunday. Nayagarh received 107.5 mm rainfall, Chatrapur 86.6 mm, Banapur



81 mm, Polosara 71.8 mm, Kodala 71.4 mm, Ganjam and Erasama 68 mm each, and Rajnagar 65 mm during the period.

Capital City and other parts of coastal districts received rainfall on the day as the system moved closer towards the Odisha coast.

The deep depression over north-west and adjoining west-central Bay of Bengal moved north-northeastwards with a speed of 18 km/hr in past six hours and lay centered at 11.30 am on Sunday close to Odisha coast about 70 km south-southeast of Puri and 150 km south-southwest of Paradip.

"Remnant of cyclone Jawad is likely to move north-northeastwards, weaken further into a

depression in next three hours. Thereafter, the system is expected to move northnortheastwards along Odisha coast towards West Bengal coast and weaken into a well marked low pressure area around Sunday midnight," said Indian Meteorological Department (IMD) DG Dr Mrutyunjay Mohapatra.

IMD has forecast heavy to very heavy rainfall at one or two places in Puri, Khurda, Cuttack, Jagatsinghpur, Kendrapara, Jajpur, Bhadrak, Balasore and Mayurbhanj districts, and heavy rainfall at isolated places in Ganjam, Nayagarh, Keonjhar, Angul and Dhenkanal districts on Sunday.

The national weather forecaster and Joint Typhoon Warning Center (JTWC) have indicated the system might not brush coastal Odisha and move towards the West Bengal coast. Private weather forecaster Skymet said the system will further weaken into a depression by Sunday afternoon and reach near Puri.

The weather system will continue its journey in northeast direction towards Gangetic West Bengal and south Bangladesh. It is likely to reach south Bangladesh and adjoining area as a well marked low pressure by Monday morning. The impact of the system will reduce significantly over Odisha and Gangetic West Bengal in the next 24 hours, added the private forecaster.

Meanwhile, flight services were suspended at Biju Patnaik International Airport (BPIA) between 1.30 pm and 3.30 pm due to inclement weather conditions.

nal film, Charlie. In a world that is in a tearing hurry, at a time when films and stories are designed to be rapid for fear of making audiences impatient, films like Maara come as a welcome relief. In this film, at least two important exchangesbetween Vellaiya and Paaru, and later, between Maara and Kani—happen as wood slowly burns to ember, as tender faces are lit by the warm glow of a fireplace. It's for such moments that I'll remember this film, even if some inconsistent performances and some synthetic moments stop it from being truly great. Consequence in case of delay in payment of tax: The assessee shall be liable to pay simple interest u/s 220(2)@1% for every month or part thereof, which shall be calculated from the day immediately following the end of the period allowed for payment in the notice **c**) u/s 156 and ending with the day on which the amount is paid.

Sec. 220(2) first proviso provides that, where as a result of an order under sections 154, or 155, or 250, or 254, or 260, or 262, or sec. 264 or an order of the Settlement Commission u/s 245D(4), the amount on which interest was payable under this section had been reduced, the interest shall be reduced accordingly and the excess interest paid, if any, shall be refunded.

W.e.f. 1.10.2014, second proviso to sec. 220(2) provides that where as a result of an order under sections specified in the first proviso, amount on which interest was payable u/s 220 had been reduced and subsequently, as a result of an order under the said sections or section 263, the amount on which the interest was payable u/s 220 is increased, assessee shall be liable to pay interest u/s 220(2) from the day immediately following the end of the period mentioned in the first notice of demand, referred to in sec. 220(1) and ending with the date on which the amount is paid.

#### Some decisions:

Birla Cotton Spg. &Wvg. Mills. Ltd. v. a) ITO and others [1995] 211 ITR 610 (Cal.): If an amount specified in notice of demand is not recoverable and enforceable, the assessee cannot be held responsible for non-payment of the said amount during the period it is not recoverable and enforceable. Liability to pay interest would arise u/s 220(2) only in cases where the amount specified in

demand is either already paid or no longer payable or subsisting, no liability to pay interest u/s 220(2) can arise.

- b) SMS SchloemannSiemag v. Dy. CIT [2001] 250 ITR 97 (AP) (FB) :Condition precedent for invoking sec. 220(2) is satisfied only if there is a demand under a notice by revenue within time stipulated therein and if such a demand is not satisfied, then sec. 220(2) can be invoked. CIT v. Sir Shadi Lal Enterprises Ltd.
  - [2009] 310 ITR 283 (All.) :Interest cannot be charged prior to date of issue of notice of Demand Notice u/s 156.
- d) CIT v. Golcha Properties (P.) Ltd. [1987] 167 ITR 737 (Raj.): The provisions of sec. 220(1) and 220(2) are inoperative in the case of a company which was in liquidation by the orders of the windingup Court.

Further, penalty may be imposed u/s 221(1) which may be equivalent to the amount of tax in arrears.

- 14. Opportunity of being heard: In J. Jayalalitha v. CIT &Ors. [2004] 244 ITR 74 (Mad.) It is not necessary to give an opportunity of being heard before levy of interest u/s 220.
- 15. Whether interest u/s 220 is payable even on interest u/s 234B: Where the assessee has not paid interest u/s 234B which is included in demand notice issued u/s 156, the assessee is liable to pay interest u/s 220(2) even on interest levied u/s 234B- Shriram Chits & Investments (P) Ltd. v. CIT [2005] 2 SOT 838 (Chen).
- 16. Where interest u/s 201(1A) has been charged: When interest is charged u/s 201(1A) on the amount specified in the intimation issued u/s 200A(1), then no interest will be charged for the same amount for the same period u/s 220(2).
- 17. Whether a company Court can waive the recovery of interest levied u/s 220(2): In Catholic Centre v. Pilot Pen Co. (India) (P) Ltd. (in Liquidation) [2003] 259 ITR 252 (Mad.) it was held that powers of Company Court u/s 446(2)(b) of the Companies Act. 1956.

and then again revived: In such a case the interest u/s 220(2) will be computed with reference to the due date reckoned from the original demand notice and with reference to the tax finally determined. The fact that during an intervening period, there was no tax payable by assessee under any operative order would make no difference to this position - Circular 334 [F. No. 400/3/81-ITCC], dated 3.4.1982, 135 ITR (St.) 10.

- **19.** Authority who may be waive or reduce interest u/s 220(2): Interest u/s 220(2A) may be reduced or waived by the CCIT or CIT if he is satisfied that -
- payment of such amount has caused or (i) would cause genuine hardship to the assessee.
- (ii) default in the payment of the amount was due to circumstances beyond the control of assessee, and
- (iii) the assessee has co-operated in any enquiry relating to the assessment or any proceeding for the recovery of any amount due from him.

#### Some decisions:

a) In G.T.N. Textiles Ltd. v. Dy. CIT 217 ITR 653 (Ker.), Metallurgical and Engineering Consultants (India) Ltd. v. CIT &Ors. [2000] 242 ITR 547 (Pat.) and N. Gopalakrishnan v. CIT & Another [2006] 280 ITR 592 (Ker.) have held that interest payable u/s 220(2) cannot be waived/ reduced unless all the three conditions mentioned in section 220(2A) are satisfied.

b) In Apeejay Industries Ltd. v. CIT [2002] 120 Taxman 440 (Cal.) held that sec. 220(2A) gives the assessee right to apply for waiver and further to get the interest amount waived if the conditions mentioned therein are fulfilled. All the trappings of substantive law are to be found, therein. Therefore, it cannot have retrospective operation.

In Kishan Lal v. Union of India 97 c) Taxman 556 (SC)it was held that when an application is filed u/s 220(2A), authority concerned is called upon to take

The application for waiver of interest should be construed liberally. Partial waiver may also be given. An application for stay of recovery proceedings cannot be construed as non-co-operation by the assessee - Arun Sunny v. CCIT [2013] 350 ITR 147 (Ker.). Principles of natural justice would be clearly applicable.

- 20. On what ground an application for waiver of interest can be rejected: The condition that the delay should have occurred because of "genuine hardship" is crucial. It is difficult to conceive of nongenuine hardship, since a hardship, if not genuine, is not a hardship at all. The expression "genuine hardship" displays the anxiety of the Legislature to spare penalty only in cases of real hardship. Supreme Court in B.M.Malani v. CIT [2008] 306 ITR 196 (SC), reversing the decision of the High Court had appreciated the expression "genuine hardship" to mean genuine difficulty on the part of the assessee in payment of tax. The fact that the assessee has large liquid assets by itself, does not mean that there is no difficulty in selling the assets and paying the tax and interest levied. What is meant by genuine hardship is to be understood primarily in the sense that a person cannot take advantage of his own wrong as decided in a number of precedents from Supreme Court. The Court allowed the waiver of Interest.
- 21. Time limit for disposal of application **u/s 220(2A):** As per sec. 220(2A) application for waiver or reduction of interest u/s 220 has to be disposed off by the Principal CCIT, CCIT, Principal CIT or CIT within 12 months from the end of month in which application is made. Before rejecting such application, an opportunity of being heard is to be granted to assessee.
- 22. Whether TRO can go ahead with the

# Pension payable to employees to be determined on rules existing at time of retirement: SC

Employee pension claim: The Supreme Court observed on December 2, 2021 that the pension payable to an employee upon retirement shall be determined based on the rules existing at the time of retirement. The court also stated that the law does allow the employer to apply the rules differently in relation to persons who are similarly situated.

The SC bench of judges comprising Justices MR Shah and BV Nagarathna gave the ruling while considering a civil appeal against an order dated August 29, 2019, which was passed by the Division Bench of the Kerala High Court wherein the High Court had dismissed an appeal.

What is the case appeal about?

The civil appeal was filed by Dr G Sadasivan Nair, who was appointed as a lecturer in the School of Legal Studies of Cochin University Of Science And Technology in September 1984. Before he was appointed as a lecturer, the appellant was a lawyer practicing in the District Court and Kerala Subordinate Courts Kerala between March 11, 1972 and February 2, 1980.

He had then pursued his Ph.D. programme

between March 1980 Sangeeta Nair February 1984 and resumed practice as an advocate in the Kerala before the Registrar of the University on No-



High Court and Subordinate Courts after getting his PhD up till the date of his appointment as a lecturer in the University.

made a representation vember 10, 2004 to

consider his practice of 8 years at the Bar to determine the pensionary benefits payable to him on his superannuation.

The Registrar of the University declined his request in January 2006. The appellant then approached the Chancellor of the University contending that the Registrar had rejected his request without following the relevant rules in their proper perspective. However, he received

no response from the Chancellor. He then submitted a writ before the Kerala High Court on the same grounds and the court

Dr G Sadasivan Nair on April 3, 2006 directed the Chancellor to decide within four months, as to whether the appellant was entitled to get the benefit under Rule 25(a), Part III, KSR.

As per Kerala HC's judgment dated April 3, 2006, the University Chancellor gave the appellant an opportunity of hearing on July 12, 2006, and subsequently dismissed his petition on October 7, 2006, by holding that the Government or any other statutory body had the right to modify the service conditions.

The appellant then submitted a writ petition before the High Court. The Single Judge of the High Court on January 25, 2012, dismissed the writ by ruling that the Government had the right to unilaterally alter the service conditions of employees during their service. The bench had asserted then that what was

applicable was the rule prevailing as on the date of retirement and not that which existed on the date of entering service. The appellant then approached the top court.

"This is a welcome move, but based on it alone, you cannot win the polls as there are a host of other factors," he said.

"Didi has shown that she can take on Narendra Modi and defeat him as well," Tripathi said and added that the 2022 Uttar Pradesh Assembly election has become Akhilesh Yadav versus Yogi Adityanath.

"If Akhilesh is seen on a strong footing, then the prime minister would have to come here and lead the (BJP's poll) campaign," Tripathi said.

Tripathi claimed that BJP's tally of seats in the 2022 Assembly elections will decrease from its 2017 total of 312, as there is "anger in the society, farmers are worried in absence of proper purchase of paddy and due to nonavailability of fertilisers".

He also claimed that the BJP will lose seats in the rural areas of Varanasi in the Assembly polls.

Tripathi said that he and his father have not taken any designation in the TMC and are working to strengthen it in the state.



## **Sahaya for Beggars**

State Government has identified a total of 6,970 beggars across the State and is implementing а scheme called Sahaya for their welfare, Ashok Minister Panda said on Saturday.

In a written reply to the Assembly, Social Security and Empowerment of Persons with Disabilities Minister Panda said as many 4128 male and 2842 female beggars have been identified by the state government in all 30 districts of Odisha. For their welfare, he said, the State Government is implementing a scheme called Sahaya. In the first phase, special drives named as Niladri Nilaya and Ekamra Nilaya have been launched in Puri and Bhubaneswar towns, respectively, he said.

Under the Scheme, baggers Rehabilitation Centres have been opened in Khurda and

Bhubaneswar: The Sambalpur districts while funds have been sanctioned for establishment of such centres in Rourkela municipality, Ganjam and Dhenkanal.

> A proposal for opening of such a Centre in Cuttack Municipal Corporation is under consideration of the government, Mr.Panda said. The Minister informed that Cuttack district tops the list with 1,060 beggars, it is followed by 595 in Bargarh district, 545 in Ganjam, 502 in Bolangir, 447 in Sundargarh, 418 in Khurda, 363 in Kalahandi, 354 in Nuapada and 350 in Puri.

Among other district, 283 beggars are identified in Sonepur district, 222 in Koraput, 205 in Angul, 196 in Jajpur, 188 in Bhadrak, 183 in Nabarangpur, 176 in Rayagada, 164 in Mayurbhanj, 132 in Dhenkanal and 131 in Balasore, he informed. However,

Even as BJD claims that Naveen takes all decisions keeping Odisha's interest on priority, Mr.Vaishnaw's recent announcement not to further proceed on setting up a wagon factory at Sitapalli in Naveen's home district of Ganjam in Odisha has come as a shock for the people of the state as the announcement of cancellation of the Sitapalli project came from none other than Mr. Vaishnaw, who got elected to Rajya Sabha with the support of Naveen.
