Chief of Defence Staff Gen Bipin Rawat, 12 others confirmed dead in TN chopper crash

New Delhi (KCN): Chief of Defence Staff General Bipin Rawat and his wife Madhulika Rawat have been killed along with 12 others when the Army chopper they were flying in crashed near Coonoor in Tamil Nadu, the IAF confirmed on Wednesday.

The tragic incident happened when the chopper was heading for Wellington from Sulur.

The IAF has issued a list of names of General Rawat's staff on board the crashed chopper. They include Brigadier LS Lidder, Lieutenant Colonel Harjinder Singh, Naik Gursewak Singh, Naik Jitendra Kumar, Lance Naik Vivek Kumar,

Lance Naik B Sai Teja and Havaldar Satpal. Group Captain Varun Singh SC, Directing Staff at DSSC, who was also on board, is currently undergoing treatment at Military Hospital,

Wellington, said the IAF.

The IAF has ordered an inquiry into the accident.

Indian Artistry: 10 Distinct Types of Paintings In India

The rich cultural diversity of India is well reflected in the vivid, distinct and enchanting folk art and crafts. Various painting styles are prevalent across various regions, each representing tradition, customs, and ideologies passed on from one generation to other. Traditionally, most of the Indian painting styles existed as wall paintings or murals. In due course of time, urbanisation brought these painting forms on paper, canvas, and cloth etc. Indian painting styles are not just a reflection of the indigenous lifestyle but a perfect example of artistic expression through simple yet distinct compositions.

Here are some of the popular Indian folk painting styles -

William G. Archer in 1934 while inspecting the damage after the massive Bihar earthquake. Archer was amazed by the beautiful illustrations on the exposed interior walls of the houses...The beauty of Madhubani lies in its simple and evocative portrayal of culture and traditions. The designs are characterised by eye-catching geometrical patterns, symbolic images, and scenes from mythology. The balance between the vibrancy of colors and simplicity in its patterns make Madhubani different from other painting styles. Bharni, Katchni, Tantrik, Godna, and Kohbar are the five distinct styles of Madhubani painting. 2. Warli Paintings

The 2500-year-old tradition of Warli paintings of the Thane and Nasik areas of Maharashtra are closely linked with nature and social rituals of the tribe. Warli paintings showcase daily activi-

4. Phad

Phad is the narrative scroll painting tradition from Rajasthan, dating back to a thousand years. Stories of local deities and heroes are painted on horizontal cloth scrolls in hues of red, yellow and



orange T h e Phad scrolls s h o w depictions of battlefields, advent u r e stories, legendary romances and the richness of the Indian princely states.

1. Madhubani Paintings

One of the most celebrated styles of folk paintings in India is, Madhubani which originated in the Mithila region of Bihar



ties of the local people of that community like farming, dancing, hunting, praying etc. Traditionally, women used twigs to draw lively designs with rice paste on mud walls of tribal houses to mark celebrations of harvests or weddings. Simple geometrical patterns in white against a red or yellow surface are used to depict

"patuas" hence the name Kalighata Pata. They depicted scenes of everyday life and mythological deities in a simple yet captivating manner and developed into the popular kalighat style of painting. Kalighat painters predominantly use earthy Indian colours like indigo, ochre, Indian red, grey, blue and white. The swift, seamless, free-flowing outline is a distinguished characteristic of Kalighat style of paintings. This paint-

The Phad painting style leaves one spellbound at how the folk artists accommodate multiple stories in a single composition, yet maintain the aesthetics of artistic expression.

5. Kalamkari

This 3000-year-old organic art of hand and block printing was traditionally used for making narrative scrolls and

panels. This exquisite folk art has a strong connect with Persian motifs. Kalamkari derives its name from kalam or pen and is a legacy that has been handed down from generation to generation in Andhra Pradesh. The stylised animal forms, floral motifs and mehrab designs predominant in Kalamkari paintings have also found a place in Kalamkari textiles. Kalamkari art primarily involves earthy colours like indigo, green, rust, black and mustard. (To be Continued)





traditional dairy product of Odisha Manikapatna Curd, A lesser known

Traditional Indian foods have been prepared for many years and preparation varies across the



country. Traditional wisdom about processing of food, its preservation techniques, and their therapeutic effects have been established for many generations in India. Despite the diversity, an Indian meal would invariably

contain a dish made of milk products due to their excellent nutritional profile and taste so also their proven medicinal value. Milk and milk products are considered as wholesome food and rejuvenator, which can be correlated to modern probiotics and prebiotics that increases the life force. In India only 5-6% of total milk is converted into western type of products in the organized sector. Nearly half of the milk produced in India (50-55%) is utilized for the manufacture of traditional milk products.

Indian Indigenous milk products can be defined as all milk products which are native of India and which were evolved over ages utilizing locally available fuels and cooking ware. In past, to enhance the shelf life of the food product many food processing preservation technique were introduced in household level such as smoking, drying, fermentation, and germination. Out of these techniques the best technique for preservation of food was fermentation. Fermentation is bioprocess technology which is practised since time immemorial. Among the fermented milk product Dahi or curd is the most popular and is being consumed on daily basis in every household in our country. In the Vedic era, the curd was also quite popular, according to Rgveda, Somajuice and barley meal are mixed with curd and consumed thereafter. From Mahabharata and Valmiki-Ramayana, it is found that rasala (According to Pakasastra, Rasala is one of this foodstuff which is to be taken by licking) is consumed as a sweetmeat prepared from curd. There is also indication of a curd drink named as Sikharini in many ancient scriptures which is made from sugar, curd and spices.

Manika patna Dahi or curd or Chilika curd is one such fermented dairy product traditionally prepared by the ethnic community living in and around Manikapatna region, from the milk produced by Chilka buffalo. Manikapatna is an archeological site in the state of Odisha in eastern India. The site is located on the sea coast in Brahmagiri block of Puri district, which is situated near the left bank of the Bhargavi river, at the northeastern end of the Chilika lake. This Chilka lake which is the largest brackish water lagoon situated in the eastern coast of India. The Chilika buffalo (water buffalo) has been named after its place of origin in Odisha (India) known as Chilika Lake. This is a unique breed of buffalo which spends the whole night grazing on weeds in Chilika water. This breed has an exceptional capability of converting the saline biomass of the lake into the most precious milk.

Though the documented historical comprehensive cognition about the Manikapatna curd may not be enough and needs more research but one of the most popular stories relating to Lord Jagannath is that of Kanchi Avijana (journey to Kanchi) is popular in almost all households of Odisha. Purushottam Dev (king of Puri) when was being insulted by the King of Kanchi, marched his army on a campaign to Kanchi. At that time both Lord Jagannath and Lord Balabhadra, disguised as soldiers, mounted on white and black horses, proceeded towards Kanchi to help their favourite devotee in the war. On the way, at the village of Dahikhia, they met Manika, a milkmaid who offered them some curd. The two lords relished the curd and in exchange they gave her a ruby ring and asked her to give it to the King of Puri when he returned from Kanchi. When the victorious Purushottam Dev was returning from Kanchi, he stopped at Dahikhia. Manika showed him the ring. The wise king understood the divine play of the Gods and gifted the entire village, which henceforth got the name of Manikapatna. The word 'Manikapatna' is a combination of two words 'Manika' and 'Patana'; 'Manika', the name of a milkmaid, and 'Patana' meaning 'village'.

The farmers of ethnic community of Chilkaregion follow traditional technique for preparation of Manikapatna curd which they had inherited from their forefathers. The curd

is being prepared inside small container or baskets made from bamboo leaves. At first bambo baskets are prepared from bamboo leaves, inorder to seal the small holes in these baskets, inner surface of the baskets are coated with layers of previously made curd and is allowed to dried in sun. Repeated layering with curd and periodic exposure to sun makes the bambo basket leak free. Then these baskets are filled with buffalo milk which was boiled previously and cooled to room temperature and was sealed with banana leaves. Then these baskets are kept in isolated places so that the process of fermentation got completed without any disturbance.

Varieties of fermented milk products are produced and consumed throughout our state, however, majority of them uses cow milk as substrate. In Manikapatna curd on the other hand, milk of Chilka buffalo is the main substrates which makes its taste and consistency unique. Another peculiarity is that here instead of using standard starter culture, back slopping techniques of freshly boiled milk is used for fermentation of milk which makes the Manikapatna curd free from pathogens. The probiotic properties of indigenous microorganisms isolated from the Manikapatna curd have been reported by many researchers. Probiotic milk products can have several health promoting benefits such as modulation of the immune system, maintenance of gut flora, regulation of bowel habits, alleviation of constipation, and curing of gastrointestinal infections. This curd is prepared inside the basket made from fresh bamboo leaves so also wrapped by banana leaves which gives it an unique advantage of environment friendly packaging. It has a long shelf life and can be stored up to 7 days at room temperature. The appearance, colour, flavour, texture and taste of the stored curd remains same as fresh sample for days in room temperature. As an ethnic fermented milk products this curd is rich in calorie content and being consumed by the locals as a energy rich food particularly in summer.

Unfortunately very less attention has been given to this unique product even within our state and what to speak of its marketing and identity at national and international forum. This product has got all the potential to got a Geographical Indication. Broadly speaking Geographical Indications are nothing but a sign that is used on a variety of goods/products (whether natural, agricultural or manufactured) that indicates the qualities, reputation or characteristics that are essentially attributable to their place of origin. The Geographical Indication tag acts as a product differentiator. In a way it contributes in development of the region where the goods are produced which is usually in rural areas. It functions as a protector of the traditional goodness and knowledge keeping alive the traditions. The product became of high value amongst the consumer which needs no advertisement and could attract premium price and tourism towards the territory for the purchase of the goods.

Sincec 2003, GI tag has been issued only to four dairy products by the Geographical Idication Registry, under the Department of Industry Promotion and Internal Trade, Ministry of Commerce and Industry. Those dairy products are Dharwad Pedha, Karnataka (2008), Banglar Rasogola, West Bengal (2017), Odisha Rasogola, Odisha (2019) and Srivilliputtur Palkova, Tamil Nadu (2019). If we consider Dharwad Pedha in particular the uniqueness of this product comes from the following practices. It is made by hands, made by using milk (buffalo) and sugar, having no flavoring agents, the Pedha has longer shelf-life and originates only from Dharwad city of Karnataka. In that prospective our Manikapatna curd has got all the potential to got a GI tag. It is not too long that we had embroiled ourselves in a bitter battle with our neighbouring state West Bengal on the GI tag of Rasagola for almost two years and finally got GI tag for our own version of that traditional sweet that is Odisha Rasagola. Since then many voices has been raised in different forum to seek formal certification for more of our traditional milk products and sweets like Nayagaeh Chhenapoda, Kendrapada Rasabali, Nimapada Chhena ghili and we must add one more product to the list and that is Manikapatna curd.

A successful FTA creates a win-win situation for both partner countries, not only in terms of providing market access but also enabling deeper engagement through investments, technology and services. In the last two decades there have been proliferation of free trade agreements globally with about 450 FTAs/PTAs concluded and another 180 FTAs/ PTAs under either negotiation or review, involving about 2/ 3rd member countries of WTO. India concluded about 16 FTAs/PTAs and another 20 of them are under either negotiation or review. India's most notable bilateral FTAs are with Japan, Korea, Chile, Singapore and regional FTAs are SAFTA, ASEAN, Mescosur, APTA, etc. Traditionally, India has been conservative to

amongst their partner countries at zero duty tariffs. Therefore, the way to go about an FTA negotiation is to seek longer staging phase out of its tariffs with a partner country while at the same time seek immediate phase outs in areas of core interest. For example, as India is relatively strong in textile, leather, chemicals, automobile components, pharma etc., seeking immediate tariff phase outs in these sectors through FTA could be benefi cial. Also, India's interest in services trade has grown exponentially; seeking openings in services sector for movement of professionals should be a priority. Similarly, encouraging investments through FTA route should form part of the strategy. Conclusion India's trade negotiating approach would need to take a broader longterm view of things to come in future. Increasing volume of trade is more important than trade defi cit because trade need not be a zero-sum game. Ultimately, combination of quality and price determines the staying power of a product in the market. Understanding the evolving linkages between trade, investment, services and technology, GVCs is critical. Investment brings technology which is crucial for making affordable quality products at competitive prices. In the age of servicifi cation of manufacturing, emphasis on providing quality services would have a ripple effect on the overall volume of trade. Technology will impact trade in big way in near future and staying in niche technologies such as machine learning, 3D printing, robotic engineering, internet-based production; e-commerce, etc. will all impact global trade in a big way. India should consciously develop a wide angle approach to evolving global trade these dynamics.(Concluded)

India's export product profile more or less remained constant for several years; petroleum products, Gems & Jewellery, machinery, organic chemicals, pharmaceuticals, electronics, leather, etc. have been consistently leading the chart. Diversifying export basket with value added products would help to expand its global market share. 18 YOJANA October 2020 Trade in services has assumed high importance in global trade. Technology and mobility of skilled manpower across borders have stimulated trade in services sector. Services constitute more than 55% of India's GDP, similar to the economic profiles of most developed countries. India's export of services trade has been gradually growing in the last two decades; in 2019, services exports were \$214 billion and imports \$128 billion and India supplies 40% of global demand for IT skilled manpower. However,

trade, India identified 12 champion services sectors with emphasis on realising their potential for employment generation. Currently, India's total trade including merchandise and services is \$1129 billion, which constitutes about 42%



of the GDP. Deeper external engagements are a necessary condition for boosting trade and, in this regard, Global Value Chains (GVCs) and Free Trade Agreements (FTAs) are important tools.

Global Value Chains Global Value Chains or Supply Chains are a reflection of fragmentation of production processes that have assumed a high degree of sophistication and specialisation due to changes in technology, skills, capital and investment policies. It denotes an underlying principle that companies source raw materials and intermediate products at qualitative and competitive prices from wide ranging sources across the world. It marks a shift away from the traditional way of manufacturing where components and finished products are all produced in one country. As GVCs reduce input costs, it makes finished products competitive in the global markets, a propitious condition for trade to thrive. Open trade and investment policies of a country naturally attract GVCs. Some sectors of India, especially Pharma, Auto and Textiles are well-integrated into GVCs while those of China, Japan, YOJANA October 2020 19 Korea, Singapore etc. are not only extensive but also deeply entrenched in several countries around the world, lending their products competitive edge in the global markets. Free Trade Agreements Free Trade Agreements (FTAs) create conducive environment for GVCs to oper-

RIP CoDS Bipin Rawat: Senior Pakistan military UK PM Johnson apologises, orders probe into leaked video of Downing Street 'party'

LONDON: British Prime Minister Boris Johnson was on Wednesday forced to "apologise unreservedly" after a leaked internal Downing Street video emerged showing his press office staff joking about a party in December last year, at a time when the UK was under strict lockdown rules to protect against the COVID-19 pandemic.

Addressing the weekly Prime Minister's Questions session at the House of Commons, Johnson

started off with an apology and an-nounced an internal inquiry by his Cabinet Secretary Simon Case to establish the full facts around the leaked video.

He, however, maintained that no party actually took place that

would have been in breach of the lockdown rules at the time.

"I was also furious and I apologise unreservedly for the offence it had caused up and down the country, and I apologise for the impression it gives," said Johnson, with reference to the video.

"I have been repeatedly assured since these al-legations emerged that there was no party and that no COVID rules were broken, the Cabinet Secretary has been charged to establish all the facts and it goes without saying that if those rules were broken then there will be disciplinary action for all those involved," he said.

The Prime Minister faced off with a furious Opposition Labour Party Leader, Sir Keir Starmer, who dismissed his opening statement as raising more questions than answers.

"Millions of people now think the Prime Minister was taking them for fools and they were lied to – they were right, weren't they," he said. Starmer accused Johnson of "pretending" that the first he knew about a party, alleged to have taken place on December 18 last year, was only as a result of the leaked video.

"The Prime Minister has been caught redhanded," he declared.

The outrage followed a video acquired by ITV News channel which shows a recording of re-

hearsals for Downing Street's media briefings.

Senior press office staff blurred out in the video pose 'mock' questions to Allegra Stratton, Johnson's official spokesperson at the time and since then his COP26 spokesper-

Stratton is mock asked about a so-called "party", to which she responds first by saying she went home and then jokes on to say it was a 'business meeting' this fictional party was a business meeting 'and it was not socially distanced'.

Members of Parliament from across party lines have condemned the video as making a mockery of a serious issue at a time when people were separated from dying relatives due to a fresh wave of the COVID-19 pandemic.

The footage is said to be from 22 December last year, four days after an alleged Christmas party took place in Number 10.

According to some UK media reports, the dummy video is understood to have been recorded by a company contracted by Downing Street to run the live broadcasts.

The contract ended when Johnson scrapped the briefings.

Odisha lost 406 elephants in last 5 years

BHUBANESWAR(KCN): On average, 80 elephants died in Odisha every year since 2016-17. In a written reply to a question by Congress legislator Suresh Kumar Routray, Minister for Forest and Environment Bikram



Keshari Arukha said 406 elephants have died between 2016-17 and 2020-21.

The Minister said that accidents claimed the lives of 162 elephants and electrocution led to the highest 54 deaths. Fourteen elephants were mowed down by trains. While four elephants were killed in road accidents, 90 lost their lives due to other reasons. He said 11 elephants were killed by poachers.

Odisha reported 282 elephant deaths from 2018 till August 31, 2021. Between 2018-19 and the first five months of 2021, one jumbo died almost every five days in the State. The highest number of elephant deaths (93) took place in 2018-19 followed by 82 in 2019-20,

this year. Anthrax and other diseases killed 95 elephants. As per the last census conducted in 2017, Odisha had 1,976 elephants.

It appears that inflation has entered the state of Schrodinger's theory, where price rise is both temporary and persistent simultaneously. On Wednesday, the RBI confirmed that headline inflation will



likely peak in January-March 2022, and should ease thereafter. But unlike in the past, Governor Shaktikanta Das has not only retired the 'transitory' phase for 'stubborn' inflation, but also decided not to

take the foot off the policy pedal. In other words, the textbook remedy for arresting persistent price pressures via rate hikes is off the table and the key policy repo rate will squat at 4% until further no-À rate hike arrests monetary inflation, or tice. rising prices due to increasing money supply. But given the present inflation is due to global supply bottlenecks, rate corrections are simply useless. So the central bank's Monetary Policy Committee (MPC), kept key policy rates and stance unchanged. Reverse repo rate too stands at 3.35%. Traditionally, the gap between repo and reverse repo rates is 25 bps and reducing the gap is the first step towards eventual rate hikes. India registers highest growth across all economies in Q2, but now there's Omicron...

Just until last week, a hike in reverse repo rate to narrow the rate corridor and set the ground for actual lift-off appeared certain, but that too has been put off until next year, thanks to the trinity of concerns -- new virus variant Omicron, persistent price pressures and global supply bottlenecks. For now, the central bank hopes to align rates without the noise around a rate hike. In fact, it has been doing so since at least since October, where excess liquidity was absorbed via 14 and 28-day Variable Reverse Repo Rate (VRRR) auctions, which in turn firmed up short-term rates. Policywatchers expected a reverse repo rate hike on Wednesday officially confirming a faster policy normalisation, but Governor Shaktikanta Das announced that tapering will now proceed at a fairly leisurely pace. Assuming the government's supply-side measures to contain food prices and fuel tax cuts may alleviate domestic cost-push build-up, inflation estimates were retained at 5.3% for FY22. Headline inflation is expected to peak in Q4 and soften thereafter, but will continue to stay at around 5% in Q1 and Q2 of FY23. Elevated energy and commodity prices, potential volatility in global financial markets due to a faster normalisation of monetary policy in advanced economies and prolonged global supply bottlenecks could irk domestic outlook. That said, as Das noted, price stability remains the cardinal principal for monetary policy and that the central bank will 'ensure soft landing that is well timed. The recovery interrupted by the second wave of the pandemic is regaining traction, but isn't strong enough to be self-sustaining and durable, which is why, RBI believes the key policy rate must squat at 4% indefinitely. Incoming data shows consumption demand improving, and is expected to fare even better due to the recent fuel tax cuts. The government's focus on capex, the deleveraging of corporate balance sheets, rising imports and production of capital goods give enough reason for cheer and so real GDP growth estimates too were retained at 9.5% for FY22 despite uncertainty surrounding Omicron virus, global spillovers and any knee-jerk reaction of Indian and global financial markets to US Federal Reserve's monetary policy action. System liquidity remains in the surplus mode with the average daily net absorption under the liquidity adjustment facility (LAF) at Rs 7.6 lakh crore in November, 21. To rebalance the surplus, Das noted that the objective was to re-establish the 14-day VRRR auction as the main liquidity management tool. Accordingly, the central bank will enhance the 14-day VRRR acution amounts on a fortnightly basis of Rs 6.5 lakh crore on December, 17 and further to Rs 7.5 lakh crore on December, 31. From January 2022 onwards, liquidity absorption will be undertaken mainly through the auction route, while any unanticipated and one-off liquidity flows will be managed and complemented by 28-day and even longer term VRRRs.

A bench comprising Chief Justice N V Ramana and Justices A S Bopanna and Hima Kohli, which had earlier sought small written submissions from parties to the litigation in place of "truckload" of bulky documents, again expressed displeasure on Wednesday over the written notes submitted by Future Group.

"Purpose of our last direction was that you circulate the written note well in advance so that we can read them earlier. I got this from FRL at 10 pm. Today morning, we received it from another party," the bench said.

It then referred to the sequence and content of the written note by saying, "We cannot make out anything. There is no connectivity with the submissions. This isn't a way to do it."

Senior advocate Harish Salve, appearing for the Future group, said, "May I suggest, I will dictate a note today myself and submit by today evening, and it may be taken up tomorrow".

The bench then said that if there was no urgency then the matter will be listed for hearing on January 11.

The parties agreed to it.

The SIAC, in the EA, had granted relief to US e-commerce major Amazon by restraining the Future from going ahead with the Rs 24,731 crore merger deal of Future Retail Ltd (FRL) with Reliance Retail.

Amazon had dragged Future Group to arbitration at SIAC in October last year, arguing that FRL had violated their contract by entering into the deal with rival Reliance.

On November 23, the bench was irked over "truckload" of bulky documents filed by parties in the case and had asked whether the purpose was just to drag on or "harass the judges" and sought a common small compilation of documents.

It had asked the counsels for the parties to file a small volume of documents so that the matter can be disposed of, and fixed the case for hearing on December 8.

"I am sorry to say to all of you. What is the fun in filing 22-23 volumes of records. How many documents both sides have filed repeatedly and is it the purpose of just dragging on or otherwise to harass the judges," the CJI had said. Prior to this, Justice Hima Kohli had offered to recuse herself from hearing the pleas, saying she and her family members have shares in Reliance Industries Ltd group firms, one of the

interested parties to the litigation. "We have no objection," said a battery of lawyers appearing for the parties -- Amazon, FRL and FCPL.

On October 21 this year, a duly-constituted panel of arbitrators at the SIAC reiterated the EA's decision.

On October 29, the Delhi High Court declined Future Group's plea for stay on the arbitration tribunal.

The high court sought response from Amazon which had challenged the merger before the SIAC, and listed the appeals by FCPL and FRL for further hearing on January 4, 2022.

FRL and FCPL moved the top court recently against the order with fresh pleas.

Kishore Biyani and 15 others including FRL and FCPL have been embroiled in a series of litigations with Amazon, an investor in FCPL, over the deal with Reliance.

Following the EA, subsequently, a three-member arbitral tribunal was constituted to decide the issues arising from the deal.

On September 9, the apex court had stayed for four weeks all proceedings before the high court in relation to the implementation of the EA and also directed statutory authorities like National Company Law Tribunal (NCLT), Competition Commission of India (CCI) and Securities and Exchange Board of India (Sebi) not to pass any final order related to the merger deal in the meantime.

Subsequently, the arbitration tribunal under the SIAC rejected on October 21 the FRL plea to

ber 25 last year, observing that "the Award was correctly granted".

The FRL and FCPL had moved the top court against the high court order of August 17 which said that it would implement the earlier order by its single-judge restraining FRL from going ahead with the deal in pursuance of the EA's award.

The high court had said that in the absence of a stay, it would have to enforce the order passed by its single judge, Justice J R Midha, on March 18.

On March 18, besides restraining FRL from going ahead with its deal with Reliance Retail, the court had imposed costs of Rs 20 lakh on the Future Group and others associated with it and ordered attachment of their properties.

On August 6, the Supreme Court gave the verdict in favour of Amazon and held that EA award, restraining the Rs 24,731 crore FRL-Reliance Retail merger deal, is valid and enforceable under Indian arbitration laws.

The apex court had also set aside the two orders of February 8 and March 22 of the division bench of the Delhi High Court order which had lifted the single-judge's orders staying the FRL-RRL merger.

A bench headed by Justice R F Nariman, since retired, had dealt with the larger question and held that an award of an EA of a foreign country is enforceable under the Indian Arbitration and Conciliation Act.

are more at risk due to the new variant and necessary pediatric management has been made at various hospitals across the State," said Dr.Mohapatra.

Odisha reported 255 fresh Covid positive cases and two deaths in the past 24 hours taking the death toll to 8426. Health department sources said the 255 new infections included 54 cases in the age group of 0 to 18 years. The State now has 2,142 active cases.

Out of the 255 new cases while 152 were reported from quarantine centers 103 were local contact cases.

Khordha district reported 106 cases, the highest in the State during the past 24 hours followed by Mayurbhanja (22), Sambalpur (19), Sundergarha (18), Jaipur (16), Anugul (14) and Cuttack (12). During the period two Covid deaths—one each from Cuttack and Khordha was reported.

General Rawat, 63, the first Chief of Defence Staff, was an alumnus of St. Edward School, Shimla and the National Defence Academy. He assumed office as the Chief of the Army Staff on 31 Dec 2016 and was elevated to his current role on January 1, 2020.

He had boarded an Embraer jet at Delhi at 8:47 am, and landed at Sulur at 11:34 am. He then got on board the MI 17 V5 helicopter at 11:48 am. At 12:22 pm, Air Traffic Control said contact had been lost, according to sources. The Chief of Defence Staff was slated to deliver a lecture at the Staff College.

Defence Minister Rajnath Singh earlier met Prime Minister Narendra Modi and briefed him about the accident. He also paid a visit to General Rawat's residence.

Home Minister Amit Shah remembered General Rawat as "one of the bravest soldiers, who has served the motherland with utmost devotion."

Defence Minister Rajnath Singh termed the loss "irreparable".

Former Chief of Army staff and the Minister of State for Road Transport and Highways and Civil Aviation, General VK Singh tweeted, "Today we have lost a brave and distinguished soldier of the country in a tragic accident. The death of him and his wife in the helicopter crash is very sad. His service to the country was important and will always be remembered. May God give strength to his family to bear this immense loss."

"This has come as a bolt from the blue and greatly distressed the lakhs of farmers of Odisha, especially from the western and southern regions of Odisha," read the Memo. In the upcoming KMS 2021-22, Odisha was estimated to procure 52 lakh MT of rice. The State's own requirement is about 24 lakh MT rice comprising all the schemes. Thus, a surplus of 28 lakh MT rice would be left with Odisha which would comprise 4 lakh MT raw rice and 24 lakh MT parboiled rice.

Odisha would be left with a surplus of 24 lakh MT of parboiled rice for lifting by the FCI. If the FCI does not lift this 24 lakh MT of parboiled rice due to restrictions imposed by the Department of Food and Public Distribution (DFPD) then it would severely affect Odisha's paddy procurement operations as well as cause distress to 10 lakh farmers, they said.

These 10 lakh farmers would be in deep distress coupled with the existing pains of the COVID pandemic.

"We as public representatives of the people of Odisha and especially on behalf of 10 lakh farmers of Odisha and their families, demand that the Department of Food and Public Distribution should direct the FCI to accept and lift the 24 lakh MT of surplus parboiled rice from Odisha for the next Kharif Marketing Season 2021-22," the BJD parliamentarians demanded.

If this surplus parboiled rice is not lifted by FCI from Odisha, it would cause immeasurable pain and distress to 10 lakh farmers of the State and their families, they pointed out. Considering that they have undergone great pain and stress due to the COVID pandemic, the MPs urged Mr.Goyal to direct the FCI to ensure that not a single grain of surplus parboiled rice is left behind in Odisha from the 10 lakh farmers in the KMS 2021-22.


