

Odisha cash haul set to be 'highest-ever' with Rs290 crore seizure

New Delhi/Bhubaneswar(KCN): The seizure of "unaccounted" cash after Income Tax department raids against an Odisha-based distillery group and its linked entities is expected to reach Rs290 crore, making it the "highest-ever" black money haul by any agency in a single operation, official sources said Saturday. The tax department has deployed about 40 large and small machines to count currency notes and brought in more department and bank staffers to finish the counting process, which began December 6 following raids against Boudh Distillery Pvt Ltd and others, they said. Besides these, more vehicles have also been requisitioned by the department to transport the seized cash to government banks in the state. A premises linked to Congress' Rajya Sabha MP from Jharkhand, Dhiraj Prasad Sahu, were



also covered as part of the searches, the sources said. Efforts to seek a response from the MP and an e-mail sent by PTI to the distillery group did not fructify. Tax sleuths are now recording the statements of various company officials and other persons involved, the sources said and added that the counting of cash is expected to finish by

Saturday. The total seizure of unaccounted cash is expected to be about Rs290 crore, they told PTI. More than Rs250 crore cash has been seized till now, and cash is continuously being deposited in government bank branches in Odisha, they said. The notes are largely of the Rs500 denomination. This is the highest-ever cash seizure made by an

agency in the country as part of an action against a single group and its linked entities, the sources said. They said almost Rs 230 crore cash was seized from about 8-10 almirahs kept on a premises of the company in Bolangir district, while the rest from locations in Titlagarh, Sambalpur and Ranchi, they said. The searches were launched after the

taxman got "actionable intelligence" of a huge amount of "out of book" sales and cash being remitted by liquor distributors, sellers and business groups. Prime Minister Narendra Modi also took note of the development and posted on X Friday that "Countrymen should look at the pile of these notes and then listen to the honest 'speeches' of their leaders....Whatever has been looted from the public, every penny will have to be returned, this is Modi's guarantee." The ruling BJD in Odisha in a statement welcomed the tax raids. "Jharkhand BJP leaders are saying the seized money belongs to Congress leaders. On the other hand, Congress leaders are saying it belongs to BJP leaders. Both are blaming the other. It seems like both BJP and Congress leaders had stashed their money with this businessman," it said.

Odisha urges DRDO to restrict missile testing during nesting season of turtles

Bhubaneswar(KCN): The state government urged the DRDO to restrict missile testing off the Odisha coast in February and March — the mass nesting season of the endangered olive ridley sea turtles, an official said Saturday. The Defence Research Development Organisation (DRDO) has two major missile testing ranges in the state — Chandipur in Balasore district and the APJ Abdul Kalam Island, formerly Wheeler Island, in Bhadrak district, he said. "It is an annual practice to request the DRDO to restrict tests during this time as these locations are close to the famed Gahirmath beach in Kendrapara district, Rushikulya beach in Ganjam and the confluence of the Devi river and Bay of Bengal in Puri district. These turtles are sensitive and it is feared that missile tests might have an adverse impact on their mating



and mass nesting, the official said. During the last season, a record 6.56 lakh turtles had laid eggs at the Rushikulya rookery and 5.12 lakh turtles turned up for mass nesting at the Gahirmatha beach, he said. The state Home Department will deploy armed police for sea patrolling during the nesting season. Besides, personnel of the Fisheries Department along with the Indian Coast Guard and the Forest Department will also be deployed for patrolling. The state government banned fishing in these areas November 1, and it will continue till May 31.

VK Pandian reviews heritage corridor project in Puri



Puri(KCN): Odisha Chief Minister Naveen Patnaik's close aide VK Pandian Saturday inspected ongoing work under the Shree Jagannath Temple Heritage Corridor project. During the early morning visit to the holy town, Pandian also reviewed the arrangement for

queue management and traffic control around the 12th-century shrine for smooth and safe entry of pilgrims into the temple. He oversaw the progress of the project, like landscaping work, 'matha' (monastery) restoration and queue management system from Shree Parking at Jagannath Ballav

Parking Centre & Marichikote to Dolabedi. According to a press release issued by the CMO, Pandian emphasised on substantial progress on Dolabedi restoration, 'Emar matha', 'Panjabhi Matha', 'Uttarparswa' matha and façade painting around the Parikrama.

The timeline was also made for the completion of the electrical work and the shifting of utilities near 'Meghanad Pachiri' (boundary wall). He too visited the Jagannath Ballav area, Shree Marga (road) and 'Pramod Udyan' (entertainment park) and instructed officials to expedite all work.

Five arrested for allegedly killing army jawan in Odisha

Berhampur(KCN): Odisha Police Friday arrested five persons for allegedly beating to death a 28-year-old Army jawan in Odisha's Ganjam district. The accused had assaulted Army jawan J Dilleswar Patra of Kalipalli near Haripur in the district Sunday, police said, adding that he succumbed to injuries at a private hospital in Bhubaneswar Wednesday. The deceased was posted at Pannagada in West Bengal's Durgapur district, police said. The arrested persons were identified as J Kalyani Patra (19), Ch Sekhar Patra (23), B Chenchya Patra (26) of Kalipalli, B Bulu Patra (26) and Ch Vicky Patra (26) of Jagannathpur. Two motorcycles and two



mobile phones were seized from them, police said. Previous enmity between two groups in the village was said to be the reason for the incident, Ganjam SP Jagmohan Meena said. Meena said there was a quarrel between two groups in the village during the immersion procession of Lord Ganesh a few months ago. While Dilleswar led one group, Sekhar, one of the accused, headed the other. According to Meena,

Dilleswar also allegedly abused another accused a few days ago. According to police, Dilleswar was here on leave around 10 days ago. On December 3, he was on way to Gopalpur to watch a cricket match. After the match, there was a heated exchange between few of the accused and the deceased. While returning, the accused allegedly assaulted him. With critical injuries, he was first admitted to MKCG Medical College and Hospital here and then shifted to a private hospital in Bhubaneswar, where he died during treatment, police said. Police said investigation was on to find out if any more people were involved in the murder.

Odisha STF arrests two wildlife criminals; live pangolin rescued

Rayagada(KCN): The Special Task Force (STF) of Odisha Crime Branch Saturday arrested two wildlife criminals from Rayagada district and seized one live pangolin and other incriminating materials from their possession. STF sources here said, acting on a tip-off, a team of STF conducted a raid on NH-326 (Berhampur-Rayagada) near Akhusingi Square under Padampur police limits of Rayagada district and arrested the wildlife criminals. STF identified the accused as Samsan Raita (45) of Gajapati district and Asmin Sabar (28) of Rayagada. In this connection, a case in this regard has been registered and the accused persons will be forwarded to the Court of SDJM, Ganupur. The live pangolin was handed over to DFO, for safe custody. Investigation is underway.

7.43 Lakh 'Fake Job Cards' Deleted Under Rural Job Scheme MNREGA Last Year: Centre

New Delhi(KCN): More than 7.43 lakh "fake" job cards under the Mahatma Gandhi National Rural Employment Guarantee Scheme were deleted in 2022-23, of which over 2.96 lakh were in Uttar Pradesh, the Centre has said in the Lok Sabha. In a written response to a question this week, Minister of State for Rural Development Sadhvi Niranjan Jyoti shared data on fake job cards.

The data showed 7,43,457 fake job cards were deleted in 2022-23 and 3,06,944 in 2021-22. The corresponding figures



for Bihar were 80,203 and 27,062. In Jharkhand, 70,673 job cards were deleted in

2022-23 and 23,528 the previous year. In Andhra Pradesh, deleted fake job cards was 1,833 in 2021-22, it increased manifold to 46,662 in the last fiscal.

Rajasthan saw the deletion of 45,646 fake job cards in 2022-23 and 14,782 in 2021-22. In West Bengal, whose MGNREGA payments have been pending for the last two years over allegations of corruption, 5,263 job cards were deleted in 2022-23 for being fake and 388 in 2021-22. Ms Jyoti said deletion and updation of job cards is a "continuous process" and as per Section 25 of the Act, whoever contravenes its provisions shall on conviction be liable to a fine which may extend

to ₹ 1,000. "Also, Aadhaar seeding has been made mandatory for the de-duplication of the beneficiaries database to prevent fake job card issuance," she said. Meanwhile, 6,47,834 new job cards were issued in 2022-23, which was an increase of 247.06 percent compared to 2021-22, when the figure stood at more than 1.49 crore. Jobs cards are deleted for various reasons, including these being fake or duplicates and when a beneficiary moves out of a panchayat area or dies.

KIMS Successfully Conducts First-Ever Non-Surgical Advanced Treatment For Facial Pain in Odisha

Bhubaneswar, (KCN): The Kalinga Institute of Medical Sciences (KIMS) has achieved a significant milestone by performing a minimally invasive procedure known as 'balloon microcompression' on a woman grappling with excruciating facial pain for the last seven years. This pioneering procedure marked the first of its kind in Odisha and aimed to alleviate the excruciating discomfort that had severely impacted her daily life. The patient, a woman suffered from

trigeminal neuralgia, a debilitating condition triggered by sharp, stabbing, and electric shock-like pain. This condition is so distressing that it's often referred to as the "suicidal disease," considering the extreme anguish it inflicts. Dr. Rajendra Sahoo, Consultant in Pain and Palliative Medicine at KIMS and his team performed the advanced procedure on the woman. The entire procedure was completed within 30 minutes, she was bringing immediate relief to the patient. Remarkably, the patient was seen smiling in the recovery ward, completely liberated from the persistent pain. Able to eat comfortably without experiencing any further agony, she was discharged the following day, marking a dramatic transformation in her quality of life.

The severity of the pain among patients suffering from trigeminal neuralgia could last from a few seconds to minutes. Daily routines like brushing, chewing and even speaking



become unbearable. Exploring options like radiofrequency ablation and balloon microcompression, Dr Sahoo opted for the latter due to its lower risk of side effects, such as corneal ulcer or keratitis, compared to radiofrequency ablation. "The minimally invasive 'balloon microcompression' procedure involved utilizing a 14 G needle under general anaesthesia, avoiding any incisions or sutures. Guided by fluoroscopy, a specialized X-ray machine, we could access the base of the skull, targeting the 'foramen ovale,' a small opening. The balloon was then carefully inflated for 90 seconds precisely at the 'trigeminal ganglion,' the source of the agonizing pain", Dr Sahoo said. The Founder of KIIT and KISS Dr Achyuta Samanta has congratulated the medical team for the success, emphasising KIMS commitment to offer advanced healthcare support with care and compassion.

Bigg Boss 17 Contestants List: Ankita Lokhande And Husband Vicky Jain To Enter Reality Show?



Retraction of Statement made in Income Tax Search Part 4

(Contd from 4th Dec. 2023)

17. Burden of Proof lies on the assessee

17.1 In CIT v. O. Abdul Razak [2013] 350 ITR 71 (Ker), the Hon'ble Kerala High Court observed in para 11 of the said decision: "Admission as has been often held is the best evidence on a point in issue and though not conclusive is decisive of the matter unless successfully withdrawn or proved erroneous. Any retraction of a clear admission made has to be on the ground of it being either erroneous or factually incorrect or one made under threat or coercion..."

And finally adverting to the issue of burden of proof in case of retraction, the Hon'ble court held in para 13: In the instant case, on the clear admission of the assessee corroborated by the documents, the burden on the Department ceases to exist. On the retraction being filed by the assessee, there is a burden cast on the assessee to prove the retraction or rather disprove the admissions made. It is not a shifting of the onus but a new burden cast on the assessee to disprove the earlier admissions

having evidentiary value. As noticed earlier, retraction made by the assessee can only be considered as a self-serving afterthought and no reliance can be placed on the same to disbelieve the clear admissions made in the statement recorded under section 132(4).

17.2 In CIT, Bikaner v Ravi Mathur [2017] (1) WLC (Raj.) 387, the Hon'ble Rajasthan High Court held that the burden to prove the retracted statement lies on the assessee. The High Court held that the statements recorded under Section 132(4) have great evidentiary value and it cannot be discarded as in the instant case by the Tribunal in a summary or in a cryptic manner. Statements recorded under Section 132(4) cannot be discarded by simply observing that the assessee retracted the statements. One has to come to a definite finding as to the manner in which retraction takes place. On perusal of the facts noticed hereinbefore, we have noticed that while the statements were recorded at the time of search on 9.11.1995 and onwards but retraction, is almost after a year and that too when the

assessment proceedings were being taken up in November 1996. We may observe that retraction should be made as soon as possible and immediately after such a statement has been recorded, either by filing a complaint to the higher officials or otherwise brought to the notice of the higher officials, either by way of a duly sworn affidavit or statements supported by convincing evidence through which an assessee could demonstrate that the statements initially recorded were under pressure/coercion and factually incorrect. In our view, retraction after a sufficient long gap or point of time, as in the instant case, loses its significance and is an afterthought. Once statements have been recorded on oath, duly signed, it has a great evidentiary value and it is normally presumed that whatever stated at the time of recording of statements under Section 132(4), are true and correct and brings out the correct picture, as by that time the assessee is uninfluenced by external agencies. Thus, whenever an assessee pleads that the statements have been obtained forcefully or by

coercion or undue influence without material/contrary to the material, then it should be supported by strong evidence which we have observed hereinbefore. Once a statement is recorded under Section 132(4), such a statement can be used as a strong evidence against the assessee in assessing the income, the burden lies on the assessee to establish that the admission made in the statements are incorrect/wrong and that burden has to be discharged by an assessee at the earliest point of time.

17.3 In S.C. Gupta v CIT [2001] 248 ITR 782 (All), the Allahabad High Court held that a statement made voluntarily by the assessee could form the basis of assessment. The mere fact that the assessee retracted the statement could not make the statement unacceptable. The burden lay on the assessee to establish that the admission made in the statement at the time of survey was wrong and in fact there was no additional income. This burden does not even seem to have been attempted to be

discharged.

18. Case laws about head of income under which disclosed income to be considered

18.1 Dev Raj Hi-Tech Machines Ltd. v. Dy. CIT [2017] 83 taxmann.com 15 (ITAT-Amritsar): The ITAT, Amritsar held that where additional income surrendered by assessee-company in search proceedings was declared as business income and same was accepted by Assessing Officer after considering reply of assessee, revision proceedings initiated under section 263 by Commissioner on basis that such income should be taxed as deemed income under section 69A was not sustainable. The ITAT also held that the wordings of surrender letter are very important as it can save the assessee from the clutches of section 115BBE. It must be clearly stated whether the income is business income or any unexplained income or investment.

18.2 Abdul Qayume v. CIT [1990] 184 ITR 404/50 Taxman 171 (All.): The Allahabad High Court opined that an admission or an acquiescence cannot be

the foundation for an assessment where the income was returned under an erroneous impression or misconception of law. It is always open to an assessee to demonstrate and satisfy the authority concerned that a particular income was not taxable in his hands and that it was returned under an erroneous impression of law. The principle can be applied in a case where the disclosure made under section 132(4) did not match with the material collected in search and seizure operation. In this case, during the course of survey under section 133A the assessee surrendered an additional income over and above the normal income for the year under consideration. In return of income, the assessee declared such surrendered income as business income. And it was held that from the surrender letter it was apparent that the assessee had made surrender as additional income over and above the normal profits of the concern and since the income has been declared as business income, the same has to be assessed under the head business income

and not as deemed income under the provisions of section 69A.

18.3 Kim Pharma (P.) Ltd. v. CIT [2013] 35 taxmann.com 456/216 Taxman 153 (Punj. & Har.) where the court came to the conclusion that the amount surrendered during survey was not reflected in books of account and no source from where it was derived was declared as business income and same was accepted by Assessing Officer after considering reply of assessee, revision proceedings initiated under section 263 by Commissioner on basis that such income should be taxed as deemed income under section 69A and not business income.

19. Tax under sec. 115BBE : After amendment in section 115BBE from assessment year 2017-18 this matter has become very important and if the department treats surrendered income as deemed income it will be subject to tax at the rate of 60 per cent plus 25 per cent surcharge and education cess. The effective aggregate rate u/s 115BBE now 78 per cent. If the A.O. makes addition penalty under section 271AAC may also be levied @ 10 per cent of tax, which will make the overall burden @ 84 per cent on assessee. It is desirable that tax under sec. 115BBE should be at best 30 per cent or the maximum marginal rate.

OLD AGE – BEING CAGED IN SECLUSION AND DEPRESSION

Life becomes a catastrophe when you are pushed hard to seclusion in old age and a person begins to feel that he is no more a part of the world. Alienated by the surroundings for his inabilities to keep pace with the momentum of the world, he realizes he is isolated and his aspirations and demands keep fading as there are rarely any takers. Old age has become a ruthlessly unprincipled and unwanted tenure for many people, as little do they receive as help from the corners they once thought would stand in support when they cross the golden line of courage and enter the terrain of isolation in the old age. Gradually, the tendency of more and more people inching closer to old age attaches the most difficult situation of being alone. This hasn't been the case almost a few decades ago. Insecurity and seclusion have been less as the families were overpopulated and well connected. But the present scenario brings an alarming increase in the population of senior citizens who are left

behind in apartments and houses devoid of adequate assistance supplied. The reason almost everywhere in India is the same; a large number of the young generation is migrating to various parts of the world. And the elder members in the families, unable to cross the uncrossable distance into which their kids got migrated, get frequently caught in an endless cycle of depressive situations. In India, Kerala is the state where the condition is alarmingly intense and this demographic transition is forcing the old people to live their last ounce of life in seclusion and depression. Has old age become a curse for most of those who find the time of their great relapse being treated as a serious liability by others? Loneliness and social isolation are sure to cause serious health hazards among the older adults. Societies all over the world are infected with a tendency to avoid the presence of the elderly and the reluctance to stretch a helping hand is mounting. A study reveals that more than one-third of adults aged 45 and older begin to feel lonely, and at the age of 65 and beyond people are perfectly socially isolated. Probably, at this stage, the number of

people being socially isolated is more than those who begin to feel lonely at the age of 45. Loneliness is the feeling of being alone. This can be principally due to the lack of attention older people receive from the younger ones in the family or a migration of the younger generation that almost left the families a silent den for the older people. The stark reality is, with old age comes various problems and with diminishing resistance power of the body and mind, life becomes practically an uphill task, a struggle. But there is an unbelieveably exponential increase in the number of older people who depend on the world of technology. Most of whom having gained a relative expertise in the internet and social media would find relief from being faced by isolation. Though India is yet to make a greater leap in pacing with technology, developed countries are known to have a better situation in which the senior citizens get obviously captured in the world of Artificial Intelligence and their lives seem to be a better and smoother deal altogether. This may not be the case with many developing countries. Studies also reveal the fact that many seniors in affluent countries chose

not to remain glued on to technology. With the rapid speed of changes in the tech-world, a large number of the older generation would be forced to survive alone and their hurdles to adopting new technologies would keep them ideally handicapped. Countries with advanced tech-assistance have already made a great leap in the process of facilitating the lone elderly population. For example, the UK has various institutions unsupported by the government rendering round the clock assistance to the needy. Telephone friendship services work every day with volunteers making friendly calls for a chat with the lone and helpless older people. There are provisions to give adequate counseling and advice on the issues of bereavement and the depression that frequently haunts the lonely. Reports representing the situation in the UK give alarming statistics. Out of the estimated 1.5 million lonely older people in the UK, about 500,000 go five days a week without seeing or speaking to anyone. Social isolation is a grave reality. In 2021, the World Health Organization (WHO) said social isolation affects around one in four adults worldwide.

Almost everywhere on the globe the situation is the same. With a shrinking population in every family, the older people often find nobody to take support from. This colossal population of the older people that undergoes the effect of bereavement of being isolated is totally disconnected from the society socially, emotionally and also economically. In many cases, even though they live with the rest of the family members, their activities remain curtailed to a limited space, mostly subjected to disrespect and deliberate distancing. This is mainly due to a transition from employment to retirement that reduces their work space and productivity, which further restricts their social outreach. But the ability to stay healthy at an older age comes with a reason to smile. This is an advantageous position to those who are with a reservoir of energy and desirable knowledge and skills. To survive in a demanding world with plenty of skills and energy gets the older population some reliable status. Yet there is a critical situation that pops up with globalization and global connectivity. The world, being systematically connected, often attracts

the younger generation to literally migrate but unfortunately breaks the traditional family structure that leaves the elderly back home. Ageing is emerging as a key policy issue for countries. Of the total population, Japan has about 30% older people. It is estimated that many countries will have a similar proportion of older people by 2050. This includes countries in Europe and North America, China, Thailand, Vietnam and Iran and many more names stretching the line longer. With almost all countries in the world gaining a better living atmosphere, life expectancy has become longer and the population of the older people keeps increasing, probably bringing a steady shift in the pattern of death to old age. This shift has probably made the condition of states like Kerala more vulnerable. Kerala's micro family pattern and the consistent migration at an increasing rate and its improved life expectancy have changed the social situation of the state altogether. It has been reported that Kerala is expected to witness its older population crossing an alarming bar of 23% by 2036 forcing the state for more facilities being arranged for it. This has probably

been the case that the state has not only been known for its high literacy rate but also for its increasing number of care homes for the aged. Mushrooming of old age homes in various names has been a reality and they have seriously been seen as a dictating factor in the state's economy. Retired veterans and normal senior citizens explicitly decide to take shelter in such homes. In many cases, it is the children who choose old age homes for their parents. The idea behind such an act is to shamelessly escape from being

Odisha hostel students walk 25km to submit grievances before Rayagada Collector

Rayagada(KCN): As many as 14 students of Badaraisingi Ashram School in Rayagada district left the school hostel and walked around 25kilometres Saturday to file their grievances on school and hostel mismanagement at the Collector's office, a source said.

According to the source, 14 students ran away from the hostel at Saturday 3:30am and walked through the forest amidst risk of wild animal attack to inform the Collector about various issues prevalent in the hostel such as poor quality of food, education and harsh punishment measures. On being informed, the Additional District Welfare Officer reached the Collector's office and tried to force the children to go back to school. After some time, Rayagada Block Welfare Officer Prakash Nayak called an auto rickshaw



and coerced the students to return to the hostel. However, the students refused to leave the Collector's office until their issues were resolved, the source added.

Afterwards, Scheduled Tribes and Scheduled Caste Development Minister Jagannath Saraka met the students at the Circuit House in Rayagada and offered them food.

The Minister assured the students of taking appropriate action following a thorough investigation. Later, the students were pacified and were taken back to Badaraisingi Ashram

School. One of the students alleged that food was not being provided properly in the hostel. They were not getting the promised egg and chicken meals, each twice every month. Besides, the quality of education is also not satisfactory, the students alleged.

When students complained before the school authorities, Headmaster Vishwamitra Sona used to get angry at them and allegedly threatened the students. The source informed that, earlier, several complaints were raised against Headmaster

Vishwamitra Sona. A similar complaint was raised by hostellers of Anwesha Hostel located in Katlaguda on the outskirts of Rayagada town against Sona. The students had approached the Collector about his mismanagement. Subsequently, Vishwamitra Sona was removed by the Collector. However, following his transfer from Anwesha Hostel, a similar incident has come to light within two months.

When contacted, Headmaster Vishwamitra Sona claimed that the children were being provided food properly. He refuted the allegations brought by the children who had jumped off the hostel gate to reach the Collector's office.

Notably, around 240 students – from Class-I to Class-VIII – reside in Badaraisingi Ashram School's hostel.

Lou Vincent's life ban revised

New Delhi: The England & Wales Cricket Board (ECB) have revised the life ban imposed on former New Zealand cricketer Lou Vincent in June 2014. Nine years ago, Vincent received 11 life time bans for his involvement in match fixing, which excluded him from participating in cricket in any capacity. Vincent had accepted the sanctions back then and stayed away. In August 2023 however, Vincent applied for the bans to be reversed and got his way as Elias CBE KC on behalf of ECB's Cricket Discipline Commission (CDC) lifted them. With immediate effect, Vincent is now permitted to participate and be involved in cricket matches at or below the level of domestic cricket. According to an official release from ECB,



revision of such a ban needs the most compelling of cases for it to be considered. It further states: "The factors to be taken into account include those in Article 6.8.2 of the ECB Anti-Corruption Code. In this regard, Mr Vincent's application is supported by the most powerful and compelling evidence demonstrating the very highest levels of contrition and remorse and the very best efforts to make amends wherever possible."

In particular, the decision was taken based on Vincent's conduct following his sanction - for full and frank admissions and the fullest disclosures, immediate and total co-operation with cricket and civil authorities in various parts of the world, participation in anti-corruption education programmes for New Zealand Cricket and the ECB.

Pacer Lungi Ngidi Ruled Out Due To Injury

New Delhi: In what is a huge blow to South Africa ahead of their first T20I vs India on December 10, pacer Lungi Ngidi has been ruled out of the match because of injury. As per a report in ESPNcricinfo, Ngidi has a left ankle sprain and is doubtful starter in Durban. Ngidi is South Africa's opening bowler who was picked for the first two T20Is vs India before he joined his domestic team to play a four-match game starting on December 14 in pursuit to get better with red ball ahead of the Test series vs visitors.

Now, all of these plans have gone to the back burner. His availability for the match will depend on an evaluation by Cricket South Africa's medical team. Ngidi has been replaced by Beuran Hendricks. He is a left-arm seamer who has played 19 T20Is for Proteas Men so far. But he has not played any

T20I for SA for more than two years. Ngidi getting ruled out means that SA's pace attack lacks experience even if skills levels have not been compromised. Kagiso Rabada was not picked for the T20Is as the selectors wanted to give him rest ahead of the Tests. Meanwhile, Anrich Nortje continues his recovery from lower-back stress fracture. SA still have a lot of quality in their fast bowling department in

form of Marco Jansen, Gerald Coetze, Lizaad Williams, Ottieni Baartman and Hendricks. Not to forget, all-rounders Nandre Burger and Andile Phehlukwayo are there to chip in with some overs. South Africa will also hope that their star and experienced spinners who are featuring in both the white-ball squads - Keshav Maharaj and Tabraiz Shamsi - come good in the T20Is. Coming to the Indian

Rinku Singh, Arshdeep Singh and Ravi Bishnoi will come good in the series.

Opting to bowl, India could score just 240 in 50 overs with Australia achieving the target in 43 overs, with opener Travis Head making a 120-ball 137.

The pitches used in India's league matches against South Africa, England, Pakistan and Australia in Kolkata, Lucknow, Ahmedabad and Chennai respectively were also rated as "average" by the ICC. However, the Wankhede Stadium pitch on which

India face New Zealand in the semifinals received a 'good' rating. There were media reports ahead of that match, suggesting that the hosts had switched pitch, offering a used surface instead of a fresh one. The ICC also gave an "average" rating to the Eden Gardens pitch in Kolkata which hosted

the second semifinal between Australia and South Africa.

It turned out to be a low-scoring match where Australia dismissed South Africa for 212 in 49.4 overs. Australia then managed to overhaul the target in 47.2 overs, losing seven wickets.

New Delhi: IPL franchise Punjab Kings have appointed Sanjay Bangar as their new Head of Cricket Development ahead of the 2024 season. The appointment marks Bangar's return to PBKS after serving in their coaching staff from 2014 to 2016.

"Mr. Bangar brings a wealth of experience and expertise to our organization, and we are confident that under his leadership, our cricket development

programs will reach new heights," read a franchise statement on X. Under Bangar in 2014, PBKS (then Kings XI Punjab) finished runners-up which remains their best performance till date. They haven't even made the Playoffs since. "It's my privilege to be with the Punjab Kings again," Bangar said in a media release. "We have a good core of players as evidenced by the fact that we have the

lowest number of player releases this year. The challenge is to give the squad the best support possible during and after the season to make the team stronger and deliver success."

Bangar, who has also coached the Indian team, served as the head coach of Royal Challengers Bangalore during the 2022 and 2023 IPL editions. His contract wasn't renewed heading into the latest season.
