Odisha Govt Restructures OHMS Cadre With Corresponding Pay Revision



Bhubaneswar(KCN): In another significant step towards attracting and retaining quality manpower for the smooth delivery of health services, the Odisha Government has restructured the Odisha Homeopathic Medical Service (OHMS) cadre with corresponding pay revision in the cadre.

As per the revised structure, the total cadre strength was enhanced to 630 with 399 posts at the base level. Health Secretary Shalini Pandit in a notification to this effect mentioned that there would be 196 posts at the first promotional hierarchy in the pay matrix of level-12 under ORSP Rules.

The number of the posts of Deputy Director in the pay level-13, would be enhanced to 2 for opening more promotional opportunities in the cadre.

The fourth promotional hierarchy in the cadre would be the post of Joint Director in the pay level-14. The revised cadre would include Joint Director - 01; Deputy Director - 02; DHMO / dy. Supdt / CMO - 32; and, Sr. HMO - 399. The officers in the OHMS cadre welcomed this resolution, and thanked the State Government for the move, the notification stated.

PRESIDENT OF INDIA GRACES 9TH CONVOCATION OF INSTITUTE OF LIVER & BILIARY SCIENCES

New Delhi(KCN): The President of India, Smt Droupadi Murmu graced and addressed the ninth convocation of the Institute of Liver and Biliary Sciences (ILBS) in New Delhi today (December 27, 2023).

Speaking on the occasion, the President said that ILBS has carved its own niche in a span of only 13 years on the strength of world-class efficiency and integrity. She was happy to note that more than 1000 liver transplants and approximately 300 renal transplants have been performed at ILBS. She termed the establishment of Artificial Intelligence Learning Unit in ILBS as a timely initiative. She urged ILBS to continue to work in the

field of research along with providing treatment.

The President said that there is a need to pay more attention to preventive healthcare. It can be said that liver is the security guard of our body. Health problems related to liver are serious in our country and the huge number of diseases caused by them

is a cause for worry. She said that ILBS is expected to make a significant contribution in the prevention of liver diseases.

The President said that due to non-availability of sufficient number of organs, many patients are deprived of liver, kidney or any other transplant. Unfortunately, unethical



Remembering Imroz

Prof. MANAS RANJAN MAHAPATRA



did not have its Odia Advisory Panel Meeting for 13 years when I joined. My immediate predecessor was a nice person, but had no background of literature and publishing. I took Odisha Sahitya Akademi as a partner in many activities. To my great fortune, Indubabu Kar, who was an OAS officer, was the Secretary. We together planned to hold an International Conference of Odia Literature, the first of its kind at Delhi. Indubabu and I together roamed around Delhi to meet prominent writers of other languages who can possibly be roped in to participate in the conference to give it a national colour. It was the maiden attempt to put Odia Literature in the national perspective. We went to residences of writers like Indira Goswami, Sisir National Book Trust

Finally artist Indrajit Singh to whom Amrita Pritam called as Jeet or Imroz out of love and lived together with him for almost half a century, has left for his heavenly abode at Mumbai today. His death brought back his memories in me. When I joined NBT way back in 1990 my office was in a rented building at Green Park. House of Dr JP Das at Hauz Khas was almost in front of my office and often I used to meet him for advice. Houses of two great authors of Punjabi, Amrita Pritam and Kartar Singh Duggal were almost next door. Art Historian and author Mulkraj Anand was also in that area. National Book Trust

Kumar Das, Kedarnath Singh and many, and finally reached the residence of Amrita Pritam. It was evening. One gentleman came out. I presumed, he may be Imroz with whom Amrita Pritam was living for years. He welcomed us and took inside. The room had dreamy light, not very sharp. Indubabu informed Amrita Pritam beforehand. We met her.

What a graceful beauty she had. And, a very soft tone. She was a personal friend of Nandini Satpathy, writer and former CM and had visited Odisha a number of times. She agreed to be in the Conference and did it. With Coffee and Pakoda we returned with a happy note.

I have been to the house of Amrita Pritam on many occasions for some or the other works of NBT. Many times I



met Imroz, who always tried to keep himself away from public eye and used to do painting. Whenever Young Odia Writers used to ask me for help to meet renowned writers in Delhi, I used to send them to Amrita Pritam, Kartar Singh Duggal, Kamalaswar or Kedarnath Singh. Today I fondly recollect memory of Amrita Pritam. She died a bit early. I translated her poems and wrote a piece on

her when she got Jnanpith in 1981. There was a lot of hue and cry when she got Jnanpith. Later I understood that many such awards are given on several considerations and not literary excellence alone. But she was a very good writer.

A few years back after the death of Amrita Pritam, Nirakar Das, PRO of East Coast Railways

remember the great author and wanted Imroz to be there. He approached me and I called Imroz. 'Manasji, when Amrita was alive, I used to not accompany her, for I always wanted her to remain great alone. Now, after her death I still maintain the same conviction. I don't want to take a share from her greatness.' Imroz politely replied.

Amrita Pritam and

Imroz had a super natural relationship based on a supra conscious love. Imroz composed several poems on Amrita after her death. He was in his early forties and Amrita in her early sixties when they started living together. Amrita used to lament, 'Jeet, why you came to my life in its evening, you should have come in the afternoon!' Amrita Pritam and Imroz had less physical and more emotional bonding. What a great man!

He always remained aloof from the world of publicity and showmanship, though was a great painter and poet. Movie Review: Kho Gaye Hum Kahan Is Compelling Coming-Of-Age Story In Digital Age

"We are so obsessed staring at the screen these days that we didn't realize life has gone past us," laments Ananya Panday's Ahaana in a poignant moment in Arjun V Singh's "Kho Gaye Hum Kahan." The hustle of living from one post to another, constant life updates, and the thirst for validation from the many faceless followers on social media are perhaps the story of our lives. Debutante Director Arjun V Singh takes us into the world of three best friends. Imaad (Siddhant Chaturvedi) is a stand-up comic with a happy-go-lucky attitude towards every situation, including his dating life. If not on stage, he is busy swiping left and right on Tinder, the dating app. Ahaana (Ananya Panday) is Imaad's flatmate, a whiz who is in a long-term

relationship with her boyfriend, whom she hopes to marry. Then there is Neil (Adarsh Gourav), a gym trainer who aspires to have his studio someday. Like any regular 25-year-old, they are following their passion, working hard, and partying harder. Introspection of life happens over several bottles of beer; they keep no secrets from each other, or do they? Even though their parents don't understand their mindset—Imaad's rich father asks him to start working in the family's business, while Neil fails to understand the penny-pinching mindset of his working-class parents, who tell him that he does not know the difference between need and want. Ahaana, a brilliant professional with fancy degrees and medals to her credit, is a pushover who gets walked over by her



boss as well as her boyfriend. unlikely to meet since a thumbs up or down from them is what can make or break us. Take Ahaana; her heartbreak after getting dumped by her boyfriend is further amplified when she realizes his new girlfriend has over a million followers. The unsure Ahaana creates a fake account to

stalk her boyfriend and starts putting out happy and sexy touched-up pictures of herself on Instagram to prove her life continues to rock. Imaad, on the other hand, who flits from one fling to another, meets an older and wiser woman (Kalki Koechelin), but being commitment-phobic, continues to see other women. Neil, who is dating his client LaLa (Anya Singh), an influencer, cannot understand her obsession with filtered images and wanting to be constantly seen. One day, when he gets a celebrity client who puts out a post with him, seeing his followers climbing up, Neil finds this as a shortcut to success. After all, the many followers on social media are directly proportional to your success. The three sucked into the abyss of the

unfathomable digital world see not only their friendship but their own identity as people being destroyed. Who are we? Are we so desperate to be seen that we can destroy ourselves and those around us? Arjun V Singh gives an impressive and raw narrative of our times. He gets the message across simply: how social media engagement makes us vulnerable to manipulation. Humans are low on emotional quotient but high on compulsive scrolling. Siddhant Chaturvedi is a natural and is on point in his portrayal of Imaad, who is shrouding his emotional baggage under a cocksure attitude. Adarsh Gourav is pitch-perfect as Neil, getting under the skin of his character with ease. Ananya fits in as Ahaana and is relatable in all aspects.

Concept of building Developed India@2047 from academic culture imbued with New National Education Policy



The National Education Policy-2020 was launched on 29 July 2020 under the guidance of Prime Minister Shri Narendra Modi. The National Education Policy (NEP)-2020, designed to deal with the new social, economic and technological circumstances, was appreciated all over the country and the world. But as Mahatma Gandhi said, great thoughts and conceptions become meaningless without action. Apprehensions were also expressed in some quarters about the implementation of NEP-2020 and it will now be relevant to account for the completion of three years of NEP-2020. How far has the NEP been implemented? What have been the achievements so far? and, What are the challenges of the future?

Before knowing the answer to these questions, it is necessary to understand what are the major objectives

and goals of NEP-2020?

A deeper study of the NEP-2020 record will reveal four ideologies: Indigenous Knowledge Tradition, Mahatma Gandhi's vision, Dr Ambedkar's vision of social justice, and PM Modi's dream of a self-reliant India. To realize these high ideals and ideas, especially for the field of higher education, some basic elements were identified in the NEP. These elements embody a dynamic and holistic approach that equally emphasizes learning both theory and application. In addition, emphasis on multilingualism and inculcation of human values and holistic development of students are two notable aspects of this new approach. Given the vastness and diversity of India, implementing the NEP was indeed not easy. Implementing these elements on the ground remains a major challenge. With the concerted efforts of the Ministry of Education, Government of India, University Grants Commission and other stakeholders, it has started to be implemented in phases. But many universities of the country are still behind in this regard, in fact, many do not know exactly what to do and

what not to do. Under the able leadership of Hon'ble Vice Chancellor Dr. Ramdas G. Atram, Dr. B.R. Ambedkar University of Social Sciences (BRAUSS), Dr. Ambedkar Nagar (MHOW), Madhya Pradesh has taken a pioneering role in the implementation of NEP-2020 in higher education system. BRAUSS has implemented NEP-2020 in a systematic, organized and holistic manner, both in word and spirit, which can be a role model for the entire country. In the first phase, BRAUSS has done this implementation at the graduate level and now preparations are underway for the next phase.

Flexibility is a key feature of NEP-2020 so that learners have opportunities to choose their learning paths and courses commensurate with their talent and interest. In this context, looking at new curriculum framework, students have the right to choose courses not only within the subject of their interest but also general electives. In courses, he will also be able to study courses from any other stream. That is, a science person can study social science - humanities to

commerce to management or marketing courses. That is, there will be opportunities to acquire multidisciplinary knowledge along with special knowledge of the subject of interest so that a holistic vision can be developed in the student. The entire syllabus has been structured in such a manner that every year's studies are complete in themselves. If for some reason a student wants to drop out, BRAUSS will give him a certificate after one year and a diploma after two years. Not only this, once you leave, BRAUSS will also give you the opportunity to come back and complete your remaining studies.

NEP-2020 lays great emphasis on skill development and employability to build a self-reliant India.

Students of every stream will get skill education in BRAUSS.

There are many skill courses which will be helpful in the direction of self-employment of our youth. Apart from this, a new and big thing is that internships, apprenticeships, projects, etc. available to students of medical, engineering, law and

management etc. are also available in the traditional program in BRAUSS which will enhance their empirical knowledge. Not only this, entrepreneurship is also now part of the BRAUSS Curriculum. If the student creates an enterprise, BRAUSS will give credit by treating it as a course. Multilingualism is another key point of the NEP. BRAUSS is a pioneer in this field as well. The teaching and study of all Indian languages mentioned in Article 8 of the Constitution has started. Along with 'Teaching and Learning of Indian Languages', the NEP also emphasizes on 'Teaching and Learning in Indian Languages'. Not only in humanities - social sciences but also for science, law, commerce, and management. In this respect, BRAUSS has done a great national service. BRAUSS was also instrumental in transforming the Social Science and Humanities curriculum prepared by the Ministry of Education, GoI, for the SWAYAM portal into Indian languages. BRAUSS, Prof. Sunil Goyal was instrumental and played an important role.

Recognizing the important role of research and innovation in the progress of the nation, a lot of

emphasis has been laid on it in the NEP. BRAUSS has also taken a big initiative in this direction. Research, extension & training has now become part of the curriculum at the undergraduate level at BRAUSS. Additionally, keeping in mind the spirit of social justice enshrined in the Indian Constitution and NEP, BRAUSS has kept very low fees for admission of economically weaker sections of society in their new programs. But the overall development of the students and thus the nation will not take place unless they are equipped with human-moral values and holistic-balanced personalities. Western lifestyle, the world shrinking in technology, virtual life instead of real life, gadget games instead of physical sports, increasing loneliness, etc. have started taking the youth in a dangerous grip. The result is the creation of such unbalanced personalities which are proving to be unproductive, burdensome and sometimes dangerous for the society and the country. To deal with them at the academic level, the Academic Council, under the leadership of Hon'ble

Vice Chancellor Prof. Ramdas G. Atram of BRAUSS has created very innovative courses. In order to build the character and overall development of the students as well as to inculcate in them the Indian knowledge tradition and human values, Prof. Sunil Goyal has designed such 'Value Addition Courses' in which stress is being laid on teaching and learning by following the Gandhian method of practical and empirical study (forty percent). This is not only on courses oriented towards science, but also on humanities and social sciences. The same applies to courses based on literature. All these courses are credit courses.

The NEP also talks about reskilling. In this context, under its Ability Enhancement Scheme (AES), BRAUSS has also made provision for admitting older people (senior citizens) so that they can increase their qualifications.

To enhance the quality of teaching-research, the NEP envisages a 'cluster' in which students of one institution will be able to move to another institution to study a subject or course. In this context too, BRAUSS took the initiative. The 'cluster'

model' created by BRAUSS Prof. Sunil Goyal under the guidance of hon'ble Vice Chancellor Prof. Ramdas G. Atram for various colleges, in this regard, has been appreciated at the national level. However, there are still challenges in the full implementation of the NEP: inadequacies of financial resources, infrastructure problems, lack of Indian vision for research and discourse, key milestones of research, the limitations of the admission process for Ph.D. in the university, coordination with foreign universities etc. are many points which have to be seriously considered. Overall, the implementation of NEP-2020 designed to prepare students for the challenges of the 21st century has been done by BRAUSS. This will prove to be a model for other higher education institutions of the country, no doubt.

Wedding season:Hacks to Darken Your Mehndi Naturally



It's the season of weddings, and who doesn't like the hands with some beautiful mehndi on them? Mehndi ki raat is one of the most important pre-wedding ceremonies.

Functions like Haldi, Sangeet, and Mehndi are celebrated with great pomp and show. As for weddings, it is celebrated as part and parcel of the wedding, where intricate designs are painted on hands and feet.

Henna or mehndi is a part of wedding rituals and is said to bring prosperity to newlyweds. It is believed that the darker the stain, the deeper the bond. That is one reason brides

are keener to get a brilliant and dark mehndi stain.

It is stated that Mehndi is a fertility symbol and is hence utilized in wedding rituals.

Majorly, the mehndi ceremony is a very special function for a bride. From the design of the mehndi to the writing of the name of the groom, the bride takes care of almost everything to perfection.

You have been patiently sitting through the mehndi application and the hard part is over now you want your mehndi to be dark and bold but have no idea how to do so.

These tips might come in handy.

You can get the deep dark colour of henna naturally through simple ways and easy steps.

Before applying henna, it is important to clean the skin and apply moisturiser. This way, there won't

be any effect of chemicals on your skin. Try to minimise the use of soap on the hands to keep the colour long-lasting.

Leave the henna for a longer duration---- Natural henna is initially light orange and then darkens considerably after a day or two. That is why it is always recommended to get Mehndi done 2 days before the big event. Keeping the henna for a longer duration helps in locking colour and yields better results. You can even keep it overnight by covering your mehndi with socks or wrapping your hands in cling film to keep the mehndi intact all night. Once you wash off the henna, dip your hands in cold water for two minutes. Cold water closes the skin pores and may seal the color for a longer time.

Fumes Of Clove: Running your hands over the fumes of

cloves will help with the penetration of the mehndi on your palms.

Take a few cloves and heat them on the pan over a medium flame. You can take clove smoke to make the colour of Mehndi completely dark. The fumes of the cloves will dry up the lemon and sugar mixture and help lock in the colour of the henna for a long-lasting design. The fumes work wonders when used with the lemon and sugar mixture. Another ingredient which is added to the henna mixture in some parts of India is walnut husk, which also gives a nutty brown colour and adds to the henna colour, making it last longer. All kinds of acidic substances, like tamarind, vinegar, etc., have been added to henna, but lemon juice is the most popular. Using lemon and sugar mixture on

your hands and feet post application of mehndi will make the mehndi design richer and dark.

Also, be sure not to overuse the mixture. Boil some water with sugar in it. Add lemon drops to it. Apply your mehndi as it is and once it dries, apply this mixture on top of the mehndi designs at least thrice on your mehndi. The sugar keeps the mehndi in contact with the skin for deeper penetration, while the lemon juice acts as a catalyst for dye release and deep penetration of colour. Lemon juice is added to the henna to bring out the colour. You can mix the henna in a glass, ceramic or plastic bowl, using a plastic spoon. Since henna becomes dry easily and cracks, it tends to fall off in pieces. That is why sugar is added, to make it stick to the skin for a longer time. Apart from lemon juice and sugar, many

people also add coffee and tea water, to get a richer colour. The tan in tea is said to help the colour. These ingredients are added to the henna powder and mixed into a paste with warm water. A few drops of jasmine oil is also added, so that the mixture is not too sticky.

After mixing the henna, wrap it and seal it. Keep it in the refrigerator overnight. Henna stains the skin easily. If you wish to apply it on the nails, first clean your nails and trim them. Push back the cuticles. Soak the fingers in warm water for 10 to 15 minutes. This softens the nails and skin around it and the henna paste is better absorbed.

Apply oil

layer of coconut oil, mustard oil, cocoa butter, Vicks or mango pickle oil.

It will stimulate the henna for deep penetration into the skin. After applying henna, avoid waxing or shaving on that part. Many methods are used for applying mehndi, starting from toothpicks and match sticks to cones and stencils. After applying the henna, if small bits fall off, just fill in with more of the paste. The longer the paste is kept, the darker the colour. The henna paste should be removed by scraping it off. It should not be washed off.

As far as the designs are concerned, there is immense variety. Fine lines, floral, paisley and highly intricate designs are done, with great detail. The artistry is such that it can only be admired. Sometimes, no

designs are followed and the paste is applied to cover the entire hand. During weddings, women in India cover the palms, forearms, feet and even the lower part of the legs with intricate henna designs. Henna, of course, has several benefits. Research has revealed that it is a natural antiseptic and anti-irritant. It is still used in Ayurveda to soothe and heal heat rashes and skin allergies. It has been used for treating burns, bruises, cuts and inflammations. Used on the hair, it has been known to control scalp disorders like dandruff, itching and related conditions. In fact, it is a natural cleanser and restores the acid-alkaline balance of the skin.

"Virtual Tours" retrace his footsteps, while "Photos/Videos" and "Last Journey" offer powerful visual narratives. This AI-powered platform isn't just a repository; it's an immersive journey into

the Mahatma's life and teachings, waiting to be discovered by visitors worldwide. To mark the importance of this event, Shri. A. D. Choudhury, Director General, NCSM mentioned, "at NCSM, we believe science museums transcend physical walls, extending their reach through digital innovation. Gandhipedia embodies this philosophy, offering an interactive, immersive experience that makes Mahatma Gandhi accessible to all, across

generations and geographies. Through this collaborative effort with IITs, we share a commitment to enriching public understanding of not only science but other disciplines like history, and Gandhipedia stands as a shining example of this synergy." State To Monitor Drug De-Addiction

Bhubaneswar(KCN): The State Government has decided to set up a State Monitoring Cell for planning and coordination of the drug de-addiction activities being taken by the Government in the State.

This decision was taken at the first meeting of the State Nasha Mukta Bharat Abhiyaan (NMBA) Committee held here recently under the chairmanship of Principal Secretary, Department of Social Security and Empowerment of Persons with

Disabilities (SSEPD) Bishnupada Sethi. Shri Sethi, who is Chairperson of the Committee, advised for strict implementation of cigarette ban order and visits to the institutions, hospitals for assessment of preparedness and implementation. The committee discussed about formulating State Abhiyaan Activities, guiding and overseeing the implementation of District Level NMBA, increase community participation and public cooperation, Sports & Yoga will be

ensuring formulation and implementation of the District Level NMBA in identified vulnerable districts in the State, conducting training programmes for the service providers at State level, district level, and below district level, developing a Social media strategy for the State Abhiyaan and implementation. Volunteers (retired Government officers having interest in the drug de-addiction field, parents, etc.) will be enlisting to create mass awareness. Sports & Yoga will be



promoted in the educational institutions and de-addiction centres will be done involving other departments and partners.

It was decided to collaborate with NGOs and other civil organizations for taking up NMBA across the State. The Government has also decided to conduct a national short film festival on the theme of "Drug Menace" like the one done by the Commerce and Transport Department on Road Safety matters.

Similarly, the SSEPD Department will work closely with the Department of Excise, Government of Odisha & Narcotics Control Bureau for more activities on reducing drug demand and drug addiction. Commissioner of Police Soumendra Priyadarshi, who was present in the meeting, threw light on DREAMS project (Drug Menace & Entrepreneurial Assistance for Making a Safe Society) - an initiative started by Commissionerate of

Police of Bhubaneswar UPD and various such awareness programmes taken up by the Commissionerate of Police on De-addiction projects in Bhubaneswar & Cuttack. He stated that the Commissionerate of Police on De-addiction matters in Bhubaneswar & Cuttack. Further, he emphasized on physically reaching out to the educational institutions and creating awareness among the students on substance abuse.

Berhampur(KCN): Twenty-eight years after he was booked for murdering a woman in Chennai, a man from Odisha's Berhampur town was arrested by Chennai police here Tuesday.

The accused identified as Harihara Pattjoshi (51) was just 23 when he stabbed Rama (48), his mother-in-law (mother of his estranged wife), at her Nanganallur residence in Chennai on August 9, 1995, police said. He had also allegedly attacked his estranged wife Indira (21) and brother-in-law Karthik (24). After committing the crime, he fled from Chennai and managed to dodge the cops for close to three decades, police



said. Police had registered a murder case in Chennai's S:8 Adambakkam police station and started investigations. During the probe, Chennai cops visited Berhampur on numerous occasions to arrest him, but returned empty-handed, police said. "We formed a team and raided different places in Berhampur and its

adjoining areas suspecting the fugitive might be hiding. A four-member police team from Chennai was also camping in the city for the last one week to assist local police," Berhampur SP Saravana Vivek M said. During one of the search operations, the team found him at a location in Gosainuagaon police station area and arrested

him, he said. Police said the accused was working in an advertisement company in Chennai when he had married Indira on July 14, 1994. Indira was working as a telemarketing executive in another company. They met due to the work related assignments and fell in love. Within a few months of their marriage, the couple separated due to domestic violence and Indira filed for divorce in a local court. This enraged Pattjoshi who attacked his wife, mother-in-law and brother-in-law on August 9, 1995. While his mother-in-law died, others were severely injured in the attack, police said.

Chorus for BeMC expansion, district status grows louder



Berhampur(KCN): Demand for merger of suburban areas on the outskirts of Berhampur Municipal Corporation (BeMC) area and the formation of Berhampur district has gained momentum with people from various walks of life raising their voices over the issue.

Recently, a peaceful protest meeting was held near the Gandhi statue in Gandhinagar against the government's indifference and callousness in implementing the Orissa High Court judgment regarding the merger of suburban areas into BeMC fold and the creation of Berhampur district.

President Sanjeev

president Devi Prasad Das, joint secretary Sudesh Kumar Pote, organisational secretary Srikanth Padhihari and assistant secretary BV Sagar addressed the gathering. Claiming that BeMC is the smallest municipal corporation in India, the speakers addressing the meeting alleged that the government has neglected Berhampur residents as it never implemented its promise to form a larger civic body by including 18 suburban panchayats into the fold of BeMC based on the gazette notification of 2008. They alleged that they have been agitating for the last 12 years, but the government is not paying any heed to their

demand. Even though there was a clear directive from the Orissa High Court, the government continued to ignore it, causing dissatisfaction and anger among the local residents. Notably, all ministers including the Chief Minister, secretaries and other officials have been apprised of their demand by the city-level joint action committee. A delegation of the committee met the then 5T Secretary and submitted a memorandum to him regarding the merger of suburban areas with BeMC, district status to Berhampur and construction of Brahmanagar tower line road when he visited Berhampur and

Heritage British Cemetery of Balasore Vandalised

Bhubaneswar (Anil Dhir): The British Cemetery at Barabati, Balasore is one of oldest colonial era cemeteries of the State. The dilapidated and abandoned graveyard has 33 gravestones including spires and tombs dating back to the 18th century. For the British, Balasore was a favoured maritime centre. The strategic location of the place bordering the Bengal province had also drawn the Dutch, French and Portuguese maritime traders to this coastal town. Besides many

merchants and mariners, the graveyard also has the tombstones of both Sir Henry Rickett, the first collector of Balasore (1827-36), his wife Lady Rickett. Lady Rickett died in Balasore while Sir Henry Rickett died in England in 1886. As per his last wish, his mortal remains were ferried by sea to this place and buried beside his wife grave. 'Henry neither forgot Balasore nor Oriya' is inscribed on the then British administrator's tomb. The cemetery also has the graves of, Captain Morgan who had freed



Balasore from the Marathas and of Sir Francis Walter, the hero of British Royal Navy who led several battles in Madras, Goa, Harisipur, Pipili port and Balasore. It also houses tombstones of five clergies. The inscriptions have corroded with the passage of time. The cemetery was built between 1776 and 1881. The Indian National Trust for Art and Cultural

Heritage (INTACH) had been entrusted to restore the old place a few years ago and a boundary wall was constructed with the MPLAD funds of Dr. Manmath Nath Das under the supervision of the then Collector Ashwini Vaishnav. INTACH, Balasore Chapter has listed this site as a heritage site along with 73 other built heritages of the district a list of which was shared with the District Administration. However, in recent months the place has become a den for anti-social elements who have vandalised this

historically important place by demolishing the compound wall, exposing the cemetery to the vagaries of street dogs and cattle. Some of the marble head stones of the tombs too have been removed. The overgrown vegetation is also spelling the ruin of this heritage site. The future administration of British cemeteries in India had been repeatedly raised during the Transfer of Power before Independence. Before 1947, most were maintained by the local Executive Engineer in consultation with the

local Chaplain. In 1949 the British Government decided not to support the maintenance of the European cemeteries in India and to leave the task of caring for the graveyards to the Christian congregations. The Governments of India had given assurances that they would protect cemeteries from destruction and desecration. A few graveyards were placed under the protection of the Archaeological Survey of India (ASI) and of State authorities. However, many of these extraordinary legacies of

British India lie strewn across the nation, most of them in forgotten, weed-covered cemeteries that have little or no future in modern India. These decaying colonial-era graveyards in India became targeted for conservation starting in the 1970s by the British Association for Cemeteries in South Asia (BACSA). Uday Ranjan Das, the Convener of INTACH's Balasore Chapter has written to the District Authorities to have the cemetery wall reconstructed and to have the place cleared of all vegetation.

'You cannot carry on like an animal' - Shamsi on social media bullying

New Delhi: Tabraiz Shamsi has revealed that his celebration after dismissing Suryakumar Yadav earned him and his wife online abuse - and has called for more vocal opposition from those who suffer violation on the web. But his own experience could serve as a cautionary tale for those considering raising their heads above the electronic parapet. As he has done several times in the wake of taking a wicket, Shamsi removed a boot and held it to his ear - as if he was talking into a phone - after he had Yadav caught at long-off during the second T20I at St George's Park on December 12. Some India fans, Shamsi said, did not appreciate the gesture.

"People took it in a negative way; they

thought it was disrespectful," Shamsi told Cricbuzz. "I had so much abuse hurled at me. It was probably the worst it's ever been. There was also abuse hurled at my wife. I didn't appreciate that. It's uncalled for. It's fine if you want to have a dig at the players, but to involve family and say nasty things, that pushes it to another level.

"I feel that if players don't say anything about it, then people think they have free licence. More people need to speak up and say it's not OK. Yes, we're all trying our best. Yes, your team might not win or you might not agree with certain things. But you need to behave like a human being. You can't carry on like an animal."

Shamsi took to social media the day after the Gqeberha match to

respond to his detractors, writing: "It's just a fun celebration which a lot of kids enjoy and means no disrespect towards the batter. All you guys hurling abuse are just giving other genuine cricket-loving fans from your country a bad name."

Far from quelling the matter or furthering the debate, Shamsi's post earned him more doses of vicious bile. "M*****r don't ever try to do this in front of Indian players," one reaction read. "We will put your attitude in your ass. Don't try to ruin your career. Keep your attitude and arrogance in your pocket. Bowlers like you are available in pedestrian [areas] on every corner of India. So shut up. Just shut up."

Another advised Shamsi to "stay within your

limits" and said he was "like a worm licking the shoes of the Indian team", adding, "you are a m*****r". Shamsi acknowledged public figures were on the wrong side of the social media equation: "People know that because we are

sportsmen we can't really say anything back, and they take advantage of it. I'm never shy to express my opinion, so from time to time I let people have a piece of my mind - if they're stepping over the line. But you can never win that battle." That didn't stop him from

joining the discussion about the ICC's stymieing of Usman Khawaja's attempts to raise awareness about Israel's asymmetric war on Gaza. The ongoing bombardment has claimed the lives of more than 20,000 Palestinians, most of them civilians, in

retribution for Hamas' October 7 terrorist attack that killed 1,200 Israelis and saw more than 200 taken hostage. Khawaja was warned off wearing boots inscribed with "all lives are equal" and "freedom is a human right" - as he has done at training sessions - during the first Test against Pakistan in Perth, lest that breach the ICC's rules on perceived "political, religious or racial" messaging by players. Then he was charged with breaching clothing and equipment regulations for wearing a black armband in the same match. Khawaja said the armband denoted a "personal bereavement". The ICC said he had not obtained permission to wear it, and refused his request to wear an image of a dove - a symbol of peace - on his bat during the second Test at the MCG.


Shamsi posted: "I would like the ICC to explain what exactly has [Khawaja] done wrong? Why the double standards?" Many cricketers have taken a knee in support of Black Lives Matter (BLM) - West Indies still do wear a BLM logo on their collars - and Marnus Labuschagne has a stylised eagle on his bat, representing his favourite bible verse. "For those that hope in the Lord, he shall renew their strength," the verse reads. "He shall soar on wings like eagles. He shall run and not grow weary and talk and not be faint." Here's hoping that reaches Gaza.

IPL title rights: BCCI outlines stringent conditions; may disallow Chinese brands

New Delhi: The Board of Control for Cricket in India (BCCI) is actively seeking a title sponsor for the Indian Premier League (IPL) and has outlined stringent conditions for prospective bidders. Notably, the BCCI has indicated that it may not entertain bids from Chinese companies or brands, citing its reluctance to be associated with firms from countries that do not have friendly relations with India. The reserve price for the rights is INR 360 crore per year.

While specific countries or brands have not been mentioned explicitly, the BCCI's decision stems from the public backlash and a negative experience with Vivo, a Chinese smartphone maker. This situation arose in the aftermath of the border standoff between India and China. Subsequently, Vivo chose to exit from the five-year sponsorship agreement, relinquishing the rights to the Tata Group.

Reads that particular clause in the Invitation to Tender (ITT) document, "Each bidder which is a corporate entity must not be incorporated in a



jurisdiction/territory with which India does not have a friendly relation. In the event, any corporate(s) which is a shareholder or a proposed shareholder in the Bidder is incorporated in a jurisdiction/territory with which India does not have friendly relations, the Bidder will be required to provide a detailed chart of the shareholding in such Bidder or its ultimate Parent Company and the details of ultimate owners/beneficiaries of all shareholders which are body corporate in such Bidder or its ultimate Parent Company along with the Bid Documents as a material obligations". The BCCI is also rejecting bids from companies associated with fantasy games, sportswear, and cryptocurrency, in

addition to betting and gambling firms. The BCCI has outlined specific criteria for ineligibility, including companies directly or indirectly linked to gambling and betting firms, fantasy gaming, cryptocurrency trading, crypto exchange, cryptocurrency tokens, and alcohol products. Notably, there is a peculiar prohibition on firms involved in the production of sportswear.

"Bidders operating/engaged directly or indirectly in athleisure, performance wear and sportswear," will not be eligible, says the ITT. Companies operating from the jurisdiction of tax havens will not be allowed, says the ITT and points out countries like Mauritius and British Virgin Islands. The need for a new title

sponsor arose as the previous deal with the Tata Group concluded after the last season. The upcoming sponsorship agreement is set to span five years, extending until 2028. The reserve price of Rs 360 crore is aligning with the value the Tata Group had been paying for the preceding two seasons.

Cricbuzz has gathered that the initial response to the sponsorship tender hasn't been particularly encouraging. However, there is still some time left for interested parties to purchase the Invitation to Tender (ITT) document and participate in the bidding process. Given the IPL's status as one of the premier leagues globally, it is anticipated that a reputable firm will come on board at a favorable price.

The ITT document, which is a prerequisite for participating in the bidding, will be available for purchase until January 8. The bidding process is expected to take place around January 13-14. Ineligibility of Bidders: (a) Bidder, including any of its Group companies, engaged or operating in the business of fantasy sports gaming, is not permitted to submit a Bid.

(d) Bidder operating/engaged directly or indirectly in fantasy gaming. To clarify, a Bidder, including any of its Group companies, engaged or operating in the business of fantasy sports gaming, is not permitted to submit a Bid.

The Super Kings could take a lot of heart from full house attendances at their home games at the Grand Prairie stadium to usher in a new era for cricket in an already robust Dallas youth cricket scene.

'We have one eye on the T20 World Cup' - Hathurusingha

Dhaka: Bangladesh are hopeful that their maiden ODI win in New Zealand will prepare them for the upcoming T20I series against the hosts. Bangladesh managed to break the ODI jinx in New Zealand after 18 successive defeats and in T20I cricket, they have an abysmal record again losing all nine matches in this part of the world so far.

"We haven't won a T20 game over here. This was the same as one-day cricket but then we managed to win the last game," Bangladesh head coach Chandika Hathurusingha told reporters ahead of the first game in Napier. "Certainly it will help (ODI win over New Zealand at Napier) mentally when you have a good win always you feel good and

because you have done something you want to repeat again no matter what the format is and that will give us confidence leading into the T20Is," he said.

Bangladesh will also be looking forward to keep their unbeaten streak intact in the shortest format having won all the three T20I series they played so far in 2023 with the wins coming against England, Ireland and Afghanistan at their own back yard. A T20I series win in New Zealand will be the icing on the cake for the tourists as they prepare for the next T20 World Cup.

Bangladesh will play 11 T20Is before the showpiece event that includes these three matches against New Zealand while they are also scheduled to host Sri Lanka and Zimbabwe.

Apart from that the players will be playing in the Bangladesh Premier League as well. "Plan wise condition dictates. Lot of the plans we want to play at the same time we want to keep one eye on the T20 World Cup and so we are trying to get our plans right for that," Hathurusingha said. "We got 11 games now and then the BPL as well but this is a national team so we are trying to get our plans and

roles right within that period," he added.

Hathurusingha also reserved praise for Soumya Sarkar after he scored a century in the second game while picking up three wickets in the third game. "Very happy with the way he (Soumya) performed and I always knew that he is capable of playing," the coach said. "He has shown before when I was here

and we all say that class is permanent. Form affects many things, especially what goes through your head. The more clear you are and the more you understand the role and the more comfortable you are with the environment, every player maximizes their potential. He is in good head space and there is no reason that he can't perform in the T20 World Cup."
