RBI Keeps Repo Rate Unchanged At 6.5%



Mumbai (KCN): The Reserve Bank of India (RBI) on Friday maintained its benchmark repo rate at 6.5%, keeping its focus on anchoring inflation and boosting growth. The RBI also continued with its policy stance of "withdrawal of accommodation" to ensure inflation is in step with its target of 6% (+/- 2), while supporting economic expansion.

In other words, the central bank will be focussed on curbing money supply in the economy to control inflationary pressure. Monetary policy will remain actively disinflationary", RBI Governor Shaktikanta Das said after a two-day meeting of the bank's six-member monetary policy committee. He said that the central bank's

successive policy rate hikes, a reference to increases in interest rates, "seems to be working". The risks of high food prices continue to key be variables to watch that can alter the course of inflation. The global economy remains fragile due to elevated debt levels, lingering geopolitical tensions and extreme weather conditions, Das said, adding, "Long-awaited normality still eludes the global economy."

Mahua Moitra: From Investment Banker To Expelled Lok Sabha MP

New Delhi (KCN): Trinamool MP Mahua Moitra was today expelled from the Lok Sabha after a discussion on the report of the Parliament's ethics committee in the 'cash for query' case. The House held her guilty of sharing her Parliament account credentials and accepting gifts from businessman Darshan Hiranandani in exchange for asking questions critical of the Narendra Modi government in Parliament.

"This House accepts the conclusions of the committee that Mahua Moitra's conduct was immoral and indecent as an MP. So, it is not appropriate for her to continue as an MP," speaker Om Birla said. Ms Moitra, who was not



allowed to speak during the heated debate over the matter inside the Lok Sabha, read out her statement outside the House. "The (parliamentary ethics) committee broke every rule... Tomorrow, the CBI will be sent to my home to harass me," Ms Moitra claimed.

The 49-year-old, who is known for her fiery speeches in the Parliament, was an investment banker before she joined politics. She left her position as vice-president at JPMorgan Chase in London in 2009 and joined the Indian Youth Congress - the youth wing of the Congress party. Ms Moitra was said to be one of the trusted aides

of the party's former chief Rahul Gandhi in the 'Aam Admi ke sipahi' project. After a brief stint at the Congress, she joined the Trinamool Congress in 2010 and was offered a ticket from Karimpur in 2016 West Bengal assembly election despite much criticism from some party workers describing her as too "urbane". Ms Moitra, however, took on the challenge and successfully won the election. Ms Moitra, who is seen by many as the urban version of feisty Bengal Chief Minister Mamata

Banerjee, was given a Lok Sabha ticket in 2019 from Krishnanagar - a seat she won against her rival Kalyan Chaubey from the Bharatiya Janata Party. She was appointed the Goa in-charge for the 2022 Goa assembly elections. Hours after her expulsion today, Ms Banerjee dubbed the move as a "betrayal" of the country's parliamentary democracy. "It is a shame for parliamentary democracy. We condemn the way Mahua Moitra was expelled; the party stands with her. They (the BJP) can't defeat us in the election, so they have resorted to vendetta politics. It is a sad day and the betrayal of Indian parliamentary democracy," she told reporters.

Zoram People's Movement (ZPM) leader Lalduhoma was today sworn-in as the new chief minister of Mizoram. Several other ZPM leaders will also take oath as ministers during the ceremony at the Raj Bhavan complex in Aizawl.

On Tuesday, the ZPM Legislature Party elected Lalduhoma as its leader and K Sapdanga as the deputy leader. ZPM media cell general secretary Eddy Zosangliana said that the Val Upa Council, an advisory body of the party, met Lalduhoma on Wednesday to decide the formation of the council of ministers. Lalrinpuia is the lone

woman minister in the 12-member council of ministry. Seven of the 12 ministers are first time winners. The other ministers who took oath on Friday include, K. Sapdanga, Vanlalhiana, C. Lalsawivunga, Lalthansanga, Dr. Vanlalhiana, P.C. Vanlalruata, Lalrinpuia, all cabinet ministers rank F. Rodingliana, B. Lalchhanzova, Prof. Lalnilawma and

Lalnghinglova Hmar, all ministers of state rank. The ZPM, which was registered as a political party only in 2019, emerged victorious in the assembly elections bagging 27 seats, increasing its tally from 8 in the 2018 polls. It dethroned the Mizo National Front (MNF) headed by outgoing chief minister Zoramthanga.

State Clears JSL Project

Bhubaneswar(KCN): Continuing its effort to make Odisha an industrial hub, State Level Single Window Clearance Authority (SLSWCA) led by Chief Secretary Pradeep Kumar Jena today approved 19 projects worth Rs 4,804.35 crore with an employment potential for 17,553 persons.

Steel Major, Jindal Stainless Limited's proposal in establishing a stainless-steel service center unit in JSL Stainless Steel Park, Jajpur, with an Rs 150 crore has been approved by the State Government. The SLSWCA approved

the proposal of Welspun Living Limited to invest Rs 200 crore to establish a textile facility in Kendrapada, which will create 2,000 jobs in the apparel & textiles sector. Tata Steel Downstream Products Limited proposed to set up a 10,00,000 MT Steel Service Center in Kalinga Nagar, Jajpur with a cost of Rs 735 crore. It promises 335 potential jobs. In the steel (ferroalloys) sector, Indian Metals and Ferro Alloys Limited committed to invest Rs 977.43 crore in Jajpur to produce 2,20,000 MT Ferro Chrome and 20 MW WHRB Power. It will

create 1,190 jobs. Similarly, the SLSWCA has approved the proposal of Crackers India Alloys Ltd to invest Rs 101.50 crore in setting up a 52,800 MT steel casting mill & rolling mill with ancillary facilities in Barbil, Keonjhar. Envirocare Infrasolution Pvt Ltd's proposal to invest Rs 100 crore in Sundergarh for establishment of a mild steel strips and pipes manufacturing unit got the State's nod. The proposal of Rungta Paints Private Limited to set up a manufacturing unit in Dhenkanal for paints, allied products & intermediate was also

approved by the Authority. The company promised to invest Rs 991 crore and to create 700 jobs in the paint (Chemical) industry. Modulus Oleochem and Surfactants Private Limited's comprehensive Chemical Manufacturing unit in

Baliapal Industrial Estate, Balasore, with a cost of Rs 313.51 crore also got approval from the government. Transnova Express India Private Limited plans to invest Rs 120.39 crore in a Chemical Hub in Khordha.

The paint giant Berger proposed setting up foot in Odisha, two of its ancillary companies, namely, Grow Max India Private Limited with investment of Rs 54.55 crore. The second one namely, Anupam Products Ltd sets up an Rs 51 crore Manufacturing unit for Empty Metal Tin Containers in Khordha. Rajshree Polypack Limited and Kesav Plasttech (P) Ltd contribute to the Plastics industry with manufacturing units in Khordha and Rengali Industrial Area, Sambalpur,

respectively. The two projects will bring a combined investment of Rs 102.25 crores and are expected to generate 554 jobs. Dhansar Group initiates a Private Freight Terminal (PFT) under PM- Gati Shakti Multi Modal Terminal scheme in Sundergarh, with a cost of Rs 190 crore and the potential to generate 160 jobs in infrastructure. Kaibalya Logistics Private Limited's proposal to invest Rs 110 crore in a Multi-Modal Inland Container Depot (ICD) in Mahakalapada Block of

district Kendrapara also got SLSWCA's nod. Among other approved proposals, Ashirbad Food Processing Private Limited (Rs 56.35 crore), Summa Real Media Private Limited (Rs 226.57 crore), Vaswani Steel Pvt Ltd (Rs 237.80 crore), and GAIA Neo Energy Private Limited (Rs 87 crore). These projects spanning across diverse sectors from Apparel & Textiles to Infrastructure reflects Odisha's multifaceted growth strategy and steps towards industrial development.

BJD MP Raises Concern In Rajya Sabha Over Coastal Highway Project In Odisha

Bhubaneswar(KCN): Biju Janata Dal (BJD) MP Manas Ranjan Mangaraj today urged the Centre to come up with a Detailed Project Report (DPR) highlighting the status of implementation of the coastal highway project in Odisha.

During the Zero Hour in the Rajya Sabha, the BJD MP raised concerns over the inordinate delay in the completion of the coastal highway project in Odisha.

"Odisha has a coastline of about 480 km which makes the infrastructural development of the coastal districts all the more important for the economy of the region. The Central government announced a coastal highway project spanning 346 km in 2015



connecting 7 coastal districts of Odisha. The project would have proved to be an important development in terms of promotion of trade, tourism, communication and industry. However there have been undefined delays in the development of the project," MP Manas Mangaraj said. "It comprised two parts- one connecting Rameshwar to Ratanpur and the other one connecting Ratanpur to Digha. It was to be developed under 4 packages. Initially, the first 2 packages were cancelled without any defined reason on the part of the central government. After the clearance of these 2 packages, the project was stalled due to the unavailability of environmental clearance from the Environment

Ministry. However, the clearance for the same has been provided since August 2023. But there has been no headway made in the project yet by the Central government," the BJD MP apprised the Upper House of the Parliament. The BJD MP further urged the Central government to come up with a Detailed Project Report (DPR) highlighting the status of implementation of the project. The central government needs to work towards completion of the coastal highway project as soon as possible because eight years have already passed since the announcement of the same and no significant development has been made as of now," the Parliamentarian concluded.

district in West Bengal, was arrested on December 4. He was produced before the Additional Chief Judicial Magistrate, Lalbag, and was brought to Bhubaneswar on a three-day transit remand to be produced before the SDJM court. Islam was one of the key members of the racket, having links mainly in West Bengal and Bihar the STF said. Earlier,

the STF arrested three scammers—Sk Hapizul, and Sk Jahangir, both of Balasore district and Sk Jamiruddin of Rampura—under the Mohanpur Police Station in West Medinipur. The scammers were running mule bank accounts and sold these bank accounts, along with their connected mobile numbers, to various cyber, cyber-financial, and

India is on the brink of a plastic catastrophe, with staggering projections of mismanaged waste and environmental consequences. In 2023, the country is

into waterways. This crisis is fueled by factors such as increased urbanization, the rise of retail chains, and pervasive plastic packaging for various products.

India's per capita plastic consumption soared to 15 kilograms in 2021, and the demand for polymers has steadily risen, reaching almost 21 million tons in the same year.

Maharashtra led the plastic waste generation in the fiscal year 2020, contributing 443,724 metric tons, while

emphasizes the need for comprehensive action from governments, corporations, and individuals.

India's plastic consumption is projected to reach 64 million tonnes by 2033, requiring a shift to circular economy principles. However, challenges persist, with 4,953 registered units and 823 unregistered facilities working with plastic across the country.

The informal sector, managing 42–86% of waste, faces limitations in disposal methods, contributing to environmental damage.

While the Indian government claims a 60% plastic recycling rate, data suggests a stark reality—only 12% is recycled, and 68% remains unaccounted for. Legislation to restrict plastic use has been enacted, yet the plastic production surge during the pandemic exacerbates the problem.

Book Festivals of Odisha: Looking back and forward

Doing a Literature Festival or a Book Fair has now become a business or political circus. But it was not there when I entered to the field of Book Publishing over three decades back. I did the first ever National Book Fair at the Exhibition Ground, Bhubaneswar way back in 1992. I was also the part of the first ever 'Pustak Parikrama' (Books on Wheels) in Bihar the same year.

How I became a part of the first ever Books on Wheels show is an interesting story. Shri Anand Swaroop was Chairman of National Book Trust in 1990 when I joined. He was a dreamer. He was the person behind National Policy on Education, National Centre for Children's Literature and many others. His dream was, books should reach villages, say each door steps. NBT bought several Book Vans during his tenure. His able deputy was Arvind Kumar, the then Director. So, the first ever Books on Wheels was planned. It was at two parts of the country, south and north. If I correctly recollect, the south one began at Chennai and the north one at Varanasi. The north one covered U P and Bihar and the South one Tamilnadu and Andhra Pradesh. Jharkhand, Uttarakhand and Telengana were not separate provinces at that time.

reached Cuttack with two drivers Dharam Pal and Pandey on one fine morning. It was not possible for the vehicle to enter to Balubazar. We parked our van near Sunshine Field. All the publishers came there with their book bundles. We took the books and went to Bhubaneswar to pick up books from the publishers there at Odisha Sahitya Akademi campus.

Inspired by the Bihar experience, I proposed a similar exhibition in Odisha. The Odisha Publishers and Booksellers Association led by Shri Pitamber Mishra whole stood by me. The other partner was Odisha Sahitya Akademi of which Shri Rajkishore Mishra was then Secretary. We had a dilemma, if to begin it from Puri or some other part of Odisha. Since I worked in Koraput district and is from Puri, everybody expected that I will like to begin from any of these. But I had a different take. During my tenure in NCERT, I used to visit Sambalpur and Bolangir very often. I had a nostalgic touch. I did a few months schooling in my class 2 at Sambalpur.

How shall it be if we begin at Bargarh? I asked all. They were all surprised. Bargarh had no reputation as a market for books at that time. There was a Gandhi Pathagar, a block called Atabira where my friend and brother Aswini Kumar Mishra was BDO, a place called Laramba where my favourite actor and the first super hero of Odia films Sarat Pujari was Principal in a College, and Bargarh had a renowned author Dayal Joshi, these were the only that I had in mind.

But all approved my plan to go ahead. Our mobile van

if we can reach there in time. Bargarh did not have a hotel that time, but a decent Marwari Dharamshala. Our only hope was Dayal Joshi. We met him and he gladly accepted our invitation to inaugurate the exhibition at 5 pm. We sold books worth over 55 thousand INR in that Book Exhibition, the highest those days in India in such an exhibition of 4 days. Rest is part of History.

This is the journey of Indian Publishing and how the first ever Mobile Book Exhibition in Odisha at Bargarh, then a sub division of Odisha took place. But alas, the new generation of Book Fair Organisers at Bargarh are possibly not aware of their glorious past in the history of Indian Book Industry!

People have also forgotten that I did four National Book Festivals in Odisha at Bhubaneswar, Rourkela, Brahmapur and Puri besides ten more in the North Eastern Region and twenty World Book Fairs. I was the only Odia who was Adviser to National Book Development Council, Singapore and Director, Art and Culture of North Eastern Region. That's now history. If I tell the truth, people feel that I am beating my own drum. But, how long can I remain silent? I have been in a festival of memories for the last two years.

Of course, there are umpteen numbers of posh areas outside south Delhi too. "Well, South Delhiwallas are not interested in you if are not from their world. They don't want to spend their energy in finding

match outside south Delhi," feels Dr. JP Sharma 'Trikha.'

Just look some of the recent matrimonial advertisements that have published in recent days in major newspapers published from capital.

-Punjabi Khatri well settled family of South Delhi is looking for match for their 1984 born/ 5 '2' daughter. Running independent family business. Caste no bar.

- Khatri, 33, 173CMS, Director, lives in South Delhi, father is an industrialist. Looking for a compatible match.

- Punjabi Brahmin, 190/ 5.11', LLB, MBA, CA Final, Lawyer, South Delhi. Seeks well qualified girl.

Can you find what is similar in these three matrimonial advertisements that were published in the Delhi edition of well-known newspaper on October 29, 2023? If you could not, we will tell you what makes these ads similar even though one is for a groom, the other two are for bride. Well, the South Delhi factor unifies



these advertisements. If you scan through the matrimonial advertisements that are published in Delhi based English and Hindi newspapers, you would find plethora of such advertisements where the advertiser has ensured that 'South Delhi' is incorporated in the matrimonial advertisements. This is a clear cut announcement from them that they would only welcome

proposals from South Delhi residents. This is also a subtle message that others may excuse them. Their proposals would be rejected. They somehow believe that with mention of South Delhi in advertisements, it would make them special and different from the rest. Moreover, South Delhi residents would respond to them. "It is an undisputed fact that South Delhi wallas only look for groom and

bridge of their kids inside the notional 'four walls' of their south Delhi. They only want to establish ties with those who live within south Delhi, says Dr. JP Sharma 'Trikha'.

It is almost unthinkable for any South Delhiwalla to think of marrying outside 'their Delhi'. They feel comfortable with South Delhiwallas only when it comes to marriage. Yes, over the last couple of years, they (South Delhiwallas) have started considering Gurugram as their own to some extent. Hence, they consider marriage proposal from Gurugram residents too. It goes without saying that Gurugram is an upmarket area South of Delhi if not in South Delhi. It is full of IT companies. Thousands of expatriates live there.

Says social scientist Aroon Kumar Delhiwallas are rank class conscious people. For them, address matters greatly. They think that your class changes when you live in South Delhi even if it is some Central government employees'

residential area. It is not easy to change that mind set. Over the years, many posh areas have come up in places other than South Delhi and NCR. Yet, living in South Delhi still gives another kind of high to Delhiwallas.

Of course, this is another kind of apartheid that is going on due to mindset of South Delhi people. Who would challenge this blatant apartheid in the marriage market? JP Sharma 'Trikha' is not sure whether South Delhi residents would consider others as their own while looking for a match of their kids in the near future. According to him, "Some youngsters are breaking the rule and moving out of South Delhi though. However, they are very few."

Interestingly, people of all castes and religions in South Delhi have similar thinking when it comes to finding a match. They don't want to cross the limits of South Delhi. It is a fact that cannot be disputed. Notwithstanding huge parking issues and some Central government employees'

temptation to live in South Delhi remains among very large number of Delhiwallas. They are convinced that south Delhi address gives them huge edge socially.

"If you live in any residential colony near or beyond Ring Road in south Delhi, then you would be considered as a special person. I was staying in IPEX in East Delhi before moving to South Delhi. When, I purchased a floor in Saferjung Enclave, my friends told me 'you have arrived. Now your class has changed'. That was something I was not expecting," reveals S. Ajay, a well-known film maker. He says that South Delhi people are very unsocial people. They think big that they don't know their next door neighbour.

Finally, Dr. JP Sharma says that it is almost impossible for you to find an example when someone from South Delhi is getting married in East Delhi. For South Delhiwallas, East Delhi is like a third world country. Ends.

IN THE MIDST OF LEGAL CONUNDRUM: PLATFORM WORKERS IN INDIA



The last decade has witnessed the rise of online platforms using digital technologies, including algorithms, artificial intelligence, to meet the demand and supply of labours which has gained globally.

The disruptive nature of the online platforms, rapid growth and their focus on intensive use of labours, brought them under the ambit of policy and regulations amidst of debates of taxation, unfair competition and the workers conditions.

The number of digital labour platforms globally have increased multi-fold during the last decade according to ILO(2021). The numbers are more staggering in the Group of Twenty (G20) countries, where the digital platforms grew from 128 to 611 only in a decade representing 79% of the such platforms operating throughout the world. Amongst the G20 group India which comprises of 10% of the digital platforms needs to be highlighted as the new frontier of platform revolution given the advent of

urbanisation, usage of smartphones and application of technology.

According to NITI Aayog (2022), approximately 6.8 million platform workers in 2019–20 engaged in web- and location-based platforms, constituting 1.3% of the total workforce in India. It is further projected that the size of this workforce will grow by 4.1% of the total Indian workforce by 2029–30. Even though it is clear that about the rise in employment growth of these platform workers but there are questions about the standard employment relationships and legal protection for these workers which needs to be answered. In this piece we strive to look into the pertinent questions of What is the legal employment status of this ever-growing workforce in India? Are they independent contractors or employees of the platform?

Legal Autonomy for Platform Workers The autonomy for platform workers varies across the digital platforms as this economy is heterogeneous in

various sectors. However, on a broad categorisation platform work can be categorised as 'crowd work' or 'app-based work' or 'location-based work' pertaining to delivery, driving and so on. In India the concentration of workers in the digital platforms is on the rise and this is going to reduce the workers in medium-skilled occupations. Moreover, the visibility of the location-based platform workers plying on the road though more are characterised as low-skilled work.

In the legal context, in "platform", employment contract lays down the workers rights, entitlements and the benefits which are extended to them. The legal construction of the who is an employee or a contract worker and the nature of work are as per the law. The contract becomes the instrument that draws out the relationship which does or does not align with how both the employee and the "platform(the company)" – work. We looked into some of the famous cases in common law jurisdiction where the court looked beyond the service contract and interpreted the nature of the work. In this landmark case Uber and Others v.

In the case of Uber and Others (2021), Uber drivers were held to be 'dependant contractors' of the company by the Supreme Court of UK. Subsequently, in Klooger v Foodara Australia Pty Ltd (2018), in this case a terminated food delivery employee of Foodara through applying the principle of work control and supervision test was held to the employee. Moreover, glancing through the common law jurisdiction, it is seen that employment status is determined through the degree of autonomy and control of workers by their employees.

In India, the Supreme court has devised the twin test of 'control and supervision', in Dhranagadhara Chemical Works Ltd v State of Saurashtra (1957). This test establishes not only the relationship between employer-employee but also exercise control and the manner in which the work needs to be done. This test was opined in the case of contractual employees.

Another, aspects which needs to be borne is the high level of informality of the workforce in India, which makes it difficult to look the platform workers only through the lens of standard employment. The enactment of parallel

laws for the formal and informal sectors of workforce makes the point. The formal sector in which the employer-employee relationship is clearly defined, is governed by labour laws as Minimum Wages Act, 1948; Industrial Disputes Act, 1947; Factories Act, 1948; and Industrial Employment (Standing Orders) Act, 1946.

However, many home-based, small scale industrial/ production units, leaves out millions of informal workers without providing a adequate employment security or social security. Most of the workers are look for the recourse from the State for regulation of minimum wage or social security schemes under the Unorganised Workers' Social Security (UWSS) Act, 2008. Also, looking at expansion of labour laws by the Supreme Court of India it is hesitant to apply the automatic absorption of contract worker in the absence of explicit notification.

The Legal Conundrum In India, the informal urban sphere of labour are leveraging the ever-growing platform economy and proving employment opportunities to the unorganised workers. But these also points

towards the 'precarious working conditions' in the platform work. The question 'How is platform work precarious' is yet to find a legal response. For instance, the NITI Aayog report (2022) addresses the health risks, road safety, physical assault, theft, occupational safety and limited bargaining power and isolated work arrangements of the platform workers.

The report however could have provided a direction through the Code on Social Security CSS, 2020 and the policy path for platform workers in India.

The legal framework itself leads to the legal conundrum in how platform and gig workers are defined under the Code on Social Security (2020) from the unorganised sector workers. A close look at the legal definition of wage worker under the UWSS Act, 2008 and now the Social Security Code, explains there is coincidence in the nature of platform work and the definition of wage worker. Similarly, it coincides with the definition of contractual labour under the CLRA Act, 1970. The Indian labour courts echo this confusion, as the definition is not consistent across different sections of

laws that applied to different types of workers could overlook the sector/ industry-specific heterogeneity among different classes of workers. We find that there are complaints registered by the on-location platform workers but the labour courts are not sure on how to deal with these complaints in the absence of a clear employment relation and a legal definition.

This legal picture is the legal vacuum which has created a legal uncertainty thus instilling legal complexities to determine the legal employment status of the platform workers.

To address this Firstly the court should start treating platform/gig economy as single entities having two distinct user groups; and Secondly given the lower safety nets for platform workers, the courts must not only attempt to harmonise the employment tests but also the fundamental rights etched in the Constitution of platform workers.

However, it has been clearly stated that all valid projects should be uploaded by December 10 and 60 per cent of these projects by December 20.

Pradhan Plea On PM-USHA



Bhubaneswar(KCN): Union Education Minister Dharmendra Pradhan wrote a letter to Chief Minister Naveen Patnaik for implementation of the Centrally Sponsored Scheme of Pradhan Mantri Uchchatar Shiksha Abhiyan (PM-USHA) in Odisha.

CSA clear Teeger, but that's not the end of the saga

New Delhi: Expect to see David Teeger's name at the top of the list when South Africa's men's under-19 World Cup squad is announced on Friday. That prediction, as banal as it is, will fuel competing fires that have leapt cricket's boundaries.

Some will celebrate the continuation of Teeger's tenure as captain, should it be confirmed. Others will be disgusted that he remains in the squad. Both sides of the argument will be driven by South Africans who have been fighting this fight for weeks. The ongoing alteration could spill over into contending protests at or near matches in the under-19 World Cup, which will be played in South Africa from January 13 to February 4. On Thursday an independent investigation cleared

Teeger of breaching CSA's and Gauteng's codes of conduct - which are identical - for making this statement: "But more importantly, yes, I've been awarded this award, and yes, I am now the rising star, but the true rising stars are the young soldiers in Israel... So I'd like to dedicate this award to the South African family that married off one son whilst the other is still missing. And I'd like to dedicate it to the state of Israel and to every single soldier fighting so that we can live and thrive in the diaspora."

Teeger said this in Johannesburg on October 22 after being presented with the Rising Star Award at the Jewish Achiever Awards function. His comments were published by Jewish Report four days later. Three weeks after Teeger spoke, the

Palestine Solidarity Alliance (PSA) lodged a complaint with CSA. The PSA called Teeger's views - which alluded to Israel's sustained bombardment of Gaza in the wake of the October 7 attacks by Hamas - "a provocative and inflammatory political statement". Many were aghast at

Hamas' vicious assault on Israeli civilians, which robbed 1,200 of their lives and facilitated the taking of more than 200 hostages. Many others have voiced alarm at Israel's response, which has killed more than 16,000 Palestinians and wounded more than 44,000. Gaza's infrastructure has been

crippled in the process, and more than 1-million people have sought shelter in United Nations facilities. Rarely are those who cast Hamas' actions as terrorism able to recognise Israel's reaction as disproportionate, brutal and inhumane. Neither do most who hold up

Hamas as heroes of a struggle that started in 1948, when the creation of the Israeli state forced Palestinians off their land, acknowledge that Israel should even exist. It is an intractable struggle that the world's best diplomatic and political minds have been unable to resolve. What chance did an 18-year-old schoolboy have of not getting it wrong, thereby angering much of South Africa's muslim community of around 1-million? What chance did he have of his words not being seized upon and amplified by the ethno-nationalists firmly in Israel's corner among the 52,000, or so, jews in this country? A far smaller chance, on both counts, than if he hadn't made his impromptu but also unprompted remarks. But, you will hear it said, freedom of speech is protected in South Africa, along with freedom of religion. That the first of those freedoms comes with responsibilities and consequences - including for 18-year-old schoolboys - is less often noted, and still less that freedom from religion - rather than of religion - in the public realm is a right every democracy should pursue.

On the face of it, Teeger is a worthy recipient of the prize he won. From July he has scored three half-centuries in seven one-day innings for South Africa's under-19 side and a South Africa Emerging

cricket? On December 3, Business Day, South Africa's last remaining serious English-language daily newspaper, published a letter from Mandy Yachad, a rebel-era cricketer and religiously observant jew. Sreesanth Accuses Gambhir Of Using Offensive Language In Legends League Cricket Spat

New Delhi: The Legends League Cricket match on Wednesday between Indian Capitals and Gujarat Giants took an unexpected turn as former teammates S Sreesanth and Gautam Gambhir engaged in an on-field spat. The controversy escalated when Sreesanth went live on Instagram, accusing Gambhir of using derogatory language, including calling him a 'fixer.'

Sreesanth initially labelled Gambhir as "Mr. Fighter" and described their altercation as rude and disrespectful. However, he refrained from divulging details. In a subsequent Instagram live session, Sreesanth disclosed the specifics, alleging that Gambhir



used foul language, repeatedly calling him a 'fixer' on live television during the match. Gambhir responded cryptically on social media, seemingly indifferent to Sreesanth's claims. This comes amid accusations that

Gambhir is utilizing his Public Relations agencies to manage the fallout. Sreesanth countered these claims, urging the public not to fall for extra PR work and emphasizing the authenticity of his statements.

Sources from the Board of Control for Cricket in India (BCCI) have revealed that star opener Shubman Gill will also join his teammates, flying in from the UK. Gill went on a holiday post the World Cup final on November 19. It is already known that

Deepak Chahar has not travelled with the side to South Africa due to a family issue back home.

His father is believed to be ill, and it is still not clear when the pacer will be able to fly to South Africa. However, sources say he could reach there soon and no replacement for him has not been named. The Rajasthan and Chennai Super Kings pacer has been included in the One-Day team as well. It is understood that all of them have taken permission from the BCCI to join the team, as has a member of the support staff. All are expected to be in Durban well in time before the first match on December 10, a Twenty20 match. After two more T20Is at Gqeberha and Wanderers in Johannesburg on December 12 and 14, there will be three ODIs on December 17, 19, and 21 at Johannesburg, Gqeberha, and Paarl. The first Test, starts on Boxing Day at Centurion and the second and final Test is at Newlands in Cape Town from January 3. There will be three India A games in between - from December 11-14, December 20-22, and December 26-29.

Munro, bowlers give Heat crushing win in tournament opener

New Delhi: Virat Kohli, the highest run-scorer of the ODI World Cup 2023, may not be the first choice for India's T20 XI in the upcoming T20 World Cup 2024. The Board of Control for Cricket in India (BCCI) officials engaged in a crucial five-hour-long meeting, signalling a potential shift in T20I leadership, according to Dainik Jagran's resources. Despite Kohli's outstanding performance in the ODI World Cup, reports suggest that his position in the T20 World Cup squad is not guaranteed. With only six T20Is scheduled before finalizing the World Cup squad, BCCI officials conveyed their preference for Rohit Sharma to lead



the T20 side. Both Rohit and Jasprit Bumrah are considered automatic choices, raising questions about Kohli's spot in the playing XI. While Kohli rewrote records in the ODI

World Cup, becoming the first cricketer to score over 700 runs in a single edition, he is currently not the preferred choice at No.3 in T20Is. Reports suggest that the selectors and the board are eyeing a player who

as he generally opens for the Royal Challengers Bangalore in the IPL. With opening slots likely filled, the selectors contemplate Kishan for No.3. The likes of Suryakumar Yadav, Rinku Singh, Hardik Pandya, and Ravindra Jadeja are expected to complete the batting order.

The selectors plan to discuss Kohli's T20I future with him soon, recognizing the need for transparency. Kohli, who has not played a single T20I since the 2022 T20 World Cup, will be considered for selection based on his performance in IPL 2024. His decision to opt out of the white-ball leg of the South Africa tour adds an air of uncertainty to his T20 future.
