Night Curfew Relaxed by 1 Hour

Bhubaneswar(KCN): With the little improvement in the Covid-19 situation in the State, the Government has reduced the night curfew timing in urban areas by an hour.


Now, the night curfew will be enforced in the urban areas of Odisha from 10 PM to 5 AM, as per an order issued by the Special Relief Commissioner (SRC) Pradeep Kumar Jena. The State Government has extended the guidelines and restrictions imposed in view of Covid-19 and Panchayat elections through various orders during the month of January will remain in force till February 28.

As per the order, all types of shops, malls, shopping complexes, markets/haats, cinema halls, swimming pools, entertainment complexes, theatres, auditoriums, assembly halls and similar places can remain open across the State from 5 AM to 10 PM every day.

The company has huge debt and liabilities exceeding Rs 6,600 crores as on 31.3.2021, including huge overdues of pro-

Core Group of Secretaries on Disinvestment (CGD) and the empowered Alternahas emerged as H-1 creditors and employtive Mechanism.

> Government Odisha with their companies, OMC & IPICOL having stake of 32.47% was also part of the decisionmaking at every stage. The Expressions of Interest (EoI) were invited on January 25, 2021. Multiple EoIs were received by the due date of March 29, 2021. In response, three bids were received by the due date. crow account. On the closure date, shares will be transferred to the strategic buyer and the balance amount will be received to be utilized in the manner prescribed in the waterfall agreement October 27, 2021 signed amongst the selling shareholders.

Part-sale proceeds would be infused in the company to the extent of the liabilities which will be setoff and the balance amount in the escrow account will sell shareholders proportional to their shareholding.

This is the first instance of privatization of a public sector steel manufacturing enterprise in India. The success of the transaction is a win-win situation for all. The biggest advan-

tage of privatization will be to the local economy of the region as the strategic buyer will be able to revive a closed plant, bring in modern technology, best managerial practices and make infusion of fresh capital, which will help in augmenting the capacity of the plant, officials said. The Government of Odisha has given active support to the process privatization. The privatization will help in creating new jobs in the region by creation of ancillary industries supplier's network. Keeping in view the best interest of the serving employees, it was decided to keep

the employees' dues as the top most ranking liability in the Waterfall Agreement to be satisfied first before any other liability, they said.

The transaction is on "going concern" basis and the employees of NINL will continue to be the employees of the company in terms of the Share Purchase Agreement (SPA), which binds the buyer to have a lock-in period of one year. The strategic buyer will also be bound to follow the terms of VRS applicable to CPSEs whenever such a decision is taken. Postsale consideration will go towards settling of the liabilities of the company, in the order provided in the

with the Awaas+. Mr.Jena also demanded sanction of 1.84 lakh Special PMAY (G) houses as promised during May, 2019 to Odisha in the aftermath of cyclonic storm Fani and open of the Awaas+ window for some time to incorporate names of eligible left out families.

While the genuine demand of Odisha has not been paid heed to by the Ministry of Rural Development so far, synchronization of data from Karnataka State Government MIS into ther deprive lakhs of tribal beneficiaries living in the Scheduled areas of the State and deserving poor people belonging to KBK region and Western parts of the State. I would request your august office to rectify this injustice being meted out to the State of Odisha and its people," Mr.Jena told Mr. Singh in the letter. In December, the Chief Minister had written a letter to Minister Prime Narendra Modi demanding 14.84 lakh housing units under PMAY-G. The Ministry of Rural

Development (MoRD) has allowed identification of eligible left-out families through Awaas+ by March 7, 2019. However, the State could identify only 35,000 families within this stipulated period because of pre-occupation of government machinery in preparatory work for general elections-2019, network connectivity issues and LWE violence in some pockets of State.

The Prime Minister had promised to allot 5 lakh PMAY-G (special) houses to Fani affected families during his visit in May 2019.





two institutions which form the bedrock of democracy, if a news report published in the New York Times on January 28, alleging Prime Minister Narendra Modi inked a deal accepting NSO's spyware Pegasus as part of a \$ 2 billion sophisticated

missiles and intelligence package for India, is correct. Modi's visit to Israel was the first-ever such visit of an Indian prime minister to Israel. Union minister V.K. Singh, rubbished the sensational news report published by the world's most respected newspaper, New York Times, calling it "supari media." This minister formerly headed the Indian Army and is the first general to have accepted a ministerial berth after retiring as a general. Be that as it may, what is even more sensational is that the Modi government has been accused of supporting Israel in the United Nations by voting against observer status for a Palestinian-based human rights body, on suspicion that it had links with terror outfits. This has been rubbished by India's permanent ambassador to the U.N. at that time, Syed Akbaruddin.

The Pegasus spyware which can be used by governments to snoop on whomsoever they choose in the name of national security, infects all mobile phones without the knowledge of the victim. It does not need the victim to click on a link as more primitive spywares do. An innocuous message is sent which activates the camera and collects data of all contacts, photos, locations, conversations even with the camera turned off.

This news was followed by a disclosure that the devices of certain Indians had been infiltrated, which was confirmed by theminister of lawand electronics and information technology in a statement made in Parliament on November 20, 2019.

The Supreme Court's stand on questioning the government emerged from its judgment last year when it clearly said judicial review was not intended to create judicial oligarchy, or covert legislation. Hence what should be debated in Parliament and in the media cannot be transferred to the judicial arena, the judgment of the three-judge bench laid down. The point is that the government wanted to set up an expert committee to probe the allegations levelled in a batch of writ petitions filed in the Supreme Court. But the petitioners opposed this saying this was tantamount to the government probing itself and the committee lacked credibility. No less a person that the solicitor general of India told the judges that the committee set up by the government would comprise experts who would not be influenced by extraneous factors. But such a governmentappointed committee was shot down by the petitioners who approached the Supreme Court because their mobile phones were allegedly infected by Pegasus.

A designated senior advocate Shyam Divanof the Supreme Court said his phone was allegedly infected by the Pegasus software and wanted this special committee to be set up. Another senior advocate Rakesh Dwivedi, said several senior journalists were victims of the Pegasus attack and if the government had sworn an affidavit that it had not used a malware or spied on its citizens in an unauthorized manner, the petitions would have

The three judges who heard the case were Chief Justice of India N.V Ramana, Justices Surya Kant and HimaKohli. They said the first requirement was there must be a law in existence to justify an encroachment on privacy which violates Article 21. Second, the requirement of a need, in terms of a legitimate state aim, ensures the nature and content of the law which imposes the restriction falls within the zone of reasonableness as against arbitrary state action. Judicial review does not reappreciate or second guess the value judgment of the legislature but is for deciding whether the aim which is sought to be pursued suffers from arbitrariness. The third requirement ensures that the means which are adopted by the legislature are proportional to the object sought to be achieved.

A committee of three judges headed by retired Supreme Court Justice R.V. Raveendran has already issued an advertisement in all national newspapers calling for those who believed their mobile handsets had been infected to hand over their devices for forensic analysis with their reasons why they felt the government had put their under surveillance. Needless to say, very few journalists or activists will respond to such an advertisement jeopardizing their sources of information.

This is why it is unlikely that anything significant may emerge from the committee set up by the Supreme Court to probe the Pegasus surveillance scandal which has rocked the nation. Given that the government will never admit to using the spyware against its own citizens and the fact that it will stonewall such endeavours to collect information, it is highly unlikely that the committee will find anything significant.

BHUBANESWAR: Amid a gradual fall in the Sawaswati Puja, Magha Saptami and Magha daily infection count in the state, the Odisha Purnima in the month will be observed with

Saraswati Puja will be observed in temples and religious places without participation of devo-

tees, while it will be allowed in educational institutions with participation of a limited number of students and proper adherence to Covid appropriate behaviour. The SRC, however, clarified celebration of the Puja will not be allowed in

public places. People celebrating Puja at home have also been advised to follow Covid safety

norms and avoid mass gathering.

Lage congregations at rive banks, ghats, sea shore and water-bodies will be allowed on the occasion of Magha Saptami and Magha Purnima. The rituals of these festivals will be allowed inside temples without participation of the devotees.

"No community feast associated to Saraswati Puja and other festivals will be allowed. There will also be restriction of musical and entertainment programmes in this period," the guidelines stated.

The SRC has allowed functioning of government, autonomous and private offices with 100 per cent staff. The General Administration department will issue detailed guidelines and SOP to this effect shortly, he said and added that virtual meetings and training will be encouraged to check transmission.

The government in its guidelines, however, has not brought any relaxation to the restrictions imposed on the crowd limit for weddings and other social functions. Besides, no decision has been taken regarding reopening of schools and colleges in the state.

Biodiversity park in Kerala's Kottayam district is a devotee of the nature KOTTAYAM: In the midst of 35 acres of land, a large pond is the abode of more than 65 va-

rieties of fish species. A few meters away, a temple pond proclaims the rich traditions of the past. Near to it, a 'sarppakavu' (a place

considered as abode of snakes) reminds about traditional culture of conservation of biodiversity. Surrounded by them, nearly four lakh trees and plants of 4800 species make the land a unique place, perhaps, in the world. This is Mango Meadows Agriculture Plea-

sure Land, a biodiversity park situated in Ayamkudi, a small hamlet in the paddy-rich Kallara grama panchayat of Kottayam district. The rare repository of a wide variety of flora and fauna is the result of two decades-long hard work and dedication of a man, who loved Nature more than anything. Meet Nellikkuzhi Kuriakkose Kurian aka NK Kurian, who dedicated his life to the conservation of nature.

Except for a few nature lovers and social media persons, NK Kurian, a native of Kallara, is not a familiar name.

The 51-year-old civil engineer carved out a niche in history by developing a bio-diversity park having 700 varieties of trees, 85 varieties of vegetables, 145 fruit trees along with fish, cattle, canines, goats, rabbits, and ducks in just 35 acres of land.

However, the road to the park was never a cakewalk for Kurian, who spent nearly 15 years in Saudi

Arabia and UAE as an employee and a businessman. It was in 1995 that Kurian, who can be termed as an earlier form of 'Cuba Mukundan' of Malayalam movie 'Arabikkatha', was sent to Saudi Arabia by his parents and party workers.

After three years of tiring jobs in Saudi, Kurian shifted to Dubai and found a better job in the field of aluminum fabrication works. His hard work and a boom in the construction field of Dubai in early 2000's helped Kurian in finding a handsome remuneration.

He soon started his company and increased his revenue. Even then, his thoughts hung on to his native village and he bought a few acres of land having a pond in the middle in Ayamkudy in 2002. In the middle of his 30's, he relinquished his business in UAE worth millions of rupees and deposited his entire earnings in preserving nature and biodiversity by developing an agriculture park.

He traveled across the country and even abroad to collect various plants and seeds. With his concentrated efforts and hard work, he widened the area of the land and developed an unparagoned land of biodiversity

For nature lovers, it is nothing but a wonder,



as a vast variety of floras, right from 'Kattupoovarasu' (Rhododendron arboreum), which grows in below five degree Celsius to Date Palm, usually flourishes in around 45 to 50 degree Celsius, are being developed in a single stretch of land having comparatively high atmospheric temperature.

"Before venturing into cultivation, I widened the pond to develop an ecosystem on its banks. Now, there are four ponds in the park, having an area of 50 sq. metres to 150 sq. meters and depth up to 2.5 meters. All four ponds are interconnected with tunnels through which fish can move to all the ponds. One of the

ponds is developed as a temple pond, which is deeper to ensure sufficient water for fish even at the peak of summer season," Kurian

The predominant idea behind the initiative was to retain the tradition and culture of Kerala for the next generations, for them places like sarpakavu would be a thing of the past.

"The sarpakavu is primarily considered as a virtue. However, many of them were destroyed over the years. Whatever is the belief or myth, Sarppakkavu consists of particular varieties of flora, which may not have any direct use for people. A kavu is developed to conserve such species from extinction," he said.

Apart from tradition and culture, the park is also an abode of several rare species of trees and plants like Maha Vilva (Aegle Marmelos), which is considered a sacred as well as medicinal plant, Ficus Alii, facing extinction, Mangrove Apple, one of the rarest species that bears edible fruits, Beggar's bowl or Calabash, which was abundant during the period of Sree Budha, Rudhraksha and so on.

Though he invested millions of rupees for developing the park, he kept it without any commercial purposes till 2018. Later, when financial difficulties started affecting him, Kurian opened it for the public in February 2018.

COVID effect: Caterers, tent house owners in Bhubaneswar seek hike in crowd limit to get over losses

BHUBANESWAR: Hit hard by the restrictions imposed across the State in view of the COVID-19 pandemic, catering service and tent house owners have urged the government to increase the number of guests allowed for weddings and other social functions to at least 300. The catering service and tent house owners in the Capital said that the pandemic has dealt a blow to their businesses they have incurred losses in crores in the last two years. "The losses sustained by the caterers and tent house owners in Bhubaneswar zone, comprising the State Capital, Khurda and Jatni, alone are around Rs 70 crore in the last one year. Imagine the amount of losses the sector would have incurred across the State," said Biswa Prakash Bhadra, owner of Grand Caterer and Tent House in the city. The losses are also affecting the State exchequer as the government gets huge amount in taxes from the industry, he said. Bhadra said the restrictions have left around 30 lakh persons, dependent on the sector directly or indirectly, in a lurch. Binay Bhusan Patnaik of Sristi Catering said the restriction on social gatherings imposed Bhubaneswar Municipal Corporation (BMC) has come as a doublewhammy for them as it is half of what the Special Relief Commissioner (SRC) had permitted in his January guidelines. "While the cap on maximum gathering for a wedding had been fixed at 100 in the State this month, it remained 50 within BMC jurisdiction leaving us in a lurch," he said. Patnaik said the busi-

nesses of caterers and tent houses had started picking up slowly, after the restrictions were eased and the ceiling on gathering restored to around 250 during November and December.

BJP slams Odisha government over illegal construction on Lingaraj temple land

BHUBANESWAR: The BJP on Sunday came down heavily on the State government for alleged illegal construction on land belonging to Lingaraj temple.

State BJP president Samir Mohanty said construction on the temple land is being carried out near the Biju Patnaik International Airport (BPIA) which is not far from the residence of Chief Minister Naveen Patnaik.

The State government cannot deny that the illegal construction is being done without its knowledge. "Any construction within the city limits is not possible without the

(BDA). It is for the BDA to explain how such illegal activities are going on and who gave permission for the same," he asked.

Mohanty said 18 acre of temple land name of the temple trust.

The temple land was illegally sold to a big real estate company for construction of a luxury hotel. The court had ordered that the proposed

two-and-a-half acre land on which construction activities were stopped by the local administration is close to the plot where the luxury hotel was coming up. This clearly shows

not safe under the BJD government," Mohanty alleged and urged the government to take prompt action to recover all the temple land which are under unauthorised occupation.

Referring to a December 2021 report of the Comptroller and Auditor General of India (CAG), the BJP leader said only 31.556 acre out of 1523.879 acre of the immovable property of Lingaraj temple across the State is under the actual possession of the temple trust.

The executive officer of Lingaraj temple had informed the auditors that 36.370 acre out of 69.423 acre land in Bhubaneswar is under encroachment.

It's said that in economics, the majority is always wrong. The Economic Survey 2022, in an unshowy way, attempts to tell us how.

Tabled in the Parliament on Monday, the Survey, in a give-mefive tone glosses over the success of government's Covid-19 policy response and emphasises how supply-side measures pulled us out of the economic blackhole. India is well placed to take on the challenges this year, it noted, yet the Survey's chief architect, Principal Economic Sanieev settled for a conservative growth projection of 8-8.5% for FY23.

Most macroeconomic indicators are pulsing with adrenalin, but the economy isn't antifragile yet and any of several factors including geo-political tensions, rising global crude oil prices, persistent inflation, further pandemic-related economic disruptions, abnormal monsoon, or withdrawal of global liquidity can take away the punch bowl. That said, the Survey dug into the data and the overall sketch makes one believe that India's growth fairy is back. From agriculture and allied sectors to industry to government expenditure to exports all are doing their bit, but two key components -- consumption and investments -- are not in step. Unhelpfully, the Survey's foresight isn't letter perfect ei-

been the hardest hit. Worse, segments like travel, trade and hotels are still hostage to the stop-start nature of Covid-19 waves. Worryingly, advance estimates too suggest full recovery of all components on the demand side this fiscal, except for private consumption. Likewise, private investment recovery is nascent, but the new Chief Economic Adviser Dr Anantha Nageswaran concluded that all will be well by the second

key industries. Thanks to Covid-19, the central government debt shot up from 49.1% of GDP in FY20 to 59.3% in FY21, and will likely decline. As on March 2021, total outstanding liabilities stood at Rs 117 lakh crore, while public debt accounted for 89.9% of total liabilites.

The Survey hopes the government not only meeting the fiscal deficit target thanks to bumper revenues, but will also be left with enough fiscal

space to provide additional support. That said, it didn't touch upon the need for tackling the twin targets of reducing debt and deficits initiated in FY20.

Inflation is now a global issue and though headline inflation is within the targeted tolerance band of 6%, wholesale inflation is running in doubledigits. Although this is partly due to base effects that will even out, India does need to be wary of imported inflation, especially from elevated global energy prices.

While the Survey noted that forex reserves of \$634 billion, equivalent to 13.2 months of merchandise imports, and higher than the country's external debt, how the adequate buffers will fare in the face of rising global crude prices and against possible global liquidty tapering remains to be seen.

In short, the Survey has fired up hopes of yet another iconic budget. Will Finance Minister Nirmala Sitharaman, whose previous annual financial statement was hailed as one of the five disntictive budgets India has seen, get lucky again? We shall know soon.

However, no Saraswati Puja will be allowed to be celebrated in public places other than in schools and educational institutions, he said. No community feast associated with puja/festivals during the period will be allowed. There will be no musical or any other entertainment programme on the occasion of Saraswati Puja, Mr.Jena further said.

Large congregations at river banks, ghats, ponds, sea shore or near other water bodies to take bath on the occasion of Magha Saptami/ Magha Purnima and on the day following have been prohibited throughout the State. However, the rituals can be performed inside the temple without participation of devotees.

All the State government-run offices will now operate with 100 per cent of the staff with strict adherence to Covid protocols. The General Administration and Public Grievances department will issue detailed guidelines/ SOP regarding attendance of officers & staff.

PUNE: Emerging feats at the season Italian star Lorenzo Musetti on Sunday said he is keen to make his mark in his debut appearance at Tata Open Maharashtra tennis tournament, which begins here on Monday.

The 19-year-old second seed will start as one of the title contenders in the men's singles event in the fourth edition of South Asia's only ATP 250 event at the Balewadi Stadium here.

"I'm here to win matches. I will try to go as far as I can and get the confidence that I used to have," Musetti said during a virtual press conference on Sunday.

He is likely to face strong competition from top players like World No. 15 Aslan Karatsev and defending champion Jiri Vesely. Musetti suffered first-round de-

opener Adelaide 1 event and Australian Open. "I played two good matches with two really great opponents. They showed they were playing best tennis and both the matches were close," he said. A Roger Federer fan, Musetti is one of the few players in the world with a strong single-handed backhand and he said it came naturally.
