UP polls: BJP gave step-motherly treatment to Raebareli, says Sonia Gandhi

RAEBARELI(KCN): Congress president Sonia Gandhi on Monday accused the BJP government in Uttar Pradesh of doing nothing in five years except dividing people, and claimed that it had meted out "step-motherly" treatment to her constituency Raebareli.

In her maiden election speech for the ongoing UP polls, Gandhi also hit out at Prime Minister Narendra Modi and UP Chief Minister Yogi Adityanath, accusing them of mismanage-

ment during the COVID-19 pandemic.

"It's going to be an important election because for the last five years you have seen a government which did nothing except divide people," Gandhi said during a virtual address on the last day of campaign for the fourth phase. Gandhi is the Lok Sabha MP from Raebareli, where voting will take place on February 23 on all five assembly seats of Raebareli (Sadar), Harchandpur, Bachchrawan, Sareni and Unchahar.

> "We had brought several development schemes for you but the Modi-Yogi government banned all of them. Step-motherly treatment was meted out to Raebareli," Gandhi said. "You



New Delhi (KCN): NTPC has recorded a generation of 314.89 Billion Units upto 18th Feb'22, surpassing the maximum annual generation of 314 BU achieved in 2020-21. Last year, the generation was 270.0 BU till 18th Feb, indicating improved performance and an increase in demand for power in the current year.

NTPC Korba (2600 MW) in Chattisgarh is the top performing thermal power plant in India with 94.32% Plant Load Factor between April'21 to

Jan'22, as per the data published by Central Electricity Authority. This demonstrates the expertise of NTPC in Operation Maintenance of the power plants and the high levels of operational excellence. The total installed



Can we ensure that all children return to schools?

Schools are slowly reopening after multiple COVID-19 lockdowns. It is time to



build a better education system that focuses on the needs of the most vulnerable children, especially girls. by SAFEENA HUSAIN

When the COVID-19 pandemic hit India, 12-year-old Rekha's father lost his job. The family lost their income and their home. They were forced to return to a small village in Rajasthan, where Rekha had no school to go to, no mid-day meal, and no menstrual hygiene products. A bigger concern, however, was her future. When an Educate Girls' volunteer visited the family and asked her parents when they were sending their children back to school, Rekha's father said, "I can barely afford to feed my family. My priority now is two square meals for my children."

This is the reality that families across India faced as the crisis deepened, and this is what confronted nonprofits throughout the length and breadth of the country. Before the pandemic, more than 4.1 million girls1 were not going to school across India. The closure of 1.5 million schools during the pandemic has further impacted over 247 million children enrolled in elementary and secondary schools.

It is now estimated that almost 11 million girls are at risk of dropping out of school. Even before the pandemic hit, one out of five girls would drop out of school in Rajasthan, and now due to COVID-19, 14.9 percent children have not even enrolled in schools. The case is similar in Uttar Pradesh, where 54 percent of girls are not sure whether they will return to school post the pandemic.

Nonprofits had to balance the reality of meeting immediate basic needs with anticipating the lasting impact of the crisis on the future of our children. The pandemic and the subsequent lockdowns pushed around 230 million people into extreme poverty in 2020. Consequently, many households in remote parts of India have had to reduce food intake and resort to child labour, forcing many young girls into early marriage and caregiving roles, and making them susceptible to violence and trafficking.

During the COVID-19 crisis, our work at Educate Girls gave us deep insights into the community, and we've had to navigate a very sharp learning curve. Over the last 18 months, more than 15,000 members of Team Balika—a group of village-based community volunteers involved in efforts to ensure education for girls—have worked closely with more than 2.3 lakh children through our community learning initiative called Camp Vidya, reaching 20,000 villages in 21 districts across Rajasthan, Madhya Pradesh, and Uttar Pradesh where 40 percent of India's out-of-school girls live. Here are some of our learnings from the pandemic, and things we need to prioritise as we move forward so that children affected by COVID-19 return to school.

1. The sector must adopt a multipronged approach to ensure no child is left behind The pandemic compounded existing inequalities in the country and impacted different subgroups disproportionately. We, therefore, need to adopt a planned,

multipronged approach to ensure

that children affected by COVID-19 in different ways continue their schooling. We need to identify children who are permanently at risk of not returning to school. For instance, for children who were already in school before the pandemic, we need to look at existing school records and ensure that they return without exception. Next, we have to identify new entrants who have attained schooling age, as well as the children of migrant workers who could not access schooling after shifting to a new location. Although difficult, we need to have a system in place to identify each one of them and encourage them to join school. We also need to focus on children belonging to transition grades, especially primary to secondary, where the dropout rates, par-

programmes that shift the focus back on education for marginalised communities. For example, schools can be incentivised and rewarded based on their capacity to accommodate children like Rekha from low-income households; the government can consider providing free education to girls up to graduation; more seats can be added in government-funded residential hostels such as Kasturba Gandhi Balika Vidyalayas; and plans can be made to accommodate and allocate extra resources for schools in rural areas where migrant children have returned so as to ensure enough food for an expanded population. Building back better

tives and support

To build back a better education system, our goal should be to recover the children that lost out on education during the pandemic. We need to put in focused efhygiene kits. This could encourage re-enrolment, particularly for the most vulnerable.

Incorporating bridge courses that help children overcome their learning losses, so that the gap created in education does not impact their learning in the future. This must be followed by age-appropriate learning programmes in the curriculum as children from diverse age groups come back to school. The new curriculum should also focus on the mental and physical well-being of children, given that they missed out almost entirely on learning and interacting with peers during the pandemic.

Launching a campaign aimed at getting girls back to school with active support from school management committees and the local government. This is critical as the chances of girls dropping out are higher this year due to the added eco-

nomic strain caused by COVID-19.

Inclusive funding will be paramount We have recognise the fact that the current national and global financing for education is just not sufficient. The funding gap, as estimated by number thought leaders, is approximately USD 75 billion per year. And this is just enough to ensure that every child receives an education—this is just the shortfall.

Funding must be inclusive and focus on initiatives that ensure access to quality education

for the most vulnerable children.

The pandemic witnessed rigorous fundraising activities both at the government and non-government levels. Most of these funding initiatives focused on direct relief measures. In the beginning of the pandemic, the focus was largely on providing daily supplies to the masses and setting up digital facilities for education, and this was non-inclusive in nature. In the second wave, the focus shifted to meeting medical emergencies such as oxygen cylinders and ventilators. The massive disproportionate spending on these causes led to the neglect of issues such as education for the most marginalised.

Now, as we seek to build an education system that can withstand future shocks and ensure that no child is left behind, we truly need a war chest. We must be able to persuade global and domestic donors as well as governments that more funding is needed. However, at the same time, this funding must be inclusive and focus on initiatives that ensure access to quality education for the most vulnerable children. And as we dive deeper into the problems related to the lack of access to resources and education for the most vulnerable communities, it is time to come together and address the problems at the grassroots, keeping the well-being of girls on priority.

Lastly, we need to identify children who are permanently at risk of not returning to school. These would be children orphaned during COVID-19 and older girls who may now not be eligible for mainstreaming. For example, girls who turned 14 in March 2020 face the highest risk of not returning to school as they would have crossed the age eligibility criteria for admission as per the Right to Education Act. They are also most likely to be married off or expected to take up caregiving roles, further curtailing their return to school. We need an alternate education plan for these children.

2. Policymakers should focus on creating incentives to get children back in school

As we emerge from the pandemic, policies and policymakers must keep the most vulnerable communities at the centre of their thinking and strategy. This holds true particularly for girls as they are now more exposed to gender-based violence, early marriage, forced labour, trafficking, and so on. Therefore, a convergence in education, public health, and agency building is critical. Focusing on vocational training for girls and provision of healthcare and hygiene facilities in schools can be key components in this strategy. An urgent policy-level intervention is also required to make education compulsory for all girls.

More importantly, think tanks, researchers, and policymakers must look to cre-

forts to reform and build back the system in a way that better accommodates the needs of all children, so that no one gets left behind.

Our efforts should include:

Identifying gaps and assessing the current economic and educational status of the children through door-to-door surveys

Focusing on direct and continuous interactions with parents to encourage increased attendance of children, including those at the highest risk of dropping out. Conducting regular dialogues between community-based organisations and Panchayati Raj institutions to help prevent child marriages. Civil society organisations and nonprofits will also need to lead counselling sessions for the communities they work with to ensure instances of early marriage, child trafficking, and child labour are identified and curbed.

Providing in-kind support such as midday meals to help families overcome the increased costs of sending children to school, and supplying basic safety and

MOSCOW: Russian President Vladimir Putin convened top officials Monday to consider recognising the independence of Russia-backed separatist regions in eastern Ukraine.

The meeting of the presidential Security Council comes amid Western fears that Russia could invade Ukraine any moment, using skirmishes in eastern Ukraine as a pretext for an attack.

Putin's statement follows televised statements by separatist leaders, who pleaded with Putin to recognise them as independent states and sign friendship treaties envisaging military aid to protect them from what they described as the ongoing Ukrainian military offensive.

Russia's lower house made the same plea last

Ukrainian authorities deny launching an offensive and accuse Russia of provocation amid intensifying shelling along the line of contact.



The Kremlin initially signalled its reluctance to make the move that would effectively shatter a 2015 peace deal for eastern Ukraine that marked a major diplomatic coup for Moscow, requiring Ukrainian authorities to offer a broad self-rule to the rebel regions.

The US and Russian presidents tentatively agreed to meet in a last-ditch effort to stave off a possible Russian invasion of Ukraine, even as sustained shelling continued Monday in a conflict in eastern Ukraine that Western powers fear could provide the spark for a broader war. If Russia invades, as the US warns Moscow has already decided to do, the meeting will

Still the prospect of a face-to-face summit resuscitated hopes that diplomacy could prevent a devastating conflict, which would result in massive casualties and huge economic damage across Europe, which is heavily dependent on Russian energy. Russia has massed an estimated 150,000 troops on three sides of Ukraine — the biggest such buildup since the Cold War. And Western officials have warned that Russian President Vladimir Putin is now looking for a pretext to invade the country, a westernlooking democracy that has defied Moscow's

attempts to pull it back into its orbit. Even as diplomatic efforts inched forward, potential flashpoints multiplied. Fighting escalated in eastern Ukraine, Russia said it had fended off an "incursion" from Ukraine, which Ukrainians officials denied, and Russia decided to prolong military drills in Belarus. Moscow denies it has any plans to attack, but wants Western guarantees that NATO won't allow Ukraine and other former Soviet countries to join as members. It has also demanded the alliance halt weapons deployments to Ukraine and roll back its forces from Eastern Europe, demands flatly

The language from Moscow and Washington was more cautious, but neither side denied a meeting is under discussion.

US national security adviser Jake Sullivan said the administration has always been ready to talk to avert a war, but was also prepared to respond to any attack. "So when President Macron asked President Biden yesterday if he was prepared in principle to meet with President Putin, if Russia did not invade, of course President Biden said yes," he told NBC's "Today" show on Monday. "But every indication we see on the ground right now in terms of the disposition of Russian forces is that they are, in fact, getting prepared for a major attack on Ukraine. Kremlin spokesman Dmitry Peskov told reporters Monday that Putin and Biden could meet if they consider it "feasible, "but emphasised that it's premature to talk about specific plans for a summit.

Macron's office said that US Secretary of State Antony Blinken and Russian Foreign Minister Sergey Lavrov are set to lay the groundwork for the potential summit when they meet Thursday. The French leader has been trying to play gobetween to avert a new war in Europe, and his announcement followed a flurry of calls by Macron to Putin, Biden, British Prime Minister Boris Johnson and Ukrainian President Volodymyr Zelenskyy.

Even as the diplomacy pressed ahead, there were signs it might not head off a broader conflict. Russia and its ally Belarus announced Sunday that they were extending massive war games on Belarus' territory, which could offer a staging ground for an attack on the Ukrainian capital, Kyiv, located just 75 kilometers (less than 50 miles) south of the border.

Starting Thursday, shelling also spiked along the tense line of contact that separates Ukrainian forces and Russian-backed rebels in Ukraine's eastern industrial heartland of Donbas.

Over 14,000 people have been killed since conflict erupted there in 2014, shortly after Moscow annexed Ukraine's Crimean Peninsula.

Ukraine and the separatist rebels have traded blame for massive cease-fire violations with hundreds of explosions recorded daily.

The world is watching the fighting warily since Western officials have warned for weeks that Russia would look for a pretext to invade, and that the conflict in Donbas could provide just such an excuse. On Friday, separatist officials announced the evacuation of civilians and military mobilisation in the face of what they described as an imminent Ukrainian offensive on the rebel regions.

Ukrainian officials have strongly denied any plans to launch such an attack.

While Russia-backed separatists have charged that Ukrainian forces were firing on residential areas, Associated Press journalists reporting from several towns and villages in Ukrainianheld territory along the line of contact have not witnessed any notable escalation from the Ukrainian side and have documented signs of intensified shelling by the separatists that destroyed homes and ripped up roads. Some residents of the main rebel-held city of Donetsk described sporadic shelling by Ukrainian forces, but they added that it wasn't on the same scale as earlier in the nearly 8-year-old conflict in the east.

The separatist authorities said Monday that at least four civilians were killed by Ukrainian shelling over the past 24 hours and several others were wounded.

Ukraine's military said two Ukrainian soldiers were killed over the weekend, and another serviceman was wounded Monday.

Ukrainian military spokesman Pavlo Kovalchyuk said the separatists were "cynically firing from residential areas using civilians as shields." He insisted that Ukrainian forces weren't returning fire. In another worrying sign, Moscow also alleged that forces from Ukraine crossed into Russia's Rostov region. The Russian military said it killed five suspected "saboteurs" who crossed from Ukraine and also destroyed two armored vehicles. Ukrainian Border Guard spokesman Andriy Demchenko dismissed the Russian claim as "disinformation". Amid the heightened invasion fears, the US administration sent a letter to the United Nations human rights chief claiming that Moscow has compiled a list of Ukrainians to be killed or sent to detention camps after the invasion.

The letter, first reported by the New York Times, was obtained by the AP.

Peskov, the Kremlin spokesman, said the claim was a lie and no such list exists.

Throughout the crisis, Ukraine's leaders have sought to project calm, repeatedly playing down the threat of an invasion.

Ukrainian Defense Minister Oleksii Reznikov said Monday that Russia has amassed 147,000 troops around Ukraine, including 9,000 in Belarus, arguing that the number is clearly insufficient for an offensive on the Ukrainian capital from the north.

"The talk about an attack on Kyiv from the Belarusian side sounds ridiculous," he said, charging that Russia is using the troops there as a scare tactic.

The European Union's top diplomat, foreign policy chief Josep Borrell, welcomed the prospect of a Biden-Putin summit but said the 27nation bloc has finalized its package of sanctions for use if Putin orders an invasion.

"The work is done. We are ready," said Borrell. He provided no details about who might be targeted. Ukrainian Foreign Minister Dmytro Kuleba said Monday that the European Union has also agreed to send military officers to the country in an advisory role. It's likely to take several months to set up.

Supreme Court seeks reply from Centre, states on plea seeking law for adherence to fundamental duties

NEW DELHI: The Supreme Court Monday sought response from the Centre and states on a plea seeking direction for enacting well defined laws/rules to ensure adherence to the fundamental duties as enshrined in the Constitution.

A bench of Justices Sanjay Kishan Kaul and M M Sundresh issued notice on the plea filed by Supreme Court lawyer Durga Dutt.

The plea sought issuance of directives ensuring adherence to the mandates as postulated under Part IV-A of the Constitution and said that non-adherence to them has a direct bearing on the exercise and enjoyment of the fundamental rights guaranteed under Article 14, 19, 21 for formulation and operationalisation of appropriate scheme providing incentives to the citizenry for their adherence.

"Moreover, it may be just and appropriate for this court to frame guidelines for regulation and effective implementation for fundamental duties in exercise of the plenary and extraordinary power of this court under Article 32 and 142 of the Constitution until the scheme in this regard is formalised by the respondents," said the plea filed through advocate Karunakar Mahalik. The plea said the fundamental duties are intended to serve as a constant reminder to every citizen that while the Constitution conferred on them certain fundamental rights specifically, it also requires citizens to observe certain basic norms of democratic conduct and behaviour because rights and duties are correlative.

"The fundamental duties are an important tool to protect the unity and integrity of several institutions including the judiciary. It is submitted that every citizen must learn how to respect the institutions of this country. There have been cases where Fundamental Duties have been brazenly flouted by the people including the officers of the law and which in turn resulted in violation of fundamental rights of other citizen," the plea said.

Dutt said his plea aims to address the issue of

national importance and to promote commitment amongst citizens towards each other and towards the nation as it contributes towards development and progress of the nation.

"The petitioner is constrained to invoke the jurisdiction of this court because the existing laws are inadequate for ensuring performance of the fundamental duties," it said.

The plea further added that except for some scattered legislations, there is neither a uniform policy nor a comprehensive code for enforcement of fundamental duties.

It said that while citizens show a serious concern towards fundamental rights, they often forget that there is a corresponding Constitutional and moral obligation upon them to perform the fundamental duties.

"It is further apt to state that at the advent of COVID-19 pandemic and then the manner in which it was cynically exploited to stoke communalism, on social media and TV channels...Therefore, it is need of the hour that certain moral obligations be converted to legal obligations by enacting legislation and framing guidelines, so that if in future such situation arises, we as a nation shall be seen standing together with united efforts", it said. The plea also sought direction for setting up of an independent high-powered committee, headed by a retired chief justice or judge of this court or High Court and consisting of distinguished citizens from different fields/professions and concerned officials of the stakeholders and the respondents, to scrutinise and review the entire legal framework relating to the effective implementation of Part IV-A of the Constitution and recommendation of appropriate guidelines needed to be laid down by this court. It sought directions to Centre and states for framing of guidelines for taking appropriate steps to sensitize people and spread general awareness among the citizens in relation to performance of fundamental duties under the Constitution.



In view of the declining trend of Covid-19 cases in the State, the Commission has relaxed certain restrictions imposed earlier for counting of votes of the ongoing Panchayat Polls. The SEC on Monday wrote to all district Collectors in this regard.

As per the latest order, there is no need to undergo compulsory Covid-19 testing (RT-PCR or Antigen) to enter into the counting centres within 48 hours of the commencement of counting. Now, all persons en-

tering the counting centres should be thermally scanned. Only double vaccinated persons will be allowed inside the counting centres. Besides, those showing Covid-19 symptoms will not be allowed into the counting centres. The counting of votes will be done on February 26, 27 and 28.



three-tier Panchayat elections in the State will be held at 163 Zilla Parishad (ZP) zones in 27 districts tomorrow.

The State Election Commission (SEC) has made necessary arrangements for 17,089 booths in 12,54-Gram Panchayats (GPs) in 64 Blocks, said Commission Secretary, R N Sahu here on Monday.

The SEC has identified 2,563 booths as sensitive booths and in place in these booths. Over 51.31 lakh voters are eligible to cast their votes in this phase, he said.

Himalayan baba may actually be former bureaucrat from Finance Ministry, claims source

NEW DELHI: The CBI and tax authorities have swooped down on former MD & CEO of the National Stock Exchange Chitra Ramkrishna. But they have not been able to find the identity of the so-called Himalayan Baba who ran India's biggest stock exchange from behind the scenes.

Highly placed sources told The New Indian Express that this person is no baba and has nothing to do with the Himalayas, and is most



likely from the other end of the country. They say he is a former bureaucrat from the Union finance ministry who was in charge of the capital markets and is credited with shaping the career of Ramkrishna and helping her reach the top at NSE.

Strongly rejecting the possibility of NSE's Chief Strategy Advisor Anand Subramaniam being the Baba, sources said there were some people, who wanted the issue to be closed by making Subramaniam the person who was communicating with Ramkrishna using the email id rigyajursama@outlook.com.

If Subramaniam is established as the Baba, then the serious charge of leaking sensitive information to an outsider would go away. This theory of Subramaniam being the Baba is also being pushed by the NSE board.

SEBI, however, has rejected this theory after a detailed investigation into the matter. SEBI investigation has also established that the NSE board had full knowledge of Ramkrishna sharing sensitive NSE information with an unknown person who used the email id rigyajursama@outlook.com.

Yet, the board allowed her to resign and leave and took no action against her. In fact, the board thanked her for her services. Sources said members of the board are also likely to be probed as investigation widens in the case. According to sources, the name of this bureaucrat who used the identity of a baba would come out if the CBI dives deep into the case. "But if the case is investigated like the colocation scam where NSE was allowed to get away with a fine, then the baba will remain a mystery," sources said.

They said that NSE's theory that Subramaniam used the fake id in order to communicate with Ramkrishna and seek favours from her is deliberately misleading. Kanchan (Subramaniam) will be the straw and I will be the suction force for this and you will vomit all that is required as always." Here, the unknown person is telling Ramkrishna to repeat his lines in discussions with SEBI, PMO and finance ministry on the listing of stock ex-

During the course of investigation in the colocation case, SEBI came across certain documentary evidence, which demonstrate that the MD & CEO of NSE had shared certain internal confidential information of NSE viz Organizational Structure, Dividend Scenario, Financial Results, Human Resources Policy and related Issues, Response to Regulator etc with an unknown person by addressing her correspondence to an email rigyajursama@outlook.com during the period 2014 to 2016.

SEBI investigator Ananta Barua concluded, "I find the allegation that Noticee no. 6 (Subramaniam) has exploited Noticee no. 1 (Ramkrishna) by creating another identity before her in the form of the unknown person having email id rigyajursama@outlook.com to guide her perform her duties according to his wish, is not sustainable."

"I find that it is a bizarre attempt at concealing the identity of the unknown person. Clearly, such an attempt is unacceptable. I note that the Noticee no. 1 (Ramkrishna) herself has stated that - "Who else and whom he would correspond with was outside my purview. He may have corresponded with any others too", and therefore, Noticee no. 1 has no assurance herself that the confidential information she has passed on to the unknown person is not being passed on to other persons. Therefore, I find that it is a glaring breach of the regulations and laws in place that requires key officials and employees to maintain confidential information of the company, which in this case being NSE, which is the leading and largest stock exchange in India," the SEBI order said.

The five assembly seats have a combined voter count of over 17 lakh, including around eight lakh women. The district, adjoining Lucknow, has a population of around 30 lakh.

After winning over Amethi, once a so-called bastion of the Congress, the BJP is making every effort to completely wash out the grand old party in Sonia Gandhi's home turf of Raebareli in the 2022 UP polls.

Noting that the Congress brought in a legislation like MNREGA to empower people with the right to work and help them have a better life, Gandhi said it is a pity that during a crisis (pandemic), the budget for MNREGA was reduced instead of being increased.

She recalled how people faced difficult times during the peak of the Covid pandemic, unable to get oxygen, medicines and even beds in hospitals and many lost their loved ones. On the other hand, she noted that the pandemic also disrupted the work and business of many people while many endured the pain of having to walk for miles on foot during the

"The Modi-Yogi government gave proof of how irresponsible they are. They turned away their faces from your problems and shut their eyes to your woes. Not only this, their behaviour towards you was also not good during the lockdown. The government did not provide you any relief," she said.

She also targeted the Centre and the state government over the issues of farmers, youth and inflation. She said farmers work hard to grow crops for everyone but in the last five years they neither got an appropriate price for their produce, nor fertilizers or facilities for irriga-

"Farmers got under burden of debt while stray animals kept ruining their crops," Gandhi said. Similar is the condition of the youth, who study hard and prepare for jobs but the BJP government forced them to sit at home, she

"There are 12 lakh vacant government jobs in the state but you were not given jobs," the Congress chief noted.

She said the price of petrol, diesel, cooking gas and mustard oil have become unaffordable for people and running a household has become difficult, and added that inflation also hit women who somehow managed to save small amounts of money.
