Liquor Ban On Polling & Counting Days

Cuttack(KCN): In the interest of free and fair Panchayat election, the State Excise Commissioner Ashish Kumar Singh has banned sale, transport and distribution of liquor in the re-

Non-proprietary clubs, star hotels, restaurants etc. and hotels run by anyone, even if they are issued different categories of licenses for pos-

session and supply of Liquor, shall also not be permitted to serve liquor on these days. Similarly, the storage of liquor by individuals will be curtailed during the above period and the restrictions provided in the Excise-law on the storage of liquor in unlicensed premises shall be vigorously enforced.

In addition to the above, the Excise Commissioner asked the Collectors to take steps to prohibit sale of liquor in the areas adjoining the wards to forestall the chance of clandestine movement of liquor from the area, had the restrictions not been in-

spective Blocks during polling and counting of votes.

Following the instruction of the SEC, Mr. Singh has written a letter to all Collectors to ensure closure of licensed premises for retail sale of foreign liquor, IMFL and country liquor in the constituency area and adjoining areas during the period of 48 hours ending with the hour fixed for the conclusion of poll up to day following the poll day. The polling is scheduled to be held on February 16, 18, 20, 22, and 24.

"This is in tune with Section 135C of the Representation of the People Act, 1951 which provides that no spirituous, fermented or intoxicating liquors or other substances of a like nature shall be sold, given or distributed at a hotel, eating house, tavern, shop or any other place, public or private, within a polling area within the respective Wards during the period of 48 hours preceding the poll upto the day following the poll day," said Mr.Singh, adding this will include the dates of re-poll if any. As per the order, no Liquor shops, hotels, restaurants, clubs and other establishments selling / serving liquor will be permitted to sell/ serve liquor to anyone whosoever, on the force.

Intensified joint raids by Excise, Police and Forest personnel will be carried out to avert any liquor related issue.

Similarly, the Collectors have been asked to declare counting days (February 26, 27 and 28) as Dry Day under section of the Odisha Excise Act, 2008 and the Odisha Excise Rules, 2017 ensuring closure of licensed premises for retail sale of foreign liquor, IMFL and country liquor within the respective Blocks on the days of counting.

The Commission has directed that no spirituous, fermented or intoxicating liquors or other substances of a like nature shall be sold, given or distributed at a hotels, eating houses, tavern, shops or any other place, public or private within the respective blocks as on the day of counting. As per schedule, the counting will be completed on the first day of counting in 15 Blocks as they have got one Zilla Parishad constituency in the Block.

Similarly, 126 Blocks have two Zilla Parishad constituencies each and their counting will be completed on February 26 and 27 while counting in remaining Blocks will be done on all the three days of counting.

Edu Institutes Reopen Bhubaneswar(KCN): As per Seating arrangements of

earlier announcement, all educational institutions of Class VIII and above across the State have reopened today for the students with strict adherence to Covid-19 protocols.

As per the instructions of School and Mass Education (S&ME) Principal Secretary Bishnupada Sethi, all schools have been reopened for students of Class- IX to XII for the academic session 2021-22. The physical teaching for Class I to VIII students will resume from

students have been made in such a way that each student maintains social distance from each other.

"After doing thermal scanning and ensuring wearing masks, students have been allowed to school. We have kept an isolation room ready for those students, who develop any Covid like symptoms" said a teacher from a Rourkela school.

SEC Relaxes Poll Norms

Bhubaneswar(KCN): With the improvement in the Covid-19 situation in the State, the State Election Commission (SEC) has partially relaxed the restrictions imposed for campaigning during ensuing General Elections Panchayati Raj Institutions (PRIs), 2022.

While addressing media persons here on Monday, State Election Commissioner Aditya Prasad Padhi said now, candidates can conduct door-todoor campaigning with a maximum of 20 persons including the candidate. Earlier, only five persons were allowed to accompany contestants in the door-to-door campaign.



Similarly, outdoor meetings have been allowed with a limit of 300 persons, he said. However, all other restrictions like bike rally, cycle rally and Padayatra, etc will be continued to remain in force, Mr.Padhi said. The Commission has modified the above guidelines taking the prevailing situation

"Public meetings can be organized by the Political Parties/Contesting Candidates with prior permission of the appropriate authority with maximum 300 persons in open ground subject to strict observance of Covid-19 protocols i.e. compulsory use of face mask and social distancing," read an order issued by the SEC.

Mr.Padhi, who held a review meeting with the District Collectors this morning, said, precautionary doses have been administered to about 80 to 90 per cent polling staff while others will get the dose in the next 2 to 3 days.

On preparation of Ward-wise Electoral Roll for the urban polls, the Commissioner said the final draft list will be published on February 10. The SEC has also conveyed a meeting with leaders from all political parties on that day for smooth conduct of the election to Urban Local Bodies (ULBs), which is likely to be held soon after the Panchayat Poll.

The Panchayat elections will be held in five phases on February 16, 18, 20, 22 and 24. The voters will exercise their franchise from 7 AM to 1 PM on these days. Counting of votes and declaration of results will be done at Block level on February 26, 27 and 28.





The film depicts how nine women belonging to different strata of society are brought together by circumstance and end up forming a sisterhood after they share their stories of abuse.

Directed by Priyanka Banerjee, the short is produced by Niranjan Iyengar and Ryan Ivan Stephen.

Budget 2022- Forty-Eight Thousand Crores devoted to the construction of 80 lakh eco-friendly houses in India

If the financial condition of a person or family is not very stable, it does not, in any manner, hinder them from dreaming of a home of their own. It is the sincere desire of every person that



they acquire the pleasure of living in their house at the very onset of their existence. To bring theirs's and million others' dreams to life, Finance Minister Nirmala Sitharaman has made a hefty proposal worth Rs

48,000 crore in the Union Budget for the year 2022-23, with a resolution to build about 80 lakh houses in the country. That is indeed a very pragmatic decision considering societal welfare and the current standard of living. A step in this direction shows the genuine intention of the government to help those people whose income is limited and who are not able to own their houses. With the construction of 80 lakh houses during the current financial year, at least three to four crore families with five to six members in each will transition into new homes.

If we are to understand the sense of freedom owning your own house brings, we must ask those who have had the pleasure of shifting from a rented house to their own after being berated by the constant taunts of their landlord. Under the Pradhan Mantri Awas Yojana 80 lakh, affordable homes will be provided to the needy while the government has decided to expand the housing scheme. The central government will work in consonance with the state governments for its implementation. They will combine their effort to reduce the time taken for land

acquisition and construction approvals for the scheme. The

government has also decided to cooperate with financial sector regulators to bring down the cost of arbitration and raise capital effortlessly.

Despite such great initiatives taken by the

Despite such great initiatives taken by the government, their impact has been limited. A major part of that money goes into the pockets of a few corrupt people. For most of the time, the benefits of the scheme are not available to the public who need it the most. This is an unfortunate situation. The concerned

to compete to build extravagant and flamboyant houses. Massive houses are being built, but some do not even have space for books. The government will have to consistently stay strong in its pursuit to build affordable ecofriendly houses in the coming years. The number of millionaires in

the country is rising day by day. This cycle is going to continue in the future as well. This section of the society can buy houses anywhere they wish with their ever-compounding wealth. But, the government also has to strive to ensure economic equality in India. Undoubtedly, the income of most people has plummeted due to the Covid-19 Pandemic. Thus, the government will have to pay special attention to this category and address the public with renewed enthusiasm and energy regarding its smart cities project.

Constitutional validity of death sentence

Death sentence or the capital punishment was accepted by the civilized society through evolution. The historical records would show even the ancient primitive tribes followed the death sentence by punishing the wrong doers by taking their lives. The



wrong doers committing the murder or other heinous crimes including sexual assault, treason and various military offences. The punishment for murder is based on a "life for a life" concept. The ancient laws of China

established the death penalty as a punishment for crimes. In 18th Century B.C. the king of Hammurabai of Babylon codified the death penalty for 25 different crimes but there was no death sentence for murder. The first death sentence was recorded historically in 16th Century B.C. in Egypt where a wrong doer or an accused a member of nobility was accused of magic and ordered to take his own life. In 7th Century B.C. the Draconian Code of Athens made death penalty for every crime committed. In the 5th Century B.C. the Roman Law of the Twelve Tablets codified the death penalty. The most notorious execution about 399 B.C. when the Greek philosopher Socrates was required to drink hemlock poison for heresy and corruption of youth. Mosaic Law codified many capital crimes. The Jews used many different techniques including stoning, hanging, beheading, crucifixion. The most infamous and intolerable execution of history occurred in 29 A.D. with the crucifixion of Jesus Christ outside Jerusalem. But after 300 years, the emperor Constantine abolished crucifixion after converting him to Christianity. By the passage of time the various methods were adapted for the execution of the death sentence such as burning alive, drowning, beating to death and impalement. In 10th Century A.D. hanging was accepted as the customary method of execution in Britain. Subsequently under the rule of William the Conqueror, hanging was not allowed except during wars. It is seen that the countries with no death penalty have less number of murders taking place whereas the country with death penalty, there are more murders. As per the records of United Nations, more than 150 countries, no longer use such death sentence or have abolished.

The Section 302 of The Indian Penal Code, 1898 deals with the punishment for murder. The said section contemplates that whoever commits murder shall be punished with death or [imprisonment for life] and shall also be liable to fine. The Section 354(3) of the Code of Criminal Procedure, 1973 deals with the language and contents of the judgment in the case of the management under Section 302 of the IPC. The said Section 354(3) of the Code of Criminal Procedure, 1973 is reproduced as under:-

"When the conviction is for an offence punishable with death or, in the alternative, with imprisonment for life or imprisonment for a term of years, the judgment shall state the reasons for the sentence awarded, and, in the case of sentence of death, the special reasons for such sentence."

For the first time the constitutional validity of the Section 302 of the Indian Penal Code was

challenged in the matter of Jagmohan Singh Versus The State of U.P.,

(1973) 2 SCR 541. The sentence of death for an offence under Section 302 of the Indian Penal Code awarded by the Sessions Judge and confirmed by the High Court was challenged in a Criminal Appeal before the Hon'ble Supreme Court on the following

(i) That death sentence puts an end to all fundamental rights guaranteed under clauses (a) to (g) of sub-clause (1) of Article 19 and, therefore, the law with regard to capital sentence is unreasonable and not in the interest of general public.

(ii) That the discretion invested in Judges to impose capital punishment is not based on any standard or policy required by the Legislature for imposing capital punishment in preference to imprisonment for life. It was a stark abdication of essential legislative function, and, therefore, section 302, IPC is vitiated by the vice of excessive delegation of essential legislative function.

(iii) That uncontrolled and unguided discretion in the Judges to impose capital punishment or imprisonment for life is hit by Article 14 of the Constitution, because two persons found guilty of murder on similar facts are liable to be treated differently one forfeiting his life and the another suffering merely a sentence of life imprisonment.

(iv) That provisions of the law do not provide a procedure for trial of factors and circumstances crucial for making the choice between the capital penalty and imprisonment for life. The trial under the Criminal Procedure Code is limited to the question of guilt. In the absence of any procedure established by law in the matter of sentence, the protection given by Article 21 of the Constitution was violated and hence for that reason also the sentence of death is unconstitutional.

After considering the above mentioned grounds, the Hon'ble Supreme Court while dismissing the appeal of the Appellant, held as under:

"However, it is necessary to emphasize that the court is principally concerned with the facts and circumstances, whether aggravating or mitigating, which are connected with the particular crime under inquiry. All such facts and circumstances are capable of being proved in accordance with the provisions of the Indian Evidence Act in a trial regulated by the Cr.P.C. The trial does not come to an end until all the relevant facts are proved and the counsel on both sides have an opportunity to address the court. The only thing that remains is for the Judge to decide on the guilt and punishment and that is what section 306(2) and 309(2) Cr.P.C. purport to provide for. These provisions are part of the procedure established by law and, unless it is shown that they are invalid for any other reasons, they must be regarded as valid. No reasons are offered to show that they are constitutionally invalid, and, hence, the death sentence imposed after trial in accordance with the procedure established by law is not unconstitutional under Article 21."

Supreme Court of Indiabefore rejecting the challenge of the validity on one of the grounds stated hereinabove has held; "the only authoritative study of the Law Commission of India published in 1967". It was the 35th report. After collecting the materials available as possible and assessing the views expressed in the west both by abolitionists and retentionists. The Law Commission has held at paragraphs 262 to 264 which were summarized at page 354 of the report as mentioned in the said judgment at page 550 as under:

In the said historic

judgment, the Hon'ble

"The issue of abolition or retention has to be decided on a balancing of the various arguments for and against retention. No single argument for abolition or retention can decide the issue. In arriving at any conclusion on the subject, the need for protecting society in general and individual human beings must be borne in mind. It is difficult to rule out the validity, of, or the strength behind, many of the arguments for abolition nor does, the Commission treat lightly the argument based on the irrevocability of the sentence of death, the need for a modern approach, the severity of capital punishment, and the strong feeling shown by certain sections of public opinion in stressing deeper questions of human values.

Having regard, however, to the conditions in India, to the variety of the social upbringing of its inhabitants, to the disparity in the level of morality and education in the country, to the vastness of its area, to the diversity of its population and to the paramount need for maintaining law and order in the country at the present juncture, India cannot risk the experiment of abolition of capital punishment. Arguments which would be valid in respect of one area of the world may not hold good in respect of another area, in this context. Similarly, even if abolition in some parts of India may not make a material difference, it may be fraught with serious consequences in other parts.

On a consideration of all the issues involved, the Commission is of the opinion, that capital punishment should be retained in the present state of the country."

The Hon'ble Supreme Court while upholding the punishment under Section 302 of the IPC has also considered the policy of law in England as stated by Halsbury in the Laws of England, 3rd Edition, Vol.10 at page 486. The relevant portion of paragraph 888 is as follows:

"DISCRETION OF COURT AS TO PUNISHMENT

In all crimes except those for which the sentence of death must be pronounced a very wide discretion in the matter of fixing the degree of punishment is allowed to the Judge who tries the case. The policy of the law is, as regards most crimes, to fix a maximum penalty, which is intended only for the worst cases, and to leave to the discretion of the judge the determination of the extent to which in a particular case the punishment awarded should approach to or recede from the maximum limit. The exercise of this discretion is a matter of prudence and not

of law, but an appeal lies by the leave of the Court of Criminal Appeal against any sentence not fixed by law, and if leave is given, the sentence can be altered by that court. Minimum penalties have in some instances been prescribed by the enactment creating the offence."

In addition to the above considerations, the Hon'ble Supreme Court has also referred the various judgments such as Ram Narain&Ors. Versus State of U.P., AIR 1971 SC 757., State of Madras Versus V.G. Row (1952) SCR 597., Furman Vs State of Georgia Supreme Court of America (NOS 69-5003, 69-5030, 69-5031) decided on 29th June, 1972, Municipal Committee VsBaisakhi Ram Criminal Law Journal 475, Mccautha Versus California, United States Supreme Courts Reports, Lawyers' Edition, 28, 713 and BudhanChoudhary and Ors. Vs State of Bihar., (1955) SCR 105.

The constitutional validity of death penalty as provided in Section 302 of the Indian Penal Code, 1898 and the sentencing procedure laid down in subsection (3) of the Section 354 of the Cr.P.C., 1973 for the second time arose before the Constitution Bench comprising Hon'ble the Chief Justice Chandrachud, Justice Sarkaria, Justice S.C. Gupta, Justice N.L. Untwalia and Justice P.N. Bhagwati in the matter of Bachan Singh Versus State of Punjab (1983) 1 SCR 145. The said Constitution Bench upheld the constitutional validity of death sentence by the majority in the ratio of four to one. Hon'ble Justice Sarkaria was the author of the judgment for the majority while Hon'ble Mr. Justice P.N. Bhagwati delivered separate judgment for minority. The following principal questions were raised before the Hon'ble Bench:

(i) Whether death penalty provided for the offence of murder in Section 302 of the Indian Penal Code is unconstitutional?

(ii) Whether the sentence procedure provided in Section 354(3) of the Cr.P.C. 1973 (Act II of the 1974) is unconstitutional on the ground that it invests with unguided and untrameld discretion and allows the death sentence to be arbitrarily or freakishly imposed on a person found guilty of murder or any other capital offence punishable under the Indian Penal Code with death or, in the alternative with imprisonment for life?

(iii) Whether the Supreme Court has powers to lay down standards or norms restricting the area of imposition of death penalty to a narrow category of murders? However the Constitution Bench of theHon'ble Supreme Court by the majority was pleased to reject the challenge to the Constitutionality of the impugned provisions containing in Section 302 of Indian Penal Code and Section 354(3) of the Code of Criminal Procedure, 1973 after referring the plethora of judgments of the Hon'ble Supreme Court.

Emmanuel Macron heads to Moscow to try to ease Ukraine tensions MOSCOW: French President Emmanuel Ma-

cron is set to hold talks in Moscow Monday in a bid to help de-escalate the tense situation around Ukraine.

The concentration of an estimated 100,000 Russian troops near Ukraine has fueled Western worries that it heralds a possible offensive, with White House national security adviser Jake



Sullivan warning Sunday that Russia could invade Ukraine "any day," triggering a conflict that would come at an "enormous human cost." Russia has denied any plans to attack its neighbour but is urging the U.S. and its allies to bar Ukraine and other ex-Soviet nations from joining NATO, halt weapons deployments there and roll back NATO forces from Eastern Europe. Washington and NATO have rejected the demands. Macron, who is set to meet in the Kremlin with Russian President Vladimir Putin before visiting Ukraine Tuesday, said last week that his priority is "dialogue with Russia and de-escalation." Before heading to Moscow, Macron had a call Sunday with U.S. President Joe Biden. They discussed "ongoing diplomatic and deterrence efforts in response to Russia's continued military build-up on Ukraine's borders, and affirmed their support for Ukraine's sovereignty and territorial integrity," the White House said in a statement.

The French presidency said Macron sought to ensure "good coordination" with Biden in the call. In an interview with French newspaper Journal du Dimanche published on Sunday, Macron said that "we won't get unilateral gestures but it is indispensable to prevent a degradation of the situation before building confidence gestures and mechanisms."

"The geopolitical objective of Russia today is clearly not Ukraine, but to clarify the rules of cohabitation with NATO and the EU," Macron said. "The security and sovereignty of Ukraine or any other European state cannot be a subject for compromise, while it is also legitimate for Russia to pose the question of its own security." Continuing the high-level diplomacy, German

Chancellor Olaf Scholz is set to meet with Biden Monday for talks expected to focus on the Ukrainian standoff. Scholz is set to travel to Kyiv and Moscow on Feb. 14-15.

In 2015, France and Germany helped broker a peace deal for eastern Ukraine in a bid to end the hostilities between Ukrainian forces and Russia-backed separatists that erupted the previous year following the Russian annexation of Ukraine's Crimean Peninsula.

The agreement signed in the Belarusian capital, Minsk, helped stop large-scale fighting, but efforts at a political settlement have stalled and frequent skirmishes have continued along the tense line of contact in Ukraine's eastern industrial heartland called Donbas.

The leaders of Russia, Ukraine, France and Germany last met in Paris in December 2019 in the so-called Normandy format summit, but they failed to resolve main conflicting issues.

Amid the tensions over the Russian military buildup, presidential advisers from the four countries held talks in Paris on Jan. 26, but they didn't make any visible progress and agreed to meet again in Berlin in two weeks.

Ukrainian President Volodymyr Zelenskyy has pushed for another four-way Normandy summit, but the Kremlin said a meeting of leaders would only make sense if the parties agree on the next steps to give a special status to the rebel east. Putin and his officials have urged France, Germany and other Western allies to encourage Ukraine to fulfil its obligations under the 2015 agreement, which envisaged a broad autonomy for the rebel east and a sweeping amnesty for the separatists. The agreement stipulated that only after those conditions are met would Ukraine be able to restore control of its border with Russia in rebel regions.

The Minsk deal was seen as a betrayal of national interests by many in Ukraine and its implementation has stalled. Amid the latest tensions, Ukrainian authorities have strongly warned the West against pressuring Ukraine to implement the agreement. Last week, Oleksiy Danilov, the secretary of Ukraine's National Security and Defense Council, told The Associated Press that an attempt by Ukraine to fulfil the Minsk deal could trigger internal unrest that would play into Moscow's hand. Ukrainian Foreign Minister Dmytro Kuleba noted that Moscow wants the rebel regions reintegrated into Ukraine in order to use them to effectively block the country's pro-Western aspirations, vowing that "this is not going to happen."

Odisha pays tributes to Nightingale of India Eminent classical vocalist, researcher Damodar Hota no more

BHUBANESWAR: Doyen of Odissi classical music Pandit Damodar Hota passed away at the age of 87 here on Saturday night. Family sources informed Pandit Hota complained of mild chest pain and succumbed while being taken to hospital. Born in 1935 in Puri, Pandit Hota was trained by his father Gopinath Hota, an accomplished singer and mardala player.

The maestro, who dedicated his life to research and promotion of Odissi classical music (Udra Paddhatiya Sangeeta), then went on to learn Odissi music from Guru Nrusinghnath Khuntia and tabla and mardala from Guru Kashinath Barik. Pandit Hota also received a scholarship from Odisha Sangeet Natak Akademi from 1954 to 1960 and used the funds to train under **Pandit** Omkarnath Thakur and Pandit Balwant Ray Bhatt.

MUMBAI: The Reserve Bank of India (RBI) on Sunday announced rescheduling the meeting of rate-setting Monetary Policy Committee (MPC) by a day in view of Maharashtra declaring public holiday on February 7 to mourn death of Bharat Ratna legendary singer Lata Mangeshkar. The MPC meeting was scheduled for February 7-9, 2022.

With the postponement, the meeting will now begin on February 8 and the outcome would be announced on February 10.

"With February 7, 2022 being declared a public holiday by the Government of Maharashtra under Section 25 of the Negotiable Instruments Act, 1881 as a mark of respect to Bharat Ratna Ku. Lata Mangeshkar, the MPC meeting has been rescheduled to February 8-10, 2022," the RBI said in a late evening statement.

In a separate release, the RBI said that there will be no transactions and settlements in government securities (primary and secondary), foreign exchange, money markets and Rupee Interest Rate Derivatives on February 7, 2022.

The draft bill is named as the 'Bill to stop all actions that could negatively affect relations established by Maldives with foreign countries.' The legislative body Majlis has resumed and this bill is likely to be submitted soon.

The draft has proposed a fine of Rs 20,000 Maldivian Rufiyan, six months imprisonment or a year-long house arrest.

In a bid to raise the pitch on their pro-India stance, during the opening session of Maldives Parliament yesterday, President Solih essayed India's role in the country's development.

"With the line of credit provided by India's Exim Bank, roadwork is being carried out to rectify the flooding problem in Addu city," President Solih said.

Addu City is the second largest city in Maldives and Addu road development project is assigned to India's Afcons Infrastructure

Meanwhile, as part of its annual financial aid, the Indian government has earmarked Rs 360 crore for Maldives. This was announced during the Union Budget on February 1st.

Passenger vehicle retail sales drop 10% in Gold bonds catch investor fancy amid Covid

MUMBAI: Indians have taken a fancy to sovereign gold bonds (SGBs) in the past two years, coinciding with the Pandemic's appearance on the world stage. Indian investments into SGBs in FY21 and FY22 (through January) accounted for 68% of the total investments into these bonds since their issue in FY16. In FY21 and FY22 (April-January) residents subscribed to bonds worth Rs 25,712 crore, accounting for 68% of the total investment of Rs 37,906 crore since the SGB scheme was launched in November

What makes SGBs attractive

"SGBs lure is the interest income, apart from the potential capital gain probability. This makes for a compelling reason for investors to invest in SGBs at a time when interest on bonds and FDs are declining, and there is a rising need for asset allocation as more and more investors jump on to the stock market bandwagon," points out Amol Joshi, founder PlanRupee Investment

The SGBs offer an interest rate of 2.5% per annum on the amount of initial Investment, payable semi-annually. Apart from potential capital gains, the interest component is attractive given scheduled commercial banks' weighted average domestic term deposit rate has fallen 187 basis points during February '19-November '21 as RBI cut the repo rate by 250 bps during the same period.

An increase in the number of aware investors may have bolstered interest in SGBs. The number of stock market Demat accounts have doubled in November 2021 from March 2019. As more investors jump onto the stock market bandwagon, they look for means of asset allocation to balance risk-reward, which implies that investors will look at spreading investments into fixed income, paper gold, etc.

is impossible to make progress. An unstable government that is constantly working to save itself cannot provide you development," she said, adding that only Congress can provide a stable government.

Notably, the Congress had emerged as the single largest party in the 40-member Goa Assembly after the 2017 state polls, but the BJP then allied with some regional outfits and independents to form a government.

"AAP or TMC cannot provide you what is required in Goa. They have come here to expand their parties. They have not come here to usher in the progress of Goa," Priyanka Gandhi alleged.

All the parties that come here from outside to destabilise the government cannot rule Goa, she said while apparently referring to the Trinamool Congress and the Aam Aadmi Party.

"The conservation between us should be about the issues like development, progress, jobs, and the safety of women. It should not be a conversation filled with negativity. It should not be about telling women what she should wear," the Congress general secretary said.

She said that the unemployment rate in Goa is the second highest in India even though the best resources are available in the coastal state. "The party which has ruled Goa for five years should tell you what they have done on the unemployment front. They should explain why so many small and medium businesses are on the verge of shutting down in Goa," she said without naming the BJP.

Priyanka Gandhi further said that no big industry can create jobs like small and medium enterprises.

She accused the Goa government of supporting its big businessmen friends.

"The biggest example is that they are creating double-laning, double-trekking, and an expressway to transport coal," the Congress leader said.

She claimed that Goans are not going to be benefited from any of these projects.

"Coal which is not bought in Goa or sold in Goa is going through Goa. It shows exactly what this government is about," she added. Priyanka Gandhi further alleged that the crime against women in Goa has risen by 24 per cent. "Goa is second in India when it comes to unemployment. There are hundreds of young people who are studying hard to get selected in government jobs but they never see employment. It is happening in every BJP-ruled state," she added.

In terms of SGB tax treatment, the capital gain on maturity amount — if held for eight years — is exempted. An exit option exists after the fifth year from the date of issue on interest payment dates. The treatment on capital gains otherwise is the same as for debt mutual funds.

If held for less than three years, capital gains are added to income and taxed at the relevant slab. For more than three years, 20% tax with indexation is applicable. The interest income on the bond is added to the bond holder's income and taxed at the applicable slab.
