Budget Session from 21 Feb

Bhubaneswar(KCN) : The Budget session of Odisha Legislative Assembly (OLA) will start from 21 February and continue till 6 April. The Assembly Secretariat has notified the schedule for the Budget Session on Thursday. The session will start with the address of Governor Ganeshi Lal on 21 February and motion of thanks on Governor's speech will

be moved on the same day. Further discussion on the Governor's address will be held on 22-23 February.

Finance Minister Niranjan Pujari will present the budget for the year 2023-24 on

24 February, while general discussion on the budget will start from 27 February. The Appropriation Bill will be laid before the House on 31 March.

There will be a gap from 2 March to 9 March during the session. There will be no business on all second & fourth Saturdays and Sundays.

Besides, the Assembly will not conduct any business on 30 March (Shree Ram Navami) and 1 April (Utkal Diwas).

According to sources, the State Government has decided to a full-flagged annual budget with a hike of about 15-20 per cent than the previous year's budget.

The size of the State Annual Budget for 2023-29 blocks likely to be covered under ABP in Odisha

BHUBANESWAR(KCN): As many as 29 blocks of the state are likely to be covered under the aspirational block programme mains such as health, nutrition, education, aglaunched by the Cen-

tre recently. Presenting the fullfledged budget of the Modi government before the next general elections, Union Finance Minister Nirmala Sitharaman said 500 blocks of the country have been covered under the programme to improve their socio-economic status. In her budget speech, Sitharaman said, "Building on the success of the aspirational district's programme, the government has recently launched the aspirational blocks programme 24 is likely to touch Rs.2.40 Lakh Crore mark.

According to financial analysts as a percentage of GSDP, the size of the Budget has remained within the range of 20% - 25% with minor inter-year variations.

As per the latest IMF projection, the world economy is expected to grow 3.2% this year,

before slowing further to a 2.7% in 2023.

In the case of Odisha, the economy is projected to register higher growth of about 8% in 2022-23 as well as in 2023-24.

Analysts pointed out that the Budget formulation is now based on the micro-economic outlook and the fiscal framework envisaged in the fiscal responsibility legislation with an objective to counter the deficit bias and maintain a sustainable fiscal position.

It also takes into account implications of key public policy decisions and factors in the risks to public finances. Thus, maintenance of fiscal sustainability is the primary concern of the budget formulation process.

The debt stock is expected to remain well within the FRBM prescribed limit of 25% of GSDP in the medium term. Odisha's overall fiscal outlook remains stable over the medium term, officials say.

BJD blasts Ayushman plan

Bhubaneswar(KCN) : Claiming that State Government's Biju Swasthya Kalyan Yojana (BSKY) is much better than Centre's Ayushman Bharat Yojana, the Governing BJD on Thursday slammed the BJP for demanding implementation of the Central scheme in Odisha.

Addressing a press meet here, BJD spokesperson Shreemayee Mishra said that on a regular basis, Odisha BJP has been harping on how Ayushman



Bharat Yojana formally known as Pradhan Mantri Jan Ayushman Yojana is such a better program than the BSKY.

However, yesterday's Union Budget has exposed the Odisha BJP's false propaganda and deception on Ayushman Yojana, she said.

Under the Outlay on major schemes in the Union Budget 2023-24 under serial no. 7 of Core Schemes, the Centre has provided only Rs.7200 crores towards Ayushman Bharat yojana.

"When we take into consideration India's 28 States and 8 Union Territories, per State/UT it comes to around Rs. 200 crores per annum for Ayushman Yojana," Shrimati Mishra said.

On the other hand, the BJD Government led by Chief Minister Naveen Patnaik spends about Rs. 6000 crores under the BSKY which is on average about Rs. 200 crores per district per year in Odisha. It means, Rs 200 crores of Ayushman by Centre per year would only cover one district of Odisha. Where would the rest 29 districts of Odisha go? Searching for the empty promises and false narrative of Odisha BJP on Ayushman? she asked.

The BJD leader further asked, "What relief will the people of Odisha get? Will Odisha BJP leaders have the courage to reply? They won't, and they can't."

The CM is committed to provide comprehensive healthcare to the people of Odisha as compared to the false propaganda of the Odisha BJP, she added.

Another BJD leader Gautam Buddha Das said a woman can only avail treatment for 5 lakhs under Ayushman Bharat while she can avail it upto Rs.10 lakhs under State scheme.

It seems Odisha BJP leaders want Odisha's Nari-Shakti not to benefit from Rs.10 lakhs of BSKY rather half of it at 5 lakhs in Ayushman, just for their selfish political interests, he said. Giving another example of organ transplants, under Ayushman Bharat, a patient requiring organ transplant cannot exceed the limit of Rs 5 lakhs but in BSKY, the beneficiary can benefit far exceeding the Rs 5 lakhs limit.

"Even after this if the Odisha BJP leaders haven't been able to understand the difference between Ayushman and BSKY and the benefits of BSKY far superseding Ayushman, we will be very happy to explain to them till they are able to understand," said Mishra. The BJD leaders urged the Odisha BJP leaders to stop misleading people.

India is a highly populous country with deep encroachment into forested areas. The recent highly monitored and media hyped reintroduction of the African cheetahs to Kuno National Park in Madhya Pradesh, has created great enthusiasm around the globe for more such reintroduction programs in different parts of the world. The social media has been loaded with several posts asking for the introduction of spotted hyena from Africa into Indian wilderness. Hyena breeding rates are high and they would not get enough prey if they establish themselves successfully. The result would be an inevitable human/ animal conflict that would prove detrimental for the animals as well as the local populations. Spotted hyenas hunt in groups, a strategy not faced by herbivores in their natural ecosystem. They are adopted to predation by lions, tigers and leopards and wild dogs. Striped hyenas present in the ecosystem are mostly scavengers like foxes and jackals. They hunt smaller prays and feed upon other animal carcasses. Strategic group hunting by aggressive spotted hyenas would lead to negative impacts on the already dwindling herbivore populations. Furthermore, other than increased predation pressure, there will be intense competition among the major predators resulting in catastrophic changes to the ecosystem. Nature selected spotted hyenas to become extinct and it would be a mistake to introduce them into the Indian wilderness without looking into the proms and cons. Sometimes our best intentions ran into disaster unless we do our homework and calculations cautiously looking at future ecological and environmental impacts!

Rishi Sunak marks 100 days as UK prime minister, problems with party mount

We need growth or our debts will get bigger," lawmaker Iain Duncan Smith, a former Conservative leader, said this week. "Targeted tax reductions will help achieve that." Sunak is resisting both labour unions and tax-cutting Tories. He argues that double-

Sunak also has struggled to rid the Conservative Party of its reputation for scandal and sleaze. A member of his Cabinet, Gavin Williamson, quit in November over bullying claims. On Sunday, Sunak fired party chair Nadhim Zahawi for failing to come clean about a multimillion-dollar tax dispute. Deputy Prime Minister Dominic Raab is being investigated over allegations he bullied civil servants, which he denies.

LONDON: U.K. Prime Minister Rishi Sunak has angry unions to the left of him, anxious Conservative Party lawmakers to the right and, in the middle, millions of voters he must win over to avert electoral defeat. It's a daunting situation for Sunak, who on Thursday marks 100 days in office, more than twice the number of his ill-fated predecessor, Liz Truss. Installed as Conservative leader after Truss' plan for huge tax cuts sparked panic, the 42-year-old Sunak calmed financial markets and averted an economic meltdown after he assumed the post of prime minister on Oct. 25.

Next, Britain's youngest leader for two centuries — and its first prime minister of South Asian heritage — has promised to tame soaring inflation, get the sluggish economy growing, ease pressure on the overburdened health care system and "restore the integrity back into politics" after years of scandals under former Prime Minister Boris Johnson.

Easier said than done.

"The things that happened before I was prime minister, I can't do anything about," Sunak told a group of health workers this week. "What I think you can hold me to account for is how I deal with the things that arise on my watch."

Jill Rutter, a senior fellow at the Institute for Government think tank, said Sunak had succeeded in overcoming the impression that the U.K. "had a completely lunatic government."

"You would chalk that up as the first thing that he had on his to-do list," she said. "Otherwise, it's slightly hard to see concrete achievements."

Rishi Sunak is a former U.K. Treasury chief, and his top priority has been the country's economic malaise. Gross domestic product remains smaller than it was before the coronavirus pandemic, and the International Monetary Fund forecast this week that the

U.K. will be the only major economy to tract this year, shrinking by 0.6%.

Sunak blames global forces — disruption from the pandemic and Russia's invasion of Ukraine. Critics say the elephant in the room is Brexit, which has led to a sharp reduction



in trade between the U.K. and the European Union.

Sunak, a longtime advocate of Britain's departure from the bloc, insisted Wednesday that the cost-of-living crisis had "nothing to do with Brexit.'

Whatever the causes, Sunak has little economic room to manoeuvre. Annual inflation hit a four-decade high of 11.1% in October and remained at a painful 10.5% in December. The U.K. is in the midst of its biggest wave of strikes in decades as nurses, paramedics, teachers, border agents and other workers seek pay increases to offset the soaring cost of living and the stresses of holding a job in an increasingly threadbare public sector.

Meanwhile, a faction inside the Conservative Party is pushing for immediate tax cuts to encourage growth, despite the damage done by "Trussonomics" just months ago.

digit public sector pay raises would drive inflation even higher and that "the best tax cut right now is a cut in inflation."

Economists say U.K. inflation will likely fall during 2023, allowing Sunak to meet one of his key pledges. Other goals are likely to be harder to achieve.

He is seeking to improve relations with the 27-member EU, and both sides have made progress toward resolving a dispute over Northern Ireland trade rules that has burdened businesses and shuttered the regional government in Belfast.

But any agreement will anger Conservative euroskeptics, who are likely to see rapprochement with Brussels as a betrayal of Brexit. A compromise also faces opposition from Northern Ireland's British unionists, who say post-Brexit customs checks undermine Northern Ireland's place in the United Kingdom.

The leader of the opposition Labour Party, Keir Starmer, alleged Wednesday that Sunak was "too weak" to tackle bad behaviour.

U.K. voters haven't yet had their say on Sunak, who was chosen as party leader by the 357 Conservative members of Parliament. The government doesn't have to call a national election until late 2024, so Sunak may have time on his side.

Or, he may not. The Conservatives are trailing 20 or more points behind Labour in opinion polls, and poor results in May's local elections could spur calls for another change of leader.

Some Conservatives hanker for the return of Johnson, whose final words to Parliament as prime minister — "Hasta la vista, baby" — hinted at a comeback.

Some analysts say it may be too late for any Conservative leader to avoid defeat. An Ipsos poll released this week, considered accurate to within 4 percentage points, found 66% of respondents wanted a change of governing party. Only 10% thought the Conservatives had done a good job.

Steven Fielding, emeritus professor of politics at the University of Nottingham, likened the mood to the final years of Prime Minister John Major's government, wiped away by Tony Blair's Labour election landslide in 1997 that ended 18 years of Conservative rule.

"People are just waiting for them to go," Fielding said. "And the longer they are there, the more irritated (voters) are with them." He said Sunak "is trying his best. But people aren't listening."

In 2023-24, the budget size has become 14.92 per cent of GDP. This decline in the share of budget size might obscure the economy's growth. To further revive the economy and to grow at 8-8.5 per cent, the budget size should have been around 16 per cent of GDP.

Capital Expenditure was budgeted at 2.91 per cent of GDP in 2022-23 which increased to 3.32 per cent in 2023-24. The capital outlay is pegged at 2.77 per cent of GDP if we exclude the repayment of past loans. Revenue Expenditure is estimated at 11.61 per cent in 2023-24 (12.38 per cent in 2022-23 BE). Therefore, Revenue Expenditure should be pegged at more than 13 per cent. The Gross Fiscal Deficit (Gross Borrowing) is pegged at 5.92 per cent of GDP in 2023-24(BE) as against 6.44 per cent of GDP in 2022-22(BE).

The total devolution to the states as a percentage of Gross Tax Revenue (GTR) has increased from 29.61 per cent in 2022-23 (BE) to 30.39 in 2023-24 (BE). A declining trend in the devolution of states' shared taxes has been witnessed over the last few years, barring a marginal increase during 2023-24. Total Transfer to states as a percentage of GTR has declined to 29.44 per cent in 2023-24 from 34.04 per cent in 2022-23.

Similarly, Other Grants/Loans/Transfers

The devolution to Odisha has increased marginally from 1.34 per cent of GTR in 2022-23 (BE) to 1.38 per cent in FY 2023-24 (BE). Its share in shared tax was budgeted at Rs 36,



977.88 crores in 2022-23 (BE). However, it amounts to Rs 42,989.33 crore in 2022-23 (RE) and Rs 46, 251.18 crore in 2023-24 (BE).

Mahatma Gandhi National Rural Employment Guarantee Scheme is down to 1.33 per cent of the budget size in 2023-24 from 1.85 per cent in 2022-23. In absolute terms, there is a slash of `13,000 core in MGNREGS. This will affect employment scenarios in rural areas. The total Core of the Core Schemes has also declined to 1.91 per cent of the budget size in 2023-24 compared to 2.51 per cent in 2022-23(BE). This will impact revenue receipts of the states and limit the economy's demand side.

RBI seeks details of banks' exposure to Adani Group

MUMBAI: The Reserve Bank of India (RBI) has sought details about lenders' exposures to the Adani Group, banking



sources said, a day after the conglomerate withdrew the Rs 20,000-crore follow on public offer (FPO) of its flagship firm Adani Enterprises amid the steep fall in its stock prices.

On Wednesday, Swiss lender Credit Suisse stopped accepting bonds by Adani group companies as collaterals for margin lending.

The going has been tough for the diversified conglomerate over the past week ever since US-based short seller Hindenburg Research levelled a slew of allegations about the group's operations, calling it the biggest corporate con ever. The Ahmedabad-headquartered group has denied all the allegations but failed to convince analysts and investors.

Government-owned life insurance behemoth Life Insurance Corporation (LIC) has disclosed of having an exposure of Rs 36,474.78 crore to Adani group's debt and equity, and added that the amount is less than one per cent of its total investments. Adani Enterprises scrip closed 26.50 per cent down at Rs 1,564.70 a piece on the BSE on Thursday, as against gains of 0.38 per cent on the benchmark.

AEL late on Wednesday cancelled the share sale due to market volatility and decided to return the money to investors.

The total number of blocks in these districts is 102. Even after five years of the launch of the ADP programme with a focus on five main themes - health and nutrition, education, agriculture and water resources, financial inclusion and skill development, and basic infrastructure - which have a direct bearing on the quality of life and economic productivity of citizens, there is a lot to be desired from the 10 districts.

None of the districts is up to the mark in improving the health and nutrition condition even after five years of the launch of the programme. The tribal-dominated Malkangiri district is at the bottom of the list with a five per cent weightage.

In the agriculture and water resources sector, Gajapati district is among the top ten districts of the country while Balangir, Dhenkanal and Kalahandi are in the bottom 10 districts since the inception of the programme. Rayagada is among the top performer's districts by achieving 51 per cent improvement in the education sector while Nabarangpur is in the bottom 10 districts with 13 per cent against the 30 per cent target. The three core principles of the programme are convergence (of central and state schemes), collaboration (among citizens and functionaries of central and state governments including district teams), and competition among districts.
