



Born Moishe Shagal, modernist Marc Chagall received his artistic training in Paris and St. Petersburg, yet never forgot his roots on a Belarussian shtetl. "I and the Village," a mesmerizing evocation of Chagall's homeland, employs the artist's trademark primary hued palette.

Also known as the "Venus de Milo," this graceful marble sculpture was produced during the Hellenistic period. One of the most recognizable images in the canon of Western art, the sinuous sculpture's identity nevertheless remains a mystery. She may represent Aphrodite, the Greek goddess of love, or Amphitrite, a sea goddess worshipped on the island of Melos.

In 1974, a group of farmers digging a well stumbled upon a lifesize, clay figure. Subsequent archaeological excavations uncovered a cache of more than 8,000 individualized terra cotta soldiers, created to guard Qin Shi Huang, China's first emperor, in the afterlife.

Popularly known as "The Scream," Munch's surrealist icon was originally titled "The Shriek of Nature" and was inspired by a disturbing vision the artist experienced while walking in the Norwegian countryside. Munch executed several versions of "The Scream," two of which were stolen and subsequently recovered.

Contemporary artist Fernando Botero is famous for his corpulent subjects, including the colorful cast of characters depicted in "Dancing in Colombia." In addition to scenes of everyday life, Botero is also well known for his zaftig renderings of the "Mona Lisa" and Pablo Escobar. In 2000, Botero bequeathed over 200 works of art-including 123 of his own-to the Banco de la República, which are now housed in the Museo Botero in Bogotá.


A titan of German Romanticism, Caspar David

in the National Museum of Ecuador, it displays the easily recognizable block-like geometric forms characteristic of Incan art.

Aptly located in the dining hall of a Milanese convent, Da Vinci's "Last Supper" is one of the most famous images in Western art, yet survives only thanks to intense restoration. Art aficionados wishing to get a glimpse of the 15-by-29-foot wall painting in person should book well in advance; admission is limited to small groups with viewings capped at just 15 minutes.

Persian miniature master Sultan Muhammad is known for his exquisite manuscript illustrations, including this miniature depicting the Prophet Muhammad's journey to heaven. Although the representation of human and animal forms was prohibited by Islam, exceptions were made for a small number of literary works. This remarkable manuscript was commissioned by Shah Tahmasp, who was also the artist's pupil.

A glittering jewel in the Art Nouveau crown, Secessionist master Gustav Klimt unveiled his celebrated painting of the entwined lovers during the height of his "Golden Period." Although prudish Edwardian audiences initially denounced the painting for its unapologetic eroticism, it fetched a record price for an Aus-



trian painting at the time. After spending almost a decade in Europe, Grant Wood returned to America's heartland



Church canonized Rublev, a member of the monastic community of St. Sergius outside Moscow, in 1988.

Korea's most influential "true-view" painter, Jeong Seon was a government official who traveled frequently, capturing local landscapes



in ink and watercolor. His breezy, lyrical style rejected the pre-existing stylized aesthetic, influencing Korean artists for generations. This elaborate manuscript was illustrated in the scriptorium of the Gunda Gunde Monas-

Scottish Art Nouveau phenomenon Charles Rennie Mackintosh, depicts the ancient tradition of wassailing—originally a pagan fertility ritual. The frieze originally graced the Ladies' Luncheon Room in Glasgow's Miss Cranston's Ingram Street Tearooms, and was part of a larger remodel of the premises by Mackintosh and his future wife, Margaret Macdonald.

This mosaic from the south gallery of



Istanbul's magnificent Hagia Sophia commemorates an important political alliance between East and West-the union of Emperor Komnenos and his redheaded Hungarian bride, Irene. Created from tiny, glittering glass tesserae, the image depicts the imperial couple presenting gifts to the central figures of the Virgin Mary and the infant Christ. (Concluded)



We must not forget Major Hari Pal Singh Ahluwalia, the great mountaineer and a friend of the specially-abled

Major Hari Pal Singh Ahluwalia was a man who wore many hats. He was an exceptional



mountaineer. а warrior of the battlefield. a renowned writer, a friend of the disabled, but he was also no less than a hero for the country's 60-plus generation. Major HPS Ahluwalia was a

member of the mountaineering team that scaled the summit of Mount Everest on 20th May 1965. He was a part of the mountaineering contingent of the Indian Army.

The Indian team successfully climbed Mt. Everest after six years of the historic ascension by Tenzing Norgay and Edmund Hillary, therefore implying that Major Ahluwalia was among the first Indians to do so. In 1965, Major Ahluwalia also fought in the war against Pakistan and taught the enemy army an unforgettable lesson on the battlefield. He passed away last Friday at the age of 85. During the war against Pakistan, a portion of his body was paralyzed. However, that did not

deter him from going after his vision. Throughout his life, he worked in favor of those with disabilities. He founded the Indian Spinal Injury Center in New Delhi, where diseases related to the spinal cord are treated. It is the best hospital of its kind in India.

Major Ahluwalia's life was legendary and awe-inspiring. He was a soldier, mountaineer, writer and founded a hospital. We need to

change our insensitive mentality about the

interests of the disabled people of our country. Persons with disabilities should also be treated as equals as they do not need undue favors. In India, people with mental and physical disabilities face discrimination every day. Are homes or commercial buildings being built for the disabled in our country? The answer to this question is disheartening.

The reason is that we have an unsympathetic attitude towards the specially-abled right from the government to the society. There are numerous aware citizens like Major HPS Ahluwalia who keep opening the eyes of the government and society, telling them that they cannot be left to fend for themselves.

There are 16 types of disabilities in India. Major Ahluwalia himself used the aid of a wheelchair. He believed that the wheelchairbound population should have the same facilities to get out of their homes, take a bus to college or the office, and go to shopping complexes or other public buildings like the ordinary public. But the situation is such that people with disabilities cannot move effortlessly in most places. We are failing to plan enough to provide adequate facilities in high-rise buildings and homes for them. The same is the case with the elderly. In India, the elderly and the disabled face blatant neglect. In a few days, Finance Minister Nirmala Sitharaman will present the Union Budget. If, in this budget proposal, she grants tax relief to those builders who are helping the differently-abled in any manner, then in a way it will be an honest and fair tribute to Major

The real estate sector in India has taken a quantum leap in the last few decades, but those real estate companies are scarce which are building their projects, keeping in mind the convenience of the specially-abled and elderly. Even today, one will rarely find such residential and commercial buildings in which wheelchairs of the disabled can fit inside the lift. There is so little space in the lifts that it is not only difficult but next to impossible to carry a wheelchair inside them. Cabinets in bathrooms and kitchens are so high that it is extremely difficult for a disabled person to use them.

Under the pretext of Major HPS Ahluwalia, it is also significant that we promote and encourage other climbers. Those climbers who have had commendable achievements must be their due share of recognition and reward. Roads in the capital are named after the two climbers who first scaled Mount Everest on 29 May 1953. There is a road named after Sir Edmund Hillary in the Chanakyapuri area of New Delhi. He was the High Commissioner of New Zealand to India from 1985–1989. The doors of Edmund Hillary's office were always open to mountaineers, sportsmen, writers, etc. He was a very popular diplomat. There is also the Tenzing Norgay Road in Chanakyapuri. It is wishful-thinking to see a road or institution named after Major HPS Ahluwalia in different parts of the capital.

Everyone knows that Bachendri Pal Ji was the first Indian female mountaineer to surmount the treacherous slopes of Mt. Everest. Having been impressed by her, Anita Kundu from Haryana has also scaled Mount Everest. The tricolor has been proudly waved thrice at the top of Mt. Everest and on the remaining highest peaks of the seven continents. The Indian couple Vikas Kaushik and his wife Sushma Kaushik have accomplished the distinction of being the youngest couple to climb Everest. At 45, Premlata Aggarwal had set the record for the oldest person to climb Everest. He had also scaled the summit of Everest along with the Kaushik couple.

It is of utmost significance that one understands that mountaineering will gain momentum only when the government, public sector, and private sector collectively bear the expenses of these mountaineers' trips as mountaineering costs are exorbitant. One must remember, that in India from the 1960s to the 1990s, the army used to bear all the expenses for the mountaineers of the army to conquer Mount Everest or other peaks. The Army has a sufficient budget for its mountaineers.

But there is an urgent need to think about those climbers who are not from the Army. Care has to be taken to rehabilitate those who get injured during these expeditions. Mountaineering is the only adventure sport in which the climber risks facing death every moment. One minor carelessness bears life-taking costs and could lead to being buried alive in the deadly cracks of ice.

His recent book "Turn Around India" was released by the Prime Minister, Narendra Modi, giving acknowledgement to his insights and vision. Speaking to Ritwik Mukherjee, R P Gupta, Non-Executive Director of Shiva Cement Ltd. and Advisor of Shivom Minerals ltd and entrepreneur-turned author, shares his thoughts on a wide range of issues facing Indian economy and India's socio-economic structure.

Excerpts:

RM: What does India need for consistent growth?

Gupta: While building new capacities for production, there might be intermittent supply overhang causing loss to producers. For which, regular export is the only answer. But India is globally not so competitive. The global competitiveness doesn't depend upon the producers alone but upon the whole gambit of policies and regulation. Those must facilitate exports to grow at the rate of 15-20 per cent every year. India's share of exports in the world is barely 1.7 per cent; that must increase to 3.5 per cent in the next 5 years. Failing which, the GDP growth may not be consistent.

Radical changes in the policies and regulations might take some time. Hence, during the interim period, India must extend export incentives in the selective sectors so that; the incremental export is 4/5 times of



temporary push to GDP growth but it will invite inflation causing miseries to public. Right choice is boosting the investment in productive assets and infrastructures. In recent years, the investment rate has declined from 38 per cent of GDP to below 28 per cent. That must be restored for consistent high growth. For this, private investment must be rekindled through a series of structural reforms.

RM: Many a times in your book, you have mentioned that 'financial economy must compliment real economy'. What did you actually mean by that?

Gupta: Financial sector must supplement and not disrupt "real economy" for the growth and development of Nation. Current regulations protect banks and financial investors but not the entrepreneurs; they have invested the seed and risk capital. In future,

major easement of the business and taxation laws. Currently, these laws are not encouraging the entrepreneurs for expanding their business. Even minor non-compliance or delay in compliance has caused the criminal prosecution. At this juncture, it is very crucial to inspireentrepreneurs and craft motivational spirit among them. India must surmount the past legacy of Colonial laws and resign from the syndrome of excess and tough regulation. That has adversely affected India's ranking on the front of "economic freedom" and it must be improved. The complete compliance of existing laws is not feasible even by a large corporate and hence; the simplification of laws is a right choice. By this, the abidance of law shall progress and the respect for law and institutions shall succeed.Several studies have concluded that; the business laws and regulations must prevail but those must be simple and compliable by the majority and those must result in to developmental outcome. Legislature intent must be disclosed in the pre-amble of each law. Facilitation must co-exist along with the regulation. RM: So far you have discussed issues pertaining to the organised sector. But what about India's large unorganised sector? Gupta: I'm glad you raised the topic. The role of unorganized sector in India is not recognized so far. Hence, it lacks policy support. This sector contributes more than 45 per cent of GDP and employs about 84 per cent of work force. Those are majorly engaged in the trade, transportation, construction, restaurants and such other services besides manufacturing. They are managed by large numbers of self-employed entrepreneurs. Their contribution to GDP, exports and job creation is very high. Any Nation, in its developing phase, needs such unorganized sector; which will graduate along with the growth of Nation. Past history of Asian

lockdown. A dedicated annual survey may be conducted not only to measure GDP but also to diagnose the problems enabling to make pro-active policy. This is the right antidote for resolving the job crisis.

RM: You have also strongly advocated corporatisation of Indian railways. Could you please throw some more light on this? Gupta: Investment in the capital assets by Railway is lesser than 20 per cent of the investments in Road transport. Hence, the share of Railway in goods traffic has reduced from 86 per cent in 1950-51 to barely 25 per cent. Road transport of goods is obviously costlier. Hence, the average logistic cost in India is 2-3 times compared to peer nations. By this, cost of goods and services are inflated and India is loser on the export front. So as to overcome, Railway needs about Rs. 30-35 trillion in next 5 years for capacity building and efficiency improvement. For mobilizing such huge resources, Railway must be split in to six corporates. Those must be listed on stock exchange. Each corporate shall raise funds from banks and capital market. At a later date, the entry of private sector may be allowed, as done in the Aviation Industry.

NEW YORK: André Leon Talley, the towering former creative director and editor at large of Vogue magazine, has died. He was 73. Talley's literary agent David Vigliano confirmed

Talley's death to USA Today late Tuesday, but no additional details were immediately available.

Talley was an influential fashion journalist who worked at Women's Wear Daily and Vogue and was a regular in the front row of fashion shows in New York and Europe. At 6-feet-6 inches tall, Talley cut an imposing figure wherever he went, with his stature, his considerable influence on the fashion world, and his bold looks. In a 2013 Vanity Fair spread titled "The Eyeful Tower," Talley was described as "perhaps the industry's most important link to the past." Designer Tom Ford told the magazine Talley was "one of the last great fashion editors who has an incredible sense of fashion history. ... He can see glamorous way than you did ... no one was grander and more soulful than you were."

In his 2003 memoir, "A.L.T.: A Memoir," Talley focused on two of the most important women in his life: his maternal grandmother, Bennie Frances Davis and the late fashion editor Diana Vreeland.

The state election commission (SEC) on Wednesday evening declared the results stating that the BJP had won 384 seats, followed by the NCP with 344 seats. As per the SEC's data, the Congress has won 316 seats, while the Shiv Sena, which currently has the chief minister post, managed to bag only 284 seats. As many as 206 Independent candidates have also won in this election, it was stated.

Despite being out of power in the state for nearly 26 months, the BJP has managed to record such success, he said.



an intra-day high of 74.32. The domestic unit finally settled at 74.44 against the American currency, up 14 paise over its last close. On Tuesday, the rupee slumped by 33 paise to close at a two-week low of 74.58 against the US dollar. "The Indian rupee gained the most in a week following stronger regional currencies. Domestic bond markets saw a recovery on suspected intervention by the central bank, which helped in rupee recovery," said Dilip Parmar, Research Analyst, HDFC Securities.

'Also, the relentless selling of dollars from corporates caused speculative unwinding of po-sitions," Parmar said. "Spot USD/INR is ex-pected to consolidate within the 74.25 to 74.80 band in the coming days," he added.

"Rupee traded volatile with weak opening trend in the morning session and picked up strength later, taking support near 74.60; and thereafter rallied towards 74.40 on the back of weakness in the dollar," Jateen Trivedi, Senior Research Analyst at LKP Securities, said.

"Technical resistance for USD/INR also supported rupee from 74.60 where it has shown resistance to cross earlier in Jan 2022 start, and going ahead market shall be in the range of 74.25-74.60," he added. Meanwhile, the US dollar index, which measures the greenback's strength against the basket of six currencies, fell 0.11 per cent to 95.62. Brent crude futures, the global oil benchmark, jumped 0.94 per cent to USD 88.33 per barrel. Foreign institutional investors remained net sellers in the capital market on Tuesday, as they offloaded shares worth Rs 1,254.95 crore, as per stock exchange data. On the domestic equity market front, the BSE Sensex ended 656.04 points or 1.08 per cent lower at 60,098.82, while the broader NSE Nifty declined 174.65 points or 0.96 per cent to 17,938.40.

disability, loss of limb or eyesight, caused due to any violent act of extremism or anti-social elements during poll duty has been fixed at Rs 15 lakh. Similarly, persons with permanent disability due to accident or any other cause in the course of election duty will be provided Rs 7.5 lakh.

A compensation of Rs 2 lakh will be provided to persons sustaining grievous injuries or multiple fractures caused by accident or any other cause during poll duty. The notification said that a person is to be treated on poll duty as soon as he/she leaves residence to report to any election related duty including training

and fair election, the Commission directed that no spirituous, fermented or intoxicating liquors or other substances of like nature shall be sold, given or transported to or distributed at hotels, eating houses, tavern, shops or any other place, public or private within the respective wards during the period of 48 hours preceding the poll up to the day following the poll day.

The Excise Department was asked to issue necessary orders in this regard to the field level officials. The Commission expects that the above restrictions shall be vigorously enforced by concerned authorities.

No arms and fatal weapons will be allowed to the booths, people carrying licenced guns and other weapons are prohibited from moving around near those places from February 14 (5PM) to March 1 (5PM), the Commission ordered the Additional Chief Secretary (ACS), Home Department.

However, the election officers, polling officers, police officers and any other person appointed to maintain law and order at a polling station, who is on duty at polling station can go armed as defined in the Arms Act, 1959 of any kind within the neighbourhood of the polling station set up in every ward. The SEC has warned of stern action against the persons who would violate its orders.

In order to facilitate the voters in these areas to exercise their franchise, the SEC asked the State Government to grant paid holiday to all Government employees and those working in Government Undertakings/Boards, Corporations, Apex Bodies etc. on the day of poll for their respective local area.

The Government employees who desire to exercise their franchise at a place away from their headquarters on the date of poll will be allowed Special Casual Leave for maximum period of 3 (three) days i.e. on the day preceding poll, one day after poll and on the date of poll.

The leave to be granted may be treated as Special Casual Leave in addition to normal Casual Leave admissible to them during the Calendar Year, 2022.

Moreover, the SEC has also written to the Labour and ESI Department to ensure that every person employed in any business, trade, industrial undertaking or any other establishment and desiring to vote at the said election shall be granted paid holiday on the date of poll.

Unreasonable 21 per cent indirect taxes resulting in chronically ill civil aviation industry: IndiGo CEO

NEW DELHI: The civil aviation industry has unable to live up to its true potential of boosting commerce and employment," he said. On January 17, rating agency Crisil said in a



resulting in a chronically ill sector, IndiGo CEO Ronojoy Dutta said on Wednesday. Dutta requested the Ministry of Finance to reduce central excise taxes on fuel from 11 to 5 per cent and eliminate custom duties on aircraft repair parts.

Civil aviation provides efficient infrastructure, critical for economic growth and employment in our country, he said in a statement.

"Yet civil aviation pays 21 per cent of its revenues to the government in indirect taxes with very little input credit," Dutta said.

It is an unreasonable proposition to expect that the industry should earn a 21 per cent margin just to pay taxes to the government, India's largest airline's CEO noted.

"This unreasonable proposition is resulting in an industry that is chronically ill and is report that Indian carriers are likely to incur a massive loss of approximately Rs 20,000 crore in 2021-22 due to third wave of the COVID-19 pandemic and rising fuel prices. Dutta requested the Ministry of Finance to take immediate action to address the long festering problem.

"Central excise taxes on fuel should be reduced from 11 per cent to 5 per cent, ATF (aviation turbine fuel) should be brought under the GST, custom duties on repair parts should be eliminated," said Dutta, who is also the Whole Time Director of the airline. A rationalisation of taxes will result in explosive growth for aviation, which will have multiplier effects throughout the economy, stimulating commerce and employment and integrating the different regions of our diverse country closer together, he said.

Calcutta High Court quashes Notices issued under section 148

Income Tax Act have been quashed with liberty to the Assessing Officers concerned to initiate fresh re-assessment proceedings in accordance with the relevant provisions of the Act as amended by Finance Act, 2021 and after making compliance of the formalities as required by the law.

Jainsaid that the Calcutta High Court has made very appropriate decision by quashing Notices issued by Income Tax Department under section 148 on or after 1st April, 2021 ignoring the provisions of section 147 to 151 substituted by the Parliament with effect from 1st April, 2021. Jain pointed out that the High Court has followed the decision of Delhi High Court in the case of Man Mohan Kohli and noted para 103 of Order that Executive cannot use the administrative power to undermine the expression of Parliamentary Supre-macy in the form of an Act of Parliament and it cannot frustrate the purpose of substituted statutory provisions like sec 147 to 151 by emptying it of content or impending or postponing their effectual operation.

KK Jain, President DTPA suggested the CBDT that it should honour the decisions of various High Courts and should issue instructions declaring the notices issued on or after 1st April, 2021 in contravention of the substituted provisions of sec. 147, 148 and 148A. Accordingly the officials should withdraw the notices in the interest of justice. RD Kakra, Chairman, Legal Relief Society said that Taxpayers, who have not challenged the notices, may still have to file the petitions in High Court or go through the long process of reassessment procee-dings and appellate procee-dings.

MELBOURNE: Top-ranked Ash Barty is breezing through the Australian Open draw so far. Things could get a lot more interesting soon enough.

Barty extended her streak of service holds to 48 games and moved into the third round at Melbourne Park for the sixth consecutive year by beating 142nd-ranked qualifier Lucia Bronzetti 6-1, 6-1 in under an hour Tuesday in Rod Laver Arena.

Barty dropped just one game in her first-round match, which also took less than an hour, as she bids to become the first Australian woman since 1978 to win the country's Grand Slam tournament.

She is already a two-time major champion, with trophies at the French Open in 2019 and Wimbledon last year.

Next up for Barty will be a matchup against another Italian, 30th-seeded Camila Giorgi.

Win that, and Barty could end up in a fourthround showdown against defending champion Naomi Osaka.

Eighth-seeded Paula Badosa has moved into the third round of the Australian Open with a 6-0, 6-3 win over Italian qualifier Martina Trevisan in Rod Laver Arena.

Badosa won the title at a Sydney tuneup tournament last week, when she put together backto-back match wins in Australia for the first time. In other early second-round results on Day 3 of the year's first tennis Grand Slam event, twotime Australian Open champion Victoria Azarenka beat Jil Teichmann⁶-1, 6-2, and No.30 Camila Giorgi beat Tereza Martincova 6-2, 7-6 (2).

Top-ranked Ash Barty, aiming to be the first Australian woman to win the home championship since 1978, was playing Lucia Bronzetti on the main court at Melbourne Park.

Nadal shares the men's record of 20 singles titles with Roger Federer and Novak Djokovic, and he doesn't have either of them in the draw

She will next face Amanda Anisimova, a 20year-old American who beat Olympic gold medalist Belinda Bencic 6-2, 7-5.

The winner of that is likely to face top-ranked Ash Barty in the fourth round.

Osaka won the Australian Open last year, her fourth Grand Slam title, but then withdrew from the French Open and skipped Wimbledon as she took a break for her mental health. She then was ousted early at the U.S. Open. After a long off-season to reset, she's unbeaten in five matches in Australia this year. Asked how she rated her form, Osaka said that's not how she's approaching things.

"Honestly I'm trying not to do that,"" she said in an on-court TV interview.

"I'm a bit of a perfectionist. If I compare myself with the past, I'll never be satisfied. The goal for me is just to have fun. I think we're accomplishing that," she said.

"Since the draw for the first major of the year was made, a big focus has been on a potential encounter between Osaka and Barty, the 2021 Wimbledon and 2019 French Open champion who is aiming to be the first Australian woman since 1978 to win her home championship. Barty was front and centre when the tournament celebrated its inaugural First Nations Day, albeit only for 52 minutes as she beat 142nd-ranked qualifier Lucia Bronzetti 6-1, 6-1.

""It was nice for me to be a part of it in a way that I feel most comfortable," Barty, who has Indigenous heritage, said of the day dedicated to the Aboriginal and Torres Strait Islander people of Australia. Out on the tennis court is how I express myself as an athlete, it's how I'm able to express myself as a person as well. "On a day we're bringing cultures together, bringing people together. It was great for me to be able to play a small role doing what I love," she said.

Miomir Kecmanovic, who was originally drawn to meet Djokovic on the opening night, advanced to the third round with a 7-6(7), 7-5, 7-6 (8) win over Tommy Paul of the United States.

Wimbledon finalist Matteo Berrettini and No.23 Reilly Opelka advanced in straight sets, while No.19 Pablo Carreno Busta beat Tallon Griekspoor 6-3, 6-7 (6), 7-6 (3), 3-6, 6-4. In two marathon five-setters, No.14 Denis Shapovalov held off Kwon Soon-woo 7-6 (6), 6-7 (3), 6-7 (6), 7-5, 6-2 in 4 hours, 25 minutes on Margaret Court Arena, and Sebastian Korda edged Corentin Moutet 3-6, 6-4, 6-7 (2), 7-5, 7-6 (6) in 4:47.

In the women's draw, French Open champion and fourth-seeded Barbora Krejcikova beat Wang Xiyu 6-2, 6-3 to move into a third-round match against No.26 Jelena Ostapenko.

Eighth-seeded Paula Badosa advanced in straight sets and two-time Australian Open champion Victoria Azarenka moved into a third-round match against 15th-seeded Elina Svitolina, who was leading 6-3, 5-7, 5-1 when Harmony Tan retired from their second-round match.

Svitolina waited on court at Margaret Court Arena until Tan, who had received treatment on her lower left leg, was removed in a wheelchair.

""It's always horrible when any athlete gets injured in competition. She played really well and she made it not easy for me. "It's tough to see a player going out like this," Svitolina said.
