### Man 'shoots dead' stray dog in **Bhubaneswar, injures another**

BHUBANESWAR(KCN): In yet another shocking incident of animal cruelty, a man killed a stray dog and in-jured another allegedly by using a firearm at Jagamara area here on Wednesday. The incident took place at Tala Sahi late in the afternoon. Locals spotted the injured animal and informed an animal welfare organisation, Sewa Hi Sankalp Anusthan. Founder of organisation the Rajesh Prusty and his colleagues rushed to the spot and began treatment of the injured dog when the locals again informed the team about another canine lying on the premises of a house nearby. However, on reaching the house they found the second dog dead. The death prima facie was due to pellet injuries in the chest part. The in-



## India's Rising Omicron Wave Brings a Grim Sense of Déjà Vu

When the Omicron coronavirus variant spread through India late in December, Prime Minis-



ter Narendra Modi urged the nation to be vigilant and follow medical guidelines. Arvind Kejriwal, the chief minister of the capital region of Delhi, swiftly introduced night curfews,

shut down movie theaters, and slashed restaurants and public transport to half capacity.

Then, both men hit the campaign trail, often appearing without masks in packed rallies of thousands.

"When it is our bread and butter at stake, they force restrictions and lockdowns," said Ajay Tiwari, a 41-year-old taxi driver in New Delhi. "There are much bigger crowds at political rallies, but they don't impose any lockdown in those areas. It really pains us deep in the heart."

In New Delhi, the number of daily infections increased by nearly 100 percent overnight. The sheer size of India's population, at 1.4 billion, has always kept experts wary about the prospects of a new coronavirus variant. In few places around the world was the toll of Delta as stark as in India. The country's official figures show about half a million pan-



#### 105 nations to get cheaper Merck Covid pill; molnupiravir not added to India's treatment protocol due to safety concerns

treatment protocol for the disease.

Five manufacturers will focus on producing the raw ingredients; 13 will produce both raw ingredients and molnupiravir itself; while nine will simply produce the finished drug.

Antivirals like molnupiravir work by decreasing the ability of a virus to replicate, thereby slowing down the disease.

Given to patients within days of a positive test, the treatment cuts the risk of hospitalisation, according to Merck, also called MSD outside the United States.

"Accelerating broad, affordable access to molnupiravir has been a priority for MSD from the start," said the company's Paul Schaper. "We are pleased to see this vision come to life." Merck jointly developed molnupiravir with the Miami-based company Ridgeback Biotherapeutics.

They will not receive sales royalties while Covid-19 remains classified as a public health emergency of international concern (PHEIC) by the WHO.

A PHEIC is the highest alarm the WHO can sound and its emergency committee last week reconfirmed the pandemic's top-alert status. The Geneva-based MPP is a United Nationsbacked international organisation that works to facilitate the development of medicines for low- and middle-income nations.

It was founded by Unitaid, which works on innovations to prevent, diagnose and treat major diseases in poorer countries.

While the search for vaccines has resulted in multiple products being approved for emergency use in the pandemic, the hunt for treatments for those who have already caught the disease has not been as fruitful.

The latest communication with the states mentioned a few amendments to IAS rules. One of the major changes proposed is if the state government delays posting a state cadre official to the Centre and does not give effect the central government's decision within the specified time, the officer shall stand released from the state cadre. At present, officers have to get a no-objection clearance from the state government.

The other change is the Centre will decide the actual number of officers to be deputed to the central government in consultation with the state and the latter should make eligible the names of such officers. According to the existing practice, states have to depute officers to the central government and at any point, it cannot be more than 40% of the total strength of the state's cadre.

The third proposed amendment says in case of any disagreement between the Centre and the state, the matter shall be decided by the central government and the state shall give effect to its decision within a specified time. The fourth change mentions that in a specific situation where services of cadre officers are

required by the Centre in "public interest", the state shall give effect to its decision. Retired bureaucrats opine that the proposed

amendment might create insecurity among the officers. "The move may cater to opportunities to political leaders to remove or bring one of their choices. For example, a state-level leader of a political party which is in power at the Centre may use his influence to remove an officer," said a retired bureaucrat of West Bengal cadre.

Another former IAS officer said, "At present, an officer can move the Central Administrative Tribunal (CAT) in his or her state if they are not ready to join the central deputation. But the proposed amendments indicate he or she may have to move CAT Delhi to register his or her objection," he said.

"Hero Indian Super League (ISL) Match No. 67 between Jamshedpur FC and Mumbai City FC scheduled for Friday, January 21, 2022, at Hyderabad FC and

Bambolim, stands postponed," the league organisers said in a statement. "The decision was taken considering advice from the League's medical team on Jamshedpur FC's inability to safely field a team and prepare for the match," the ISL added in its statement.

On Monday, the ISL between match

also postponed due to COVID-19, and so was Thursday's game between Kerala Blasters FC and ATK Mohun Bagan due to unavailability of enough players in the former's ranks after being hit by COVID-19 inside the biobubble.

Three days back, Jamshedpur FC's match against Hyderabad FC was postponed hours before kick-off after the

failed to field a team due to COVID-19 cases in its ranks. A match between Kerala Blasters FC and Mumbai City FC in Vasco was also postponed on Sunday, hours before kickoff as the southern outfit did not have the requisite number of players to field.

Prior to that, two more matches had been postponed this season after the coronavirus breached

MELBOURNE: Three Australian Federal Court judges on Thursday revealed their reasons for backing a government order to deport tennis star Novak Djokovic, explaining they did not consider the "merits or wisdom of the decision."

The judges on Sunday unanimously endorsed Immigration Minister Alex Hawke's decision to deport the 34-year-old Serb following an urgent court challenge on the eve of what was to be Djokovic's first match in defense of his Australian Open title. Djokovic accepted the verdict and flew from Melbourne to the United Arab Emirates hours later.

Chief Justice James Allsop and Justices James Besanko and David O'Callaghan on Thursday released a 27-page explanation of why they rejected Djokovic's challenge.

"The court does not consider the merits or wisdom of the decision," the judges said. "The task of the court is to rule upon the lawfulness or legality of the decision."

"Another person in the position of the minister may have not cancelled Mr. Djokovic's visa. The minister did," they added.

Djokovic had his visa revoked at Melbourne's airport on Jan. 6 hours after arriving because he wasn't vaccinated against COVID-19. A judge later found that the border officer's decision to cancel the visa was legally unreasonable and restored it.

But Hawke used his sweeping discretion under the Immigration Act to cancel the visa again on Friday on the broad ground of public interest.

Djokovic was a "high profile unvaccinated individual" whose presence in Melbourne "may foster anti-vaccination sentiment" and increase pressure on the health system, Hawke said in his 10-page decision to revoke the visa. Hawke had rejected Djokovic's arguments that his deportation would appear to be "politically motivated decision-making" that could jeopardize Australia's role as host of the first Grand Slam of the year.

Many argue the government deported Djokovic in response to public anger that an unvaccinated athlete had been allowed into the country without undergoing quarantine, even as the omicron variant strains hospitals, home COVID-19 tests are in short supply and Australians' relatives overseas are barred from visiting because authorities don't recognize their types of vaccines.

The judges rejected Djokovic's three grounds of appeal. The first was that the decision was illogical, irrational or unreasonable. The second was that the minister could not find that Djokovic's presence in Australia may be a risk to health or good order. The third was that the minister could not find Djokovic had a well known stance opposed to vaccination.

"It was open to infer that it was perceived by the public that Mr. Djokovic was not in favor of vaccinations," the judges said.

Djokovic, who returned to Serbia, is in talks with lawyers about suing the Australian government for £3.2million (\$4.4 million) for "ill treatment," the London-based The Sun newspaper reported, citing an unnamed source close to his agent Edoardo Artladi.

John Karantzis, a partner in Australian firm Carbone Lawyers, said Djokovic could have a case.

"If he concentrates on the ... unreasonable actions he would allege towards him, and not on policy grounds, he may succeed," Karantzis told Seven Network television.

CHENNAI: For the second time in as many years, India's domestic season is unlikely to have its premier domestic tournament, the Ranji Trophy. The Board of Control for Cricket in India's (BCCI) office-bearers had a meeting on Tuesday and, according to reliable sources, it has been decided that should the Covid situation improve, other domestic events including Cooch Behar, CK Nayudu and the senior women's T20 will be held, but due to the short window, hosting Ranji Trophy will not be possible. As things stand, the BCCI has not communicated anything officially to the state units. It is believed the BCCI have sought time but state associations have all but given up hope. While the Ranji Trophy was scheduled to begin on January 13, the onset of the third Covid wave meant the BCCI was forced to suspend the domestic season on January 4. Although the BCCI had stated that it had only postponed the start by 15 days, there has been little development since then and the Covid cases have only been increasing in most cities across the country. As per BCCI's original schedule, it needs around 75 days to host the Ranji Trophy. When the tournament was suspended, the Plan B for IPL BCCI initially thought of splitting it into two halves, sandwiched between the IPL. Under this method, the group stages were scheduled to be played in February-March, with the knockout stages in June-July or September-October. However, the onset of the southwest monsoon in June would make it impossible to host the matches in June-July. So, for the BCCI to host Ranji Trophy in two halves, the tournament has to begin at least by February 20, because the next edition of use.

the IPL is scheduled to start on April 2 as they need at least 35 days to hold the five group stage matches. With the players supposed to enter IPL bio-bubble by March 20, unless the tournament begins by February first week, it will make it impossible for the BCCI to host it. As a result, the BCCI is being left with no choice but to scrap Ranji Trophy again. If it is not able to host the tournament this season, questions will be raised about their decision to host white-ball events - Syed Mushtaq Ali T20s and Vijay Hazare Trophy — ahead of the Ranji Trophy. While the initial plan was to start the current domestic season with the Ranji Trophy, the BCCI changed the plans keeping the IPL auctions in mind. In fact, state associations and players have been fearing the worst since the rejig as it clearly sent a signal of the BCCI prioritising white-ball meets over Ranji Trophy. Cancelling the Ranji Trophy means several domestic players, umpires and match officials will suffer financial



World over, the BCCI is the only cricket board not to conduct red-ball cricket the previous season. While none of the other mainstream cricket nations has as many as 38 teams, given the BCCI's resources it is not an impossible task. Although playing the entire tournament under a bio-secure environment will definitely shoot up the expenses, it should never be an issue for the board which continues to make huge profits through the IPL.

Meanwhile, it is understood that the BCCI will decide on the IPL host country before the player auction takes place on February 12. At the moment, it is a toss-up between Sri Lanka and South Africa. Supposed the BCCI moves the event to South Africa, franchises believe it won't make much of a difference as they will be forced to use airports to juggle between cities. In Sri Lanka, they can avoid it as Colombo has three stadiums that can be put to
