Farmers' ire over Haldia dam delay echoes in polls

BARIPADA(KCN): Delay in upgradation of the century-old Haldia dam in Mayurbhani district may become another poll issue in the upcoming rural elections as farmers depending on the project feel deprived of irrigation facilities during rabi season triggering discontentment for years now. The lack of water supply during the winter months has also affected groundnut cultivation which fetches good returns for the growe. Sources said, the problem has been per-




sisting for 11 years now since the government undertook the dam upgradation project in 2011. To cater to the water crisis during the kharif season, Haldia dam supplies water through canal system to over 2,429 hectare (ha) land mostly in Baiganbadia, Dumurdiha, Marangtandi, Kautunmari, Haldia panchayats along with adjoining areas. Before upgradation of the project started, the dam catered to rabi irrigation and helped farmers grow the lucrative groundnut crop. But later, the dam work lagged and water was stooped for rabi season which did not go down well with farmers. They alleged that despite repeated appeals to the district administration and other higher-ups for speedy completion of the project, none paid heed.

"Discontinuation of farming activity during rabi season has affected us economically. Groundnut farming gave us good returns but we are now unable to pursue it due to water scarcity as the dam is not releasing water during this time for a decade now," said farmers Sudam Murmu and Kartikeswar Singh of Dumurdiha.

Kartikeswar said, he has 2.5 acre land under the irrigation project location but is unable to use it for farming activity during rabi cycle. Incidentally, Haldia Dam comes under Bangiriposi constituency from where Revenue and Disaster Management CONTINUED ON: P-7

The scrutiny of the nomination papers was done on January 22. During the exercise, 5,544 nominations filed for the 1,119 for Panchayat Samiti Member and 232 Zilla Parishad Members were rejected.

The papers were re-

jected due to various reasons including non submission of related documents and proper cast certificates, etc, officials mained valid. Out of the total valid papers, 1,56,753 are for the post of Ward Member, 32,860 for Sarpanch, 27,034 for PS Member and 3,767 for ZP Member.

Candidates can withdraw their nomination up to January 25 and the final list of candidates will be published on January 25.

The Panchayat elections will be held in five phases on February 16, 18, 20, 22 and 24 with strict adherence to Covid-19 protocols.

Counting of votes and declaration of results will be done at Block level on February 26, 27 and 28.

The voters will exercise their franchise from 7 am to 1 pm. Over 2.79 crore voters are eligible to exercise their franchise to Elections to be held for 91,913 Ward Member posts, 6,794 Sarpanches, 6,793 Panchayat Samiti members and 853 Zilla Parishad members.





Caxing of deemed Income -Part 4

(Contd from article published on 17th Jan. 2022)

23. Section 115BBE: Tax rates applicable to amount charged to tax by virtue of sections 68, 69, 69A,



As per Section 115BBE, income tax shall be calculated at 60% where the total income of assessee following includes income:

Income referred to in Section 68, Section 69, Section 69A, Section 69B, Section 69C or Section 69D and reflected in the return of income furnished under Section 139; or

b) Which is determined by the Assessing Officer and includes any income referred to in Section 68, Section 69, Section 69A, Section 69B, Section 69C or Section 69D, if such income is not covered under clause (a).

Such tax rate of 60% will be further increased by 25% surcharge, 4% Education Cess i.e., the final effective tax rate now comes out to be 78% (including cess). This rate is exorbitant and needs to bring down to 30 per cent which was rate applicable upto assessment year 2016-17 before demonetisation. Provided that 6% (that is 10 per cent of tax of 60 per cent) penalty under section 271AAC may be imposed if the addition is made by the A.O. sec. 132 and survey under sec. 133A. 25. **Taxation of Real Income:** In landmark case of Poona Electric Supply Co. Ltd vs Commissioner Of Income-Tax, [1965] 57 ITR 521(SC): 1965 SCR (3) 818, the Supreme Court held that Income-tax is a tax on the real income. It was observed: "As a business concern the real profit of the appellant had to be ascertained on the principles of commercial accountancy. As a licensee governed by the statute its "clear profit" was ascertained in terms of the statute and the schedule annexed thereto. The two profits are for different purposes-one for commercial and tax purposes and the other for statutory purposes in order to maintain a reasonable level of rates. The amounts for which deduction was claimed were a part of the excess amount paid to the assessee and reserved to be returned to the consumers. They did not form part of the assessee's real profits, and therefore, to arrive at the taxable income of the assessee from the business, under sec. 10(1) of the Income-tax Act, 1922 the said amounts had to be deducted from its total income. The income tax is a tax on the real income, that is the real profits arrived at on

provisions of the Income-tax Act. The real profit can be ascertained only by making the permissible deductions. There is a clear cut distinction between deductions made for ascertaining the profits and distributions made out of profits. It is a question of fact to be found on the relevant circumstances, having regard business principles. Another distinction that should be borne in mind is that between the real and the statutory profits, that is between the commercial profits and statutory profits. The latter are statutorily fixed for a specified purpose. The real profit of a businessman under s. 10(1) of the Income tax Act, 1922 cannot, obviously include the amounts returned by him by way of rebate to consumers, under statutory compulsion, from the statutory profits. 26. Deeming provision has to be interpreted strictly: It is settled principle of interpretation of tax statute that a deeming provision has to be interpreted strictly in terms of the language employed. It is also a cardinal principle of interpretation of taxing statute that a deeming fiction over a deeming fiction cannot be applied.

27. Notional Income or Deemed Income should not be taxed, Real income should only be taxed: The Government should find out the ways of curbing the trend of tax avoidance. It would do well if only real income is taxed under Income Tax Act. The Courts have also held in many cases that Real income should only be taxed. Therefore growing of taxing of deemed or notional income is not justified.

Would Netaji Subhash Chandra Bose have stopped the unfortunate partition of India?

Would the dream of Pakistan have ever turned into reality if Netaji Subhas Chandra Bose was alive? Would he have been able to convince Muhammad Ali Jinnah that the partition of India would benefit no one? This question, though

imaginary, is in itself of core significance.



It was during the lifetime of Netaji Subhash Chandra Bose that the All India Muslim League had passed the resolution for the formation of Pakistan. On March 23, 1940, Jinnah had

openly expressed his acutely sectarian thinking while addressing a gathering at Minto Park, just next to the Badshahi Mosque in Lahore. In his 2-hours long and aggressive speech at the conference, Jinnah relentlessly cursed Hindus. He said Hinduism and Islam are two incompatible religions. Both have very distinct views, traditions, histories, and heroes. Thus, the two cannot co-exist.

During his deliverance, Jinnah also ill spoke of Lala Lajpat Rai and DinbandhuChittaranjan Das. Undoubtedly, Netaji Subhash Chandra Bose must have read excerpts from Jinnah's hate speech. The Pakistani writer, Farooq Ahmed Dar, has written in his book 'Jinnah's Pakistan: Formation and Challenges' that after the Muslim League passed a resolution in favor of Pakistan, Netaji Subhash Chandra Bose, in his capacity as Congress President, urged Jinnah to relinquish his appalling demands for a separate

He also proposed to make Jinnah the first Prime Minister of post-independence. A similar proposal was also extended by senior Congress leader, C.Rajagopalachari to Jinnah. However, the adamant Jinnah did not respond positively

to either offer. The rest, as we know it, is

history. Subsequently, Netaji Subhash Chandra Bose left the country via Peshawar, to free India from the clutches of the British. Then, he lived in numerous countries across the globe.

Netaji formed the Azad Hind Fauj in Singapore. He must have lost track of Jinnah and the Muslim League's activities after leaving the country. As far as we've been told, it is said that he passed away in a plane crash in 1945. But, so far no proof of this has been found. For 70

Sikhs and Hindus were wealthy and prosperous in Rawalpindi. Their property was the prime target. Jinnah neither appealed to stop those riots nor went to any riotprone area. The riots had soon reached East Bengal. There too, thousands of Hindus were massacred. Later, Mahatma Gandhi intervened to put an end to the series of horrific riots.

Of course, Netaji Subhash Chandra Bose would have taken to the streets with public power against Jinnah's direct action. He was the mayor



years, the Congress government only told the story of the plane crash to the public. The Modi government made public the secret documents related to Netaji. Now new facts seem to be coming forth every day.

However, one can only speculate and imagine how he would have reacted to Jinnah's call for direct action on August 16, 1946, had he not died. In a way, it was the beginning of riots against Hindus. Then there was the Muslim League government in Bengal. He openly supported the rioters. Around 5000 innocent Hindus of Kolkata were killed in those riots. Among those who died, the majority were Oriya laborers. After that, the riots spread all-round like wildfire.

In May 1947, the goons of the Muslim League fiercely attacked the Hindus and Sikhs in Rawalpindi, openly looting their property and

of Kolkata in 1930 and was aware of every corner. He would have fought Jinnah and Muslim League goons on the streets as a militant leader. Netaji was not one to sit at home and watch the situation. But alas, he had already left the world before that. However, it is fair to say that if he lived, then the history of India as we know it would have been different today, and probably the country would not have been divided.

He also had a tremendous impact on Muslims. One of his most prized companions in the Azad Hind Army was Shahnawaz Khan. Apart from that, the number of Muslims in the Azad Hind Army was also very high. Netaji's personality was very miraculous and secular. Note that the consequences of the partition were mainly faced by Bengal and Punjab, as these ended up divided. Bengal was the planetary state of Netaji.

In both these states, Muslims and Sikhs also considered him their hero. He was and still is respected by the Namdhari Sikhs.

As Netaji Subhas Chandra Bose's birthday approaches, elderly Sikhs remember him with profound respect and gratitude. Netaji's relationship with the Namdhari Sikhs was established in the early 1940s. Netaji Subhash Chandra Bose was in contact with the Indian society settled in Thailand to liberate India from the slavery of British rule. One day Netaji Subhas Chandra Bose visited the residence of Sardar Pratap Singh, the head of the Namdhari Sikh fraternity of Thailand. When he arrived, members of all the fraternities were present there. Netaji Subhas Chandra Bose called upon all of them to help him with funding, money, etc. so that India could overthrow the British government.

After that, Namdhari Sikhs and the other Indians present there started giving their money, jewelry, and other items to Netaji Subhash Chandra Bose. He was closely watching all this but could not believe that his host did not offer anything until the end. Then he asked Sardar Pratap Singh, "So you do not want Mother India to be free from the chains of slavery?" In response, Sardar Pratap humbly said, "Netaji, I am waiting for all those present to give whatever they have to give from their side. After that, I will give you an equivalent amount to match theirs separately." Upon hearing this, he heartily embraced Sardar Pratap Singh. Even today, the family of Sardar Pratap Singh resides in the capital city, New Delhi.

However, it is disheartening that when the matter of the country's partition came forth, such an illustrious son of Mother India had left the world.

PM Mantra for DMs

District Magistrates (DM)s shared their experience with Prime Minister Narendra Modi, which has led to improvement of performance of their districts on a host of indicators. The Prime Minister sought direct feedback from them about the key steps taken by them which has resulted in success in the districts, and about the challenges faced by them in this endeavour.

He also asked them about how working under the aspirational districts programme has been



different from their work done earlier. The officers discussed how JanBhagidari has been a key factor behind this success. They spoke about how they kept people working in their team motivated on a daily basis, and made efforts to develop the feeling that they were not doing a job but were performing a service. They also spoke about increased inter-departmental coordination and benefits of data driven governance.

CEO, NITI Aayog gave an overview of the progress and implementation of the Aspirational District programme. He mentioned how the programme leveraged competitive and cooperative federalism, driven by a Team India spirit. The efforts have resulted in these districts performing remarkably better in every parameter, a fact which has been recognized independently by global experts as well. The best practises like smart classroom initiative from Banka, Bihar; Mission Aparajita to prevent child marriages in Koraput, Odisha etc. were replicated by other districts as well. Analysis of performance of districts vis-a-vis stability of tenure of key officials of the district was also presented.

Rural Development Secretary gave a presentation on a mission to uplift 142 selected districts, on the lines of the focussed work done in the aspirational districts. Centre and State will work together to uplift these identified districts to address the pockets of under-development. 15 sectors corresponding to 15 Ministries and Departments were identified. In the sectors, key performance indicators (KPIs) were identified.

The aim of the government is to ensure that the KPIs in the selected districts surpass the state average in the next one year and that they come at par with national average in two years. Each concerned Ministry/Department has identified its set of KPIs, on the basis of which, districts were selected. The initiative is aimed at achieving saturation of various schemes by various departments in the districts in mission mode, in convergence with all stakeholders. Secretaries of various Ministries and Departments presented an overview of an action plan about how their ministries will go about in achieving these targets.

Addressing the officials, the Prime Minister noted that when the aspirations of others become your aspirations, when fulfilling the dreams of others becomes the measure of your success, then that path of duty creates history. Today we are seeing this history being made in the aspirational districts of the country, he added.

The Prime Minister noted that various factors led to a situation where aspirational districts, in the past, started lagging behind. In order to facilitate holistic development, special handholding was done for the aspirational districts. The situation has changed now as today, Aspirational Districts are eliminating the barriers of the progress of the country. The Aspirational Districts are becoming an accelerator instead of an obstacle. The Prime Minister underlined the expansion and redesigning that has taken place due to the campaign in the Aspirational Districts. This has given a concrete form to the federal spirit and culture of the Constitution, the basis of which is the

team work of centre-state and local administration, the Prime Minister said.

The Prime Minister stressed that for development in aspirational districts, a direct and emotional connect between the administration and the public is very important. A sort of 'top to bottom' and 'bottom to top' flow of governance. Important aspect of this campaign is technology and innovation, he said. The Prime Minister also mentioned districts where excellent results have been obtained by the use of technology and innovation in the fields like malnutrition, clean drinking water and vaccination

The Prime Minister noted that convergence is a major reason for the country's success in the aspirational districts. All resources are the same, government machinery is the same, officials are the same but the results are different. Seeing the entire district as a unit enables the officer to feel the enormity of her efforts and give a sense of purpose of life and satisfaction of bringing meaningful change.

The Prime Minister noted that during the last

The Prime Minister noted that during the last 4 years, Jan-Dhan accounts have increased by 4-5 times in almost every aspirational district. Almost every family has got a toilet and electricity has reached every village. A new energy has been infused in people's lives, he said. The Prime Minister said due to a tough life the people of Aspirational Districts are more hard-working, courageous and capable of taking risks and this strength should be recognized.

The Prime Minister remarked that aspirational districts have proved due to the elimination of silos in implementation optimum utilisation of resources takes place. He emphasized the exponential benefits of this reform and said when silos end, 1+1 doesn't become 2, 1+1, becomes 11. We see this collective power in the Aspirational Districts today, the Prime Minister said. Elaborating on the approach of governance in the Aspirational Districts, the Prime Minister said that, firstly, people were consulted in identification of their problems. Second, the working style kept on being refined on the basis of experiences in the Aspirational Districts and measurable indicators, real time monitoring of progress, healthy competition among the districts and replication of good practices were encouraged. Thirdly, through reforms like stable tenures of the officers, creation of effective teams was encouraged. This helped in getting big results even with limited resources. The Prime Minister asked for developing detailed guidelines for field visits, inspections and night halts for proper implementation and monitoring.

The Prime Minister drew the attention of the officers towards the changed mindset of New India. He reiterated that today, during the Azadi ka Amrit Kaal, the country's goal is to achieve 100% saturation of services and facilities. That is, we have a long way to go compared to the milestones we have achieved so far and have to work on a much bigger scale. He stressed time-bound targets for taking roads to all the villages of the districts, ayushman cards, bank account to every person, Ujjwala gas connection, insurance, pension housing for everyone.

He called for a two year vision for every district. He suggested that every district can identify 10 tasks to be completed in the next 3 months to improve ease of living for common people. Similarly, 5 tasks may be associated with the Azadi Ka Amrit Mahotsav to achieve historical success in this historical epoch.

The Prime Minister said the country is witnessing a silent revolution in the form of Digital India. No district should be left behind in this. He stressed the importance for digital infrastructure reaching every village and becoming a means of door-step delivery of services and facilities. He asked NITI Aayog to devise a mode of regular interaction between the district DMs. Central Ministries were asked to document the challenges of these districts.

The Prime Minister said various ministries and departments of the government have prepared a list of 142 districts which are not so much lagging in development but are weak on one or two parameters. The Prime Minister emphasized the need to work with the same collective approach as is being done in the Aspirational Districts. "This is a new challenge for all the governments- the government of India, the state government, the district administration, and the government machinery. Now we have to complete this challenge together", Mr.Modi said

The Prime Minister urged the Civil Servants to remember their first day in their Services and recall the passion and urge to serve the country. The Prime Minister asked them to move forward with the same spirit.

Bhubaneswar: Political observers see a new trend that has emerged this time during the ongoing three-tier panchayat elections in Odisha. Instead of multi-corner fights in elections, the parties, leaders and village heads are coming together to field 'consensus' candidates for some reason or the other. Though, the reasons behind the groups advocating for consensus candidates, appeared justified, it created a new trend in the election process. Two such incidents have come to the fore from Bolangir and Koraput districts. Community development is cited as the reason behind the consensus candidates, although it denies many aspirants the right to participate.

The news received from Bileisarada gram panchayat in Bolangir district, was in fact too disturbing when one Susant Chhatria claimed that the village heads hold an "auction" for the Sarpanch post. He won the bidding for Rs 44,000. The village heads justified the auction saying that the money to be received from auction would be spent for the development of the village temple.

When the report reached the State Election Commission (SEC), Odisha, its chief AP Padhi was prompt to issue a directive to the Bolangir district Collector to ensure that no willing candidate is obstructed from filing the nomination. Padhi's orders were carried out and four candidates have filed papers for the so called "auctioned" sarpanch posts.

Now, the question arises whether it is legal to auction a sarpanch post, which is created under the provision of the Constitution? Do the village heads have rights to allow for raising funds for the development of any institutions, maybe a temple in the village? The village heads and the winner of the bidding have also dared to openly speak on camera about their actions and no action has so far been taken

against the persons involved in attempting to auction the sarpanch post. The District Administration has not taken any action so far. Do the village heads have the authority to go for such a brazen mode of auction of the post? If the District Administration remains silent, it will give a wrong message to the society. The persons involved in the auction may be issued at least a warning for attempting to

dilute the democratic practice. Tomorrow, some goons of an area may force the people not to file nominations and field their candidates in elections and win the polls. They may also cite some reason to justify their action. It must be kept in mind that there is every chance of misuse of the election process if the persons involved in the auction are allowed to go scot free. In another instance, Odisha's three major political parties, the

ruling BJD, opposition BJP and Congress decided to field consensus candidates for the panchayat elections in Kotia cluster of villages. The intention of the parties was clear that this strategy would prevent neighbouring Andhra Pradesh from meddling in the election process in the area. The southern state has already held its panchayat polls last year in the Kotia area on which it claimed to have ownership. Both the states are at loggerheads in a border issue over the Kotia region. Of

the 28 villages under Kotia GP, 21 are disputed. Andhra Pradesh claims that the 21 villages were under their jurisdiction while Odisha also makes a similar claim and tries its best to protect its land.

The border dispute over the Kotia area had been sub-judice in the Supreme Court since 1968. In 2006, the apex court held that interstate boundaries did not fall within its juris-

diction and only the Parliament could resolve them, as it imposed a permanent injunction on the disputed area. In August last year, the Odisha government deployed police and also erected barricades in Kotia after the Andhra Pradesh administration attempted to launch several schemes in the area. There have been several flare ups last year over the ownership of 21 villages under Kotia gram panchayat.

The intention of the parties is good, but the manner in which it is adopted appears contrary to the 'free and fair' electoral practice. If the consensus candidates are fielded, one candidate will get a chance for one post. Then what about other aspirants? It may also be a fact that an aspirant may be popular and not in the good book of three-four local leaders. In such cases, the popular candidate, having the spirit to work for the people, will be defeated. There is also no such provision in the

law where the parties will forcefully fix consensus candidates in elections.

It is a known fact that in cases, a political party fields a candidate and others support it. But, the parties have no such freedom under the provision of the Constitution to deny the rights to others to contest the elections. The consensus candidate may win the polls as he/she is supported by major parties. But, others should not be denied the opportunity given by the Constitution of India.

It is, in fact, a positive development that the political parties have closed their ranks for a cause like the Kotia issue for the first time. It is also good to jointly oppose the designs of Andhra Pradesh which has set eyes on the areas of Odisha. But, the idea of a consensus candidate may not fit the decades old democratic system as well as the election process prevalent in the country and also in the state. Therefore, the parties, which run the government and those who represent people in the Assembly, should do some 'brainstorming' and evolve a better strategy to counter Andhra Pradesh's designs. Apart from taking the shelter of the law as it has been done over five decades ago, the leaders should also find alternative avenues to tackle the land grabbing menace. The Chief Ministers of both the states have so far sat for discussion and mechanisms are being evolved through the dialogues between the respective Chief Secretaries. All parties should not utilize this platform to teach a lesson to Andhra Pradesh and protect the Kotia area from it. We must do something to resolve the issue while remaining within the ambit of the Constitutional provisions. The idea of filing consensus candidates to resolve the contentious issue may not solve the nagging problem.

"Who conducts these surveys. I have yet to come across any surveyor of any such opinion polls. Moreover, the sample size also matters a lot. If a small chunk of the population is surveyed, how it could convey the sentiment of the majority. Surmust veys banned," said a senior SP leader.

IT firms looking beyond metros to hunt talents

At the middle level, Chandigarh leads with 20.83%, and at the senior level, Coimbatore leads with 37.86% of the IT jobs among tier-II cities. There is a good concentration of software companies in Tier-II cities due to talent availability and also cheaper real estate. The report further adds that Tier- II cities in India are expanding rapidly as they have started developing as sector hubs for IT, services and manufacturing.

Mindtree MD and CEO Debashis Chatterjee says, "As part of our 'Work of the Future' talent strategy, we are also tapping into tier-II&-III cities and setting up offices in Coimbatore and Warangal. The idea is to take work to talent instead of bringing talent to work. These cities have a vibrant educational ecosystem and are great reservoirs of talent. The response from talent in these cities looking to associate with us without having to relocate has been overwhelming."

India's economy has some bright spots, a number of very dark stains: Ex-RBI Governor Raghuram Rajan

NEW DELHI: The Indian economy has "some bright spots and a number of very dark stains" and the government should target its spending "carefully" so that there are no huge deficits, noted economist and former RBI Governor Raghuram Rajan said on Sunday. Known for his frank views, Rajan also said the government needs to do more to prevent a K-shaped recovery of the economy hit by the coronavirus pandemic. Generally, a K-shaped recovery will reflect a situation where technology and large capital firms recover at a far faster rate than small businesses and industries that have been significantly impacted by the pandemic. "My greater worry about the economy is the scarring to the middle class, the small and medium sector, and our children's minds, all of which will come into play after an initial rebound due to pent up demand. One symptom of all this is weak consumption growth, especially for mass consumption goods," Rajan told PTI in an e-mail interview.

Rajan, currently a Professor at the University of Chicago Booth School of Business, noted that as always, the economy has some bright spots and a number of very dark stains. EDITORIAL: A Season of possibilities for India's economy

"The bright spots are the health of large firms, the roaring business the IT and IT-enabled sectors are doing, including the emergence of unicorns in a number of areas, and the strength of some parts of the financial sector," he said.

On the other hand, "dark stains" are the extent of unemployment and low buying power, especially amongst the lower middle-class, the financial stress small and medium-sized firms are experiencing, "including the very tepid credit growth, and the tragic state of our schooling".

Rajan opined that Omicron is a setback, both medically and in terms of economic activity but cautioned the government on the possibility of a K-shaped economic recovery.

"We need to do more to prevent a K shaped recovery, as well as a possible lowering of our medium term growth potential," he said. The country's GDP is expected to grow over 9 per cent in the current financial year that ends on March 31. The economy, which was significantly hit by the pandemic, had contracted 7.3 per cent in the last fiscal.

While the government must spend where necessary at this time to alleviate the pain in the most troubled areas of the economy, he said, "We must target the spending carefully so that we do not run huge deficits." OPINION: India's export performance may save its economy Finance Minister Nirmala Sitharaman is scheduled to present the Union Budget 2022-23 in Parliament on February 1. Regarding the rising inflationary trends, Rajan said inflation is a concern in every country, and it would be hard for India to be an exception.

According to him, announcing a credible target for the country's consolidated debt over the next five years coupled with the setting up of an independent fiscal council to opine on the quality of the budget would be very useful steps. "If these moves are seen as credible, the debt markets may be willing to accept a higher temporary deficit," he said, adding that to convince markets that "we will be responsible, we should strengthen the institutional support to future fiscal consolidation." Further, Rajan said that one way to expand budgetary resources is through asset sales, including parts of government enterprises and surplus government land. "We need to be strategic about what we can sell, and how we can improve the economy's performance through those sales...Once we decide to sell, though, we should move fast, something we have not done so far," he opined. Regarding the upcoming budget, Rajan said that he would be happy to see more tariff cuts and far fewer tariff increases, and far fewer sops or subsidies to specific industries. "Particularly, (I) would welcome an independent assessment of the Production Linked Incentive

India out of women's Asian Cup; match against Chinese Taipei called off after 12 players test COVID positive

NAVI MUMBAI: India were forced out of the AFC Women's Asian Cup football tournament on Sunday after a dozen COVID-19 cases among their players led to the cancellation of a group match against Chinese Taipei minutes before kickoff here.

Apart from the COVID cases, two players were also laid low by injuries which made it impossible for India to field a team given that two of their footballers were already out of contention after being infected by the virus a few days ago.

The Asian Football Confederation (AFC) said given the situation, Article 4.1 of the tournament rules comes into effect, which makes it clear that if a team fails to assemble for a match, it would be "considered to have withdrawn from the relevant Competition."

The RT-PCR tests on the squad were conducted on January 21 and the results came this morning.

The All India Football Federation (AIFF) President Praful Patel also issued a statement expressing sadness at the turn of events but surprisingly did not clarify the team's tournament status.

"We are as disappointed as probably the entire nation would be right now with this unwarranted situation," he said.

"However, the players' health and well-being are of paramount importance to us, and it cannot be compromised under any circumstances. I wish all the infected players and team officials a swift and full recovery. They will be well supported by the AIFF and AFC."

India failed to name the required minimum of 13 players for the Group A match against Chinese Taipei before the game and there was no sign of the team at the ground even as the ri-

vals warmed up.

India were next scheduled to play China in

their final group match on Wednesday but that is unlikely to go ahead now given that the team does not have enough players to field an XI. The knockouts start from January 30, making it nearly impossible for the tournament organisers to manuever the schedule.

"This happened to us despite the best measures put in place, and it is sheer bad luck that it happened to us. Let there be no fingers pointed at any. We need to understand this is a pandemic situation, and no bubble is fool proof around the world," Patel said in his statement which focussed on feelings of the players but offered no insights on how the situation arose. It is still not clear how the spread happened. As per Article 4.1 of the 'Special Rules Applicable to AFC Competitions during the COVID-19 pandemic', "If a Participating Team/Participating Club has less than thirteen (13) Participating Players (including one [1] goalkeeper) available for a match for any reason (whether or not relating to COVID-19), the relevant Participating Team/Participating Club shall not be able to participate in the Match.

"Such Participating Team/Participating Club shall be held responsible for the Match not taking place and shall be considered to have withdrawn from the relevant Competition. The relevant Participating Team/Participating Club ners, runners-up and the two best third-placed teams qualifying for the quarter-finals.

"The India-Chinese Taipei match matter will now be referred to the relevant AFC Committee in accordance with the applicable regulations," it said.

The Article 4.1 which determines the result of a match that cannot be played, further states, "In exceptional circumstances and provided that any rescheduling will not affect the Match

Schedule determined by the AFC General Secretariat, the AFC Competitions Committee (or any sub-committee carrying out duties on its behalf) may grant an exception to the foregoing and allow the relevant Match to be rescheduled."

India were held to a goalless draw by Iran in their tournament-opener a couple of days ago and there were two COVID cases in the team before that game.

It remains to be seen how Iran is impacted by the outbreak in the Indian camp, having been in close contact with the side.

The AFC said its medical team will continue to work closely with the Local Organising Committee and the AIFF to prioritise the health and wellbeing of the teams, officials and stakeholders.

"Appropriate medical care is being provided to the infected players."

COVID-19 had breached the Indian team's bio-security bubble on Wednesday ahead of its tournament opener with two players testing positive for the virus, forcing the organisers to shift them to a medical facility for isolation.

All the semifinalists of the ongoing tournament will directly qualify for the 2023 FIFA World Cup in Australia and New Zealand.

Two more teams from the remaining four quarterfinalists will also get direct berths to the World Cup if Australia make it to the semifinals of this tournament, which is highly probable.

That means even the teams that lose in the quarterfinals can directly qualify for the World Cup if they win the play-off matches of the AFC Asian Cup on February 2 and 4.

The two losing quarterfinalists will feature in the Intercontinental play-offs.
