As the Covid-19 situation is improving in the State, there are possibilities of holding the board examinations for Class X and XII students, he If any special situation arises in the country as well as the State due to Covid-19, the State Government will take a final decision on this, said

the Minister. As per prevailing situation is concerned, there is every possibility for the conduct of the examinations, Mr.Dash added.

The summative examination-1 for the Class X students has already been completed in the State.

Mr.Dash further informed that the Department will always try to ensure that the examinations are held and the results are published on time.

The State Government had earlier reduced the syllabus as part of the reforms which were initiated following the cancellation of the Matriculation and other examinations last year due to Covid-19 situation.

At present, the State is showing a declining trend as far as the daily reporting of Covid-19 cases are concerned. Odisha reported 7,291 fresh COVID-19 cases on Monday, pushing the tally to 12,11,951, while the death toll mounted to 8,525 with five more fatalities.

Public Health Director Niranjan Mishra on Monday said Omicron variant will soon be in a community transmission stage in Odisha as the transmission rate of the variant is high.

Omicron cases have risen significantly in the state. Previous analysis shows that 60 per cent of the Omicron cases in the State were local contacts, he said.

At any moment, the cases might explode, as the variant is highly transmissible, Dr.Mishra added.

US draws down Ukraine embassy presence as war fears mount

WASHINGTON(KCN): The State Department on Sunday ordered the families of all American personnel at the U.S. Embassy in Ukraine to leave the country amid heightened fears of a Russian invasion.

The department told the dependents of staffers at the U.S. Embassy in Kyiv that they must leave the country. It also said that non-essential embassy staff could leave Ukraine at govern-

ment expense. The move came amid rising tensions about Russia's military buildup on the Ukraine border that were not eased during talks Friday between Secretary of State Antony Blinken and Russian Foreign Minister Sergey Lavrov in Geneva.

State Department officials stressed the Kyiv embassy will remain open and that the an-

nouncement does not constitute an evacuation. The move had been under consideration for some time and does not reflect an easing of U.S. support for Ukraine, the officials said.



The actor shared that it was "really cool" that they all decided on coordinating their outfits since they "have such distinct personalities."



NOTA and Indian Electoral Reform- Are We a Matured Democracy?

Elections are at the centre of the democratic process. People in a democracy participate in public affairs



and express their through elections. In a democracy, power is transferred in a peaceful orderly manner through elections, and government's

authority is given legitimacy. "Elections, in this way, not only sustain but also enliven democracy. As a result, free and fair elections are a requirement of democracy. India is both the world's largest and one of the world's most populated democracies. Apart from that, in compared to most developed democracies throughout the world, illiteracy, poverty, and other issues persist in India, as they do in most developing countries.

Periodic elections as a mechanism of peaceful power transition have been a regular and successful component of India's democracy for the past seventy years, according to India's track record. Not only that, but Indians have consistently viewed elections as the most effective nonviolent and peaceful means of protesting government omissions and actions. Elections have thus become an important part of India's democracy, as they have been in many other successful liberal democracies across the world.

However, over time, several anomalies in the electoral system's operation have become apparent. The necessity to address such troubling circumstances has sparked a debate in the country over election changes. The Election Commission, which is entrusted with the actual power of superintendence, direction, and control of elections in the country under the Constitution, has made tangible proposals/suggestions based on objective issues experienced during the conduct of elections from time to time. Politicians have expressed their desire for reform through the platforms of parties and Parliament, including the different committees established for that reason. Governments have also taken corrective action in response to suggestions from various committees.

Issues in Indian Elections

The substantial criminal past of the candidates is one of the key irregularities impacting a fair election. The sudden increase in the number of legislators facing criminal charges will have a significant influence on voters' faith in India's democracy and its working mechanisms. This might have terrible consequences for the people's democratic spirit and their faith in the current system. According to a poll conducted by the Association for Democratic Reforms after the 2019 Lok Sabha elections, approximately 43 percent of newly elected members of the lower house have criminal cases pending against them. In the 2004 national election, 24 percent of candidates had ongoing criminal convictions, which increased to 33 percent in 2008.

The criminalization of politics in India might have a variety of factors. In most situations in India, there is a link between criminals and politicians. This link could be because to the criminals' physical power and influence over the people in their districts, which can be a boon to politicians when they go election campaigning to win, while the criminals obtain exemption from prosecution and

backing from the administration to

carry out their unlawful activities. This nexus could prove to be a ticket for crooks to run for office. The criminalization of politics is gaining traction as a result of the public's lack of understanding of how to choose their representatives and how to vote.

NOTA- certainly not a panacea but a powerful tool

Since 2009, Indian voters have had the option of voting "None of the Above" (or NOTA) in most elections. The The problem has been with implementation of the judgment. The Election Commission of India decided, in its wisdom, to implement the letter of



potential is that political parties and their leaders have been actively campaigning against NOTA. They have been asking people not to opt for NOTA because these votes have no impact on who gets elected. This, when the votes polled by NOTA have continued to increase gradually. Several constituencies have seen NOTA getting more votes than the winning margin, the difference between the votes polled by the winner and the candidate who came second. There have also been some, very few, cases where NOTA came at number 2, getting more votes than any of the candidates except



Maharastra and Haryana's Case

Maharashtra experienced the most substantial change as a result of NOTA. The State Election Commission (SEC) approved the clause and declared that if NOTA won any election in Maharashtra, a necessary re-poll would be held. This was the first major modification in the electoral system since NOTA was founded. The State Election Commission of Maharashtra issued a notification on November 6, 2018 that treats NOTA as a fictional candidate and states categorically that clause 7 of the ECI order dated declaring that if NOTA receives the most votes, the candidate receiving the second most votes after NOTA shall be declared the winner violates the accepted principle (the candidate with the majority of votes winning the election) by declaring the candidate as elect. The order also considers the PUCL case, arguing that

has not led to increased voter participation,

the adoption of NOTA:

- has not compelled political parties to field good candidates,
- does not reflect negative votes in election results and
- does not honor and respect the majority will/ opinion of the people expressed through NOTA

Although the Supreme Court intended and expected that NOTA would increase voter participation in elections, this does not appear to have occurred, if the election commission, whether state or federal, gives teeth to NOTA, as in Maharashtra and Haryana, it may address the concerns of many, including Major General (Retd) Anil Verma. Fear of 'rejection' by the power of NOTA, by 'We the people of India,' the process of

purifying the political system by driving parties to put up stronger candidates appears to have started already. The key benefit of including NOTA is that it upholds and recognises citizens' right to abstain from voting while retaining anonymity during that time. The essential spirit of democracy is the public' freedom to choose their representatives on a regular basis. Clearly, the goals of democracy can only be achieved if a majority of citizens use this privilege. At the same time, it must be ensured that citizens are not forced to pick between the best and the worst (which, regrettably, is often the case). This is precisely what NOTA aspire to. This is hardly surprising, because citizens would rather not vote than express their dissatisfaction, which will have no impact on the election results. Even if more than half of the voters chose negative voting, the election result will not be influenced or a particular candidate will not win. It is for this reason that NOTA has been heavily criticised, and it is for this reason that voters have been unable to exercise their right to record a negative vote. The inclusion of NOTA in electronic voting machines is undoubtedly a significant step forward in implementing electoral reforms, bringing it closer to the goal of democracy. However, its full impact and potential can only be realised if it is allowed to be used in its full and unrestricted sense, i.e. not only the right to register a negative vote but also the right to reject it.

Electronic Media and NOTA

It's really surprising to see that very few electronic media have taken up the issue of NOTA in recent years. The same media house which are devoting much of their prime time in highlighting the so called achievements of the government, have not taken up reflecting the provisions of NOTA in prime time. Possibly they have taken it for granted that NOTA have no teeth and it will not enforce clean elections. This very attitude needs to be changed. While reflecting upon the criminalization of politics on the one hand, it is equally their responsibility to make aware the voters and electorate that they have the much needed tool at their disposal and they can use it to provide an opportunity of self introspection to political parties.

Conclusion

The subject of NOTA is as divisive as any other national issue. It has numerous benefits and drawbacks. Few individuals see it as a good thing, while others see it as a bad one. In elections, a skewed free option is never a bad thing. When the option of NOTA was not available, people squandered their right to vote by remaining in their homes; however, with NOTA, people realised their rights and opted to vote rather than sit at home. It is undoubtedly a great systemic development in society, but the main negative is that its enforcement is not as robust as it should be, necessitating suggested modifications. Simultaneously, this needs to be debated, discussed and deliberated upon in as many forums as possible and every inch of social and electronic media must highlight the issue. May be NOTA is not very effective to cleanse the political democracy but nonetheless, is has emerged as the one of the most powerful tool to empower people and make the political parties more responsible. May be, there might have hundred of such options more effective than NOTA, but somewhere we need to have nationwide discussion on the same and may be, a fine morning, we will get some robust system for the same.

Supreme Court recommended the adoption of NOTA in the context of direct elections to the Lok Sabha and respective state assemblies in PUCL vs. Union of India Judgement 2013. A citizen can choose not to vote for any of the candidates running for office by expressing a preference for none of the above. The vote has no electoral value: even if a majority of ballots are cast, the candidate who receives the most votes is deemed the winner. The NOTA option was first used in four states (Chhattisgarh, Mizoram, Rajasthan, and Madhya Pradesh) during the 2013 assembly elections. In the current dispensation, NOTA is seen as a citizen's right to reject affiliation. The 2013 verdict recognised the voter's two most fundamental rights in the election system:

- Right to Reject
- Right to Secrecy

As a result, India has become the 14th country to use negative voting. However, the electorate in India did not have a true 'right to reject,' meaning that the candidate with the most votes would win the election regardless of the number of NOTA votes cast. Votes cast on NOTA, in particular, have no bearing on the election's legality or outcome. Even if NOTA gained a majority of votes, the election would be decided by the candidate who received the most votes in each constituency.

This is what democracy should really mean: the ability of the general population to compel political parties to change their positions. However, it will only be effective if the legislation allows for re-election in any seat where the NOTA has received a majority of votes. Unfortunately, such a rule does not exist in India at the moment, so the candidates who receive the second greatest number of votes will be considered elected under Rule 64 of the Representation of Peoples Act. Now, the question arises: what is the legality of an election if the majority of votes are cast against a candidate, and what is the purpose of include NOTA on the ballot paper?

The Supreme Court made very significant observations in the judgment, one of which said, "When the political parties realize that a large number of people are expressing their disapproval with the candidates being put up by them, gradually there will be a systemic change and the political parties will be

"It's good that Chief Minister Yogi Adityanath is not contesting from here. I had suggested it earlier and advised that it will be better that he contest from any seat of Gorakhpur. I speak after asking Ram Lalla. I spoke with Ram Lalla's inspiration," said Das, who is the chief priest of the makeshift Ram Lalla temple, which is being replaced by a grand temple.

The 84-year-old priest said that the seers here are divided in their opinion and those whose houses and shops were demolished are against him. "All are saying that it's his work. This opposition is there. I said he better go there (Gorakhpur). He would have won from here but could have faced problems," the priest said. There was a strong buzz in political circles that Adityanath would enter the fray from Ayodhya but the BJP leadership decided to field him from the Gorakhpur (Urban) Assembly segment. About the election mood in Ayodhya, Das said it is not yet clear as all parties have not declared their candidates.

The priest, however, said the ruling BJP will not let go the Ram temple issue and it will remain on their agenda. "Earlier, there was Ram Lalla andolan, then came the court's order and the construction of the Ram temple started. This Ram temple issue will never go away. They will say firing was opened here (on 'kar sewaks'), application was moved in the court to prevent the construction - but the temple construction

is on. They will certainly take the name (of Ram temple). This will not go away," Das said. Das hoped to see the completed Ram temple in his lifetime. "Let's see how many days it takes for the construction to complete. A majority of those who were with me have gone (passed

away)," Das said, adding that he will be serving



here till his last.

Das said he joined as the priest of the makeshift Ram Lalla temple in 1992, the year the Babri mosque was demolished.

When asked if he was present when the mosque was demolished, Das said, "I was there. It happened before me. I was witness to it. Out of three domes, north and south domes were demolished by 'kar sewaks'. I took Ram Lalla with its throne in my hand. The demolition was over by 5 pm. Later, 'kar sewaks' pitched a tent and levelled the place and by 7 pm, I kept Ram Lalla there." When asked whether local politicians have started coming to him to take his blessings, Das said, "Till now, wife of Samajwadi Party leader Pawan Pandey has come to me. He is a strong candidate from the SP."

Pawan Pandey had won the 2012 Assembly elections from Ayodhya and was made a minister in the previous Akhilesh Yadav government. In 2017, BJP's Ved Prakash Gupta won the Ayodhya seat. All five Assembly seats in the district--Ayodhya, Bikapur, Rudauli, Gosaiganj and Milkipur—are held by the BJP now.

Ayodhya will go to the polls in the fifth phase on February 27.

AIEBA SOS for coal

Bhubaneswar: Struggling to cope with the acute coal shortage in Odisha that continues to plague local industries, the Association of Industrial Entrepreneurs of Bhubaneswar (AIEBA) has sought personal intervention of Chief Minister Naveen Patnaik in the resumption of adequate coal supplies to the Statebased industries.



The ongoing crisis has deeply affected the manufacturing sector and threatens their survival. A respite from the crisis would help ward off any shutdown of the State's industries and enable sustainable industry operations.

In a letter to the Chief Minister, Ali Kishore Patnaik, President of AIEBA, acknowledged the State Government's progressive policy reforms and support towards industries, also sought to draw attention towards the continued coal shortage facing them.

Owing to the curtailment of the coal supplies and rakes, the viability of industries that form a significant part of the State's business land-scape driving employment and revenue generation is now seriously threatened, he said. Mr.Patnaik further highlighted that Captive Power Plants (CPPs) based industries in the State were facing alarmingly depleted coal stocks of only 2-3 days as compared to the prescribed levels of 15 days.

On the other hand, the situation of the power sector has drastically improved to 9-10 days of stocks. The CPPs, which are heavily dependent on coal as their primary raw material, are unable to run smoothly due to the current situation, he mentioned.

Surprisingly, despite the ongoing crisis, the Coal India Limited/Mahanadi Coalfields Limited (MCL) has once again issued directives this week to divert coal supplies from the non-

power sector to the power sector.

The association said the decision to divert coal supplies from major coal bearing areas in Odisha will further take a toll on the hampered manufacturing sector and deprive the already ailing non-power sector from getting coal, heavily impeding the industrial operations.

The letter further brings to attention that since August 2021, the CPPs have been receiving only 40-50% of the required coal supplies needed for them to function optimally, creating a backlog of over 1500 coal rakes as most of the available coal rakes are being diverted away from CPPs.

This struggle to receive uninterrupted coal supplies for continued operations has brought the industry to a veritable standstill, leaving them with limited time to devise mitigation plans for sustained operations.

Due to the aforesaid reasons, the operational power plants are forced to operate at drastically reduced power generation levels, creating a huge risk of closure, he warned.

The AIEBA also emphasized on the crucial role the manufacturing sector has played in the socio-economic development of Odisha. However, the current situation has brought the CPPs to a grinding halt and resulted in the increased prices of finished products that is affecting the end consumer.

He reiterated that the state's booming manufacturing sector is at risk if the current situation remains unaddressed. The intermittent coal supplies to CPP-based industries in Odisha made the very survival of local industries a challenge. This could cause cascading effects, in terms of loss of employment of over one million people, closure of ancillary industries and MSMEs, loss of revenue & state exchequer accounting to over Rs. 15,000 crore, forex loss due to loss of exports and hurt the sentiments of global investors.

Seeking government support in this matter of critical importance, the AIEBA President requested the Chief Minister's intervention in resolving the crisis, to resume the coal and rake supplies from the MCL towards meeting 100% coal requirements for CPP-based industries in Odisha.

He requested that the demands of the local industries be prioritized and met through the State's own coal production before being supplied to other areas. This timely action could spur growth opportunities in the state and create millions of jobs while bringing in revenue.

perts sent by the secret service wing of Netaji Subhas Chandra Bose's Indian National Army landed by submarine at Konark in 1944.

Capital City based Historian Anil Dhir has revealed in his upcoming book -"Netaji and Odisha: The Untold Stories".

In his book, Mr.Dhir wrote that in March 1944, a fully armed Japanese submarine left its secure base in Penang, carrying four INA Secret Service officers Odisha.

Led by Pabitra Mohan Roy, there were three radio experts, Mohinder Singh, Tuhin Mukherjee and Amrik Singh Gill in the team.

Before they embarked on the journey, Netaji had messaged them directly saying: "Though few in number, your mission will strike a deadly blow at the entire British secret service. The radio base must be set up in Calcutta at all

cost". The submarine reached its destination on March 14 and they landed with the equipment at daybreak. "They buried their equipment in the sand near the Konark temple. Later, they dispersed with the parts, camouflaged as Gramophones and made their separate ways to Puri, Bhubaneswar and Cuttack railway stations," Mr.Dhir said in his book.

However, one of them was caught at Puri, while the remaining members separately boarded the Madras Mail on different dates and reached Calcutta. They met at the Metro Cinema on March 19, he said. After the transmitter was set up in the house of a dental surgeon Dr. Dutt at Behala, the team started sending coded messages to INA Headquarters about British troop movements, the landing of bombers at Dum Dum airbase and naval move-

ments. The INA's radio service functioned actively for six months before the British intelligence closed in on it and ultimately arrested all involved.

The military trial of the INA Secret Service was famously known as the "Calcutta Conspiracy Case". The military trial for "waging war against the King Emperor" began in May 1945 and ended in a month.

The "King's Witnesses" included 12 traitors, who were trained at the INA Centre in Penang, Dhir said, adding that the three were condemned to death by hanging.

It was only with the intervention of Mahatma Gandhi that they escaped the gallows. Writing to Lord Wavell, on September 14, 1945, Gandhi wrote, "It will be a political error of the first magnitude if this sentence of death is carried into effect."

According Mr.Dhir, ten such groups of INA Secret Service men had landed on the Odisha coast. Even Janaki Nath Bhawan at Puri was used by the INA Secret Service as a safe house, according to Mr.Dhir.



Cuttack(KCN): Odisha Open Super 100, the first ever International badminton tournament is all set to be kicked off at Jawaharlal Nehru Indoor Stadium, Cuttack on Tuesday.

About three hundred fifty players from as many as seventeen countries are participating in this tournament. While the preparations of this mega tournament is almost ready, players



had their warm up practice sessions at Cuttack on Monday.

The tournament, a BWF event, is being organised with the joint efforts of state sports and youth service department, Badminton Association of India and Odisha State Badminton Association.

The tournament will be played in four courts at JNIS Cuttack. The venue is absolutely made ready to host the first ever international badminton event at Odisha. Since the tournament is played as per the covid guidelines and therefore no spectators will be allowed to enter into the stadium. Covid tests of all players, technical officials, volunteers have been conducted, after their arrival at Bhubaneswar and only those found negative will be allowed to enter into stadium premises.

Significantly, while Odisha has earned a name in international circuit for organising international sports event successfully, mainly in the fields of hockey and athletics etc., the Odisha Open Super 100 is all set to add another feather to its cap. While all out efforts are made by the organisers to make the tournament a grand success, State sports minister Tushar Kanti Behera on Monday expressed his good wishes for the success of the tournament. "It is a mat-

ter of pride for our state to host such a prestigious sports event." Sports minister Tushar of Badminton World Federation at Odisha soil Kanti Behera said. "I hope each members of the organising team will exhibit their same zeal and enthusiasm, which they had shown during hosting of other international sports events in the state, for making this tournament a grand success," Behera added. According to the officials, the matches would be played in five

categories, i.e. men's singles, women's single, men's doubles, women's doubles and mixed doubles. "About three hundred fifty players from as many as seventeen countries of the Globe are competing in five events in this tourna-

ment, in which there has been seventy five thousand US dollar cash prize will be given to the winners," said Girish Nattu, Deputy Chief Referee of this tournament. Air India likely to be handed over to Tata group by weekend

NEW DELHI: Air India is likely to be handed over to the Tata group by the end of this week, senior government officials said on Monday. After a competitive bidding process, the government had on October 8 last year sold Air India to Talace Private Limited -- a subsidiary of the Tata group's holding company -- for Rs 18,000 crore. Following that, on October 11, a Letter of Intent (LoI) was issued to the Tata group confirming the

government's willingness to sell its 100 percent stake in the airline. On October 25, the Centre signed the share purchase agreement (SPA) for this deal. Officials said on Monday that the remaining formalities regarding this deal are expected to be completed in the next few days and the airline will be handed over to the Tata group by the end of this week. As a part of the deal, the Tata group will also be handed over Air In-

US draws down Ukraine embassy presence as war fears mount

against Ukraine. However, the Russian Foreign Ministry has accused NATO countries of escalating tensions around Ukraine with disinformation.

The State Department added: "The security conditions, particularly along Ukraine's borders, in Russia-occupied Crimea, and in Russia-controlled eastern Ukraine, are unpredictable and can deteriorate with little notice. Demonstrations, which have turned violent at times, regularly occur throughout Ukraine, including in Kyiv."

The department's travel advisory, which had warned against travelling to Ukraine because of COVID-19 as well as the tensions over Russia, was changed Sunday to carry a stronger

"Do not travel to Ukraine due to the increased threats of Russian military action and COVID-19. Exercise increased caution in Ukraine due to crime and civil unrest. Some areas have increased risk," the department advised.

The travel advisory for Russia was also changed: "Do not travel to Russia due to ongoing tension along the border with Ukraine, the potential for harassment against U.S. citizens, the embassy's limited ability to assist U.S. citizens in Russia, COVID-19 and related entry restrictions, terrorism, harassment by Russian government security officials, and the arbitrary enforcement of local law."

The State Department would not say how many Americans it believes are currently in Ukraine. U.S. citizens are not required to register with embassies when they arrive or plan to stay abroad for extended periods.

Asian Currency Union settlement of USD 515 million which the local analysts said stopped the bleeding of reserves.

New Delhi also announced a billion-dollar assistance package in addition to other balance of payment support for the island nation. The billion-dollar loan credit facility is to be used to avert a food crisis while allowing for the import of items and medicines.

Additionally, there will be USD 500 million for importing fuel from India.

Sri Lanka is currently facing a severe foreign exchange crisis with falling reserves. The country is grappling with a shortage of almost all essentials due to the lack of dollars to pay for the imports.

Additionally, power cuts are imposed at peak hours as the state power entity is unable to obtain fuel to run turbines.

The state fuel entity has stopped oil supplies as the electricity board has large unpaid bills. The only refinery was recently shut as it was unable to pay dollars for crude imports.

The Sri Lankan government is also in talks with China to overcome the current financial crisis.

During the visit of Chinese Foreign Minister Wang Yi to Colombo earlier this month, President Gotabaya Rajapaksa requested Beijing's assistance in mitigating his country's deepening forex crisis and spiralling external debt, saying it will help Colombo to the best of its capacity.

Israeli PM likely to visit India as two nations celebrate 30 years of diplomatic ties: Envoy

of bilateral relations.

The Israeli envoy in his speech highlighted ties going back thousands of years with no trace of anti-semitism in India, unlike in Europe and other parts of the world.

Recalling the visit of Jaishankar, Gilon mentioned India's role in shaping the region with Indian soldiers participating in the World Wars and buried in different parts of Israel.

Israel's first Prime Minister David Ben-Gurion saw India and Israel's national movement as "sister liberation movements", he said, pointing out the deep respect the Israeli leader had for Mahatma Gandhi whose picture he had on the wall of his bedroom.

Singla in his address said 2022 also marks five years of a bilateral strategic partnership which was established during the historic visit of Prime Minister Modi to Israel in 2017.

The year, therefore, provides an opportunity to not only look back and take account of the bilateral achievements of the past thirty years but also the past five years when the relationship was put on a "qualitatively higher trajectory", he said.

As the two countries celebrate this milestone, it is also an opportunity to appreciate the efforts of our leaders, diplomats, thinkers, strategists and all the people who have led our partnership and continue to nurture this important relationship, Singla said.

"Our two peoples are connected by civilisational bonds that go beyond trade and economic ties. The Jewish people have thrived in India for centuries and, in fact, enriched the composite culture of India," he said.

As International Holocaust Remembrance Day approaches on January 27, the Indian envoy narrated how Maharaja Jam Sahib of Nawanagar not only saved the lives of several Jewish children but provided them shelter during World War II, also took care of them as long as they chose to be under his guard-

Addressing the Indian Jewish community in Israel, Singla said they "form the organic link, a bridge" which "continues to grow with shared traditions, cultural practices, mutual trust and friendship".

"For the last five years our thrust has been on tapping our strengths as two knowledge economies", he asserted, highlighting deeper collaboration in research and development, innovation, artificial intelligence and quantum computing.

To create the 30th-anniversary logo, both countries launched a contest last year for students of prominent design colleges in Israel and India.

Entries were invited from the Israel Holon Institute of Technology and India's National Institute of Design (NIT).

NIT's Nikhil Kumar Rai's design was unanimously selected as the commemorative logo for the celebrations.

Nikhil, hailing from Varanasi, is a final year student at NIT Ahmedabad and has also studied in the Faculty of Visual Arts at Banaras Hindu University (BHU).

"I wanted my design to be simple and bold that connects audiences from both the countries", Nikhil said during the Webinar to launch the logo.

"It should depict the rich history of the two countries and also be forward-looking," he added.

The event's moderator, Dr Oshrit Birvadker, said the special logo symbolises the strong friendship, love and admiration that exists between the people of Israel and the people of India.

"It also depicts the growing strategic partnership between the two sides," Birvadker said.

In her 63rd try, Alize Cornet makes Grand Slam quarterfinals

MELBOURNE: Alize Cornet has finally reached the quarterfinals of a Grand Slam tournament in her 63rd attempt.

The 32-year-old Cornet survived a second-set meltdown to advance to the last eight at the Australian Open with a 6-4, 3-6, 6-4 win over two-time major winner Simona Halep.

"It's never too late to try again!" Cornet said in her on-court TV interview. "To be in my first quarterfinal. It's a dream come true.

"The journey goes on. I still can't believe it. Cornet led by a set and 3-1 before losing five consecutive games and 16 straight points to send the match to a decider.

Halep saved two match points on her serve in the ninth game before Cornet clinched the match in the 10th. She dropped to her knees on the court and clasped her hands together, putting them over her face before looking into the stadium at her support team.

"It feels amazing," said Cornet, who is playing in her 17th Australian Open. "The battle we had with Simone, with this heat. After 30 minutes, we were dying."

Cornet will next play Danielle Collins, who beat 19th-seeded Elise Mertens 4-6, 6-4, 6-4.in an almost three-hour match to open play on Rod Laver Arena. Collins was a semifinalist in Australia in 2019.

Cornet has never made it past the fourth round since making her Grand Slam singles debut as a wild-card entry at the 2005 French Open. The marquee men's match was on Margaret Court Arena, where U.S. Open champion Daniil Medvedev needed 3 1/2 hours to beat No. 70-ranked Maxime Cressy 6-2, 7-6 (4), 6-7 (4), 7-5.

The No. 2-ranked Medvedev is trying to be the first man in the Open era to win his second major singles title in the next Grand Slam event. He's now potentially three wins from achieving that.

Medvedev was a runner-up in Australia last year but avenged that with a win over Novak Djokovic in the U.S. Open final. Djokovic isn't defending his Australian Open title after being deported on the eve of the year's first major for failing to meet the country's strict

Aliassime, who beat 2014 U.S. Open champion Marin Cilic 2-6, 7-6 (7), 6-2, 7-6 (4). Medvedev beat the Canadian in the semifinals at last year's U.S. Open.

Both women's matches on Day 8 were played in temperatures of up to 34 Celsius (93 F). Cornet used bags of ice to cool down her head



COVID-19 vaccination criteria.

Cressy's serve-and-volley style created some frustrations for Medvedev, who late in the fourth set that this was the "most unlucky day I've ever had in my life." His luck changed quickly. After saving eight break-point chances in the set, Cressy was broken in that game and Medvedev served out at love.

"Hell of a match," Medvedev said. He'll next play ninth-seeded Felix Auger-

"I just stopped thinking after . . . 30 minutes of playing. My brain was already like, overloaded," Cornet said. "My vision was not clear anymore. My hands were shaking."

But, she added, "I thought, on the other side

of the court, she was not feeling much better than me."

Cornet, playing in her 60th Grand Slam tournament in a row, was 0-5 in fourth-round matches at the majors before Monday.

Her victory over Halep, a former Wimbledon and French Open champion and runner-up in Australia, gave her a record for most appearances at a major before reaching the last eight. Tamarine Tanasugarn previously held the mark at 45, set at Wimbledon in 2008.

Cornet had to do the hard way, too. Cornet beat third-seeded Garbiñe Muguruza in straight sets in the second round but had to rally from 6-4, 4-1 down to beat 2021 French Open semifinalist Tamara Zidansek in a 2hour, 43-minute third-round win.

Collins hasn't had a straight-forward path, either, having to rally from a set down to win back-to-back matches at a Grand Slam tournament for the first time.

The 28-year-old American also dropped the first set in her third-round win over Clara

Against Mertens, Collins was aggressive with her ground strokes, hitting 45 winners and making 41 errors. She converted five of her 18 break-point chances and clinched the victory when Mertens, a semifinalist in Australia in 2018, served a double-fault.

"Today it was really physically tough for me," Collins said. "I played a long match the other day — 2 1/2 hours — and then I played doubles, so I spent about five hours on court. "I had to make a lot of technical adjustments to make myself comfortable moving around, especially serving.


