


Addressing a press conference to high-

Odisha begins vaccination for 15-18 age group amid rapid surge in Covid cases

BHUBANESWAR(KCN): Amid the rapid surge in Covid-19 cases, vaccination drive for adolescents in the 15 to 18 years age group commenced across Odisha on Monday.

Apart from the existing 2,700 vaccination centres, the state government has designated 939 exclusive vaccination centres to facilitate smooth inoculation of teenagers. The vaccination was carried out in as many as 3,193 session sites on the first day, Health and Family Welfare department sources said.

Beneficiaries were seen lining up at the vaccination centres for their turn in the morning. The drive at most of the centres started after 9 am.

Mayurbhani CDMO Rupabhanu Mishra said the vaccination drive carried out at the designated vaccination centres of the district remained smooth. He said the response from the teenagers was also good on the first day. A teenager, who turned up for vaccination, at one of the designated centres in Sambalpur district said the inoculation process was smooth even though she had opted for offline registration. "Though I was nervous, I felt safer and protected from the infection after getting the jab," she said.

Director of Capital Hospital in Bhubaneswar Dr Laxmidhar Sahoo said beneficiaries registered their names on the CoWIN portal as well as those who have opted for on-site registration are being given shots.

six lakh register on CoWIN Sahoo said immunisation of adolescents was highly essential as children in this age group are more active and susceptible to catching the infection.

Additional district urban public health officer (ADUPHO) Antaryami Mishra, the nodal officer for vaccination in Bhubaneswar, said provision has been made for the administration of 150 doses of vaccine in each centre every day.

The state has around 23.65 lakh eligible beneficiaries in the 15 to 18 year age group.

With the state government planning to complete the vaccination process of teenagers within a month, the Health Department has asked school and college principals to share the list of students eligible to get the jabs. The educational institutions have also been asked to provide adequate space for inoculation on their campuses in the coming days.

Health department officials said eligible teenagers can register in the CoWIN portal and also opt for on-site registration for the vaccination.

Health officials said efforts are on to inoculate beneficiaries in the 15 to 18 age group at the earliest in view of the rapid surge in Covid infections and a sudden spike in Omicron cases in the state in the recent days.

Over 800 cases of Covid-19 has been reported in the state in the last 48 hours. The state logged 424 more confirmed infections in the last 24 hours. Khurda district reported the highest 151 cases followed by 66 in Cuttack. Besides, the State's Omicron tally also jumped to 37 after 23 more tested positive for the new infectious variant of Covid-19 on Sunday.

Missing Civil Society in Odisha-A Perspective

In general, civil society is defined as a political organisation that regulates social conflict by



imposing laws that prevent citizens from injuring one another. The notion was employed as synonym for the good society during the classical period, and it considered was indistinguishable from the state. When democracy does not

work properly, it is quite obvious and evident that citizens must take up the responsibility unto themselves to question the system and influence other stakeholders to raise critical concerns. This is the essence of democracy. But unfortunately, this is not true in Odisha. Odisha, a state having a golden history in numerous fields such as maritime venture, arts, crafts, and excell3ence in sculptural superiority have now reduced to a state of indignity with headlines like Nagada, Dana Majhi, poor health services, rape of minors, and farmers suicide..my friends will criticize me of not acknowledging the recent development in sports infrastructure especially Hokey and the renewed facelift of Jagannath temple in Puri. Without any hesitation, I must confess that apart from veryfew positive changes in governance, the entire picture is bleak. This should ideally change. And in order to bring this change, it is expected that the governance mechanism and apparatus become more responsive and transparent, media becomes more unbiased, and civil society becomes more vibrant and vigilant in its overall approach. At this juncture, I have tried to delve into the moot question. The question is quite obvious. Why there has been no civil society movement or movement led by civil society on critical issues affecting the state of Odisha. Does the next obvious question also come to mind that; is everything well in Odisha with regard to the performance of government or governance as a whole? We all will agree to the fact that there are a whole lot of issues from the overpowering bureaucracy to the poor performance of government, in every front, there is laxity and mismanagement, but still, the voice from civil society is almost unheard of or if it exists, there is no voice at all. Let's analyze the "why aspect of the question.

Before moving into the missing of civil society in Odisha, let us discuss at length, where Odisha stands in so far as different governance indicators are concerned and what has been the observations and remarks by different credible agencies and institutions on the performance so far.

Health Indicators in Odisha

As per the National Family Health Survey 5 (NFHS-5) the highest spike has been recorded among the children where 64.2 per cent (pc) are anaemic as compared to 44.6 pc in NFHS-4 conducted in 2015-2016. While 65.6 pc children are anaemic in rural areas, more than half of the urban children (56.2 pc) are also suffering from anaemia. Around 64.3 pc pregnant women, aged 15-49 years, are anaemic as against 51 pc during the last survey. Among nonpregnant women between the ages of 15 and 19, it is up from 51 pc in 2015-2016 to 65.5 in 2020-2021. More young women in rural areas (66.3 pc) are anaemic as compared to urban areas the latest NFHS statistics also indicated that son-preference has emerged as the new epidemic in Odisha as the sex ratio at birth (females per 1,000 males) in the last five years has come down from 932 during 2015-16 to 894 in 2020-21. The sex ratio is more alarming in rural areas as it was 885 at birth compared to 950 in the urban localities. Though, the sex ratio of the overall population of the State has improved to 1,063 from 1,036.

Primary Education in Odisha

Agricultural Growth in Odisha

Odisha has 32.6% of the population below poverty line (Tendulakar Committe 2011). The state's per capita income in 2017-18 was Rs. 80,991 compared to the national average of Rs 126,043. Land utilisation pattern² in Odisha has undergone considerable change over the last two decades. While land available for agriculture has declined, there is a substantial increase in fallow lands. Gross cropped area (GCA) decreased from 9.6 m ha during 1992–93 to 8.5 m ha during 2016-17 and the net sown area (NSA) fell from 41 to 36% of the total geographical area of 15.6 m ha during the same period. This decline in cultivable land can be attributed to increased salinity in soil due to frequent flooding, soil erosion and inadequate irrigation during the rabi season. The irrigation ratio (gross irrigated area as a proportion of gross cropped area) in Odisha has consistently remained below the all-India level. Odisha has abundant groundwater resources—about 16.69 lakh bcm. However, the state lags behind in the development of these resources as only 5.02 lakh bcm or 30% of the total potential has been used so far for different purposes, especially for irrigation. Deficiencies in the transmission and distribution infrastructure of power are the main reasons for the low utilisation groundwater. Electricity is an important input for agriculture for use in irrigation and operating agricultural machinery and equipment and is considered as an indicator of an economy's development. However, Odisha's situation in power sales/ consumption is poor, especially when it comes to the agricultural sector, resulting in the under-utilisation of groundwater resources in Odisha.

The per hectare power consumption in agriculture or power intensity in Odisha is among the lowest in the country. While Odisha recorded a power intensity of 24 KWh/ha during 2014–15, states like Tamil Nadu with 2070 KWh/ha, Haryana with 1477 KWh/ha and Karnataka with 1469 KWh/ha were the highest-ranked terms in of intensity. Horticulture in Odisha suffers not only from the lack of organised marketing but also from a shortage of cold storage facilities for perishable fruits and vegetables. As of 2017, Odisha had 171 cold storage, which represented a mere 2.2% of the total cold storage capacity in India. Most of these cold storages are used for keeping potatoes. More cold storage are needed for potatoes as well as other fruits and vegetables.

Child labour In India

A survey conducted by the Odisha State labour department in compliance with honourable Supreme Court order in 2013 found that Odisha had 2.15 lakh child labour, of which 121,526 were boys and 93,696 were girls. A report prepared by V. V. Giri National Labour Institute provides national and state-level statistics on the work participation rate (WPR) of children disaggregated by age group. The survey reports of working children as young as five to nine years. Around 0.3% of children aged five to nine years in India and 0.5% in Odisha are working. It reported that in the five to 14 year age group, Odisha has 4.9% working children as compared to 3.3% in

Sexual Harassment in Odisha

Odisha ranked third in sexual harassment cases and dowry deaths, fourth in voyeurism along with the total IPC crimes against women. Shrinking Space of Civil Society in Odisha It's really deplorable to see that in spite of the fact that, there has been tremendous noise in the form of debates discussions in both print and electronic media highlighting the present state of affairs, why is it so that no big movement around such issues is not erupting in Odisha. Relating to my earlier question as to why there is no civil society movement around such bad governance specifically in Odisha, let's explore different possible factors responsible for the same.

From a concerned citizenry, we have travelled to a more selfish one, with a very little affinity towards my society. Odisha has slipped to such a state where we have taken it for granted that the present administration is maintaining the status quo and there is hardly any choice left for the people, in so far as change in the political system is concerned. As a whole, people have lost faith in the political system as a whole, wherein it hardly makes a difference whether it is BJD today or possibly BJP tomorrow. At the end of the day, the people have internalized without any convincing prophesy at their disposal that, nothing will change, irrespective of any political party or leader at the helm of affairs. This kind of attitude possibly has not aroused any public outcry for critical outbursts and social movements.

Secondly, critical thinking not getting a proper platform and influencing larger public discourse is probably because of the dearth of dynamic leaders with whom people can relate themselves to. Unfortunately, in Odisha, we have not been able to have a leader of that stature and ability who can influence the masses and nobody knows, whether we will get one in near future or not. ThirdlyGreen's 2017 report, Civil Society at a Crossroads, emphasizes how many civil society organizations rely on donor funding to carry out their missions. Green's 2017 research, Civil Society at a Crossroads, notes how many civil society organizations rely on donor money to achieve their goals, leading to criticisms of their grant-driven business model, particularly traditional civil society organizations' failure to achieve radical change. For three reasons, critics claim that these successes are palliative rather than revolutionary. It is ironic that nothing of that sort is emerging and it's almost quite clear from the present scenario that we all like that the status quo should be maintained without any critical outburst. Being part of the unfortunate middle class we are privy to all kinds of noisy prime time debates and flooded with pieces of information starting from the Renovation of Educational Infrastructure and Quality Education in Delhi to Mohalla Clinic and Free Electricity. But we don't see any attraction to such types of governance models ensuring free, quality education, and a series of indicators of good governance practised by ArvindKejriwal in Delhi.The possible causes of such a callous Firstly, the number in the assembly. The thumping majority or say the sweeping win in

attitude might be for the following reasons. a democracy gives a dual picture. One that the people have undaunted faith in the present political leadership but the flip side is as recently seen in many states like Delhi and Odisha, that the opposition has got no presence at all. They have simply abdicated their responsibility merely because of their weak number. The people, in general, have taken it for granted that since there is no opposition, there is no point in expecting that any critical voice will emerge. Another facet of such development might be of weak and irresponsible media. Here we are stressing upon the Odisha specific print and electronic media, where somehow our media and especially the electronic media have not been very vibrant in its functioning. I have never seen a state other than Odisha, where none of the prominent media has ever got an opportunity to get an interview from the Chief Minister. Forget about fixing accountability of misgovernance, not a single media house has ever been able to have an interview with Mr. Naveen Pattnaik. While exploring the possible causes of shrinking civil society space, one thing is quite prominent that the middle class who ideally spearhead the critical thinking and social movement, are also getting their due share of the pie in the form of 6th, 7th and so on pay commission, work from home, varieties of benefits and so on. Most importantly, in the present circumstances, a new trend has been unravelling in the form of compulsory retirement of government servants in the guise of corruption, non-performer etc. Hence a big chunk of the population, that to the middle class who is expected to spearhead critical thinking are being suppressed and coopted.In recent times we have seen how for a temporary manner, the opposition political parties and at times the ruling party in the state, who otherwise is a tacit supporter of the Central government policies in the Parliament have staged Gherao and Dharana in the issue of Petrol& Gas price hike but that seems quite misplaced for the simple fact that they (the political parties) have given false hope to the society that they are reflecting people's grievances and aspirations and unfortunately they have given a false hope that they represent civil society in a sense. It's high time that we as citizens of the country and people from Odisha needs to see how we

can best contribute towards airing the critical voice of governance. The civil society space should always not be taken away by political parties for their petty political mileage. Hence people from all walks of life must get involved in critical thinking and givespace to such misgovernance of the government of the day. As citizens, we also need to be more innovative in seeing the future of the state and be more pragmatic in our approach in visualizing the future instead of being happy with the status quo. We as responsible citizens must come forward with suggestions and ideas as to how to bring an end to photo up politics. Let's change the way we accept politics, governance and non-responsive leaders. Let us question things at the appropriate level and channelize the grievance in a proper direction. Odisha needs its civil society to become the harbinger of change.

The price-OI relationship can give an indication of market mood. For example, if price rise is accompanied by an OI rise, the sentiment (on the asset) is bullish. If the price falls and OI rises, the sentiment is bearish.

the last one in Kathmandu in 2014. The 2016 SAARC Summit was originally planned

to be held in Islamabad on November 15-19, 2016. But after a terror attack on an Indian Army camp in Uri in Jammu and Kashmir on September 18 that year, India expressed its inability to participate in the summit due to "prevailing circumstances"

The summit was called off after Bangladesh, Bhutan and Afghanistan also declined to participate in the Islamabad meet.

Noting that there was no change in relations with India in 2021, Qureshi cited the alleged dominance of "Hindutva thinking" in India for sabotaging the prospects of good ties between the two countries. Unfortunately, ties with India in 2021 were frozen. "In our view, the potential of regional cooperation has been hit by aggressive Hindutva behaviour in recent years," he said.

He said Pakistan wanted peaceful ties with all its neighbours, including India, but the responsibility for improving the relations was on India.

Qureshi said peace with India was not possible without resolving the Kashmir issue.

The bilateral relations deteriorated after India withdrew the special powers of Jammu and Kashmir and bifurcated the state into two union territories in August 2019.

India has told Pakistan that it desires normal neighbourly relations with Islamabad in an environment free of terror, hostility and violence.

Qureshi dwelt at length on Pakistan's ties with the rest of the world and concluded by saying that political, economic and diplomatic relations improved last year with the entire world, including the US, Russia and China.

Qureshi specially mentioned that the ties with Bangladesh were improving and Prime Minister Imran Khan has interacted with his Bangladeshi counterpart Sheikh Hasina.

He said Khan invited Hasina to visit Pakistan who also invited him to visit Bangladesh.

To a question on the reported 'Cold War' between China and the United States, he said Pakistan's policy was clear and Islamabad will not become a 'part of

Responding to another question on the removal of fencing by the Taliban forces on the border, he said Pakistan carried out the fencing work and was aware of the latest incidents (of its removal) while adding that Afghanistan is our friend and we will be able to resolve it.

Qureshi's remarks on the SAARC Summit came after Pakistan Prime Minister Khan last month expressed hope that his country would host the muchdelayed meeting when the "artificial obstacle" created in its way is removed.

Khan made the remarks during his meeting with the Secretary-General of the South Asian Association for Regional Cooperation (SAARC) Esala Ruwan Weerakoon, who paid a courtesy call on the Prime Minister here.

Calculating OI

If trader A buys a futures contract and trader B sells one contract on Monday, there is one long and one short contract. By Monday end, OI is 1.

On Tuesday, trader C sells 3 contracts which trader A buys, the total short contracts are 4 and the long contracts are 4 (B = 1 short, C=3 short and A=4long). OI is 4.

On Wednesday, trader C squares off her 3 shorts by buying them back from trader A.

Now, A holds 1 long contract and B holds 1 short contract, while C is out of the market, so the OI declines to 1.

This is how OI keeps changing. For every buyer, there is a seller and vice versa, which is why derivatives are called a zero sum game.




