Govt efforts alone cannot be successful, Development only goal of govt: Naveen people's participation required: PM Modi

New Delhi(KCN): Prime Minister Narendra Modi on Thursday underlined the importance of people's participation in the efforts for wa-



ter conservation and said the governments' attempts alone cannot be successful.

In his virtual address at the first national conference of water ministers from states, Modi said water should be a subject of cooperation, collaboration and coordination among states and asked them to plan in advance in view of the fast pace of urbanisation.

His remarks assume significance as disputes over water-sharing have lingered among several states for decades.

The prime minister said he thinks that under the MGNREGA maximum work should be done on water as he called for spreading awareness among people for its conservation. Water is most consumed in sectors such as

industry and farming, and awareness should be spread among them, he said, advocating for crop diversity and natural farming.

Modi also urged states to work on waste management and sewage treatment to stop water bodies from being polluted, and said they can use the 'Namami Gange'

scheme as a template.

People's participation in any programme develops a sense of ownership among them which, he said, is a key to success. Modi cited the 'Swachh Bharat' (clean India) campaign as a successful example of this.

The all-India water ministers' meet on the theme 'Water Vision@2047' brings together key policy makers to discuss "ways to harness water resources for sustainable development", the government has said.

The Union Jal Shakti Ministry is organising the national level conference on water.

Washington(KCN): The Biden administration has proposed a massive hike in immigration fees, including the much sought-after H-1B visas for high-skilled foreign workers which is very popular among Indian tech professionals.

Under the proposed rule, published by the US Citizenship and Immigration Services (USCIS) on Wednesday, the application for the H-1B visa increases from USD 460 to USD 780, and L-1 from USD 460 to USD 1,385. The application fee for O-1 visas has been pro-

The H-1B visa is a non-immigrant visa that allows US companies to employ foreign workers in spenies depend on it to hire tens of thousands of employees each year from countries like India and China.

cation, the Department of Homeland Security (DHS) said that USCIS is primarily funded by fees charged to applicants and petitioners for immigration and naturalisation benefit requests. Rahul concludes UP leg of Bharat Jodo Yatra; draws many, disappoints a few

LUCKNOW(KCN): Congress MP Rahul Gandhi completed the UP leg of the Bharat Jodo Yatra by stepping into Panipat in neighbouring Haryana through Kairana in the Shamli district on Thursday evening.

However, during the course of the UP leg of Yatra, the Congress MP drew support from unexpected quarters and a huge crowd joined him in his sojourn but left a few, especially the RLD workers, disappointed as well.

The Bharat Jodo Yatra resumed its journey around 6:45 am on Thursday after the night halting at Ailum village in Shamli district with a huge crowd marching through the hinterland braving the chilling cold wave condi-

While the yatra drew a huge crowd, it also left the workers and leaders of Jayant Chaudhury-led Rashtriya Lok Dal (RLD) high and dry who claimed that they were ignored by Rahul Gandhi and the yatris while passing through Kandhla town in Shamli.

Notably, following the diktat of their president Jayant Chaudhury, a number of senior leaders, including three MLAs and workers, of RLD were prepared to welcome the yatra. RLD leaders said they had also made arrangements for Rahul Gandhi to stop at the statue of former PM Chaudhury Charan Singh at welcome the yatra but it passed through even without acknowledging the RLD workers," said an agitated RLD leader.

He was joined by a party worker who accused



Kandhla to pay tribute to him.

"He did not pay any attention to us. We had been standing by the roadside for hours to

the Congress MP of insulting Chaudhury Charan Singh and the farmers' community by not stopping at his statue and paying homage to him.

However, earlier around 10 am on Thursday, the Yatra took a break at Unchagaon village in Shamli district for nearly five hours. A special VIP camp was set up on land owned by farmer Ramchandra Singh at Unchagaon for Rahul Gandhi to take rest, while a separate camp was set up for other yatris. A kitchen was also established over 10 bigha land where 90 cooks, ferried from the Ajmer district of Rajasthan, prepared food for the Yatris.

As per the Congress sources, the cooks had reached Unchagaon on Wednesday evening along with four trucks full of necessary food items, spices, grains and vegetables.

Interestingly, Motichur laddoos, green vegetables, Chapatis, Pooris, and curries were there on the menu which was similar for VIPs and common yatris.

Rahul Gandhi was accompanied by senior Congress leaders including General Secretary (Communications in-charge) Jairam Ramesh and the party's state chief Brijlal Khabri while he made his way through Shamli district to enter Haryana.

January 10, 2023 **Budget Utilization On Rise**

Bhubaneswar(KCN): While Budget utilization during Current Fiscal has increased, the State Government has urged the Development Departments to take steps to further increase the pace of expenditure to ensure full utilization of Budget Provision. Vishal Dev, Principal Secretary Finance has presented detailed report on Fiscal Performance up to December 2022 in the All Secretary Meet held on 4 Janu-

Principal Secretary Finance has informed that the Budget Utilization has increased by about 1.15%.

There is also increase in expenditure by 25.6% against 22.5% increase in Budget Provision.

So far Programme expenditure as percentage of Budget Provision is 46.34% till December, 2022 compared to 45.20% during previous year. Total expenditure as percentage of Budget Provision, which includes Budget Estimate and supplementary Budget is 54% till December, 2022 which shows 2.6% increase in budget utilization compared to previous year. Utilization in Agri-

penditure in Agriculture and Allied sector till December, 2022 has been 53.2% of BE compared to 52.5% previous year.



culture & Allied Sector is 54.4% compared to 53% previous year.

Infrastructure spending is 53% against 34.6% previous year. Percentage utilization of budget in social sector is 54.9% compared to 53.1% previous year.

Budget utilization has increased by about 0.7% over previous year. In absolute term, it has increased by 20.2%.

The Programme Expenditure in Infrastructure till December 2022 is 54.7% of BE compared to 32.7% previous year. In absolute term, it has increased by 103%.

The Social Sector Programme Expenditure till December, 2022 is 46.5% of BE compared to 46.4% against previous

Programme expenditure in other sectors till December, 2022 has been 32.8% compared to 48.2% previous year.



Ignoring the human aspects of the farmers in agricultural development

Earth is the most unique gift of nature and along with living on this earth, we



grow all the food here for earning a living. This is because of the giving tendency of this earth. The earth's sense of giving is also our basic existence. Cultivating the seeds and turn-

ing them into plants, trees and becoming the life of the living beings is the biggest favor of the earth. The most emotionally connected with the earth is a farmer who becomes the medium of charity for the produce of the earth. In fact, he is most connected to the ground. The importance of the farmer has not received the respect it deserves in the

flourishing urban culture. Basically the farmer does the

hard work to grow the crop, but he is still on the margins and the middlemen who buy and sell the crop grown by him are in the mainstream and all the glory is tied to them. If today's farmer is being inspired to commit suicide, then behind it is the economics of agriculture based on middlemen.

It is said in the Atharvaveda that the Gods cultivated sweet grain-barley, rice etc. in the best land with water, at that time Indra was the protector of the plows (Sirpati) and the best giver Maruts were the farmers. Kutsitah nashayati iti ki naashah means he who destroys sorrow, inferiority and evil is a farmer. The condition of poverty and famine is destroyed by the attainment of food grains.

Dr. Lokendra Singh KotThe farmer is the one who destroys the bad by produc-

ing food. Due to providing prosperity to the nation and society by removing scarcity and poverty through food production, the farmer has been praised in the Vedas by calling him the husband of food and the owner of the field. It is easy to gauge the development of agriculture from the fact that before independence, the contribution of agricultural sector to the GDP was more than 50 percent, which is currently only about 15 percent. The increasing demand for food grains not only increases the pressure on agriculture, but also various additional efforts are made for more production. There are many challenges for the farmer at the same time where he is benefiting from the use of modern techniques, while he has also opened the doors for accidents from those machinery. Even today, there is special focus on production in agriculture but its human side is yet to be included. Due to predominantly production based policies, the farmer himself becomes secondary. For the last several decades, more attention was paid on how to produce more, but humanity kept disappearing in its desire. Today, the excessive use of pesticides, chemical fertilizers has not only put the lives of farmers at risk, but the common people who consume it are also indirectly becoming victims of many non-communicable diseases. Due to the incomplete definition of agricultural development, today's farmer and common man both are at a great risk. Indigenous agriculture in India relies heavily on human and animal energy sources for various agricultural activities. However, nowadays energy and electricity are widely used in various agricultural activities. At present, the number of agricultural machinery in the country is about 200 million. Due to the small size of the land administration, India is the world's largest market for tractors and other agricultural equipment such as threshing etc. However, the number of tractors used in Indian agriculture is estimated at 2.5 million. India is the largest producer of tractors in the world (0.25 million/ year). Apart from being used as an agricultural power source for a variety of activities, tractors are widely used to transport goods, people and even ani-

The increased use of agricultural machinery has increased the production of Indian farms. But, on the other hand the risk of agricultural accidents increases. Injury or loss of a family member due to agricultural accidents causes a huge financial loss not only to the family but to the entire state. The unavailability of adequate and reliable data on the cause and nature of agricultural accidents makes it difficult to measure the economic burden of these risks and identify ways to mitigate them. Most of the world's population, more than 75 percent, is directly or indirectly dependent on agriculture for their livelihood. But this is one sector in which there is a deep tendency to overestimate and undervalue the role that good health and safety management can play.

Agriculture is a dangerous business to-

day, with millions of workers facing injuries and deaths around the world. Comparisons between agricultural exposure levels in different countries are difficult because reporting and injury and mortality rates between countries and between countries may not be fully available. In many low-income countries, information about agricultural hazards is not always available. It is important to set the risk statistics correctly. The pain of the injured is well known. However, various other aspects of the problem need to be considered. Agricultural accident has wide ranging consequences. In smallholder agriculture, the loss of agricultural activity can bring severe and intolerable problems to the family. The focus of care should not only be on the injured but also on the family as normal family processes may be disrupted and income may be greatly reduced. At the national level, agricultural risks place a significant burden on the economy. Efficiency is limited and agricultural productivity is declining. Furthermore, in many cases the equipment involved in the accident may need to be replaced, often at great cost. Agriculture is a dangerous business today, with millions of workers facing injuries and deaths around the world. The issue of health and safety of agriculture in a developing country like India is still in its infancy despite the fact that agriculture is still a pillar of their economy. "Agriculture" includes not only farming but also many other related activities such as crop preparation and packing, irrigation, pest management, grain storage, animal husbandry, construction and household chores (watering or firewood, etc.). Agricultural work - and this is one of the main attractions - is being done in a rural area where there is no clear distinction between working and living conditions. Since agricultural work is carried out in rural areas, it depends on the health risks of the rural environment as well as those associated with specific labor processes. Due to the nature of agricultural work, workers in this sector are exposed to a number of risks, which is why health and safety in agriculture is essential. The latest developments in agriculture will not only increase the risks or risks faced by agricultural workers. By using chemicals they may be exposed to toxic substances associated with harmful chemicals which are injurious to health. The use or equipment exposes them to excessive noise pollution, resulting in the accumulation of all these hazards associated with new technologies that may ultimately affect the well-being of these workers, if an effective health and safety approach is put in place to mitigate the effects. The system can be set up against these threats. While it is true that data on agricultural damage are limited, it is clear that such exposures present a serious problem. Take exemplary action against tipsy air travellers Should we stop serving liquor onboard?

Two back to back incidents onboard in flights that are coming to India from New York and Bangkok respectively have shaken anyone and everyone. They cannot be put under the carpet. In the first incident, a Mumbai based businessman Shekhar Mishra boarded a New York to Delhi Air India flight- business class. After taking enough booze, Mishra went up to a woman passenger and urinated on her in a full view of other passengers. Just spare a thought for the poor lady who had to face such a scary situation. You can not say that he had urinated under the influence of liquor. No, this is a lame defence. He didn't urinate on any male co-passenger. proves a point beyond any doubt that he was a sex manice. And equally shocking is the fact that the crew took no action against Mishra. And did not support the shocked woman. Did you know about the incident, Ratan Tata, chairman emeritus of Tata Group?

The only good thing is that the brave woman pursued the case tooth and nail. And it's now that AI has imposed a measly 30 day flight ban on Mishra. That's too late and too late considering the fact that the incident took place on last 26 November, 2022.

Noted writer Seema Mustafa has rightly said-"Flights with Indian men aboard are becoming a security risk. They beat up fellow passengers; they abuse the air stewards and now this. Sheer dirt and filth."

Now the big question: Can't we stop serving liquor in flights? What is so great about it? This very incident should be a wake-up call for all of us. On my recent return flight from Dubai to Delhi, a young passenger just two seats away from me was creating ruckus for more and more liquor. The Air India staff had served him enough, yet he was asking for more to the embarrassment of his family. He was not listening either his family or crew members. Thankfully he didn't urinate on his co passengers. But given his tipsy condition, he could easily become another Mishra. The authorities concerned must think whether serving liquor to passengers can be discontinued? However, the noted ad professional Preet KS Bedi says that you can not take such a drastic step because of couple of black

An in another incident that also happened recently, an Indian passenger's refusal to straighten his reclined seat before take-off first led to an acrimonious argument with a stewardess on board a taxiing Bangkok-Kolkata flight and then a full-blown assault involving some fellow flyers who decided he should be taught a lesson. A viral video of the December 27 fracas on the Thai Smile Airways flight prompted the Bureau of Civil Aviation Security (BCAS) to institute a suo

motu probe and register a case with the airport police station in Kolkata.

Union aviation minister Jyotiraditya Scindia tweeted, "...Such behaviour is unacceptable." Mr. Scindia, you must take strong actions against such travellers. Tweets are not suffice.

Meanwhile, the airlines said the take-off had been "slightly delayed" as a result and "the incident has been taken care of as we followed the flight safety procedures in accordance with international standards. "Since Thai Smile hadn't reported the incident, regulator DGCA and the aviation security bureau both sought a report from the full-service carrier, which currently doesn't have a country head in India. "Thai Smile Airways feels sorry for this. Our flight crews have already provided support to the persons affected by the incident," the airline tweeted.

Experts say since the episode took place aboard a foreign airliner and abroad, the scope and jurisdiction of Indian agencies to act against unruly passengers is apparently limited. BCAS's police complaint is against the flyer who started the assault as well as the one who was targeted for not following safety instructions.

It is said that there were passengers seated in 38 A, B and C. When the crew asked him to straighten his seat during take-off, the person in 37C said he had a backache. The crew tried explaining that the seat must be in upright position (for safety reasons). The airline quoted the passenger as telling the crew, "I fly often, I know what to do." The stewardess then told the passenger that if he didn't follow safety rules, the crew would be forced to report him to the pilot. "Ok, tell him. I am not scared," he allegedly said.

Finally, those who travel often know that some passengers refuse to tow the requests of captain of the plane and other crew members. Even when it is announced that "All passengers are requested to take their seats as the weather is rough", these 'problems flyers' keep on moving from one side to another. Only God knows what kind of joy or pleasure they get in flouting the simple instructions. They forget that they are risking the lives of their so many co-passengers. Naturally, all such passengers should be punished. The action can be ban of their air travel from 3-5 years as well as police action. And those passengers who argue with crew for vegetarian and non-vegetarian food should also be warned of. Often, we see many travellers creating a scene for food. It is high time that we take a lead in dealing irresponsible travellers. Let us start some exemplary action against Mishra who urinated on a lady.

'Govt to set up committee for Padampur dist soon:' Naveen Patnaik

BHUBANESWAR: The state government has decided to set up a high-level committee to start the process for the formation of a separate Padampur district as promised by Chief

Minister Naveen Patnaik during the campaign for the recent bypoll there. Announcing this, Revenue and Disaster

Management Minister Pramila Mallick said the department is ready to start the process. It is only waiting for direction from the chief minister in this regard. The

high-level committee can either be a cabinet sub-committee or an executive committee headed by a senior official of the state government. The new district can be formed either by an executive order or the government may take the legislation way by bringing a bill in the Assembly.

Former Law minister in the Biju Patnaik cabinet Narasingh Mishra said there is no need for taking the matter to the Assembly or form a District Reorganisation Commission. The new district can be announced simply by an executive order as was done by Biju Patnaik to increase the number of districts in the state from 13 to 30.

Sources in the know of things, however, said that the state government will not go for the formation of only Padampur district when there are demands for more than a dozen new districts. Such a decision will be suicidal for the ruling BJD when the elections are less than a year away.



As the chief minister has said that the new Padampur district will be announced before 2023-end, the state government will no doubt form a committee to consider several district demands. In an election year, it will also benefit the ruling BJD to accede to the district demands of some other regions along with Padampur to keep a check on the Opposition. There are demands for new districts from Rourkela in Sundargarh, Titlagarh in Balangir, Berhampur in Ganjam, Rairangpur in Mayurbhanj, Anandpur in Keonjhar, Gunupur in Rayagada, Talcher in Angul, Jaleswar and Soro in Balasore, Banki in Cuttack, Reamal tehsil in Deogarh, Dasapalla in Nayagarh and Bhubaneswar in Khurda. The Padampur district will have to be carved out from the Bargarh district.

The operators also complain about lack of quality amenities at the ghats, like proper accommodation, drinking water, washrooms etc for tourists. Many boat operators are tribals or the Polavaram project-affected people with weak financial clout, they stressed.

They have urged the state government to exempt them from paying the user charges at least for two years during which time they hope to recover from the present financial crisis. Meanwhile, the boat operators have been served notices by the forest authorities to ensure they pay another user charge of Rs

Annavaram, Dwaraka Tirumala etc and giving wide publicity to such efforts.

A good number of tourists from Hyderabad and other places in Telangana arrive in the temple town of Badrachalam and set sail on Godavari from Pochavaram to Papikondalu and go back, they say.

COVID-19 crisis: Celebrity deaths in China spark fears over death toll

BEIJING: The growing number of Chinese linked to Covid in their obituaries, promptpublic figures whose deaths are being made

public is prompting people to question the official Covid death toll, according to a media report.

The death of Chu Lanlan, a 40-year-old opera singer, last month came as a shock to many, given how young she was, BBC reported. Her family members said they were saddened

by her "abrupt departure", but did not give details of the cause of her death, the report said. China scrapped its strict zero-Covid policy in December and has seen a rapid surge of infections and deaths. There are reports of hospitals and crematoria becoming overwhelmed. But the country has stopped publishing daily case data and has announced only 22 Covid deaths since December, using its own strict criteria. Now, only those who die from respiratory illnesses such as pneumonia are counted.

On Wednesday, the World Health Organization (WHO) warned that China was underrepresenting the true impact of Covid in the country - in particular deaths.

The BBC reported that Chinese media divulged details surrounding the deaths of 16 scientists from the country's top science and engineering academies from December 21 to 26. However, none of these deaths were

unclear, but many social media users linked it to the recent deaths of other older people, BBC reported.

Vaishnaw and Union Minister for Education and Skill Development Dharmendra Pradhan launched the much awaited 5G service in the twin cities of Bhubaneswar and Cuttack.

The service will now be provided by Reliance Jio and Bharti Airtel in the state in the first phase. The operators have installed 510 base transceiver stations (BTS) towers, including 410 by Jio, to provide the service.

The 5G service will be available in eight cities and towns, including Berhampur, Rourkela, Sambalpur, Puri, Balasore and Angul by March this year and the 5G network will cover entire Odisha by December 2024.

Vaishnaw said the fifth-generation cellular technology will bring a revolution at the grassroots level as it will not only be available for cell phone users, but also for many public services like health and education.

BHUBANESWAR: Debt-ridden telecom firm Vodafone Idea has various requirements, including infusion of capital, and discussions on this front are going on, Telecom Minister Ashwini Vaishnaw said on Thursday.

Vodafone Idea (VIL), reeling under debt burden of over Rs 2 lakh crore, has opted for converting about Rs 16,000 crore of interest liability payable to the government into equity, which will amount to around a 33 per cent stake in the company while promoters' holding will come down to 50 per cent from 74.99 per cent.

'Vodafone (Idea) has many requirements. It has a particular requirement of capital. How much capital, who will infuse? All those things are under discussion at this point of time," Vaishnaw said. VIL has offered a stake to the government at a par value of Rs 10 per share and the government is waiting for the company's shares to stabilise at Rs 10 apiece. "The responsibility of capital has to come from various sources. The company just doesn't require conversion. It requires capital. All those things are a complex issue," Vaishnaw said.

Biden administration proposes massive hike in immigration fees including H-1B visas

The proposed rule went on a 60-day public opposition period, following which it is expected to be enforced. Under the proposed rule, the fee for the H-2B petitions (for seasonal, nonagricultural workers) is proposed to increase from USD 460 to USD 1,080.

?Economists would note that fee increase on these visa categories would work against the desire of US policymakers for more workers to enter the United States legally,? Forbes said in a news report.

While there is no increase in the premium processing, the number of days is now 15 business days from the existing 15 days.

However, in this proposal, DHS would eliminate the additional biometric services fee in most cases by, including the costs in the underlying immigration benefit request fee.

The USCIS said the new fees would allow the immigration agency to more fully recover its operating costs, reestablish and maintain timely case processing, and prevent the accumulation of future case backlogs.

The agency receives approximately 96 per cent of its funding from filing fees, not from congressional appropriations, it said.

The proposed fee rule is the result of a comprehensive fee review at the USCIS. That review determined that the agency's current fees, which have remained unchanged since 2016, fall far short of recovering the full cost of agency operations.

The USCIS generally publishes a fee rule biennially, and proposes these changes to account for the expansion of humanitarian programmes, federally mandated pay raises, additional staffing requirements, and other essential investments, a media statement said. In 2020, the onset of the COVID-19 pandemic led to a dramatic reduction in receipts of new applications, resulting in a temporary drop in revenue by 40 per cent. The combination of depleted cash reserves, a temporary hiring freeze, and workforce attrition has reduced the agency's capacity to timely adjudicate cases, particularly as incoming caseloads rebound to pre-pandemic levels, it said.

According to the USCIS, the proposed rule would increase some fees, including a modest increase in the fee for certain naturalisation applications, while preserving existing fee waiver eligibility for low-income and vulnerable populations and adding new fee exemptions for certain humanitarian programmes. If finalised, the proposed rule would decrease or minimally increase fees for more than one million low-income filers each year.

?In addition to improving customer service operations and managing the incoming workload, the USCIS must continue to fulfil our growing humanitarian mission, upholding fairness, integrity, and respect for all we serve,? said USCIS Director Ur M. Jaddou. ?This proposed rule allows the USCIS to more fully recover operating costs for the

first time in six years and will support the administration's effort to rebuild the legal immigration system,? he said.


