Quick response vehicles for Fire Service Odisha speaker Bikram Keshari Arukha urges



Bhubaneswar(KCN): The Odisha Fire Service Directorate has decided to deploy PCR type pre-positioning of quick response unit vehicles for towns and villages where big fire service vehicles cannot move for quick response.

Will start soon PCR type pre-positioning of quick response unit vehicles (207 types) in Odisha cities to attend inaccessible/ narrow approach roads like unit 1,2,4 etc of Bhubaneswar, Chhatra Bazar of Cuttack etc promptly, said SK Upadhyay, DGP, Fire Services.

Bigger vehicles face problems due to constricted access. So, on such routes, the small vehicles can quickly respond. Initially, one unit will be deployed during evening hours from 6 pm to 9:30 PM, Mr. Upadhyay said. It is part of public outreach to provide effective public service under Mo Sarkar and 5T mandate. Such service has been rolled out in Mumbai, but new in Odisha, informed the DGP Fire Services.

"We will be putting five units exclusively for Kalpana and Secretariat Fire Stations. Similarly, five other units will be deployed in Cuttack city," he added.

According to sources, the quick response multi-purpose vehicles will be fitted with modern fire-fighting equipment including a water mist fire fighting system and with various rescue equipment, a hose reel of 30 meters, breathing apparatus sets and a foam tank.

These vehicles will be stationed at mini fire stations for a quick response especially in case of fire reported in slums or congested

New Delhi/Washington (KCN): Prime Minister Narendra Modi will participate in the four-nation India-Israel-US-UAE (I2U2) virtual summit to be held on Thursday, New Delhi announced on Tuesday. He will participate in the summit along with US President Joe Biden, Israel's new Prime Minister Yair Lapid and UAE President Sheikh Mohamed bin Zayed Al Nahyan.

President Biden will be hosting the first-ever I2U2 summit during his visit to Israel later this week, which begins on Wednesday. "I2" stands for India and Israel, while "U2" stands for the United States and the UAE. During his Middle East trip, Mr Biden will also visit Saudi Arabia.

The four leaders will discuss "joint investments in six mutually identified areas such as water, energy, transportation, space, health, and food security", and the group "intends to mobilise private sector capital and expertise to help modernise the infrastructure, low carbon development pathways for our industries, improve public health and promote the



development of critical emerging and green

technologies", the MEA said.

Briefing reporters in Washington on Monday night, US national security adviser Jake Sullivan said the summit will focus on food security and the global food and energy crisis arising out of the Ukraine conflict.

Earlier, on Sunday, US secretary of state Antony Blinken had said that Russia's aggression in Ukraine has impacted the entire world, including probably in Sri Lanka. "I think we are seeing that impact around the world, and it may be one of the contributing factors to what's happened in Sri Lanka, although I think there were, as I've just said, many others that have come together." 





about a 25-year-old Just 'normal' to exclude women in decision making process: Adil Hussain

MUMBAI(KCN): Actor Adil Hussain has offered support to the growing group of female artistes who are asking the reason for women's absence from the Bollywood delegation of producers and actors that recently met Prime Minister Narendra Modi to discuss issues faced by the film indus-

On Tuesday, an 18-member panel, including Akshay Kumar, Karan Johar, Ajay Devgn, Siddharth Roy Kapur, Ritesh Sidhwani and CBFC chief Prasoon Joshi, met Modi to discuss how to take the entertainment industry to the next stage.

The meeting of the delegation came under fire on Wednesday for its exclusion of female representation with some activists and filmmakers pointing out that it was 2018 and asking, "Where are the women?" Adil took to Twitter to criticise the panel that met the prime minister, saying it has become the habit to exclude women from the decision making process.

National budgets need to take Gender into account

Gender budgeting is a public finance management tool in which governments analyse fiscal policy in terms of its differing effects on men and women. Gender budgeting identifies policies that are unequal as well as



opportunities to spend money on helping women and which have a high return.

Designing fiscal policies to support gender equality is good for growth. Many country

governments pride itself on pursuing policies that promote gender equality. However, they fail to live up to its word. The government does not set out to discriminate. Rather, it overlooks its own bias because it does not take the trouble to assess how policies affect women. Government budgets are supposed to be "gender-neutral"; in fact they are genderignorant.

In poorer countries, the bias can be more explicit. When Uganda first looked at its budget through a gender lens, it discovered that little of the spending on agriculture was going to support women farmers, though they did most of the work.

What may sound simply like feminism infiltrating fiscal policy is thus also about efficiency. Gender budgeting is good budgeting, argues Janet Stotsky, who led an IMF survey of such efforts around the world. You don't have to be a feminist to accept that investing in girls' education or in women's labour-force participation will generate a high return on investment.

Such a utilitarian approach appeals to finance ministries in a way that pious talk of "women's empowerment" may not. Ministries can fail to grasp how their budgets affect women and girls. In developing countries, for instance, investment in clean water and electricity eases housework, freeing time for mothers to earn money and for girls to go to school. Cutting funding may save money in the short

term, but when women spend their days fetching water, growth suffers.

There are plenty of examples of the idea in action. In Rwanda spending aimed at keeping girls in school—such as providing basic sanitation—has led to higher enrolment. In India the use of gender budgeting in a state is a better indicator of girls' school attendance than higher incomes. In South Korea a lack of child care has forced women to choose between work and family.

Both female labour-force participation and fertility rates are low—a poor formula for growth in an ageing country. Gender budgeting helped the government design programmes to reduce the burden of care on women. Around the world, safer transport systems can ease the vast, often unseen, burden of violence against women and girls—in medical costs, and lost productivity and labour, as they are prevented from working or learning.

Gender budgeting has won the backing of international financial institutions. Diana Elson once took the IMF and the World Bank to task for their bias, arguing that austerity forced on countries seeking funds in the 1980s imposed heavy burdens on women. Now the World Bank backs gender budgeting. The IMF used not to see promoting sexual equality as its job, but Christine Lagarde, its managing director, now wants gender-budgeting to play a role in the advice it gives to member countries.

Not everything has gone well for gender budgeting, however. Some initiatives have proved half-hearted, short-lived or prey to party politics. Egypt introduced the concept in 2009, encouraged by international donors; when the donors left, it petered out. Australia was the first country to have gender budgeting. But today's conservative government saw it as left-leaning and anti-austerity and dropped it in 2014, the year after it took office.

Other countries have issued sexual-equality statements and begun tracking data, but have not changed budget allocations. Much of their

It is easy to be cynical about government—and rarely does such cynicism go unrewarded. Take, for instance, policy towards women. Some politicians declare that they value women's unique role, which can be shorthand for keeping married women at home looking after the kids. Others create whole ministries devoted to policies for women, which can be a device for parking women's issues on the periphery of policy where they cannot do any harm. Still others, who may actually mean what they say, pass laws giving women equal opportunities to men. Yet decreeing an end to discrimination is very different from bringing it about.

Amid this tangle of evasion, half-promises and wishful thinking, some policymakers have embraced a technique called gender budgeting. It not only promises to do a lot of good for women, but carries a lesson for advocates of any cause: the way to a government's heart is through its pocket.

At its simplest, gender budgeting sets out to quantify how policies affect women and men differently (see article). That seemingly trivial step converts exhortation about treating women fairly into the coin of government: costs and benefits, and investments and returns. You don't have to be a feminist to recognise, as Austria did, that the numbers show how lowering income tax on second earners will encourage women to join the labour force, boosting growth and tax revenues. Or that cuts to programmes designed to reduce domestic violence would be a false economy, because they would cost so much in medical treatment and lost

workdays.

As well as identifying opportunities and errors, gender budgeting brings women's issues right to the heart of government, the ministry of finance. Governments routinely bat away sensible policies that lack a champion when the money is handed out. But if judgments about what makes sense for women (and the general good) are being formed within the finance ministry itself, then the battle is half-won.

Gender budgeting is not new. Feminist economists have argued for it since the 1980s. A few countries, such as Australia and South Africa, took it up, though efforts waxed and waned with shifts in political leadership—it is seen as left-wing and anti-austerity. The Nordic countries were pioneers in the West; Sweden, with its self-declared "feminist government", may be the gold standard. Now, egged on by the World Bank, the UN and the IMF, more governments are taking an interest. They should sign on as the results are worth having.

Partly because South Korea invested little in social care, women had to choose between having children, which lowers labour-force participation, or remaining childless, which reduces the country's fertility rate. Gender budgeting showed how, with an ageing population, the country gained from spending on care. Rwanda found that investment in clean water not only curbed disease but also freed up girls, who used to fetch the stuff, to go to school. Ample research confirms that leaving half a country's people behind is bad for growth. Violence against women; failing to educate girls properly; unequal pay and access to jobs: all take an economic toll.

Inevitably there are difficulties. Dividing a policy's costs and benefits between men and women can be hard. Sometimes, as with lost hours of school, the costs have to be estimated. Redesigning the budgeting process upends decades of practice. If every group pressing for change took the same approach, it would become unmanageable. In a way, though, that is the point. Governments find it easy to pay lip-service to women's rights. Doing something demands tough choices.

Presidential Election in India-A Celebration

In the upcoming presidential election in India, Draupadi Murmu, a candidate for the ruling Bharatiya Janata Party, will face



Yashwant Sinha, a candidate for the opposition. As the BJP and its allies have the numbers to put Murmu in the lead, she is predicted to win the race. The Indian C on stitution requires, in Article 62(1), that "an

election to fill a vacancy caused by the end of the term of office of President shall be completed before the expiration of the term." The term of current President Ram Nath Kovind expires on July 25. On July 18, a presidential election will take place. On that day, an electoral college made up of elected members of both houses of parliament and legislatures from every state and union territory in India will cast their votes. The results of the election will be announced on July 21, and the 15th president of India will take office on July 25.

The opposition parties and the ruling party have been in frenzied negotiations over who they will put up as candidates in the election in recent weeks. Three seasoned lawmakers made up the opposition's list: Sharad Pawar, the leader of the Nationalist Congress Party; Farooq Abdullah, the former chief minister of Jammu and Kashmir; and Gopalkrishna Gandhi, the former governor of West Bengal. All three chose to withdraw from the contest, and

Sinha, a former BJP leader who has previously held the

finance and external affairs positions, was chosen as the opposition's candidate. Murmu, the candidate chosen by the BJP-led coalition, is a member of the Santhal tribe. As a former governor of the state of Jharkhand, she has opposed laws that were unjust to tribal groups. The BJP lost control of Jharkhand as Murmu's term as governor came to an end in 2017.

Analysts believe Murmu will triumph handily. The BJP is anticipated to receive support from its regional allies, including the Biju Janata Dal, All India Anna Dravida Munnetra Kazhagam, and the Yuvajana Shramika Rythu Congress Party in the presidential election, in addition to its significant presence in the national parliament and state legislatures. Contrary to the BJP-led coalition, which firmly supports Murmu, sources in the Congress Party informed The Diplomat that Sinha's candidacy for president is not well-liked among many members of the opposition Congress-led United Progressive Alliance. India is preparing for the first time to have a tribal woman as its president.

Murmu will have a lot of difficulties in his role as president. Will she ultimately acquiesce in silence to every law and policy the Narendra Modi administration sends her way? India's social structure and democracy are in ruins. Will she criticise the government if it doesn't uphold the values outlined in the constitution? Will she, most importantly, stand out against companies' wrongful and unlawful seizure of native land? At this point, it appears doubtful.

BEIJING: While China has so far maintained a conspicuous silence on the dramatic fall of Sri Lanka's pro-Beijing Rajapaksa brothers, experts have warned that the current chaos in Colombo will have a "big impact" on the country's close ties and its large-scale infrastructure investments in the strategically located island nation in the Indian Ocean.

President Gotabaya Rajapaksa fled the country on a military jet, days after demonstrators overran his residence He had pledged to stand down on Wednesday amid mass protests over the island's worst economic crisis.

For months people have been struggling with daily power cuts and shortages of basics like fuel, food and medicines.

"In the short run, there will be a big impact on China's relations with Sri Lanka because the influence of the Rajapaksa family in Sri Lanka's political circles will be undermined and a political comeback will be unlikely in the near future," Lin Minwang, a South Asia expert at Fudan University in Shanghai said as quoted by Hong Kong-based South China Morning Post on Tuesday.

While President Gotabaya fled the country

Mahinda Rajapaksa is a much-liked Sri Lankan leader in China for promoting large scale Chinese investments in the island nation, disregarding India's security concerns and the US criticism and warnings over Beijing's "debt-trap diplomacy" in the strategically important country in the Indian Ocean. China has so far maintained a conspicuous silence on the fall of the powerful Rajapaksa clan, considered to be the main backers of Chinese investment in the country, which is now facing its worst economic crisis since independence in 1948.

Windfall tax on crude oil: Govt rakes in Rs 1.3 lakh crore; here's what brokerages say

NEW DELHI: The windfall taxes imposed by the government on domestic crude oil production and fuel exports will hit ONGC's earnings severely while shaving off up to USD 12 per barrel in refining margins for Reliance Industries Ltd.

The new levies will give the government up to Rs 1.3 lakh crore additional revenue, brokerages said.

In a surprise move, the government on July 1 increased import duties on gold (by 5 per cent), added export duties on petrol and ATF (Rs 6/litre; USD 12 per barrel) and diesel (Rs 13/liter; USD 26/bbl) and slapped a windfall tax on domestic crude production (Rs 23,250 per tonne; USD 40/bbl).

inflation, a higher tax on gold should decrease imports and help the external balance mar-

"Yet, Friday's (July 1) measures will serve squarely to raise revenue for the government." Duties on crude oil should raise an additional USD 3-4 billion (net of lower royalties, income taxes and dividends) while the gold duty can raise USD 1.5-2 billion annualized.

Export taxes on diesel/petrol can raise close to USD 9 billion gross per annum, it said adding the revenue for current fiscal will be 75 per cent of these numbers.

"The government intent appears to be to maximise revenues from upstream producers by capping their upside from higher oil



This follows earlier duties imposed on steel (15 per cent) and iron ore (up 20-45 per cent).

While the export tax will be applicable on only-for-exports refinery of Reliance Industries (RIL), the restriction on product exports wherein at least 30-50 per cent is first supplied domestically will not apply to SEZ units. HSBC Global Research in a note said in May 2022, the government announced a cut in the excise duty of Rs 8 per litre on petrol and Rs 6 a litre on diesel, which is estimated to have reduced its revenues by Rs 1 lakh crore. "The additional excise duty just announced and effective from July 1, 2022 aims to fill this revenue gap. We estimate these taxes could generate Rs 1.2 lakh crore in government revenue and could also discourage the export of products which are being diverted away from the domestic market."

The windfall tax on crude production could generate revenue of Rs 65.600 crore and tax on export products another Rs 52,700 crore if they were to be continued for the full year. Kotak Institutional Equities said the taxes will result in additional tax revenues of Rs 1.3 lakh crore on an annualized basis and Rs 1 lakh crore for the rest of FY2023 assuming the government retains the taxes for the entire

UBS estimated that the government can raise Rs 1.38 lakh crore annually from additional taxes. "Based on diesel and gasoline export volumes in past year and estimate for FY23, we estimate additional revenues of Rs 68,000 crore on three transportation fuels. Similarly, windfall taxes on crude can raise Rs 70,000 crore in additional revenues."

Nomura said the windfall taxes could potentially impact RIL's GRM by USD 12 per barrel (Rs 47,000 crore on an annualised basis). Goldman Sachs said it saw limited earnings risk for RIL (despite wide scenarios of USD 1.5-12.7 risk to gross refining margins or GRMs from new taxes) as the spot implied GRM run rate is over USD 27 per barrel.

HSBC said while the new tax will lower ONGC earnings by Rs 30 per share, its impact on RIL would be Rs 36 a share.

"We continue to believe the loss on its domestic marketing margin is still greater than the export tax, and thus, we believe RIL is likely to continue to export significant amounts," HSBC said.

JP Morgan said while the duties on steel/iron ore helped reduce domestic prices and curb prices as well as disincentivising refined product exports by private refiners to ensure domestic fuel availability isn't compromised," Citi said in a note.

The USD 40 per barrel windfall tax is "a material negative for ONGC in particular where earnings are likely to be severely impacted," it said.

On the top of the new levy, ONGC will continue to pay oil 20 per cent (a fifth of the oil price) as OIDB cess and another 10-20 per cent royalty.

The net realisation for ONGC will be around 40 per cent of the oil price.

The gross refining margin (GRM) impact for RIL assuming two-thirds of its diesel, petrol and ATF were being exported, could be USD 9-10 per barrel, Citi said adding the firm must be currently earning USD 25 per barrel GRM. "The earnings impact for RIL is likely to be less material given offsets from marking-tomarket for current GRM strength, which would likely preclude earnings upgrades rather than drive major downgrades.'

Kotak said it does not "see much merit in the government's decision to impose export duties on exports from RIL's SEZ refinery. The government has cited increased exports of diesel and gasoline and lower availability of such products for the domestic market as a key reason to impose the exports tax. However, RIL's SEZ refinery was set up for exports and its products were not intended for sale in the domestic market."

It said demand-supply analysis of petroleum products shows that there is enough availability of diesel and petrol for the domestic market even excluding volumes from RIL's SEZ refinery.

Haitong said India's total diesel demand is 80-83 million tonnes while the total PSU diesel supply is 65-68 million tonnes.

"Therefore, the rest can be met by private players like RIL and Nayara Energy. Similarly, total consumption of petrol in India stands at 30-31 million tonnes while PSUs supply is 21-22 million tonnes. Therefore, one-third of India's consumption can be fulfilled through private players."

According to CLSA, RIL's GRMs may be hit by USD 5-6 per barrel due to the new tax. It said the new taxes would give the government extra annual revenue of Rs 1.1 lakh crore (\$14 billion), negating the Rs 97,000 crore revenue loss from the excise duty cut done about six weeks ago.

Credit Suisse said the impact on RIL from cess on the export of petroleum products is about USD 7-8 per barrel, translating to an annualized impact of USD 3.5-4.0 billion on

The guy is a genius but needs advice from Freud: McEnroe on Kyrgios

Three-time Wimbledon champion John McEnroe said Tuesday that controversial Australian Nick Kyrgios "needs Sigmund Freud" to sort out the "demons" in his game. Kyrgios carved a sometimes thrilling, often controversial path to the final at the All England Club where he lost in four sets on Sunday to Novak Djokovic.

A series of outbursts saw the 27-year-old fined and he was described as "evil" and "a bully" by third round opponent Stefanos Tsitsipas. But there was some

impressive and inventive hitting, not least in the final, where he clattered 30 aces and 62 winners in total.

"The guy is a genius out there the way he plays," McEnroe told the BBC, adding that Kyrgios needed some advice from the father of psychoanalysis.

"He needs Sigmund Freud to come out of the grave and somehow figure out a way to keep this guy going for a couple of years because we could use him."

"It's unbelievable, he moves the needle for us in tennis. We need this big time but we don't need him to try half the time."

Off court the world number 45, who has admitted to 'tanking' during matches, also faces a court hearing in Canberra next month in relation to an allegation of common assault. 'Demons'

"He's a good kid, the players like him, he's well liked in the locker room, he does a lot of charity work," said McEnroe in mitigation. "But he's got demons you know, in a way -- we all have this fear of failure and it's a question of how you best deal with it."

McEnroe, a seven-time Grand Slam winner, was himself no stranger to controversy in his career, often lapsing into pantomime histrionics on court in a bid to raise his own game. "I would say I'm proud of most of what I did but there are certainly times where I'm like,

> 'I didn't need to do that" said McEnroe. "It only exacerbated the situation and made more people get mad at me or start booing me so it wasn't like it helped

"It may be at times you blow off some steam. Obviously, you see Kyrgios doing that all the time."

The Australian was handed a code violation in Sunday's final during which he also volubly demanded the removal of a spectator who he claimed was drunk and launched a foulmouthed tirade at his own box.

"How do you think his box feels when he's screaming at them? Those are the people that love him most, right?" said McEnroe.

"Unfortunately, the people that you love most you take it out on, because you feel closest to them. I think we can all relate to that. But if it wasn't so sad it would be funny in a way. "So that part, hopefully he would look at and go, 'I don't need to do that to my dad or my girlfriend'.

"You know he's sitting there and he's obviously tortured in certain ways. (He's) unbelievably talented, very smart... a hell of a player when he wants to be."

"Everyone knows their job and after playing so much of cricket, if you come with a question mark in your mind, then I believe it's not good."

It was also a milestone match for Shami who became the fastest Indian and third fastest bowler overall to take 150 scalps in ODI cricket.

"It's extremely important to come with a clear mind as you already know what you need to do, where you need to pitch the ball, the variations in white-ball and everyone knows these

"But you need to be courageous from heart and if you are that, then you can get set in any format at any given moment."

While Shami claimed three wickets, fellow pacer Jasprit Bumrah finished with a careerbest 6 for 19 to blow away hosts England in the first ODI.

"As soon as we started, the ball was stopping and seaming, it became important for us to pick our areas and keep line and length in con-

"We played our best performance (in first ODI); like, the way a series has to be started, it set an example."

Shami said the key was to keep things simple and put pressure on the batters from both

"The only thing to be kept in mind was if the area will be great on a pitch where it swings and seams, you bowl with great pace from both ends and makes life difficult for (batting teams) on a wicket like this.

"We kept things simple, got to fetch wickets quickly and result is there for all to see." Shami feels not much needs to be changed if the conditions remain the same in the next two games.

"Personally speaking, reverting back to keep it simple theory will be the best. If the wicket behaves a little differently, then you need to think a bit more," he said.

"If you take the confidence from here to rest of matches, then the chances are there for being more successful.

"But if the wicket is dry or slow, then the plans can be changed. But to carry confidence from here is very important."

India lead the three-match series 1-0.
