Reportedly, if Marvel loses, Disney would have to share ownership of characters worth bilLarry Lieber's (who worked at Marvel as a writer, too) estate. In August, the administrator of Ditko's estate filed a notice of termination on Spider-Man, which first appeared in comic book form in 1962. Under the

heirs can reclaim rights once granted to publishers after waiting a statutory set period of time. According to the termination notice, Marvel would have to give up Ditko's rights to its iconic character in June 2023, reported The

Hollywood Reporter. Larry also filed termination notices to Marvel in May.

The heirs of the comic book creators (including Black Widow creator Don Rico) are being represented by Marc Toberoff, who had also represented Superman creators Jerry Siegel and Joe Schuster in an unsuccessful termination attempt against DC which saved off termination by counterclaiming against Toberoff.

As per The Hollywood Reporter, Dan Petrocelli represented the publisher at that time and will be representing Disney for the new case.

Petrocelli has already filed several lawsuits against Lieber, Don Heck, foreign exploitation.

She even engaged a female priest for her wedding to emphasise gender equality.

The bride, pretty, radiant and in red, sits in front of the sacred fire, her family, the groom and his parents around her, the love flowing like a balmy breeze.

And in that arguably most precious moment, she looks into the camera and asks, "why must a woman be commodified through the custom of 'kanyadaan? literally 'donating a daughter."

The ad for a lehenga brand featuring Bollywood star Alia Bhatt as the much-indulged daughter and granddaughter has fired debate on social media platforms and elsewhere on the age-old tradition of giving away the daughter. Many term it Hindu pho-

bic for casting aspersions on a ritual that is part of the warp and weft of society, others appreciate it for calling out the patriarchy that underscores the custom and there are those that feel it should have gone even further in its rejection. "There is a growing number of young women who are beginning to think about the issue, especially as increasing number joins

> the workforce, has access to ideas (via social media etc) that are critical of 'women as property' concept. This ad reflects that," sociologist Sanjay Srivastava told PTI.

> In the 1.41 minute ad, Bhatt, the self-assured woman of today who also does a selfie pout with her father while at the 'mandap', recalls her lifetime of 'othering' in a monologue - her fond grandmother saying she would one day go to her own home, her father not reacting when people called her "paraya dhan" (alien property) and her mother calling her a 'chidiya' which would fly away one day.

> The Manyawar ad ends with the grooms' parent also joining in in the ritual (though it is unclear whether they too are giving away their son) and Bhatt's bride saying it should be 'kanyamaan' (respect for the girl child) and not 'kanyadaan', and asking, "Am I a thing to be given away?" Her angst finds a wide echo. Actor Dia Mirza, who decided to do away with the rituals of both "bidaai" and "kanyadaan" when she got married to businessman Vaibhav Rekhi, said they wanted the wedding to reflect their "beliefs and not outmoded ideas." "Neither of us believes that women are com

bassador from India.

The ritual of giving away the bride is, of course, not just about Hindu weddings.



It is also a vital part of a Christian wedding service where the father walks down the aisle with his daughter and "hands her over" to the waiting groom.

Brought up on tradition and a diet of popular culture, including movies, both Indian and western, many women have now begun to question the patriarchal traditions of wedding ceremonies across societies.

Mumbai-based IT analyst Meghna Trivedi, who got married in February last year, said the ritual of 'kanyadaan' does not make sense in today's day and age but had to undergo the ritual anyway.

Trivedi, a Gujarati who married a Punjabi, said she asked the priest to find another way but he maintained 'kanyadaan' is a "must".

"What you mean by 'kanyadaan' is that you're giving away your daughter to somebody else and that is something you have to do in your life and it's related to your duties as a parent that now your daughter belongs to another family," she told PTI.

"But I'm still my parents' daughter after I got married. 'Kanyadaan' is like you're giving me their rituals."

One of the Twitter users echoed similar sentiments.

> "Our traditions are not regressive, your mindsets surely are! Kanyadaan is a sacred tradition, where a father/ parent parts with their most precious and cherished daughter, a bittersweet emotional moment filled with hopes, promises and dreams,' the user wrote.

Women's rights activist Shabnam Hashmi said the attacks on the ad "reflects the highly patriarchal mindsets of our society".

"It is a very progressive advertisement and raises

important questions of women's dignity and equality," Hashmi told PTI.

Sociologist Shrivastava added that people reacted negatively because there is an increasing intolerance against anything that is seen to question 'Indian traditions'.

The reaction, he said, also reflects a "male anxiety" about the changes that are happening in addition to the current climate where it has become difficult to question anything Indian/Hindu.

There were also those who felt the ad didn't go far enough.

'The idea should not be to perpetuate the custom but to break away from it," said a young woman, who welcomed the ad and the questioning of traditions but would have preferred that it didn't end with the parents of both sides taking part in it.

A radical break would have been more effective in sending out the message, she said. However, a debate reflects a churn.

And in that sense, any discussion is welcome, even if it has unlikely beginnings in an ad for a bridal lehenga.

respect of which he is assessable within 12 months/ 24 months (as the case may be) from the end of the assessment year, as under:

- (i) Updated Return with 25% additional tax and interest – may be filed within 12 months from the end of the assessment year;
- (ii) Updated Return with 50% additional tax and interest – – may be filed within 24 months from the end of the assessment year.

Updated return cannot be filed in the undermentioned situations:

- a) if the updated return, is a return of a loss or has the effect of decreasing the total tax liability determined on the basis of return furnished under g) sec 139(1), 139(4) or 139(5). However where a loss return was previously filed under sec 139(1), an updated return of income can be filed, provided that such updated return is h) a return of income;
- b) results in refund or increases the refund due on the basis of return furnished under sec 139(1), 139(4) or 139(5);
- c) if search has been initiated under section 132 or books of account, other documents or any assets are

requisitioned under section 132A or

- if a survey has been conducted under section 133A, other than TDS survey under sec 133A(2A) or
- if a notice has been issued to the effect that any money, bullion, jewellery or valuable article or thing, seized or requisitioned under section 132 or j) section 132A in the case of any other person belongs to such person or
- if a notice has been issued to the effect that any books of account or documents, seized or requisitioned under section 132 or section 132A in the case of any other person, pertain or pertains to, or any other information contained therein, relate to, such person.
- The restriction in the case of search under sec 132 or requisition under 132A or survey under sec 133A, is for the assessment year relevant to the previous year in which such search is initiated or survey is conducted or requisition is made and any assessment years preceding such assessment year.
- Where an assessee has furnished an updated return under section 139(8A), he cannot again furnish an updated return for the same assessment year
- any proceeding for assessment or reassessment or recomputation or revision of income is pending or has been completed for the relevant asst. year;
- the AO has information in his possession under the Smugglers and Foreign Exchange Manipulators (Forfeiture of Property) Act, 1976,

or the Prohibition of Benami Property Transactions Act,

1988, or Prevention of Money Laundering Act, 2002 or the Black Money (Undisclosed Foreign Income and Assets) and Imposition of Tax Act, 2015 or and the same has been communicated to the assessee

- information for the relevant assessment has been received under an agreement referred to in sections 90 or 90A of the Act in respect of the assessee and the same has been communicated to him prior to the date of furnishing of return under sec. 139(8A);
- k) any prosecution proceedings have been initiated under Income tax Act
- if he is a person or belongs to a class of persons, as maybe notified by the Board in this regard.

If an updated return filed for any assessment year results in reduction of carried forward loss or unabsorbed depreciation or reduction of MAT credit or AMT credit for subsequent tax years, assessee is required to file an updated return for all such subsequent assessment years.

The updated return under sec 139(8A) must be accompanied by the proof of payment of tax under sec 140B, otherwise the updated return will be defective.

Where no return of income under sec. 139(1) or sec 139(4) has been furnished by an assessee, tax on the updated return of income will be computed after adding interest/fee under sec 234A, 234B, 234C, 234F along with applicable surcharge and health and education cess. From the figure so arrived, TDS, TCS, advance tax, Relief under sec. 89, sec. 90, sec. 90A and sec.

91, tax credit under sec. 115JAA or 115JD shall be reduced.

Where the assessee has furnished Return under sec. 139(1), sec. 139(4) or 139(5), the tax, interest, fee, surcharge and cess will be computed and the same shall be reduced by TDS, TCS, advance tax, self assessment tax, relief under sec 89, sec 90, sec 90A and sec 91, tax credit under sec 115JAA or 115JD shall be reduced.

Additional payment of 25% of tax, interest, surcharge and cess shall be payable if the updated return is furnished within 12 months from the end of the asst. year and in case updated return is furnished after 12 months from the end of the asst. year, additional payment of 50% of tax, interest, surcharge and cess shall be payable.

For computing interest under sec. 234B, the assessed tax will be determined on the basis of income in the updated return. Where the assessee has furnished the return of income, the computation of interest under sec. 234C shall be made on the basis of income in the updated return.

The updated return, furnished under section 139(8A) shall be accompanied by proof of payment of such tax, additional tax, interest and fee. The assessee shall get immunity from prosecution under sec. 276CC with respect to the income offered in updated return An assessment is to be completed within 9 months from the end of financial year in which the updated return is furnished – sec. 153(1A)

The taxpayers are advised to furnish updated return in appropriate case where the date for furnishing revised return has elapsed.

The World Investment Report 2022 shows



that the structure of global foreign direct investment (FDI) flows has been affected significantly by the pandemic. The report brought out by the United Nations Conference on Trade and Development (UNCTAD) indicates

that global FDI inflows staged a smart recovery in 2021 rising by a substantial 64.3% to touch \$1.58 trillion, thus surpassing the pre-pandemic flows. This is in sharp contrast to the 35% fall in FDI inflows to \$963 billion in 2020.

A major consequence of the pandemic was

that the share of FDI inflows to developed economies slipped to just around one-third in 2020, the lowest recorded. Though the FDI inflows to developed economies more than doubled to \$746 billion in 2021, its share in global FDI inflows still remained lower than that of the developing economies. A major reason for the shrinking share of developed economies in global FDI inflows is the decline of inflows into the European Union (EU) for two consecutive years, which reduced its share in global FDI inflows from around a quarter to less than a tenth.

Another major consequence of the pandemic was that FDI outflows from developed countries rose sharply from around twothirds of the global outflows in the prepandemic years to around three-fourths in 2021. This surge was mainly powered by the United States (US), which now emerged as the largest source of FDIs. The US now accounts for close to a quarter of global FDI outflows, marginally exceeding even that of the EU. Another major change noticed after the pandemic was that, for the first time, in many years, the global outflows of FDI from almost all major developed countries were higher than their FDI inflows. Similarly, another major fallout of the pandemic was that the developing countries have now become the dominant beneficiaries of global FDI inflows with its share exceeding that of developed countries both in 2020 and 2021. However, the pickup in FDI inflows to developing economies was sharply skewed. While FDI inflows to Africa more than doubled to \$82.9 billion in 2021 and that to South America surged by threefourths to \$88 billion, both flows probably buoyed up by the global commodity boom.

However, FDI inflows into Asia barely grew by around one-fifth.

And this was also highly skewed. While inflows increased by around half in South East Asia and West Asia, it declined by a quarter in South Asia.

What is surprising is that the disruption of supply chains and the setback to globalisation during the pandemic seems to have had no significant impact on the geographical distribution of FDI inflows. Though many developed countries repeatedly promised to reduce the global dependence on China's exports and ward off trade vulnerabilities by diverting investments to other areas, these initiatives seem to have floundered. In fact, the trends show that the result has been the opposite with FDI inflows to China accelerating even as FDI inflows to other developing countries like India falter badly. Consequently, between 2019 and 2021, the share of FDI inflows to China (including that to Hong Kong) went up from 14.5% to 20.3%, while that to India shrunk from 3.4% to 2.8%. Certainly, India seems to have failed to take advantage of the new opportunities offered by the pandemic. The efforts to persuade the world to bring in increasingly larger share of the FDI flows within its shores and diversify the global supply chains have apparently not borne fruit. Similarly, the slowdown in the economy has also affected FDI outflows from India with its share in global FDI outflows slumping down to 2.8%, the lowest level across the last four years.

The Government of India data on the FDI show that equity inflows have declined by around one-fifth to \$51.3 billion in 2021. However, the decline was not uniform. While FDI inflows from Mauritius, the largest contributor to the cumulative FDI inflows into India, more than doubled to \$8.7 billion in 2021, that from Germany and Japan increased by around a quarter. However, FDI inflows from almost all other major investor nations declined. While FDI from Singapore, the US, the Netherlands, and United Arab Emirates fell by more than a quarter, that from the United Kingdom and Cayman Islands fell by around one-fifth.

However, the bulk of decline in FDI flows in 2021 was due to the fall in investments in the computer software and hardware, the biggest segment, which fell by half to \$12 billion. Similarly, FDI inflows into infrastructure and construction sectors also declined by half. Surprisingly, FDI inflows to services (that include finance, banking, insurance, research and development, and others), which account for more than a tenth of the total FDI inflows, rose by a quarter to touch \$6.5 billion in 2021. In manufacturing, the improvement in FDI inflows was largely confined to automobiles, drugs and pharmaceuticals. Clearly, India still has a long way to go to emerge as a manufacturing hub in the global economy.

The steady decline of FDI outflows from the EU is a major setback for India, more so because India has failed to tap the potential for increasing inflows from the US, which has emerged as the largest source of FDI outflows. The consequent slump in the share of FDI inflows into India should set alarm bells ringing in the government. Certainly, it is still not too late to woo new investments to reduce global supply chain vulnerabilities and the excessive dependence on China.

Existing supply chain for storage and transport of COVID19 vaccines was leveraged and strengthened and effective monitoring of vaccine distribution and assured availability and efficient utilization of vaccines and syringes was ensured at all times.

India's free and voluntary nationwide COVID19 vaccination exercise is also being carried out in a citizen friendly approach through initiatives like Har Ghar Dastak, Workplace CVČ, School based vaccination, vaccination of persons with no identity documents, Near-to-Home CVC and Mobile Vaccination Teams. With 71% of CVCs located in rural areas and over 51% of vaccine doses administered to women, India's National COVID19 Vaccination Programme also ensured geographical and gender equity.

Despite the decline in COVID cases across the country, consistent efforts were ongoing to vaccinate all eligible citizens. India surpass 200 CR Vax Milestone

Bhubaneswar: It is said that Mahaprabhu Jagannath runs this Utkal state, not the ministers and the bureaucrats. The state that was struggling to pay salaries to its employees in 2000, is now flush with funds. And now our political leaders and policymakers take credit as the state overcomes major financial hurdles. However, all this is due to the 'money rain' Odisha received during FY2021-22 with massive revenue of Rs 48,642 crore from the mining sector alone. This was beyond the imagination of our financial experts or economists engaged in the budget making process. Interestingly, our experts had set a target of mining revenue collection to the tune of Rs 13,700 crore only for the 2021-22 fiscal, which is less than actual mineral revenue of Rs 13,792 crore, earned in the previous year.

This high earning from the mining sector is being celebrated across the state. Odisha bagged first prize in Category-I & second prize in Category-II There is also a possibility of uncertainty around share in central taxes. A fall in economic activity reduces national tax collection which results in lower central transfer share to state. The 15th Finance Commission has recommended reduction in state share from earlier 42 percent to 41 percent owing to bifurcation of the Jammu & Kashmir into two union territories. The share of Odisha has reduced from 4.64 per cent to 4.53 per cent for the 15th Finance Commission award period which is from 2021-22 to 2025-26. The FC had recommended a share of Odisha for 2020-21, pandemic year, at 4.63 per cent as per the interim report. However, the actual release was much lower. The difference was almost 30 per cent. However, there was a higher release in 2021-22 due to higher GST collection.

All of us know that Odisha is prone to frequent natural calamities like cyclones and floods. Between

under Rastriya Khanij Vikas Puraskar of the Ministry of Mines. It is indeed good news for our mineral rich state which despite its huge mineral treasure remained neglected. Thanks to the officials, laborers, workers and staff engaged in the mines sector the state is reaping benefits.

However, it is surprising that our financial experts could not anticipate that Odisha is going to make such a huge gain in a year. When the so-called experts fail to anticipate gains to be made, how can they fathom the losses in store for the future? Unless we have better planning, calculation and estimation, the state may earn a benefit "by chance", but cannot sustain the loss in store. The job of the expert is to see things which are not visible or anticipated by the common man.

This time for the 2022-23 fiscal, the government has set the target of Rs 43,444 crore revenue collections from the mining sector. This is Rs 5,000 crore less than the revenue generated in the 2021-22. This is done keeping in view the volatility in mining revenue generation. Mining Revenue constitutes about 6 per cent of the GSDP, 26 per cent of total revenue receipt, 90 per cent of the state's own tax and 46 per cent of state's own revenue. If there is a fall in mining revenue, it will have a direct impact on the state's annual budget. Since mining revenue is sensitive to demand and price of metal in the national and international market, there is risk associated with the mining revenue.

The state's mining revenue is likely to suffer as the centre has raised duty on export of minerals. Large quantities of iron ores are exported from Odisha. Natural disasters, volatile nature of mining revenue, GST, Odisha's share in central taxes and electricity sector are the major risks for the economy. During the 2021-22 fiscal, the mining revenue produced a positive shock. Since volatility in metal price directly affects the mining revenue, the risk associated on this account will substantially increase in future due to higher exposure.

The state was assured of compensation for the loss incurred on account of GST implementation till June, 2022. But due to pandemic, the cess collection in the GST Compensation Fund has been low. Now there is no GST compensation regime, so there will be a fiscal shock to the extent of about 1 percent of the GSDP for the state, which could be around Rs 6,000 crore. Therefore, one has to be very cautious while dealing with this aspect of the economy.



2014 and 2021, the state has sustained a direct loss of more than Rs 24,000 crore. Keeping in view the fast climate change, such calamities will certainly make regular visits to the state and one must remain prepared for this also.

The state public sector undertakings are also a major worry for the state as Odisha has invested more than Rs.21.000 crore in them. The SPSUs have incurred a loan of more than Rs 6,000 crore where the government is a guarantor. Though the PSUs will pay back the debts, the state has moral responsibility to the lenders. Therefore, efforts must be made to revive the loss making PSUs, not just by pumping more money, but also by putting in place a robust management. While private sector undertakings make wonders, why not the state PSUs? It is high time to fix accountability on the PSU management.

The total outstanding public debt of Odisha in 2021-22 stands at Rs 1,00,813 crore which is 15.8 per cent of the GSDP. However, the composition of debt stock in the state has also witnessed a transition from some of the high cost borrowing sources such as National Small Saving Fund (NSSF) to low cost borrowing sources. The state has been taking short term loans at cheaper interest rates from funds set up for dedicated purposes like OMBADC and CAMPA. The state can borrow up to 60 percent of surplus funds available in these funds.

Therefore, it is high time that our experts and policy makers should do their homework and reorient their vision. They should make proper planning and estimation while anticipating risks and planning for their mitigation. Utmost care must be taken for the proper management of the state economy with a fail-safe framework for risk planning.

He said the opposition is doing so as it had nothing against the government and the leadership of Prime Minister Narendra Modi was "Actually there is no major issue against the government as it is functioning well under PM Modi's leadership and it is being hailed in may elections," he said.

Joshi said presiding officers in previous years also released such a list of unparliamentary words, but the Opposition did not raise it then. He said the words are expunged on the demands made in Parliament and the Chair takes the final call.

"No word has been barred from use in Parliament and the Lok Sabha Secretariat has been bringing out such a list of unparliamentary words since 1954," Joshi also said, adding that it is the Lok Sabha Secretariat and not

the government that brings out such a list. Similarly, he said a normal circular was issued by Rajya Sabha Secretariat on not holding any dharnas and protests in Parliament, but the Opposition raised it as if it is something new.

Such circulars are issued ahead of every session, he said. On criticism over the absence of the prime minister from the meeting, he said Congress leader Jairam Ramesh raised the issue.

"The prime minister never attended all-party meetings before 2014 when the Congress was in power."

"It was his good gesture to do this from 2014. They are trying to make an issue that is a nonissue. Our senior colleague Rajnath Singh and deputy leader of the house chaired the meeting," he said.

"We are open to discussion on all issues under the rules and procedures of parliament," Joshi said when asked about the opposition demand on the Agnipath scheme.

He also stated that the government would hold an all-party meeting on the Sri Lanka situation on Tuesday which will be chaired by Union ministers Nirmala Sitharaman and S Jaishankar.
