

day. Earlier, the Dam authorities have warned the people residing on the downstream and also the river side to remain alert of the flood water being released from Hirakud. The dam authorities released water through sluice gates for power generation, irrigation in the Hirakud command area for agriculture, local industries and for drinking water purposes, he added. The Chief Engineer said to maintain a perfect balance the inflow to the reservoir and the outflow cusecs. 75,000 cusecs water is being released into the river through the five gates.

There are 64 sluice gates including 24 on the right and 40 on the left side of the dam to release flood water. Each sluice gate has the capacity to discharge 16,440 cusec of water when reservoir level, also termed as danger level, is 630 ft. Besides, there are 34 crest gates, 13 on the right and 21 on the left side, which have the potential to discharge 16,238 cusec of water.

Zelenskiy announced the sacking of Ukraine's ambassadors to Germany, India, the Czech Republic, Norway and Hungary and said new candidates were being readied for the posi-

envoys would be assigned new positions. Zelenskiy has urged his diplomats to drum up international support

Kyiv's relations with Germany, which is heavily reliant on Russian energy supplies and also Europe's biggest economy, are particularly sensitive.

Andriy Melnyk, who was appointed by Zelenskiy's predecessor as ambassador to Germany in late 2014, is well known among politicians and diplomats in Berlin.

The 46-year-old regularly engages in outspoken social media exchanges and has branded politicians and intellectuals who oppose arming Ukraine to fight the Russian invasion as appeasers. **CONTINUED ON: P-7**

party leader Niranjan Patnaik. However, the AICC High Command has appointed Sarat Pattanayak as Congress State Chief.

Commenting on the cross voting made by Mr.Moquim, PCC President Mr. Pattanayak said, "We have informed our High Command. Acper the instruction of the AICC."

Congress Legislature Party leader Narasingha Mishra said the Party will take final call on this matter.

Congress MLATaraprasad Bahinipati said this cross voting Mr.Moquim proves

that he is not satis-

fied with the party's decision. This move has also raised questions on the unity within the party, he added.

Another party MLA Santosh Singh Saluja said it is unfortunate and action will be taken by AICC.

Mr.Saluja said he should have voted for the opposition candidate as a disciplined member of the party. Meanwhile, Chief Minister Naveen Patnaik and many legislators have casted their votes in the ongoing President Poll here at Room No-54 of the Odisha Legislative Assembly.

# Uproar over GST Hike

Assembly on Monday witnessed uproarious scenes during 'Zero Hour' after the opposition Congress targeted the State Government over the Centre levying GST on puffed rice (Mudhi) and flattened rice (Chuda).

The Congress members urged the Speaker to allow a resolution to pass in the House demanding the withdrawal of the tax on food items. # Decline in FDI inflow for Indian Economy

The World Investment Report 2022 shows that the structure of global foreign direct investment (FDI) flows has been affected significantly by the pandemic. The report brought out by the United Nations Conference on Trade and Development (UNCTAD) indicates



h a global FDI inflows staged a smart recovery in 2021 bу rising substantial 64.3% to touch \$1.58 trillion, thus surpassing the pre-pandemic

flows. This is in sharp contrast to the 35% fall in FDI inflows to \$963 billion in 2020. A major consequence of the pandemic was that the share of FDI inflows to developed economies slipped to just around one-third in 2020, the lowest recorded. Though the FDI inflows to developed economies more than doubled to \$746 billion in 2021, its share in global FDI inflows still remained lower than that of the developing economies. A major reason for the shrinking share developed economies global FDI inflows is the decline of European into the Union (EU) for two consecutive years, which reduced its share in global FDI inflows from around a quarter to less than a tenth. Another major consequence of the pandemic was that FDI outflows from developed countries rose sharply from around two-thirds of the global outflows in the

2021. This surge was mainly powered by the United States (US), which now emerged as the largest source of FDIs. The US now accounts for close to a quarter of global FDI outflows, marginally exceeding even that of the EU. Another major change noticed after the pandemic was that, for the first time, in many years, the global outflows of FDI from almost all major developed countries were higher their FDI inflows. Similarly, another major fallout of the pandemic was that the developing countries have now become the dominant beneficiaries of global FDI inflows with its share exceeding that of developed countries both in 2020 and 2021. However, the pickup in FDI inflows to developing economies was sharply skewed. While FDI inflows to Africa more than doubled to \$82.9 billion in 2021 and that to South America surged by threefourths to \$88 billion, both flows probably buoyed up by the global commodity However, FDI inflows into Asia barely

grew by around one-fifth. And this was also highly skewed. While inflows increased by around half in South East Asia and West Asia, it declined by a quarter in South Asia.

What is surprising is that the disruption of supply chains and the setback to globalisation during the pandemic seems to have had no significant impact on the geographical distribution of FDI inflows. Though many

repeatedly promised to reduce the global dependence on China's exports and ward off trade vulnerabilities by diverting investments to other areas, these initiatives seem to have floundered. In fact, the trends show that the result has been the opposite with FDI inflows to China accelerating even as FDI inflows to other developing countries like India falter badly. Consequently, between 2019 and 2021, the share of FDI inflows to China (including that to Hong Kong) went up from 14.5% to 20.3%, while that to India shrunk from 3.4% to 2.8%. Certainly, India seems to have failed to take advantage of the new opportunities offered by the pandemic. The efforts to persuade the world to bring in increasingly larger share of the FDI flows within its shores and diversify the global supply chains have apparently not borne fruit. Similarly, the slowdown in the economy has also affected FDI outflows from India with its share in global FDI outflows slumping down to 2.8%, the lowest level across the last four years.

The Government of India data on the FDI show that equity inflows have declined by around one-fifth to \$51.3 billion in 2021. However, the decline was not uniform. While FDI inflows from Mauritius, the largest contributor to the cumulative FDI inflows into India, more than doubled to \$8.7 billion in 2021, that from Germany and Japan increased by around a quarter. However, FDI inflows from almost all other major investor nations declined.

While FDI from Singapore, the US, the Netherlands, and United Arab Emirates fell by more than a quarter, that from the United Kingdom and Cayman Islands fell by around one-fifth. However, the bulk of decline in FDI flows in 2021 was due to the fall in investments in the computer software and hardware, the biggest segment, which fell by half to \$12 billion. Similarly, FDI inflows into infrastructure and construction sectors declined bу half. Surprisingly, FDI inflows to services (that include finance, banking, insurance, research and development, and others), which account for more than a tenth of the total FDI inflows, rose by a quarter to touch \$6.5 billion in 2021. In manufacturing, the improvement in FDI inflows was largely confined to automobiles, drugs and pharmaceuticals. Clearly, India still has a long way to go to emerge as a manufacturing hub in the global economy.

The steady decline of FDI outflows from the EU is a major setback for India, more so because India has failed to tap the potential for increasing inflows from the US, which has emerged as the largest source of FDI outflows. The consequent slump in the share of FDI inflows into India should set alarm bells ringing in the government. Certainly, it is still not too late to woo new investments to reduce global supply chain vulnerabilities and the excessive dependence on China.

# Covid-19 Vaccination during Pregnancy — Two for the Price of One

The benefits of maternal vaccination to the infant through maternal antibody transfer across the placenta have long been recognized. In the 1870s, babies born to mothers who had received smallpox vaccination were unlikely to have smallpox early in life.1 Tetanus toxoid vaccination during pregnancy, along with improved hygiene during delivery, has resulted in substantially reduced rates of neonatal tetanus in some developing countries. 1 Decreased risks of influenza and pertussis have been reported during the first few months of life among infants whose mothers had received the inactivated influenza vaccine and the combined tetanus-diphtheria-acellular pertussis (Tdap) vaccine, respectively. Both vaccines are routinely recommended during pregnancy in the United States; the influenza vaccine is recommended anytime during pregnancy, whereas the Tdap vaccine is recommended preferentially during the early part of gestational weeks 27 to 36 in order to maximize maternal antibody production, placental transfer, and antibody levels in the newborn.2 Studies to evaluate whether maternal vaccination could prevent illness from other infections (e.g., respiratory syncytial virus infection or group B streptococcus infection) among infants are underway.1

At the time of authorization of the coronavirus disease 2019 (Covid-19) vaccines, information on their use during pregnancy was limited because pregnant women were excluded from the clinical trials. Since the time of authorization, safety data on vaccination during pregnancy have been accumulating

rapidly.3,4 The results of a retrospective cohort study now reported

in the Journal5 showed no association between maternal vaccination and serious acute adverse events in the 42 days after vaccination. On the basis of the increased risk of severe disease and pregnancy complications associated with Covid-19 during pregnancy,6 the reassuring safety data on the use of other vaccines during pregnancy, and the accumulating data on the safety of Covid-19 vaccination for the mother and fetus, the Centers for Disease Control and Prevention and professional organizations (e.g., the American College of Obstetricians and Gynecologists) have strongly recommended vaccination in pregnant women. A booster dose is also recommended after the completion of the initial vaccine series.

Given the experience with previous vaccines, maternal Covid-19 vaccination was expected to provide some level of infant protection. Maternal antibodies have been shown to be present in umbilical-cord blood, neonatal blood, and breast milk after maternal Covid-19 vaccination, but the correlation with infant protection from infection was unclear.6 Now in the Journal, Halasa and colleagues7 report on the results of a large multicenter study in which a case-control, test-negative design was used to estimate the effectiveness of maternal vaccination against hospitalization for Covid-19 among infants younger than 6 months of age. In this study, 16% of the 537 infants hospitalized for Covid-19

In contrast, 29% of the 512 hospitalized infants who had a negative test for severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) (control infants) had been born to mothers who had been fully vaccinated during pregnancy. Maternal vaccine effectiveness against Covid-19-associated hospitalization among infants was 52%. Vaccine effectiveness against admission to an intensive care unit for Covid-19 was higher, at 70%. The current report extended earlier findings of this population8 to include an additional 670 infants, many of whom were admitted to a hospital during circulation of the omicron variant. As expected, vaccine effectiveness was lower during circulation of the omicron variant than during the delta-predominant period (38% vs. 80%). In addition, vaccine effectiveness was higher when the second dose of Covid-19 vaccine was given after 20 weeks of pregnancy than when it was

> The results of the study by Halasa et al. provide compelling evidence that maternal vaccination is effective in reducing the risk of Covid-19-related hospitalization in infants younger than 6 months of age, a finding that further supports recommendations for Covid-19 vaccination during pregnancy. not be vaccinated now or in the near future. Because vaccines are less likely to be effective in infants younger than 6 months of age,1 the recently completed clinical trials of Covid-19 vaccines in young children have excluded that age

This study also raises the question of the appropriate timing of Covid-19 vaccination during pregnancy. Determining the appropriate timing is difficult because the benefits of maximizing infant protection must be balanced against the maternal risks of delaying vaccination, given the increased risk of severe Covid-19 during pregnancy. Further study is needed to assess whether an additional booster dose given in later pregnancy would increase infant protection. Despite the increased risk of severe Covid-19 among pregnant women and the accumulating safety data regarding vaccines, only 71% of pregnant women in the United States were fully vaccinated as of May 14, 2022, with a markedly lower rate among non-Hispanic Black women (58%).9 A recommendation from a health care provider has been found to be associated with a higher likelihood of maternal vaccination, and data on vaccine safety and on protection of the infant through maternal vaccination have been shown to be important to a pregnant person's decision-making process.10 Thus, this evidence that Covid-19 vaccines help to protect infants as well as mothers is highly relevant for patient counseling: a "two-for-one" deal may encourage more mothers to receive Covid-19 vaccination.

BHUBANESWAR: The grand Inter State Bus Terminal (ISBT) project at Bhubaneswar's Baramunda missed its deadline, again. Planned to be completed by June this year, it has been grappling with issues related to encroachment and moving bus owners as well as vendors. A crucial legal issue pertaining to a private lodge was sorted recently. All of these could, finally, push the progress of the high-profile project. The Bridge and Roof Company India Limited, a Central Government undertaking, was awarded the project with a bid of-

by the High Court. As per the court order, the lodge owner now has to vacate the place within a month. We are hopeful it will be done by the end of this month after which acquiring land for the project will not be a problem," the BDA VC said. Covid Hiatus

While the Covid-19 outbreak in 2020 was a major hindrance to the project, it faced hurdles in the finalisation of design, eviction of encroachment and acquisition of land. OSRTC MD Diptesh Kumar Pattnayak said the corporation had handed over

After Chief Minister Naveen Patnaik reviewed the project in December 2020, the State government announced the ISBT will be ready within 18 months to become a landmark in the Capital. Out of the 46,474 sq m area, the terminal space will occupy 12,241 sq m while commercial space will be around 15,884 sq m. The entire project is planned on 15.5

Progress So Far

Sources point out that out of 28,125 sq m of work, structural work has been completed on around 20,000 sq m. The project expenditure, though, is barely about 40 per cent by now. The entire terminal and commercial structure has been divided into six blocks. Work on the first four blocks on a G+2 structure is complete and the remaining two blocks with B+G+2 design are in progress.

However, a number of works are yet to start. The government has planned 35 bus bays and 190 idle parking spaces as well as a public parking lot for more than 250 four-wheelers and 175 two-wheelers at the ISBT. Construction work of the facade, bus bays, and a sewage treatment plant is yet to begin while BDA struggled with the acquisition of 4-acre land but managed eventually.

The existing OSRTC building on around 1-acre land, adjacent to the terminal structure, remained partially demolished due to a legal dispute between the corporation and a lodge in which the latter had got a stay order from the Orissa High Court. Overcoming Hurdles

Vice Chairman of Bhubaneswar Development Corporation Sanjay Kumar Singh said the brownfield project required a number of bottlenecks to be removed for implementation. "The major hurdle was to negotiate with bus owners to shift from the existing bus stand to a transit stop. This required a lot of time as a temporary parking area was needed to be created with required facilities," he said.

Rehabilitation of vendors was another major issue. As it was an OSRTC bus stand, a number of vendors needed to be shifted and convincing them took time. "The stay order on removal of a lodge at the old OSRTC structure was vacated only recently

the land, required for ISBT, to BDA by 2021 but the lodge remained a problem. The project was conceptualised in 2017. The BDA floated a tender for architectural and urban design the same year in July and Delhi-based Integrated Multimodal Transit System Limited won the bid the next month. In 2018, Chief Minister Naveen Patnaik announced that the bus stand will get a grand makeover as the best-in-class ISBT by April 2019.

It, however, remained a mere announcement till it received a nod from the State Cabinet on September 26, 2019. Construction work for the terminal started the same year after an agreement between the BDA and Bridge and Roof. However, the work was hampered for over six months in 2020 following the Covid-19 pandemic.

While the pandemic had its own impact, there were also lapses on part of Bridge and Roof which delayed the project implementation. "The company was issued a show-cause, while I spoke to the CMD and now we are given a schedule to complete the work by December 2022," Singh said. "The positive achievement is that we have been able to shift the bus stand to the temporary parking area amicably. Relocation of vendors and removal of encroachments were also done smoothly and expect the project work will now continue smoothly," he said.

## Slave Island starves as Sri Lanka's food prices soar

His hair is neatly combed but his cheeks are sunken and veins visible on his gaunt frame: like many Sri Lankans, Milton Pereira and his family cannot afford to buy enough food.

During the country's worst-ever economic crisis, which has driven rampant inflation and spurred protests that last week brought down the president, Sri Lankans are buying less, eating less and working less.

"It's very difficult to live, even a loaf of bread is expensive," Pereira told AFP outside his modest home in Slave Island, a poor enclave of the capital Colombo.

"If we take one meal, we skip another."

With six children in the family, the 74-yearold said the best they had been able to afford in recent weeks was the occasional fish, cut into small pieces for everyone.

sometimes we give the fish to the children," he said. The adults, he added, "only eat the gravy". Triggered by the coronavirus pandemic, the country's financial woes were exacerbated by government mismanagement, critics say.

"Because we don't have much money,

Peirera's son, B. G. Rajitkumar, is an electrical labourer who has had no work for months. "Food prices go up every day," he said. "This exponential price rise is the most terrible thing I have ever faced."

Food inflation in Sri Lanka reached 80.1 percent in the year to June, according to official figures.

At a nearby vegetable store, residents pay 1,000 rupees (\$2.80) for a kilo of gourd, twice as much as three months ago, and owner Mohamad Faizal said some of his customers were now buying as little as 100 grams a time. "The prices have gone up," he said. "The main reason is there is no way to transport those items because there is no fuel."

- 'No option' -

With no foreign exchange reserves for imports and having defaulted on its \$51 billion foreign debt, Sri Lanka is experiencing dire shortages of fuel, medicines and other essentials.

According to the World Food Programme, nearly five million people -- 22 percent of the population -- need food aid.

In its latest assessment, it said more than five out of every six families were either skipping meals, eating less or buying worse food. While food is not in short supply, the issue is affordability.

The city's New Manning main wholesale vegetable market was bustling on Sunday as buyers, sellers and porters jostled with sacks of produce.

But traders say business has gone down by more than half since March.

"Prices for everything have more than doubled," said trader M. M. Mufeed. "Some unsold vegetables go to waste and many poor people come to take away some of it every day after the market closes."

His sales are down 70 percent, he added. "Sometimes I sell to poor people for much

less to avoid wasting food and make up somewhat."

But potatoes, onions and garlic continue to be imported from India, Pakistan and China, said import-export bussinessman Ashley Jennycloss.

"Supply of food is not a problem, but because there is no fuel that makes it difficult and everything becomes expensive," said Jeeva, another trader, who gave only one name.

Some people travel long distances on foot to the New Manning market in the early morning to buy small amounts of vegetables for their kitchens at bulk rates.

"I have no option but to walk 10 kilometres to this market because food is cheaper here compared to retail stores near my home," said 50-year-old Howzy, who gave one name.



- Pumpkin patch -

The protest movement that brought down Rajapaksa has its headquarters outside his former office, where dozens of volunteers work in a patchwork of tents lining the seafront promenade.

Among them, former government employee Theodore Rajapakse -- no relation -- is teaching people how to produce fast-growing vegetables in small patches of land near their homes.

"My country is in trouble," he said, adding that he has taught around 3,000 protesters since he joined the demonstrations.

"You can grow 100 kilos of pumpkin in a three-feet-by-three-feet patch of land," he added.

But the prospects of immediate improvement in Sri Lankans' plight are limited, and the most likely successor as president, former prime minister Ranil Wickremesinghe, is reviled by the protesters as a Rajapaksa ally.

At Slave Island -- an area named after a staging post the Portuguese used for slaves from Africa during the colonial period -- Pereira had little hope.

"Gota is gone, but there is no one candidate to lead us out of this terrible condition," he said. "Politicians are divided. So it will get worse, what else can happen?"

Clean chit for Aryan Khan in cruise drugs case

Mumbai: All the hype and hoopla over the drugs case against Aryan Khan has come to nothing. Almost eight months after the registration of the case, in which the 24-year-old star kid spent 26 days in custody, the narcotics control bureau has given him and five other accused persons a clean chit.

The special investigation team of the NCB on Friday filed a 6,000-page charge sheet naming 14 accused. The agency said that the names of six persons, who were made accused by the earlier investigating team, including Aryan, Avin Sahu, Gopal Anand, Samir Sehgal, Bhaskar Arora and Manav Singhal have been dropped from the charge sheet for the "lack of sufficient evidence".

# North Korea test-fires most powerful missile since 2017

SEOUL: North Korea on Sunday tested its most powerful missile since 2017, ramping up the fire-power for its record-breaking seventh launch this month as Seoul warned nuclear and long-range tests could be next. Pyongyang has never test-fired this many missiles in a calenqdar month before and last week threatened to abandon a nearly five-year-long self-imposed moratorium on testing long-range and nuclear weapons.

With peace talks with the US stalled, North Korea has doubled-down on leader Kim Jong Un's vow to modernise the regime's armed forces, flexing Pyongyang's military muscles despite biting international sanctions.

South Korea said Sunday that North Korea appeared to be following a "similar pattern" to 2017 -- when tensions were last at breaking-point on the peninsula -- warning Pyongyang could soon restart nuclear and intercontinental missile tests.

North Korea "has come close to destroying the moratorium declaration", South Korea's President Moon

Jae-in said in a statement following an emergency meeting of Seoul's National Security Council. South



Korea's military said Sunday it had "detected an intermediate-range ballistic missile fired at a lofted angle eastward towards the East Sea."

A lofted trajectory involves missiles being fired at a high angle instead of out to their full range. Sunday's ballistic missile was estimated to have hit a maximum altitude of 2,000 kilometers and flown around 800 kilometers for half an hour, Seoul's Joint Chiefs of Staff said. That indicated that Pyongyang may have tested its "first Intermediate-Range Ballistic Missile (IRBM) since 2017", Joseph Dempsey, an analyst with the International Institute for Strategic Studies, wrote on Twitter.

The last time Pyongyang tested a similar missile was in 2017, when the Hwasong-12 flew 787 kilometers at an apogee of just over 2,111 kilometers.

Analysts said at the time that the trajectory indicated that the missile could have flown around 4,500 km if fired on a range-maximizing ballistic trajectory -putting the US territory of Guam in range.

Japan's top government spokesman Hirokazu Matsuno said Sunday that the ballistic missile "was one with intermediate-range or longer range."

Time is ripe

Pyongyang has tested hypersonic missiles twice this month, as well as carrying out four launches of short-range ballistic and cruise missiles.

Last week, leader Kim was photographed by state media inspecting an "important" munitions factory that produces "a major weapon system".

"Kim has been withholding his appetite for testing and provocations," Soo Kim, an analyst at the RAND Corporation, told AFP.

Now however, "the time is ripe, and North Korea's continued missile firing will only throw another wrench into Washington's already high plate of foreign policy challenges," she added.

The frenzy of missiles was also aimed at reminding the world that "the Kim regime hears external discussions of its domestic weaknesses," said Leif Easley, a professor at Ewha University.

"It wants to remind Washington and Seoul that trying to topple it would be too costly," he added.

The string of launches in 2022 comes at a delicate time in the region, with Kim's sole major ally China set to host the Winter Olympics next month and South Korea gearing up for a presidential election in March.

## Unique megalithic burial site discovered in Dakshina Kannada

Mangaluru: A team led by MSRS College History and Archaeology department Head Prof T Murugeshi



has discovered a unique Megalithic burial site, dating back to 800 BC at a cashew plantation in Dakshina Kannada district of Karnataka.

Based on the information provided by the villagers, the team visited 'Pandavara Guhe,' (Cave of Pandavas) at Aturu-Kundaje government cashew plantation near Ramakunja of Kadaba taluk. To their surprise they found a unique type of rock cut cavea Megalithic burial- at the place.

"Normally the rock cut caves of the Megalithic era are 2.5 or 3 feet long with openings in the centre and about a meter deep it is hemispherical in shape. But here, there is no central opening but a huge circle engraving. The circle is about 7 feet in diameter on the laterite surface. What is more interesting is that exactly below, there is a cave with the same measurement. On the side, there is an opening of about 2 feet in height," Prof Murugeshi told Deccan

"Usually, Megalithic burial sites are marked by stone circles, menhirs and stone carnes. But for the first time a sepulchral is marked by a circle," he said. Prof Murugeshi remarked that this could perhaps be the first rock engraving of the megalithic period found from Dakshina Kannada.

According to Prof Murugeshi, the burial site dates back to 800 BC- 500 BC.

Members of the excavation team entered the cave to get a clear picture of the structure inside.

"About 4-5 people can easily sit inside. Interestingly at the centre we noticed an altar-like pit. We did not find any grave goods inside the cave as they might have been taken away long ago," he added.

Similarly, nutrition sensitive schemes are implemented by Departments of Agriculture & Farmers' Empowerment, Fisheries and Animal Resources Development and Women & Child Development.

While nutrition sensitive

components comprise **NUTRITION BUDGET** 

Largest numbers of nutrition specific schemes are implemented by Departments of women & Child Development, Food Supply & Consumer Welfare, School & Mass Education.

84.62 Percent, nutrition specific component include 14.38 Percent of the Nutrition Budget.

**Nutrition Specific Sector** has been allocated Rs.5408.72 Crore and Nutrition Sensitive sector has got Rs.35,830.90 Crore.

In fact, such an initiative has helped the State as it is a frontrunner of many health & nutritional indicators. There has been significant increase in early child health indicators such as early initiation of breastfeeding, exclusive breastfeeding, complementary feeding and adequate diet diversity in children, which are above the national averages.

Odisha has ranked Number One in the country in terms of indexing IYCF Indicators.

The big leap in children receiving adequate diet has been one of the most remarkable and noteworthy achievements. This is one of the most important determinants in reducing stunting in children.

While Odisha is on a mission mode to improve nutritional status of its citizens, specifically children, women, more schemes and programs are included in 2022-23, officials admit.

It left road communication affected between Nuagada and Gunupur as boulders fell on the roads from the hills. In the neighbouring Rayagada district, two youths were left stranded on a rock in the Nagavali river due to a sudden rise in the water level. Odisha Fire Service personnel rushed to the spot and rescued the two who are natives of Kashipur block.

Chief Minister Naveen Patnaik appreciated the efforts of the firefighters of Rayagada and Kolnara in rescuing the two persons from the swollen river. The Odisha Fire Service personnel also rescued a four-year-old boy afin parts of the Nayagarh and Malkangiri districts. Nuagada and R Udayagiri in Gajapati district and Tangi in Khurda received extremely heavy showers and recorded 240 mm, 230 mm and 210 mm rainfall respectively. Fifteen other places in Kandhamal, Jajpur, Puri, Nayagarh, Gajapati, Cuttack, Kalahandi and Balangir districts also witnessed very heavy rainfall in the last 24 hours.

The low pressure that caused the pounding showers is now over north Odisha and there is a strong possibility that the system will start weakening within 24 hours. There is no warning for very heavy rainfall in Odisha from Monday onwards, said Director of Bhubaneswar Meteorological Centre HR Biswas.

With the rains leading to flash floods, Odisha Government kept a close watch over the situation. The upper catchment in Chhattisgarh also received a good amount of rain on Saturday night. With Hirakud Dam's water level reaching 611.58 ft on Sunday, a close watch is being kept on the Mahanadi river, he added

and MLAs with regard to voting.

The value of the vote of a Member of Parliament has gone down to 700 from 708 in this presidential poll due to the absence of a legislative assembly in Jammu and Kashmir.

The value of vote of an MLA varies in different states. In Uttar Pradesh, the value of vote of each MLA stands at 208, followed by 176 in Jharkhand and Tamil Nadu. In Maharashtra, it is 175. In Sikkim, the value of vote per MLA is seven, while it is nine in Nagaland and eight in Mizoram.

In accordance with the system of proportional representation by means of single transferable vote, every elector can mark as many preferences, as there are candidates contesting the election.

These preferences for the candidates are to be marked by the elector, by placing the figures 1,2,3, 4, 5 and so on, against the names of the candidates, in the order of preference, in the space provided in column 2 of the ballot paper.

According to Election Commission's directions, while MPs will get a green-coloured ballot paper, the MLAs will get a pink ballot paper to cast their vote.

Separate colours help the returning officer ascertain the value of vote of each MLA and MP.

Seeking to maintain secrecy of voting, the EC has issued a specially designed pen with violet ink to enable voters mark their ballot papers in the presidential poll.

"The CJI-led bench, on July 11, had granted interim relief to the Uddhav Thackeray faction MLAs by asking Maharashtra Assembly Speaker Rahul Narwekar not to proceed with the plea seeking their disqualification as sought by the Shinde group on the ground of defying the party whip during the trust vote and the election of the speaker.

The top court seized of five petitions and the first one was filed by the Shinde faction during the summer vacation when some rebel Sena MLAs moved before it challenging the

disqualification proceedings initiated by the



deputy speaker.

Bengaluru FC signs Fiji striker Roy Krishna for two years

I would have an impact at the club," said Krishna following the completion of formalities on his deal. I've always admired the way Bengaluru played and organized itself over the years that I've played in India."

Krishna is the Blues' sixth signing of the season, following the arrivals of Javi Hernandez, Prabir Das, Faisal Ali, Amrit Gope and Hira

After beginning his career with local side Labasa as a teenager, Krishna made his first move abroad in 2008, joining New Zealand Football Championship side Waitakere United.

In his six seasons with Waitakere, Krishna scored 55 goals in 75 appearances and picked up the NZFC Golden Boot in 2012-13.

Following a short stint at Auckland City, where he became the first Fijian to score at the finals of a FIFA tournament by netting against Raja Casablanca in a playoff of the FIFA Club World Cup, Krishna moved again, this time to Australia where he joined Wellington Phoenix.

"When we played against Bengaluru FC, they have always been a tough opponent and we knew it wouldn't be a walk in the park. We had a different strategy when taking on BFC," said Krishna.

"From the start I've had a good impression of the club, but it took some time to finalize the goalscorer with 51 goals, and his record of 18 goals in a single A-League season has not been matched by any other Phoenix player.

"We wanted to bring Roy to Bengaluru FC the moment we knew he was available. There were a host of clubs within the League and outside who were in the running to sign him," said BFC Director Parth Jindal.

"We want to bring BFC back to where it belongs, and this signing is as big a statement of intent. Roy's work ethic, eye for goal and records are phenomenal, and we're all excited to see how he teams up with Sunil and the rest of the squad."

In his three seasons in the ISL, Krishna has 36 goals and 18 assists and was joint topscorer in the League twice -- in 2019-20 with 15 goals as ATK lifted the ISL trophy and in 2020-21 with 14 goals, as ATK Mohun Bagan reached the final.

Krishna, who is an ambassador for the Oceania Football Confederation, represented Fiji at the U-20 and U-23 levels, before making his debut for the senior national team at the 2007 South Pacific games.

His opening goal against Mexico at the 2016 Rio Olympics is Fiji's first and only goal at an Olympic Games.

With 31 goals in 45 appearances, Krishna leads the charts for goals and appearances for his country.
