

China plans to build new highway along LAC with India: Report

BEIJING(KCN): China plans to build a new highway along the Line of Actual Control (LAC) with India as part of Beijing's efforts to strengthen its strategic position and project its power, a media report said on Wednesday.

The highway, spanning from Lhunze county in Tibet to Mazha in Kashgar, Xinjiang region,



is among 345 construction plans proposed in the new national programme, which aims to build a total of 461,000 kms of highway and motorway by 2035, as China seeks to revive its faltering economy with infrastructure investment, the Hong Kong-based South China Morning Post reported.

Lhunze county, according to reports, formed part of Arunachal Pradesh, which China claims as part of South Tibet.

There was no official reaction here to the news report in the Hong Kong media. India has said previously that it keeps an eye on all the activities along its border.



As it presses ahead with providing tens of billions of dollars in military, economic and direct financial support aid to Ukraine and encourages its allies to do the same, the Biden administration is now once again grappling with longstanding worries about Ukraine's suitability as a recipient of massive infusions of American aid.

Those issues, which date back decades and were


not an insignificant part of former President Donald Trump's first impeachment, had been largely pushed to the back burner in the immediate run-up to Russia's invasion and during the first months of the conflict as the U.S. and its partners rallied to Ukraine's defense.

But Zelenskyy's weekend firings of his top prosecutor, intelligence chief and other senior officials have resurfaced those concerns and may have inadvertently given fresh attention to allegations of high-level corruption in Kyiv made by one outspoken U.S. lawmaker.

It's a delicate issue for the Biden administration. With billions in aid flowing to Ukraine, the White House continues to make the case for supporting Zelenskyy's government to an American public increasingly focused on domestic issues like high gas prices and inflation. High-profile supporters of Ukraine in both parties also want to avoid a backlash that could make it more difficult to pass future aid packages.

What is Art for?

For decades, Western culture has been reluctant to assign an inherent value or a purpose to arteven as it continues to hold art in high esteem. Though we no longer seem comfortable saying so, our reverence for art must be founded on a timeless premise: that art is good for us. If we don't believe this, then our commitment—in money, time, and study—makes little sense. In what way might art be good for us? The answer, I believe, is that art is a therapeutic instrument: its value lies in its capacity to exhort, console, and guide us toward better versions of ourselves and to help us live more flourishing lives, individually and collectively.

Resistance to such a notion is understandable today, since "therapy" has become associated with questionable, or at least unavailing, methods of improving mental health. To say that art is therapeutic is not to suggest that it shares therapy's methods but rather its underlying ambicion, to help up to some better with a viotence. bition: to help us to cope better with existence. While several predominant ways of thinking about art appear to ignore or reject this goal, their ultimate claim is therapeutic as well.

Art's capacity to shock remains for some a strong source of its contemporary appeal. We are conscious that, individually and collectivel we may grow complacent; art can be valuable when it disrupts or astonishes us. We are particularly in danger of forgetting the artificiality of certain norms. It was once taken for granted, for instance, that women should not be allowed to vote and that the study of ancient Greek should dominate the curricula of English schools. It's easy now to see that those arrangements were far from inevitable: they were open to change and improvement.

When Sebastian Errazuriz created dollar signs out of ordinary street markings in Manhattan, his idea was to jolt passersby into a radical reconsideration of the role of money in daily life to shake us out of our unthinking devotion to commerce and to inspire, perhaps, a more equitable conception of wealth creation and distribution. (One would completely misunderstand the work if it were taken as an encouragement to work harder and get rich.) Yet the shock-value approach depends upon a therapeutic assumption. Shock can be valuable because it may prompt a finer state of mind—more alert to complexity and nuance and more open to doubt. The overarching aim is psychological improvement. Shock can do little for us, though, when we seek other adjustments to our moods or perceptions. We may be paralyzed by doubt and anxiety and need wise reassurance; we may be lost in the labyrinth of complexity and need simplification; we may be too pessimistic and need encouragement. Shock is pleasing to its adherents in its assumption that our primary problem is complacency. Ultimately, however, it is a limited response to impoverished thinking, timid or ungenerous reactions, or meanness of spirit. Another way of addressing these shortcomings

is to pursue a deeper understanding of the past. Vittore Carpaccio's painting The Healing of the Madman offers a rare visual record of the Rialto Bridge—then still made of wood—before it was reconstructed, so it has much to teach us about the architecture of Venice circa 1500. It's also highly instructive about ceremonial processions, the prominent civic role of religion (and its intersection with commerce), how patricians and gondoliers dressed, how ordinary people wore their hair, and much else. We also gain insight into how the painter imagined the past; the ceremony depicted took place over 100 years before the picture was painted. We learn something about the economics of art—the image is

part of a series commissioned by a wealthy commercial fraternity.

In a less scholarly way, the richness with which a past era becomes visually present allows us to imagine what it would have been like to clatter across the wooden bridge, to be rocked along the canals in a covered gondola, and to live in a society in which belief in miracles was part of the state ideology.

We value historical information of this kind for various reasons: because we want to understand more about our ancestors and how they lived and because we hope to gain insight from these distant people and cultures. But these efforts lead back, eventually, to a single idea: that we might benefit from an encounter with history as revealed in art. In other words, the historical ap-



proach does not deny that the value of art is ultimately therapeutic—it assumes this, even if it tends to forget or dismiss the point. Hence the irony (to put it gently) of scholarly resistance to the idea of art's therapeutic benefit. Erudition is valuable only as a means to an end, which is to shed light on our present needs.

Another approach sees art as a succession of discoveries or innovations in the representation of reality. In this almost scientific way of evaluating art, we elevate artists who pioneered new techniques, much as we prize explorers and inventors from history ("Who discovered America?" "Who built the first steam engine?"). Leonardo da Vinci is crucial, in this view, because he was an early adopter of sfumato, an artistic technique for showing shapes without using outlines.

Likewise, Paul Cézanne's Mont Sainte-Victoire is seminal for being one of the earliest works to emphasize the flat surface of the canvas. In his image of the mountain as seen from Les Lauves, his property near Aix-en-Provence, Cézanne uses blocks of paint to symbolize shrubs though they are, on closer examination, equally colored marks forming an abstract pattern. (This is most apparent if the top half of the painting is covered.) We are presented not with the illusion of three-dimensional space but with the admission that this is a two-dimensional work. Cézanne's approach is so familiar to sophisticated enthusiasts that it seems almost embarrassing to point out that his technique explains little about the work's value to us. The worth of an invention can be assessed externally only in terms of the genuine benefits that it brings. Technical discussions reveal only the changes in methods of design or production. The new ways

only if we have reason to believe that they are better than the old. Hence the technical view of art has a buried assumption: it presupposes that the works in question are beneficial to us. It does not explain why this should be so but, like the historical approach, takes this for granted. Technical advances are valuable insofar as they bring new, or enhanced, therapeutic resources to the art form.

If one agrees with Hegel that art is the sensuous presentation of the idea (or ideal), it remains to be explained why such a presentation is valuable. What is the nature of our troubles or aspirations, such that art is something that we need? The therapeutic thesis is not simply another idea about art's value. It homes in on the only area in which such value could be explained: art's capacity to improve our lives. Art can be:

A corrective of bad memory: Art makes the fruits of experience memorable and renewable. It is a mechanism to keep our best insights in good condition and make them publicly accessible. A purveyor of hope: Art keeps pleasant and consoling things in view, fortifying us against deoair.


A source of dignified sorrow: Art reminds us of the legitimate place of sorrow in a good life, so that we recognize our difficulties as elements of any noble existence.

A balancing agent: Art encodes with unusual clarity the essence of our good qualities; it holds them before us to help rebalance our natures and

direct us to our best possibilities.
A guide to self-knowledge: Art can help us identify what is central to life but difficult to put into words. Visual art helps us recognize our-

A guide to the extension of experience: Art is an immensely sophisticated accumulation of experience, presented to us in well-organized forms. We can hear the voices of other cultures, extending our notions of ourselves and the world. At first, much art seems merely "other" but we discover that it contains ideas that we can make our own, in ways that enrich us.

A tool of re-sensitization: Art saves us from our habitual disregard for what is all around us. We



recover our sensitivity and look at the familiar in new ways. We are reminded that novelty and glamour are not the only solutions.

Consider, for example, Tischbein's Goethe at the Window of His Roman Apartment. We see the great man from behind: a slipper falls casually from his foot as he leans out, and the dim coolness of the room and the bright sunshine of the street make a powerful contrast. Some might see in this work an attempt to preserve the lessons learned on holiday. Away from home and work, in the warm South, Goethe became (like most travelers) a slightly different—and, in some ways, better—version of himself. The drawing attempts to memorialize the good version of the self and make that more prominent and more readily accessible when one has returned to familiar surroundings. The point is not so much to recall that Rome was interesting as to encapsulate who one became there. Goethe could hardly take the Italian weather back to Weimar; what he could do was hold on to the insight into his nature and needs that he gained while away. Hence it is a pity if one is more likely to encounter such images on the walls of a pensione in Trastevere than in a subway station in a metropolis, where its meditative qualities are more needed.

Tischbein depicts Goethe in his Roman apart-

In Rocky Reef on the Sea Shore, Caspar David Friedrich uses a striking, jagged rock formation, a spare stretch of coast, the bright horizon, faraway clouds, and a pale sky to induce a mood. We might imagine walking in the predawn hours, after a sleepless night, on the bleak headland, away from human company, alone with the basic forces of nature. The lower portion of the sky is formless and empty, a pure silvery nothingness, but above it are clouds that catch the light on their undersides and pass on in their pointless, transient way, indifferent to our con-

The image of nature does not refer directly to human relationships or to the stresses and tribulations of daily life. Its function is to give us access to a state of mind in which we are acutely conscious of the largeness of time and space. The work is somber, rather than sad; calm, but not despairing. And in that condition of mind that state of soul, to put it more romantically we find ourselves, as so often with works of art, better equipped to deal with our intense, intractable, and particular griefs.

The idea that art's value should be understood in therapeutic terms is not new. In fact, it is the most enduring way of thinking about art, having its roots in Aristotle's philosophical reflections on poetry and drama. In the Poetics, Aristotle argued that tragic drama can elevate how we experience fear and pity—two emotions that help shape our experience of life. The broad implication is that the task of art is to help us flourish, to be "virtuous," in Aristotle's special sense of that word: that is, to be good at living, even in challenging circumstances.
This understanding of art has been in abeyance

in recent decades, but it is, I believe, the only plausible way of thinking about art's value. Other approaches, as we have seen, must tacitly assume it, even when they deny it. To consider art from a therapeutic point of view is not to abandon profundity but to embrace it and to return art to a central place in modern culture and modern life.



Widow creator Don Rico) are being represented by Marc Toberoff, who had also represented Superman creators Jerry Siegel and Joe Schuster in an unsuccessful termination attempt against DC which saved off termination by counterclaiming against Toberoff.

As per The Hollywood Reporter, Dan Petrocelli represented the publisher at that time and will be representing Disney for the new case.

Petrocelli has already filed several lawsuits against Lieber, Don Heck,

Patrick Ditko, Don Rico and Keith Dettwiler. The cases will focus on the creation of famous comic book characters and who should be deemed the statutory author.

One of the complaints filed on Friday asserted, "Marvel had the right to exercise creative control over Lieber's contributions and paid Lieber a perpage rate for his work."

If the plaintiffs win, Disney would have to share profits with the others and hold on to at least a share of character rights as co-owners.

As per The Hollywood Reporter, the termination provisions of copyright law only apply in the United States, allowing Disney to continue to control and profit from foreign exploitation.

The bride, pretty, radiant and in red, sits in front of the sacred fire, her family, the groom and his parents around her, the love flowing like a balmy breeze.

And in that arguably most precious moment, she looks into the camera and asks, "why must a woman be commodified through the custom of 'kanyadaan? literally 'donating a daughter."

The ad for a lehenga brand featuring Bollywood star Alia Bhatt as the much-indulged daughter and granddaughter has fired debate on social media platforms and elsewhere on the age-old tradition of giving away the daughter.

Many term it Hindu phobic for casting aspersions on a ritual that is part of the warp and weft of society, others appreciate it for calling out the patriarchy that underscores the custom and there are those that feel it should have gone even further in its rejection.

"There is a growing number of young women who are beginning to think about the issue, especially as increasing number joins the workforce, has access to ideas (via social media etc) that are criti-

cal of 'women as property' concept. This ad reflects that," sociologist Sanjay Srivastava told PTI.

In the 1.41 minute ad, Bhatt, the self-assured woman of today who also does a selfie pout with her father while at the 'mandap', recalls her lifetime of 'othering' in a monologue - her fond grandmother saying she would one day go to her own home, her father not reacting when people called her "paraya dhan" (alien property) and her mother calling her a 'chidiya' which would fly away one day. The Manyawar ad ends with the grooms' par-

ent also joining in in the ritual (though it is unclear whether they too are giving away their son) and Bhatt's bride saying it should be 'kanyamaan' (respect for the girl child) and not 'kanyadaan', and asking, "Am I a thing to be given away?" Her angst finds a wide echo. Actor Dia Mirza, who decided to do away with the rituals of both "bidaai" and "kanyadaan"

when she got married to businessman Vaibhav Rekhi, said they wanted the wedding to reflect their "beliefs and not outmoded ideas." "Neither of us believes that women are com-

modities to be given away or 'donated.' Women have agency, selfhood and can make decisions about their lives on their own so my wedding reflected exactly that by not including a ritual like 'kanyadaan'," the actor told PTI.

She even engaged a female priest for her wedding to emphasise gender equality.

"It is time for young couples to define how they want to get married and if their ceremony is truly representative of their personalities and love for each other," said the actor, who is also the United Nation's National Goodwill Ambassador from India.

BRICS, a grouping of major emerging economies - Brazil, Russia, India, China, and South Africa - has become one of the trending buzzwords in global public opinion lately. After Iran and Argentina applied to join the BRICS mechanism, Saudi Arabia, Turkey, and Egypt also plan to knock on the door of the BRICS for official membership, Sputnik quoted BRICS International Forum President Purnima Anand as saying. If the trend tells anything, it is the growing charm of BRICS' strength and values, as well as the loss of attraction in the current West-

dominated global governance. Crises have been surfacing on a global level since the outbreak of the Russia-Ukraine conflict. Yet BRICS countries have shown much less sensitivity and

vulnerability than the US and European countries amid these challenges.

Brazil has diverse agricultural products and vast mineral wealth. Their different advantages plus the promotion of BRICS' cooperation on food supply and the exchanges of national currencies have made the group less impacted by the global crises. More importantly, BRICS countries have the will, and, to different degrees, capability, to fix the deficit in global governance. In this regard, BRICS has already launched a series of innovations. But when Turkey, a NATO ally, applies for BRICS membership, it mirrors BRICS, be it its capacity or ideas, and represents something much cooler than US-dominated rules and orders. At least it signals that the world needs reformed governance where Western voices are not the only sound.

When it was formed in 2009, the group was expected to reshape the global economy and create a new financial order to help the developing world. Its success can be described at best as moderate, but its importance can't be overstated. BRICS nations have a combined population of 3.23 billion and their combined GDP is more than \$23tn. The BRICS may seem irrelevant because it hasn't really moved the needle forward on its long-standing efforts to usher in viable global economic alternatives to the US-led existing system, While China has been more open about its support for Russia, India, South Africa, and Brazil have tried to walk the diplomatic tightrope over the war. They haven't openly criticized Russia but have advocated talks to end the war. But a lot has changed since the war started. The economic impact of the war and the West-led sanctions is showing across the world - inflation is up in many countries, global supply chains have been disrupted and there are fears of food shortages. Russian commentators have been talking about the importance of the BRICS nations in blunting the impact of the sanctions. Therefore, how should BRICS navigate the challenges that the Russian-Ukrainian war presents? Will it cause a sizable diversion from the BRICS to aim to balance a world system dominated by the west? Will it strengthen BRICS' position as the driving force behind changes to global economic governance? Or will its members' geopolitical concerns continue to cloud its focus? Whether the current crisis is viewed as a game-changer and an opportunity to challenge the current system, which is dominated by

unilateralism and exclusion, depends on how BRICS will adapt to the new circumstances.


The BRICS countries comprise a potent group in terms of global power standing from an economic, military, technological, social, and cultural perspective. They make up more than 40% of the world's population and occupy more than a quarter of its landmass across three continents, with an estimated combined population of 3.23 billion. Together with the two countries that are expanding the quickest in the world, India, and China, they represent more than 25% of the global GDP, or \$23.53 trillion.

A place for potent new narratives to emerge from the BRICS is created by the new geopolitical reality, where so much is in flux and unclear. The next potential target of a similar form of total economic warfare used by the West against Russia might be the BRICS nations. The current circumstance is the perfect opportunity to take stock of the BRICS countries, especially in light of their frequently contentious relationships with the West. It is now imperative that the BRICS and other like-minded nations work diligently to establish a second economic bloc independent of US-led institutions and the dollar. At this point, BRICS partners' unity is crucial. In opposition to US and EU sanctions, it is anticipated that BRICS partners will stand with Russia. Individual members who do not consider themselves allies and who want to avoid this conflict will be acting against their country's interests. In their interactions with the West, China, Brazil, South Africa, and India all have a lot at risk. The west has not yet predicted that the BRICS nations will comply with the sanctions equally. However, expecting them to maintain this mentality is naive and impractical.

Can BRICS endure the Western economy's and institutions' strength? The BRICS New Development Bank (NDB) and Contingent Reserve Arrangement have successfully been established, demonstrating BRICS's standing as a club of somewhat developing powers (CRA). Although China, India, and Russia are members of the group, less than 20% of world trade is conducted inside the BRICS. The group lacks international message channels, cards, or payment methods. The Western lenders should have had some competition from programmes like the New Development Bank. BRICS cannot immediately replace the West's economic might, but the way the West responded to the situation in Ukraine shows how urgent it is to move now and do more to deal with potential financial instability.

BRICS undoubtedly must strengthened. The timeline organization need to be re-evaluated. Now is the time to reconsider the notion of enlarging the BRICS by inviting new participants. Once more nations are added, the development objectives for BRICS to pursue its principles and ideals to protect will be strengthened with renewed vigour. It is important to actively promote the goal of evading sanctions and developing Western alternatives to the financial, logistical, and other systems. It ought to transform BRICS into the G20 for emerging nations.

By the end of June, the Hill published a headline, "An out-of-touch G7 could lose global leadership to BRICS." On Twitter, some Western netizens also describe BRICS as a rival of G7 and NATO. It cannot be more narrow-minded to view BRICS in this way. As if for some Westerners, when some countries get together, they are bonding to have a target to oppose, just like what the West has always done.

Cooperation has been one of the natural needs across the globe, as well as a normal state in international relations for a long time. Why deliberately twist specific cooperation into a bloc confrontation? BRICS has simply no interest in becoming another G7 or NATO. Instead, as stipulated in the organization's spirit, namely "openness, inclusiveness and win-win cooperation," BRICS calls for global security and economic governance while emphasizing not only South-South cooperation but also dialogues between South and North. What BRICS is against are power politics, hegemony, and the law of the jungle, all of which basically determine that in international politics, only major powers have a say, and small countries must be obedient or even be exploited. Against this backdrop, BRICS calls for fairness and justice, global governance in which developing countries have their due status and their voices can be heard. The BRICS just want to bring a balance to the current global order.


Maoist under control

Bhubaneswar: The overall Left-wing extremism scenario in the State has remained well under control during 2021, as per Home Department White Paper tabled in the Odisha Assembly on Wednesday. The intensity of CPI Maoist perpetrated violence declined, the cadre strength of Maoists dwindled, the area of influence of the banned outfit shrunk and the mass support base of the Maoist slackened during the year, it said.

Out of the 10 districts of State presently affected by Maoist activities, the situation has remarkably improved in most of the areas including in Swabhiman Anchal of Malkangiri and Kalahandi-

Rayagada- Kandhamal axis due to pro-active security and administrative response. However, the situation remained dynamic and challenging in a few pockets, said the White Paper.

A total of 28 Maoist-related incidents including 21 exchanges of fire on police initiatives were re-



ported in the State during the year in which two civilians were killed and one security personnel attained martyrdom. While seven hard-core CPI Maoists were neutralised in separate incidents of anti-Maoist operations by security forces in Malkangiri, Kalahandi, Bolangir, and Bargarh districts, as many as 36 were arrested in connection with their involvement in Maoist activities and 21 surrendered during the period.

The security forces recovered 30 guns, 48 IEDs and a huge quantity of ammunition, explosives materials and other articles.

The proactive steps were taken to augment the security cover in the core Maoist-affected areas and create a secure atmosphere for development activities in those areas, the white paper said.

It claimed that focus was given to ensure timebound implementation of the Surrender and Rehabilitation Scheme as a part of the composite endeavour to integrate CPI Maoist cadres in the mainstream society. No terrorist activity has been noticed in the state during 2021.

Total 1,55,420 cognizable cases including 1394 murder, 552 dacoity, 2826 robbery, 5133 burglary, 13,024 theft, 5138 swindling, 2220 rioting, 3327 rape, 10,983 MV accident and 110823 misc cases were reported in the State during 2021.

Laupada, Rengalaberha N-E extension & Nuagaon West, Alaghat West, Gandhalpada West, Kendudihi North, Roida-I and Jhumka-

Similarly, Ballada, Nunapaimali, Sijimali Kutrumali bauxite mineral blocks have been put in papers for auction this year. The other proposed

Odisha government to pilot 'Grain ATM' to dispense PDS ration

BHUBANESWAR: The State government will soon pilot a project to dispense ration through automated teller machines (ATMs) to beneficiaries covered under national and State food security

Informing this to the Assembly on Tuesday, Food Supplies and Consumer Welfare Minister Atanu Sabyasachi Nayak said the facility will be introduced in the urban areas of the State in the first phase. Initially, the service will be available in Bhubaneswar, he added.

A special code card will be provided to the beneficiaries to avail the service. The ATM will be equipped with a biometric system having a touch screen, where the beneficiary will have to enter the Aadhaar or ration card number.

On biometric authentication, foodgrain prescribed

by the government to the beneficiaries will be pro-



vided through the machines. Majority of the beneficiaries under National Food Security Act (NFSA) and State Food Security Programme (SFSP) are provided rice.

The State government has signed several partner-ship agreements with the World Food Programme (WFP) in 2021. Transformation of the public distribution system and paddy procurement, grain ATM and smart mobile storage units are some of the projects to be taken up under the agreement. The country's first 'Grain ATM' was set up in Gurugram, Haryana last year. This machine has been installed under the World Food Programme and it is called the 'Automated, Multi Commodity, Grain Dispensing Machine'. Uttarakhand government has also introduced the Grain ATM. him nor inform him about the meetings and other developments taking place in the JalShakti department.

Khatik claimed that the officers were deliberately ignoring him as he belonged to a scheduled caste.

The copy of the letter is doing rounds on social media. Khatik did not attend the cabinet meeting chaired by CM Yogi on Tuesday relinquishing the security and official vehicle provided to him. However, he put only the officers on target saying that he was being made to feel that the MoS should not expect anything more than an official car. However, the minister did not say anything about his senior Swatantra Dev Singh, who is also state BJP chief.

Khatik also made claims about prevailing corruption in departmental transfers and postings. Referring to an instance where he sought information on July 9 about transfers after receiving complaints of irregularities and corruption, the minister said that he was yet to get the response from officials concerned. He even claimed that the PM's favourite Namami Gange project was also marred by corruption on the ground.

On the other, another Yogi minister, Jitin Prasada, heading PWD, is believed to be disenchanted with the action initiated by Chief Minister's Office against the officers of his department over the irregularities found in transfer and postings of engineers.

As per the sources, Prasada met CM Yogi Adityanath after the cabinet meeting to discuss the issue on Tuesday and believably met Union Home Minister Amit Shah in Delhi to put forth his stand. However, he rejected the claims of discontent saying he was working under CM Yogi Adityanath who had the policy of zero tolerance to corruption. "In case of anomalies, action is imperative," he said.

The office of CM Yogi Adityanath cracked the whip on the PWD officials removing Prasada's OSD Anil Kumar Pandey on Monday over his alleged role in irregularities including involvement of money in transfer and posting of engineers. It was followed by the suspension of five senior officers of the department in the matter.

The CM had taken the notice of complaints of anomalies in departmental postings on July 12 and had set up a probe committee comprising Agriculture Production Commissioner Manoj Kumar Singh and senior IAS officer Devesh Chaturvedi.

As per the official spokesperson, on the basis of recommendations of probe report, besides Pandey's removal, the axe of suspension fell on five officers including PWD Head of the Department and Engineer-inchief Manoj Kumar Gupta, Chief Engineer (Project and Planning) Rakesh Kumar Saxena and Senior Staff Officer Shailendra Kumar

A five per cent GST has kicked in on pre-packaged and labelled food items such as cereals, pulses and flour weighing less than 25 kg. For a commodity measured in litres like curd and 'lassi, the limit is 25 litres. Rejecting criticism, Finance Minister Nirmala Sitharaman had on Tuesday said the five per cent tax is being levied after a nod from all states, including the non-BJP ruled.

Punjab, Chhattisgarh, Rajasthan, Tamil Nadu, West Bengal, Andhra Pradesh, Telangana and Kerala had also agreed on imposing the levy, she said.

In a series of tweets, Sitharaman said states levied sales tax or VAT on foodgrains in the pre-Goods and Services Tax (GST) regime and the present levy on cereals, pulses, flour, curd and lassi is an exercise to curb tax leakage.

The decision, she said, was taken by the GST Council, where all states are represented, through a consensus.

Rahul Gandhi, who had been calling GST 'Gabbar Singh Tax', on Wednesday described it as 'Grahasti Sarvnaash Tax', suggesting that it will be a body blow for common households.

The CM was speaking to the group of ministers after Tuesday's cabinet meeting. Yogi also asked the cabinet ministers to take their juniors along. Probably being in the knowhow of the discontent of Khatik, CM Yogi categorically told the cabinet ministers to work in tandem with Ministers of state keeping them abreast of all the developments and inviting them to departmental meetings.

China plans to build new highway along LAC with India: Report

of talks to disengage troops at different points.

At Sunday's 16th round of talks between the top military commanders of the two countries, it was learnt that the Indian delegation sought resolution of pending issues in Depsang Bulge and Demchok. India has been consistently maintaining that peace and tranquillity along the LAC were key for the overall development of the bilateral ties.

Last month External Affairs Minister S Jaishankar asserted that India will not allow any unilateral attempt by China to change the status quo or the LAC.

At his meeting with Chinese counterpart Wang Yi on the side-lines of recent G20 foreign ministers in Bali, Jaishankar conveyed to Wang the need for early resolution of all the outstanding issues in Eastern Ladakh.

The eastern Ladakh border standoff erupted on May 5, 2020, following a violent clash in the Pangong lake areas. Both sides gradually enhanced their deployment by rushing in tens of thousands of soldiers as well as heavy weaponry. As a result of a series of military and diplomatic talks, the two sides completed the disengagement process last year on the north and south banks of the Pangong lake and in the Gogra area. China has been ramping up infrastructure in Tibet.

Last year it launched a high-speed bullet train connecting the provincial capital Lhasa with Nyingchi, the Tibetan border town close to Arunachal Pradesh.

On Tuesday, new satellite images emerged indicating the construction of a Chinese village East of the Doklam plateau on the Bhutanese side, a region that is considered important for India's strategic interest.

Chinese President Xi Jinping travelled by bullet train during his rare visit to border areas in Tibet.

The massive development of rail, road and airport development vastly improved the Chinese military's ability to move men, materials and weapons to the border areas at a faster pace. Tibet has five airports including at Nyingchi, Shigatse and Ngari located close to the Indian and Nepal borders.

Authorities in Tibet accelerated 15 key construction projects last year, including the middle section of the highway from the regional capital Lhasa to Xigaze. Tibet completed an investment worth 20.1 billion yuan (about USD 3.2 billion) in fixed assets for road transport last year, according to an official media report.

"In all of our relationships, and including in this relationship, we invest not in personalities; we invest in institutions, and, of course, President Zelenskyy has spoken to his rationale for making these personnel shifts," State Department spokesman Ned Price told reporters on Monday.

Price declined to comment further on Zelenskyy's reasoning for the dismissals or address the specifics but said there was no question that Russia has been trying to interfere in Ukraine.

"Moscow has long sought to subvert, to destabilize the Ukrainian government," Price said. "Ever since Ukraine chose the path of democracy and a Western orientation this has been something that Moscow hassought to subvert."

Still, in October and then again in December 2021, as the U.S. and others were warning of the increasing potential for a Russian invasion, the Biden administration was calling out Zelenskyy's government for inaction on corruption that had little or nothing to do with Russia. "The EU and the US are greatly disappointed by unexplained and unjustifiable delays in the selection of the Head of the Specialized Anti-Corruption Prosecutor Office, a crucial body in the fight against high-level corruption," the U.S. Embassy in Kyiv said on Oct. 9.

"We urge the selection commission to resume its work without further delays. Failure to move forward in the selection process undermines the work of anti-corruption agencies, established by Ukraine and its international partners," it said. That special prosecutor was finally chosen in late December but was never actually appointed to the position. Although there are indications the appointment will happen soon, the dismissal of the prosecutor general could

Mahuchikh left shortly after her country came under siege by the Russian military. The war grinds on. Though thousands of civilians and soldiers are dying, Mahuchikh felt it was her duty to keep doing what she does best, if for no other reason than to give people back home something to be happy about. And, she said, to show Ukraine is strong.

"We will fight for our independence and for our territory," she said. "And of course, finally, we will win." She came into the biggest high jump contest of the year as a favourite, in part because the threetime defending champion, Maria Lasitskene, is from Russia and not allowed to compete in major events due to the war. The Ukrainian finished behind the surprising Eleanor Patterson of Australia, who had one fewer miss than Mahuchikh at 2.02 meters (6 feet, 7 1/2 inches), which made the difference between first and second.

Still, this was a night to celebrate for Ukraine, and for Mahuchikh, who said she felt the warmth from the stands, where the yellow-and-blue Ukraine flags dotted a few seats and fans cheered for her before every jump. "Now, everything is for our Ukrainian people, and everything you do, you want to show the good results," she said. The silver medal goes alongside the gold she won

at the world indoor championships in March. That came shortly after she escaped her hometown of Dnipro, which had come under attack by Russia
