2Lac Cr Budget presented

Bhubaneswar(KCN): Minister Finance, Niranjan Puari on Saturday presented the Annual Budget for the year 2022-23 in the State Legislative Assembly with a total outlay of Rs 2 lakh crore, which is the highest ever allocation in the history of

The Budget size is Rs 30,000 crore more than the Annual Budget of last fiscal 2021-22.

"The fiscal space created has been effectively employed for creation of physical, social and human capital. Over the last twenty-two years, there has been a seventeen-fold increase in budget size and this year, we are touching the landmark figure of Rs 2 lakh crore," Mr.Pujari said.

The Program expenditure has shown a twentyeight-fold increase and Capital spending has increased by about fifty times during the same period, he said.

Total Program expenditure outlay for the financial year 2022-23 estimated at Rs 1 lakh crore, which is half of the entire budgetary allocation. In addition, Rs10,000 crore will be spent through off-budget sources and by Public Sector Undertakings (PSUs), he said.

Total Administrative Spending will be Rs.89,590 Crore during 2022-23.

The outlay for Disaster Risk Management Fund will be Rs.3,210 crore. Transfers from State will have an outlay of Rs.7200 crore, said the Finance

Minister. The capital outlay in 2022-23 is Rs.38,732 crore, which is about 5.4 per cent of GSDP and 56 per cent increase over the previous year. Additionally,

loans and advances, grants for creation of capital assets and other expenditure for capital formation together account for Rs.11,933 crore, which is an additional 1.7 per cent of GSDP. Informing about financing for the year, Mr.Pujari

said the outlay is proposed to be financed mainly through revenue receipts of Rs. 1,63,967 crore and borrowing and other receipts of Rs.36,033 crore. The total revenue receipts for the year 2022-23 include State's share in Central Taxes for Rs.36,978

Scheduled Castes, Other Backward Classes, Minorities, differently-abled and senior citizens.

A total sum of Rs.12,624 crore has been proposed for public health care, which is an increase of about 25% over previous year's provision. Similarly, an allocation of Rs.27,324 crore has been made for the education and skill development sector.

For conserving and developing the places of religious and cultural importance, the Finance Minister has allocated Rs.1,950 Crore under different schemes during 2022-23.

This includes an outlay of Rs.1,325 crore under ABHADA, Rs.200 crore each under EKAMRA and SAMALEI, and Rs.150 crore under Integrated Development of Heritage, Monuments & Tourists Destinations in the budget.

Stating our road infrastructure is one of the best in the country, Mr.Pujari said, "To further improve road infrastructure for the upcoming industrial regions and their connectivity with the mineral hinterlands and ports, it has been proposed to allocate about Rs.14,454 crore during the year 2022-23 for construction and improvement of roads in the State."



No Reduction in COVID-19 Hospitalizations, Deaths with Ivermectin

Alarge study investigating potential repurposed treatments for COVID-19 has found no benefit for ivermectin in



reducing person's risk of being hospitalized or dying from the disease, according to a preprint posted by the researchers on medRxiv yes-

terday (June 12). The randomized placebo-controlled trial included more than 1,500 people, and adds to a growing body of research suggesting the antiparasitic drug is unlikely to be effective at staving off disease progression. "Overall, most people improved their symptoms whether they took ivermectin or not," study coauthor Adrian Hernandez, executive director of the Duke Clinical Research Institute, says in a press statement. He adds that "there does not appear to be a role for ivermectin outside of a clinical trial setting, especially considering other available options with proven reduction in hospitalizations and death."

Just last month, the TOGETHER trial, another multi-arm study, reported in the New England Journal of Medicine that treatment with ivermectin "did not result in a lower incidence of medical admission to a hospital due to progression of Covid-19 or of prolonged emergency

department observation among outpatients with an early diagnosis of Covid-19."

The NIH updated its clinical guidelines in late April of this year to recommend "against the use of ivermectin for the treatment of COVID-19, except in clinical trials." Prior to that, it had stated that there was "insufficient evidence" to recommend for or against the use of the drug as a COVID-19 treatment.

The ACTIV-6 trial is ongoing. Other arms that have yet to report findings include a study of the antidepressant fluvoxamine and a separate study of ivermectin at a higher dose of 600 µg/ kg for six days.

Chinese homebuilders let farmers pay for homes with watermelons, peaches



BEIJING: Struggling developers in China have started taking payment for homes in watermelons, peaches and other agricultural produce, state media reported Sunday, as they attempt to lure buyers deterred by a property market slump.

China's housing market has been hit by a slowing economy and debt crisis precipitated by a government ban on builders taking deposits before construction begins on a project.

One developer in the eastern city of Nanjing said it would accept truckloads of watermelons worth up to 100,000 yuan as down payment from local farmers, state-run China News Weekly reported.

In the nearby small town of Wuxi, another developer was taking peaches as payment, the

Homebuyers in Qi county, a major garlic-producing region in central China's Henan province, can exchange their produce at three times the market price to settle part of their down payment.

Accepting crops at inflated prices has allowed developers to offer steeper discounts on homes than permitted by local governments while tapping into an underserved market.

"On the occasion of the new garlic season, the company has made a resolute decision to benefit garlic farmers in Qi county," homebuilder Central China Management said on social media in late May.

"We are helping farmers with love, and making it easier for them to buy homes."

About 30 properties had been sold since the garlic campaign was launched, it added.

Home sales in China measured by floor area have slid for 11 consecutive months and were down 31.5 percent in May compared to the same month last year, official data shows.

Bennett led it initially but stepped down following a series of defections and legislative defeats. Parliament dissolved itself, triggering new elections and handing power to Lapid.

Activists, parties hold protest against move to construct Metro car shed at Aarey

MUMBAI: Environmental activists and some day, but urged the government to reconsider its political parties, including the Uddhav decision. Thackeray-led Shiv Sena and the AAP, on Sunday staged a protest at the Aarey Colony, a green belt in suburban Goregaon, against the Maharashtra government's proposal to build a Metro-3 car shed at the site.



Holding placards, the protesters raised slogans against the new government's proposal to shift the Metro-3 car shed project back to Mumbai's Aarey forest, an 1,800-acre area that is often termed as the megalopolis's 'green lung'.

In their first cabinet meeting held soon after their swearing-in ceremony on Thursday, Maharashtra Chief Minister Eknath Shinde and his deputy Devendra Fadnavis of the BJP had directed the state administration to submit a proposal to build the Metro-3 car shed in Aarey Colony instead of Kanjurmarg.

The previous Uddhav Thackeray-led Maha Vikas Aghadi (MVA) government had shifted the proposed car shed site to Kanjurmarg from Aarey Colony on the ground of environment protection, but the issue got embroiled in a legal dispute.

The Thackeray government had also declared Aarey as a reserved forest.

Some leaders and workers of the Shiv Sena as well as its youth wing Yuva Sena, which is headed by former environment minister Aaditya Thackeray, participated in the protest.

Opposition to Metro carshed in Aarey is about protecting Mumbai's biodiversity, says Aaditya Thackeray, who represents Worli Assembly constituency in Mumbai, tweeted that he was not able to join the protest due to the crucial session of the state Legislative Assembly on Sun-

Party MP Priyanka Chaturvedi, who participated in the protest, accused the Eknath Shinde-led government of politicising the issue.

"What harm have Mumbaikars done to indulge in such politics? Why are you seeking revenge from Mumbai for your politics? If you have anything against us, fight us, why fight Mumbaikars,"" Chaturvedi said.

According to environment activists, the forest not only provides fresh air to the people of the city, but it also a key habitat for wildlife, including some endemic species.

The forest has some five lakh trees, and also has a couple of rivers and some lakes flowing through it, they say.

Ruben Mascarenhas, the working president of Aam Aadmi Party's (AAP) Mumbai unit ,said Aarey is the only urban forest ecosystem in the world and must be saved at all costs.

He said as a minister in the Uddhav Thackeryled government, Shinde was in favour of the Metro-3 yard being shifted to Kanjurmarg and was part of the decision.

"His U-turn right now is astounding," he said. Activists up in arms again as Maharashtra decides to move Metro car shed back to Aarey Colony

Maharashtra Navnirman Sena (MNS) chief Raj Thackeray's son Amit also came out against the proposed construction of the car shed in Aarey. He said the government's decision has shocked many nature lovers like him and added that he hoped that the Shinde-led dispensation will reconsider its decision.

On Friday, addressing a press conference at Shiv Sena Bhavan, the party headquarters at Dadar in central Mumbai, Uddhav Thackeray had made a fervent appeal to the new government not to go ahead with the Metro-3 car shed project at Aarey Colony.

"I am very upset. If you are angry with me, then vent out your anger, but don't stab Mumbai in the heart. I am very upset that the Aarey decision has been overturned. This is not a personal property," he had said.

The officer said police were interrogating the suspect to ascertain the intention of the trespassing.

to outpace other segments

NEW DELHI: From mere 15% market share 2 decades ago to accounting for over 40% of the total domestic passenger vehicle (PV) sales, demand for sports utility vehicles (SUVs) continues to outpace other segments by a big margin.

A change in consumer preferences to opt for an upright driving stance and high ground clearance vehicle that got complemented with multiple options available at an affordable price point played a big role in mainstreaming SUVs, which a decade back were mostly associated with big, bulkier, diesel-powered vehicles that had off-roading capabilities.

Mitul Shah, head of research at Reliance Securities, said the launch of budget compact SUVs 7-8 years ago led to the beginning of the current trend of preferring SUVs to small cars. Significant lower pricing compared to conventional large SUV

with over 50% market share, had a 15% share last fiscal while Maruti Suzuki, with only two options, had nearly 12% share in the SUV market.

"Competition in the segment would further intensify with numerous launches planned by all the key players for the coming period, which may put some pressure on pricing and margins of the companies, going ahead, though overall margins of SUVs are better than small cars in general," said Shah.

Not only the established automakers, new carmakers and those who are trying to revive their fortune in India are banking heavily on SUVs. For example, Kia Motors, in less than three years has become a serious player in the Indian PV space by having an all-SUV portfolio (except for Carnival UV) while Volkswagen (including Skoda) has seen a big surge in sales in recent months after launching a mid-size



and increasing first-time buyers in lower age groups who prefer stylish sporty SUVs are key driving factors behind the rising contribution of SUVs in overall PVs, he added. Shashank Srivastava, Maruti Suzuki's senior executive director (marketing and sales), said SUVs currently account for 40% of all passenger vehicles sold in India.

"We expect the SUV segment to grow at a CAGR of 9-10% in the next 3-5 years and going by the vehicle-buying trends in other countries, which have seen a surge in SUV sales, this segment should comprise 49-50% of the domestic market in future," added Srivastava.

At present, there are about 50 vehicles in India that come in SUV body type while the number of hatchbacks has seen a steady decline over the last few years.

Cut Throat Competition

Three big launches from 3 top auto-makers and a brand new unveiling by Toyota highlights that demand for SUVs will remain robust. Hyundai recently launched the facelift of its sub compact SUV Venue to maintain its market leading position in the segment while Maruti Suzuki launched the all-new Brezza in what is seen as the first major launch to increase its share.

Home-grown auto-major Mahindra & Mahindra launched Scorpio N, the modern version of its highly popular Scorpio SUV, while Fortuner & Innova maker Toyota unveiled new Urban Cruiser Hyryder to challenge the likes of Hyundai Creta, Kia Seltos and other mid-size SUVs. Currently, Hyundai, with nearly 2.5 lakh SUV sales last fiscal, had a market share of 22% and leads the SUV segment, while its closest competitor Tata Motors had a market share of 18% in FY22 as it sold about 2.05 lakh SUVs.

Mahindra & Mahindra, which till last decade was the undisputed SUV champion SUV.

Maruti's Big Come Back

The country's largest carmaker Maruti Suzuki is betting big on SUVs to conquer a 50% market share in the PV market, which now has come down to around 42-43%. Besides Brezza, MSIL is launching a fresh product in the mid-size SUV seg-

"The All-New Brezza is an important step in this direction. This model is the first offering in our upcoming vibrant SUV portfolio," said Hisashi Takeuchi, Managing Director and CEO of MSIL. He added that the company's new model will be high on design, technology and features. Currently, the carmaker has only two SUVs in its long line-up and has a share of about 20% in the compact SUV segment.

Srivastava of MSIL said that its first midsize SUV 'hatchling' (the rebadged Toyota Hyryder) will be a hybrid vehicle in two variants - mild and strong hybrid. The SUV will be unveiled this month and mass production will begin from August.

Commenting on Maruti Brezza, analysts at Kotak Institutional Equity said that going by Google Trends data, they expect only a marginal increase in market share for the company in the compact SUV segment. It added that It will be challenging for Maruti Suzuki to enjoy the success of FY2017 when it used to have >40% market share in the compact SUV segment.

On Maruti's entry in the mid-size segment, Kotak noted that the company has only 5% market share.

"The company will soon be launching a mid-size SUV along with Toyota in order to address its product gap. While we expect the company to gain market share gain (+8-12%), we remain concerned on lack of diesel offering by the company (~60% of the sales in mid-size SUV is pertaining to diesel powertrain) given consumers preference for higher torque," the Kotak report said.

Demand for SUVs continues India's fuel sales soar with overall economy picking up pace in June

NEW DELHI: India's petrol and diesel sales soared in June on the back of the start of the cropping season, summer travels and an overall pick up in economic activity, preliminary industry data showed.

The start of the cropping season helped diesel demand register double-digit growth over the pre-pandemic period -- a record in recent years. litre hike in petrol and diesel prices after an over four-month hiatus.


The government had on March 25, 2020 imposed a nationwide lockdown to control the spread of coronavirus. The complete lockdown, which halted mobility and crippled business, was slowly eased after two months.

Cooking gas, whose prices were hiked by Rs

103.50 per cylinder since March, saw sales rising by a marginal 0.23 per cent to 2.26 million tonnes in June. This was 9.6 per cent higher than the consumption in June 2020 when the government extended free cooking gas to the poor to help them tide over the hardships of the lockdown. LPG consumption was

Jet fuel (ATF) sales more than doubled to 535,900 tonnes as the aviation sector opened

ATF consumption was 150.1 per cent more than June 2020 but 12.9 per cent lower than the pre-COVID sales of 615,400 tonnes in June 2019. Month-on-month sales were up 6 per cent.



Industry sources attributed the pick-up in diesel demand -- which first rose above pre-pandemic levels in April - to higher consumption by the agriculture and transport sectors.

Petrol sales by state-owned fuel retailers, which control roughly 90 per cent of the market, at 2.8 million tonnes in June were 29 per cent higher than the same period last year when a devastating second COVID-19 wave wreaked havoc on the economy.

Government imposes restrictions on exports of

This consumption was 36.7 per cent higher than the demand in June 2020 and 16.5 per cent more than 2.4 million tonnes of sales in the pre-COVID June 2019.

Month-on-month sales were up 3.1 per cent, as per the preliminary data.

Sources said consumption in June was helped by the low base effect of last year.

Consumption has been on the rise since May when annual summer vacations led to higher

requires all its players to play as a unit to win, India too is a team whose success is "based on all its people, all the religions, all the languages, the States and all the communities" here coming together.

"That is what team India is. However, we have a ruling dispensation which does not understand this. They think by dividing India along religious lines, language lines, community lines, Team India can be successful. You can see the result of hatred and division. You can see the economic collapse that has taken place. You can see the joblessness that is apparent to every single person," he said.

"Therefore, my advice to you is that the same way you treat your fellow players in the team, treat all Indians as a team. Carry everybody together. Regardless of where they come from, regardless of their religion, language or community, treat them all the same. Then Team India will overcome all the challenges before it," the Congress MP said.

Gandhi, in his speech, further said that the only India possible was a "secular India".

"There is no other India that is possible. An India that is divided along religious lines, that is divided along linguistic lines, is no longer India. An India where people feel humiliated because of the State they come from, the religion they follow or the language they speak, this is not the true India. India is a union of all States, religions, languages and communities and India exists only if every person who belongs here feels comfortable here," the Congress MP said.

Gandhi was on a three-day visit to Kerala and will return to Delhi tonight.

our own revenue in the budget has exceeded the devolution from the Centre by a substantial margin. Thus, the Own Revenue/GSDP ratio would be 13.20 per cent in 2022-23."

To achieve the high growth rate, several key social sectors have been allocated higher allocation. Social sector expenditure has been pegged at 34 per cent of the total budget while development sectors have been provided the rest of the funds.

While Rs 12,624 crore has been allotted for the health sector, an increase of 38 per cent over the previous year, housing has got Rs 6,406 crore, an increase of 97 per cent. In a bid to make Odisha a sports hub, Rs 911 crore has been provided for development of sports, an increase of 100 per cent. Similarly, energy, and industries and MSME have got provision of Rs 3,497 crore and Rs 1,269 crore respectively. The allocation for religious and cultural places is Rs 1,970 crore, an increase of 97 per

Allocation for agriculture and allied sectors increased to Rs 21,166 crore in the 2022-23 budget, from Rs 20,344 crore that was projected in the vote-on-account. However, higher government spending will lead to a high debt burden of Rs 1,12,400 crore which is 15.6 per cent of the GSDP. The fiscal deficit projected in the budget will be Rs 21,588 crore, 3 per cent of the GSDP.

Several key schemes of the State government including KALIA and Biju Swasthya Kalyan Yojana (BSKY) have received higher allocation. While KALIA has been provided Rs 1,874 crore, the BSKY has received Rs 2,664 crore. Besides, Rs 2,325 crore has been provided under Mukhya Mantri Swasthya Seva Mission for upgradation of healthcare facilities across the State.

French soccer tournament celebrates diversity, fights racism

CRETEIL(KCN): An amateur soccer tournament in France aimed at celebrating ethnic diversity is attracting talent scouts, sponsors and increasing public attention, by uniting young players from low-inm

neighbourhoods with high-profile names in the sport.

The National Neighborhoods Cup is intended to shine a positive spotlight on working-class areas with large immigrant populations that some politicians and commentators scapegoat as breeding grounds for crime, riots and Islamic extremism.

Players with Congolese heritage beat a team with Malian roots 5-4 on Saturday in the one-month tournament's final match, held at the home stadium of a third-division French team in the Paris suburb of Creteil. The final was broadcast live

on Prime Video. The event competi-

tion grew out of local tournaments modelled after the African Cup of Nations that have been held in recent years in suburbs and towns across France where former immigrants with African backgrounds have lived for years or generations. This tournament, however, was broader, and international in scope.

Along with teams from former French colonies in Africa, the participants included teams from European nations like Portugal and Italy. Players from France's former colonies in Asia also competed.

The tournament, which was launched in 2019, challenges the French ideal of a colourblind republic that doesn't count or identify people by race or ethnic background. The ideal was intended to provide equal opportunity by treating everyone as simply French; in practice, people in places like Creteil experience discrimination and ethnic tensions daily.

"We are Afro-descendants, we are claiming our roots and we are proud," said tournament founder Moussa Sow, a French-Senegalese player who grew up in Creteil

neighbourhood with a tough reputation and who has played professionally in France and Turkey. "It's not because we carry this heritage that we are going to erase our French identity."

The France team like its World Cupwinning national team — is made up of white, Black, Arab and multiracial players that reflects the country's diversity.

"We have players who have two or three nationalities. It is a strength for us, a richness," Sow told The Associated Press. Sow witnessed first-

hand the growing tensions among young people divided into rival groups according to which quarter of Creteil they were from, and wanted to gather inhabitants around the love of soccer and a celebration of cultural heritage.

Mohamed Diamé, who made 31 appearances for Senegal and played for West Ham and Newcastle in the English Premier League, former Mali and Paris Saint-Germain defender Sammy Traoré and Senegal manager Aliou Cissé all took part. In February, Cissé became a national hero after guiding Senegal to longawaited victory in the African Cup of Na-

Traoré and Diamé both made it to the top level in soccer and both grew up in Creteil, providing an

example to young people that success is within their reach.

"I started my first training here when I was 7. I considered people from this neighbourhood as brothers," Diamé told the AP. "This feels like a pro tournament. We have a group chat, we support each other, we are determined."

The amateur cup has grown since Sow started in 2019. Colourful placards of multinationals and local companies sponsoring the event were seen around the field. Young people and families can grab a merguez sandwich a spicy sausage of North African origin long popular around France's soccer stadiums — or other snacks and sing along to popular French songs, played by a DJ

near the field.

"I am happy and proud, despite the anxious climate in France, to see people of different generations gathering," Sow said.

Even though the tournament is strictly amateur, the technical level among players was good. At last weekend's semifinals, high-quality crossfield passes and clever dribbles were cheered by the crowd. Some scouts were on the sidelines, sensing an opportunity to recruit talented young players.

Suburbs and satellite towns around big cities, known in French as "les banlieues," are fertile ground for soccer talents in Europe. Academies in France — notably Lyon, Monaco, Nantes and Rennes — are ranked among the best in the Europe along with

Spain for developing young players such as Real Madrid great Karim Benzema and World Cup star Kylian Mbappé.

But these same areas have also carried and been scarred by a rough reputation.

At the end of May, some far-right politicians blamed young people from the suburbs for violence outside the Champions League final at Stade de France in the Paris suburb of Saint-Denis. They were widely accused of vandalism, disruption of public safety and fraud.

Sow stressed that despite many people being suspicious of young people from the suburbs, where poverty and minority populations are concentrated in France, the tournament in Creteil has gone well. Defeats have been ac-

cepted with grace, and fans who have run onto the field after wins have been joyous rather than violent.

The mayor of Creteil supports the events, and a newly elected parliament member for the district, Clémence Guetté of the left-wing parliamentary coalition NUPES, came to the semifinals. Guetté called it a "unifying" event that promoted "beautiful values" that sport generates. Diamé, who made around 240 Premier League appearances, has never let that take him away from his roots. "No matter if you are Black, white, or Asian, everyone is welcome," he told the AP. "Children, parents, grandparents, uncles or aunts. Everyone is here to enjoy a pure moment of pleasure."

Wimbledon: Eight-time champion Federer pays a visit



WIMBLEDON: Roger Federer returned to Wimbledon as the All England Club prepared to celebrate the centenary of Centre Court. Federer has won eight Wimbledon titles — a men's singles record — but is not playing at the grass-court tournament for the first time since his debut in 1999.

The 20-time Grand Slam champion was

dressed in a dark suit and white sneakers as he walked the grounds toward Centre Court. Federer said earlier this year that any tournament comeback from his knee surgery last year will not be until at least the late summer.
