TOKYO(KCN): Japan protested to Beijing after spotting Chinese and Russian warships just outside its territorial waters around the disputed East China Sea islands on Monday.







State Registers 15K Rape Cases

Bhubaneswar(KCN): State has registered over 15,000 rape cases during the period from 2019 to 2022, Minister of State (MoS) for Home, Tusharkanti Behera informed Assembly, Monday.

While giving a written reply to a question asked by Congress MLA Santosh Singh Saluja, the Minister said a total of 15,713 rape

cases have been registered between 2019 and 2022 in Odisha.

Of the total cases registered, in 10,129 cases women were the victims while 5,584 sexual assaults cases against minors were reported, he said.

While 4,585 rape cases

were registered in 2019, 4,630 cases recorded in 2020. The state has witnessed a steep rise in the rape cases in 2021 with 5,198 cases. This year till April, Odisha has registered 12300 rape cases, Mr.Behera said.

Out of the total rape cases reported in the period, 1635 minor rape cases were registered in 2019, while the state had witnessed 1,646 minor rape cases in 2020 and 1871 in 2021. In 2022 (till April), 868 rape cases have been registered of which 432 cases are sexual assaults against minors.

Similarly, the state has also registered 3756 dowry torture and 341 dowry homicide cases in 2019, whereas, 320 dowry homicide and 3759 dowry torture cases were reported in the next year (2020), Mr.Behera informed the House.

In 2021, 293 dowry homicide and 4953 dowry torture cases against women reported in Odisha. Moreover, 1442 dowry torture and 85 dowry related homicide ceased registered till April of 2020, he added.

The state has witnessed a steep rise in nondowry related torture against women during the last three years. While 2532 such cases were reported in 2019, the cases increased to 3153 in 2020 and 4889 in 2021. Besides, 1430 non-dowry torture

against women were recorded in Odisha during first four months of the current year. In a written reply to a question of BJD Member Prafulla Samal, MoS Home said 5826 out of 7603 missing girls have been traced during the three years. The reply of Minister indicates that 1777 girls are still missing. The Minister also informed that 1096 cases of missing of minor boys have been reported in Odisha during 2019 to 2021. Of which, 907 boys have been traced out.

Moreover, the state has recorded missing of 25,973 women during the period, of which 9920 were rescued or traced out while 16,053 women are still missing in the state.

Export Rise in Major Sectors

New Delhi(KCN): Santosh Sarangi, Director General Foreign Trade (DGFT) is happy as the country has achieved a monthly value of merchandise export in June 2022 amounting USD 37.94 billion, an increase of 16.78% over USD 32.49 billion in June 2021.

Mr.Sarangi discussed about India's mer-chandise export in April -June 2022-23 with officials. While it is USD 116.77 billion with an increase of 22.22% over USD 95.54 billion in April -June 2021-22.

Value of non-petroleum exports in June 2022 was 30.12 USD billion, registering a positive growth of 5.53% over non-petroleum exports of USD 28.54 billion in June 2021. The cumulative value of non-petroleum exports in April -June 2022-23 was USD 92.49 billion, an increase of 11.92% over USD 82.65 billion in April -June 2021-22. Value of non-petroleum and non-gems and jewellery exports in June 2022 was USD 26.75 billion, registering a positive growth of 4.0% over non-petroleum and non-gems and jewellery exports of USD 25.72 billion in June 2021. The cumulative value of nonpetroleum and non-gems and jewellery exports in April -June 2022–23 was USD 82.43 billion, an increase of 12.19% over cumulative value of non-petroleum and non-gems and jewellery exports of USD 73.47 billion in April -June 2021–22.

Petroleum products (98.01%), Electronic goods (50.66%) and RMG of all Textiles (44.67%) led the way in high increase in exports during June 2022.

India's merchandise import in June 2022 was USD 63.58 billion, an increase of 51.02% over USD 42.1 billion in June 2021. India's merchandise imports in April -June 2022-23 was USD 187.02 billion with an increase of 47.31% over USD 126.96 billion in April -June 2021-22.

Value of non-petroleum imports was USD 42.84 billion in June 2022 with a positive growth of 36.36% over non-petroleum imports of USD 31.42 billion in June 2021. The cumulative value of non-petroleum imports in April -June 2022–23 was USD 126.95 billion, showing an increase of 32.18% compared to non-oil imports of USD 96.04 billion in April -June 2021–22.



Udaipur brutality and some points to ponder

The Udaipur shocker has become a gruesome tale of brutality executed in the name



of religion. Once again there was uproar against radicalization, but of course, this time it was limited within the boundaries of Rajasthan. Bubbles of repercussion else-

where got easily settled. The democratic minds in India are determined not to talk too much about this bone-chilling persecution. Not only India but also the world across, a sense of understanding is effervescent, that there is no escape but fall prey to the contradictions of beliefs which draw justice lines around the conscience of human intelligence. For India, this incident of beheading a Hindu shopkeeper is not less than the beheading of its democracy. The horror was capable enough to send feelers across India's social canvass, significantly reminding its people that it is not the percentage of population of a certain community that matters but the sense of unity that a thought can bind and blindfold its people. Kanhaiya Lal Teli's killing is seen to be justified as a reaction, a spontaneous outrage, an aftermath effect of the TV debate, which literally shook the country a little while ago and much to its surprise the West Asian friends of the Modi dispensation came rattling and the BJP, in its diplomatic U-turn acted against its media faces. Paradoxically, India's precariousness is evident from its efforts to balance between its democracy and a theocracy terrifyingly pulling its ugly head from the dungeons of theology. The horror in Udaipur was an act mostly determined to bring the idea "Kill one, frighten a thousand", a lesson that the plural social establishment should diligently learn from.

It's time for us to realize the quantum of

mistrust and enmity that we as a nation

have grown into. The street violence in the name of the controversial TV debate across the country was not a spontaneous outrage. India was clouded with a conspiring silence for almost ten days after the debate and the uproar was probably an effect of a meticulous plot hatched deliberately to create a whirlwind of unrest and bring the country on its knees. The idea of secularism that the country offers in its democratic platter has shrunk too much to be identified. If a majoritarian mindset was responsible for the horror that India witnessed in Udaipur, the violence erupted in West Bengal before and after the state elections, killing and raping numerous Hindus should have attracted equal reaction. It is time for India to define blasphemy based on its democratic principles. If blasphemy is punishable to one religion, a secular country should legally profess the same for all religions democratically. Easily getting offended on facts that are genuine and codified in religious texts is evidently meant to deliberately derail an intellectual discourse and an ideology, with short of facts to justify its anomalies, frequently attempts to make its presence felt through violence. Scarcity of intellectual depth and scientific comprehension in religions force them to pull cleavers to slit open their ideological opponents. The question is, how long the world should remain susceptible to brutality in the name of religion.

for obsessive compulsive disorder, although it is also prescribed for depression. An offpatent drug, fluvoxamine is cheap and widely available. making it potentially attractive as repurposed COVID-19

treatment—if it can be shown to be effective. The drug drew splashy headlines last October, when a study reported that it lowered hospitalization risk among COVID-19 outpatients. But debate on this and other fluvoxamine data has been swirling for some months now.

Currently, National Institutes of Health (NIH) guidelines state there is insufficient evidence "to recommend either for or against the use of fluvoxamine for the treatment of COVID-19." The Infectious Diseases Society of America (IDSA) recommends the drug only be considered for COVID-19 in the context of clinical trials.

Recently, the US Food and Drug Administration (FDA) turned down an emergency use authorization request, filed late last year by University of Minnesota infectious diseases researcher and physician David Boulware, that would have provided official backing for doctors to prescribe the drug as an early treatment for people infected with SARS-CoV-2

The agency "determined that the data are insufficient to conclude that fluvoxamine may be effective in the treatment of nonhospitalized patients with COVID-19 to prevent progression to severe disease and/or hospitalization," it announced in a document widely shared online this week.

In the wake of this latest decision, here's a look at the available evidence on the drug's efficacy against COVID-19, as well as perspectives of scientists and health experts about what that evidence means.

What do the clinical data on fluvoxamine show? Despite a recent uptick in media coverage of the drug, most discussions about fluvoxamine's efficacy in COVID-19 patients draw on data from two randomized controlled trials of un-

vaccinated adults that were published before this year.

The first, dubbed STOP COVID, was launched as a preliminary study in 2020 by Washington University in St. Louis psychiatrists Angela Reiersen and Eric Lenze. Reiersen has written about how she came up with the idea to test the drug while ill with COVID-19, having read that fluvoxamine could dampen inflammation and improve survival in mice models of sepsis.

Different people have come to very different conclusions about whether or not fluvoxamine should be considered a viable treatment for COVID-19.

The STOP COVID results, published in JAMA in late 2020, hinted that 100 mg of fluvoxamine taken three times a day for 15 days could reduce an infected person's risk of clinical deterioration, as assessed through a combination of measures including reported shortness of breath and a need for supplemental oxygen or decrease in oxygen saturation.

Limitations including a small number of trial participants and a reliance on patient-completed surveys for data collection meant that "larger randomized trials with more definitive outcome measures" would be needed to determine clinical efficacy, the authors wrote in their paper.

The second published study, which Reiersen and Lenze also worked on, was part of the TO-GETHER trial, a multi-arm study designed to evaluate repurposed drug treatments in high-risk outpatients with COVID-19. The fluvoxamine arm included more than 1,400 participants in Brazil, about half of whom took a placebo and half took 100 mg of fluvoxamine two times a day for 10 days.

The results, which sparked the spate of media coverage in October when they were published in The Lancet Global Health, showed that treatment was linked to a statistically significant, moderate reduction in the risk of hospitaliza-tion due to COVID-19—provided that "hospi-talization" included emergency room visits of at least six hours, a definition the study authors justified based on the way Brazil was operating field hospitals at the time. The drug didn't show an effect on mortality in the study's main analysis.

In addition to these studies, there are at least two unpublished datasets from trials that failed

to find evidence of fluvoxamine's benefit as an early COVID-19

treatment. STOP COVID 2, a follow-up to STOP COVID, tested 100 mg twice a day. This trial was stopped early for futility last year, according to an NIH summary, "after lower than expected case rates and treatment effect were observed." Reiersen tells The Scientist that the team had trouble recruiting patients and is planning to publish its data soon.

A separate trial run by Boulware and colleagues at Minnesota, known as COVID-OUT, was also recently terminated early for futility. That trial used doses of 50 mg, taken twice daily. Boulware tells The Scientist that the team plans to release the COVID-OUT data when possible. What are health experts saying about the evidence?

Major US health organizations have taken a relatively consistent line: that there's not enough evidence to say the drug works. In updates posted in the last few months, the NIH and IDSA note a lack of data on fluvoxamine's effect on death rates, as well as difficulties interpreting the TOGETHER trial's definition of hospitalization and differences in adherence to treatment between the fluvoxamine and placebo groups. The FDA—which, in an unusual move, issued a 27-page summary detailing its reasoning for rejecting Boulware's request-echoed those concerns in its decision earlier this month. It additionally highlighted the negative findings from COVID-OUT, uncertainty about the drug's mechanisms of action, and the availability of already approved antiviral drugs such as Pfizer's paxlovid for US patients.

Various physicians and health experts concur with the view that there's not enough evidence to recommend fluvoxamine as a COVID-19 treatment. In late April, Abhijit Duggal, vice chair of critical care at the Cleveland Clinic, told MarketWatch: "Based on existing data, this is not something that we feel needs to be looked at as a standard of care for patients with COVID.

... In the day and age of COVID, there's a lot of things that have been introduced based on data that would not have really stood the test of scientific rigor in any other situation."

Justin Morgenstern, an emergency physician in Toronto who has tracked research on potential COVID-19 treatments on his blog First10EM, tells The Scientist he thinks fluvoxamine should not be prescribed for the disease based on available data. (Ontario is one of a couple of regions in North America that have updated their local health guidance to suggest physicians consider fluvoxamine as a treatment in high-risk patients.)

From a statistical perspective, given the huge number of compounds tested against COVID-19 in the last two years, it's highly likely that some show moderately positive trial results despite no real health benefit, he adds, making replication of findings essential. With as many fluvoxamine trials stopped for futility as trials that found an effect, "there's a reasonable chance that it's in that false-positive, or chance-alone finding," he adds.

The debate around fluvoxamine highlights the need for better and faster ways of organizing and evaluating clinical research, particularly for off-patent drugs that lack the logistical and financial support provided by the pharmaceutical industry.

Others have expressed more enthusiasm about fluvoxamine. University of Wollongong epidemiologist and public health researcher Gideon Meyerowitz-Katz, who has collaborated with the TOGETHER trial's Edward Mills on an unrelated project, calls the TOGETHER trial a "fantastic piece of research [that] shows a convincing benefit" for fluvoxamine. The study asked its questions in "a robust, scientific way," he says, adding that some of the negative reaction to it seems unjustified.

It's a new era for funding on both sides of abortion debate

NEW YORK: The Supreme Court's overturning of Roe v. Wade has ushered in a new era of funding on both sides of the abortion debate.

With the legality of abortion now up to individual states to determine, an issue long debated by legislators and philanthropists when it was largely theoretical because only the Supreme Court could change it — suddenly has real-world ramifications for people across the country. And donors on both sides will now be expected to put money behind their words.

"I think we will see funding that's going to be a lot less performative and a lot more realistic," said Leslie Lenkowsky, a professor emeritus in public affairs and philanthropic studies at Indiana University. Those kinds of gifts are already starting to arrive.

Donations are pour-

ing into nonprofit groups in what experts call an example of "rage giving." Yet few believe the additional funding for their causes will be enough to address the increased demand for help either for women to obtain abortions or to support babies put up for adoption or into the foster care system.

At The Brigid Alliance, a New York nonprofit that provides funding and logistical help for people seeking abortions, the number of donors more than doubled to 6,000-plus after the leak in May of a draft of the Supreme Court ruling, according to Sarah Moeller, the group's director of resource development. Once Roe was overturned last month, their number of donors doubled again within three days, with people contributing anywhere from \$5 to \$50,000. Even so, Moeller said, the donations can't begin to match the need.

"Since September, when Texas implemented their six-week ban, we saw a 900% increase in requests for our services," she said. "We expect that we'll continue to see surging rates as the dominoes fall after this ruling."

The Brigid Alliance helps about 125 people a month with abortion logistics and expenses — about \$1,200 per person. Most requests come from women in the South, Moeller said, and inflation has increased many of the costs. "I think it's going to be impossible for every individual who needs abortion care to be able to get to their appointments," Moeller said. "We're doing everything that we can to grow in order to meet increasing demand. And every single person who is able to help makes a huge difference. But the volume is just incalculable at this point."

"The end of Roe v. Wade, unfortunately, does not mean the end of Planned Parenthood or the end of abortion," Shakely said. "Abortion will tragically continue to be a multibilliondollar business in America until we clarify that abortion is incompatible with constitutional justice."

Brandi Collins-Calhoun, a manager at the National Committee for Responsive Philanthropy, said she hopes donors will regard the next stage in the abortion debate as a reason to redouble contributions to what she sees as



reproductive justice.

"There are a lot of gaps and voids that both the states and philanthropy created, because of their practices — the ways that they frame abortion as a rights issue, not a health issue," she said. "I think anybody who has the capital and the access should be paying for people's abortions. Whether that's the state, whether it's philanthropy — I think everybody has a responsibility.'

Aaron Dorfman, the committee's president and CEO, suggested that philanthropy's responsibility, in part, is to fund programs that the government can't or won't.

"It's a perfectly appropriate role for donors to step up in this way — to both meet an urgent need and also lay a framework for a better government that more fully meets the needs of its citizenry," he said. "Part of how philanthropy can do that is by investing in power-building work at state and local levels to support community organizing, and advocacy work that really helps change how government functions and who it is responsive to."

Modi's security scare? AP Police denies lapse as black balloons released near PM chopper

VIJAYAWADA: In what is termed as a security breach by the State BJP unit, a group of Congress leaders released black balloons into the air as a protest against the visit of Prime Minister Narendra Modi to the State without fulfilling the assurances he made before the elections. After finishing his twoday visit to Hyderabad, Narendra Modi arrived at Gannavaram airport in the morning where Governor Biswa Bhusan Harichandan, Chief Minister YS Jagan

Mohan Reddy, and other officials welcomed him grandly. From there, the dignitaries were supposed to reach Amiram village near Bhimavaram in Mi-17 choppers to take part in the 125th birth anniversary celebrations of

revolutionary freedom fighter Alluri Sitarama Raju.

Minutes before Modi's arrival, Congress workers Sunkara Padmashree and two others were seen walking toward the airport holding placards and black balloons to stage a protest against BJP and Modi.

"Immediately, we took three Congress leaders Sunkara Padmashree, Challa Savithri, and Kishore into our custody and booked them under sections 353, 341, 188, and 145 of IPC, Krishna district SP P Jashuva told TNIE.

Windfall tax on crude oil: Govt rakes in Rs 1.3 lakh crore; here's what brokerages say

NEW DELHI: The windfall taxes imposed by the government on domestic crude oil production and fuel exports will hit ONGC's earnings severely while shaving off up to USD 12 per barrel in refining margins for Reliance Industries Ltd.

The new levies will give the government up to Rs 1.3 lakh crore additional revenue, brokerages said.

In a surprise move, the government on July 1 increased import duties on gold (by 5 per cent), added export duties on petrol and ATF (Rs 6/ litre; USD 12 per barrel) and diesel (Rs 13/ liter; USD 26/bbl) and slapped a windfall tax on domestic crude production (Rs 23,250 per tonne; USD 40/bbl).

imports and help the external balance marginally.

"Yet, Friday's (July 1) measures will serve squarely to raise revenue for the government." Duties on crude oil should raise an additional USD 3-4 billion (net of lower royalties, income taxes and dividends) while the gold duty can raise USD 1.5-2 billion annualized.

Export taxes on diesel/petrol can raise close to USD 9 billion gross per annum, it said adding the revenue for current fiscal will be 75 per cent of these numbers.

"The government intent appears to be to maximise revenues from upstream producers by capping their upside from higher oil prices as well as disincentivising refined product ex-



This follows earlier duties imposed on steel (15 per cent) and iron ore (up 20-45 per cent). While the export tax will be applicable on only-for-exports refinery of Reliance Industries (RIL), the restriction on product exports wherein at least 30-50 per cent is first supplied domestically will not apply to SEZ units. HSBC Global Research in a note said in May 2022, the government announced a cut in the excise duty of Rs 8 per litre on petrol and Rs 6 a litre on diesel, which is estimated to have reduced its revenues by Rs 1 lakh crore. "The additional excise duty just announced and effective from July 1, 2022 aims to fill this revenue gap. We estimate these taxes could generate Rs 1.2 lakh crore in government revenue and could also discourage the export of products which are being diverted away from the domestic market." The windfall tax on crude production could generate revenue of Rs 65,600 crore and tax on export products another Rs 52,700 crore if they were to be continued for the full year. Kotak Institutional Equities said the taxes will result in additional tax revenues of Rs 1.3 lakh crore on an annualized basis and Rs 1 lakh crore for the rest of FY2023 assuming the government retains the taxes for the entire year. UBS estimated that the government can raise Rs 1.38 lakh crore annually from additional taxes. "Based on diesel and gasoline export volumes in past year and estimate for FY23, we estimate additional revenues of Rs 68,000 crore on three transportation fuels. Similarly, windfall taxes on crude can raise Rs 70,000 crore in additional revenues." Nomura said the windfall taxes could potentially impact RIL's GRM by USD 12 per barrel (Rs 47,000 crore on an annualised basis). Goldman Sachs said it saw limited earnings risk for RIL (despite wide scenarios of USD 1.5-12.7 risk to gross refining margins or GRMs from new taxes) as the spot implied GRM run rate is over USD 27 per barrel. HSBC said while the new tax will lower ONGC earnings by Rs 30 per share, its impact on RIL would be Rs 36 a share. "We continue to believe the loss on its domestic marketing margin is still greater than the export tax, and thus, we believe RIL is likely to continue to export significant amounts," HSBC said.

The USD 40 per barrel windfall tax is "a material negative for ONGC in particular where earnings are likely to be severely impacted," it said.

On the top of the new levy, ONGC will continue to pay oil 20 per cent (a fifth of the oil price) as OIDB cess and another 10-20 per cent royalty.

The net realisation for ONGC will be around 40 per cent of the oil price.

The gross refining margin (GRM) impact for RIL assuming two-thirds of its diesel, petrol and ATF were being exported, could be USD 9-10 per barrel, Citi said adding the firm must be currently earning USD 25 per barrel GRM. "The earnings impact for RIL is likely to be less material given offsets from marking-tomarket for current GRM strength, which would likely preclude earnings upgrades rather than drive major downgrades.' Kotak said it does not "see much merit in the government's decision to impose export duties on exports from RIL's SEZ refinery. The government has cited increased exports of diesel and gasoline and lower availability of such products for the domestic market as a key reason to impose the exports tax. However, RIL's SEZ refinery was set up for exports and its products were not intended for sale in the domestic market." It said demand-supply analysis of petroleum products shows that there is enough availability of diesel and petrol for the domestic market even excluding volumes from RIL's SEZ refinery.

"We managed to do centralized withdrawal and evacuate all injured," Haidai said. "We took back all the equipment, so from this point withdrawal was organized well."

The Ukrainian General Staff said Russian forces were now focusing their efforts on pushing toward the line of Siversk, Fedorivka and Bakhmut in the Donetsk region, about half of which is controlled by Russia. The Russian army has also intensified its shelling of the key Ukrainian strongholds of Sloviansk and Kramatorsk, deeper in Donetsk.

On Sunday, six people, including a 9-year-old girl, were killed in the Russian shelling of Sloviansk and another 19 people were wounded, according to local authorities. Kramatorsk also came under fire on Sunday. An intelligence briefing Monday from the British Defense Ministry supported the Ukrainian military's assessment, noting that Russian forces will "now almost certainly" switch to capturing Donetsk. The briefing said the conflict in Donbas has been "grinding and attritional," and is unlikely to change in the coming weeks.

While the Russian army has a massive advantage in firepower, military analysts say that it doesn't have any significant superiority in the number of troops. That means Moscow lacks resources for quick land gains and can only advance slowly, relying on heavy artillery and rocket barrages to soften Ukrainian defences. Russian President Vladimir Putin has made capturing the entire Donbas a key goal in his war in Ukraine, now in its fifth month. Moscow-backed separatists in Donbas have battled Ukrainian forces since 2014 when they declared independence from Kyiv after the Russian annexation of Ukraine's Crimea. Russia formally recognized the self-proclaimed republics days before its Feb. 24 invasion of Ukraine. In his nightly video address, Ukrainian President Volodymyr Zelenskyy acknowledged the withdrawal but vowed that Ukrainian forces will fight their way back. "If the command of our army withdraws people from certain points of the front where the enemy has the greatest fire superiority, in particular, this applies to Lysychansk, it means only one thing: We will return thanks to our tactics, thanks to the increase in the supply of modern weapons," Zelenskyy said. Since failing to take Kyiv and other areas in Ukraine's northeast early in the war, Russia has focused on Donbas, unleashing fierce shelling and engaging in house-to-house combat that devastated cities in the region. Russia's invasion has also devastated Ukraine's agricultural sector, disrupting supply chains of seed and fertilizer needed by Ukrainian farmers and blocking the export of grain, a key source of revenue for the country. In its Monday intelligence report, Britain's defence ministry pointed to the Russian blockade of the key Ukrainian port of Odesa, which has severely restricted grain exports. They predicted that Ukraine's agricultural exports would reach only 35% of the 2021 total this year as a result. As Moscow pushed its offensive across Ukraine's east, areas in western Russia came under attack Sunday in a revival of sporadic apparent Ukrainian strikes across the border. The governor of the Belgorod region in Western Russia said fragments of an intercepted Ukrainian missile killed four people Sunday. In the Russian city of Kursk, two Ukrainian drones were shot down, according to the Russian Defense Ministry.

Indian crude oil basket hits 10-year high; petrol, diesel prices unchanged

JP Morgan said while the duties on steel/iron ore helped reduce domestic prices and curb inflation, a higher tax on gold should decrease Haitong said India's total diesel demand is 80-83 million tonnes while the total PSU diesel supply is 65-68 million tonnes.

"Therefore, the rest can be met by private players like RIL and Nayara Energy. Similarly, total consumption of petrol in India stands at 30-31 million tonnes while PSUs supply is 21-22 million tonnes. Therefore, one-third of India's consumption can be fulfilled through private players.'

According to CLSA, RIL's GRMs may be hit by USD 5-6 per barrel due to the new tax. It said the new taxes would give the government extra annual revenue of Rs 1.1 lakh crore (\$14 billion), negating the Rs 97,000 crore revenue loss from the excise duty cut done about six weeks ago.

Credit Suisse said the impact on RIL from cess on the export of petroleum products is about USD 7-8 per barrel, translating to an annualized impact of USD 3.5-4.0 billion on EBITDA.

Bombay: The Indian currency, unmindful of its committment to the economy, is touching new lows each day. Last week, it tore into 79 against the US dollar and now seems steadfast on cracking 80. The RBI, which has all the powers to lord over the exchange rate, is intervening prudently and is instead letting the rupee find a level of its liking. Perhaps, for now.

The one thing that's weakening INR is higher demand for dollars. High imports led by soaring crude oil prices and sharp capital outflows (India being one of the worst among emerging Asian peers) are together raising the demand for dollars, depreciating rupee.

Since January, the domestic unit is down 5.6%



against the greenback over last year, prompting the central bank to spare \$41 billion out of its over \$600-billion-odd forex reserves war chest it built in the past two years. But that move has sliced India's import cover to single digits -- for the first time in three years. According to Barclays, RBI, under Governor Shaktikanta Das has a strong preference for currency stability and the ferocity of pressure on the currency can be seen from the fast depletion of forex reserves. That said, allowing INR to gently weaken for now could be the right strategy, allowing the import-export imbalance, or the trade deficit, to improve. A weakening rupee boosts exports, though given the slack in global demand, exporters aren't particularly enthused. Others believe, the central bank is letting the exchange rate adjust to new realiites, which in turn could act as a natural macro stabilizer.

Moreover, as Finance Minister Nirmala Sitharaman noted, the INR was relatively better placed than other global currencies against the greenback and pegged against other currencies, rupee is holding its ground, firmly.

LONDON: Manchester United have agreed a deal in principle to sign Denmark midfielder Christian Eriksen on a free transfer, according to reports on Monday.

United manager Erik ten Hag made the threeyear contract offer to Eriksen after the Dane's impressive comeback with Brentford.

The 30-year-old is reported to have a verbal agreement with United and will officially complete his move to Old Trafford after a medical.

Eriksen's impending switch to United completes an incredible return after his brush with death last year.

He had a cardiac arrest on the pitch in Copenhagen while playing for Denmark at the European Championship and was forced to leave Inter Milan after recovering due to Serie A health regulations.

Eriksen, fitted with a implantable cardioverter

defibrillator, proved his form and fitness during a loan spell at Brentford in the second half of last season.

He played 11 times in the Premier League for Brentford, scoring once and providing four assists.

Eriksen was also targeted by his former club Tottenham, but was impressed by Ten Hag after training with Ajax as part of his return to football following the cardiac arrest.

Ten Hag, who took charge at United in the close-season after leaving Ajax, is looking to revamp his new team after they finished a disappointing sixth in the Premier League last term.

United missed out on a place in this season's Champions League and could see Cristiano Ronaldo depart after the Portugal striker reportedly demanded a move to a team in Europe's elite club competition.

LONDON: Novak Djokovic admits he can see a lot of Jannik Sinner in himself as the pair face off for a place in the Wimbledon semi-finals on Tuesday.

Six-time defending champion Djokovic is in familiar territory, targeting an 11th semi-final at the All England Club and 43rd at the Slams. Italian 20-year-old Sinner is yet to get past the quarter-finals of a major. "I kind of see a little bit of myself in his game from the back of the court, playing flat backhand, constantly staying

Matteo Berrettini, who was runner-up to Djokovic last year.

Berrettini was the first Italian man to reach the Wimbledon quarter-finals since Davide Sanguinetti in 1998.

"It's going to be a tough match against Novak, of course. I mean, he's playing very, very good. I will try my best. That's the minimum I can do," said Sinner.

Djokovic will hope the Wimbledon schedulers are kind to him after he hit out at having to play

Birmingham Test: India 245 all out, set England 378-run target

BIRMINGHAM: India set England a recordbreaking target of 378 runs in the series-deciding test on Monday after getting bowled out for 245 on Day 4.

England has a tough task on its hand to level the series 2-2 with plenty of time left in the test match. England's best successful run chase in a test came against Australia at Leeds in 2019 when it made 362-9 to win by one wicket.

Skipper Ben Stokes claimed three quick wickets after lunch to finish with 4-33 as India's tail folded inside half an hour into the second session.

Matthew Potts (2-50) and Stuart Broad (2-58) struck in the first session after India resumed on 125-3, but lost the last seven wickets with the addition of 120 runs.

Earlier, England hit back with four wickets in an intriguing first session but India still stretched its lead to a strong 361 by reaching 229-7 by lunch.

England's ploy to use the part-time off spin of Joe Root inside the first half hour didn't work before it switched back to Broad.

Cheteshwar Pujara (68), who had completed his half-century in the last over of the third day, started off well by hitting James Anderson for two boundaries in one over, but fell off Broad's third ball.

Pujara had been patient throughout his over 3-1/2 hour knock, leaving dozens of balls outside the off stump before he cut hard at Broad and was caught at backward point.

Shreyas Iyer's (19) inability to cope against

the short deliveries yet again got exposed on English wickets when he played a tame pull shot against Matthew Potts (2-50) and was caught at mid-wicket.



First innings century-maker Rishabh Pant (57) completed his half century with a boundary off his pads to fine leg against Broad before Root plucked a fine catch as the left-hander attempted an extravagant reverse sweep against left-arm spinner Jack Leach.

Potts continued to threaten India's tailenders with short balls and Shardul Thakur got struck on the helmet twice before he finally holed out at deep fine leg while attempting a hook shot against the tall fast bowler.

Stokes then folded India's tail which put up a staunch resistance in the first innings. Mohammed Shami holed out off a short delivery; first-innings century maker Ravindra Jadeja (23) played onto England skipper and Jasprit Bumrah was caught in the deep after striking a six over fine leg. England has successfully chased down close to 300 runs in the last three test matches which led them to clean sweep the New Zealand 3-0.
