Despite numbers not in its favour, Oppn likely China slams US General for criticising its milito put up joint candidate for presidential poll

NEW DELHI(KCN): The opposition is likely to put up a joint candidate for the July 18 presi-



dential election despite not having numbers on its side and consultations in this regard have already begun.

Sources said that Leader of Opposition in Rajya Sabha Mallikarjun Kharge has reached out to leaders of some opposition parties and sought their views for a joint opposition candidate who can be fielded.

Some opposition parties are of the view that they should not give a walkover to the ruling dispensation but put up a fight, the sources

CPI Rajya Sabha member Binoy Viswam said the Congress had reached out to him to discuss a "common candidate".

"Mallikarjun Khargeji called and consulted about a common candidate for the presidential election. I told him that the CPI would support a common candidate with secular credentials and progressive outlook. He replied that Madam Soniaji and the Congress Party also have the same position," Viswam said in a tweet.

"Consultations for the presidential election have begun among various opposition parties," a senior opposition leader told PTI, adding that once a consensus is arrived at, a joint candidate may be put up.

The BJP-led NDA is comfortably placed to win the presidential election with its vote share touching the 50 per cent mark of the total elec-

While there are 776 MPs of both Lok Sabha and Rajya Sabha, each having 700 votes, there are as many as 4033 legislators in states with different votes who will also elect Ram Nath Kovind's successor.

Though the final list of electors will be notified after the bye-elections to three Lok Sabha seats and the Rajya Sabha polls to 16 seats, the NDA has 440 MPs in its favour while the opposition UPA has around 180 MPs, besides 36 MPs of Trinamool Congress who normally **CONTINUED ON: P-7**

Chinese Foreign Ministry spokesman Zhao Lijian made the remarks during a media briefing here while replying to a question on the comments by US Army's Pacific Commanding sides have the will and capability of resolving the question through dialogue and



Assessing the True Meaning of US Generosity in Ukraine

The US Congress recently voted to authorize \$40 billion to the war effort in Ukraine. The resulting legislation that provides the framework for this allocation bears the title, "Ukraine Democracy Defense Lend-Lease Act of 2022." On its



website, the Department of Defense explains that the law "authorizes the administration, through fiscal year 2023 to lend or lease military

equipment to Ukraine and other Eastern European countries."

Most commentators have focused on the enormity of the sums of money involved. Along with the \$13 billion already pledged to Ukraine's military effort, this means that in just a few months the US contribution (\$54 billion and counting) to Ukraine's war effort rivals Russia's entire annual military budget (\$66 billion). But there is another less talked-about historical facet of this question: the 82 year-old precedent for this new Lend-Lease law.

During his 2020 campaign, candidate Joe Biden promised, if elected, to become the new Franklin Delano Roosevelt (FDR). He assigned himself the mission of transforming a nation still confused by the hyperreal presidency of billionaire president Donald Trump. Biden promised to promote FDR scale reforms designed to focus on the real needs of the people. Ironically, this new Lend-Lease law, responding to the needs, not of the American people, but of the Ukrainian military, may turn out to be the only reminder Biden is capable of summoning up that reflects FDR's legacy. Biden has failed to push through any of the supposedly ambitious social policies he promised to promote as his updated "New Deal."

Instead, Biden has revived a policy dating from the period in which the dominant mood of isolationism in Washington had positioned the US as a bystander in Europe's raging war that began in September, 1939. In December 1940, a year before the attack on Pearl Harbor, Roosevelt's government cleverly invented what would be called the Lend-Lease policy, designed to make the growing American military arsenal available to already impoverished Britain and its allies. Today's Weekly Devil's Dictionary definition:

Lend-Lease:

A concept that plays on the ambiguity that exists between the notion of generosity associated with lending to the needy and the hard-nosed commercial practice of making someone pay for the use of a piece of property that already exists without being currently exploited

Contextual note

Biden offered this justification of the new Lend-Lease bill: "The cost of the fight is not cheap, but caving to aggression is even more costly." He certainly meant this to sound like a banal statement of a principle so abstract, so divorced from any real context and so self-evident that most people reading it would pay little attention to its meaning. It leaves the impression of an attitude of limitless generosity by agreeing to assume the cost of Ukraine's struggle. The world's wealthiest and most powerful nation will make the financial sacrifice of supporting a valiant people in

By putting the emphasis on the noble act of not caving to aggression, Biden spares himself the further calculation that should be on everyone's mind. The cost is not limited to the \$53 billion Ukraine will owe the US. Beyond the literal value of the material and services provided, so long as the war continues, Ukraine will continue enduring the costs in lives and property damage associated with a war that, thanks to this massive transfer of technology, is likely to last for many months if not years. Biden himself has conveyed his belief that the war will continue for a long time to

That means Ukraine's debt to the US is likely to grow exponentially. Given the precedent of wars in Afghanistan and Iraq, that could be a very long time. In an important article in Foreign Policy, Michael Hirsch makes a pertinent point that Biden and the media have studiously avoided. Hirsch notes that Biden's Ukraine policy "raises the prospect for a drawn-out global cold war with not only Russia but China as well." He adds that it inevitably augments the risk of a nuclear conflagra-

In the short term, however, American generosity can be seen as the programmed impoverishment of Ukraine. This helps to clarify Biden's deeper strategy that has little to do with the noble struggle of the Ukrainians seeking to respond to aggression. It has everything to do with the avowed intent of weakening Russia as well as the (as yet unavowed) intent of using NATO expansion and the inevitable weakening of Europe's economy to conthat would appear to be a generous, disinterested offer of assistance.

He notes that at the end of the war the US made Britain pay a heavy price.

In his statement explaining the importance of the 2022 law in favor of Ukraine, Biden, as expected, stressed the perennial theme of the defense of the Ukrainian people and their commitment to democracy, a democracy avidly assisted by a well-armed and significant neo-Nazi minority that over the past eight years the US has never found in the slightest embarrassing. "I'm signing a bill," Biden declared, "that provides another important tool that directly supports the government of Ukraine and the Ukrainian people and their fight to defend their country and their democracy against Putin's brutal war."

As everyone knows, with US assistance, Britain won the war. But as Hudson points out, "Britain once again became a war debtor through victory." Hudson makes the case that the strategy of the US included the dismantling of the British Empire. At the end of the war, Americans saw the UK, not the Soviet Union, as their most dangerous rival.

Similar hindsight five or ten years from now may reveal something similar. The entire Ukraine drama, prepared for decades by the US, with a notable acceleration in 2014 that forced a change of government, may well be more about humiliating the European Union and undermining its geopolitical influence than about "weakening Russia." If Ukraine survives intact as a democratic nation, its debt to the US alone will make it a province of Washington.

The worst thing about this scenario is that the Russians and undoubtedly the Chinese – and indeed other nations, such as those like India that were part of the British Empire – are aware of the history of American assistance and understand its implications. In contrast, Americans' studied indifference to the lessons of history – even to history itself – means that the risks of a less favorable outcome for the US are very real. And for the world, that includes the risk of a nuclear conflagra-

KOLKATA: Reacting for the first time to two BJP leaders' hate speeches, which triggered diplomatic outrage from Gulf countries, West Bengal Chief Minister Mamata Banerjee on Thursday condemned the hate speech and demanded the immediate arrests of the leaders for their "atrocious" remarks referring to Islam and the Prophet.

"I strongly seek that the accused leaders of BJP be arrested immediately so that the unity of the country is not disturbed and people at large do not face mental agony," Mamata tweeted.

Following the diplomatic outrage overseas, the BJP on Sunday took action on

two of its leaders and suspended its national spokesperson Nupur Sharma and expelled its Delhi media head Naveen Kumar Jindal over their comments and issued a statement asserting that it "respects all religions" and "strongly denounces insults of any religious personality".

Taking to Twitter, Mamata wrote, "I condemn the recent heinous and atrocious hate speech remarks by a few disastrous BJP leaders, resulting in not only spread of violence but also division of the fabric of the country, leading to disturbance of peace and amity."

In her message on the micro-blogging platform, the Bengal CM appealed to maintain peace. "At the same time, I appeal to all my brothers and sisters from all castes, creeds, religions and communities to maintain peace in the larger interest of the common people, despite provocation the which we so strongly condemn," she tweeted.

An organisation of Imams in Bengal, the Imam Association of Bengal, circulated a video-clip urging to protest against hate speech. The message given by Yah Yah Khan, the president of the association, urged all Imams across the state to stage demonstrations at mosques after Friday's namaaz session. Khan also demanded the immediate arrest of Nupur and Jindal.

Irked by the hatespeech, hundreds of people of minority community staged demonstrations squatting on arterial thoroughfares in Howrah district on Thursday. Protesters put up roadblocks on the national highway in Howrah's Bagnan and Uluberia demanding arrests of Nupur and Jindal.

The Bengal CM's reaction over the issue of hate speech came shortly after the protests.

The minority community has proved to be the ruling Trinamool Congress's strong vote bank in previous elections since 2011. The community supported Mamata's party en bloc in all the electoral exercises in the recent past.

BJD For Rs.2930 MSP

Bhubaneswar: Just a day after the Centre enhanced the minimum support price (MSP) for paddy by Rs. 100 per tonne, the Governing Biju Janata Dal (BJD) on Thursday reiterated his demand to enhance the MSP to Rs 2930 per quintal.

Addressing a press meet today, BJD National Spokesperson Sasmit Patra said that the Centre had increased the MSP of common grade variety of paddy yesterday by Rs. 100 per quintal, Rs. 1940 in 2021-22 to Rs. 2040 per quintal for 2022-23 crop year for common variety. He reiterated that this increase of merely Rs. 100 per quintal is not sufficient and that the BJD has been demanding for increasing the MSP for paddy to 1.5 times of the Cost of Production at C2 value; as per the

Dr. Patra further stated that on March 25, 2017, the Odisha Vidhan Sabha had unanimously passed a resolution recommending that the MSP of common paddy be increased to Rs 2930 per quintal.

"All MLAs including those from BJP, Congress and BJD had unanimously supported this. But even after five years of the passage of this resolution and numerous demands in this regard

Apart from the issue of increasing the MSP of paddy to Rs. 2930 per quintal, Centre has also decided to stop



lifting surplus parboiled rice from Odisha, he pointed out.

Stating most of rice produced in Odisha is par-boiled rice and is one of the leading states in contributing to the PDS rice in the nation, the BJD MP said the Centre's decision to stop lifting surplus par-boiled rice will adversely affect lakhs of farmers of Odisha and that too from the western Odisha majorly.

He said that in 2021-22 kharif marketing season (KMS), out of 52 lakh tonnes of procurement of rice, the State's consumption will be about 39 lakh tonne under public distribution system (PDS) and other wel-

fare schemes.
The State is likely to have a surplus of 13 lakh tonnes of rice which should be lifted immediately for

smooth procurement operation. But the Centre is silent on this matter.

In addition, the State Government has taken all necessary steps to deliver five lakh tonnes of fortified parboiled rice to FCI as per target given by the Department of Food and Public Distribution (DFPD) in the Ministry of Consumer Affairs, Food and Public Distribution. The State is in a position to deliver a higher quantity of fortified parboiled rice and DFPD has been requested to give additional targets of fortified parboiled rice during KMS 2021-22. However, the Centre has not notified the State for higher quan-

tity targets so far.
Dr. Patra stated that the Odisha Government had demanded the release of Rs 10,334 crore food subsidy bill

sidy bill.
"Despite the State demanding that the Centre release the money immediately to bail out the State paddy procuring agency from financial stress, no action has been taken in this regard by the Centre," he said.

He further pointed out that Odisha State Civil Supplies Corporation, the designated agency for procurement of paddy for the State government, is to yet receive Rs 7,931.90 crore as provisional subsidy and advance subsidy of Rs 2,402.19 crore taking the total subsidy claim to Rs 10,334 crore by the

end of April 2022. Further, the additional interest incurred till March 31, 2022 because of delay in release and short release of subsidy comes to around Rs 5,454.67 crore which remains

"The Centre should pay the interest component failing which the State will bear the additional cost," he demanded.

Concluding the press meet, Dr. Sasmit Patra laid five demands in Odisha's farmers' interests before the Centre. First, that the MSP of paddy should be increased to Rs. 2930 per quintal as per the unanimous resolution of the Assembly in 2017.

Secondly, the MSP of Paddy should be increased by 1.5 times of the C2 value as per the Swaminathan Commission report recommendations.

Thirdly, the surplus par-boiled rice of Odisha should be lifted immediately which would otherwise cause great hardship to the lakhs of farmers of Odisha and particularly from western Odisha.

MUMBAI: Stock markets corrected and bond yields fell after the RBI's Monetary Policy Committee (MPC) raised the repo rate by an anticipated 50 basis points (bps) on Wednesday. Rupee tumbled marginally to 77.73 as foreign institutional investors (FIIs) continued selling

FIIs sold a provisional Rs 2,484 crore worth of Indian shares as the RBI raised inflation forecast and changed its policy stance to withdrawal of accommodation from remaining accommodative. Higher input costs squeeze margins of companies, which in turn impacts their share price.

the China-India border," he said.

Gen Flynn, who is on a visit to India, said on Wednesday that some of the defence infrastructure that is being created by China near its border with India in Ladakh is "alarming", calling the Chinese activity in that region as "eye-opening".

Flagging concerns over the Chinese infra build-up, the US General also said that the "destabilising and corrosive" behaviour of the Chinese Communist Party (CCP) in the Indo-Pacific region is simply not helpful. "I think it is worthy of us working together as a counterweight to some of those corrosive and corruptive behaviours that the Chinese do," he told reporters.

The Indian and Chinese troops have been locked in a tense border standoff in eastern Ladakh since May 5, 2020, when a violent clash between the two sides erupted in the Pangong lake area.

Last month, it emerged that China is constructing a second bridge in an area held by it around the strategically key Pangong Tso lake in eastern Ladakh and this could help its military to quickly mobilise its troops in the region.

China has also been establishing other infrastructure such as roads and residential units in the border areas with India. India and China have held 15 rounds of military talks so far to resolve the Ladakh standoff.

As a result of the talks, the two sides completed the disengagement process last year on the north and south banks of the Pangong lake and in the Gogra area.

However, each side currently has around 50,000 to 60,000 troops along the Line of Actual Control (LAC) in the sensitive sector.

Srinivasan, an Indian national, has more than 27 years of Fund experience, starting in 1994 in the Economist Program.

He is currently a Deputy Director in APD where he oversees the department's surveillance work on a number of large and systemically important countries such as China and Korea, and smaller states in the Pacific such as Fiji and Vanuatu.

He will assume charge on June 22.

Georgieva said Srinivasan's appointment is a culmination of his superior record of leadership across a wide range of departments, including the African Department (AFR), European Department (EUR), Monetary and Capital Market Department (MCM), RES, Strategy, Policy and Review Department (SPR), and West Hemisphere Department (WHD).

The Congress and the BJP are likely to win six more Rajya Sabha seats in the June 10 election and the UPA partners may bag three seats

According to rough calculations, the NDA has around 5,35,000 votes out of a total of 10,86,431 votes of all electors. This includes 3,08,000 votes with the support of its MPs along with that of its allies.

The NDA candidate may get the support of some regional parties including the AIADMK, the BJD and the YSRCP for its candidate in the presidential poll. Among the states, the BJP has the maximum of 56,784 votes from Uttar Pradesh where it has 273 MLAs. Each MLA in Uttar Pradesh has the maximum vote of 208. The NDA will get its second-highest votes among states from Bihar where with 127 MLAs, it will get 21,971 votes as each legislator has 173 votes, followed by 18,375 votes from Maharashtra where it has 105 MLAs and each has 175 votes.

With 131 MLAs, the NDA will get 17,161 votes from Madhya Pradesh, 16,464 votes of 112 MLAs from Gujarat and 15,982 votes of its 122 MLAs in Karnataka.

The UPA, on the other hand, has a little over 1,50,000 votes from among its MPs and will get around the same number of votes from its legislators in states.

Opposition candidates in the past too have been getting a little more than 3 lakh votes in the previous elections for the highest post in the country. The value of the vote of a Member of Parliament has gone down to 700 from 708 in the presidential polls this time due to the absence of a legislative assembly in Jammu and Kashmir.

The value of the vote of an MP in a presidential election is based on the number of elected members in legislative assemblies of states and union territories, including Delhi, Puducherry and Jammu and Kashmir.

Election will be held on July 18 to elect incumbent Kovind's successor, the Election Commission announced on Thursday. The nominations can be filed after the issue of notification on June 15 till June 29, Chief Election Commissioner Rajiv Kumar told a press conference.

Benzema scored early in the second half when Karius tried to roll the ball to a defender. The striker stuck out his right foot and deflected

the ball into the net. Sadio Mané equalized then Bale scored on an unstoppable scissorkick. But Karius then let Bale's swerving shot squirm through his hands, handing Madrid a 3-1 lead.

"Karius had a concussion. It was proven afterwards. Nobody talks about that," Liverpool manager Jurgen Klopp said a day before the team's 1-0 loss to Madrid in this year's Champions League final.

Karius was on loan to Besiktas and Union Berlin before returning to be part of Liverpool's goalkeeping group at its training centre this season. He joined the team in 2016 from German club Mainz.

Origi leaves eight years after he signed from French club Lille. Reports have linked him to Italian champion AC Milan.

In 175 appearances, the Belgium international scored 41 goals — none bigger than his pair at Anfield in the 4-0 Champions League semifinals win over Barcelona in 2019 to complete a historic comeback. He added an insurance goal late in Liverpool's 2-0 victory in the final against Tottenham.

The club also said youngsters Sheyi Ojo and Ben Woodburn will leave when their contracts expire this month.
