

Landslide Victory for BJD

Jharsuguda(KCN): Governing BJD once again proved that it doesn't have a strong political opponent in Odisha by ensuring a landslide victory in the by-election to Brajrajnagar MLA seat.

BJD candidate Alaka Mohanty won the election with a thumping majority of 93,953 votes while her rivals in Congress and BJP got 27,831 and 22,630 votes in the by-poll. Alaka, the widow of late Kishore Mohanty has won the seat with a margin of 66,122.

As per Election Commission data, a total of 1,53,398 votes were polled during the by-poll held on May 31. This includes 1,53,096 votes through EVM and 302 through postal ballot.

Panda was in third Alaka got 61.25 per place with 14.75 percent of votes.



nearest Congress rival Kishore Patel got 18.14 per cent of votes, while BJP candidate Radharani

Ramesh Kumar Tripathy from CPI got 3105 votes whereas 1511 voters have selected NOTA (none of the above). The ruling BJD has not lost a single Assembly by-poll since 2019. From one after another, the BJD became stronger in the State. The party won the by-election held for Bijepur, Balasore, Tirtol and Pipili MLA seats. Among the four seats, Balasore seat was with BJP.

This is the first time since the 2019 Lok Sabha polls that the BJP clinched the third spot, with the Congress coming up in the second spot. The ruling party workers started celebrations with crackers and beating drums.

The by-poll was necessitated as MLA Kishore Mohanty, the husband of the BJD candidate, died in December last year.

Odisha reels under sweltering heat conditions

BHUBANESWAR(KCN): Odisha continued to reel under sweltering heat conditions as 17 places in the State recorded 40 degree Celsius or more on Sunday. Sonepur was the hottest at 44 degree Celsius, followed by Titlagarh 43.8 degree Celsius and Jharsuguda and Balangir 43.4 degree each.

Bhubaneswar and Cuttack recorded 38.2 degree Celsius and 38.8 degree respectively on the day. The India Meteorological Department (IMD) has said there will be no large change in maximum (daytime) temperature during the next four to five days in Odisha.

"Isolated places in interior Odisha might witness slightly above normal daytime temperature and other places will experience normal temperature in next four to five days due to no significant system and clear sky conditions," said Bhubaneswar Meteorological Centre Director, HR Biswas.

Odisha Bridge Construction Corporation (OBCC) and manager of Tata Projects, the agency executing the Jagannath temple heritage corridor project. Acting on the direction of the subdivisional judicial magistrate (SDJM) of Puri, the cases were registered under section 30-A and 2, b(c) of the Ancient Monu1958.

The SDJM had directed Simhadwar police to register cases after hearing a complaint petition filed by lawyers of Puri Bar Association alleging that work is being carried out illegally in violation of the Archaeological Survey of India (ASI) guidelines in the prohibited zone (100 mtr) of 12th century Srimandir as part of the

Simhadwar police urging it to investigate the matter. Subsequently, they filed a case in the SDJM court alleging that police did not accept their complaint. They prayed the court to direct the police to register a case or conduct hearing in the case.

The lawyers had alleged that the administration was undertaking works of the Srimandir

and National Monuments Authority (NMA). In their petition, they also alleged that construction work in prohibited zone of the Centrally protected temple of national importance is likely to cause harm to its structure, they stated. The lawyers had sought prosecution of the Puri Collector, Tata Projects and OBCC, the nodal agency of the

project.



A Non-Resident Indian businessman, currently Mumbai, Sachiin J. Joshi has claimed in a police complaint that he was reportedly lured and then cheated by SGPL's 'Satyug Gold Scheme', launched around 2014.

Joshi has lodged a criminal complaint of cheating, fraud and other charges against Shilpa Shetty, Raj Kundra and officials of SGPL such as Ganpati Chaudhary, Mohammed Saifi and others with the

lice Station told IANS that "the complaint is currently under investigation" but declined to elaborate. Despite repeated at-

tempts by IANS, Shilpa Shetty was not available for her comment.

According to Joshi, under the five-year gold plan, sold as 'Satyug Gold Sheme' the buyer was offered a 'Satyug Gold Card' at a discounted rate and promised a certain fixed quantity of gold redeemable after a five-year pe-

As per Kundra's statements at the 'gold dream' launch, an investor who bought a certain sum of gold at the then current rates with full advance

attractive discounts -- 15 per cent after two years, 26 per cent after three years, 30 per cent after four years and 37 per cent after five years.

Joshi had purchased One kg gold for nearly Rs 18.58 lakhs in March 2014 at the then prevailing rates. It would be redeemable on or after March 25, 2019 at the promised discount on presentation of the Satyug Gold Card to the SGPL, his spokesperson told IANS.

Explaining stakes, the spokesperson said that at current rates, the original investment would have fetched around Rs 44 lakhs or more than double as today the gold Joshi attempted to redeem his one-kilo golden asset on the due date in March last year, he discovered that the SGPL office in Bandra Kurla Complex, suburban Mumbai, was shut with no employees or representatives available

at its address. Upon enquiring he learnt that the office had been closed down a long ago, the SGPL website showed a new office address, at Shalimar Morya Park in Andheri west.

When Joshi's team visited the new office, they were informed that the addressed did not belong to SGPL.

Further online searches and scanning the company's annual returns re-

encountered the same reply that these addresses did not belong to SGPL. Ditto was the experience with the company's helpdesk and customer care numbers (18002679090)which elicited no response, Joshi said. In November 2019, Joshi's representative happened to meet one of the company officials at the Malad West address who claimed that it was not possible to redeem the claim as the company was processing multiple claims, and suggested he should return in December 2019.

A search on the Ministry of Corporate Affairs (MCA) website pertaining had resigned as the company directors in May 2016 and November 2017 respectively.

"It became clear from all these facts that SGPL was a fraudulent entity being used to run the fake 'Satyug Gold Scheme' using the name of celebs like Shilpa Shetty. I have suffered a loss of Rs 18.58 lakh on my gold investment," Joshi said. Sources in the gold industry hinted that many more such investors may have been lured by SGPL and only a detailed police investigation would reveal the extent of the alleged

scam. SGPL was formerly known as Avyaan Gems & Jewellery Pvt Ltd with its offices in Bandra Kurla Complex.

ppreciating the Harbingers of Peace: International Day of UN Peacekeepers

The United Nations Peacekeeping Forces are used by the United Nations to keep or restore



peace in areas where there is armed conflict. The UN has the authority to intervene in both inter-state and intrastate conflicts. The **United Nations serves** as an unbiased third party in order to provide the groundwork for a

peaceful resolution of the issues that have led to armed conflict. If a peaceful settlement is impossible to achieve, UN forces may be able to help reduce the degree of hostilities. Only when both parties to a conflict agree to their presence can the UN Peacekeeping Forces be deployed. As a result, they may be employed by the fighting parties to prevent the escalation of a conflict and, in this case, to end a struggle. The United Nations' leadership is in charge of the Peacekeeping Forces. They are usually sent out in response to a Security Council decision. The General Assembly, on the other hand, has taken the lead on occasion. The Secretary-General and his secretariat are in charge of operational control. There is a distinction between unarmed observation groups and lightly armed military forces in peacekeeping operations. They are only permitted to use their guns in self-defence. In total, 14 UN operations have taken place. Observer groups and military units are evenly distributed. The UN observer groups are tasked with gathering information regarding actual conditions in a certain area, such as whether both parties are adhering to an armistice deal. Military troops are tasked with more complex tasks, such as separating conflicting parties and preserving order in a certain area.

In the Middle East, UN interventions have been particularly popular, both in terms of observer groups and military personnel. In 1948, the United Nations was tasked with sending observers to supervise the armistice between Israel and the Arab states. Following the wars of 1956, 1967, and 1973, observer group activities was resumed. Following the 1956 war, the first armed UN force was deployed in the Sinai to act as a buffer between Israeli and Egyptian forces. Soldiers came from ten different countries.

With presence in eight of the 14 (present)

United Nations Missions throughout

the world, the Indian Army continues to play a leading role in UN Peacekeeping, with over 5,400 military troops deployed in difficult conditions under the UN flag. In the Democratic Republic of Congo,

Lebanon, South Sudan, the Golan Heights, Syria, Western Sahara, Abyei, and Cyprus, the Indian Army maintains a significant presence. India is also participating in UNISFA with an infantry battalion group (Abyei). India is a founding member of the United Nations, and its participation in UN peacekeeping missions dates back to 1950, when it joined the United Nations Multinational Force in Korea. Since then, India has participated in 51 of the 71 United Nations peacekeeping deployments, contributing over 2,64,000 personnel and making it one of the world's top contributors of peacekeepers. India has always participated in United Nations peacekeeping missions without any hyperbole or symbolism but in plain pursuit of the United Nations Charter's purposes. This devotion is true, even if it means accepting personnel casualties, and 159 Indian Army soldiers have made the ultimate sacrifice in the name of freedom.

As a "founding" member of the United Nations, India has never hesitated to respond to UN demands for troops to assist in the maintenance of world peace and security. The Indian Army's 60 Parachute Field Ambulance was despatched to provide medical support to US/ROK and UN forces fighting in the Korean War shortly after India's independence in 1950. The unit served in Korea for three and a half years, from November 1950 to May 1954, the longest term of service by any UN military unit. From 15 November 1956 to 19 May 1967, eleven Indian infantry battalions rotated through the UN Emergency Force (UNEF 1) to supervise the withdrawal of France, the United Kingdom, and Israel from Egyptian territory and to keep the peace between Israel and Egypt.

When Belgian rule dissolved in 1960, the Congo urged UN soldiers to prevent secession and reconcile the country. From 14 July 1960 to 30 June 1964, two Indian brigades participated in the ONUC UNPKO. The rules of engagement were altered to permit the use of force in the defence of the mandate, humanitarian missions, and countermercenary operations. A total of 39 Indian troopers were killed in the action. For laying down his life in defence of the UN mandate in the Congo, Captain Gurbachan Singh Salaria received India's highest military honour, the ParamVir Chakra. A growing pool of Indian military commanders has been seconded to the UN as a result of India's participation in the initial UNPKOs, whose professionalism and expertise have aided UN peacekeeping doctrine. In this sense, Major-General I.J. Rikhye, who served as the UN Secretary-Military General's Adviser from 1960 to 1967, made an important contribution. The three essential principles of effective UN peacekeeping were formulated based on UNPKOs' on-the-ground experience. These include deployment with the parties' participation, operations that are impartial, and the use of force solely in self-defence or to defend the mandate.

The end of the Cold War set off a chain reaction of disasters. More than 20 further UNPKOs were deployed between 1989 and 1994. India's contribution to these new firms grew considerably. In three areas, India's initiatives have made a big difference.UNPROFOR in

the former Yugoslavia, which had India's Lt. General SatishNambiar as its first Force Commander; UNTAC in Cambodia; ONUSAL in El Salvador; ONUMOZ in Mozambique; UNOSOM in Somalia; UNAVEM in Angola; UNAMSIL in Sierra Leone; UNMEE in Ethiopia-Eritrea; and UNMIT in East Timor are examples of UNPKOs. The third area is leading the groundlevel response to emerging issues, while the UN Security Council continues to be ineffectual in enforcing its decisions, due to reasons outlined unanimously by world leaders at the 2005 UN World Summit, which demanded Security Council reforms. One problem where India's UN troops have made a significant influence is the protection of civilians involved in intra-state conflicts, particularly in complicated UNPKOs like MONUSCO in the Democratic Republic of Congo and UNMISS in South Sudan. Indian UN peacekeepers have donated medical services, including veterinary support, and engineering services in various UNPKOs, going above and beyond the call of duty to help conflict-affected local residents maintain their livelihood.

Terrorist threats to the UN by non-state actors are among the issues encountered by India's forces today, which have contributed to UNPKOs. Indian UN military soldiers based on Syria's Golan Heights were the first to face such obstacles from the Jabhat al-Nusra terrorist organisation, which kidnapped UN peacekeepers in 2014. The refusal of permanent members of the Security Council to participate in "decisions of the Security Council" concerning the deployment of India's troops, as called for in Article 44 of the UN Charter, is a greater difficulty for troopcontributing countries like India.Between 1948 and 2018, 3802 UN member-state troops gave their lives upholding the UN Charter. India had the biggest number (164) of participants. India has established a virtual memorial for its peacekeepers. The United Nations General Assembly has approved the construction of a memorial to all UN peacekeepers who have died in the line of duty. "It would be most suitable if the proposed memorial wall to the slain peacekeepers is created immediately," Prime Minister Shri NarendraModi said.

Joe Biden appeals for tougher gun laws: 'How much more carnage?'

WASHINGTON: "Enough, enough," President Joe Biden exclaimed over and over as he delivered an impassioned address to the nation imploring Congress to take action against gun violence after mass shootings he said had turned schools, supermarkets and other everyday places into "killing fields." If legislators fail to act, he warned, voters should use their "outrage" to turn it into a central issue in November's midterm elections. Speaking at the White House on Thursday night, Biden acknowledged the stiff political

headwinds as he sought to drive up pressure on Congress to pass stricter gun limits after such efforts failed following past attacks.

He repeated calls to restore a ban on the sale of assault-style weapons and high-capacity magazines and said if Congress won't embrace all of his proposals, it must at least find compromises like keeping firearms from those with mental health issues or raising the age to buy assault-style weapons from 18 to 21. "How much more carnage are we willing to accept?" Biden asked after last week's shootings by an 18-year-old gunman, who killed 19 students and two teachers at an elementary school in Uvalde, Texas, and another attack Wednesday in Tulsa, Oklahoma, where a gunman shot and killed four people

For all the passion of Biden's address, and for all his big asks and smaller fallback alternatives, any major action by Congress is still a long shot.

"I know how hard it is, but I'll never give up, and if Congress fails, I believe this time a majority of the American people won't give up either," he added. "I believe the majority of you will act to turn your outrage into making this issue central to your vote.'

Adding a stark perspective to young people's deaths, he noted that Centers for Disease Control data shows "guns are the number one killer of children in the United States of America," ahead of car crashes.

"Over the last two decades, more school-age children have died from guns than on-duty police officers and active-duty military combined," he said.

Aware of persistent criticism from gun-rights advocates, Biden insisted his appeal wasn't about "vilifying gun owners" or "taking away anybody's guns.

"We should be treating responsible gun owners as an example of how every gun owner should behave," Biden said. "This isn't about taking away anyone's rights, it's about protecting children, it's about protecting families."

He called on Congress to end "outrageous" protections for gun manufacturers, which severely limit their liability over how their firearms are used, comparing it to the tobacco industry, which has faced repeated litigation over its products' role in causing cancer and other diseases.

"Imagine if the tobacco industry had been immune from being sued, where we'd be today," Biden said. All major broadcast networks broke away from regular programing to carry Biden's remarks at 7:30 p.m. EDT, before the start of prime-time shows.

In his address, he spoke of being passed a note by a woman in a Uvalde church grieving the loss of her grandchild, calling on people to come together and act.

His Thursday night address coincided with bipartisan talks that are intensifying among a core group of senators discussing modest gun policy changes. Republican Sen. Susan Collins of Maine said the group is "making rapid progress," and Biden has spoken to Connecticut Sen. Chris Murphy, among those leading Democrats' efforts on the issue.

Democrats are hoping Biden's remarks encourage the bipartisan Senate talks and build pressure on the Republicans to strike an agreement. White House press secretary Karine Jean-Pierre said Biden is "encouraged" by congressional negotiations but the president wants to give lawmakers "some space" to keep talking.

The private discussions in the Senate, which is split 50-50 between Democrats and Republicans, are not expected to produce the kinds of sweeping reforms being considered by the Democratic-led House — which has approved expansive background checks legislation and will next turn to an assault weapons ban.

A House package debated Thursday and approved by a committee, 25-19 is less sweeping but includes a provision raising the required age for buying semi-automatic firearms to 21. It still faces slim chances in the Senate. Instead, the bipartisan senators are likely to come up with a more incremental package that would increase federal funding to support state gun safety efforts with incentives for bolstering school security and mental health resources. The package may also encourage "red-flag laws" to keep firearms away from those who would do harm.

Government amends norms for appointment of directors

NEW DELHI: The government has put in place stricter norms for appointment of individuals from certain

Putting in place a stricter framework, the ministry has now mandated security clearance for individuals

In this regard, the rules governing compromises, arrangements and amalgamations were amended.

On May 5, the ministry amended rules governing companies with respect to prior approval being mandatory for investments by entities and individuals from countries that share a land border with India. Amendments were made with respect to rules for the prospectus and allotment of securities.

In April 2020, the Department for Promotion of Industry and Internal Trade (DPIIT) had issued Press Note 3 regarding foreign investments.

With the press note, the government had made its prior approval mandatory for foreign investments from countries that share land border with India to curb opportunistic takeovers of domestic firms following the coronavirus pandemic.

Countries which share land borders with India are China, Bangladesh, Pakistan, Bhutan, Nepal, Myanmar and Afghanistan.

As per the decision, FDI proposals from these countries need government approval for investments in India in any sector.

Services activity expands at strongest rate in over 11 years in May amid mounting price pressures

NEW DELHI: India's services sector activities improved further and expanded at strongest rate in over 11 years in May, supported by a substantial pick-up in new business growth, even as input cost inflation climbed to a record high, a monthly survey said on Friday.

The seasonally adjusted S&P Global India Services PMI Business Activity Index jumped to 58.9 in May, up from 57.9 in April, amid better underlying demand and strong inflows of new work. For the tenth straight month, the services sector witnessed an ex-

pansion in output. In Purchasing Managers' Index (PMI) parlance, a print above 50 means expansion while a score be-

low 50 denotes contraction.
"The reopening of the Indian

economy continued to help lift growth in the service sector. Business activity rose at the quickest pace in over 11 years in May, supported by the fastest upturn in new orders since July 2011," said Pollyanna De Lima, Economics Associate Director at S&P Global Market Intelligence.

The upturn was supported by a substantial pick-up in new business growth as demand continued to recover following the reopening of the economy after COVID-19 lockdowns, the survey said.

The latest results, however, continued to signal subdued global demand for Indian services, with new business from abroad having now declined in each month since the onset of COVID-19 in March 2020. On the prices front, the rate of inflation climbed to the highest in 16and-a-half years of data collection.

high time that such petitions are nipped in the bud so that development work is not stalled," the bench said.

The top court said that a hue and cry was made that the construction carried out is contrary to the inspection report carried out by ASI.

However, the note of the Director-General of ASI clears the position.

"It can thus be seen that even if the appellant had genuine concern the same is already taken care by the high court in the impugned order. Inspite of that matter was mentioned for obtaining urgent orders before the vacation bench on Monday. Till the matter was not listed again a hue and cry was made as if heavens are going to fall if the matter is not heard. Activity undertaken is in sync with our earlier orders," the bench said.

Earlier, senior advocate Mahalakshmi Pavani, appearing for the petitioner, had said there's a clear embargo and there can be no construction in the prohibited area.

"They (state government) did not even take permission to construct in the regulated area," she had submitted.

The state, she had said, got a no objection certificate from the National Monuments Authority (NMA) and went ahead.

She said the NMA could not have granted a valid certificate and this is something only the director of archaeology in the Central or the state government can do.

Advocate General for Odisha Ashok Kumar Parija had submitted that under The Ancient Monuments and Archaeological Sites and Remains Act, the authority is the NMA, and the competent authority has been notified to be the Odisha government's director culture. "Construction does not mean repair or remake existing structures or clean the sewage, drains

etc. This is how it is understood and DG ASI also understands the same way.

"Grant of the permission was by director culture. The director culture of the government of Odisha is the competent authority. What was prohibited within 100 metres was construction. The concept plan of the state aims to provide amenities and beautify the temple," he had said.

He added that 60,000 people visit the temple everyday and there is a need for more toilets. "The amicus curiae in the case pointed out there was a necessity of more toilets and the court had issued directions in that regard," he had added.

The top court was hearing a plea filed by Ardhendu Kumar Das and others alleging illegal excavation and construction work by the Odisha government at the temple.

According to the petition, state agencies have been working in gross violation of Section 20A of The Ancient Monuments and Archaeological Sites and Remains Act, 1958.

The plea alleged that the Odisha government is carrying out unauthorized construction

The club's call for answers came six days after problems occurred outside the Stade de France in

"We would like to know the reasons which led to this venue being chosen to host the final and the criteria used, taking into account the experiences of the day," Madrid said.

Liverpool had already complained about those involved in organizing the event shortly after the

supporters being "attacked, harassed, assaulted and robbed in violent fashion. These occurrences continued as they moved in their cars or busses, causing concern for their physical well-being. Certain fans even had to spend the night in hospital as a result of injuries."

Bopanna-Middelkoop suffer heartbreaking defeat to bow out of French Open

PARIS: India's Rohan Bopanna and his Dutch partner Matwé Middelkoop saved two match points but their dream run at the French Open ended with a semifinal defeat at the hands of Marcelo Arevalo and Jean-Julien Rojer, here on Thursday. The



16th seeds, Bopanna and Middelkoop, who have played some exhilarating tennis throughout, lost 6-4 3-6 6-7 (8-10) to the 12th seeded pair from El Salvador and the Netherlands in the men's doubles match that lasted two hours and seven minutes.

No Indian has played in a Grand Slam men's doubles final since Leander Paes' 2013 US Open triumph and Bopanna was bidding to become the first Indian in nine years to achieve the feat.

The first and last time Bopanna featured in a Grand Slam final was in 2010 with Pakistani partner Aisam-ul-haq Quereshi, losing the title clash to legendary Bryan brothers -- Bob and Mike. Rojer's first serve accuracy was a huge factor in the outcome of the match.

Bopanna and Middelkoop fell behind 2-5 with the Indian making three errors -- first an overhead smash, a forehand return error and then a backhand return.

Bopanna and Middelkoop logged four straight points from 2-7 to make it a close affair and even saved two match points but Arevalo converted the third.

With this defeat, India's challenge ended at the clay-court major.

Anjum clinches silver, India moves up to third spot in Baku Shooting World Cup

NEW DELHI: Experienced Indian in the corresponding Men's 50m Rifle 3 shooter Anjum Moudgil clinched a silver in the Women's 50m Rifle 3 Positions as India moved up to the third spot in the medal tally at the ISSF World Cup in Baku, Azerbaijan, on Friday.

Anjum went down 12-16 in the gold medal match to Denmark's Rikke Maeng Ibsen.

Anjum, also a world championship silver medallist, had on Thursday qualified for the top-eight ranking round with a score of 587 out of 600, which gave her a fourth place in a field of 60 shooters. On Friday, she finished second to Ibsen in stage two with a 406.5 to the Norwegian's 411.4.

She then put up a strong challenge in the final but could not put it across the Dane. It is Anjum's second individual World Cup silver in the event.

The Men's 3P trio of Swapnil, Deepak Kumar and Goldie Gurjar also won a silver in the team competition.

The trio came through two rounds of qualifying to make it to the gold medal match which they lost 7-17 to Croatia. Ukraine picked up the bronze.

Swapnil Kusale had also finished second
