# Scholarship amount hiked



Bhubaneswar(KCN): The State Government on Monday enhanced the pre-Matriculation Scholarships for the students belonging to Scheduled Tribe (ST) and Scheduled Caste (SC) communities.

The pre-matriculation scholarship for boy students has been increased to 950 from Rs 750. Similarly, the girl boarders will now be entitled to get Rs 1,000 from Rs 800.

Provision of pre-matric scholarships to ST & SC boarders of schools under the ST & SC Development Department and School & Mass Education Department is one of the flagship schemes of the State Government.

The scholarship primarily meant for the mess management in the hostels aims at the educational and holistic development of ST & SC students.

An expenditure amounting to Rs 490 crore would be incurred annually towards prematric scholarship. The monthly scholarship for the SC, ST students was last enhanced in the year 2015.

Further, millet (mandia) based food items would be introduced in the hostel's menu to address the nutritional security of the boarders. The scheme would benefit more than five lakh ST & SC boarders.

Senior lawmakers including Sushant Singh, Pratap Jena, Dibya Shanker Mishra, Jyoti Prakash Panigrahi, Sudam Marndi, Padmanabha Behera, Padmini Dian and Raghunandan Das held a meeting with the Chief Minister Patnaik at Naveen Niwas.

The Ex-Ministers were told to look after the organisational activities of the governing party. They were also told to strengthen the party at the grassroots level by reaching out to more people.

Besides, the leaders have been asked to regularly pay visits to blocks and panchayats to strengthen the party's base at grassroots level so that the party's core vote bank will remain intact. Most importantly, the Ministers were advised not to be controversial.

#### In a brief statement, with high-tech missile system kraine support boosts

KYIV: The British government said Monday that the multiple-launch rocket systems it is offering to Ukraine will bring "a significant boost in capability" for the country's efforts to resist Russia's invasion.

"If the international community continues its support, I believe Ukraine can win" its war against Russia, British Defense Secretary Ben Wallace said in a statement.

The statement came after comments Sunday by Russian President Vladimir Putin, who warned the West against sending longer-range rocket systems to Ukraine.

The British government described the M270 weapon system as a "cutting edge" military asset which can strike targets up to 80 kilometers (50 miles) away "with pinpoint accuracy." The United Kingdom pledged last week to send the weapons. It gave no details about delivery dates.

The U.S. last week announced plans to deliver \$700 million of security assistance for Ukraine, including four precision-guided, medium-range rocket systems, as well as helicopters, Javelin anti-tank systems, radars, tactical vehicles and more.

Washington and London hope the deliveries will help Ukraine turn the tide of the war in its eastern Donbas region which Russia appears minded to capture entirely.

They are unlikely to have an immediate im-

pact, however. The Pentagon said last week that it will take at least three weeks to get the U.S. weapons onto the battlefield. Russiabacked separatists have fought the Ukrainian government since 2014 in the Donbas.

The U.S. has stopped short of offering Ukraine longer-range weapons that could fire deep into



Russia and could inflame tensions with Mos-

cow.

Russia's own use of missiles in Ukraine, meanwhile, continued to pummel targets, with the Russian military claiming Monday it had struck a Ukrainian factory that was repairing armor.

Russian warplanes fired long-range missiles to destroy a plant on the edge of the town of Lozova in the northeastern Kharkiv region that

was repairing armored vehicles, Russian Defense Ministry spokesman Maj. Gen. Igor Konashenkov said.

Russian aircraft hit 73 areas of concentration of Ukrainian troops and equipment, while the Russian artillery struck 431 military targets, Konashenkov said. His claims couldn't be in-

dependently verified. Putin vowed to strike deeper into the heart of Ukraine if the West sends Kyiv longerrange missile systems. In a show of force, Russian missiles struck Ukraine's capital, Kyiv, on Sunday. Ukraine's General Staff said Russian forces fired five X-22 cruise missiles from

the Caspian Sea toward Kyiv, and one was destroyed by air defenses. Four other missiles hit "infrastructure facilities," but Ukraine said there were no casualties.

Before Sunday's early morning attack, Kyiv hadn't faced any such Russian airstrikes since the April 28 visit of U.N. Secretary-General António Guterres.

Ukrainian President Volodymyr Zelenskyy on Sunday visited command posts and the frontline positions of Ukrainian troops in the Donetsk and Luhansk regions, which make up the Donbas.

Ukraine's struggle on the 103rd day of war was heartfelt for veterans of D-Day who gathered in northern France on Monday.

American D-Day veteran Charles Shay, 97, was at Omaha Beach in Normandy morning to mark the 78th anniversary of June 6, 1944 landings and pay tribute to those who fell that day.

Asked about his feelings regarding the war being waged on the European continent, Shay told The Associated Press it "is a very sad situation."

"In 1944 I landed on these beaches and we thought we'd bring peace to the world. But it's not possible," he added with regret.

A Ukrainian regional governor said Monday that the situation in a key eastern town has worsened for defending troops.

Luhansk Gov. Serhiy Haidai said Monday that fierce fighting was continuing in the city of Sievierodonetsk, which is at the epicenter of the Russian offensive.

He described the combat situation as "quite dynamic," adding that the Ukrainian forces had lost some of the gains they made over the weekend but are holding their positions in the city's industrial zone.

#### **Uniform Allowance For Fire Service**

Bhubaneswar(KCN): In a major decision for the Fire Service officials, the State Government has introduced uniform allowance for all groups of employees working in the Directorate of Fire Services.

The Home Department has issued a detailed notification for this purpose on Monday. "After careful consideration, the Government has been pleased to approve the proposal for introduction of Uniform Allowance of employees of Fire Service



Organization of the State in lieu of existing centralized procurement of uniform and other items," read the notification. As per the notifica-

tion, Assistant Fire Officer, Station Officer/Fitter Station Officer, Assistant Station

Officer Havildar Major and Fireman/Fireman Driver/ Helper Fireman will now get Rs 5700 per annum as uniform allowance.

Similarly, Rs 5800 per annum will be given to the Leading Fireman/ Driver Havildar/ Havildar Mechanic while Rs 2000 per annum will be distributed to follower orderly.

The payment of allowances during 2022-23 will be allowed against the exhausted items based on the above rate proposed. The Fire Service Directorate will work out the shortfall items and amount payable there on to the eligible employees during 2022-23.

There was a budget proposal of Rs 2.004 crore for the financial year 2022-23. The Directorate can distribute the allowances during 2022-23 after enactment of a full-fledged budget for implementation of the scheme.

Further those who have received the available items, payments against those items shall be made only after the lifespan of those items expires. Hence, accordingly, the allowances for those employees will be worked out by the Fire Service Directorate, as per the notification.

The proposed allowances will be sanctioned annually in the month of July. The officers and employees who have less than six month of service for superannuation on the first date of July will not be entitled for uniform allowances for that year.

The Fire Service Directorate has been asked to prescribe the detailed dress code for all the officers/employees covered under the uniform allowance to maintain uniformity.

Moreover, the officers/employees will furnish undertaking at the time of sanction of allowances for utilization of the same for the purpose for which it is sanctioned.







At the outset, Netflix's latest release, Decoupled, might seem like the antithesis of love and romance because it tracks a broken marriage, and

how worse romantic life can get. And yet, the glimmers of love and shared Madhavan's Arya and Surveen's Shruti is the lifeline of this series. "I liked the take on splitting up. It is normal for people to grow apart. Not all splitting or divorces need to be about something dramatic. There is both a real image and a proected image in a mar-

In this conversation with Cinema Express, he is joined by an equally philosophical Surveen Chawla as they discuss marriages, literally and metaphorically. Excerpts:

Marriage of their real and onscreen selves Surveen Chawla (SC): Playing Shruti was so nuch fun. There were times when it felt like I was talking to my real-life husband, and not Madhavan's Arya. It was not about the manner of speech, but simply about the way both conduct themselves. The relatability factor is that the basic issues faced by this couple are things we might have experienced. Just because there is relatability, it doesn't mean all couples have to end up like Shruti and Arya. Relationships are always a work in progress.

Madhavan (M): There were so many instances

# RSS and its unburdening of the communal trap

Mohan Bhagwat, the Rashtriya Swayamsevak Sangh (RSS) chief has always been viewed as a media-savvy person, a perspective that I personally disagree with. The RSS chiefs, according to my understanding and study, meet



the media rarely and when they do, their views capture headlines. This is because not only Mohan Bhagwat, but also his predecessors maintained the norm of not

making media-centric remarks for popularity, which I think; the outfit has been strictly following. Bhagwat is known for his highly influential and intellectual deliberations. In the RSS, what I understand is its cadre swallows the ideology without questioning that its hierarchy pedals. There are genuine reasons to put the philosophy that the Sangh propagates to critical examination. The Sangh's pursuit to identify India as one cultural entity with diversity sprouting from across the span of its existence is mutually accepted by many in the country. Probably, nobody contradicts that view but when it calls that diversity, the basic structure, on which the idea of India exists as Hindutva, disagreements pour in from all directions. But its outreach for dialogues with its ideological opponents needs to be seen as a remarkable faculty that the RSS holds. The interpretations that Mohan Bhagwat made on the Gyanvapi row must have, to some extent, doused the temperature that the BJP and some units in the Sangh Parivar have been gearing up with. The BJP must have had a plan to keep the heat building up until the state and national elections are over-a well calibrated move before 2024. But now, the siblings in the 'parivar' under the umbrella of the Sangh need to hold their tongue before they step out with aggressive bad-mouthing on issues that are under dispute.

The Muslim community in India should

have welcomed the statement of Bhagwat at Nagpur. While addressing the delegates of the third year officers training camp (OTC), the Sangh chief made the opinion of the RSS public, on the disputes that the media and the courts are extensively exploring. He said it was futile and unnecessary to look for shivling in every mosque. This indeed has come as an acceptance by the Sangh on the volatility that such disputes could push this country into, especially, when it realises that radical changes with long standing effect can happen only if it manages to grab power at the centre again. Its political tool the BJP, that the RSS devised to capture the country politically, has been prospering successfully breaking the brittle bones of major parties including that of the Congress. We need to understand the success the Sangh was capable of making through the BJP in India. Everybody at the power centres including the President and the Prime Minister of the country, walk along with the Sangh ideology. The RSS, for that matter, stays behind with a steady silence when controversies erupt, while its organisational arms such as Bharatiya Janata Party (BJP), Bharatiya Mazdoor Sangh (BMS), Viswa Hindu Parishad (VHP), Akhil Bharatiya Vidyarthi Parishad (ABVP) and many more organisations under its umbrella are planted to speak for its cause. While the RSS presents its views amicably without damaging its stature, it keeps the radical and most inflictive and aggressive Bajrang Dal or VHP in the front row to respond to issues that can rake up outrage in the country for its cause and also to frame counter narratives. This needs to be seen as a diplomatic somersault of the Sangh.

The RSS, in a way, is happy and complacent to have made a larger section of the country

accept the Hindutva ideology that it was vocal about. Leaders

in the opposition parties were also forced to publicly admit their Hindu identity despite their efforts to woo the minorities. Rahul Gandhi's temple visits and Mamata Banerjee's proclamation on her Hindu identity in public was an ideological victory for the RSS that it kept on hammering since 1925. It was also capable of expanding its presence in the civil society and the state institutions tremendously. Eight years of Modi Raj in India has intensified the ecosystem that the RSS was struggling to build. The ambiance that the Modi rule could generate for the Sangh's growth in India was remarkable. The Sangh could not have achieved the stature and status that it did, had the BJP under the persona of Modi been not in power. The common mistake that every critique of RSS is prone to make is his ignorance on the depth into which the RSS has managed to send its roots. To fathom the space into which it has stretched its reach can be a subject of academic research. Whatever, the RSS has always managed to distance itself from maximum controversial issues, intelligently playing from behind the curtain- a strategy it has been playing out for years. Most of the controversial issues that the RSS is blamed for were not directly fuelled by the outfit. Now, the difficulty is with the BJP. After Bhagwat's views on the Gyanvapi controversy, the party needs to cautiously inch in the direction of moulding the issues that it identified as political game-changers. Issues similar to Gyanvapi have been set to boil in the poll bound states of Karnataka and Gujarat and the RSS chief has probably sprayed water on the prospects that the party has been dreaming for. The BJP leadership is fully aware of the potentiality of the RSS on the ground to toil the party to victory. That was the reason the top

leaders of the party were cautious before they expressed their views on Mohan Bhagwat's statements and also urged its rank and file to refrain from making comments in public. The Sangh had been vocal on its stance on three important spiritual places Ayodhya, Mathura and Kashi. It always maintained its stand on the spiritual importance of these places to the Hindus. Though the Sangh chief was critical about the frequent sweltering of controversies on every worship place under dispute, Bhagwat was firm on the faith that was attached to Gyanvapi by the Hindus. Essentially, his remarks on the fresh controversy on Gyanvapi should be seen as an attempt to nullify the damage, the blot, that it strongly believes certain sections of the media in India and abroad have been trying to cause to its image. Its outreach to the Muslims by incorporating a new wing to the Parivar, the Muslim Rashtriya Manch has been an endeavour to entice the Muslims to recognise the cultural ancestry that the RSS believes both the Hindus and the Muslims share in common. The Sangh first passed a resolution on Kashi in its Akhil Bharatiya Pratinidhi Sabha (ABPS), its highest decision making body, in 1959 and its resolution on Ayodhya came much later in 1987. Kashi was on its cards from the beginning itself, Mathura and Ayodhya were subsequent attachments. Many resolutions on disputed sites were passed in its meetings again and again but the organisation abstained from taking any controversial issue except Ayodhya into the streets. Mohan Bhagwat's call for restraint and adherence to the court ruling is an approach that everybody in India can embrace with a sigh of relief.

# Young crusaders take baby steps towards a greener world

Fifteen-year-old Soumyadeep Bhuniya doesn't remember anything of the fateful day in 2009 when supercyclone Aila pummeled their village in Patharpratima block of South



24-Parganas, West Bengal. He was only a toddler at the time. But he has heard horrifying stories from his parents,

neighbours and relatives. People and cattle were washed away and never found. Some had to cling to high, quivering branches of submerged trees for hours before help arrived. Mud houses were razed to the ground. Trees were uprooted and acres and acres of farmland destroyed by swirling saline water. His family and their neighbours and people from neighboring villages spent long days and nights at hastily set-up dingy shelters, waiting for the 'storm' to pass, in every which way. More than a decade on, teenager Soumyadeep is well aware that he lives in an environmentally fragile zone. Year after year, cyclones and tropical storms have ravaged this region, leaving behind a trail of death, destruction of property and infrastructure, damage to the environment and eco-system and endless misery. School buildings have been damaged, time and again, hampering primary and secondary education of children. Healthcare centres have had to be shut down for days together, disrupting routine services for children and the community at large. Over time, lives and livelihood have been rebuilt, only to be decimated again by another ferocious storm the following year or the next.

A recent UNICEF report on The Children's Climate Risk Index brings to the fore the calamitous future that Soumyadeep and his generation stare at. According to the report, 400 million children (nearly 1 in 6 children globally) are currently highly exposed to cyclones. This is likely to get worse as high-in-

tensity cyclones increase in frequency,

rainfall intensity grows, and cyclone patterns shift. Around 330 million children (1 in 7 children globally) are highly exposed to riverine flooding. This is likely to worsen as glaciers melt, and precipitation increases due to higher water-content in the atmosphere as a result of higher average temperatures. Increasingly catastrophic droughts, fires and storms are forecast to become even worse as our planet continues to warm. Important food and water systems will fail and entire cities are expected to succumb to destructive floods.

Grim facts, figures and statistics, indeed! But do they really mean anything to the people on the ground in Patharpratima, who shudder every time they see the skies darken and riv-

ers swelling up? What children learn today, community will profess tomorrow

CRY believes it is essential to groom young students and make them flag-bearers of a sustained campaign on climate change and the need to conserve and protect the environment. With on-ground support from a partner organization, Kaajla Janakalyan Samiti, work has started in full swing in remote hamlets in Patharpratima.

As part of the project, 300 children from villages in Patharpratima and Gopalnagar are taking supplementary lessons at centres run by volunteers of Kaajla Janakalyan Samiti. Soumyadeep is one of them. He is learning more about concepts such as environment conservation, climate change, rainwater harvesting, tree plantation and 3R (Reduce-Reuse-Recycle), along with various sources of energy.

Acutely conscious of the fragile eco-system around him, the young boy has taken up the crusade to spread awareness about the little things that we all can do and learn to conserve our environment. People in the community

With active support from Kaajla volunteers, Soumyadeep now leads a Green Scout team that visits door to door in the community and convinces people to plant trees and nurture them. The more the greenery, the less the amount of carbon-di-oxide in the air – the best and the easiest remedy to reverse the adverse of effects of climate change.

The 15-year-old has managed to stop the use plastic in his home and he and his team asks the neighbours to do the same. Plastic waste can choke the rivers and propel erosion at the edges, the young crusader tells people. This is especially relevant for the topography he lives in – rivers and riverines crisscrossing each other and small villages being shielded from the impending fury of swirling waters by mud or cement embankments. The young team is also vocal about practicing personal hygiene and sanitation, especially after a natural calamity.

Fruits of labour

Even as villagers wait in trepidation for news of an impending cyclone hurtling towards them from the ocean, silent winds of change are blowing in the region. Sample this.

Once upon a time, the ground in front of Raghunathpur Saraswati Free Primary School in Uttar Gopalnagar village used be a green haven, full of old trees and fresh saplings, planted and taken care of by villagers. But successive storm surges and the consequential trail of destruction left the land completely barren, bereft of any greenery.

Last year, the villagers, led by the gram panchayat pradhan, put forward the idea of setting up a fruit garden on the ground to Kaajla volunteers. As part of the project, 300 fruit trees were planted on the piece of land

by the women's self-help groups, who water them regularly. Kaajla volunteers supervise and monitor the overall work. It is being hoped that in the years to come, the produce from the jamrul, guava and other trees will not only boost healthy eating among villagers, but also sprout economic activity through sale in local markets.

One for the Earth

Patharpratima and Gopalnagar blocks are located in a unique geographical location - the mangrove belt. Successive cyclones including Amphan (2020) and Yaas (2021) wreaked havoc on Sagardwip, Patharpratima, Kakdwip, Namkhana and Gosaba. Agricultural land has been inundated and destroyed, mangroves uprooted and river embankments damaged completely.

An initiative has now been taken to plant mangrove trees on the river banks to prevent erosion, with help from the gram panchayats, forest department and villagers. The Banashree Mangrove Protection Committee has 17 women from Uttar Gopalnagar village as members. They have planted about 10,000 mangroves along the river and fenced them, to keep fishing nets and other equipment from causing harm.

Project coordinator and supervisor Vivekananda Sahu is hopeful that things are moving in the right direction. "We need to conserve the environment and are trying to teach the young generation simple ways to do that. What the children are learning today, their parents will learn from them tomorrow. And soon enough, the awareness will spread in the community," Sahu said. Plans are on the anvil to paint boundary walls of public spaces to create awareness about the importance of conserving the environment. Online campaigns through video clips will be carried out and short films on environmental issues screened to boost understanding and awareness among students and the community.



# Finance Ministry releases third instalment of rev-Global tourist arrivals enue deficit grant of Rs 7,183 crore to 14 states



NEW DELHI: The finance ministry on Monday released the third monthly instalment of revenue deficit grant of Rs 7,183 crore to 14

The Fifteenth Finance Commission has recommended a total Post Devolution Revenue Deficit Grant of Rs 86,201 crore to 14 states for the financial year 2022-23.

This is to be released in 12 equated monthly

The states receiving this grant are Andhra Pradesh, Assam, Himachal Pradesh, Kerala, Manipur, Meghalaya, Mizoram, Nagaland, Punjab, Rajasthan, Sikkim, Tripura, Uttarakhand and West Bengal.

"The Department of Expenditure has on Monday released the 3rd monthly instalment of Post Devolution Revenue Deficit (PDRD) Grant of Rs.7,183.42 crore to 14 States," the ministry said in a statement.

With the release of the third instalment for the month of June 2022, the total amount of revenue deficit grants released to the states in 2022-23 stands at Rs 21,550.25 crore.

flation. Imagine you were (are) living in the USA. From 1980 till 2021 you had inflation of 2% per annum. Now inflation is not just above 2%, it is at 8%! There is a whole generation of Americans who have not experienced inflation.

Luckily for us, we have always had inflation in India. However, many Indians who have experienced inflation also ignore - or underestimate inflation.

Of course when you are young it is difficult to imagine inflation in your '80s. I met a 82 year old who was earning Rs 5000 a year when he was 23 years of age. He now spends Rs 50,000 a month on himself and his wife. Just imagine would he have believed that 'he would spend 10x his annual income on a monthly basis after 50 years'. Other way of looking at inflation is "it is negative compounding". Remember this while planning for your retirement".

Another big blunder is taking advice from talking heads - sales heads, fund managers, almost anybody willing to talk. They come and talk some nonsense like

One of the biggest "Flexicap is the best derstand - blunders that people fund to invest" or Cryptocurrency, like "the amount you have in debt assets is the same as your numerical age" - so a 25 year old should have 25% in debt and an 80 year old should have 80% in debt.

> These generalisations and should be used only with the understanding of complex topics like Asset Allocation. When you follow the herd you have to remember that there could be a cliff- and you could fall along with the herd!

Trying to time the market - when a person retires, he wants to look busy. Women don't fall into this trap as much as the men do!

One way men keep themselves busy is trying to trade and timing the market. Trading is an expensive way to find out who you are.


